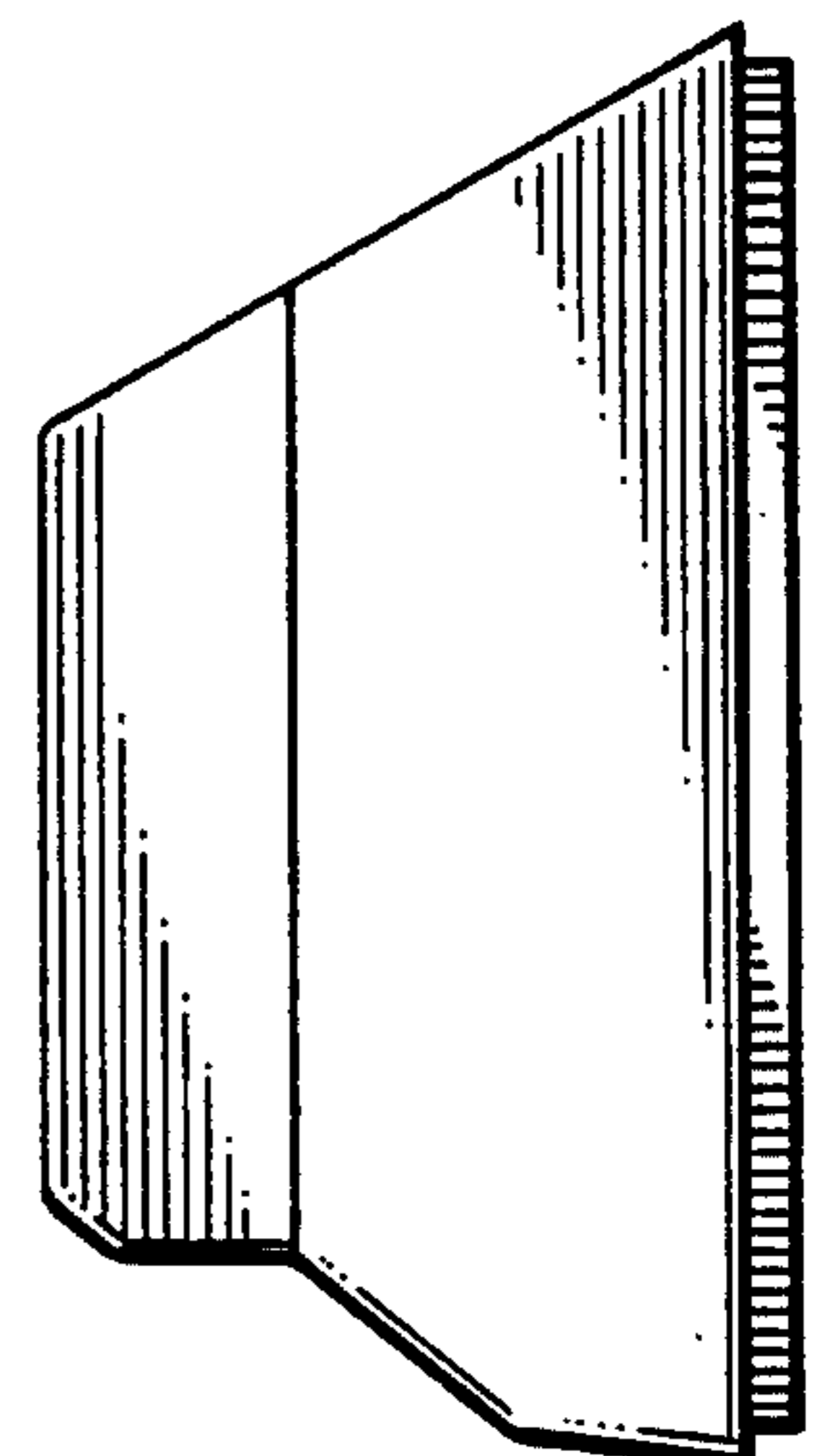
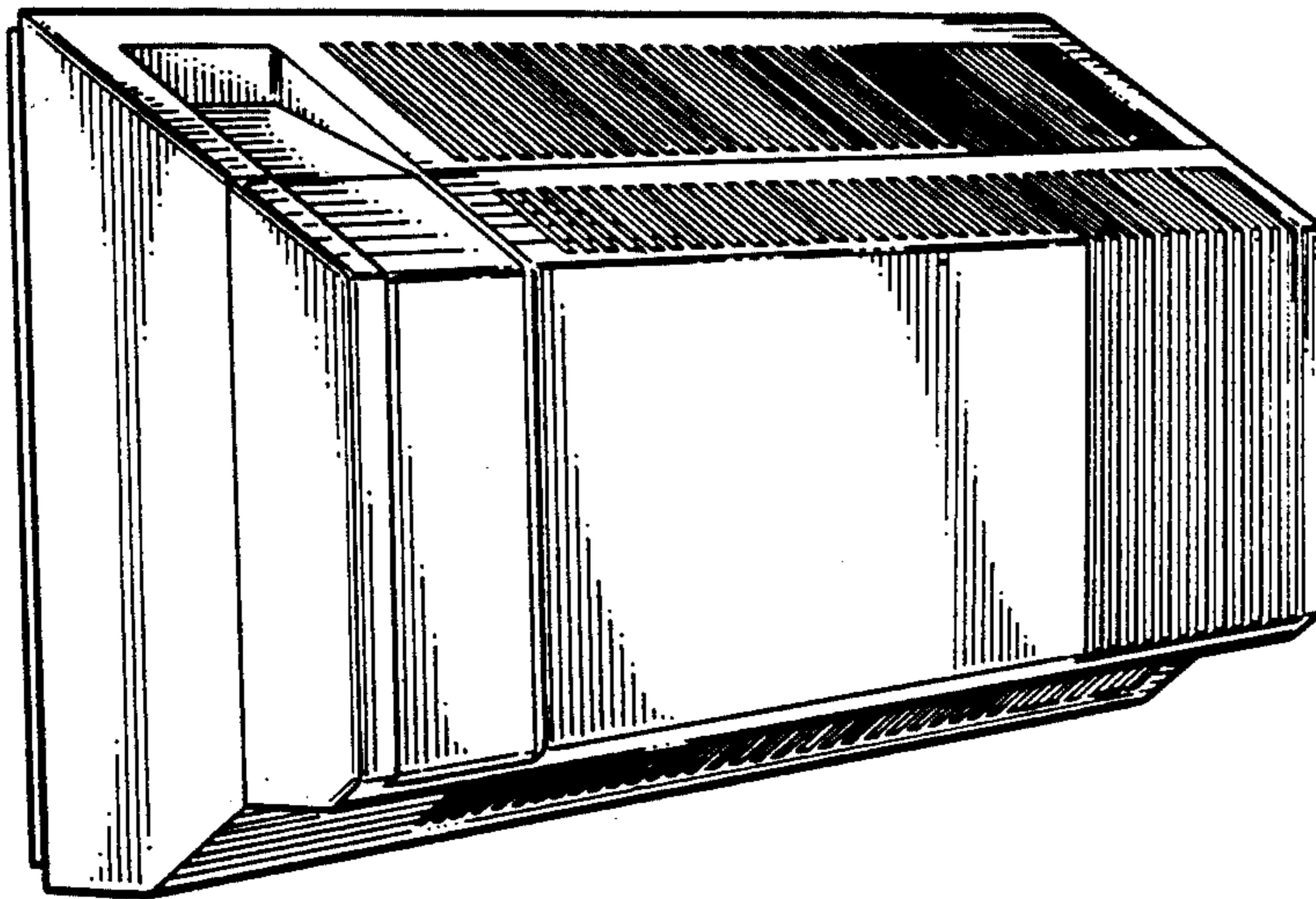

[57] CLAIM

The ornamental design for a controller housing with extender, as shown and described.

DESCRIPTION

FIG. 1 is a top, front and left side perspective view of a controller housing with extender, in a wall-mounted position, showing our new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a top plan view of the controller housing with extender; FIG. 4 is a bottom plan view thereof; and FIG. 5 is a right side elevational view thereof, the left side elevational view being identical.



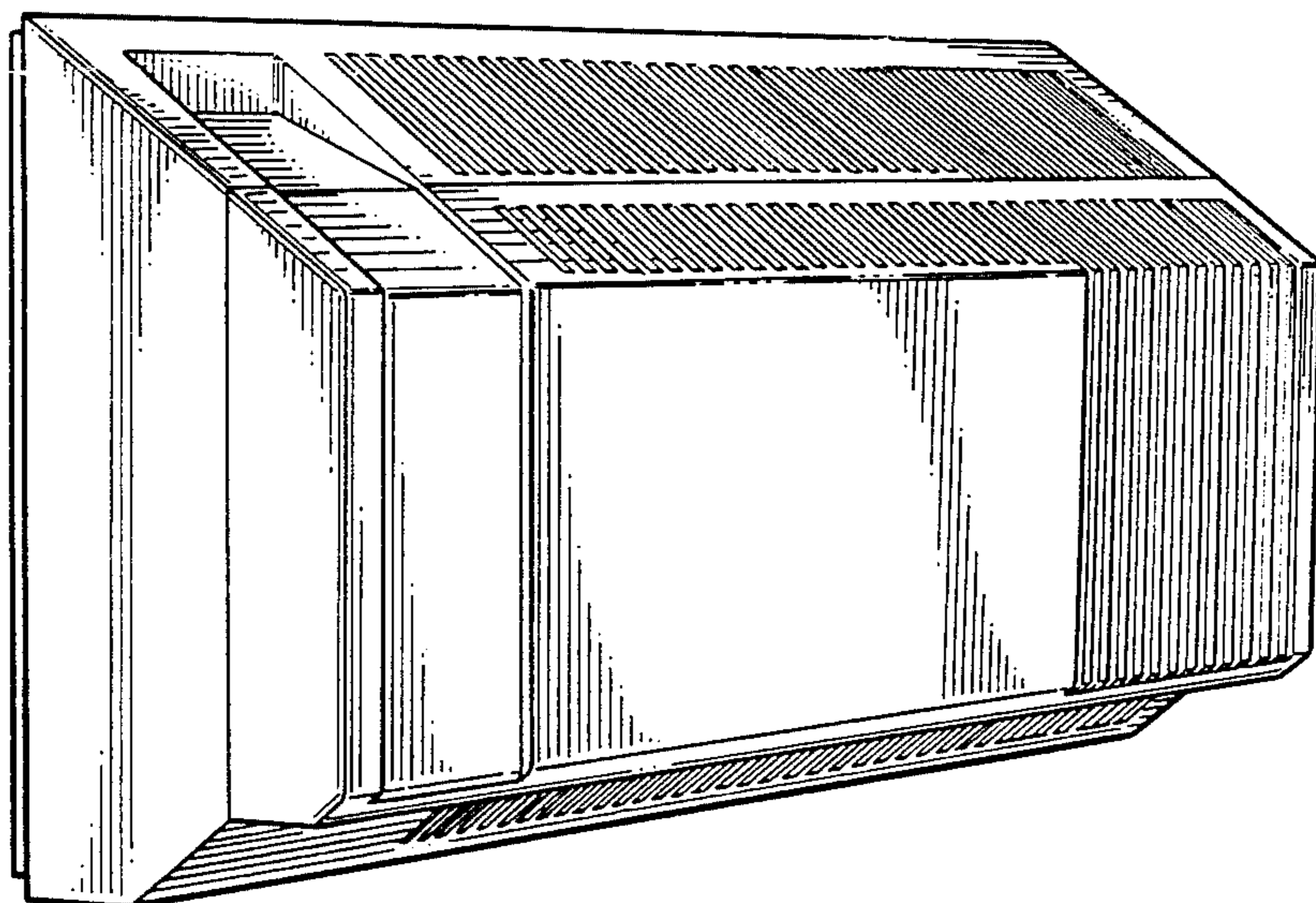

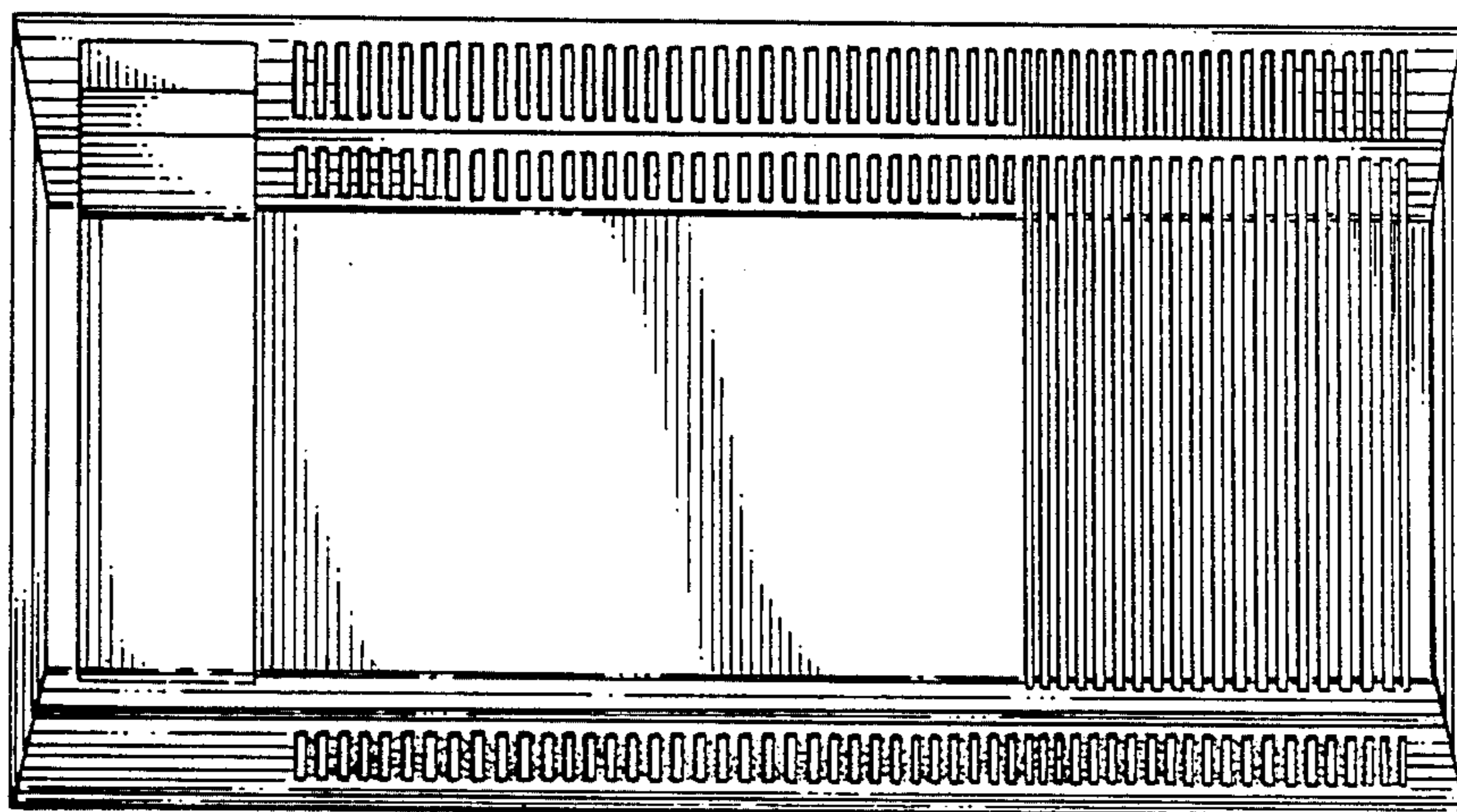

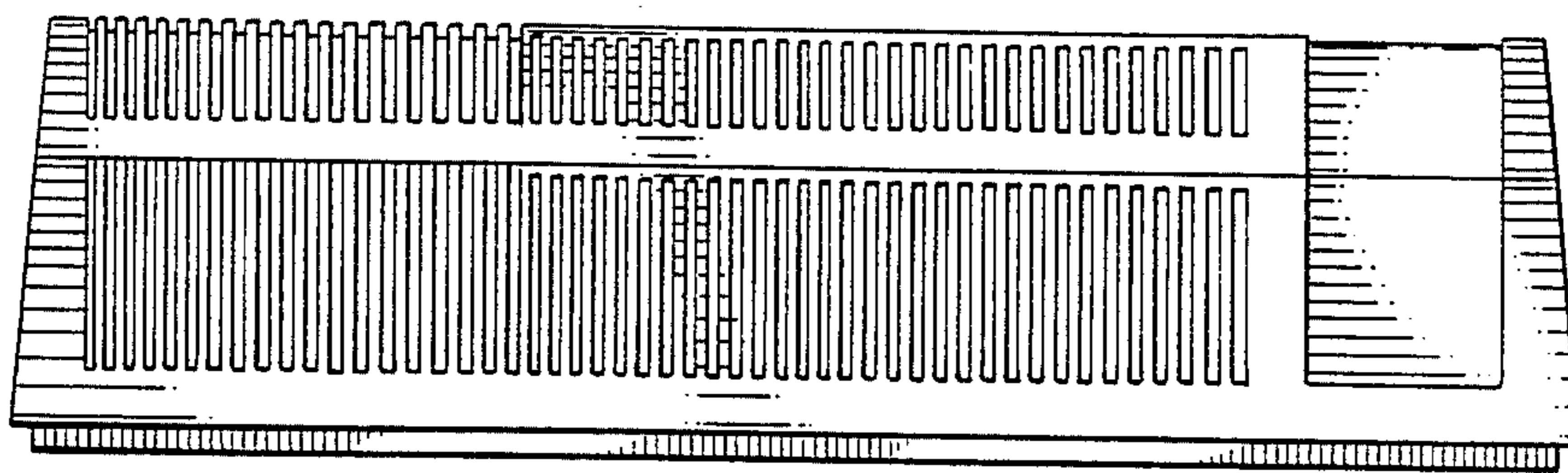

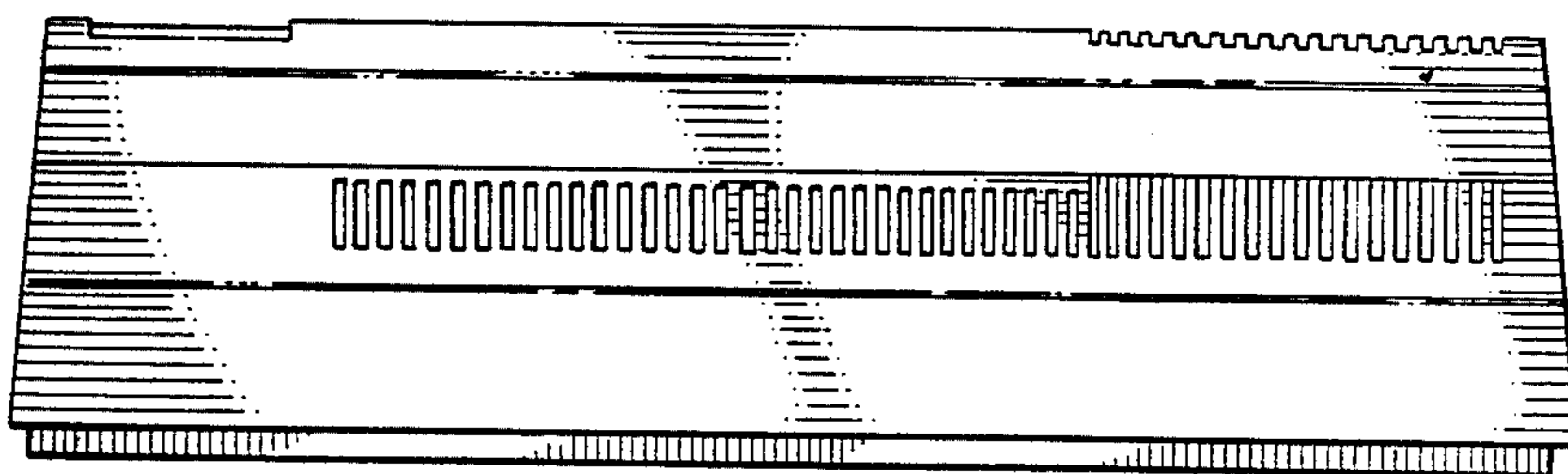

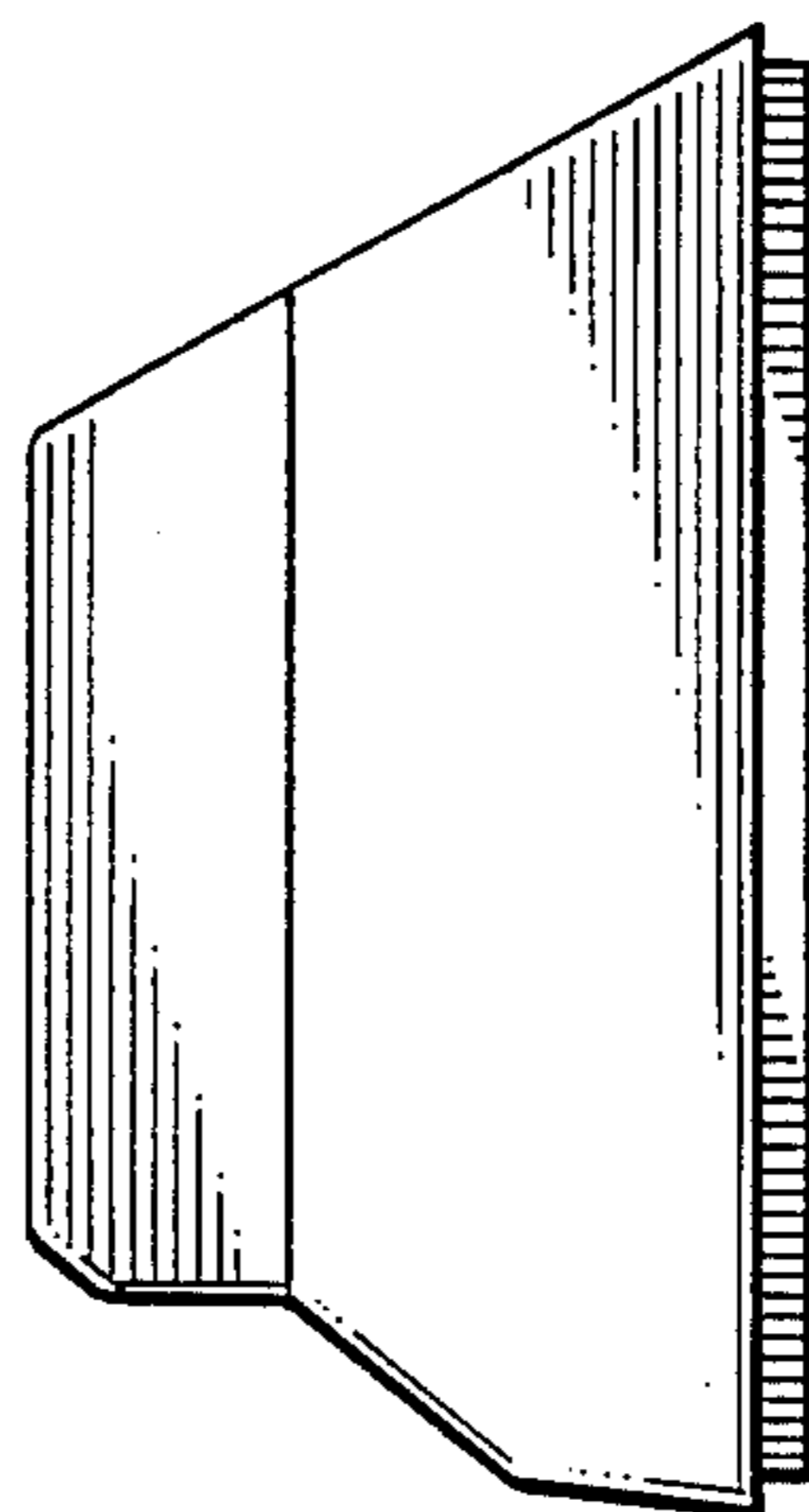
