FIG. 2 is a front elevational view thereof.

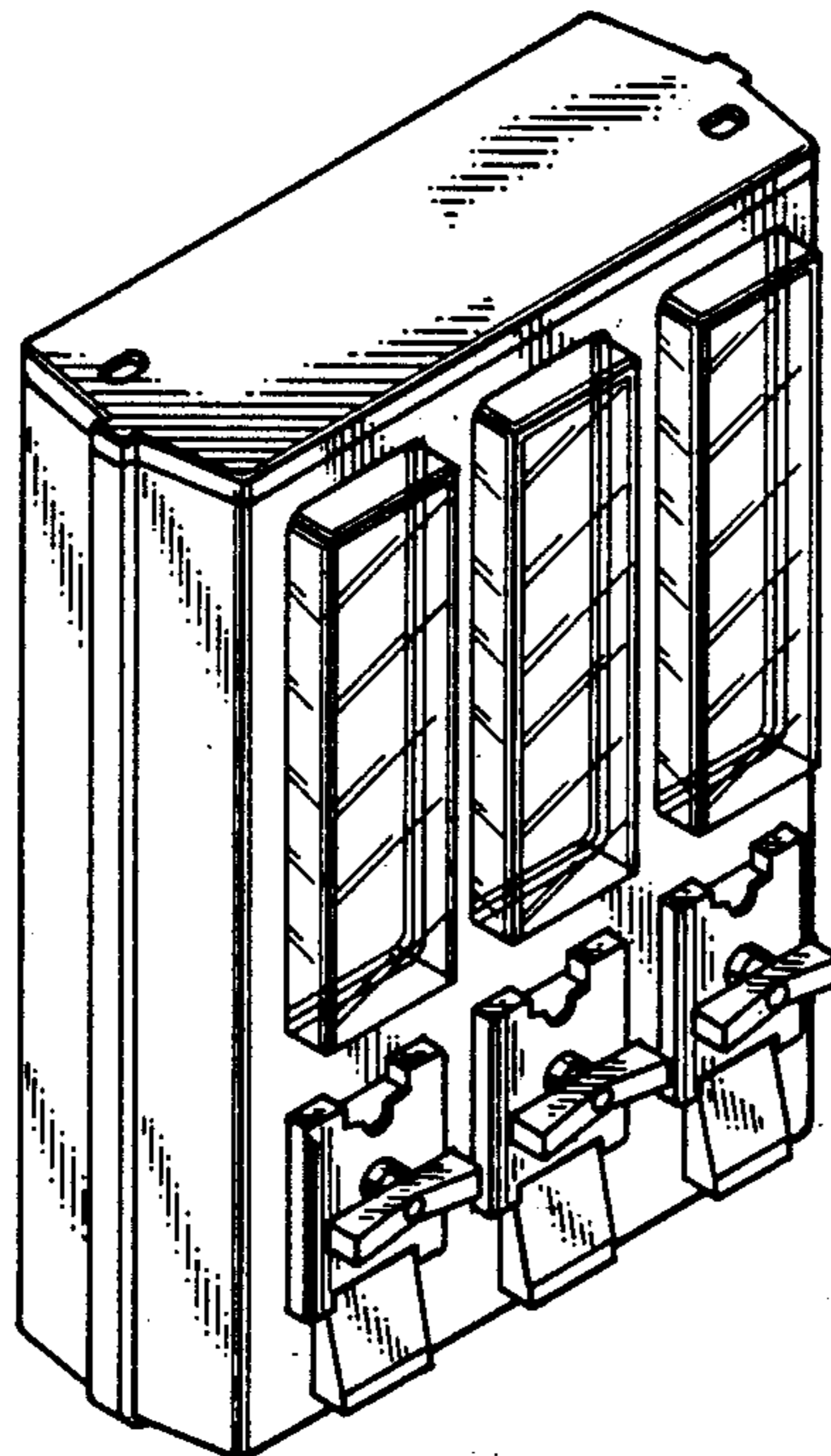
FIG. 3 is a rear elevational view thereof.

FIG. 7 is a bottom plan view thereof.



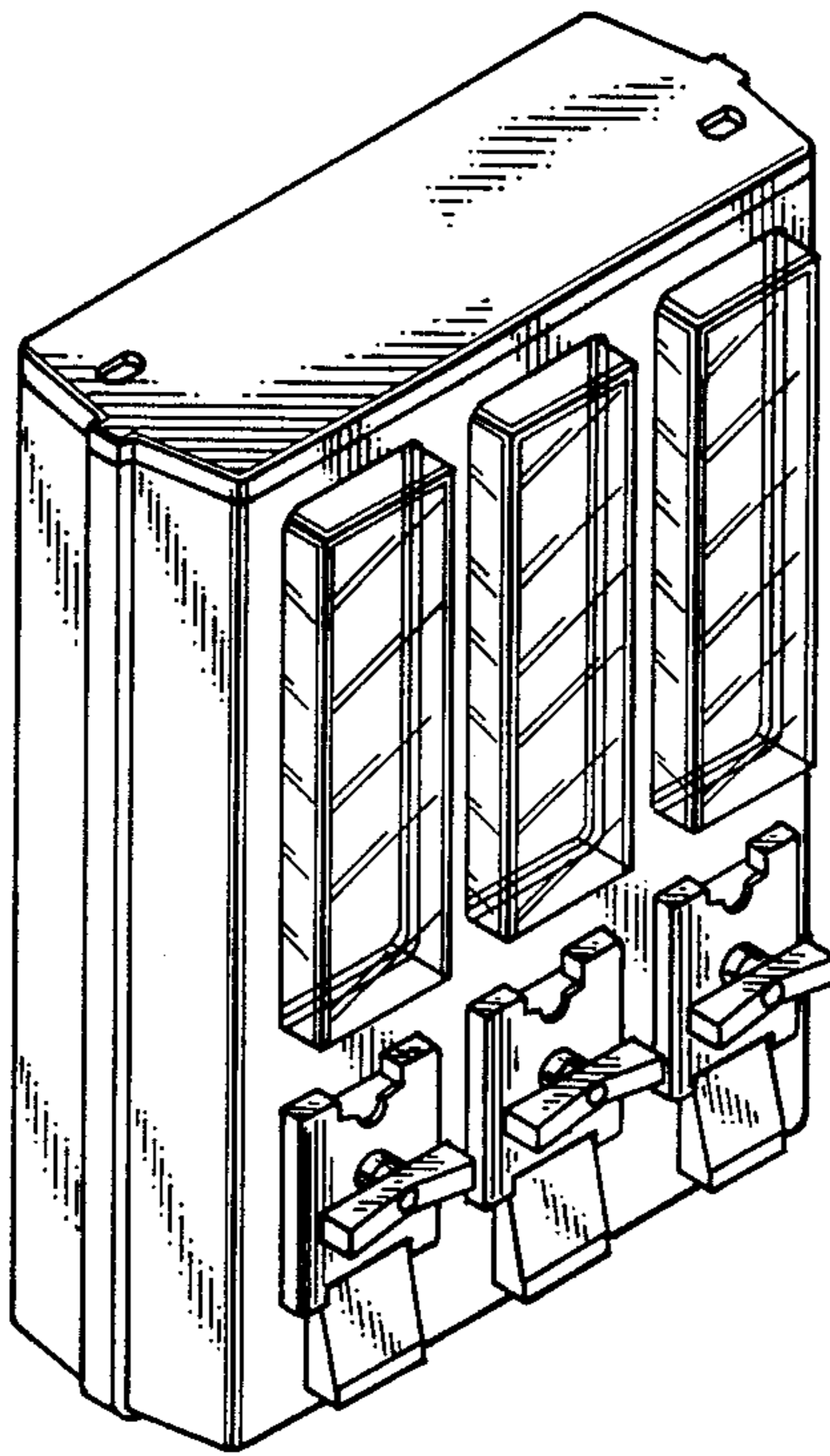

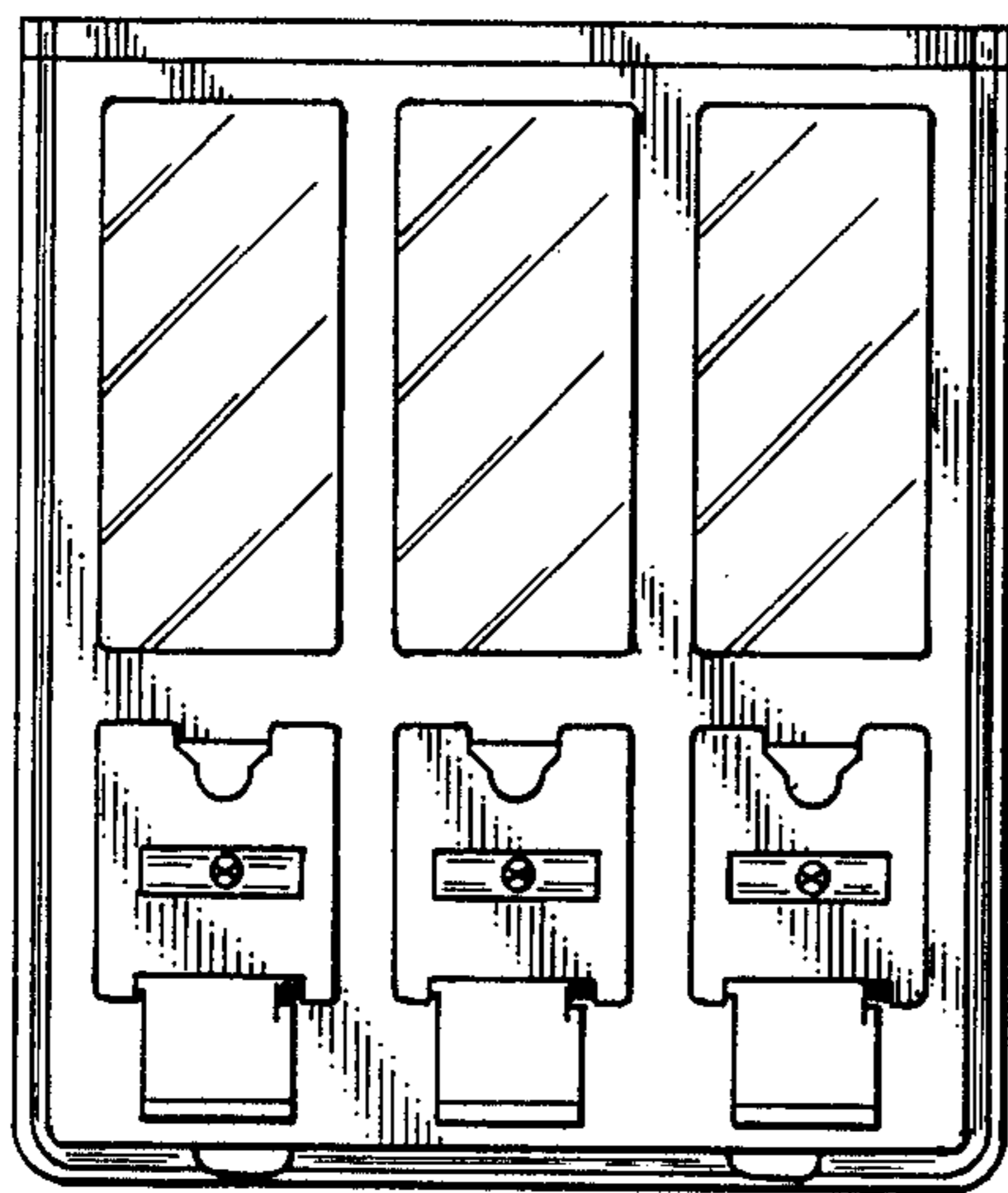

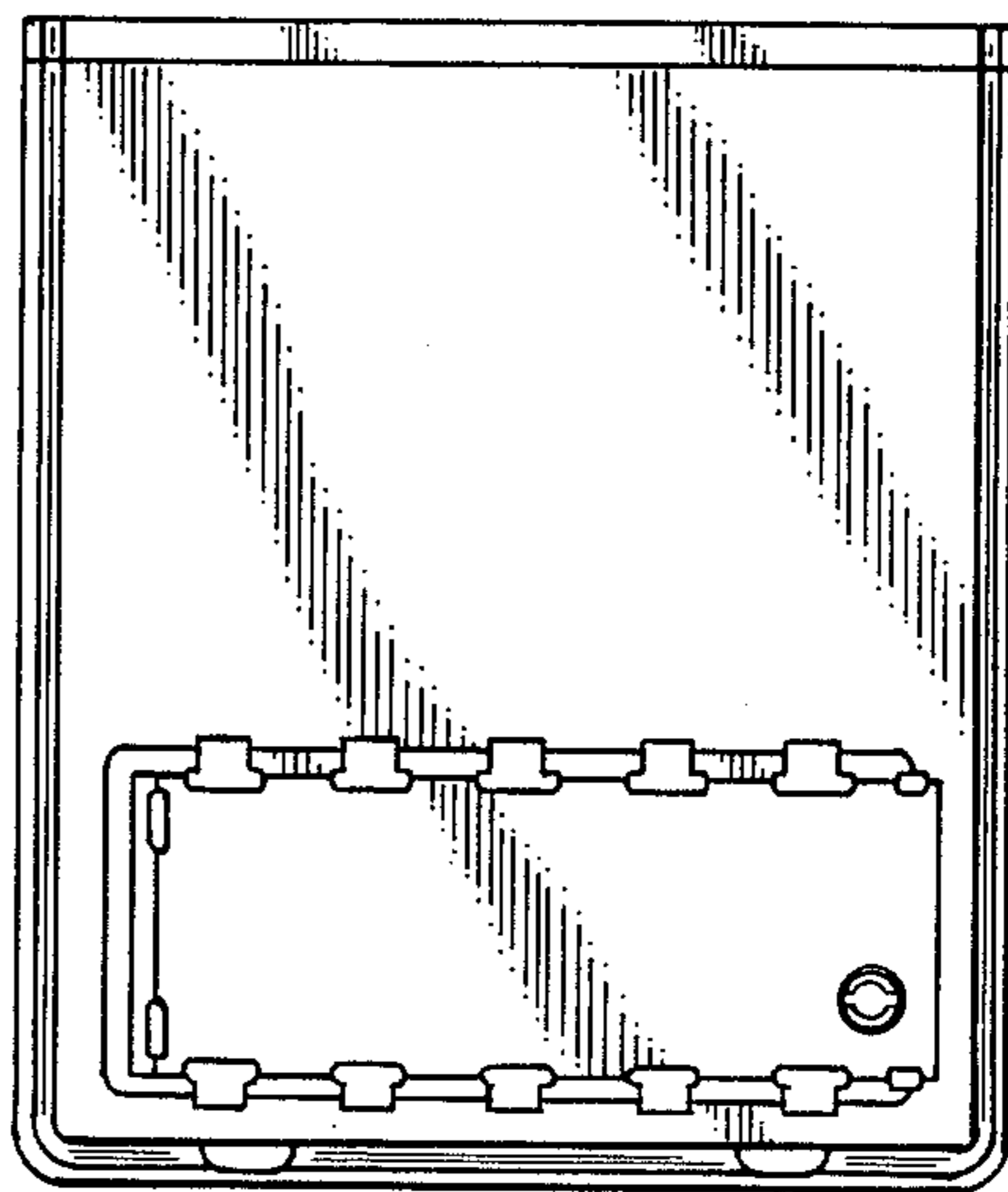

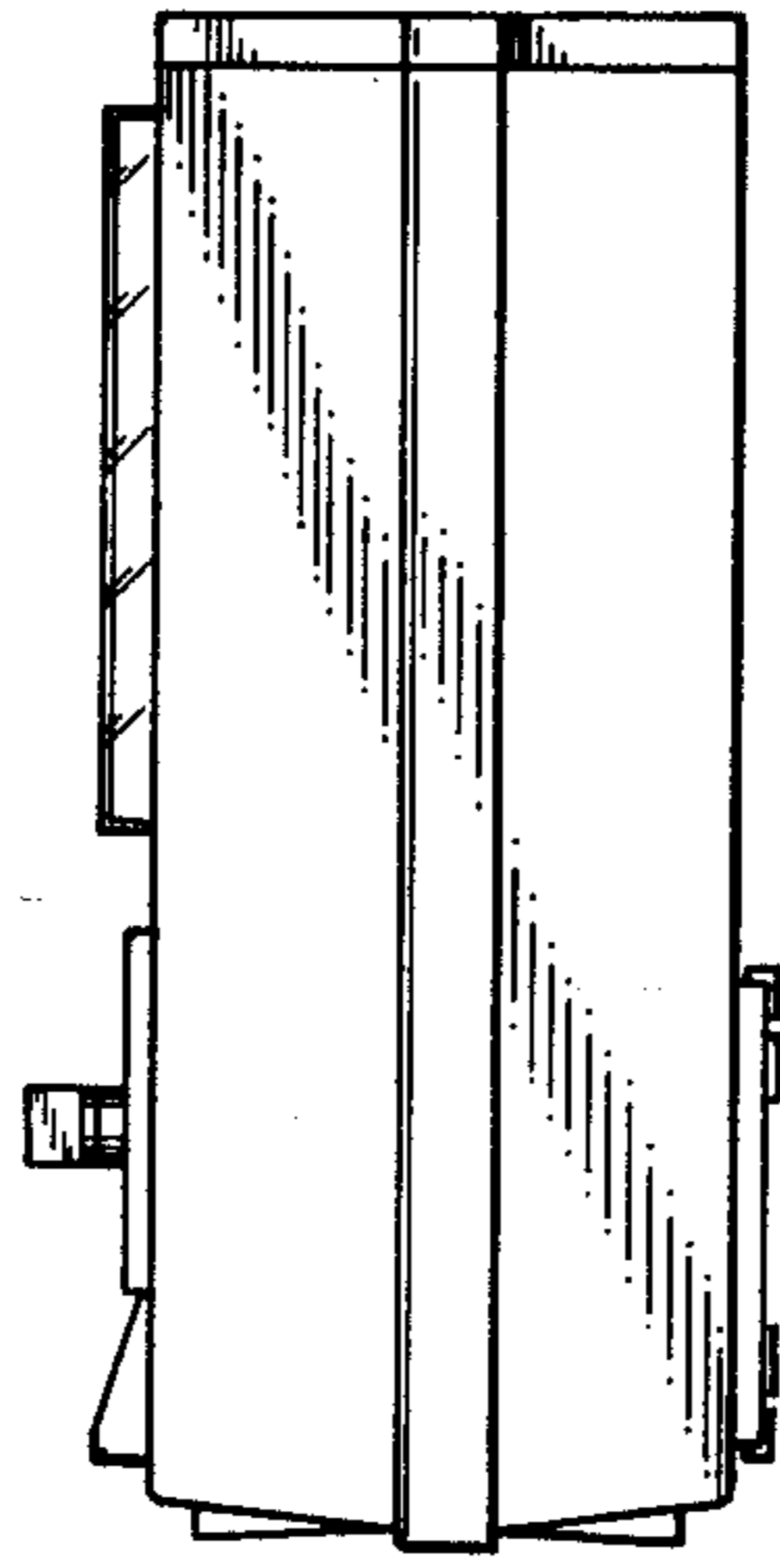

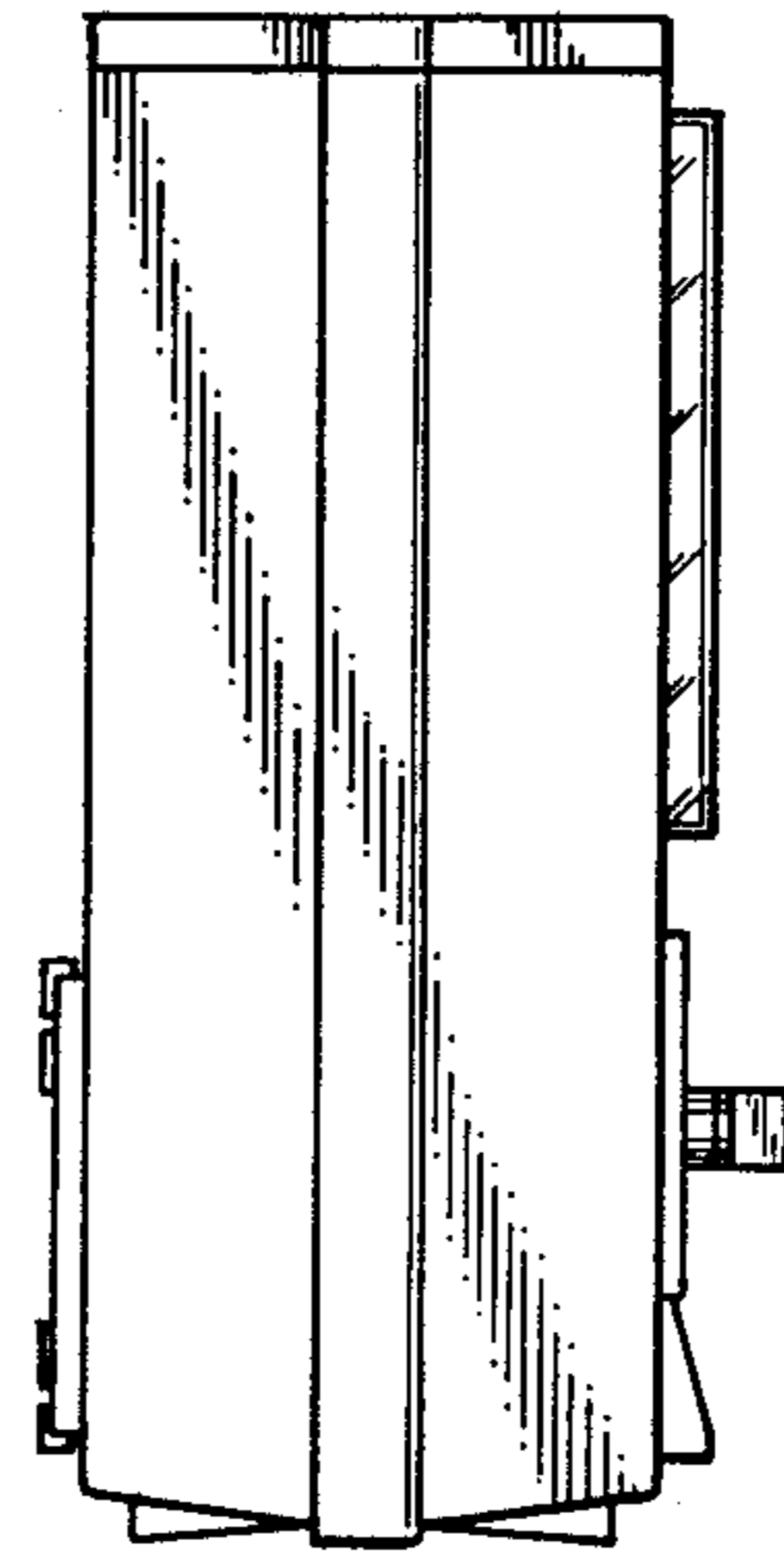

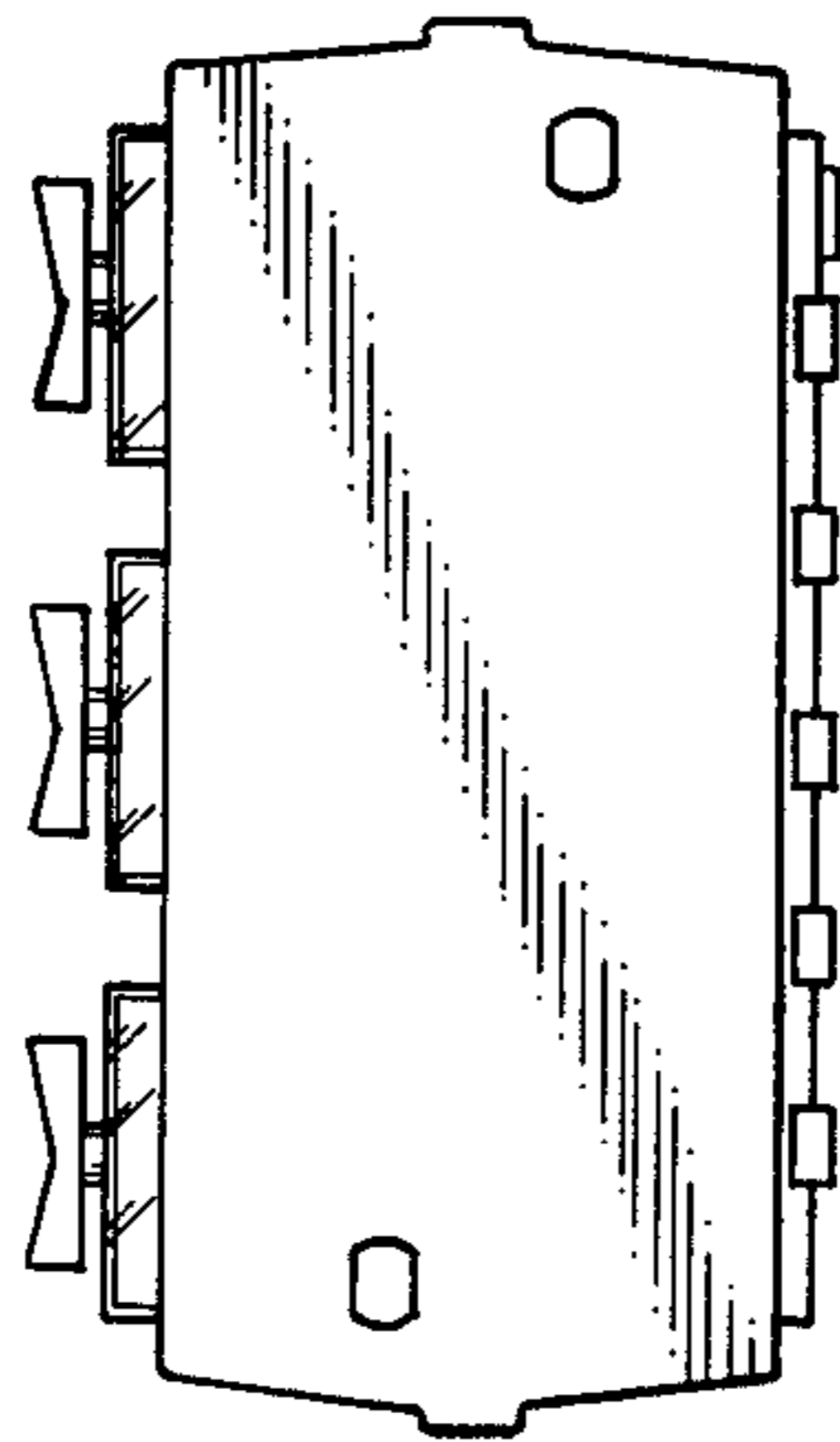

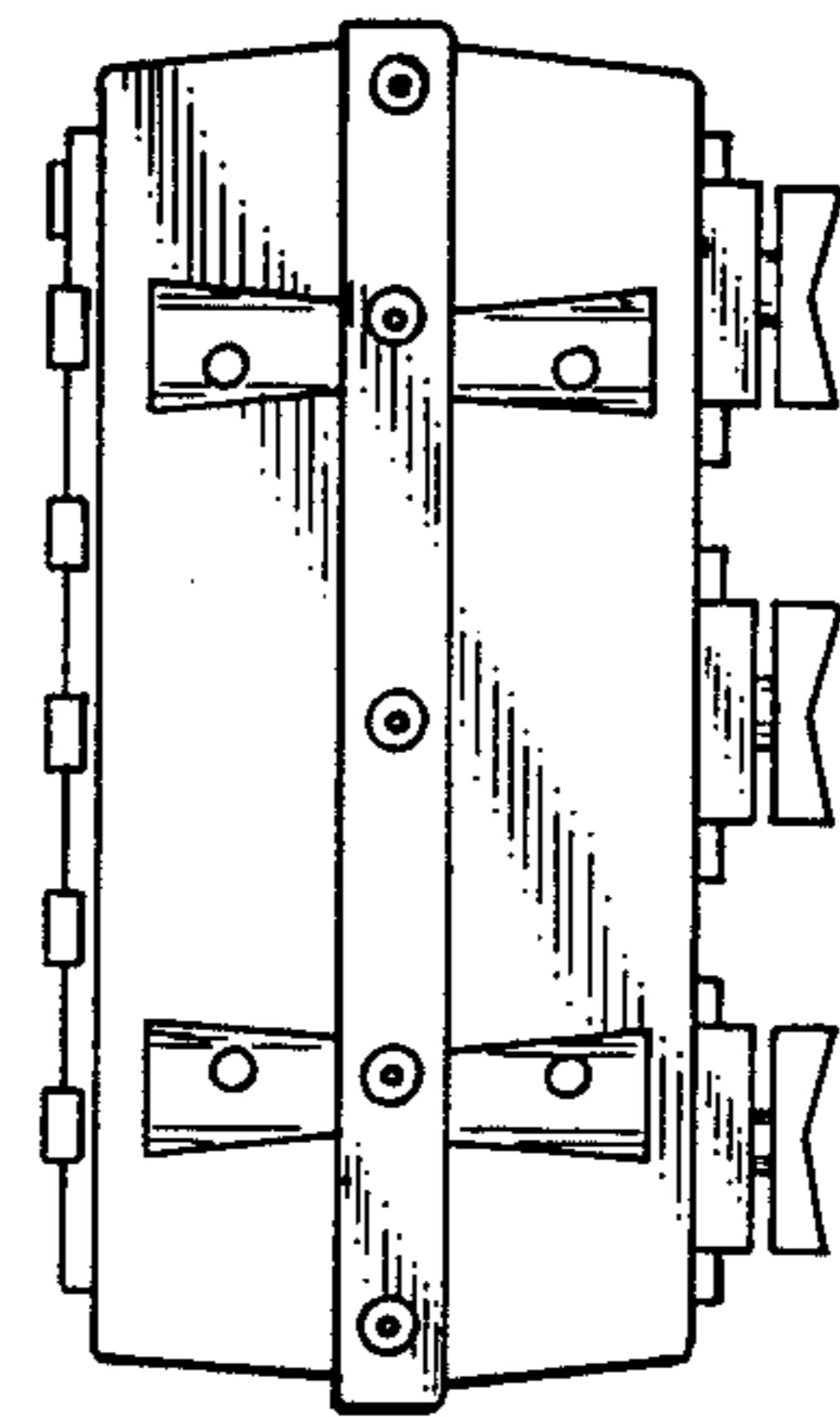
