[57] CLAIM

The ornamental design for a two piece container cap, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a two piece container cap showing my new design;
FIG. 2 is a rear elevational view thereof;
FIG. 3 is a right side elevational view thereof, and the left side elevational view is identical;
FIG. 4 is a top plan view thereof;
FIG. 5 is a perspective view thereof;
FIG. 6 is a front elevational view of the outer cap, shown separately for clarity of illustration;
FIG. 7 is a bottom plan view of FIG. 6;
FIG. 8 is a front elevational view of the inner cap, shown separately for clarity of illustration;
FIG. 9 is a rear elevational view of FIG. 8;
FIG. 10 is a left side elevational view of FIG. 8;
FIG. 11 is a right side elevational view of FIG. 8;
FIG. 12 is a top plan view of FIG. 8; and
FIG. 13 is a bottom plan view of FIG. 8.

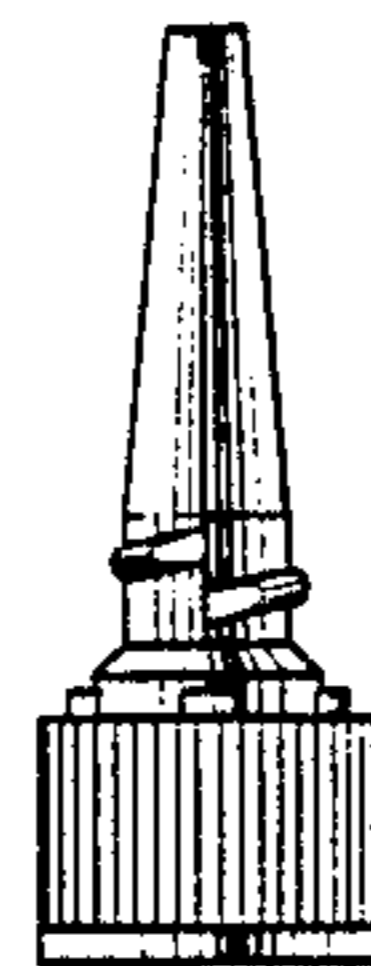

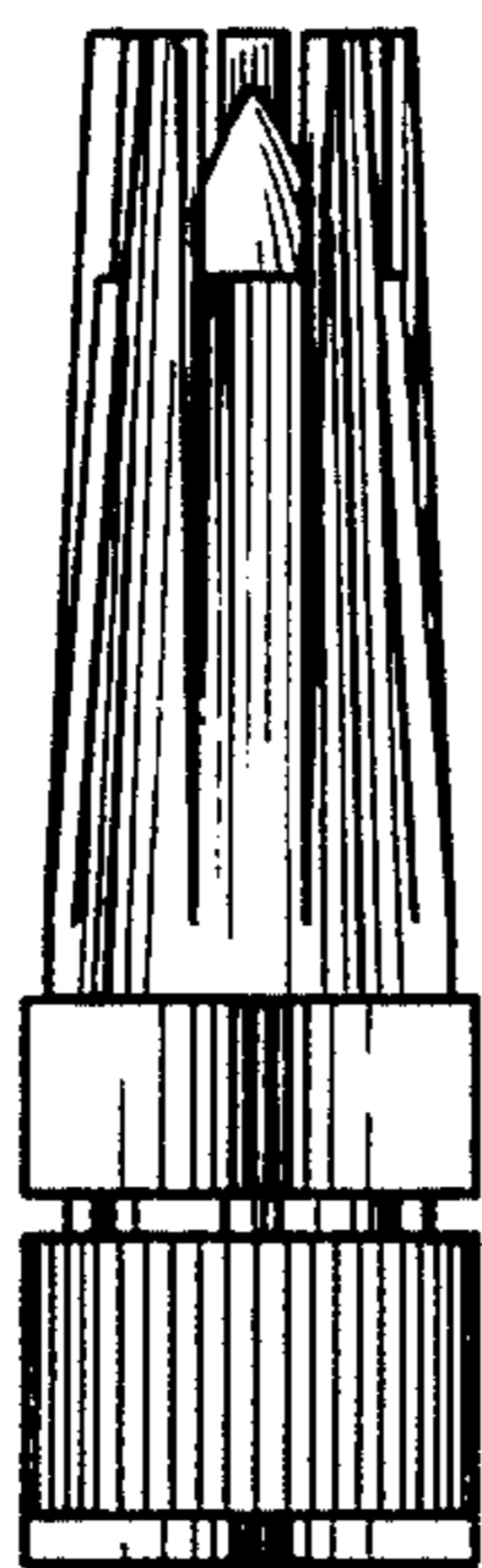

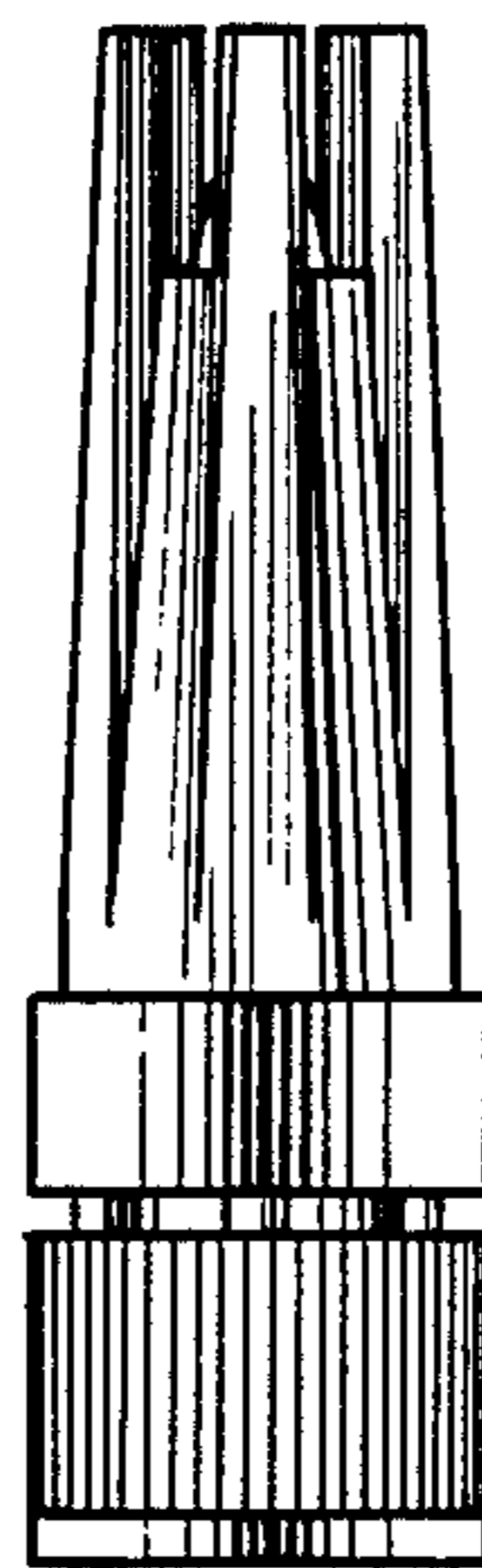

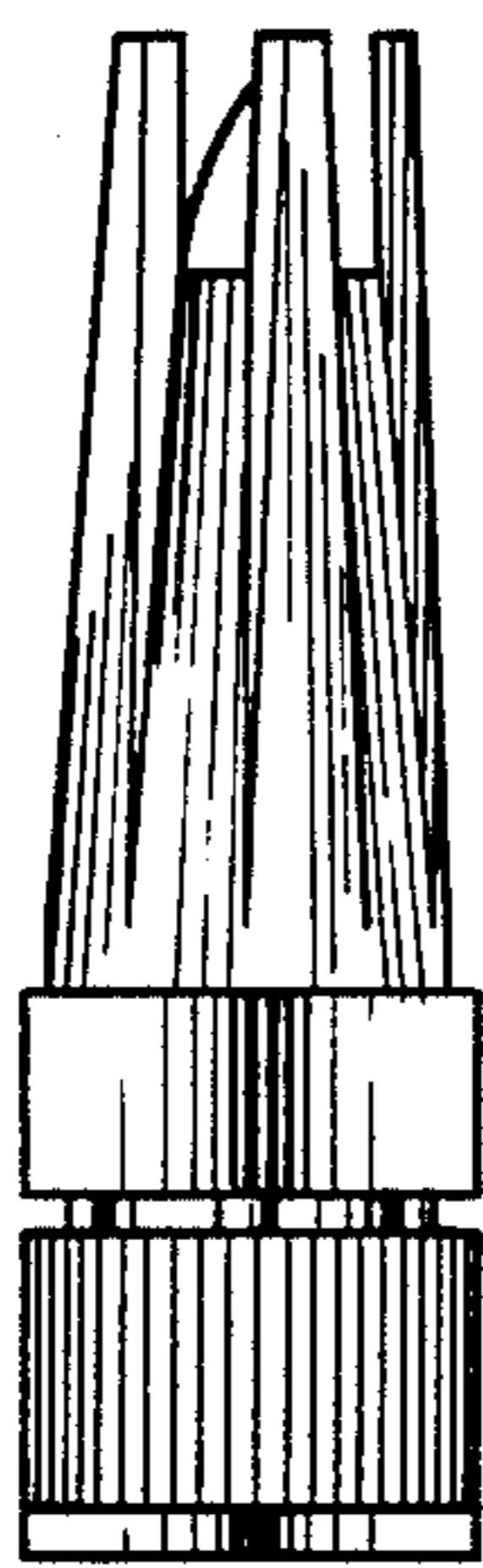

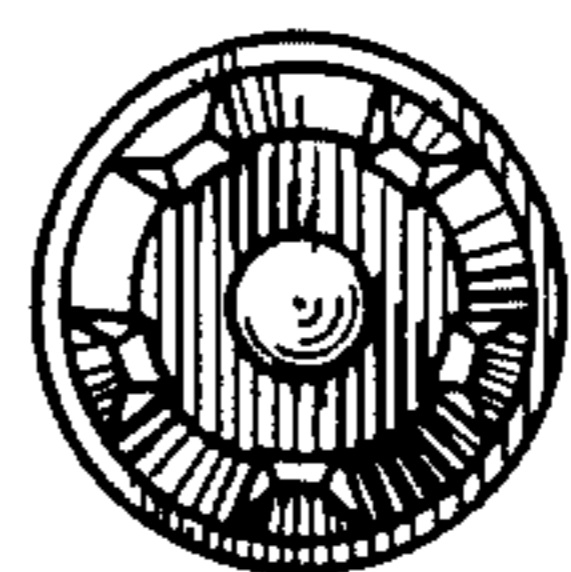

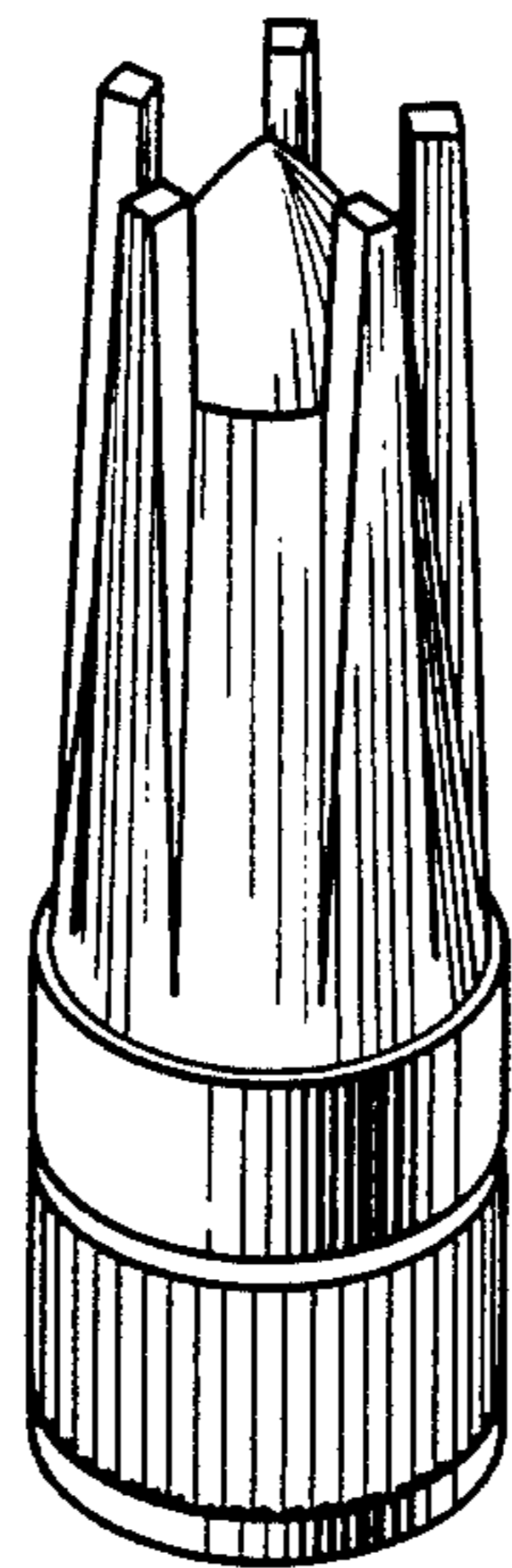

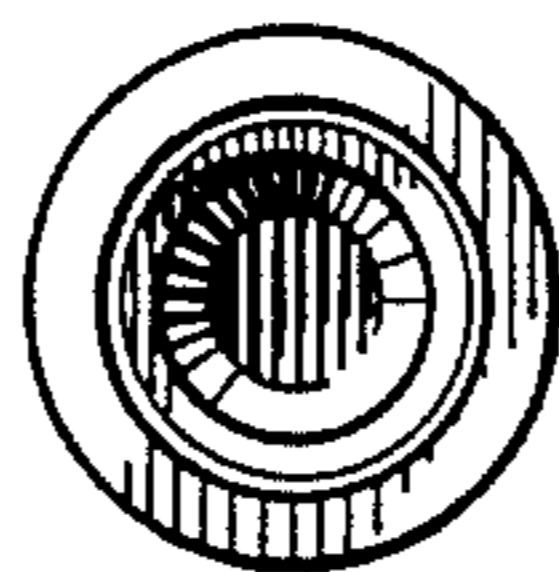

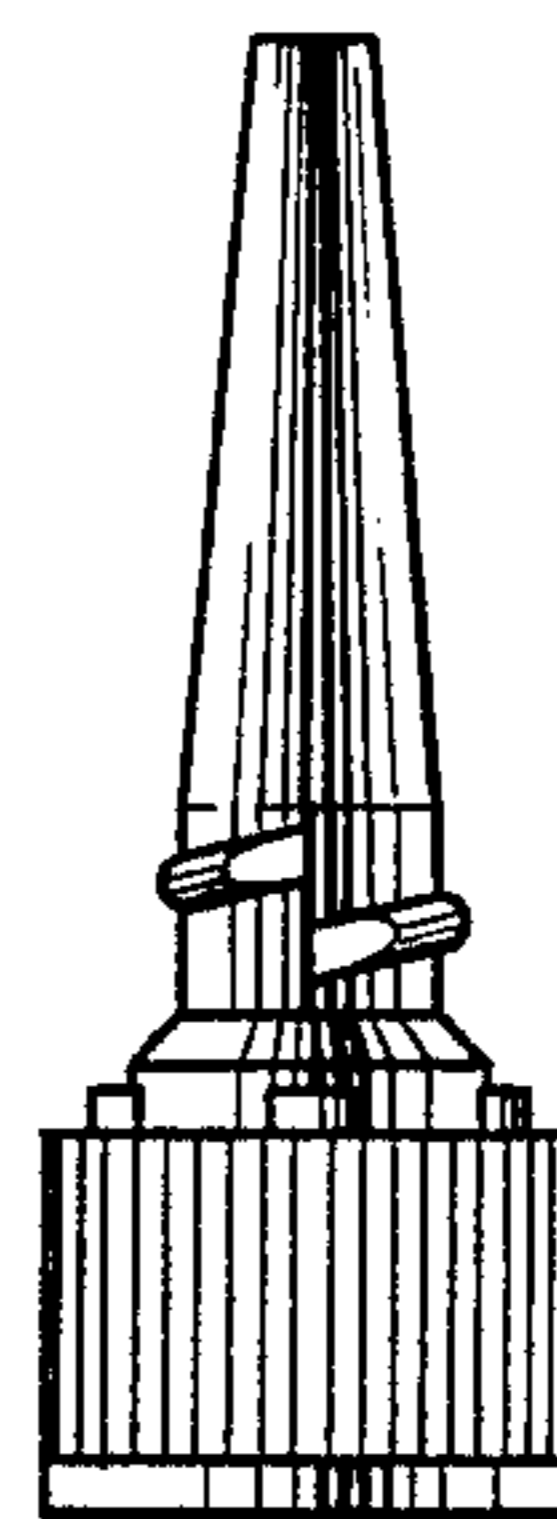

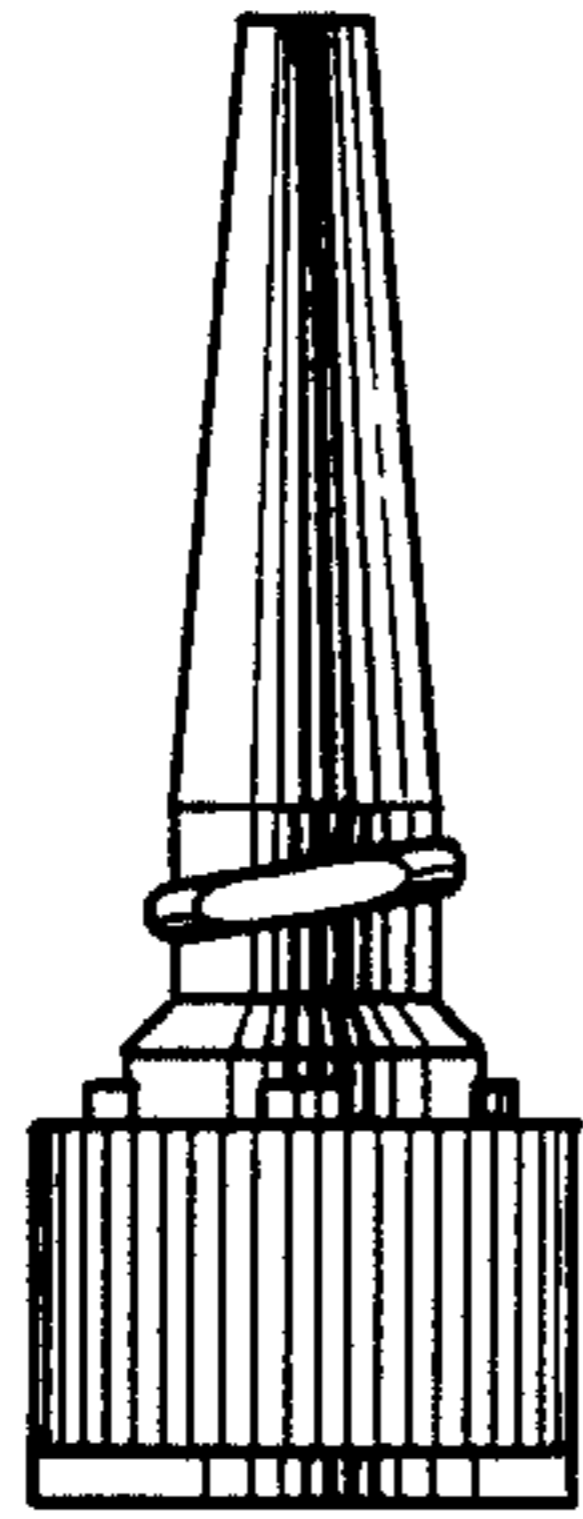

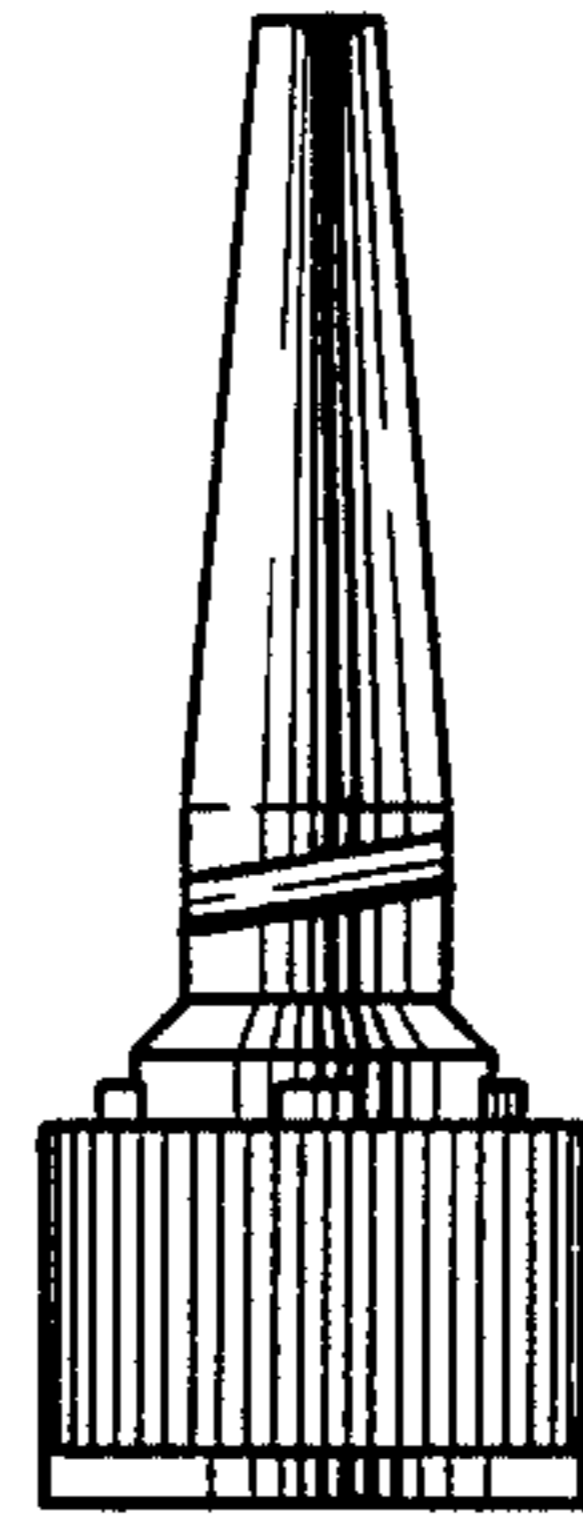

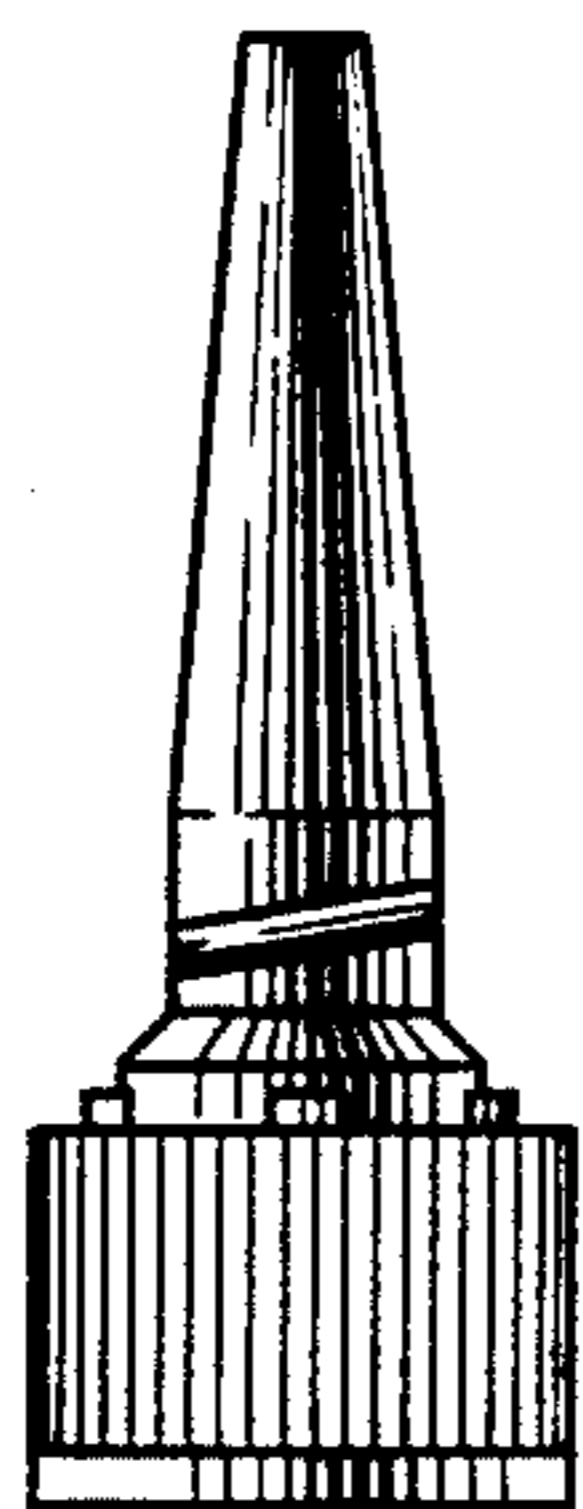

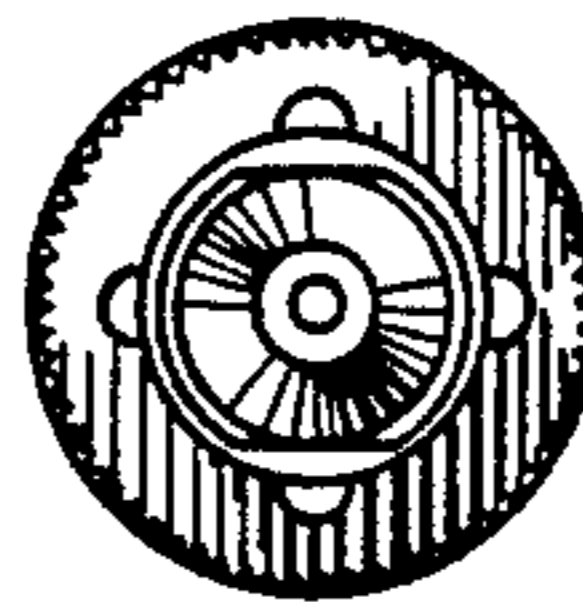
