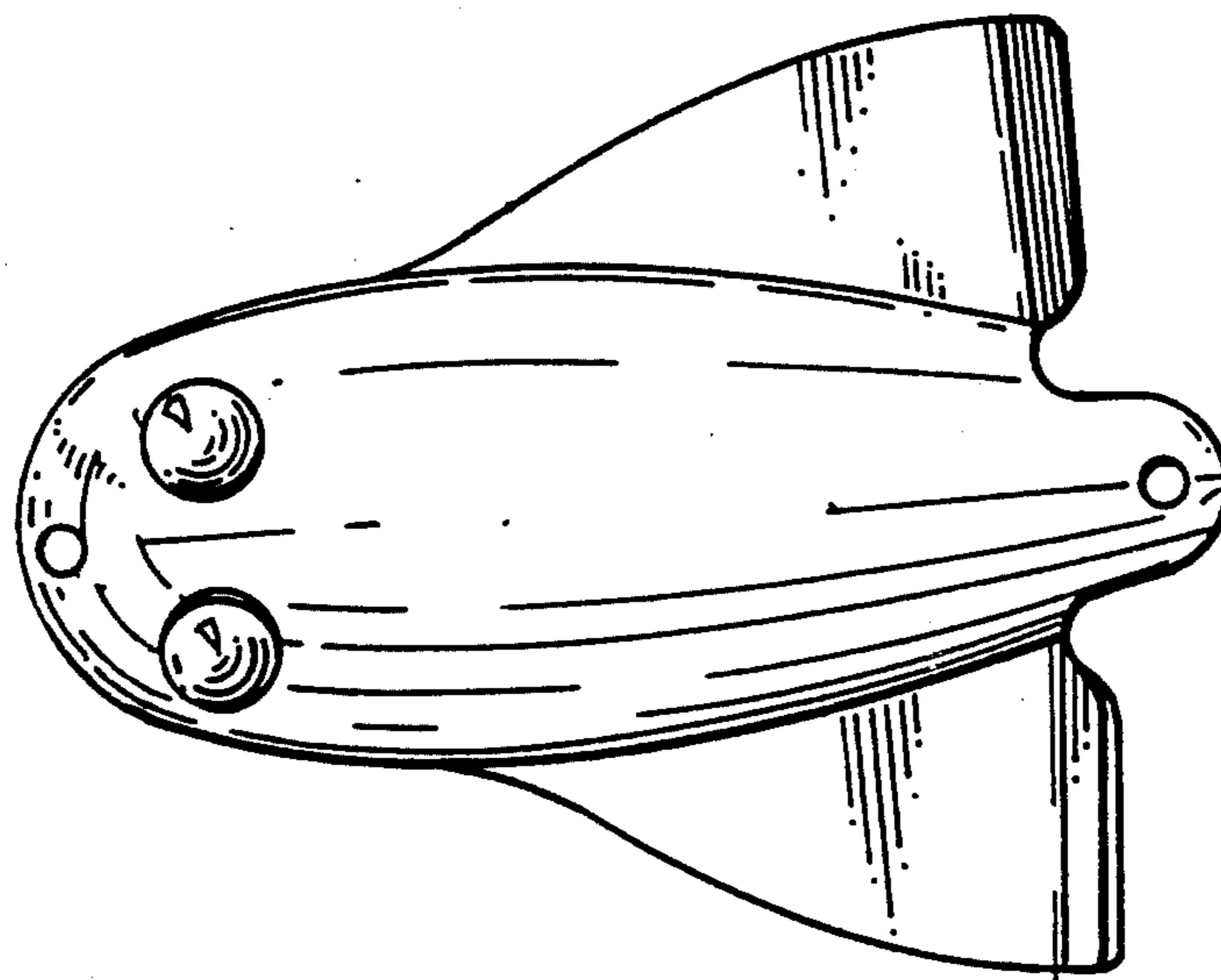

DESCRIPTION

FIG. 10 is a rear elevational view thereof.



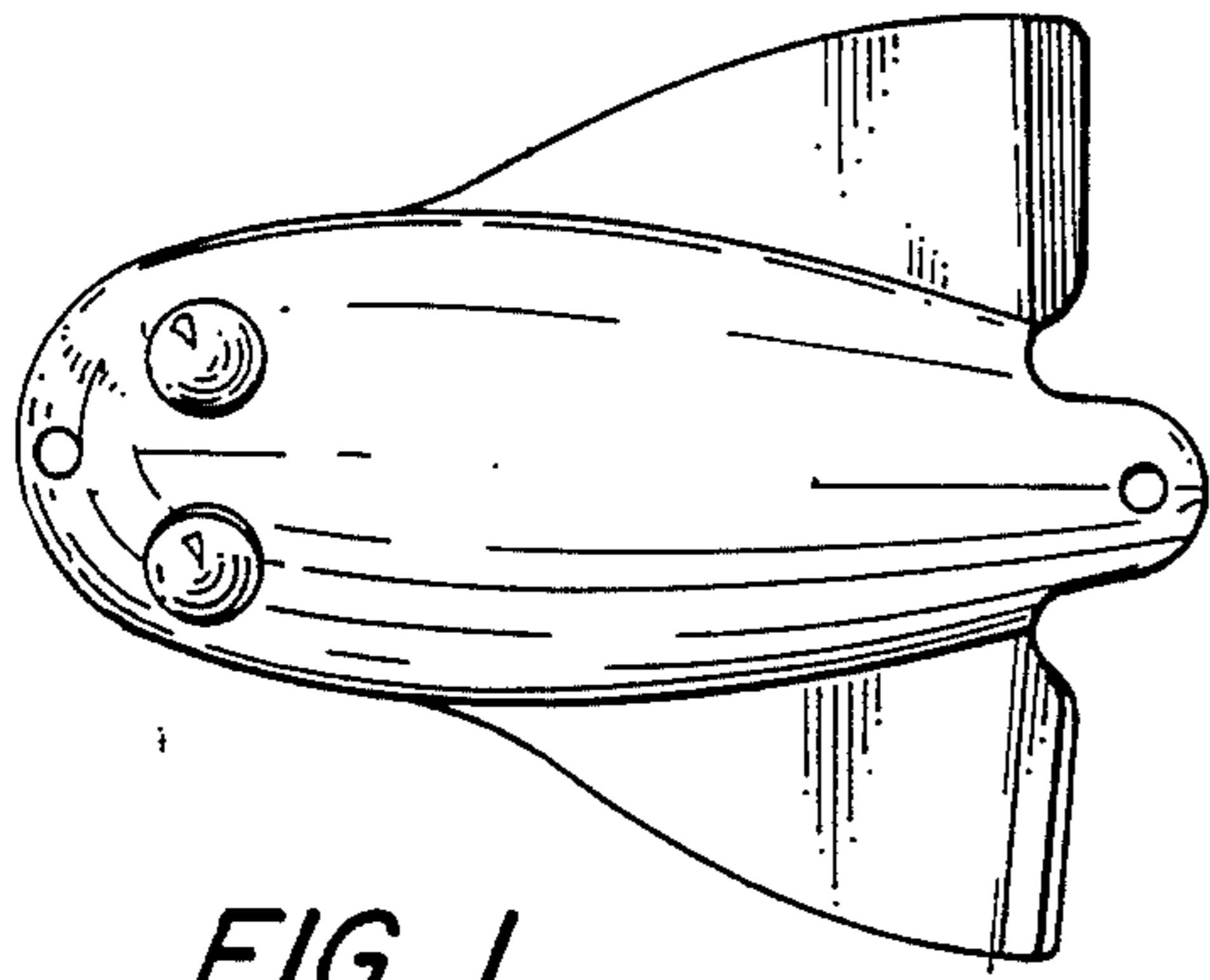

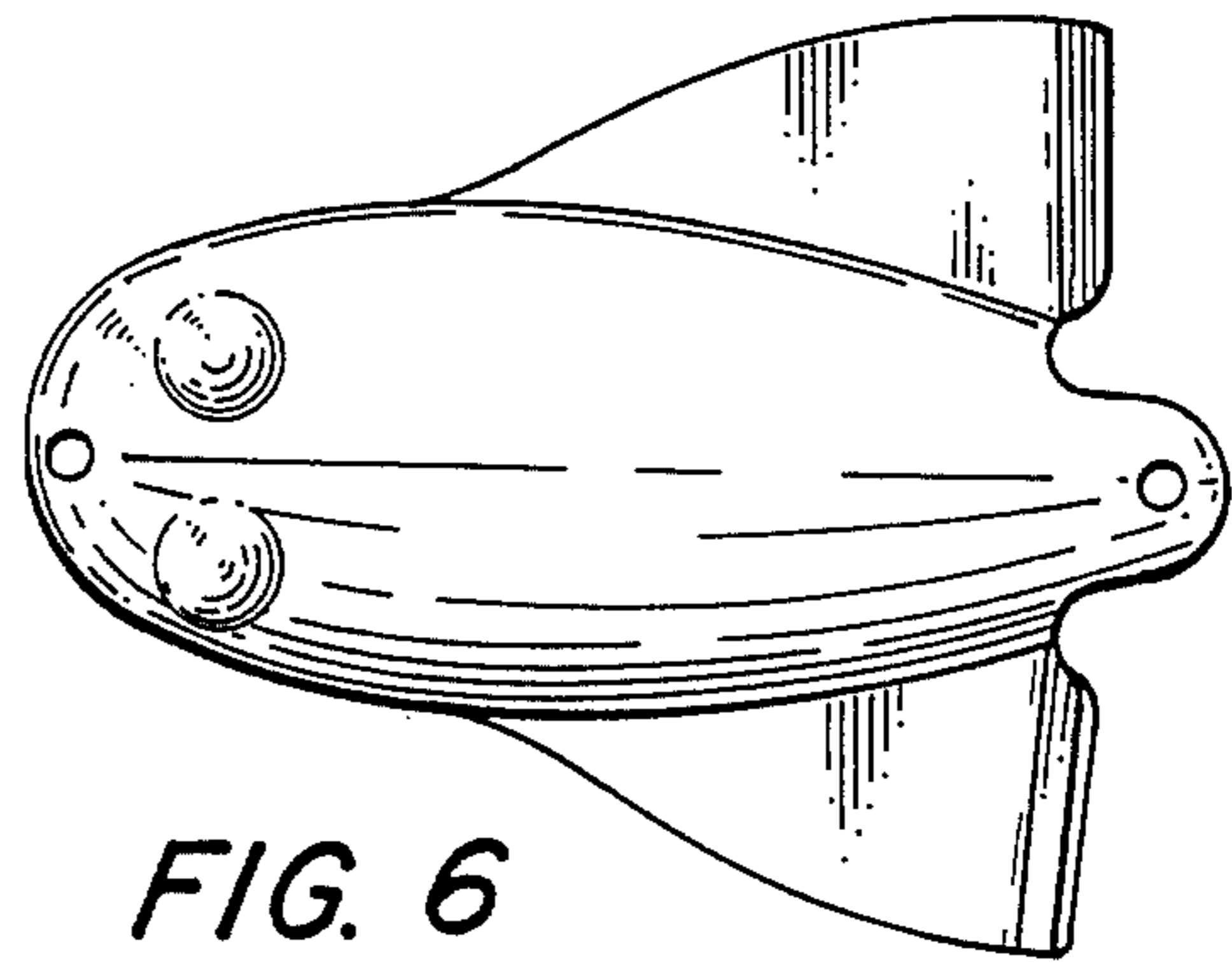

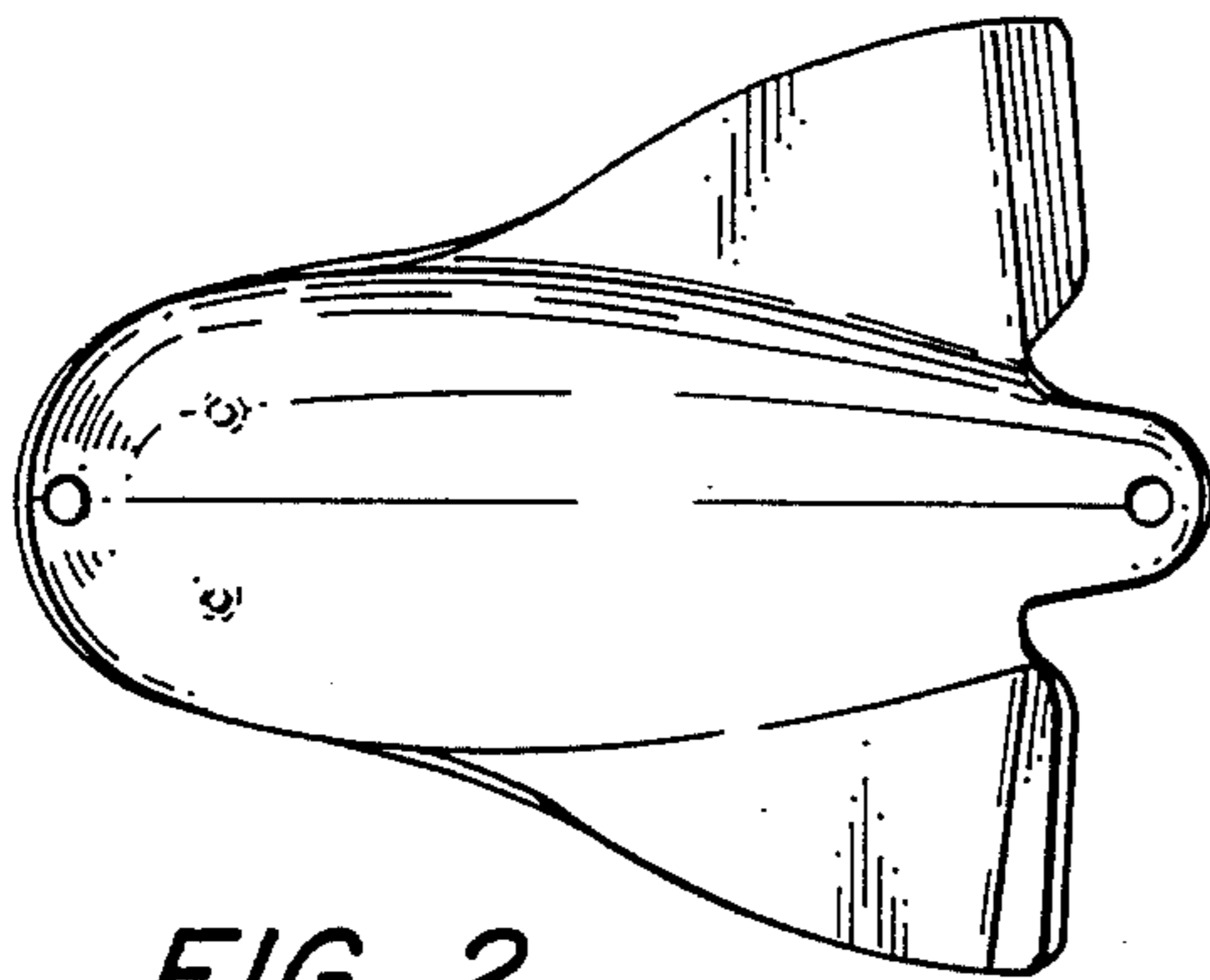

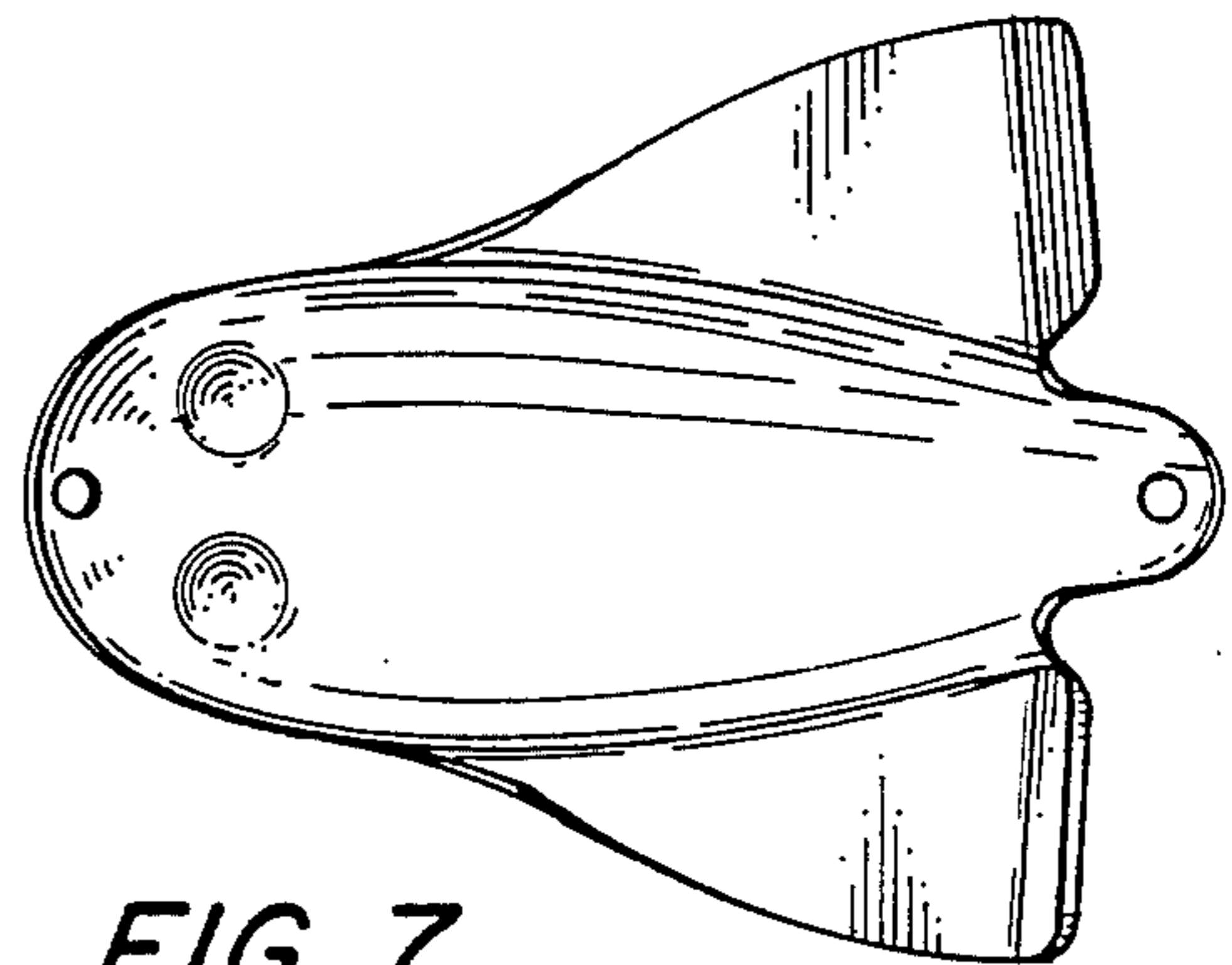

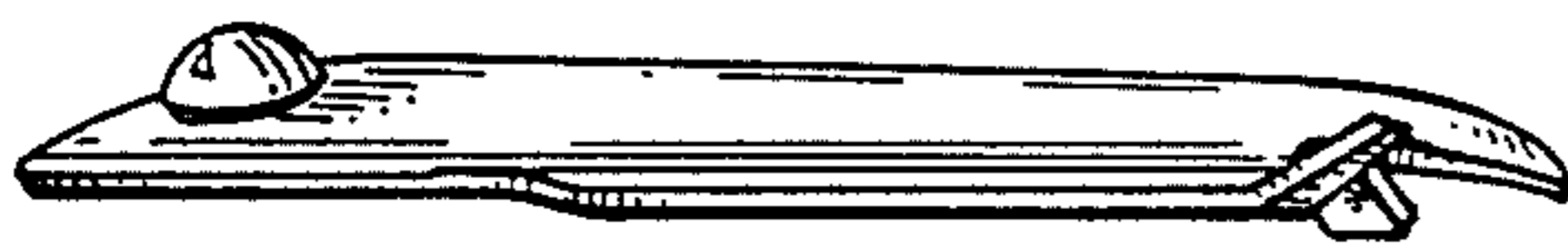

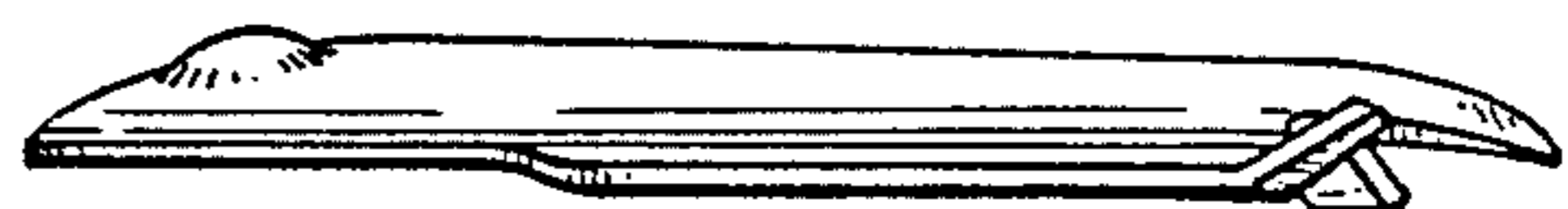
