[57] **CLAIM**

DESCRIPTION

FIG. 1 is a front elevational view of a wristwatch dial showing our new design; and
 FIG. 2 is a typical side elevational view thereof, the rear being flat, plain and unornamented.
 FIG. 3 is a cross-sectional view thereof as taken from line 3-3 of FIG. 1.

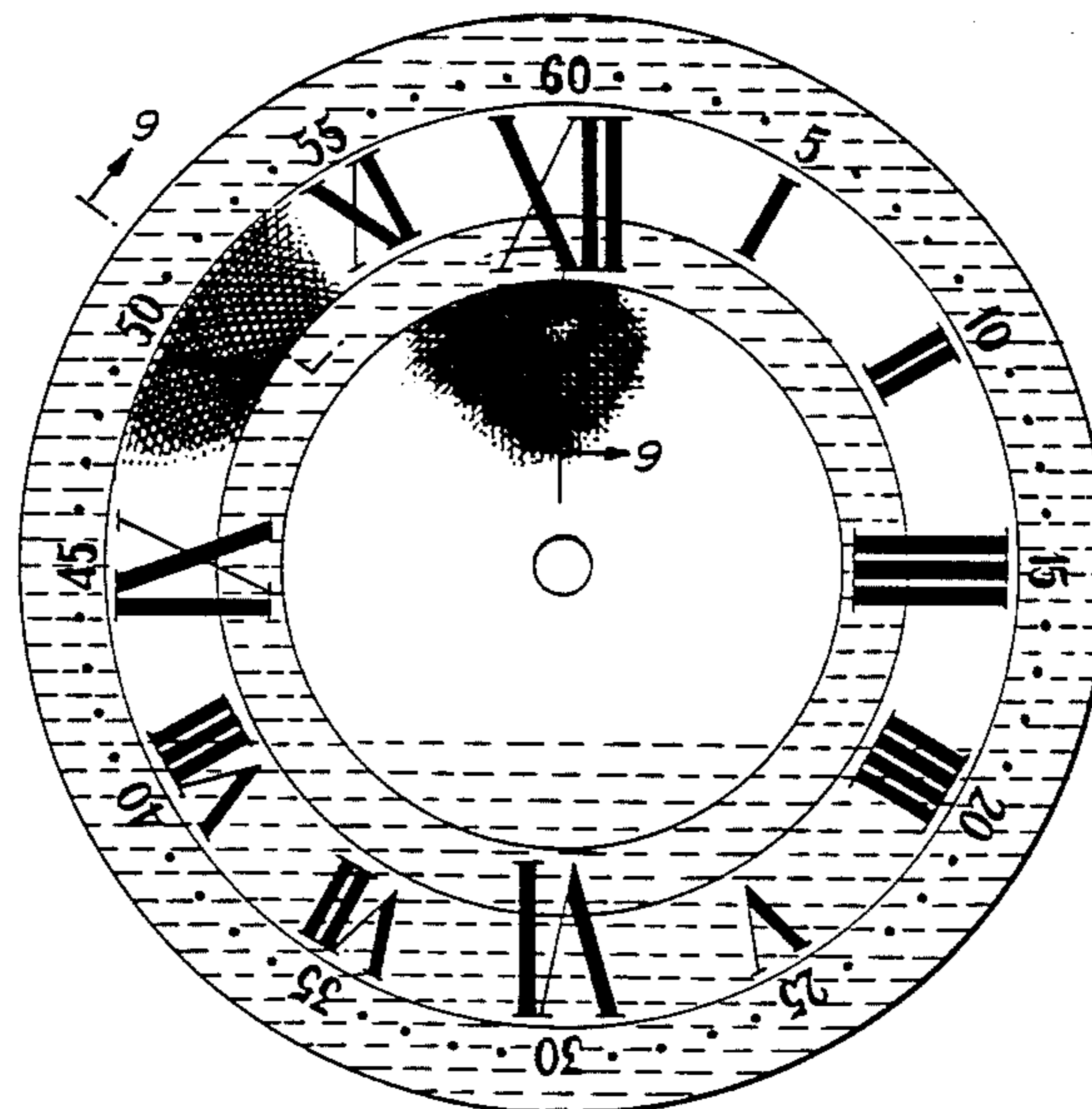

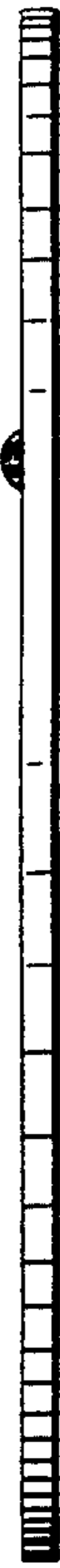
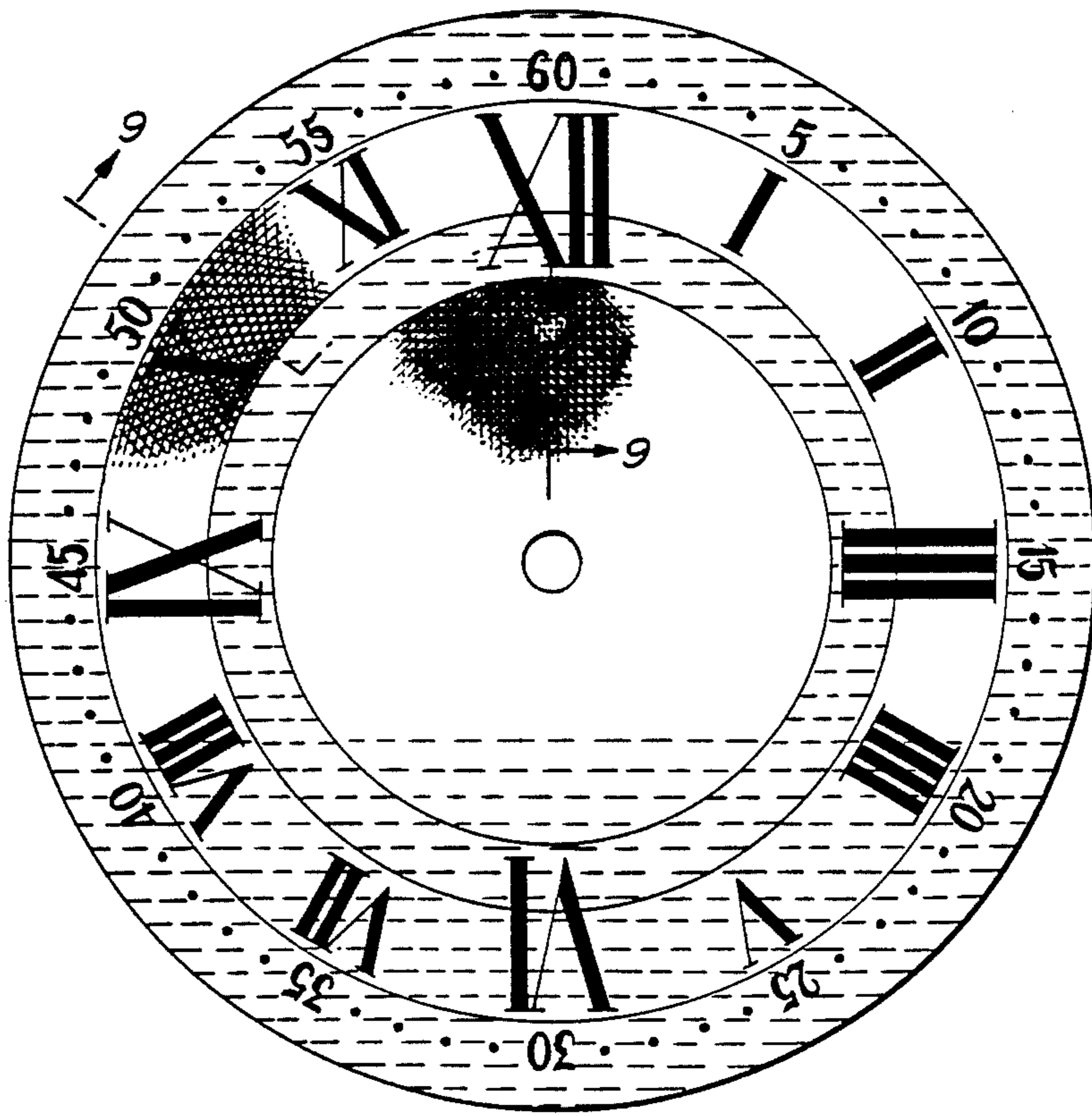
