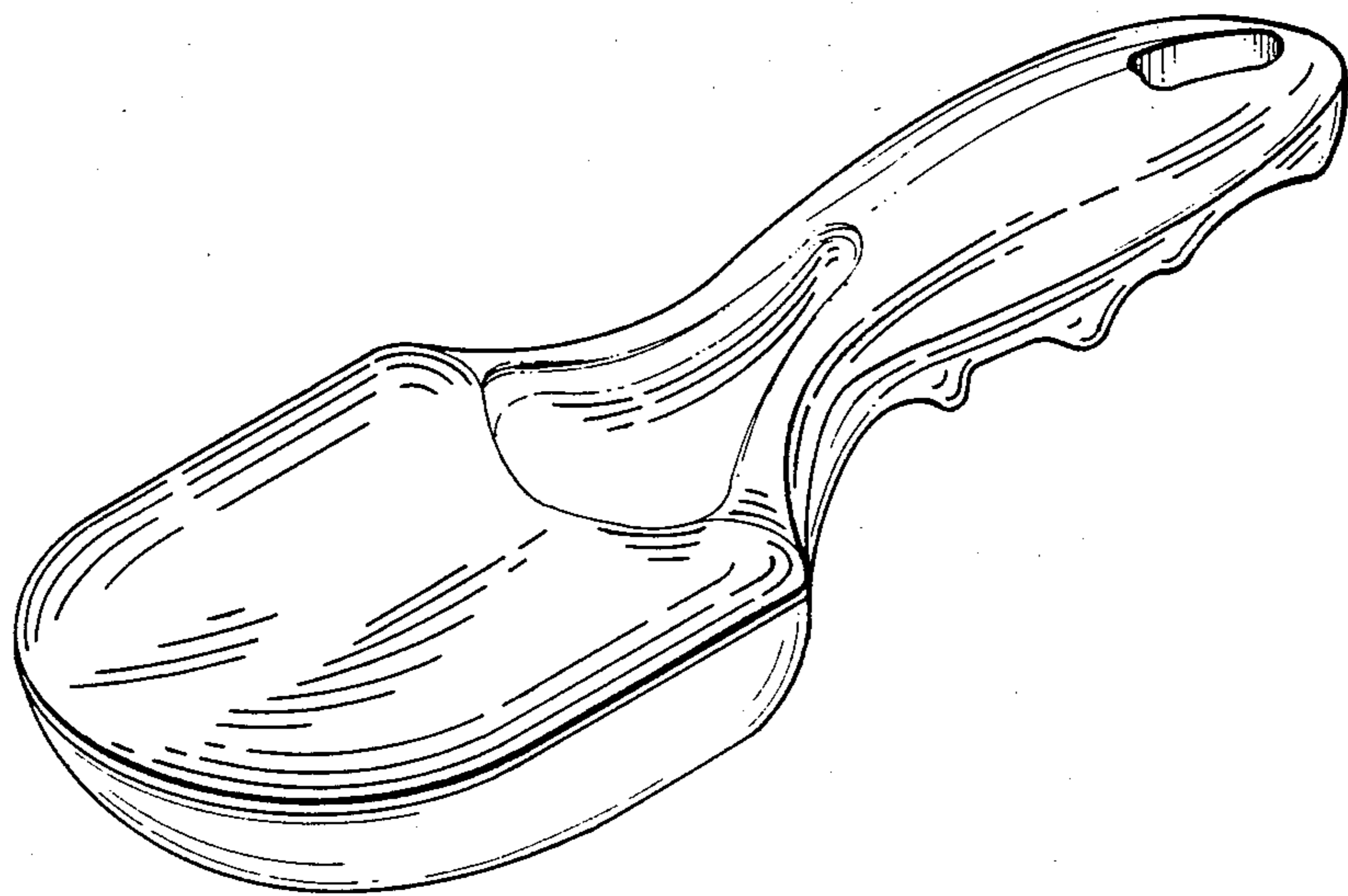

DESCRIPTION
 FIG. 1 is a front, top and side perspective view of a utility brush block and handle unit showing my new design.
 FIG. 2 is a top plan view thereof.
 FIG. 3 is a side elevational view thereof, the opposite side being a mirror image.
 FIG. 4 is a bottom plan view thereof.
 FIG. 5 is a front elevational view thereof.
 FIG. 6 is a rear elevational view thereof.



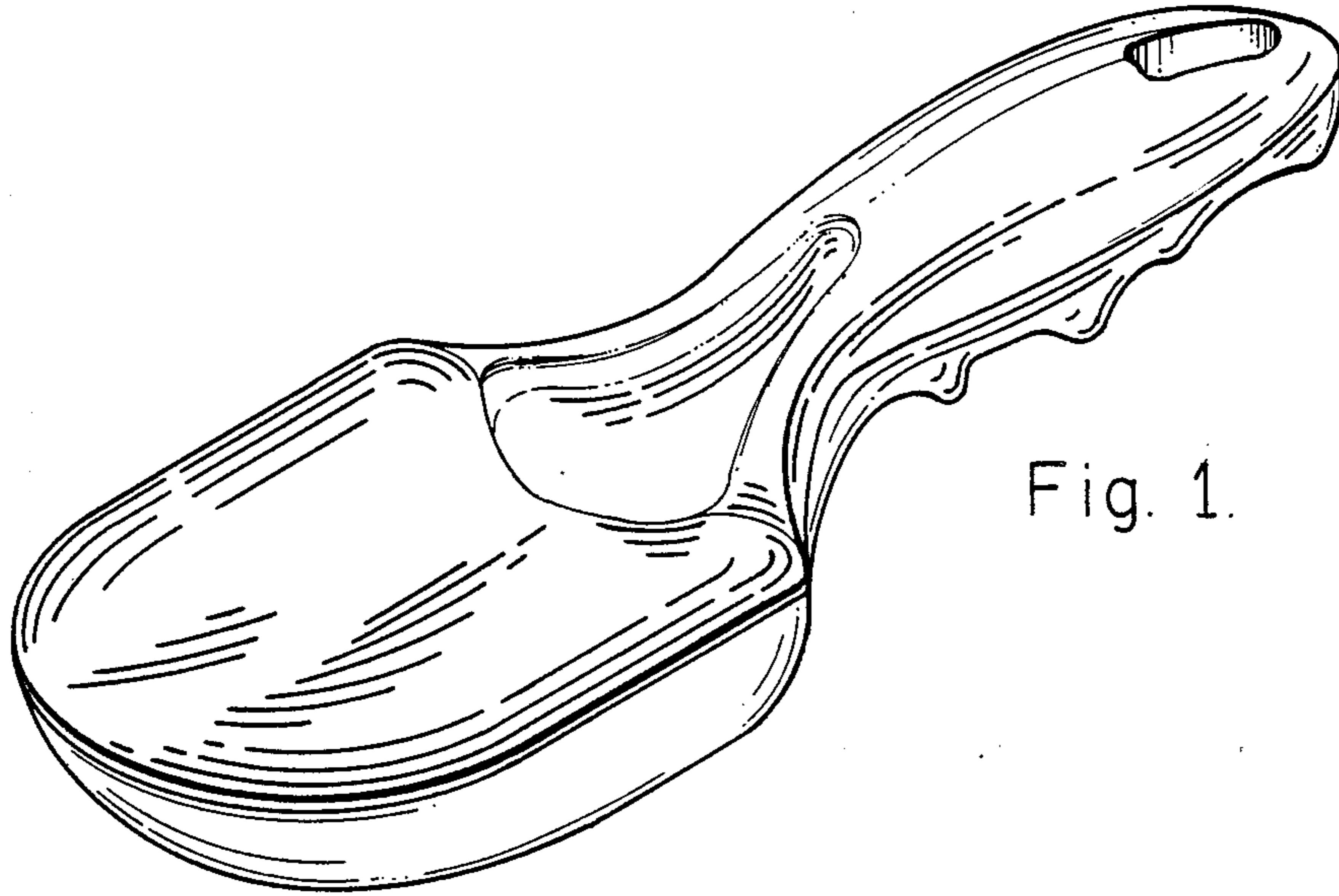

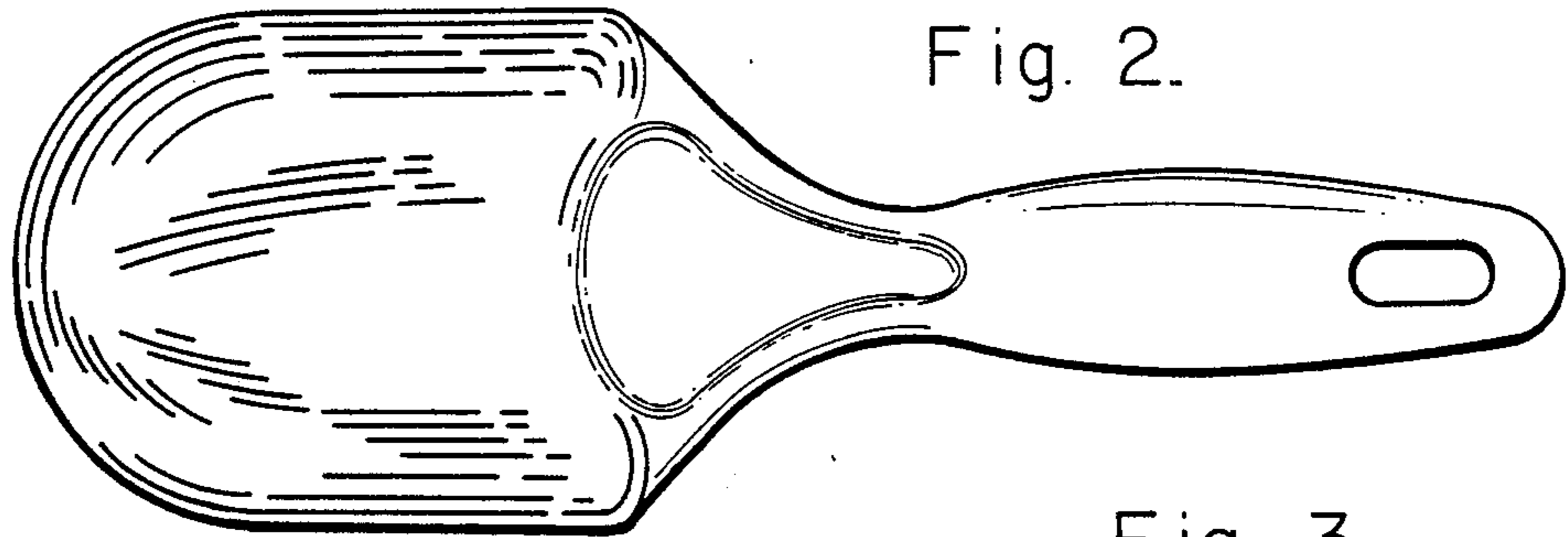

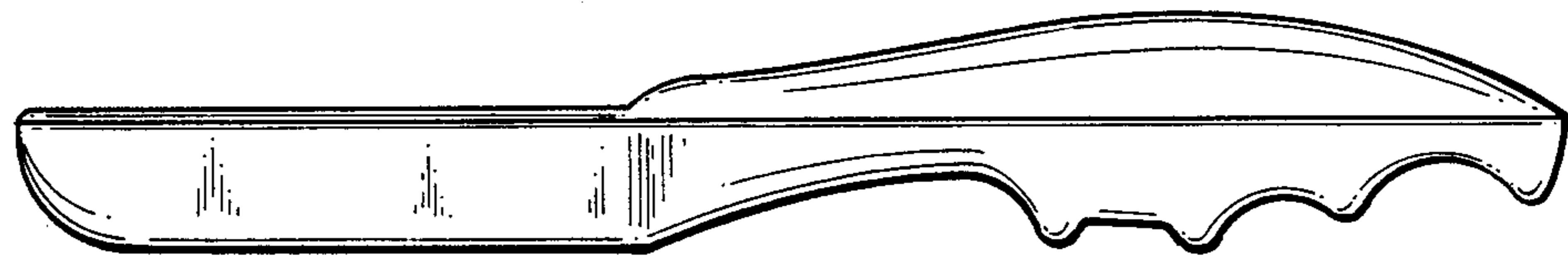

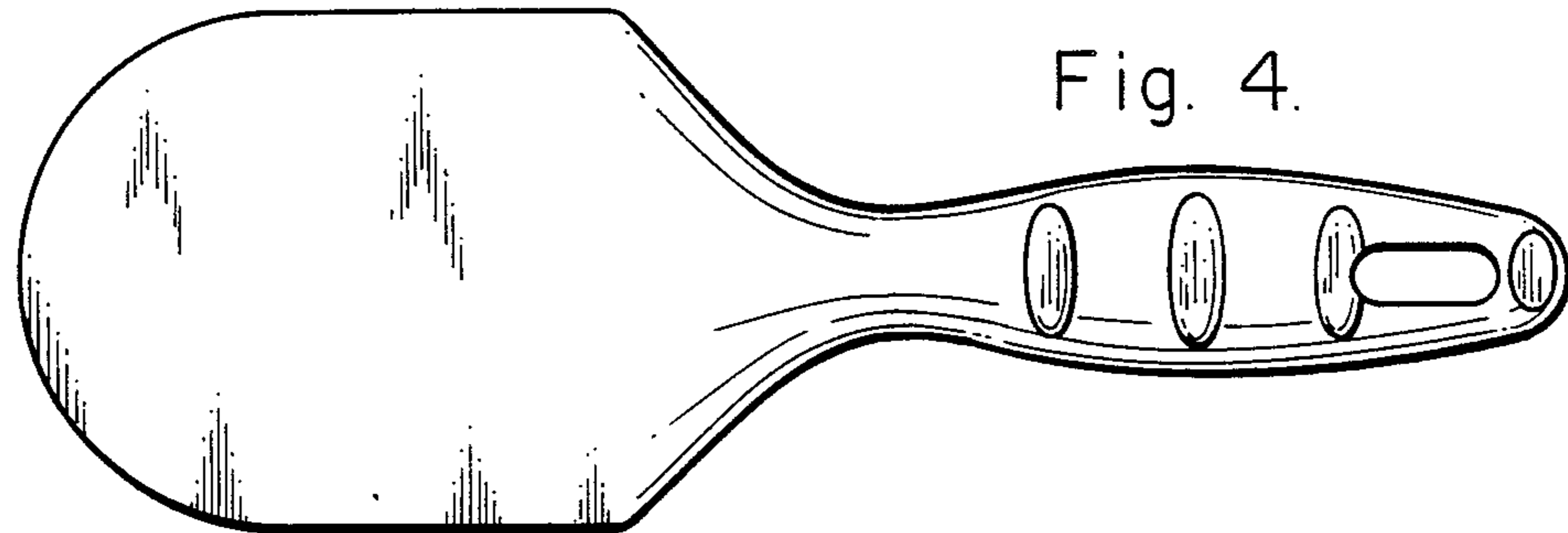

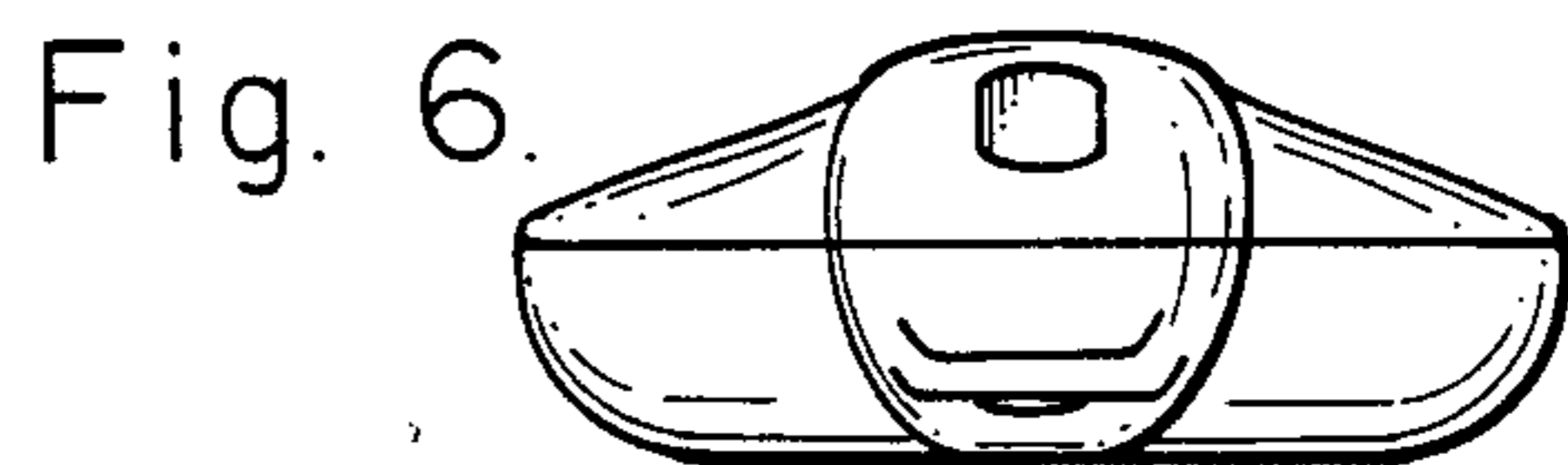
