**DESCRIPTION**

FIG. 1 is a right, front perspective view of a retail terminal or similar article showing my new design, the broken line showing of a keyboard is environmental only and forms no part of the claimed design; FIG. 2 is a front elevational view thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is a left side elevational view thereof; FIG. 5 is a right side elevational view thereof; FIG. 6 is a top plan view thereof.

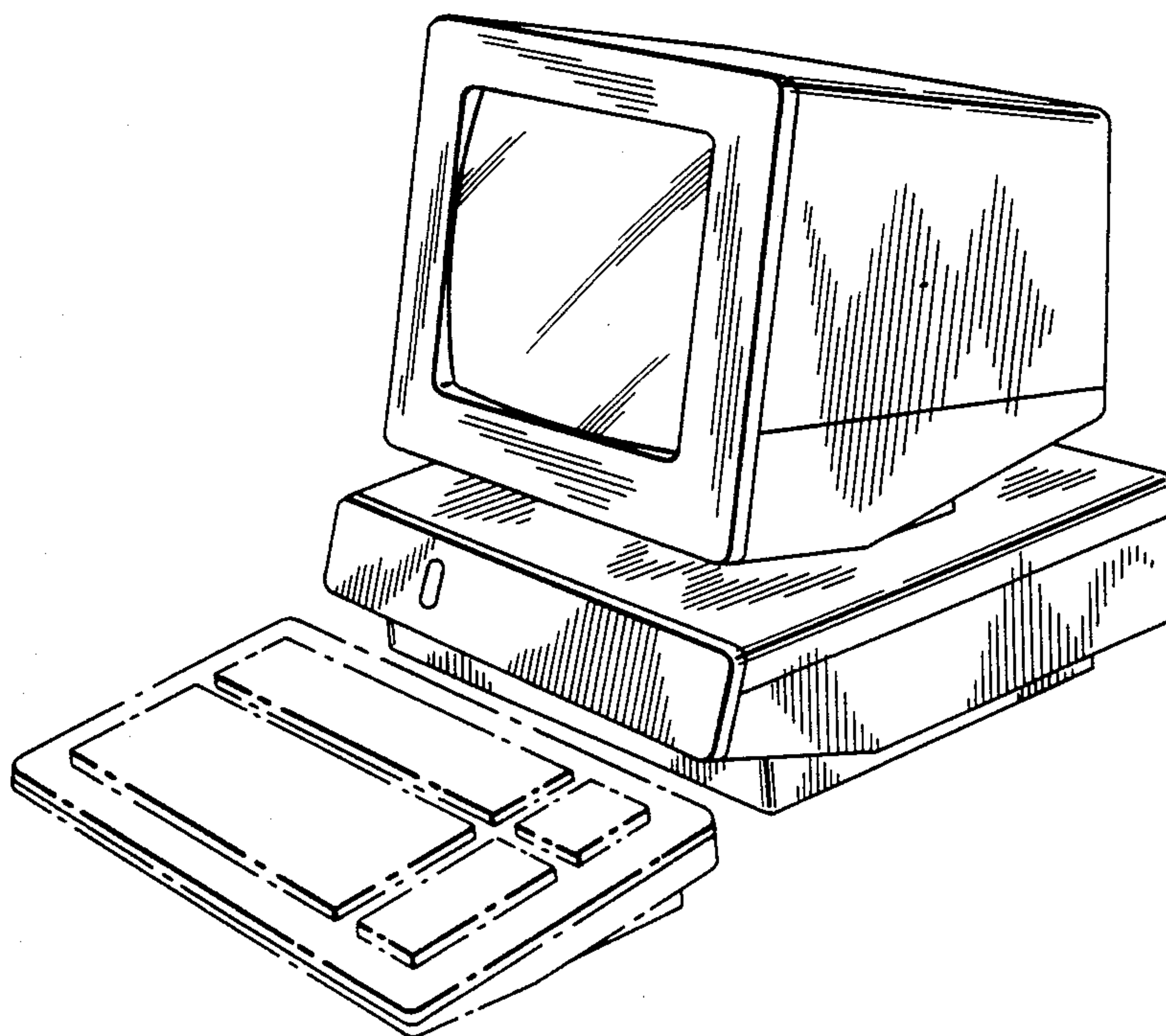

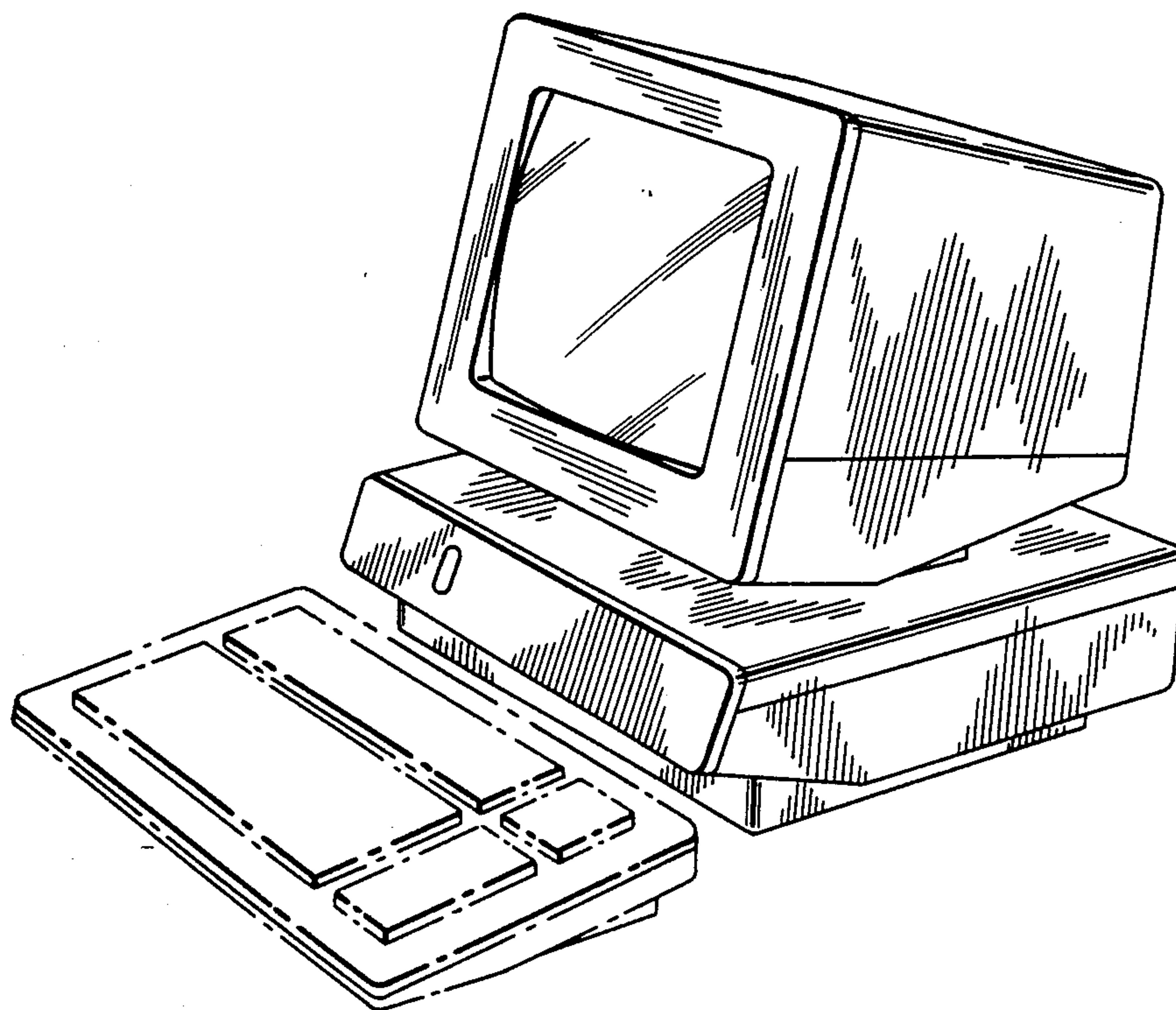
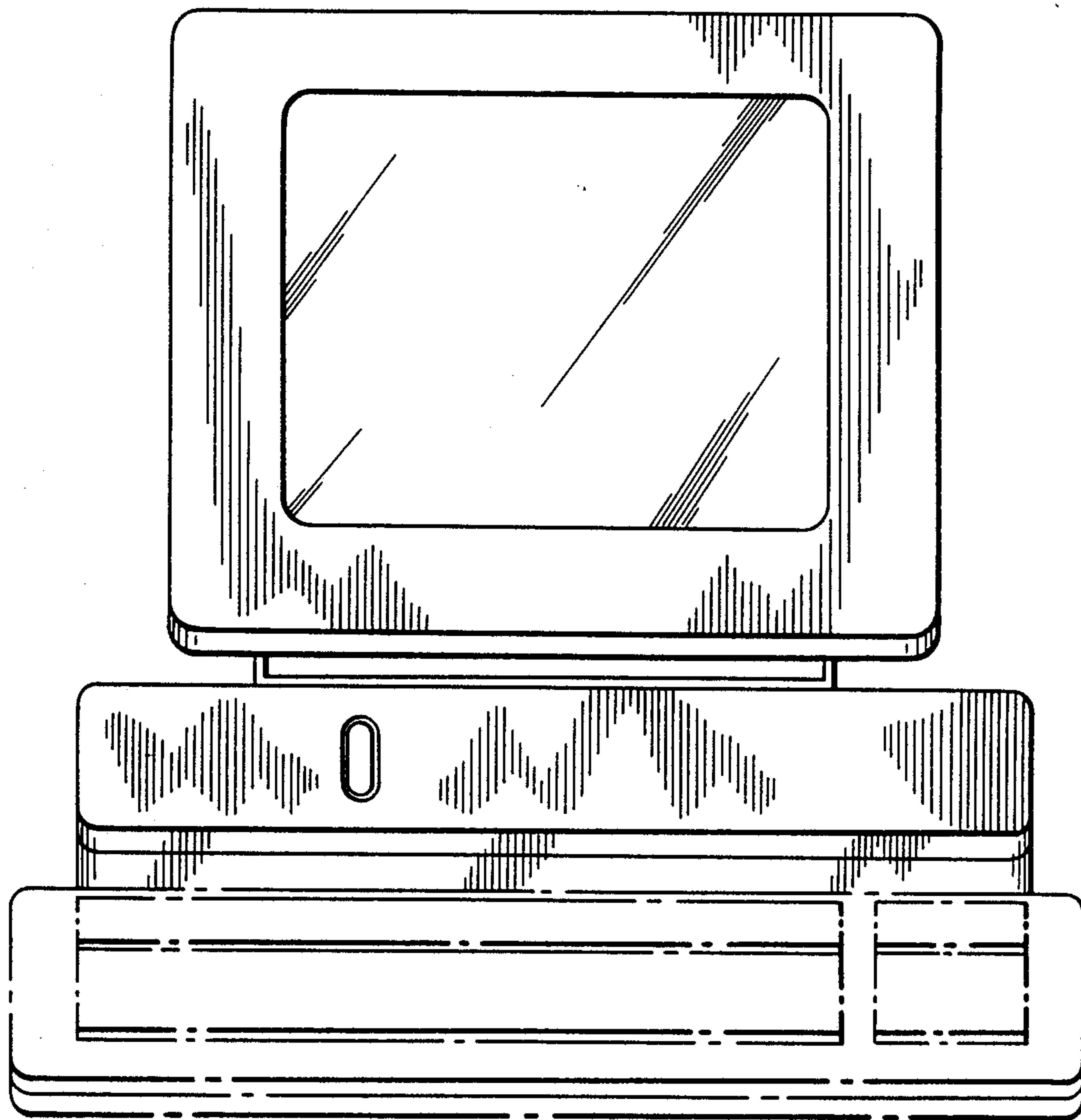

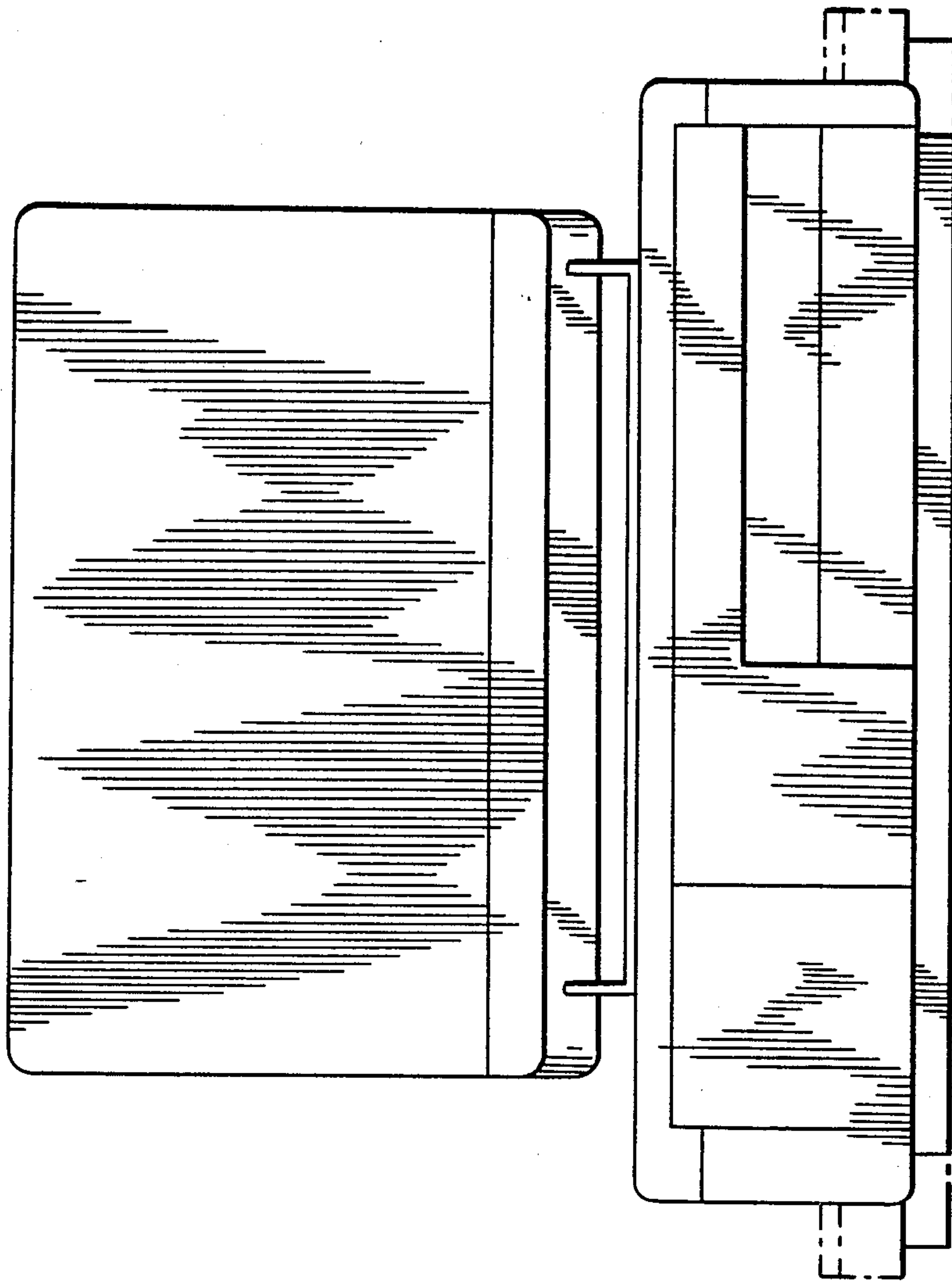

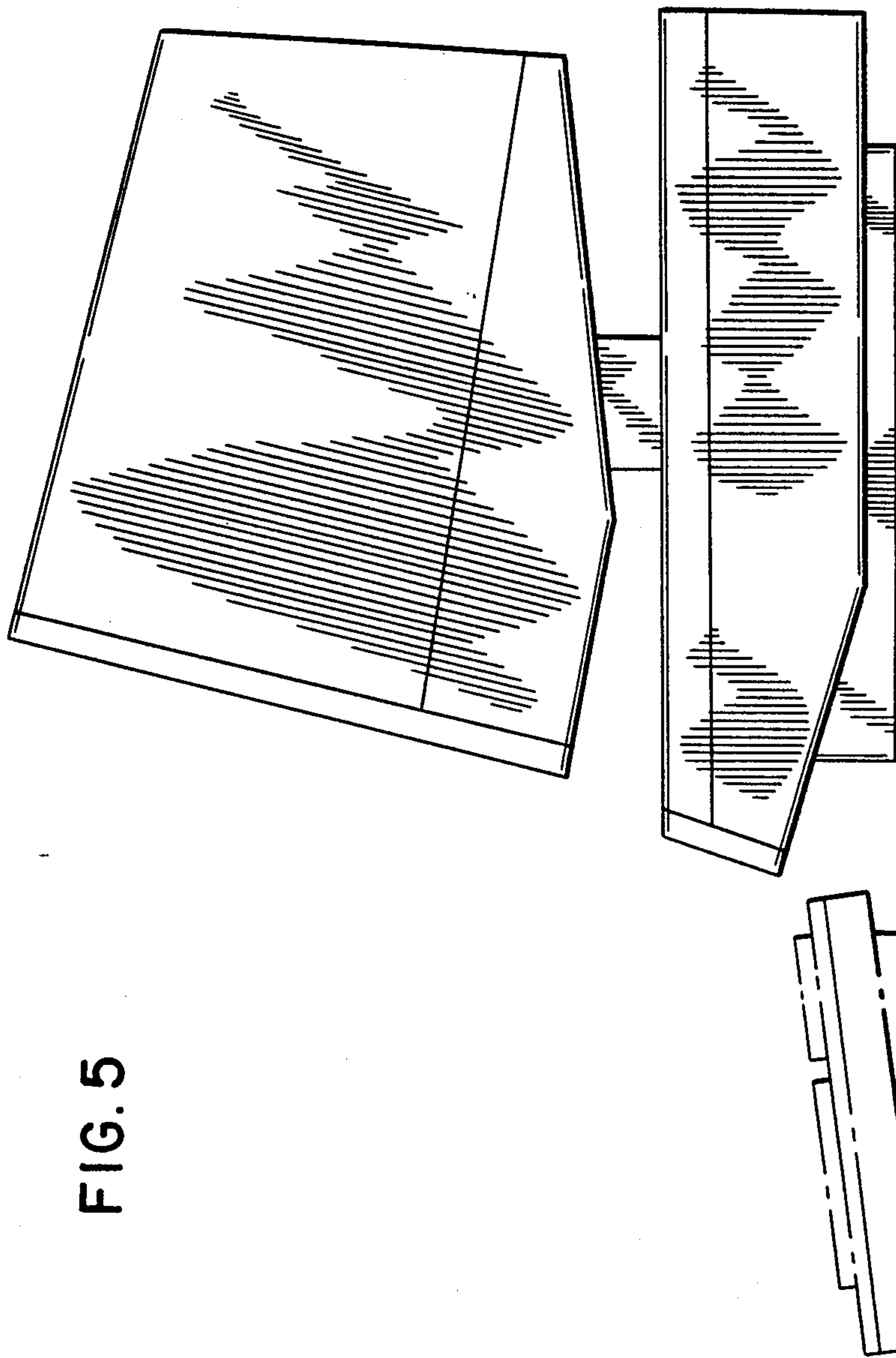
