The ornamental design for a golf shoe bottom, as shown and described.

DESCRIPTION

FIG. 1 is a bottom plan view of a golf shoe bottom showing my new design;

FIG. 4 is an end elevation of the heel end thereof;

FIG. 5 is an end elevation of the toe end thereof;

FIG. 6 is a bottom plan view of a golf shoe bottom showing a second embodiment of my new design;

FIG. 7 is a side elevation of the left side;

FIG. 8 is a side elevation of the right side;

FIG. 9 is an end elevation of the heel end;

FIG. 10 is an end elevation of the toe end;

FIG. 11 is a bottom plan view of a golf shoe bottom showing a third embodiment of my new design;

FIG. 12 is a side elevation of the left side thereof;

FIG. 13 is a side elevation of the right side thereof;

FIG. 14 is an end elevation of the heel end;

FIG. 15 is an end elevation of the toe end;

FIG. 16 is a bottom plan view of a golf shoe bottom showing a fourth embodiment of my new design;

FIG. 17 is a side elevation of the left side;

FIG. 18 is a side elevation of the right side;

FIG. 19 is an end elevation of the heel end; and

FIG. 20 is an end elevation of the toe end.

The top is unornamented.

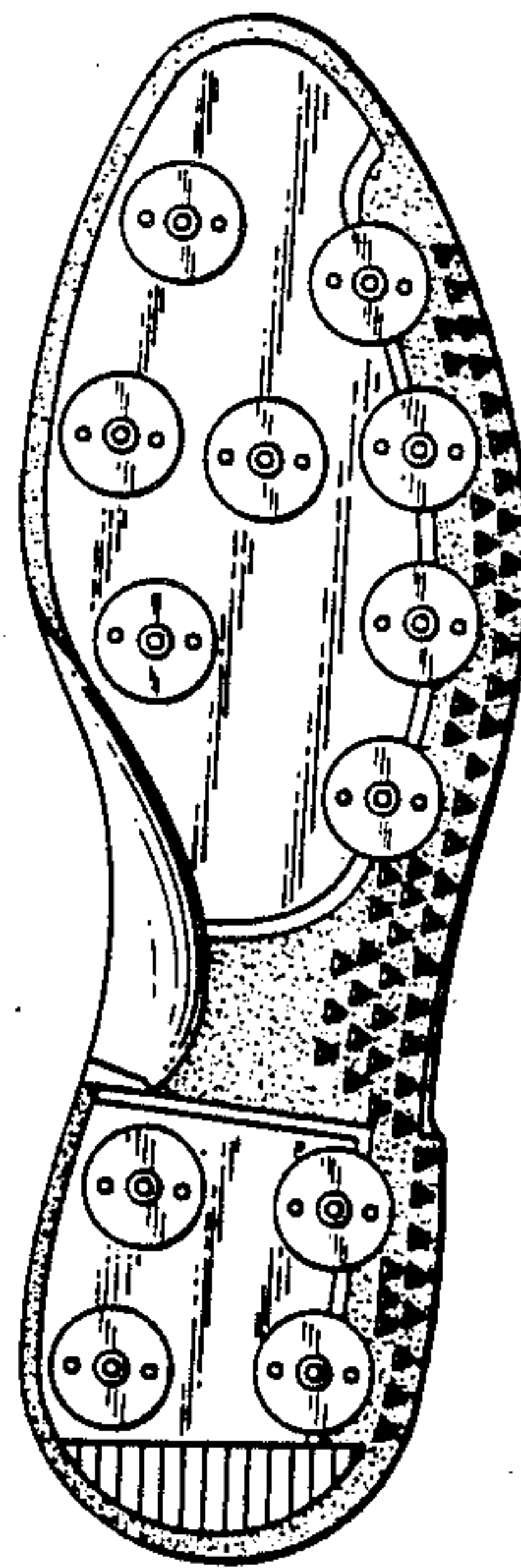

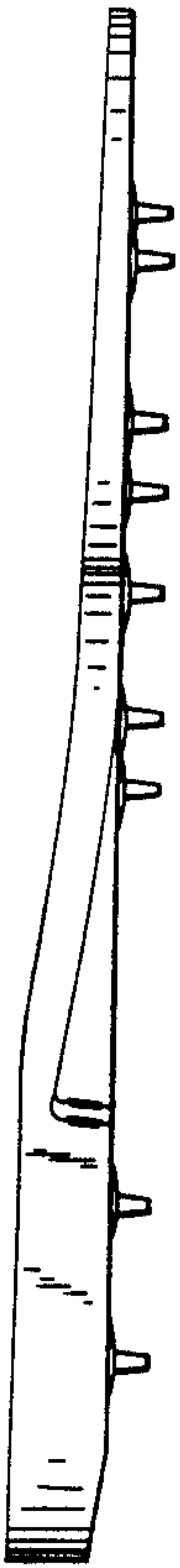

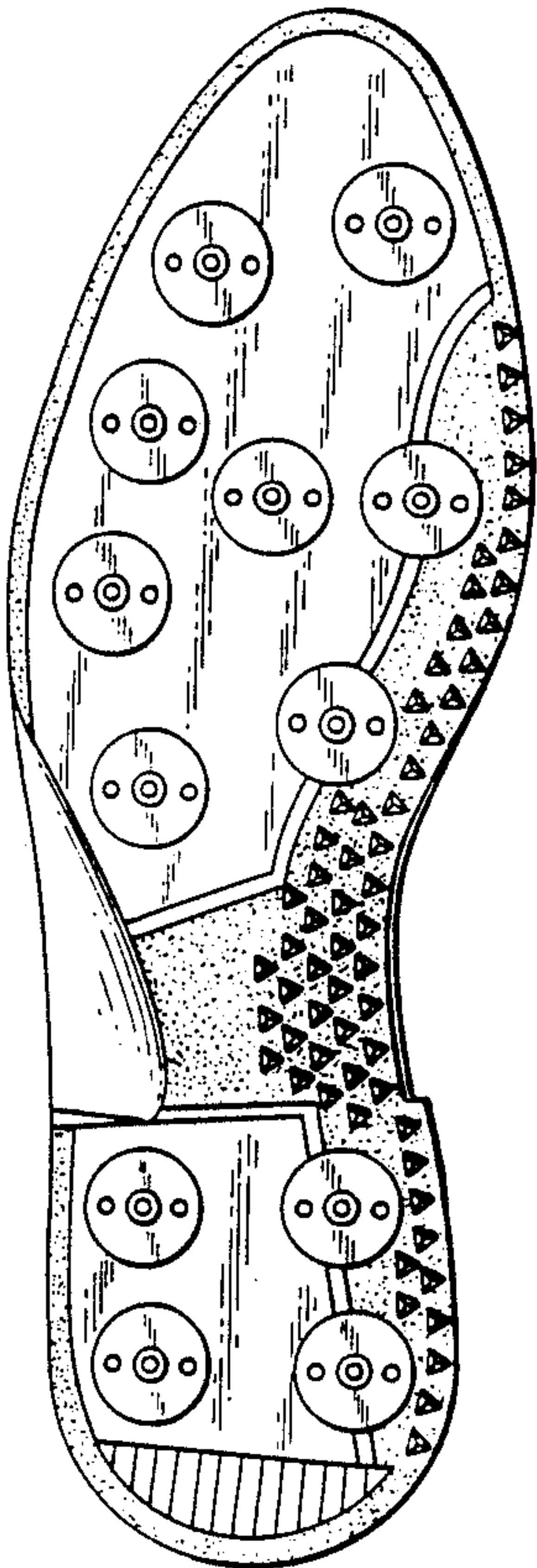

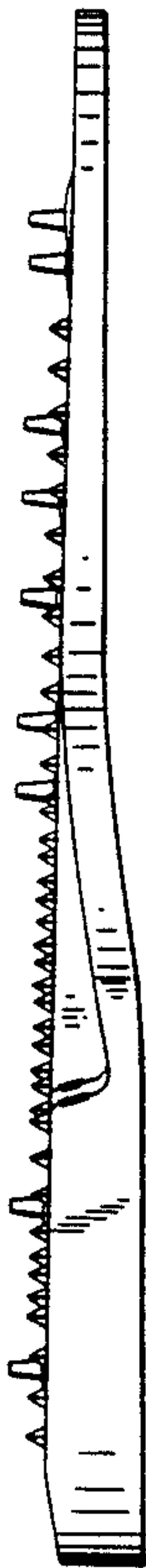

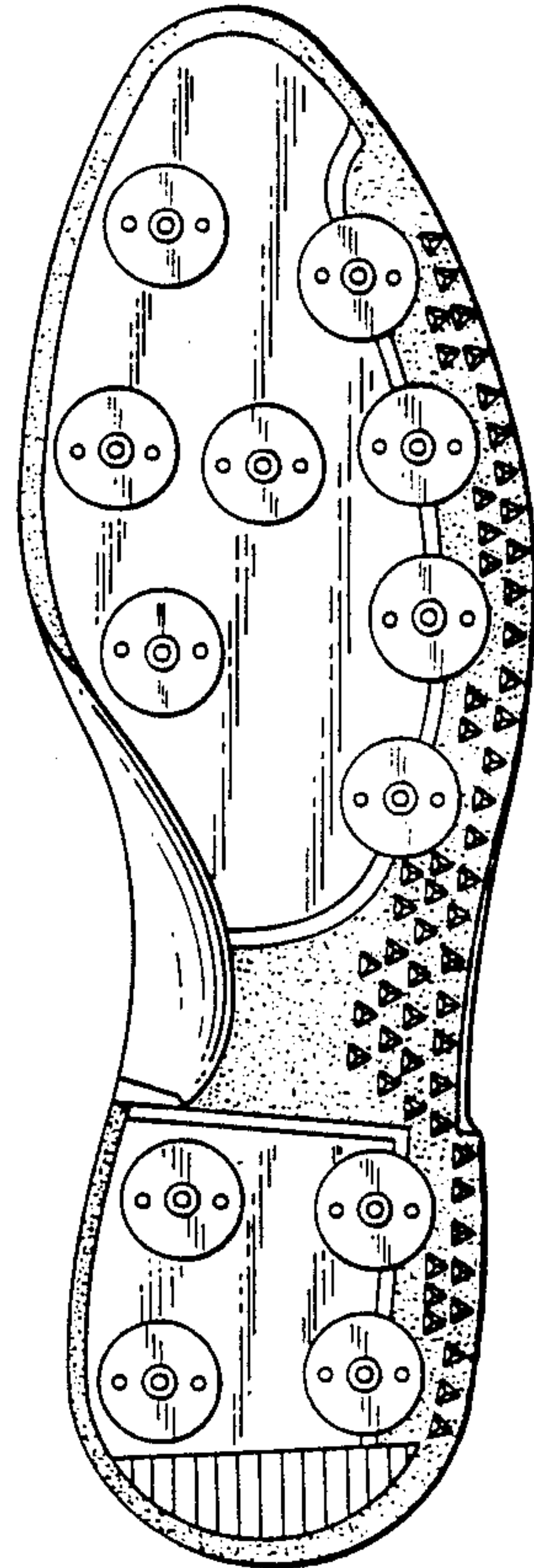

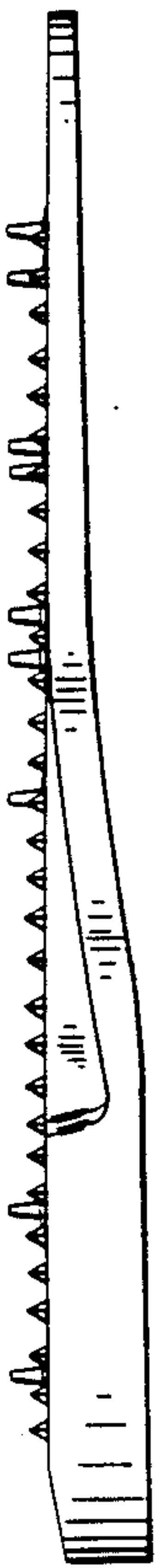

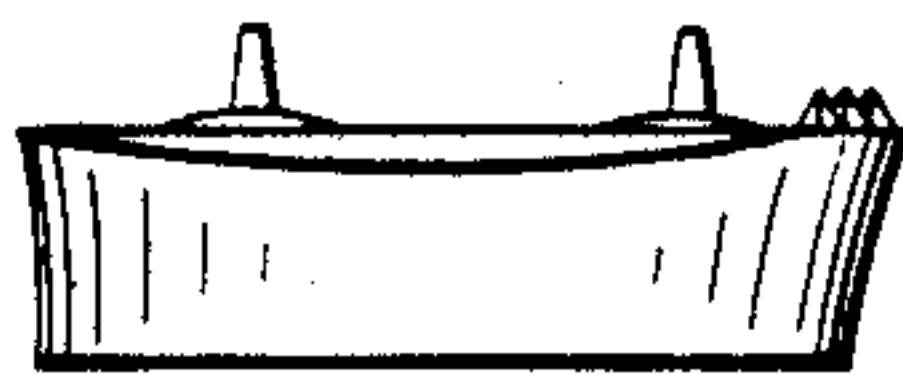

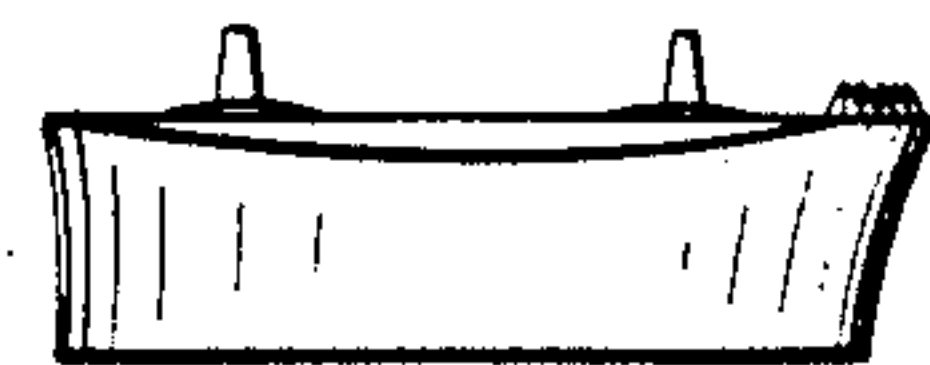

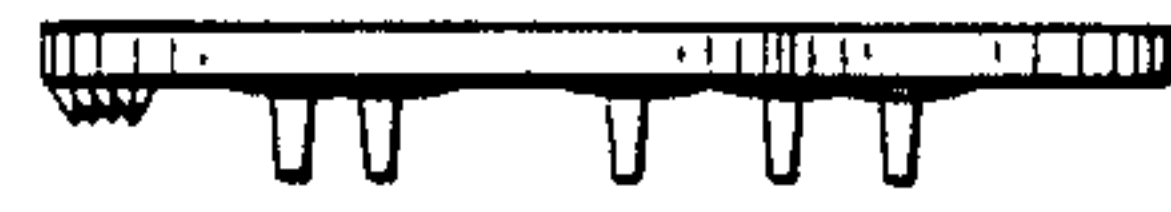

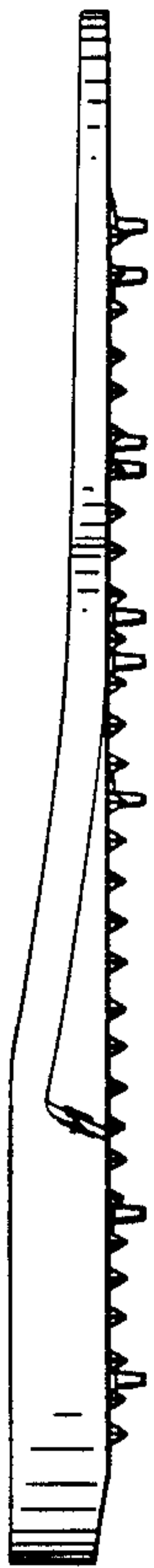

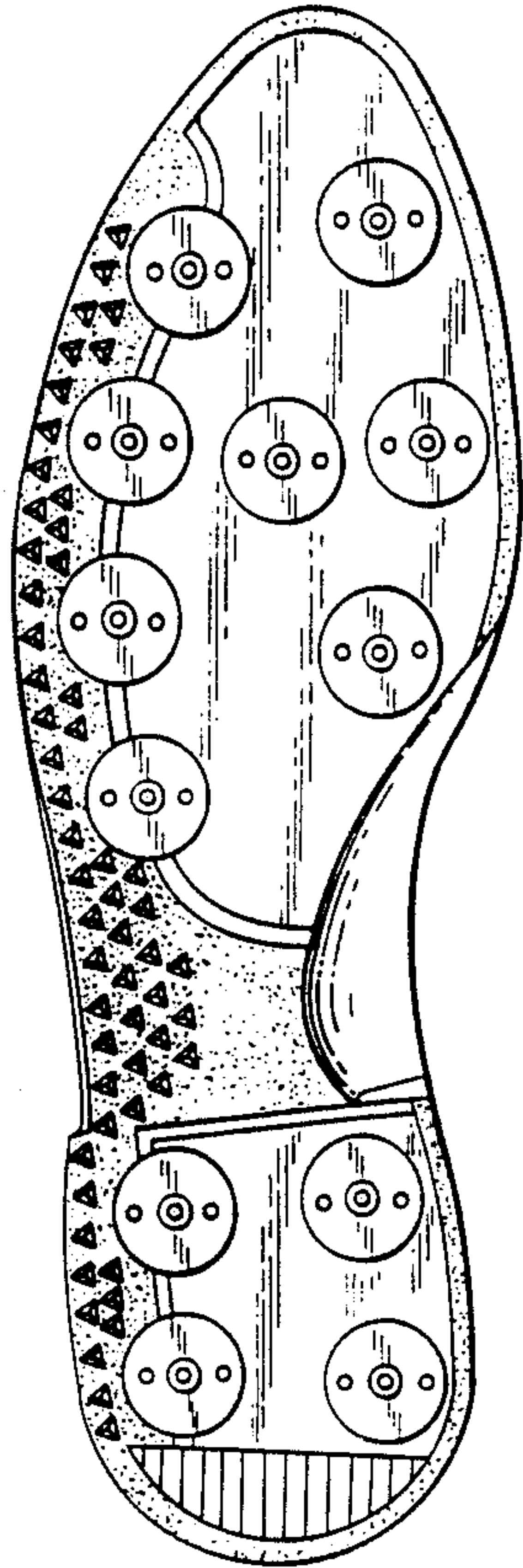

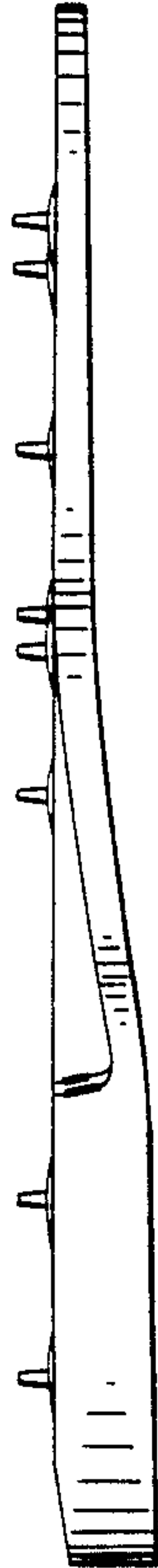

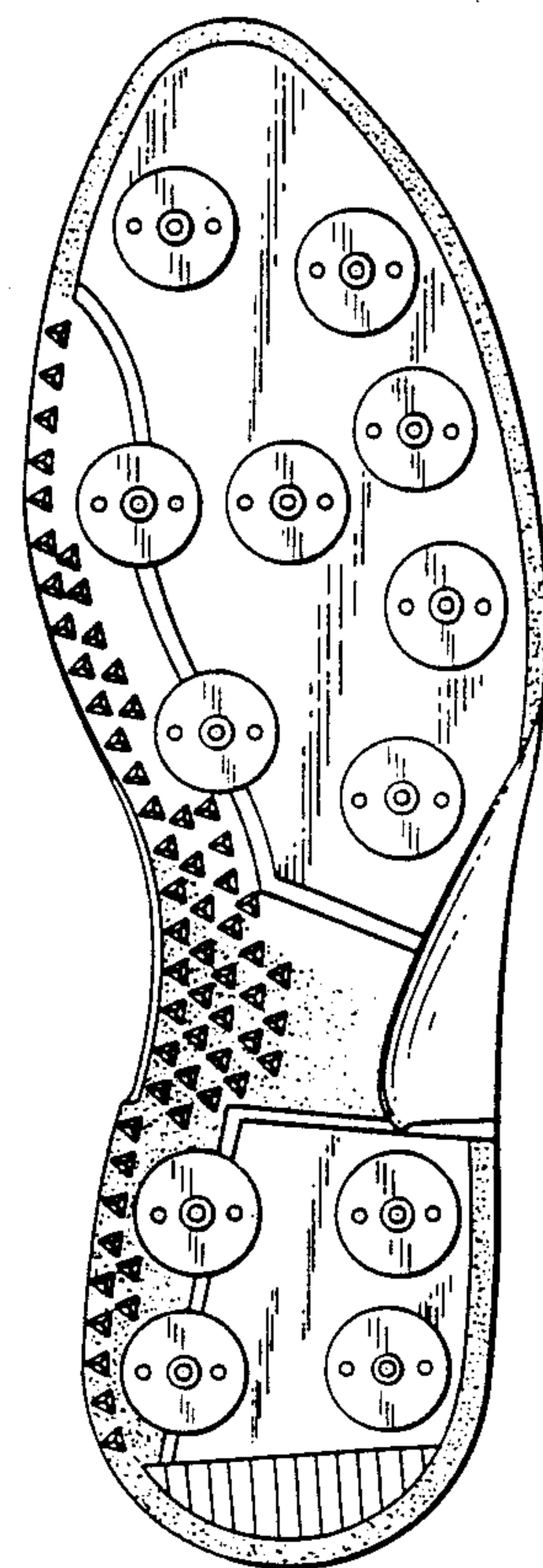

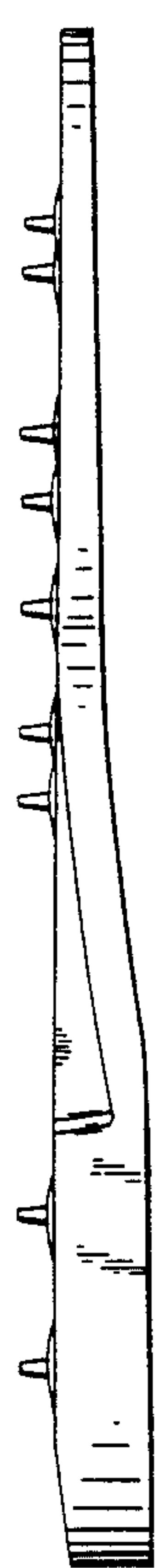

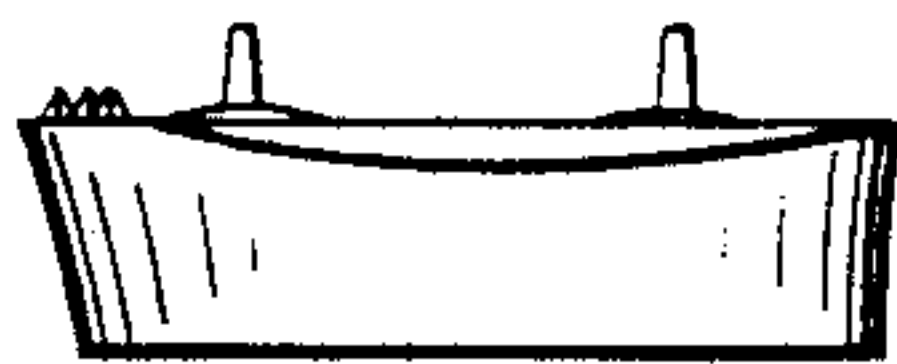

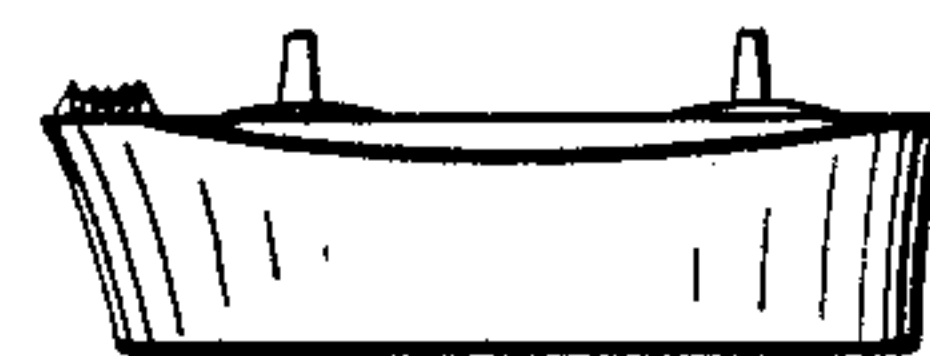
