[57] CLAIM

The ornamental design for a protective cover for electrical outlet, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a protective cover for electrical outlet showing my new design, the lid in its closed position;

FIG. 2 is a rear elevational view thereof;

FIG. 3 is a left side elevational view thereof;

FIG. 4 is a top plan view thereof;

FIG. 5 is a rear perspective view with the lid in its open position;

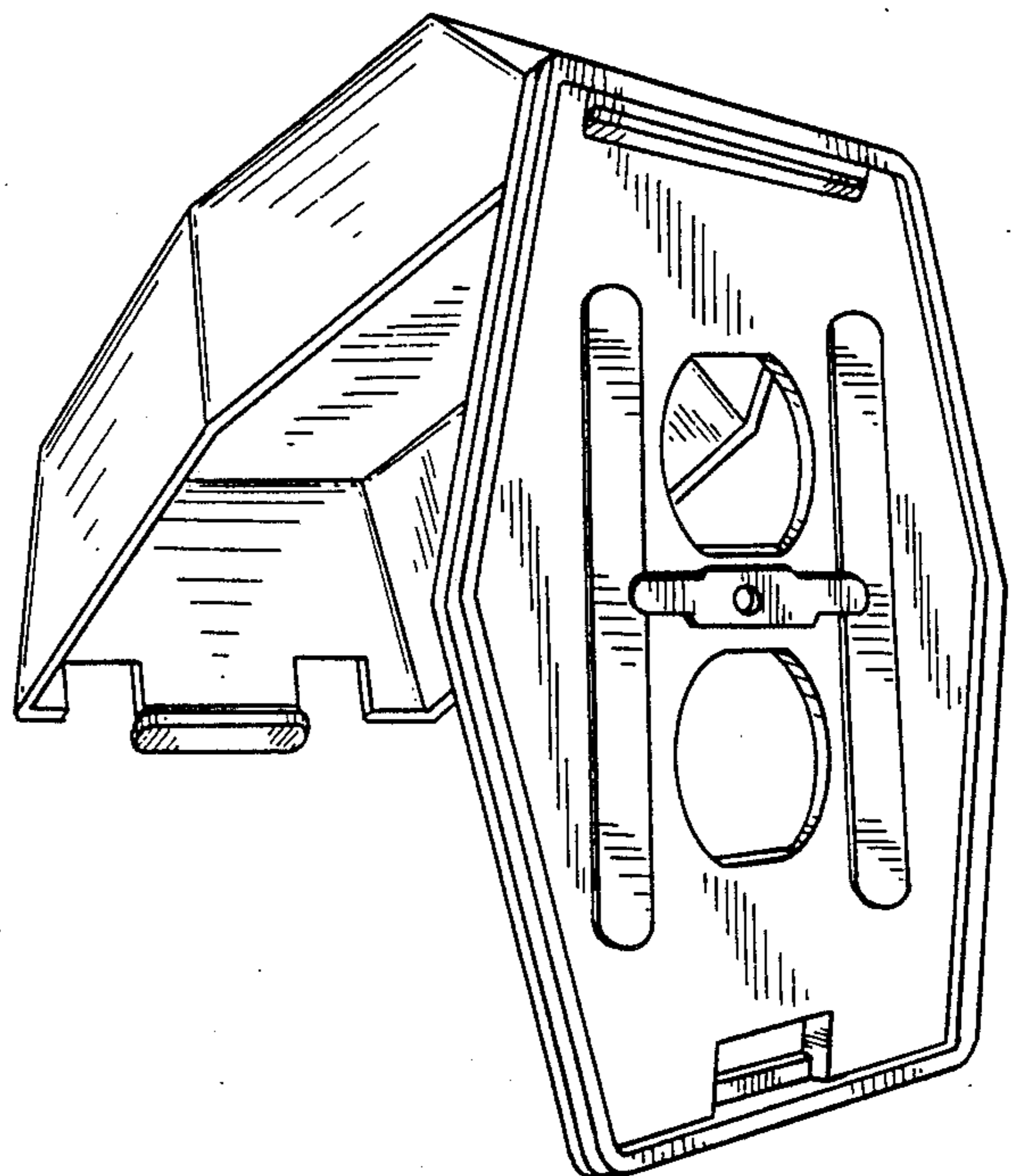
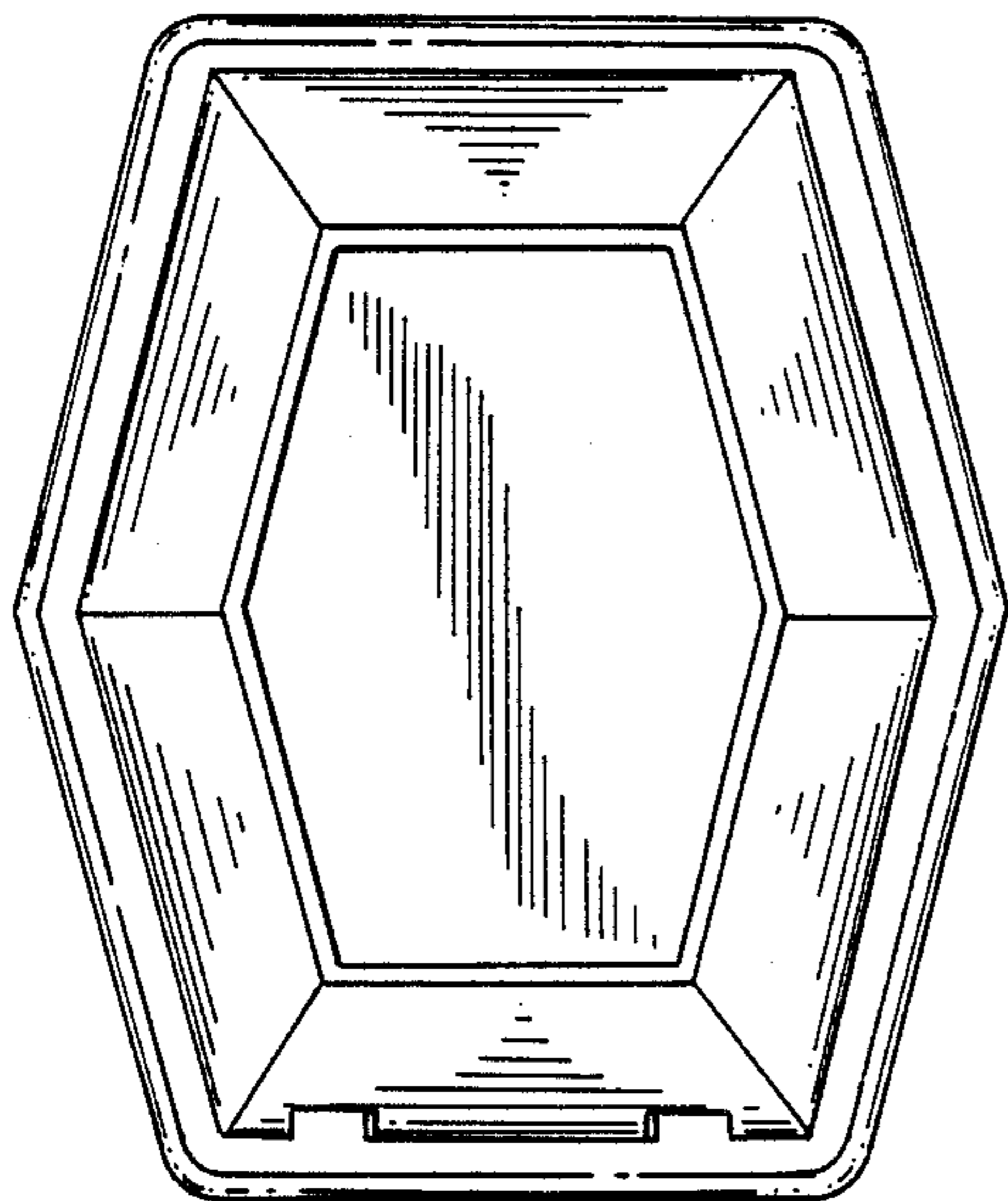
FIG. 6 is an inside elevational view of the lid shown separately for ease of illustration;

FIG. 7 is a sectional view taken in the direction of the arrows on line 7—7 of FIG. 6;

FIG. 9 is a right side elevational view thereof;

FIG. 10 is a bottom plan view thereof.



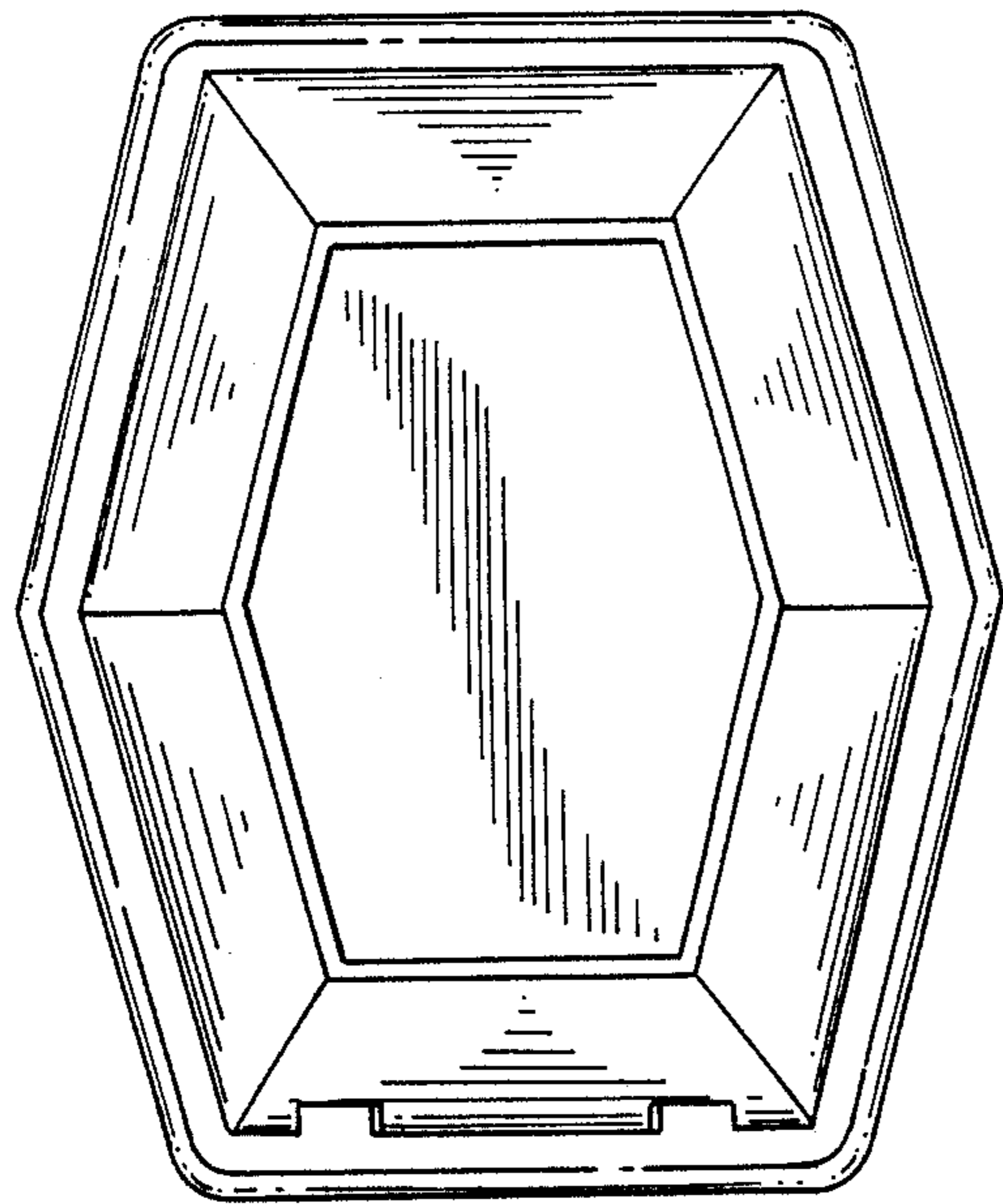

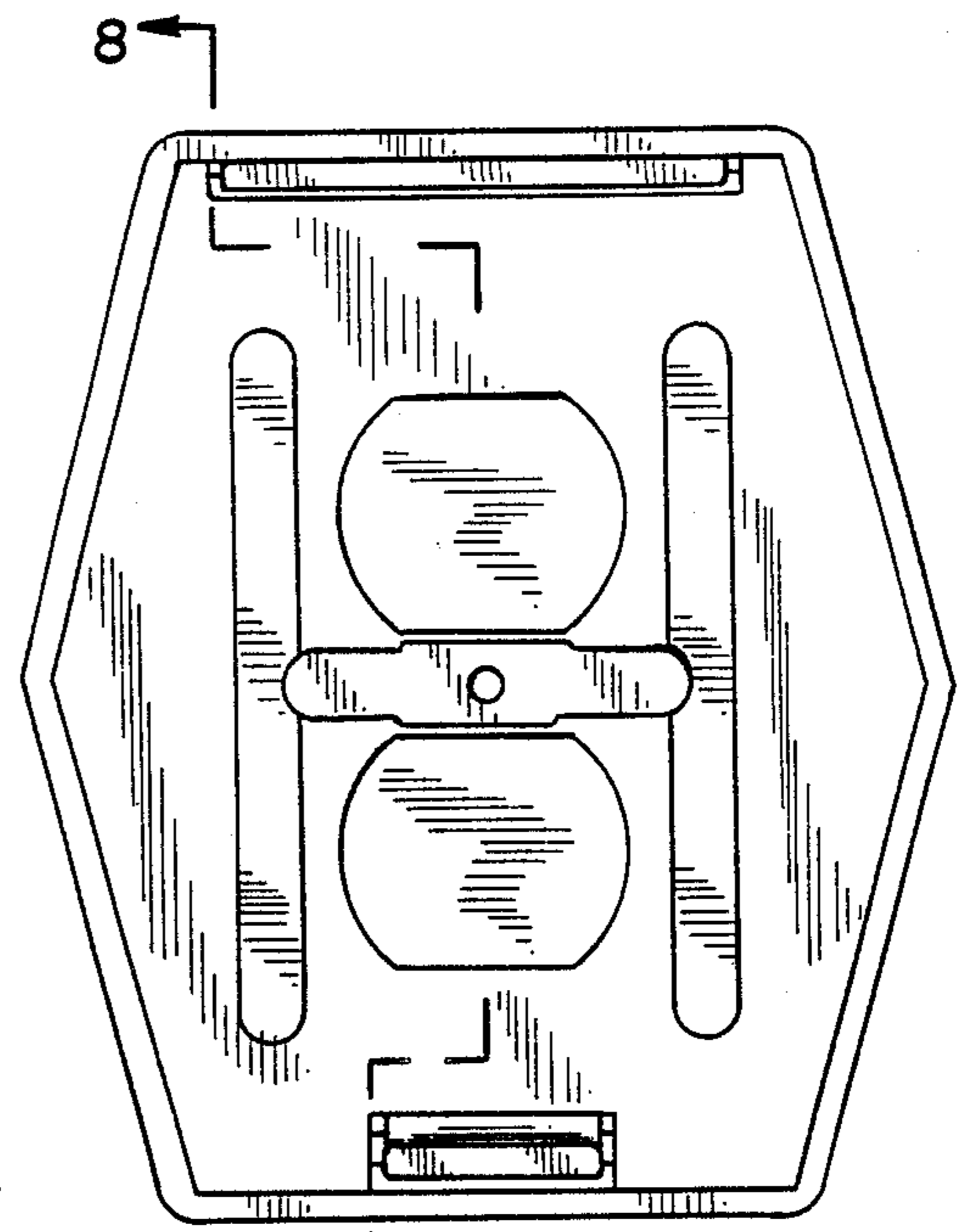

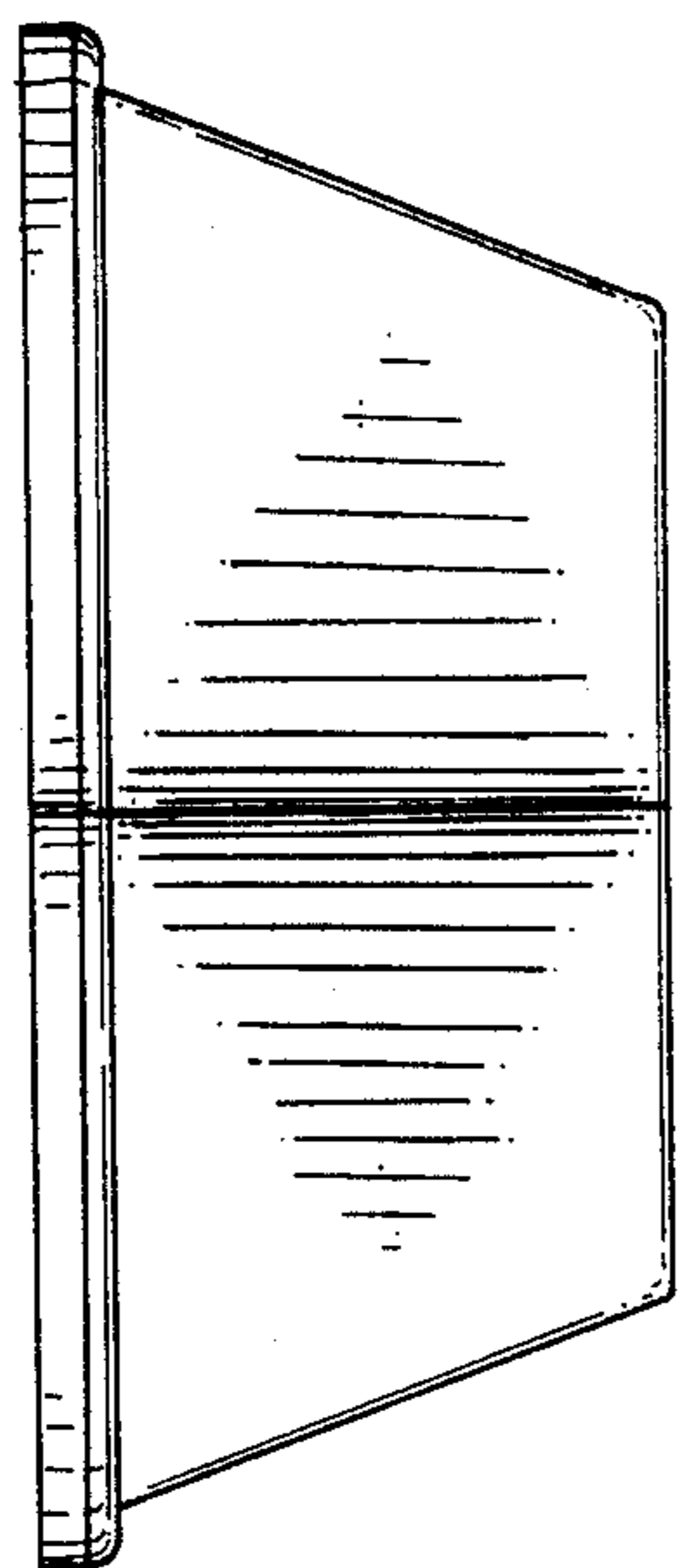

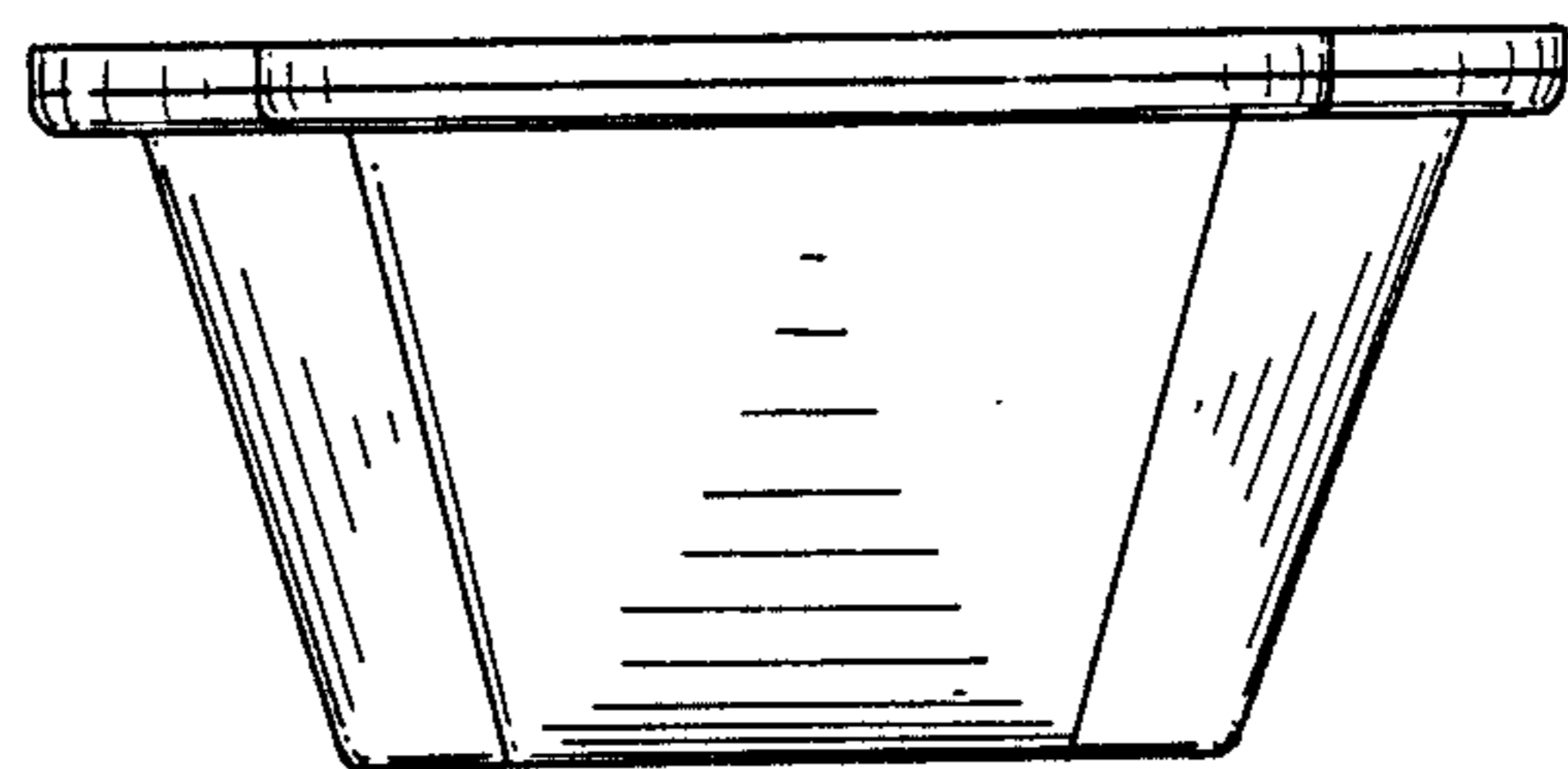

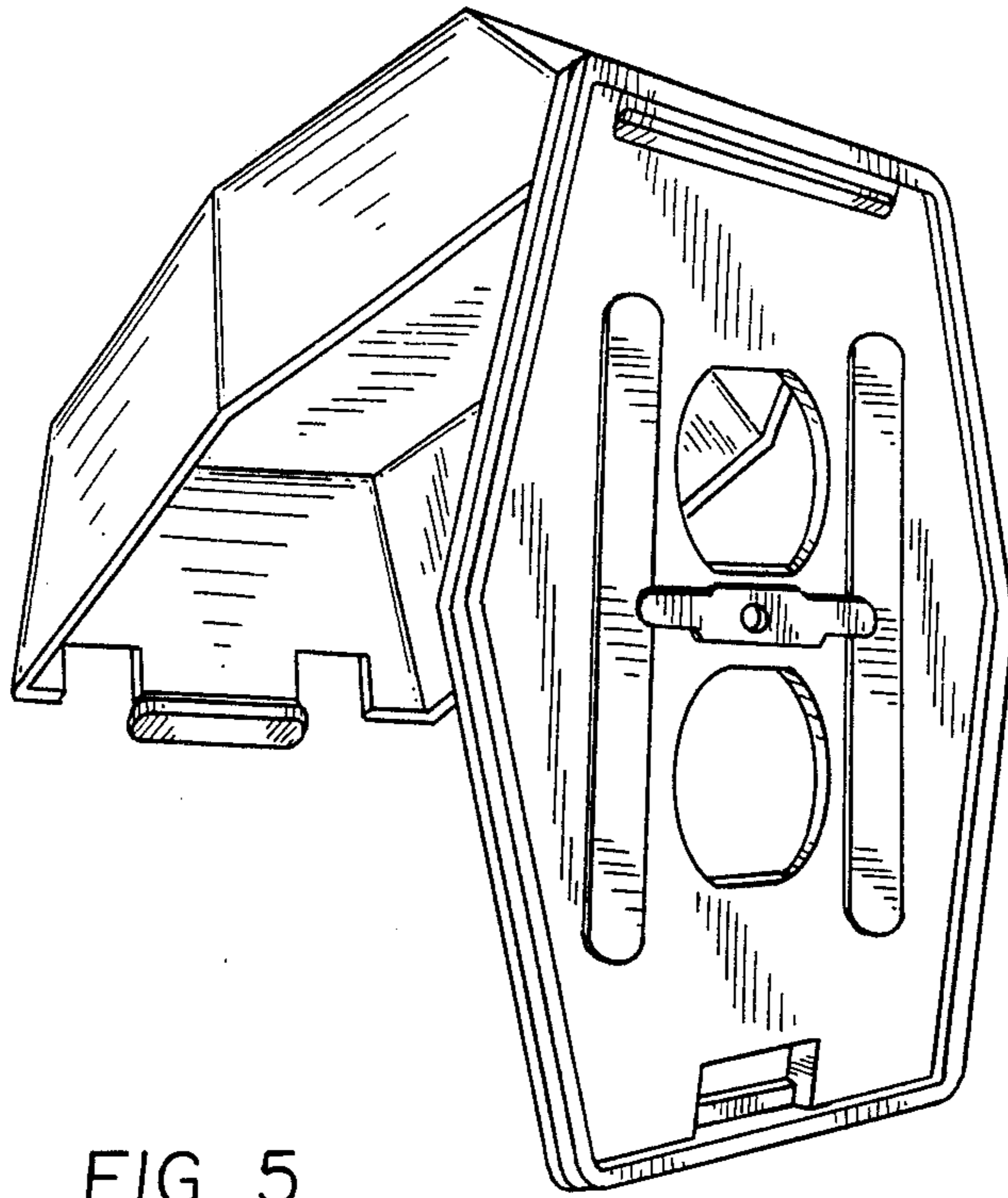

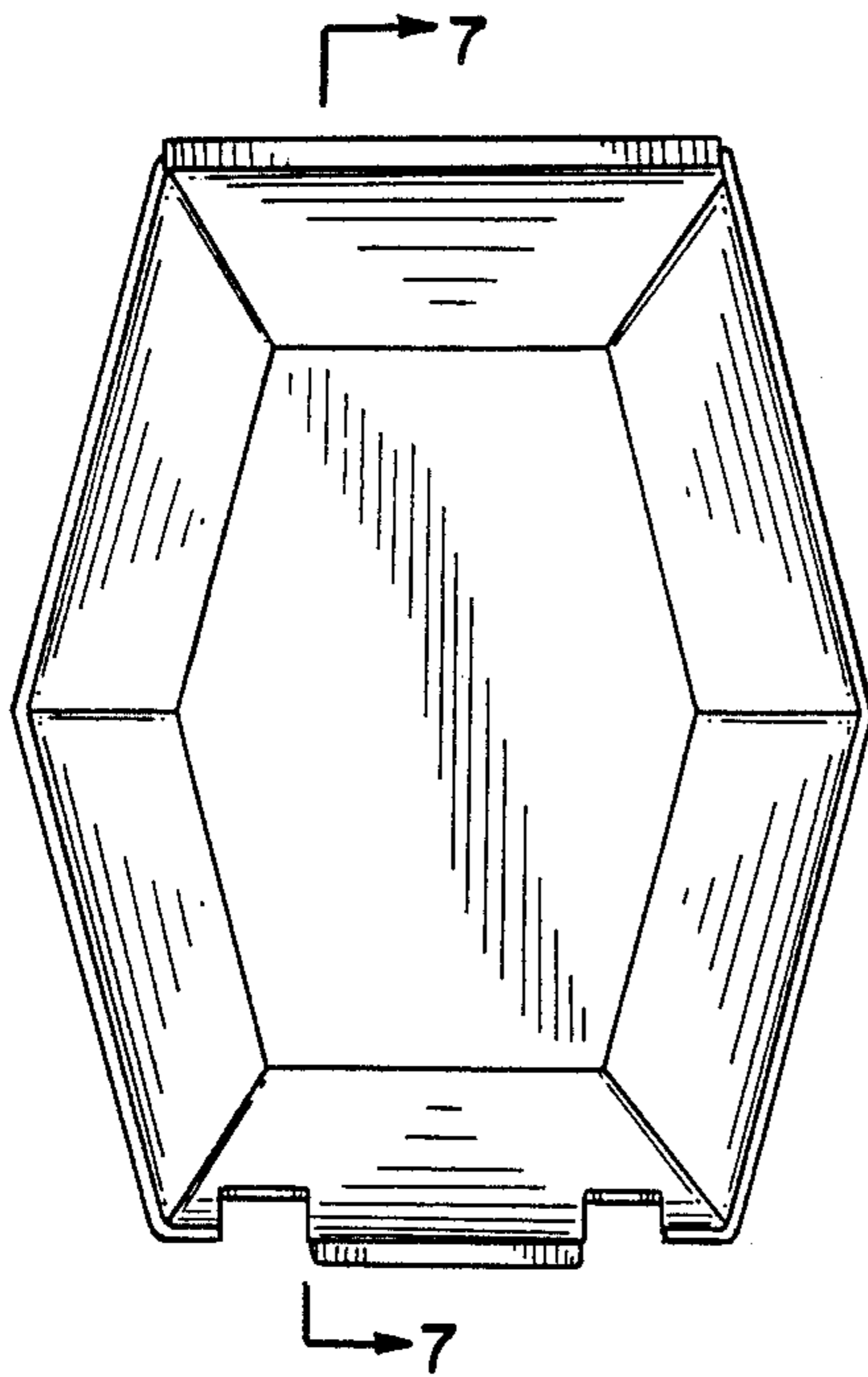

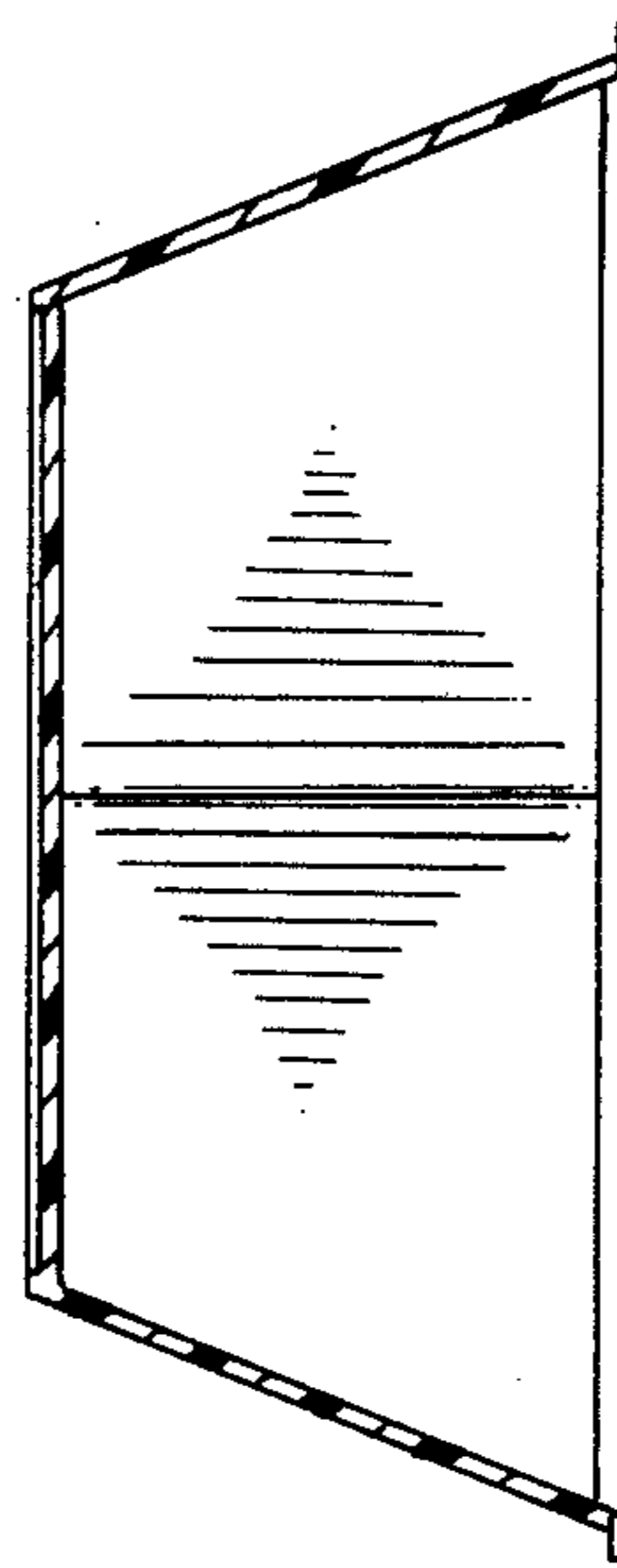

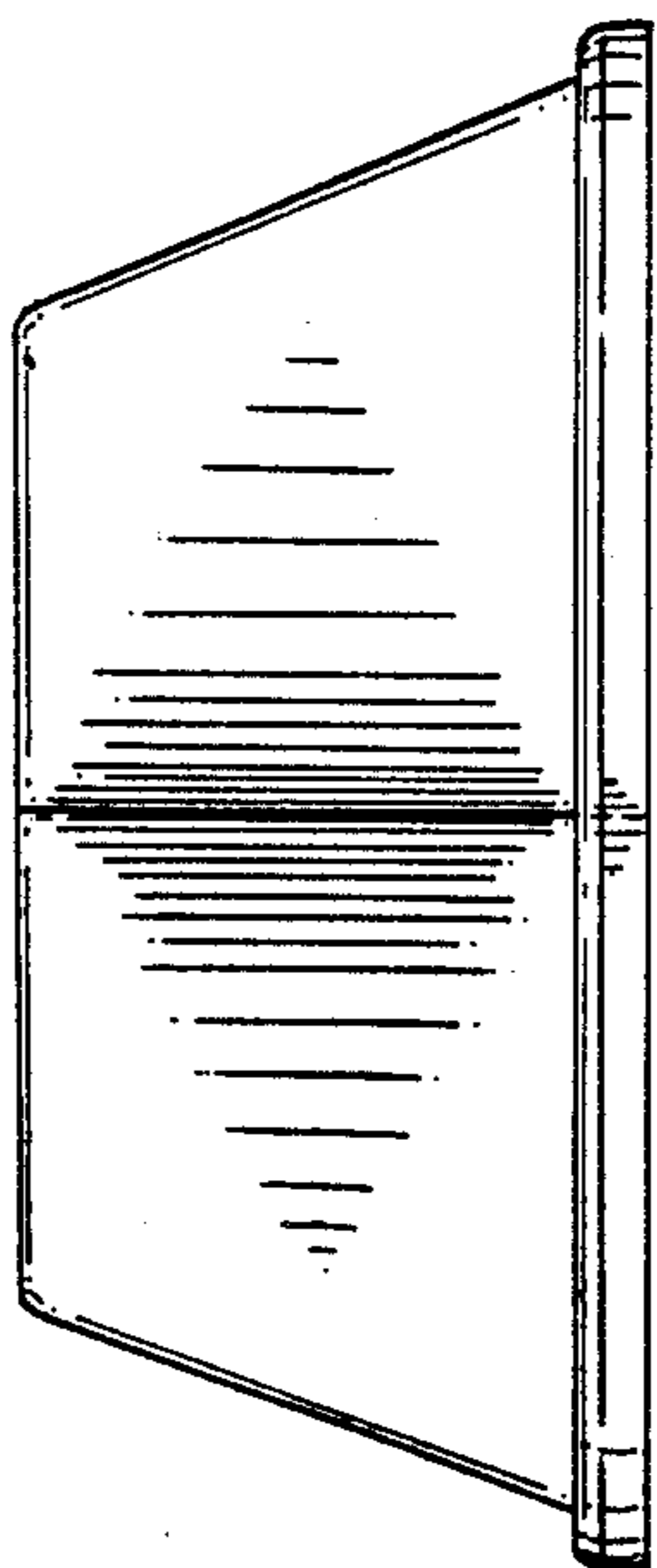

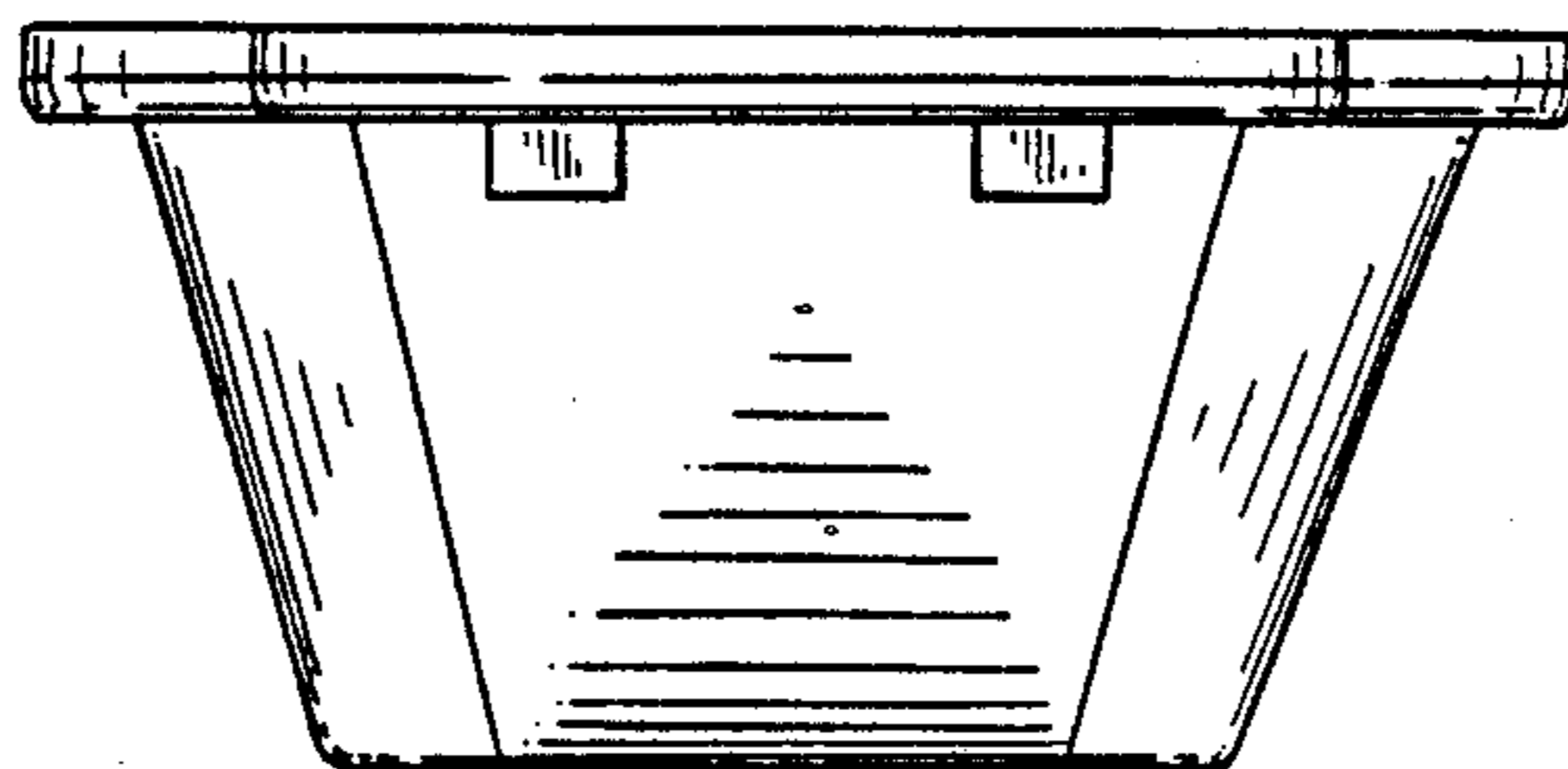
