[57] CLAIM

The ornamental design for a combined data input/out-
put terminal and card reader, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, right side perspective view of a
modular keyboard or similar article showing our new
design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a rear elevational view thereof;

FIG. 4 is a right side elevational view thereof;

FIG. 5 is a left side elevational view thereof;

FIG. 6 is a top plan view thereof;

FIG. 7 is a top, front, right side perspective view of a
second embodiment showing our new design, the front
elevational view and the rear elevational view being
similar to FIGS. 2 and 3, respectively;

FIG. 8 is a right side elevational view thereof;

FIG. 9 is a left side elevational view thereof;

FIG. 10 is a top plan view thereof;

FIG. 11 is a top, front, right side perspective view of a
third embodiment showing our new design, the right
side elevational view being similar to FIG. 4;

FIG. 12 is a front elevational view thereof on an en-
larged scale;

FIG. 13 is a rear elevational view thereof on an en-
larged scale; and

FIG. 14 is a left side elevational view thereof on an
enlarged scale.

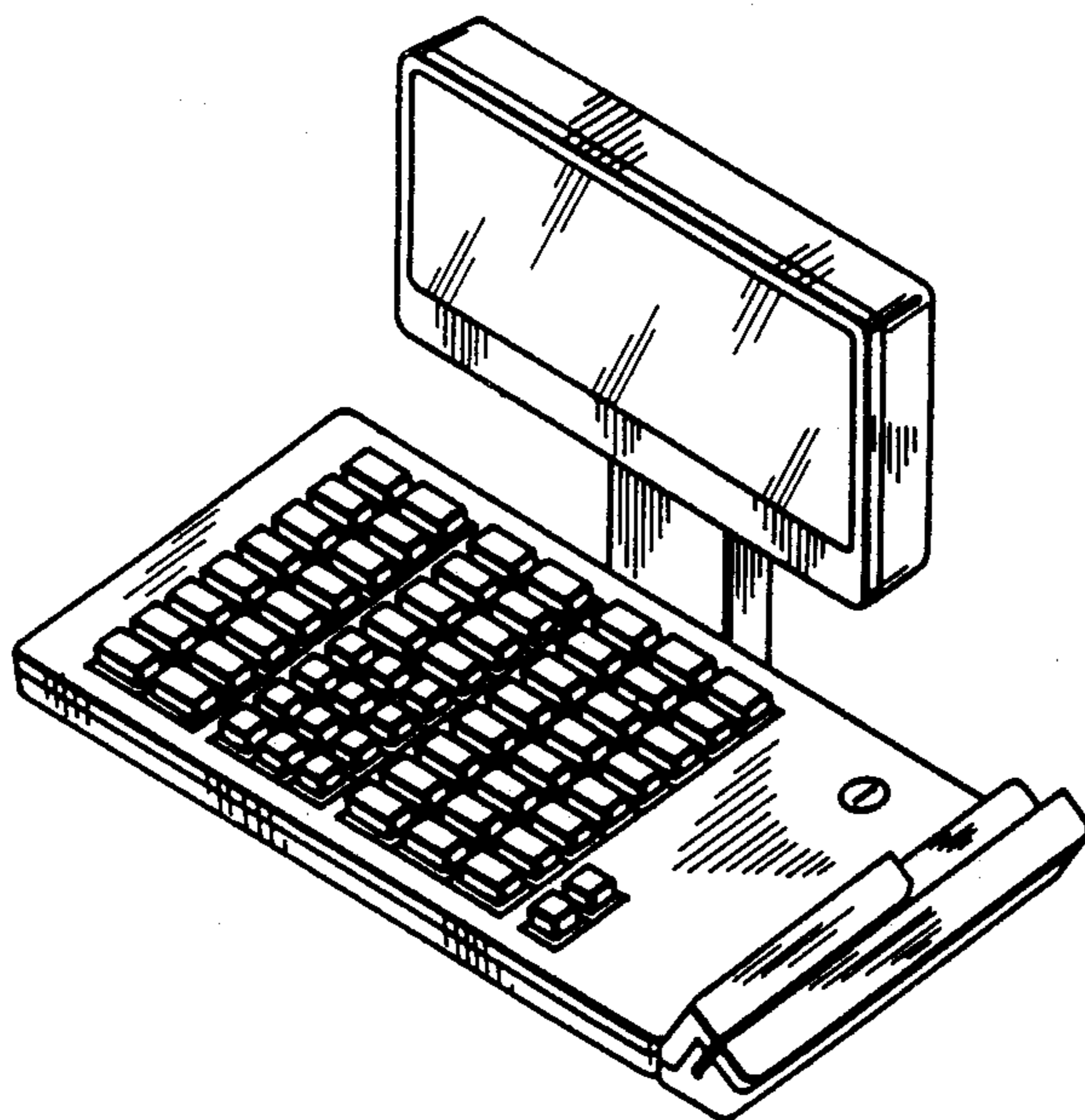

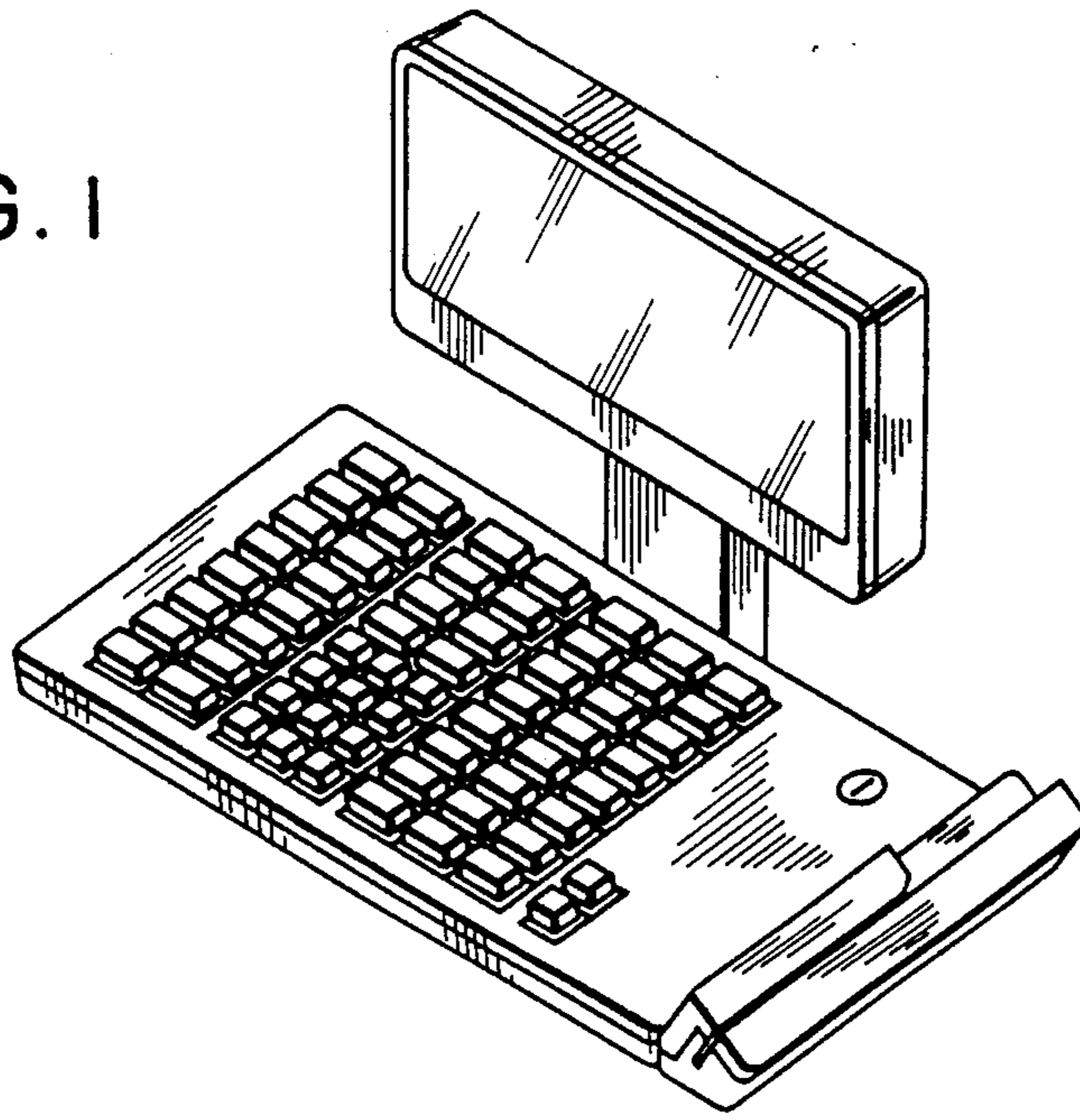

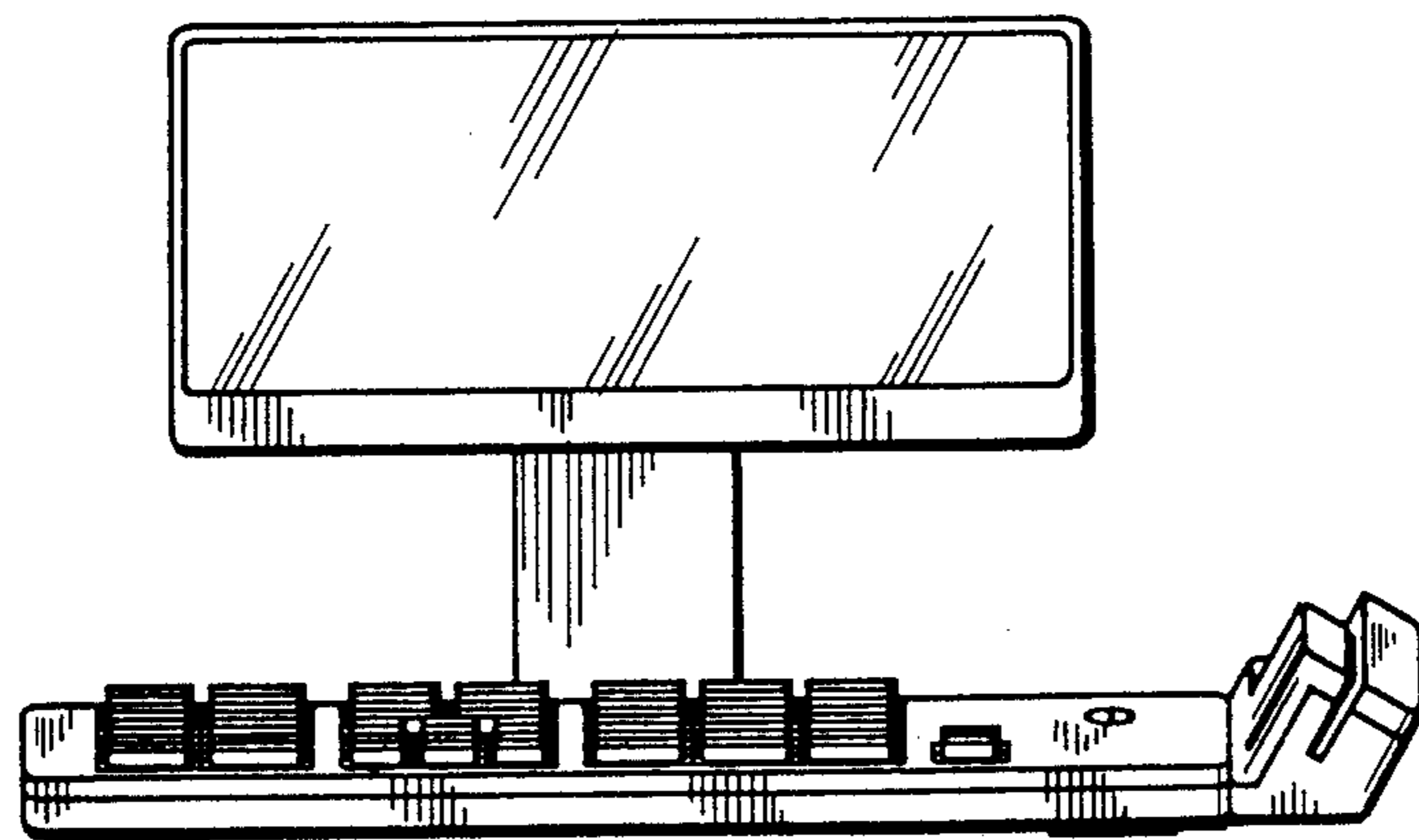

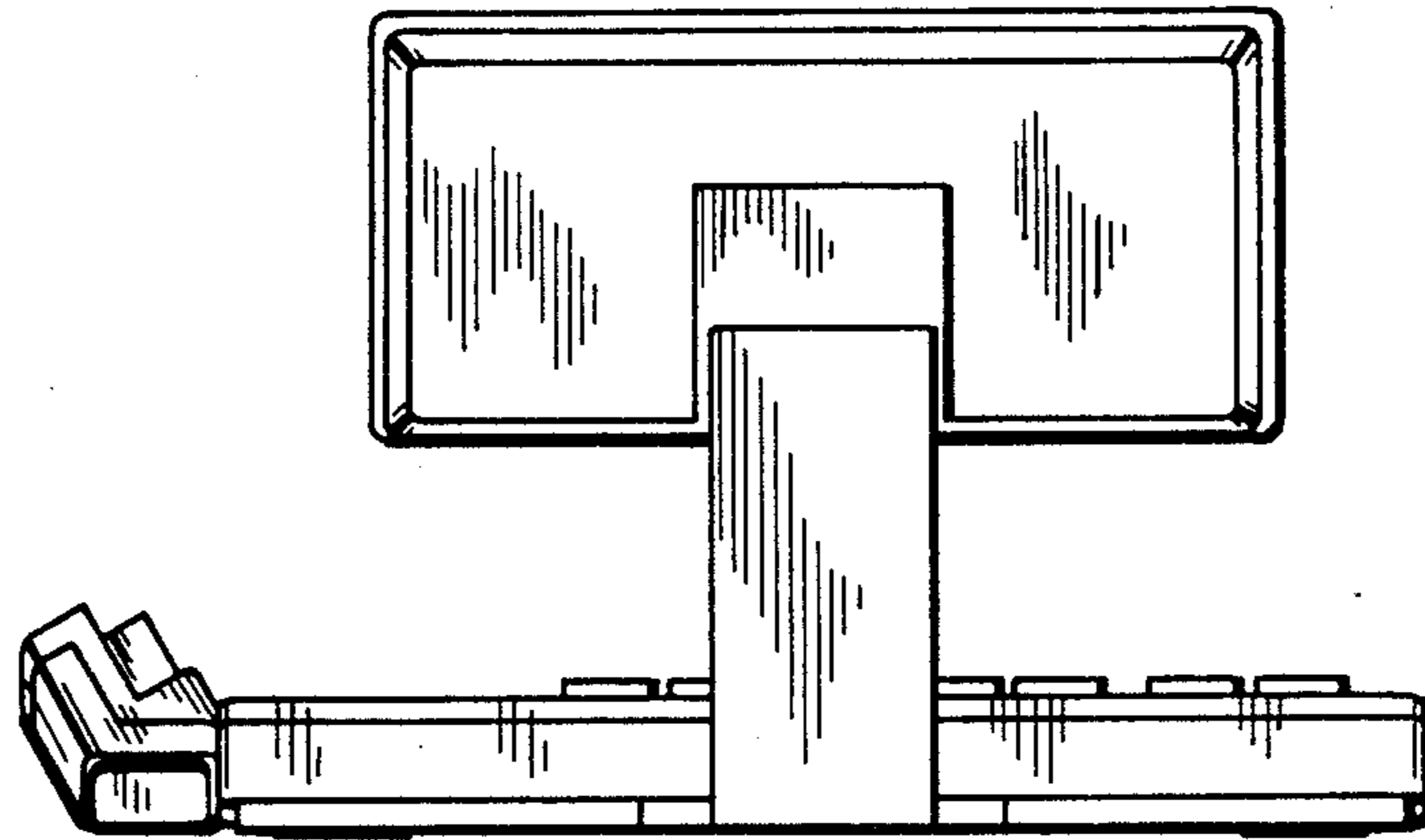

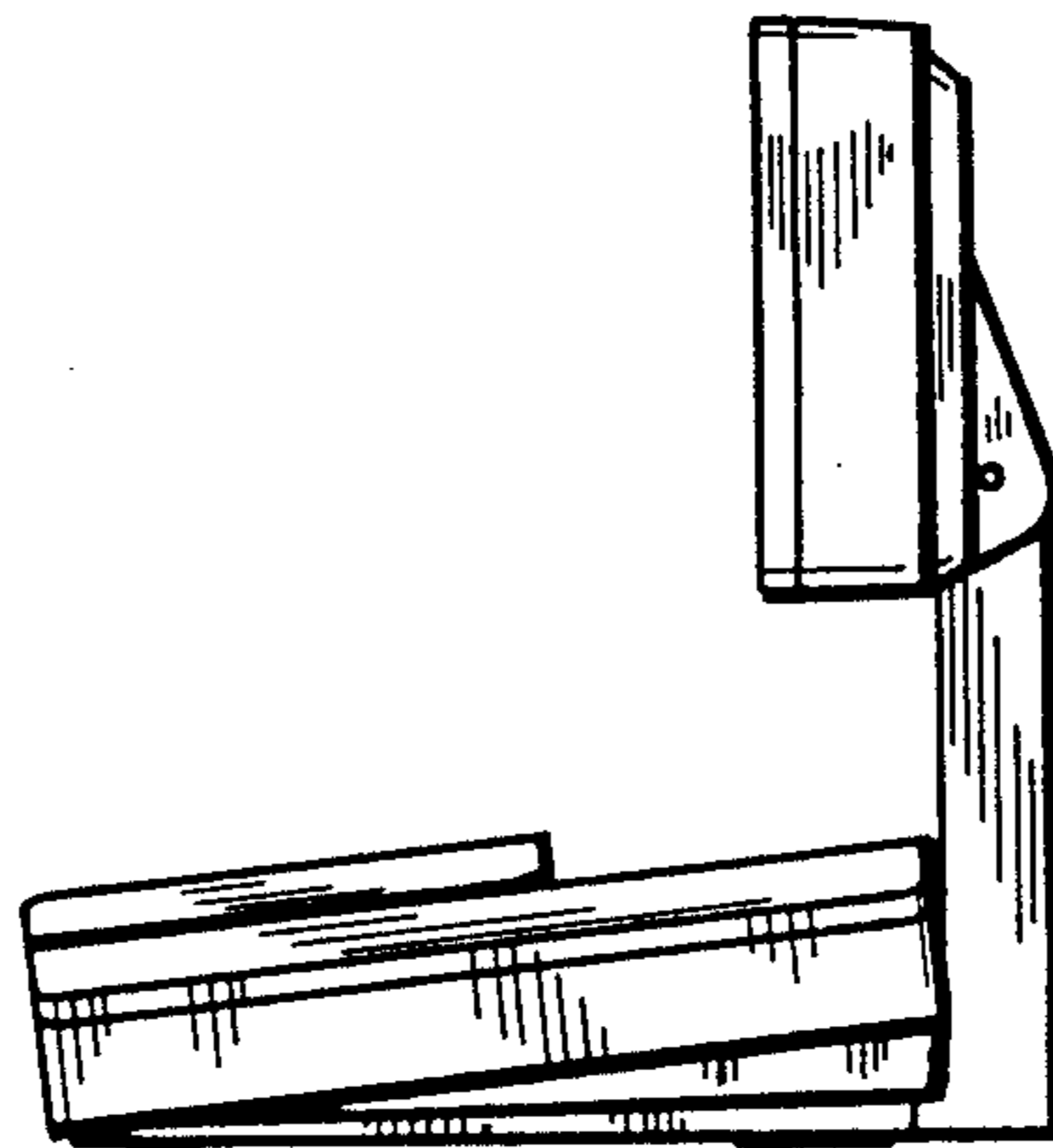

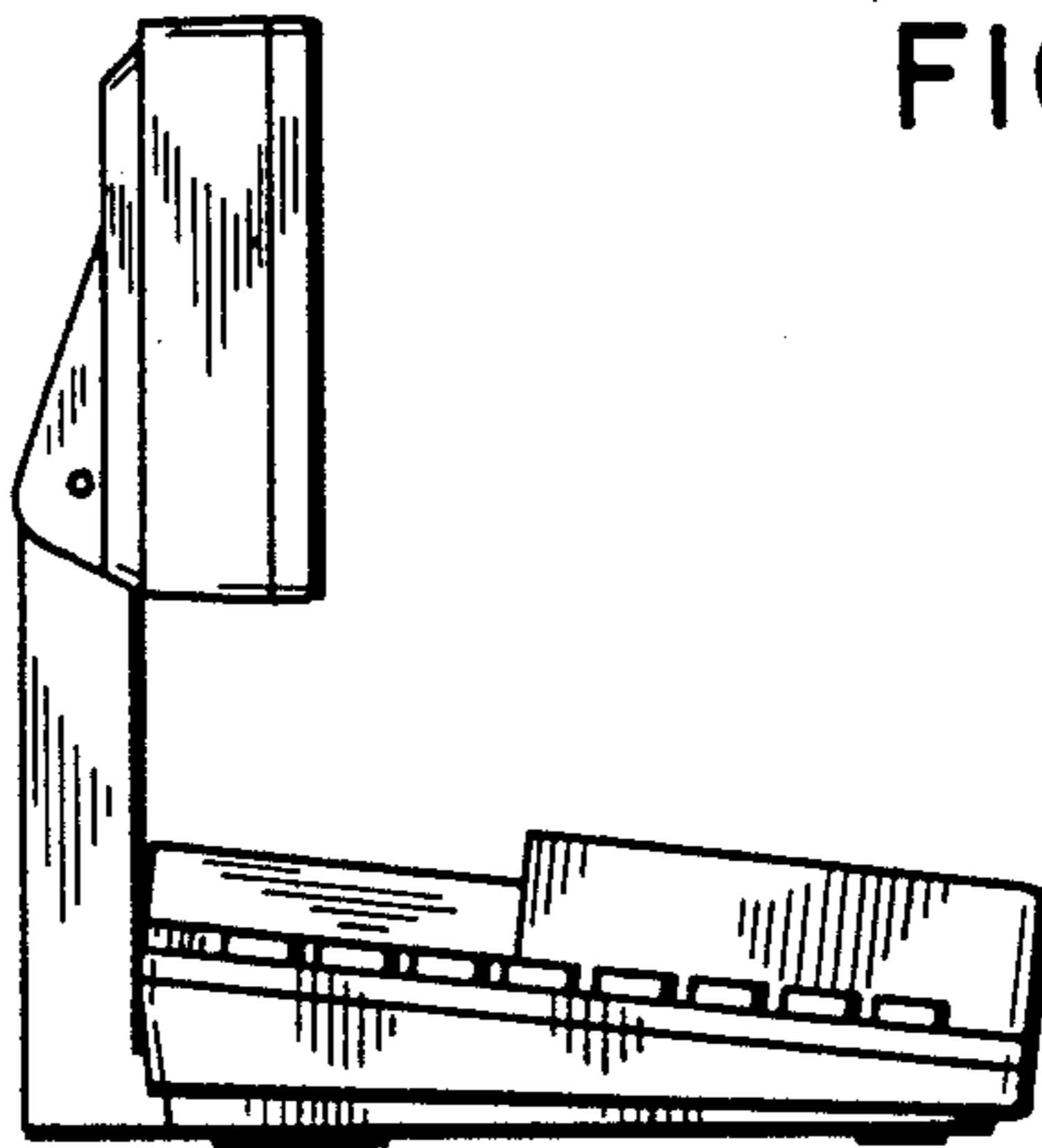

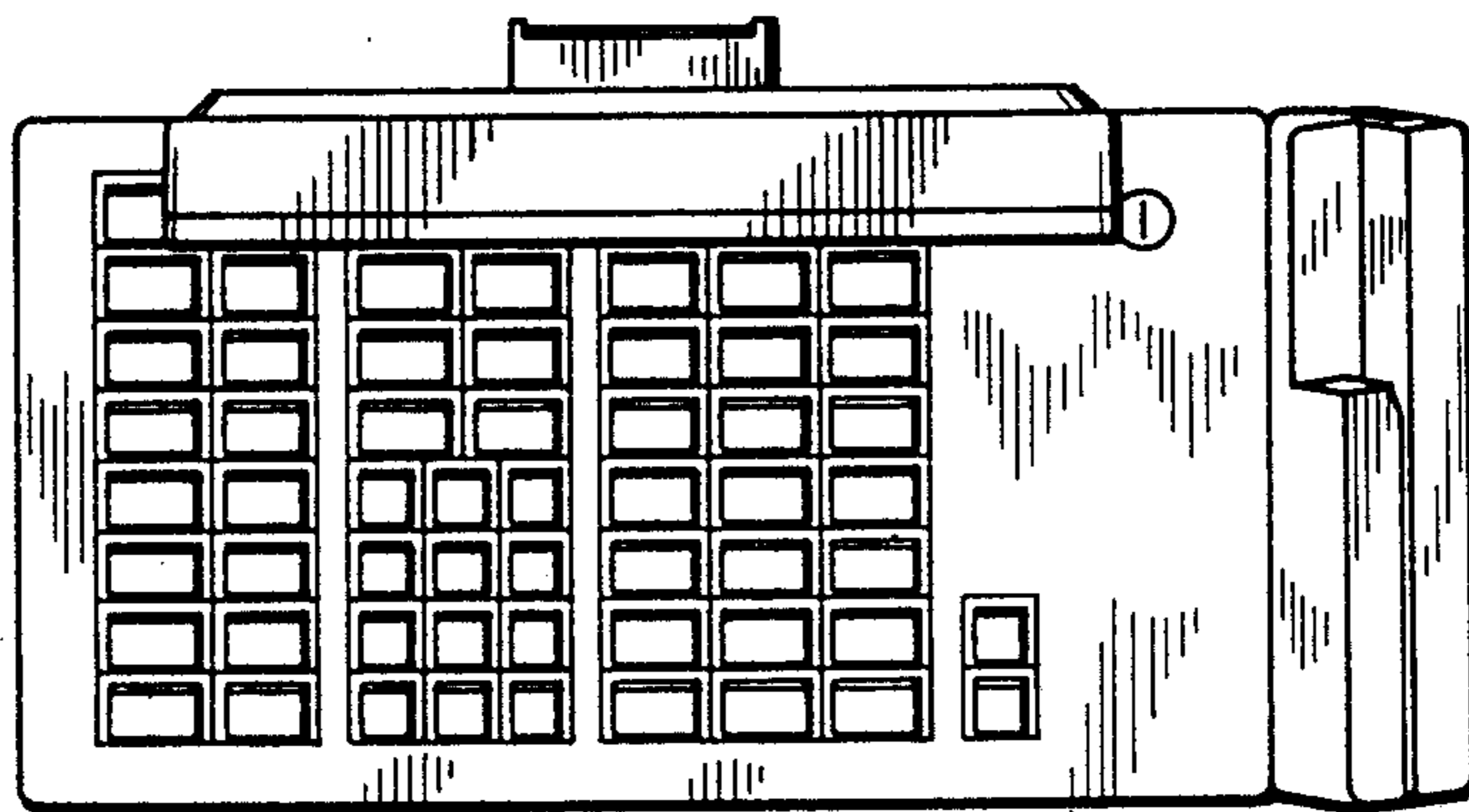

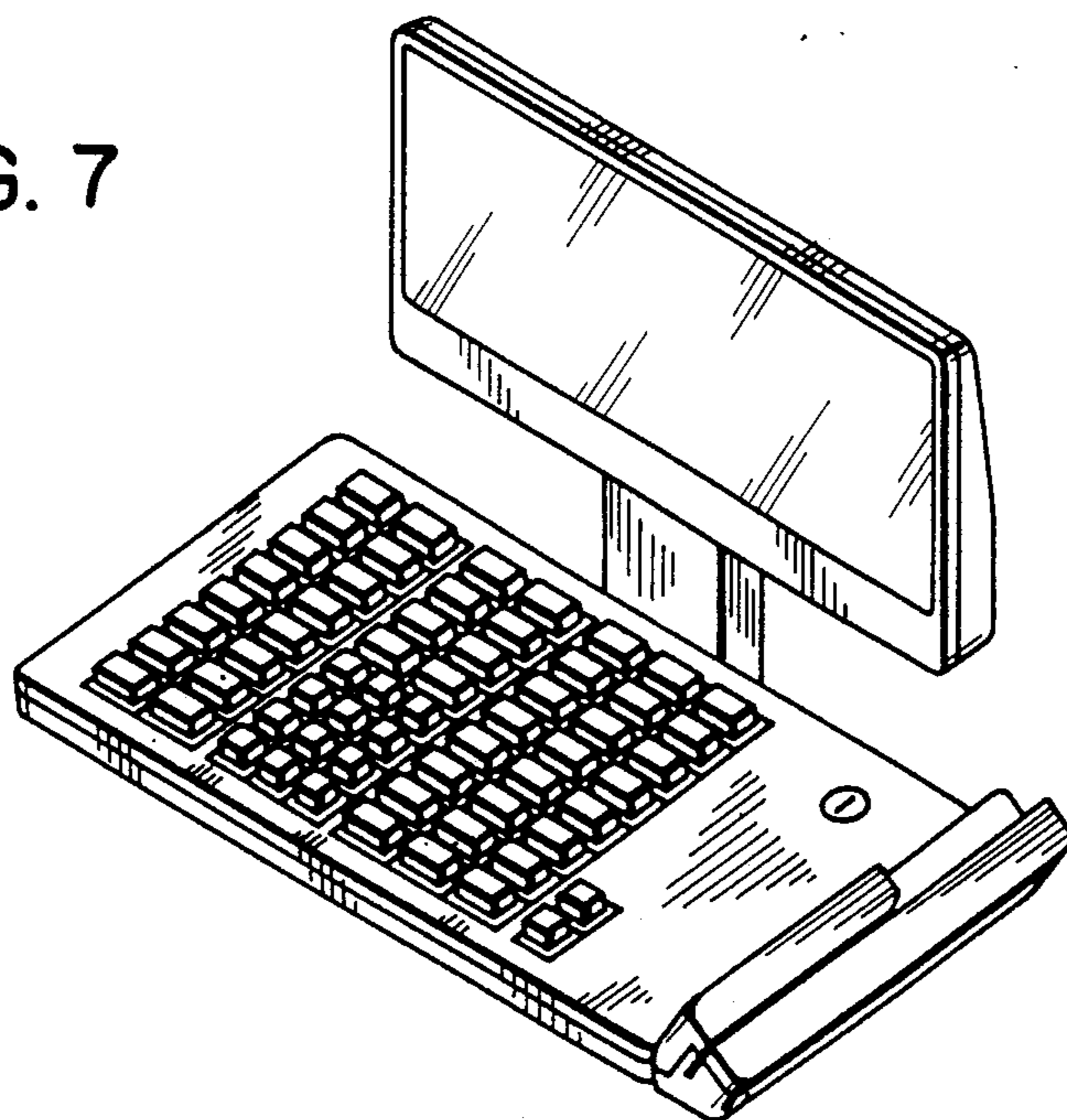

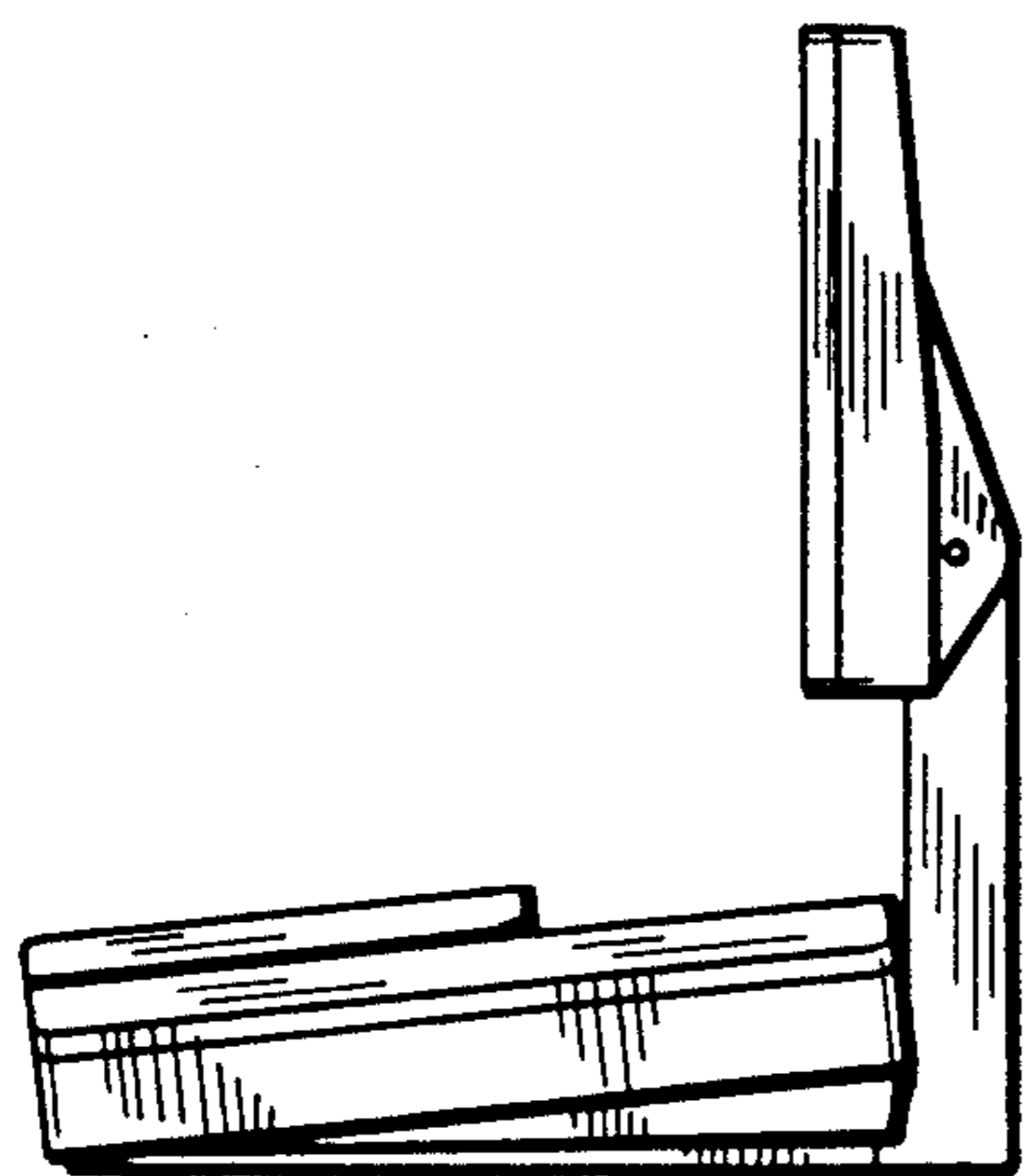

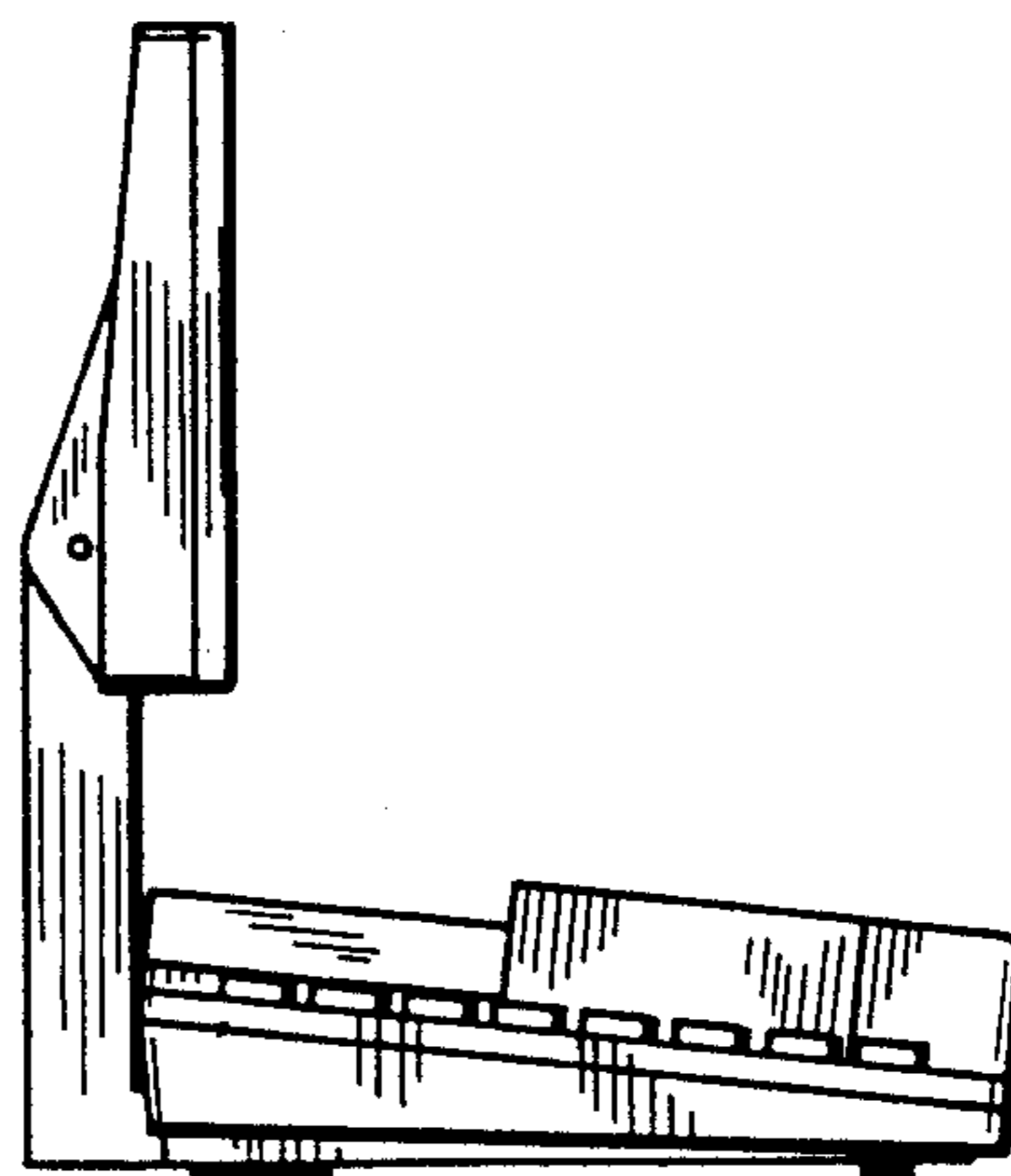

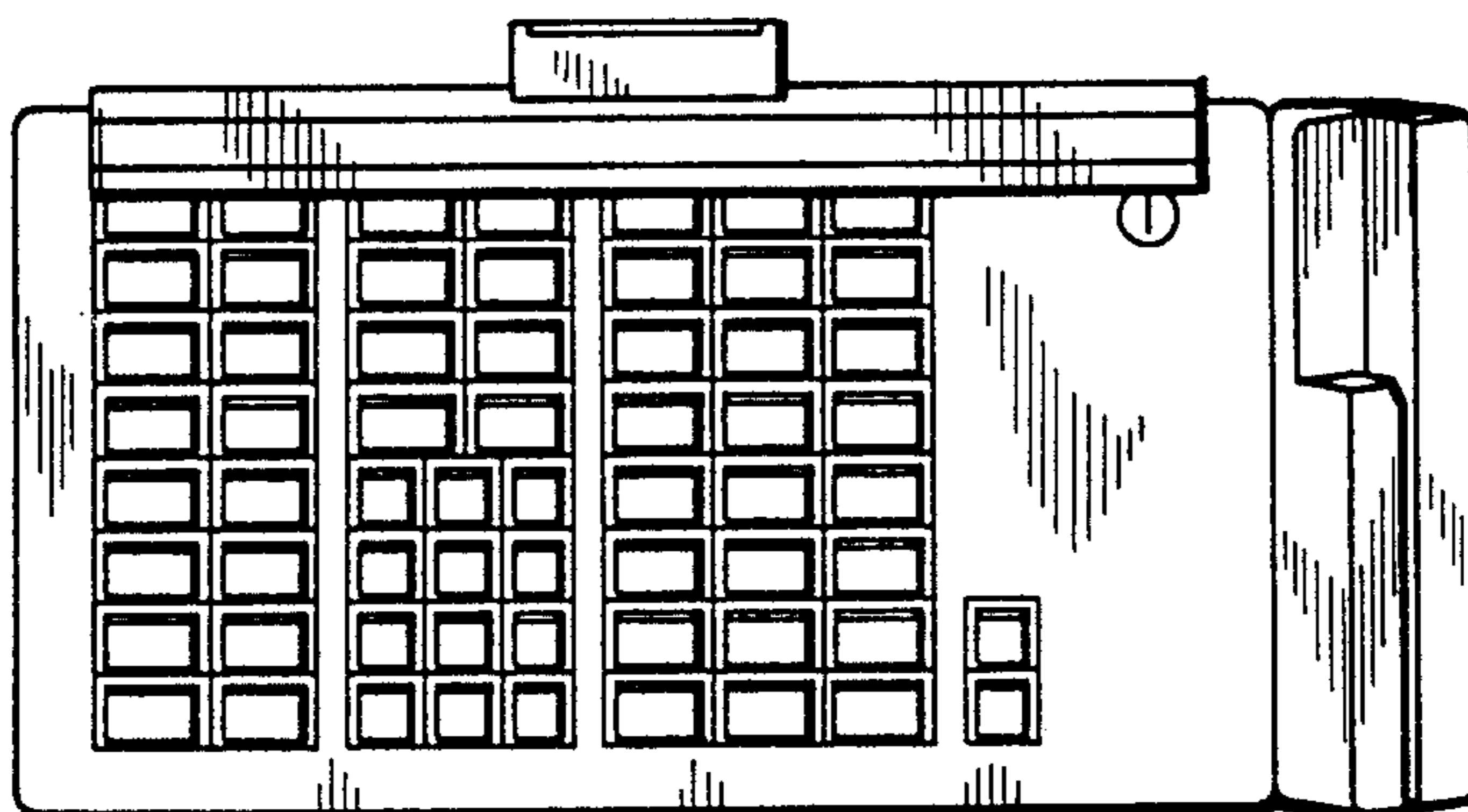
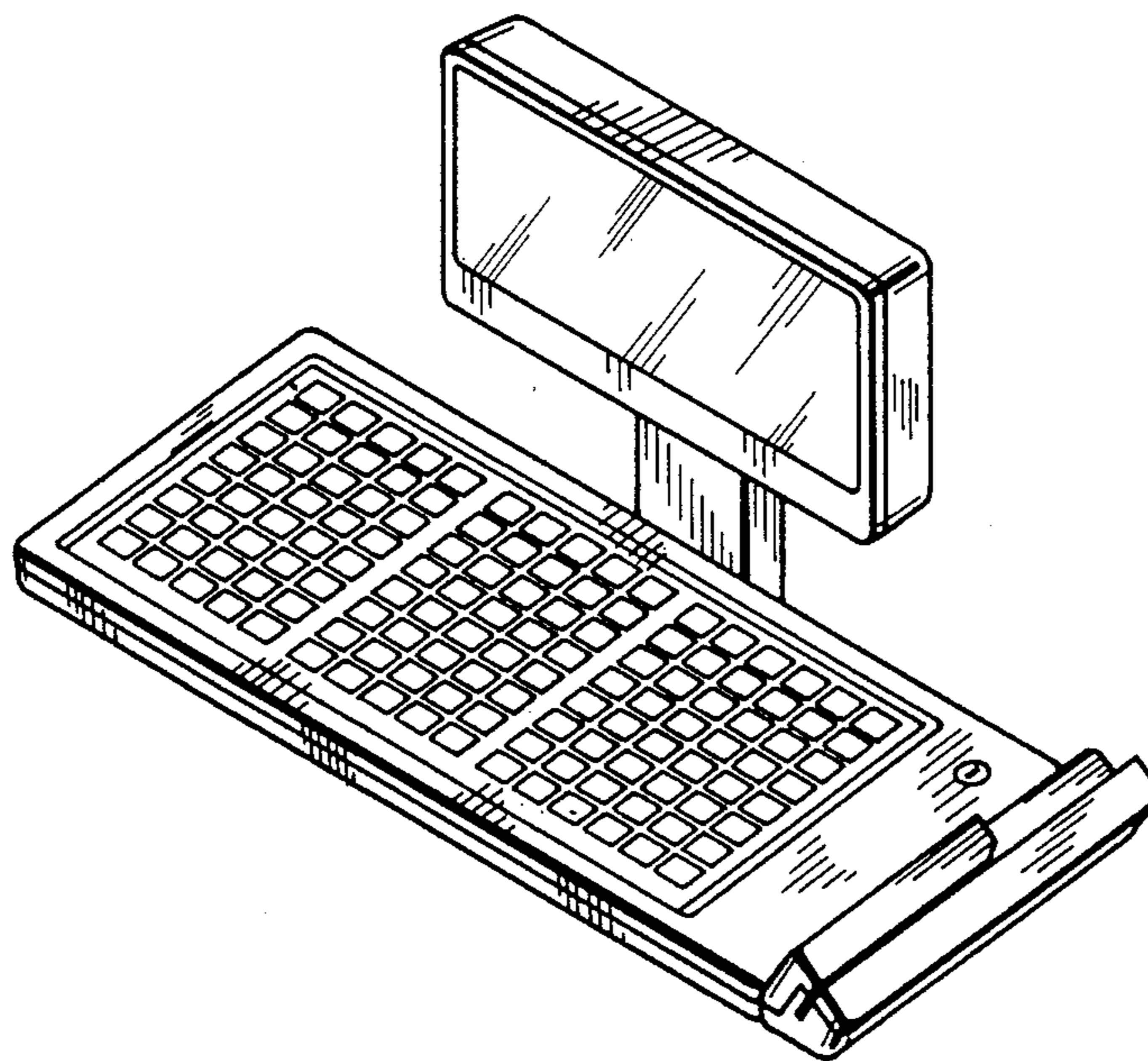

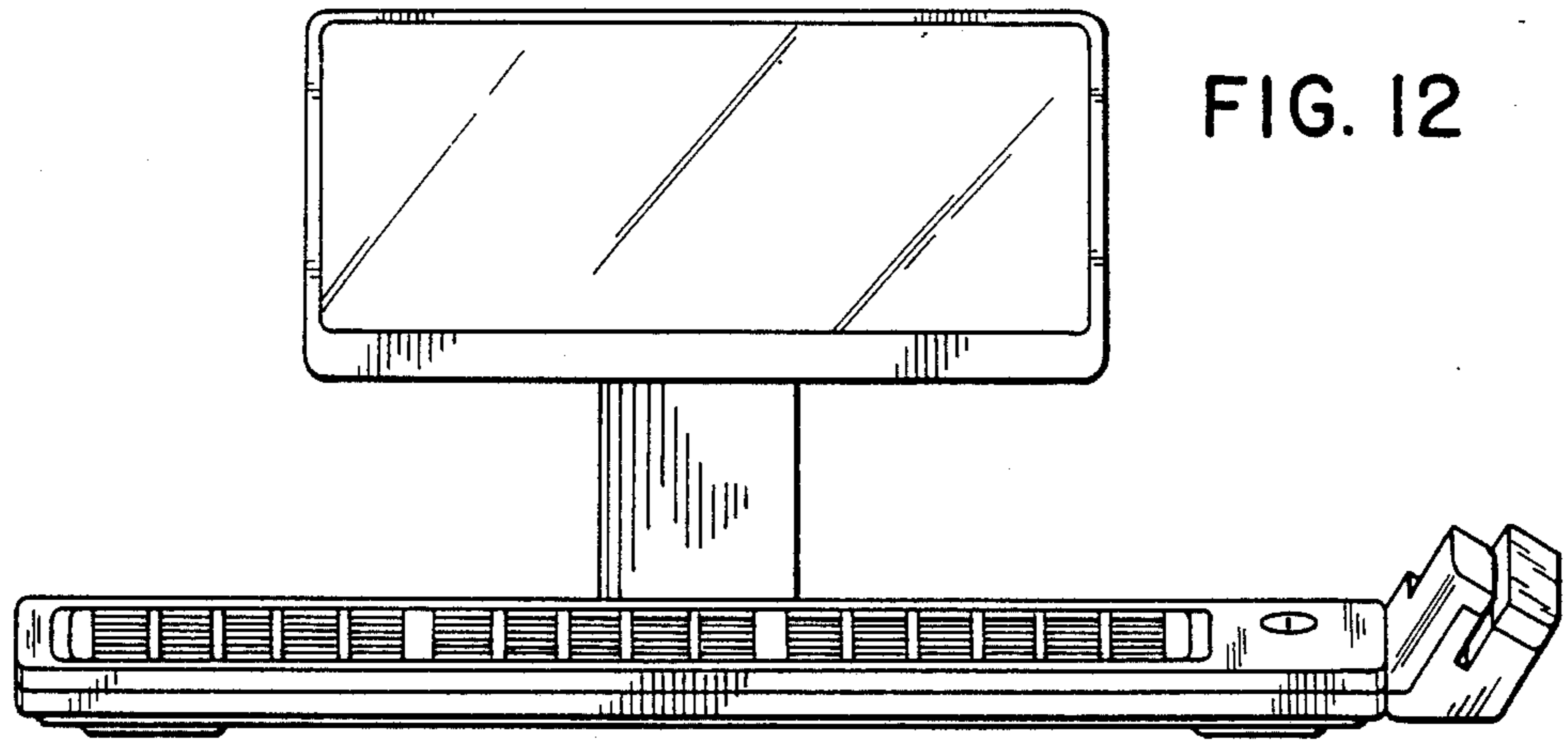

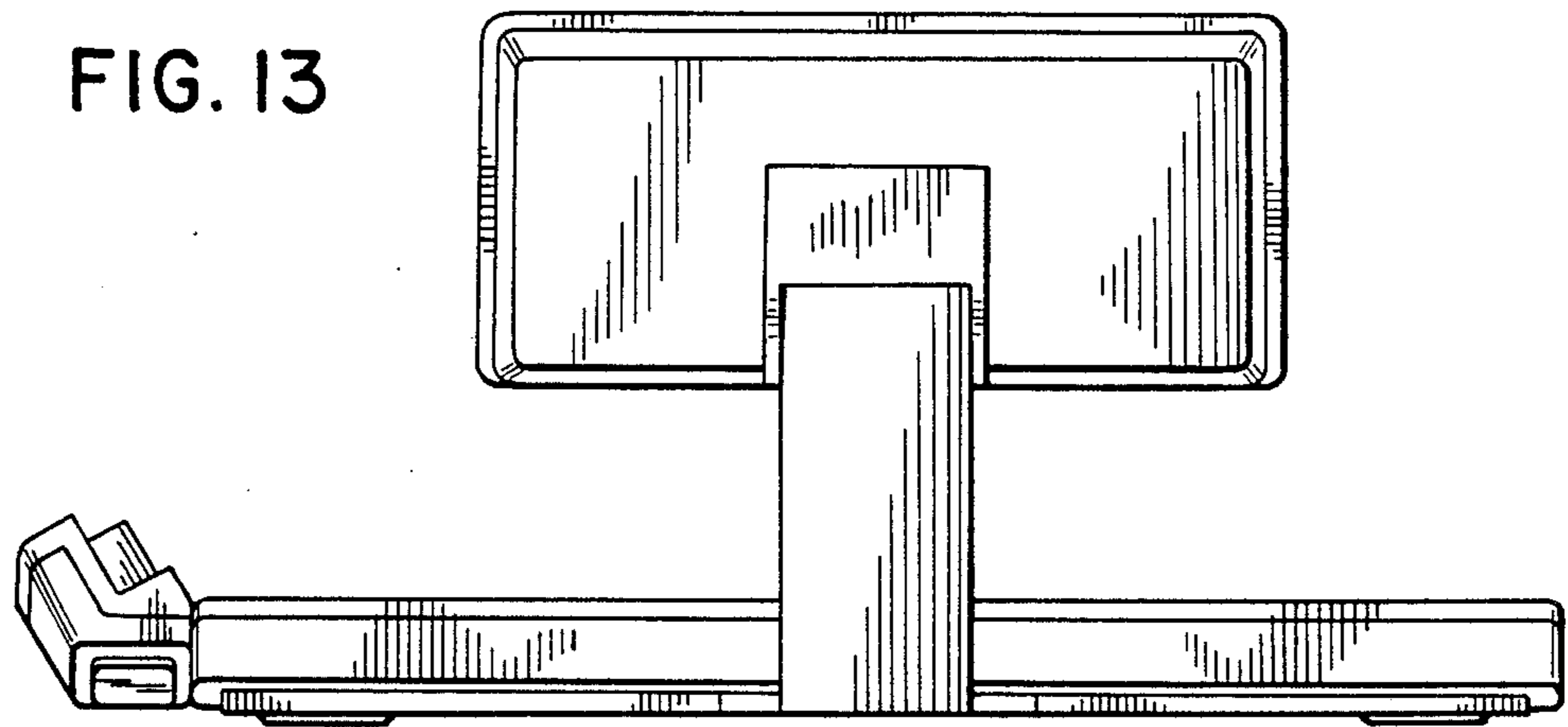

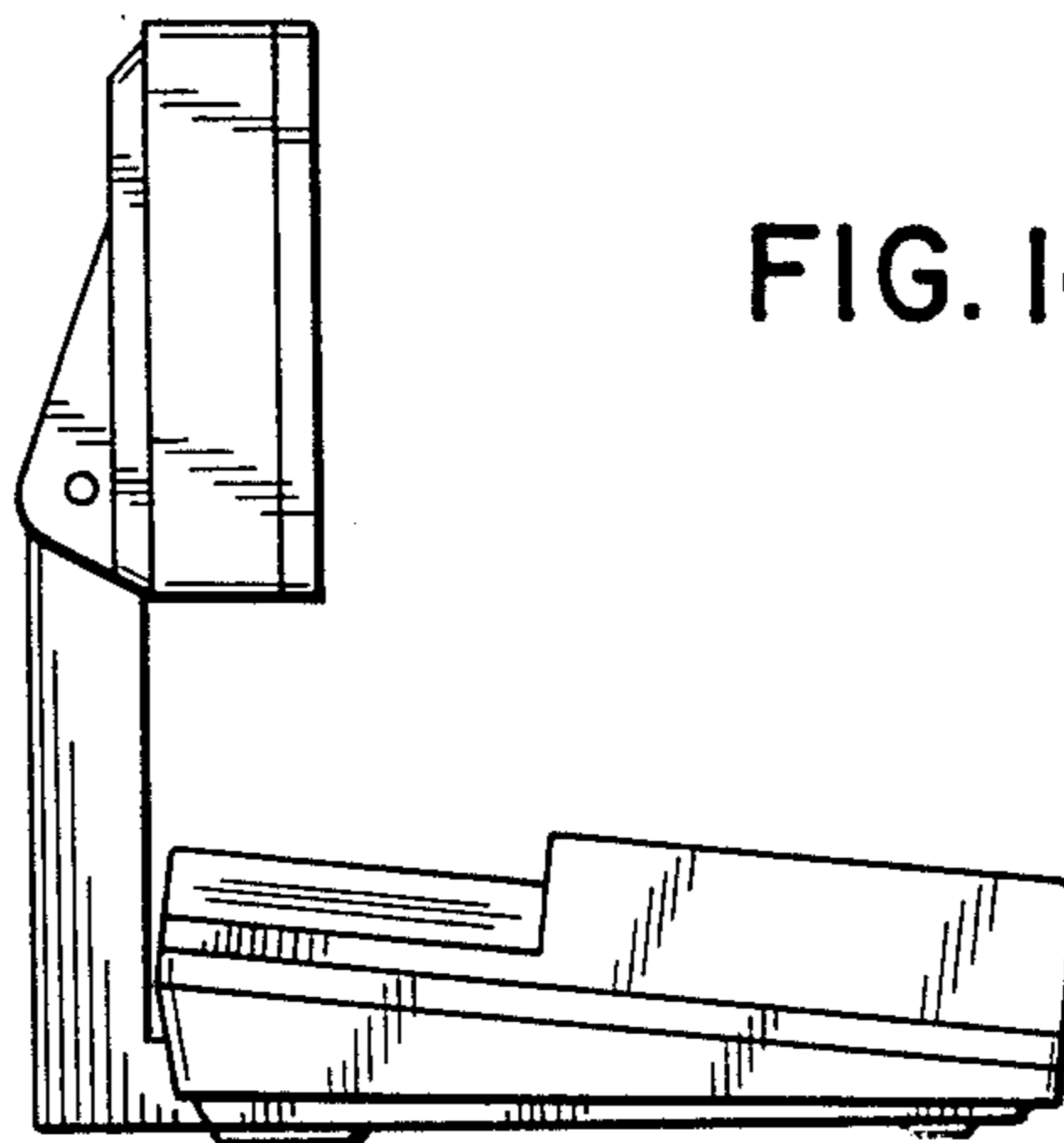
