FIG. 12 is a right side elevational view of the handset removed from the stand;

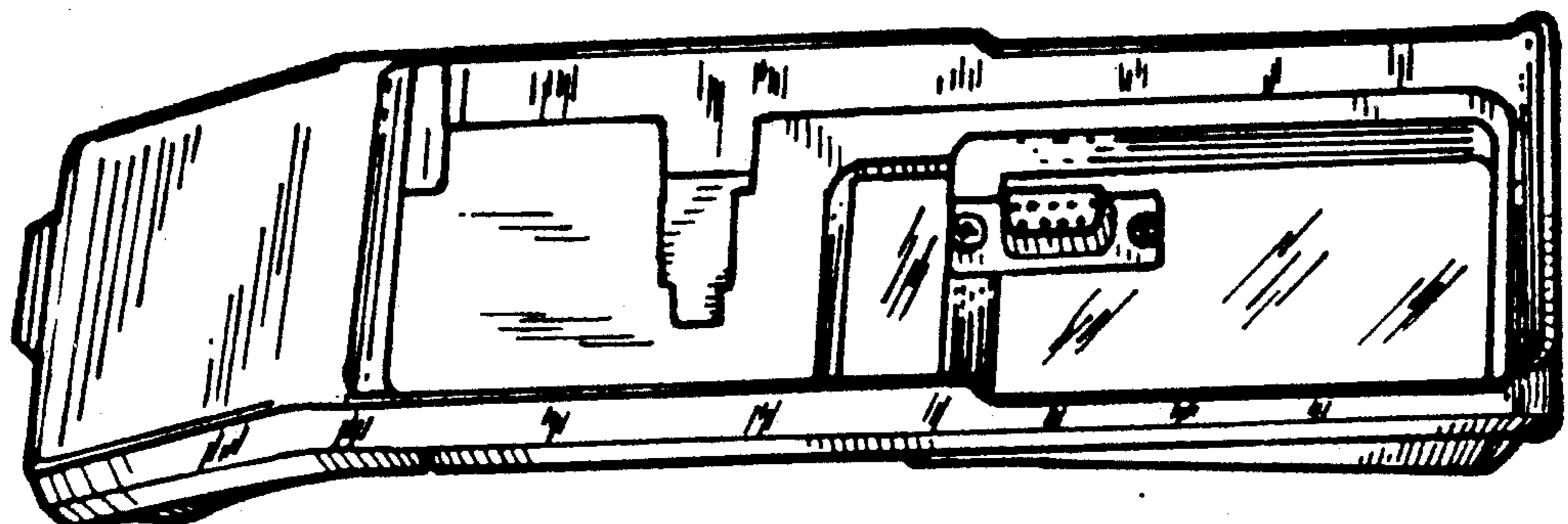
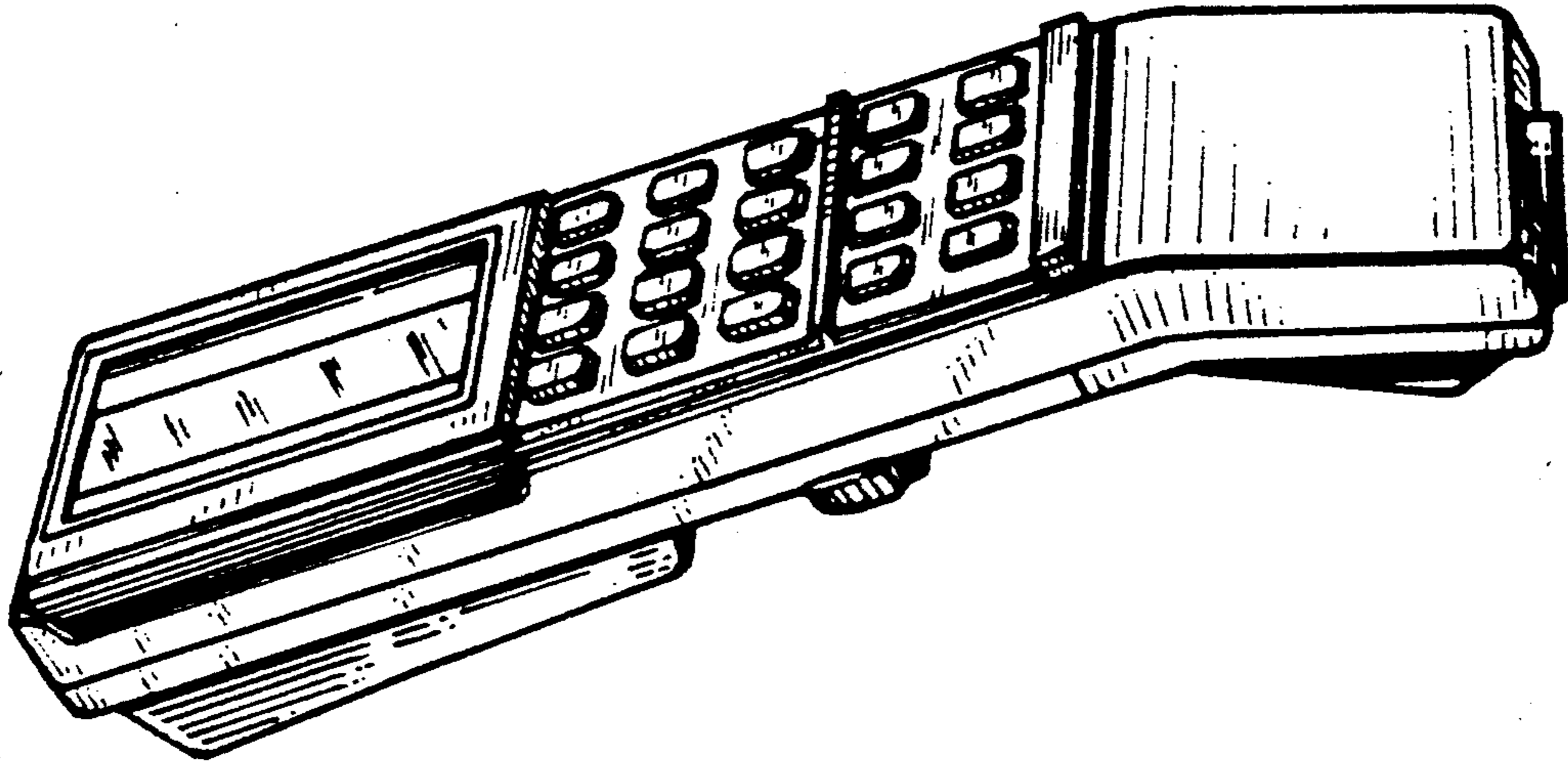
FIG. 13 is a left side elevational view thereof;

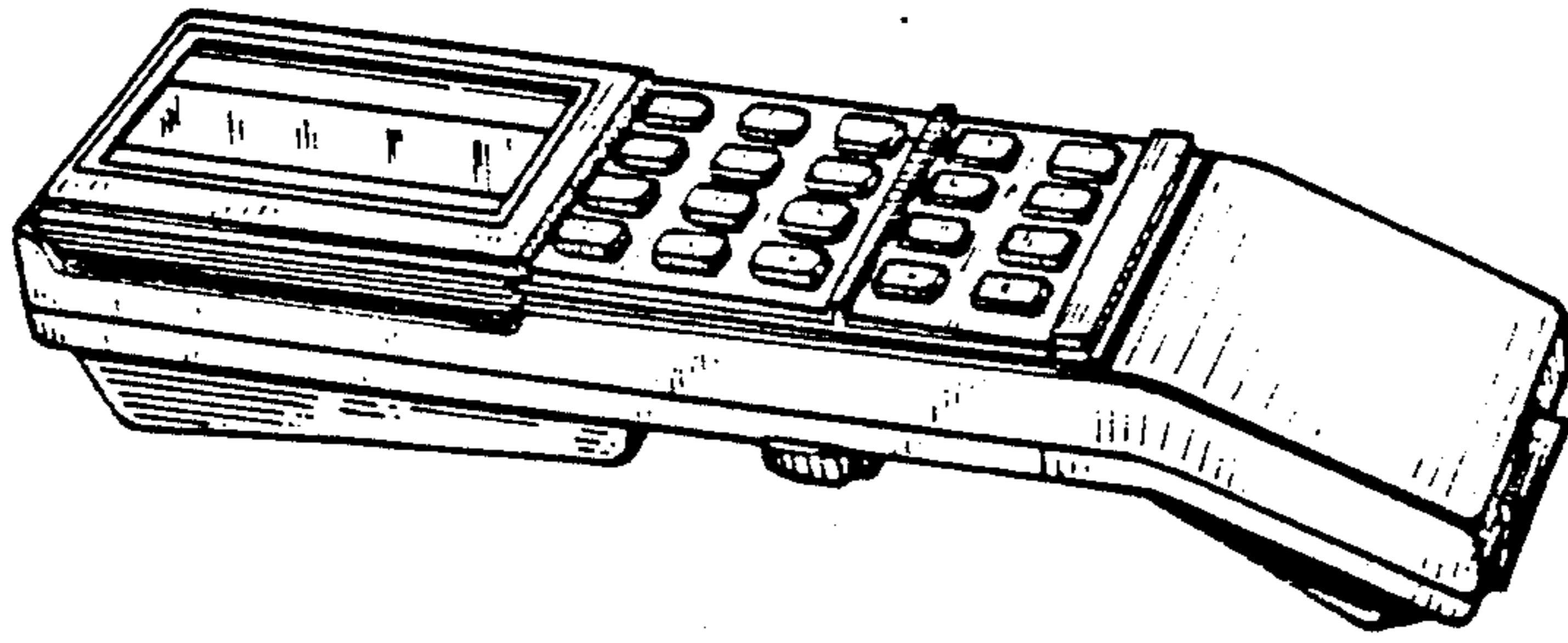

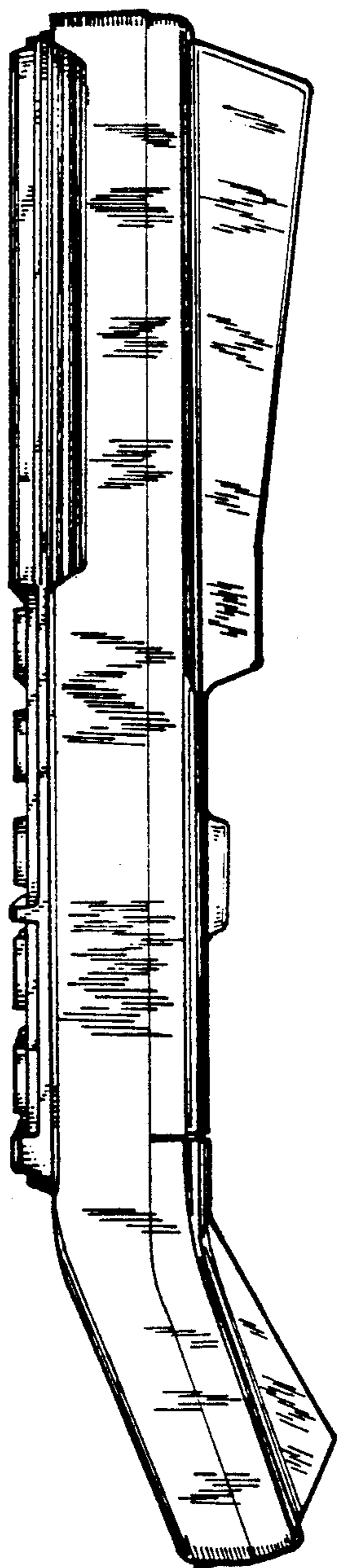

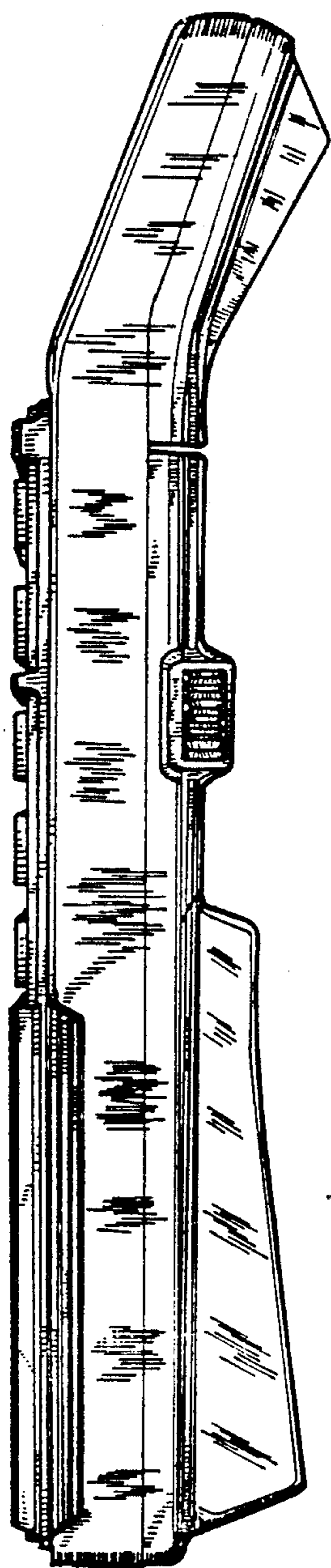

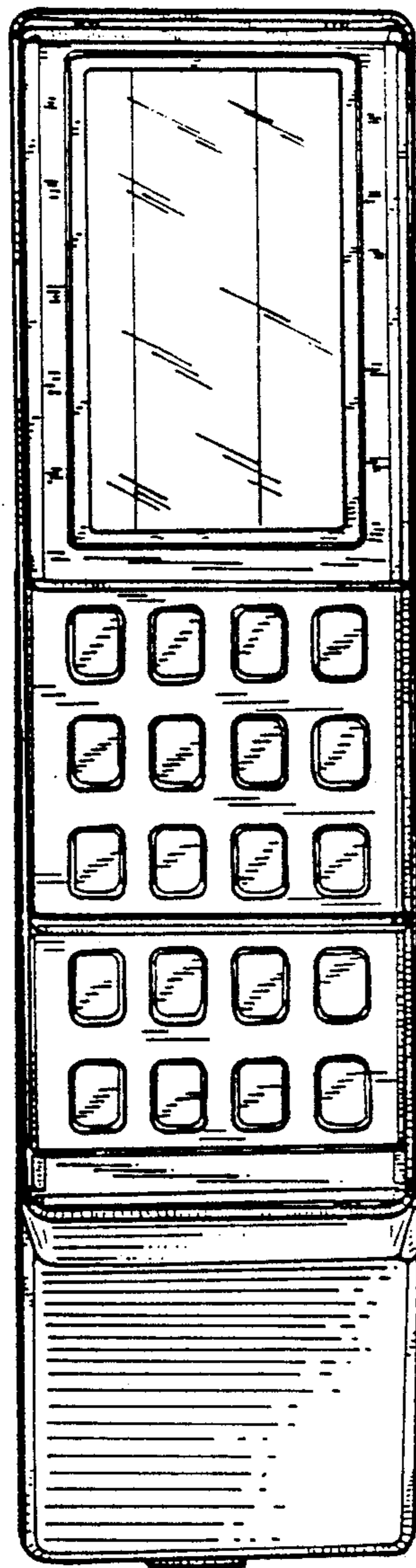

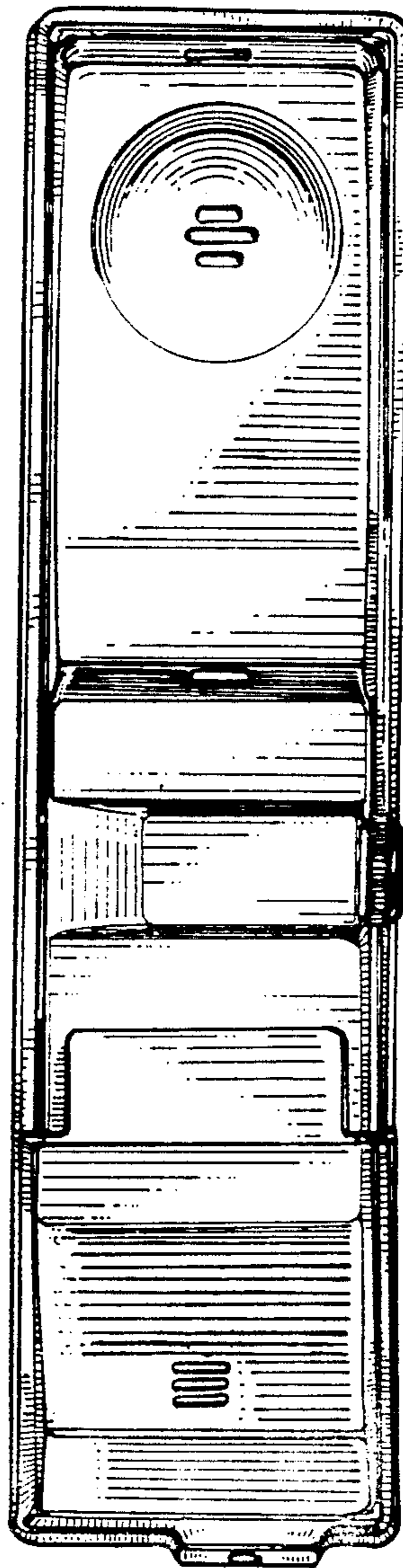

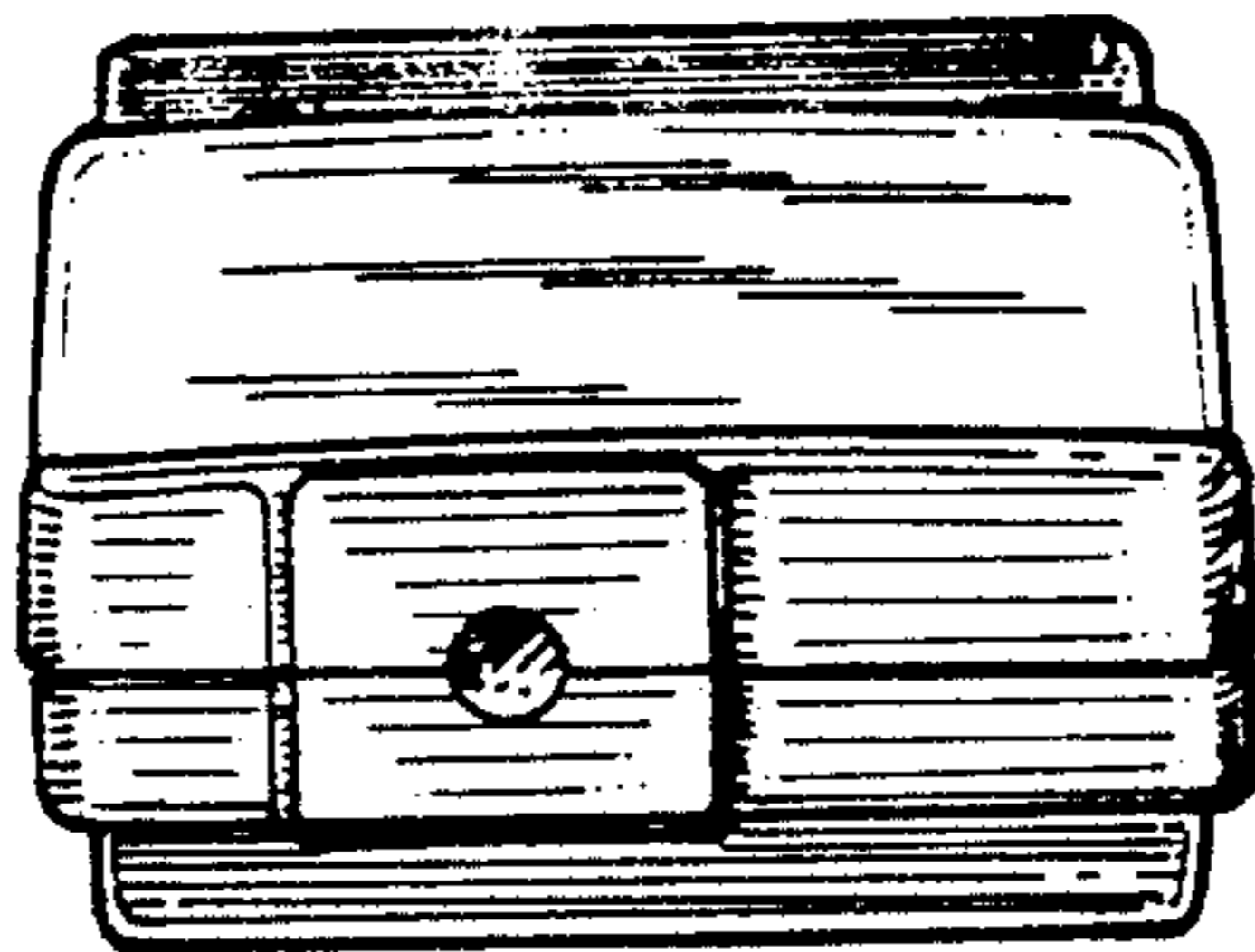

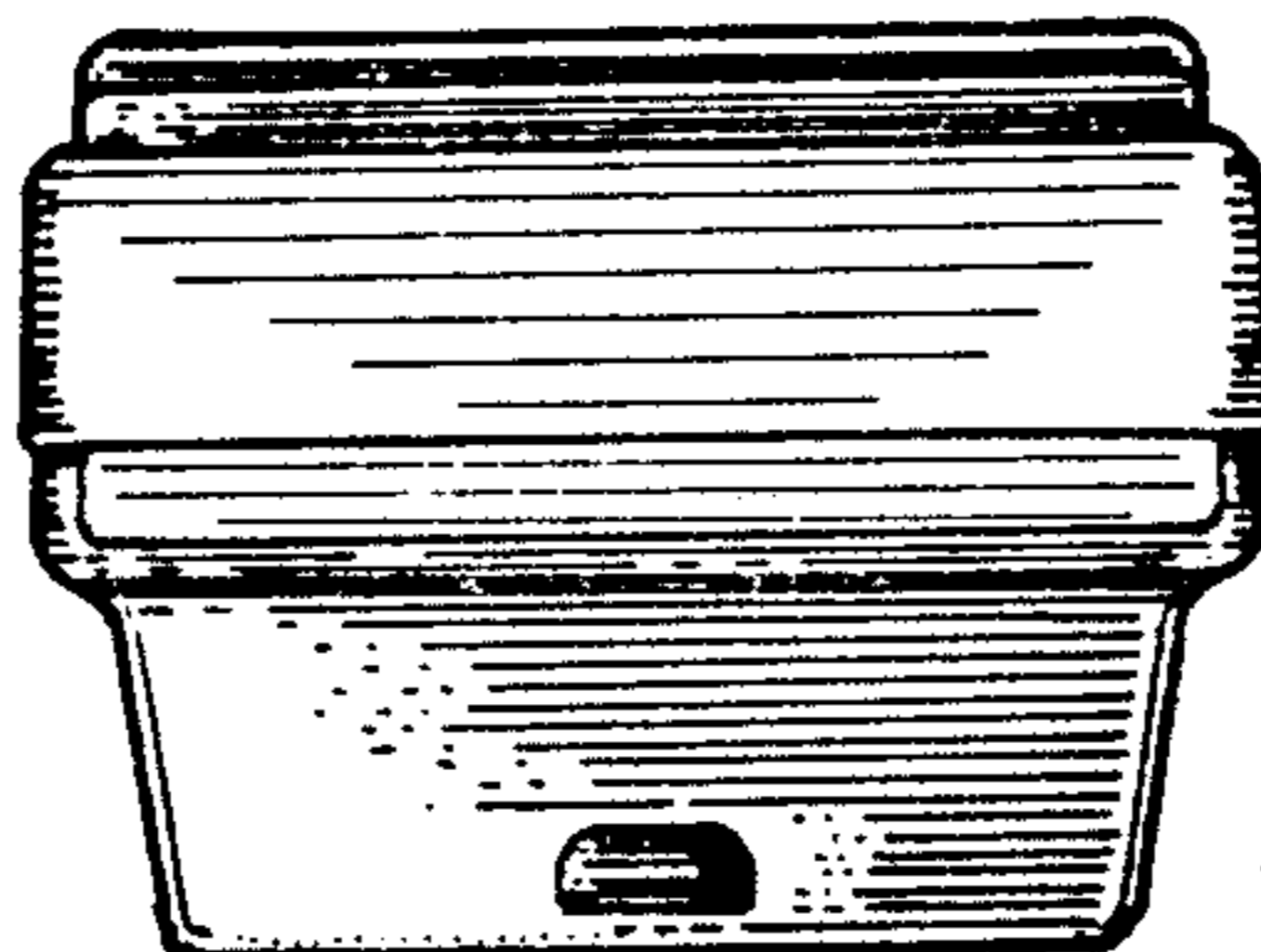

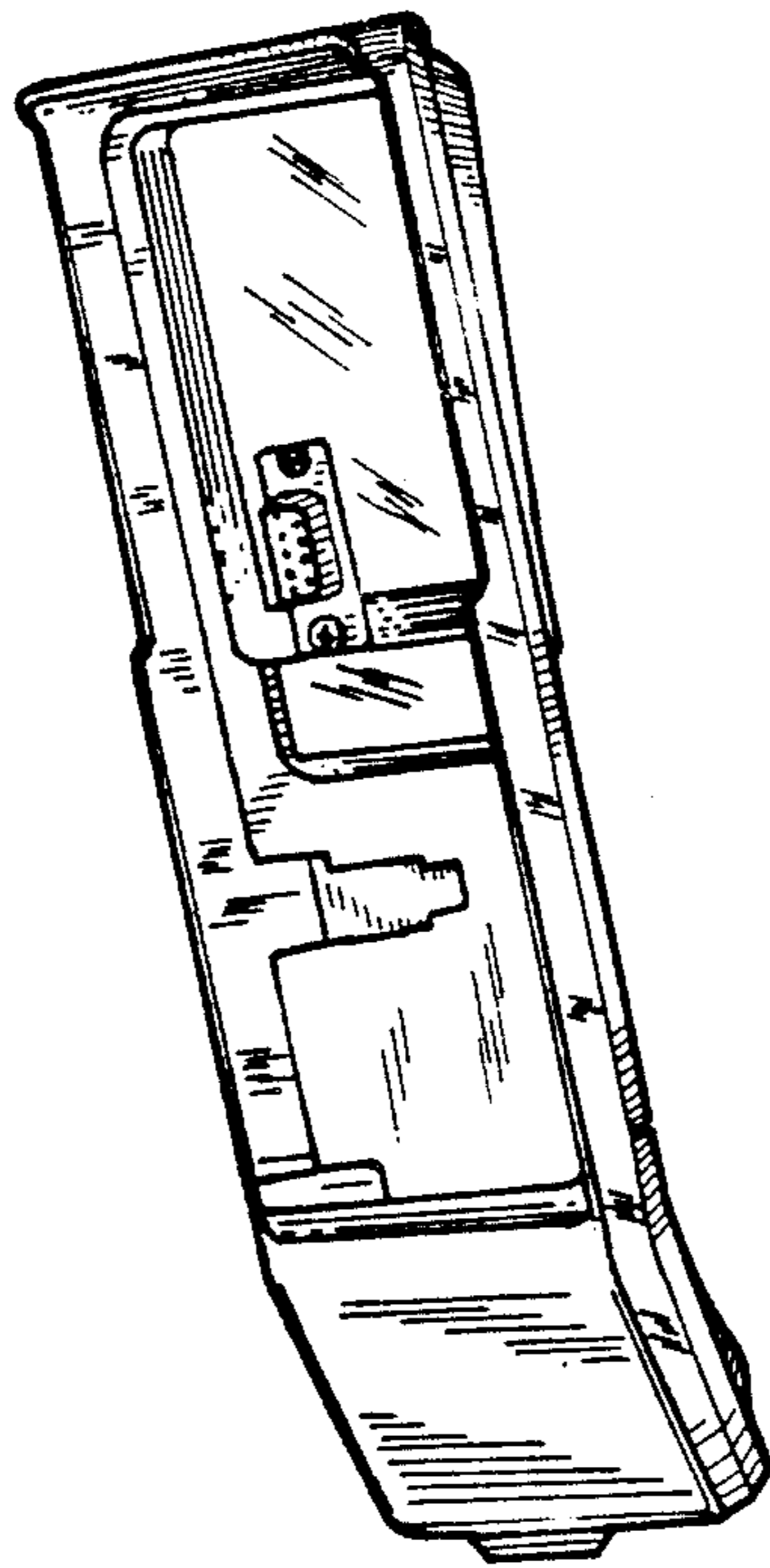

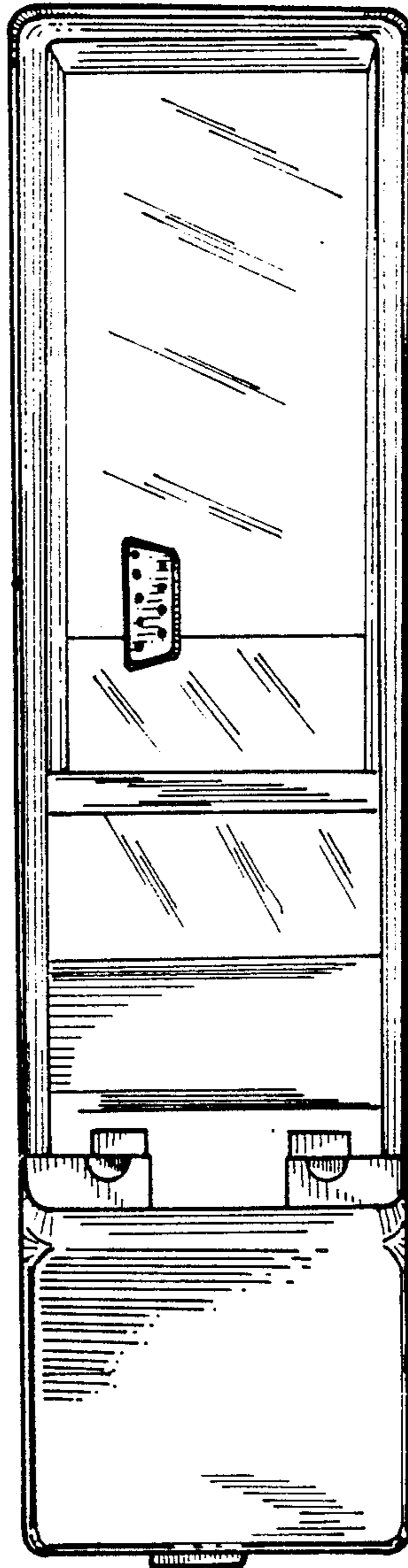

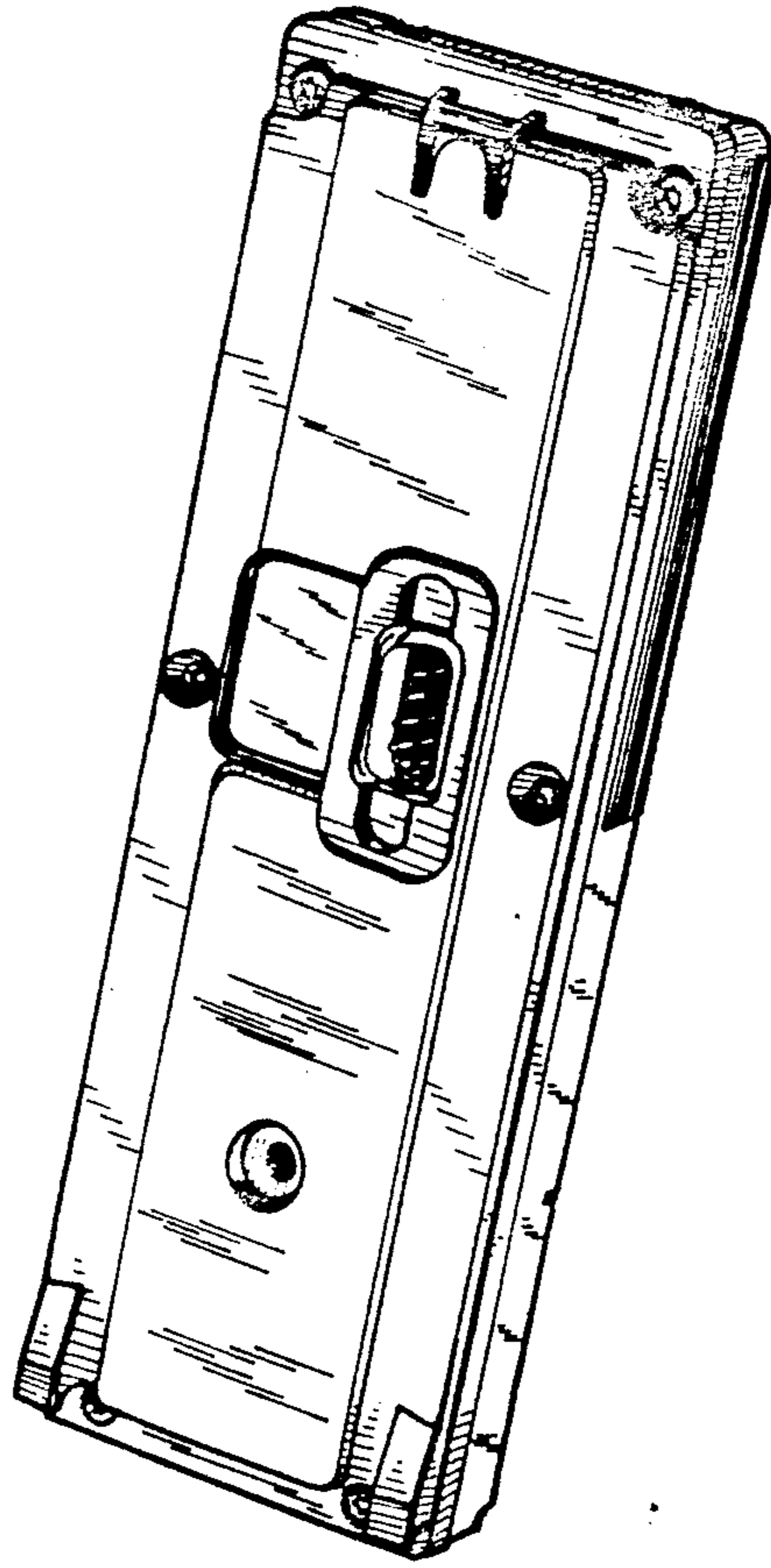

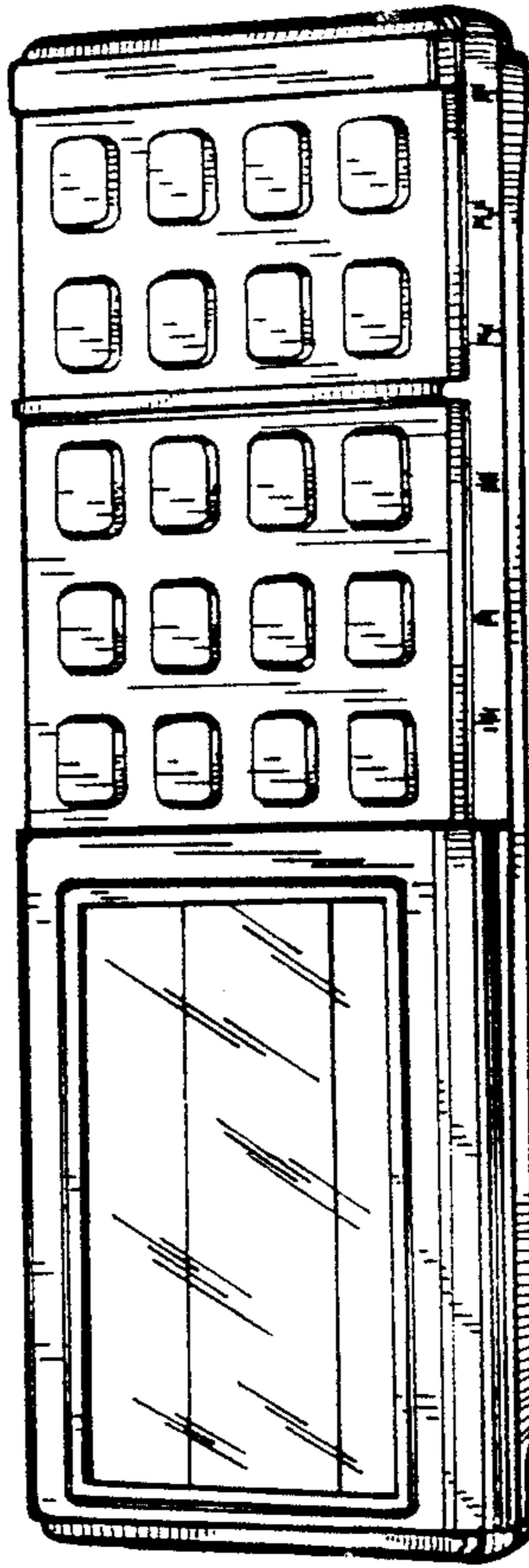

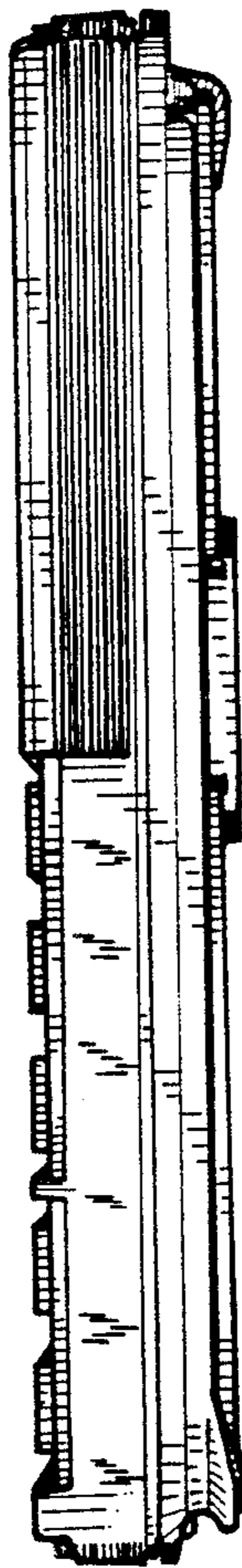

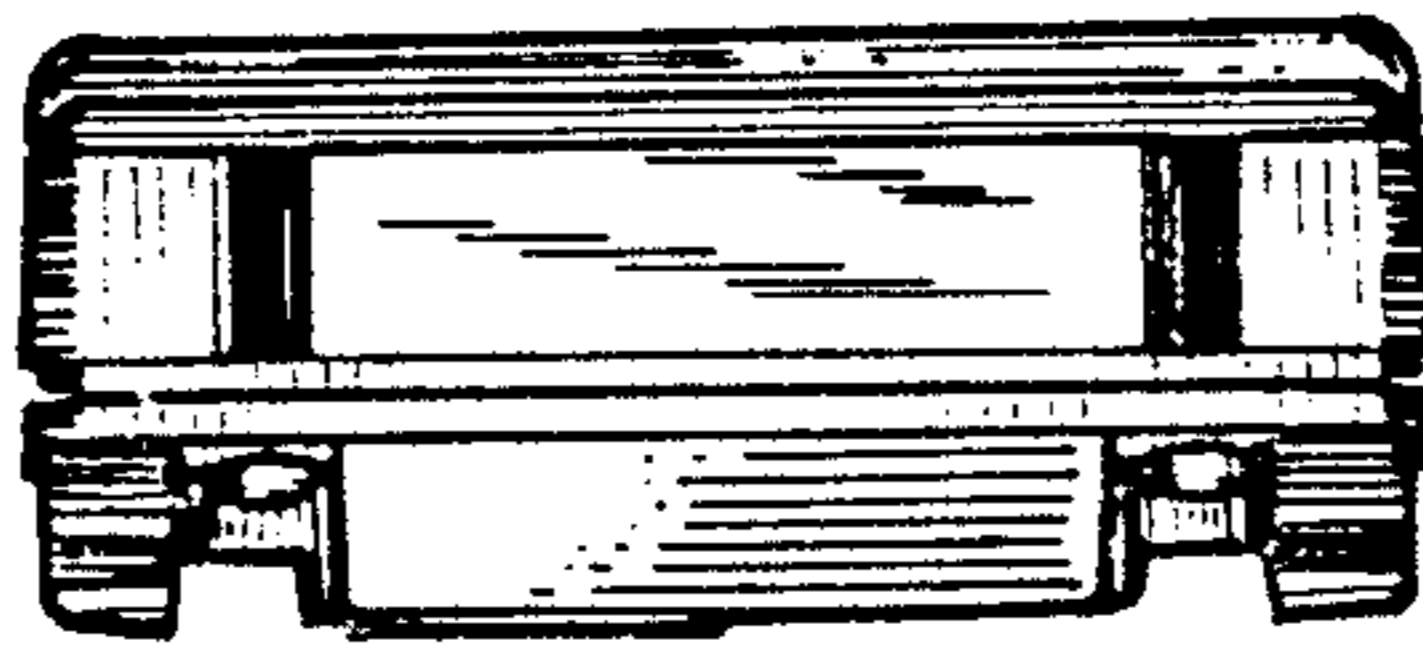

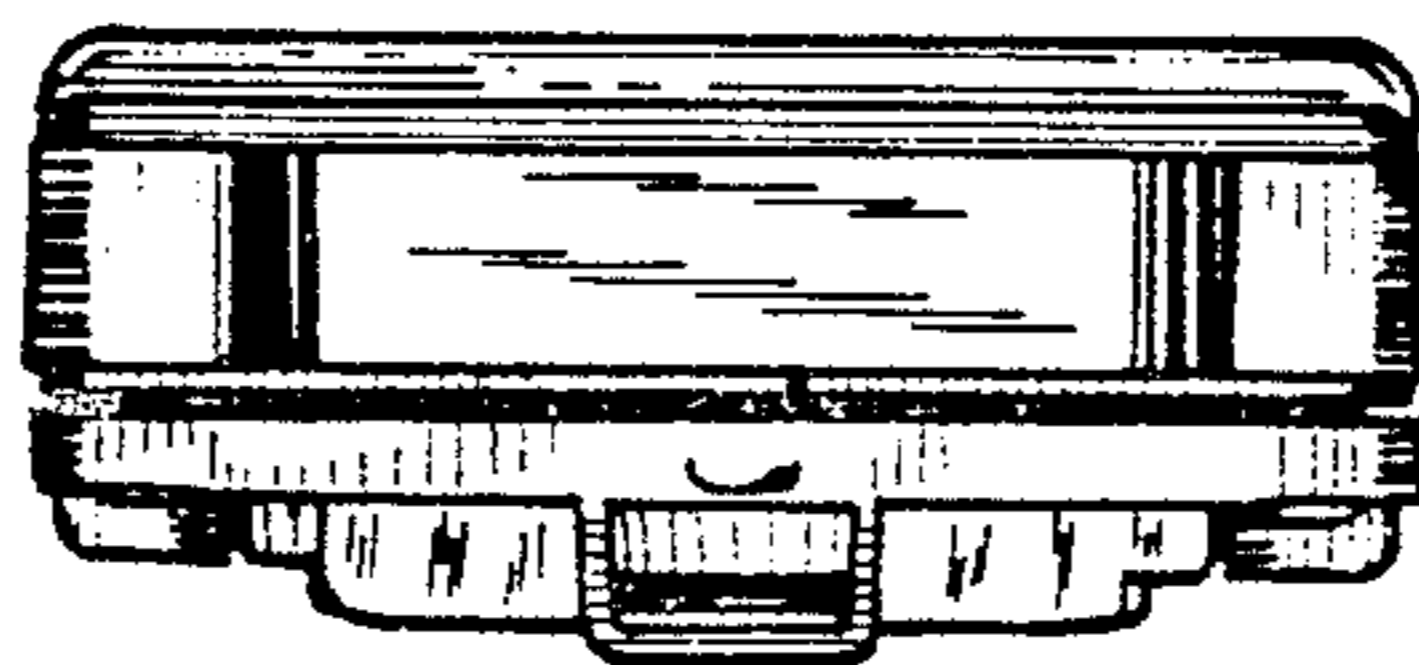
