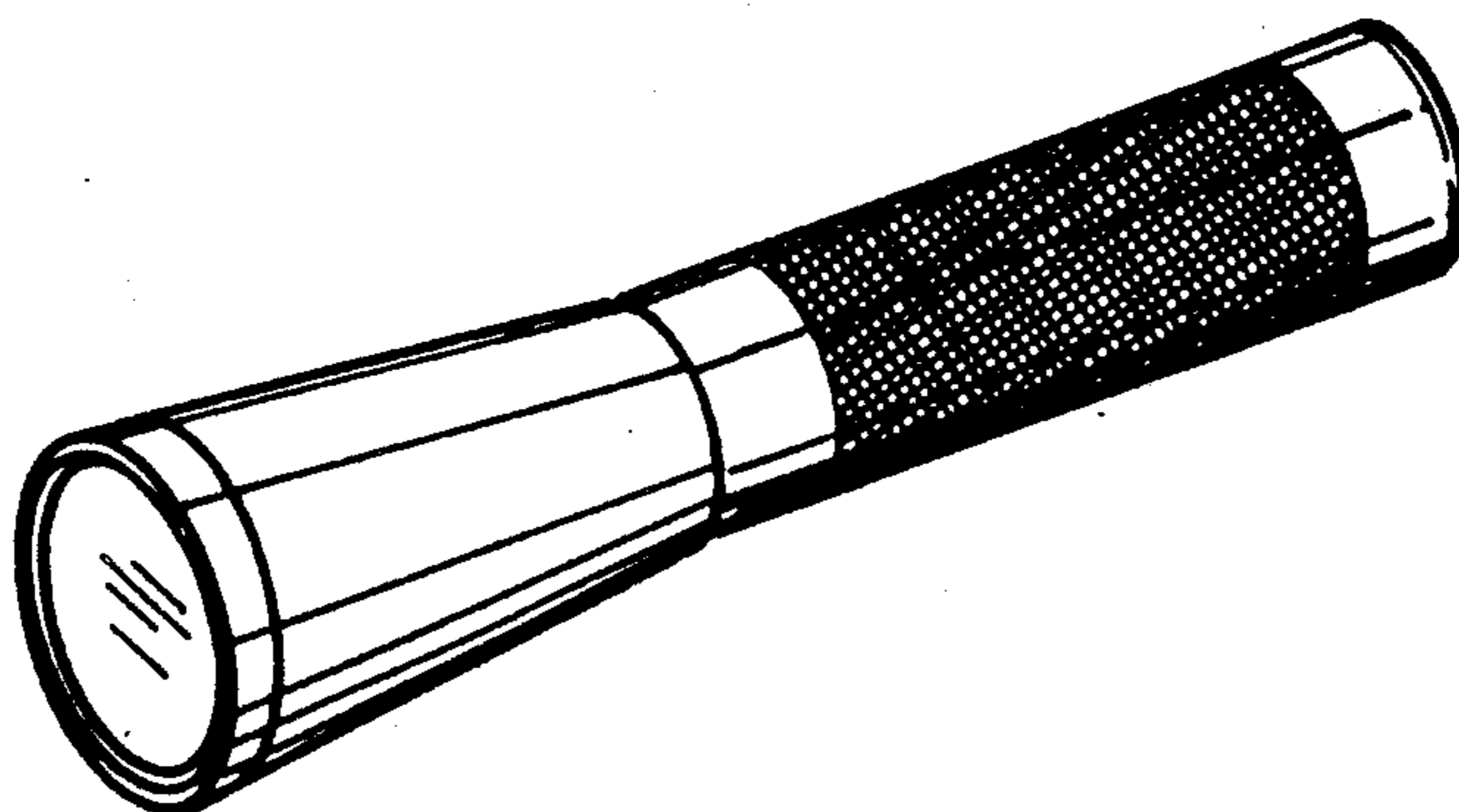

The ornamental design for a flashlight, as shown and described.

**DESCRIPTION**

FIG. 1 is a side elevational view of a flashlight showing my new design, the opposite side being identical. FIG. 2 is a front elevational view thereof; FIG. 3 is a rear elevational view thereof; and FIG. 4 is a perspective view thereof.



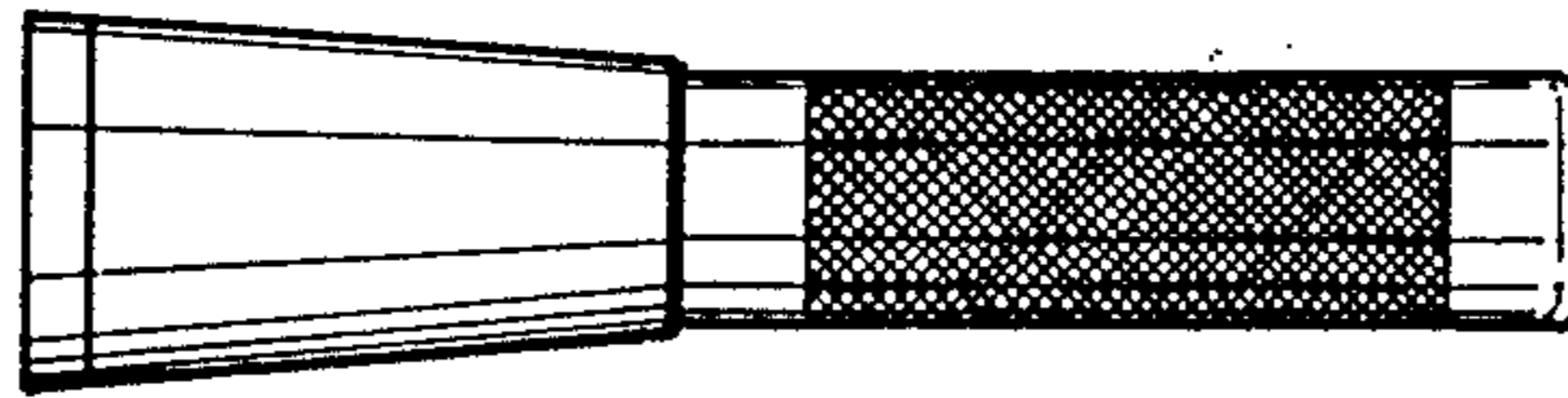

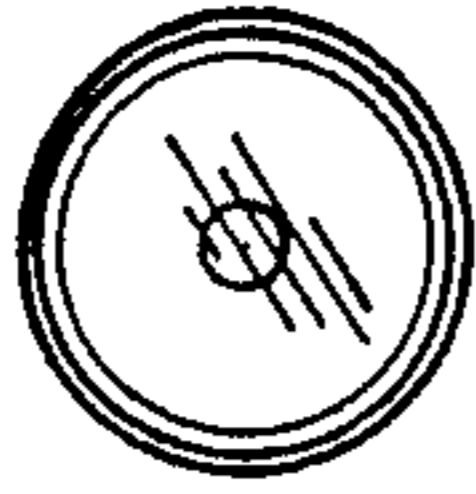

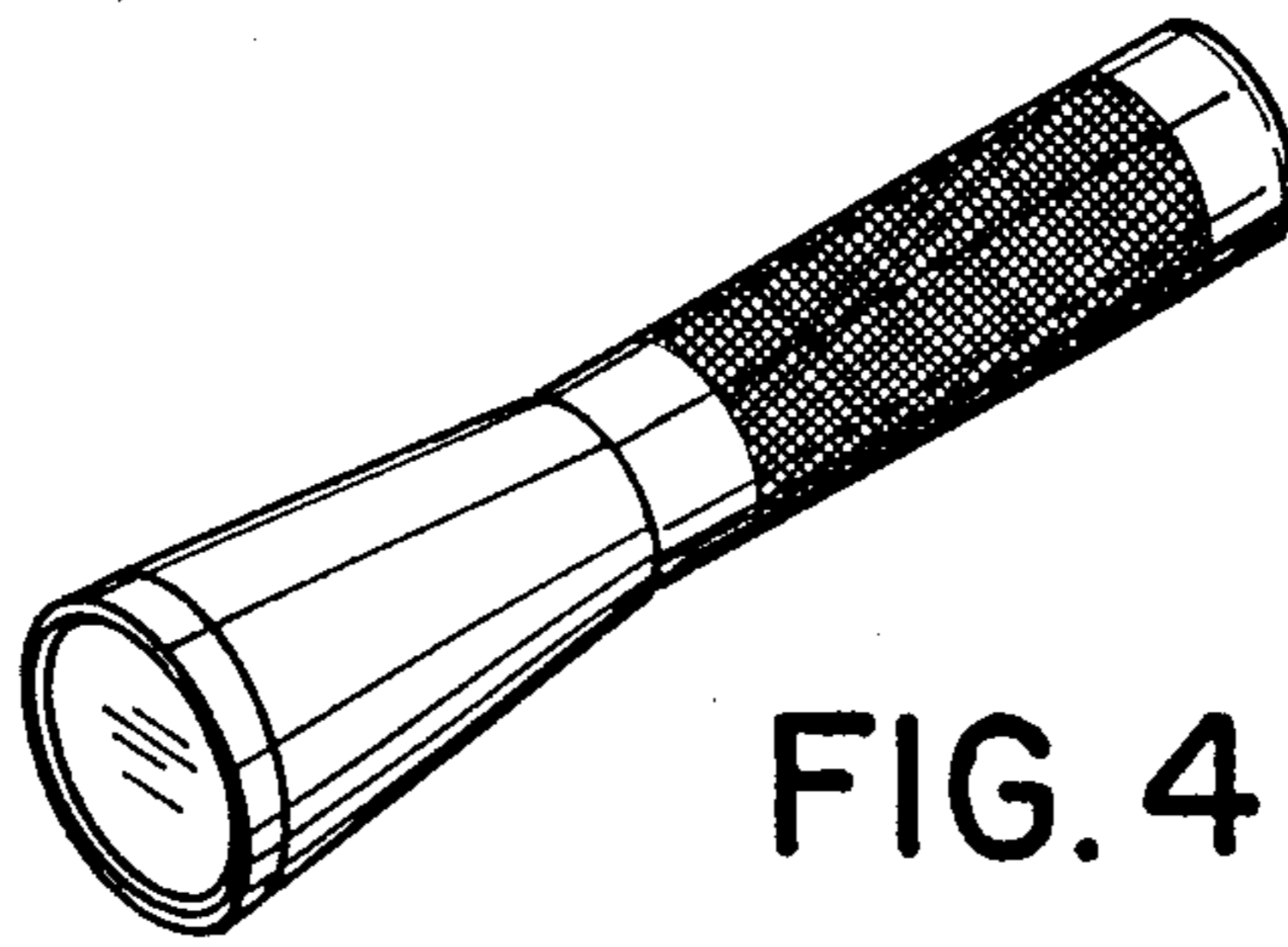
