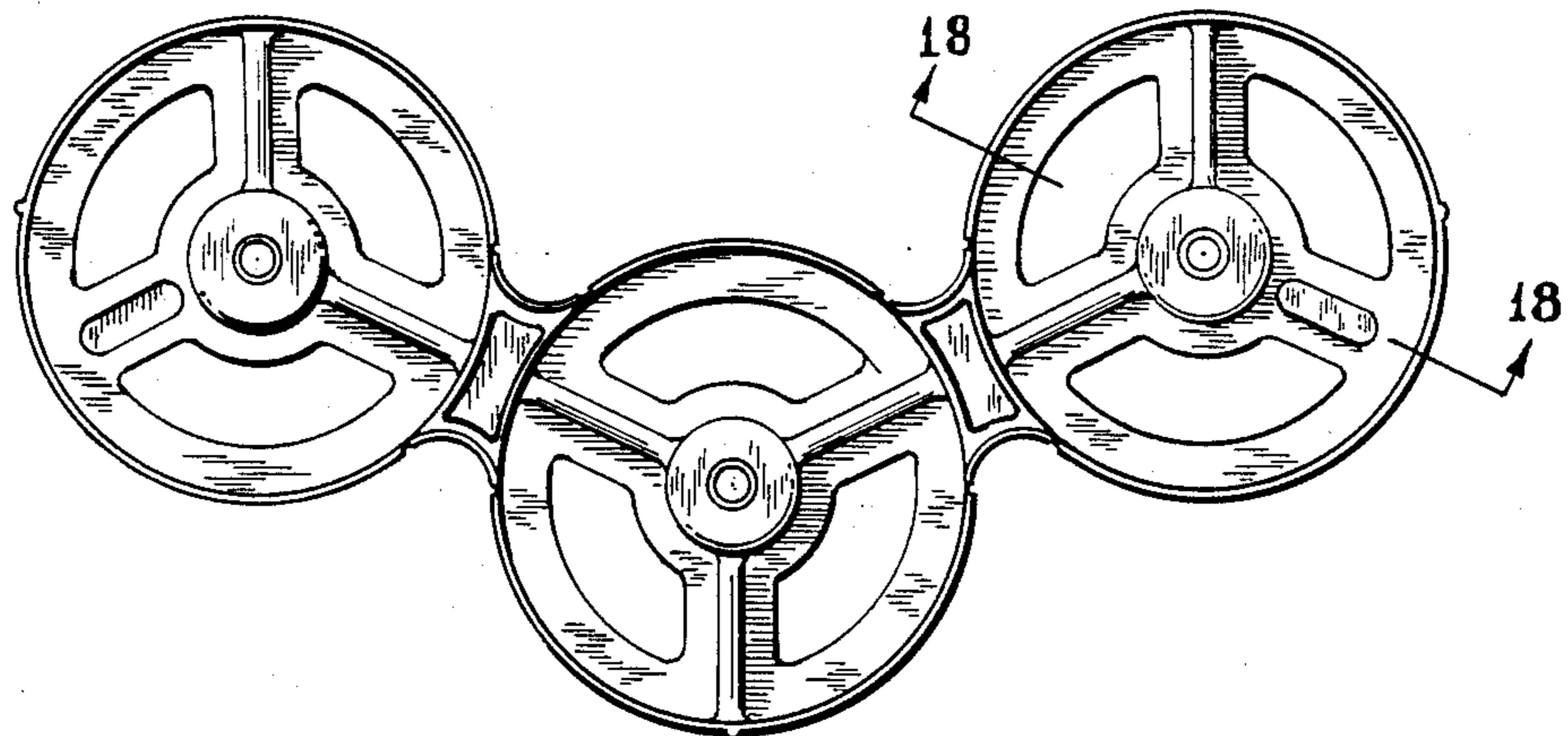

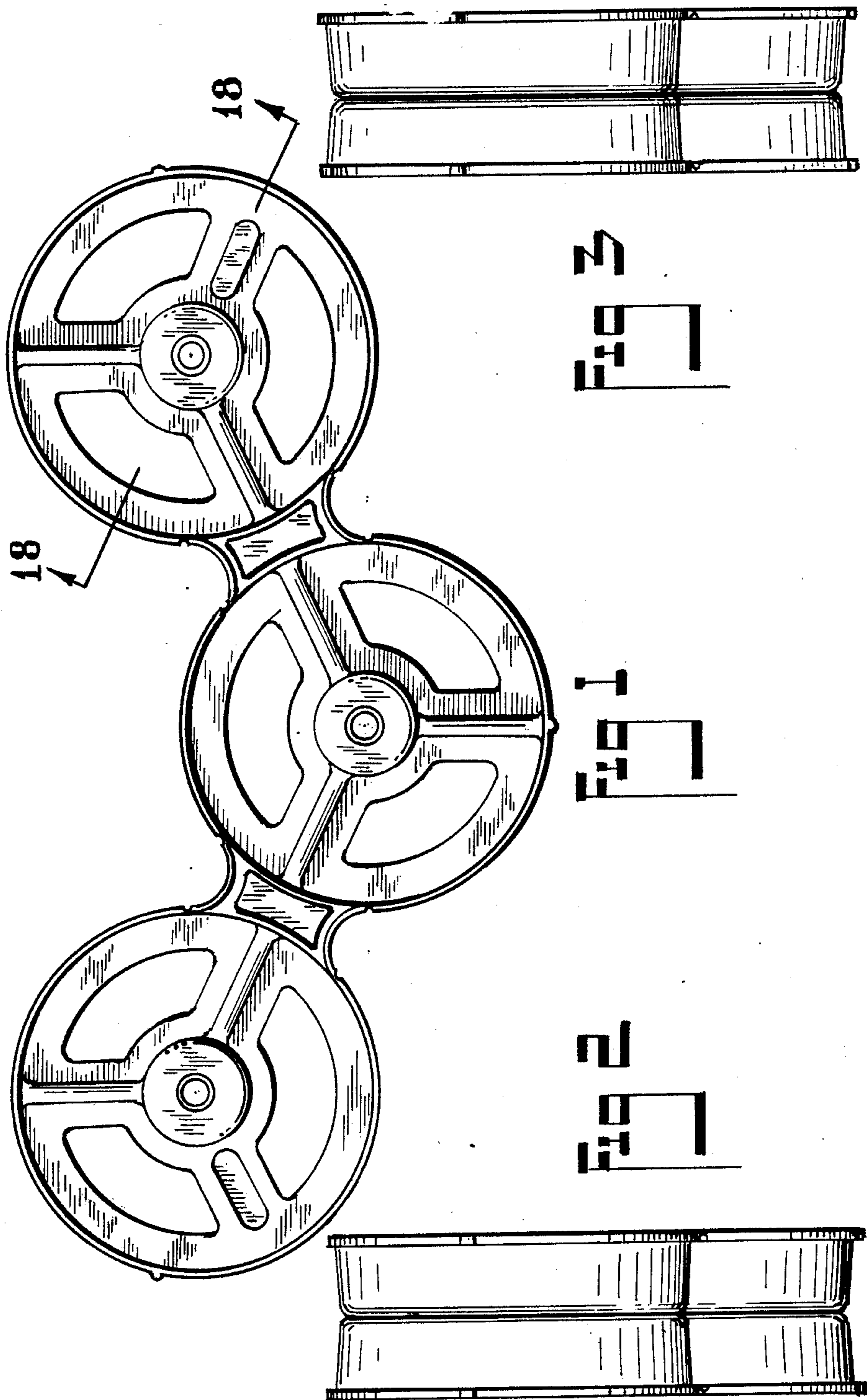

[57] CLAIM

The ornamental design for top for merchandise display unit, as shown and described.

FIG. 1 is a top view of a top for merchandise display unit, embodying our new design;
 FIG. 2 is an end elevational view taken from the left hand end of the top shown in FIG. 1;
 FIG. 3 is an end elevational view taken from the right hand end of the top of FIG. 1;
 FIG. 4 is a front elevational view of the top of FIG. 1;
 FIG. 5 is a bottom plan view of the top of FIG. 1;
 FIG. 6 is an end elevational view taken from the left hand end of FIG. 5;
 FIG. 7 is an end elevational view taken from the right hand end of FIG. 5;
 FIG. 8 is a rear elevational view of the top of FIG. 1;
 FIG. 9 is a top plan view of a modified top for a merchandise display unit, and embodying the invention;
 FIG. 10 is a rear elevational view thereof;
 FIG. 11 is a rear elevational view thereof;
 FIG. 12 is an end elevational view taken from the right hand end of FIG. 9;
 FIG. 12a is an end elevational view taken from the left hand end of FIG. 9;
 FIG. 13 is an enlarged perspective view taken from the upper portion of FIG. 9;
 FIG. 14 is a generally perspective enlarged view taken from the front of FIG. 9;
 FIG. 15 is an enlarged top plan view of a further modification of top for a merchandise display unit, embodying the invention;
 FIG. 16 is a front elevational view of the top shown in FIG. 15;
 FIG. 16a is a rear elevational view of the top of FIG. 15;
 FIG. 17 is a bottom plan view of the top of FIG. 15;
 FIG. 18 is a sectional view taken generally along the plane of line 18-18 of FIG. 1;
 FIG. 19 is a sectional view taken generally along the plane of line 19-19 of FIG. 9; and
 FIG. 20 is a sectional view taken generally along the plane of line 20-20 of FIG. 15.
 The tops are adapted for mounting on column structure of a merchandise display unit, such as for instance a "spinner type" merchandise display unit.





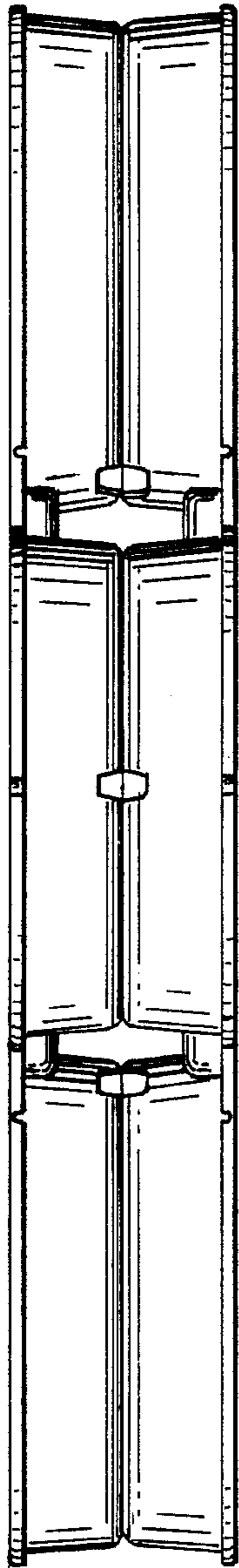

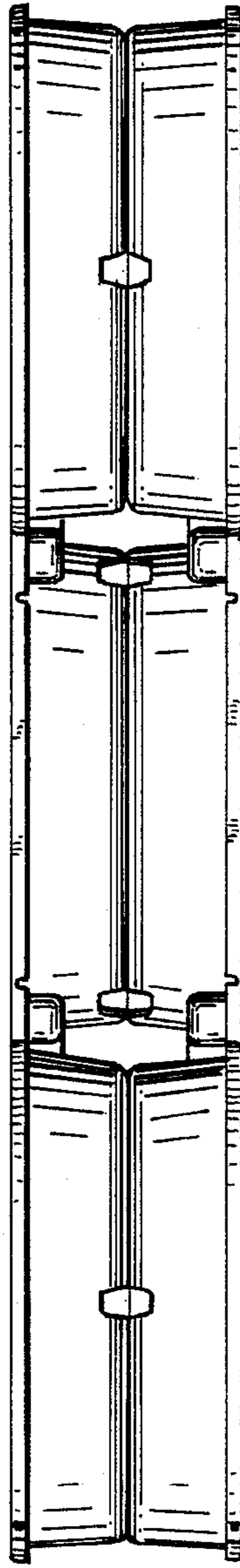
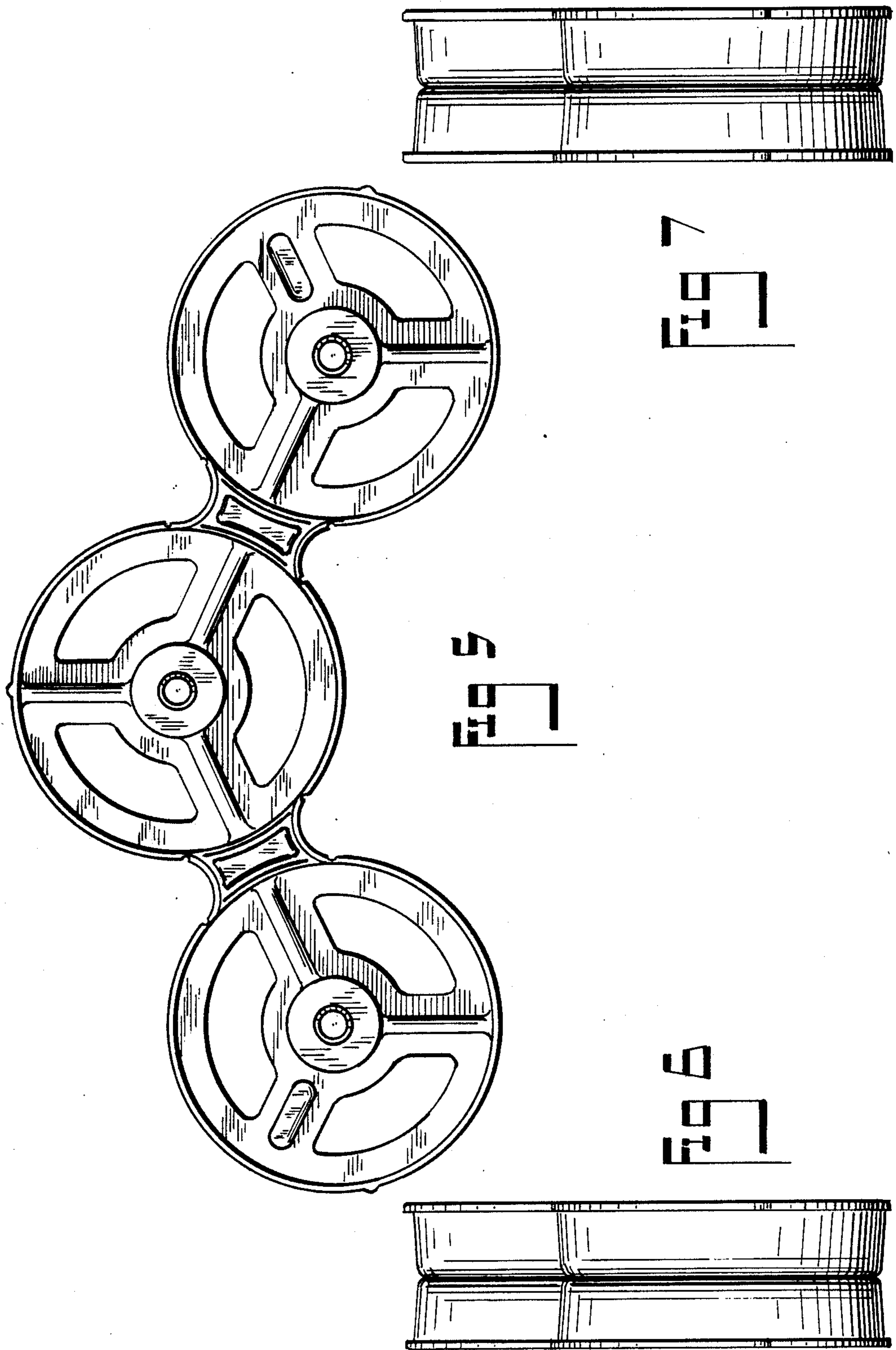

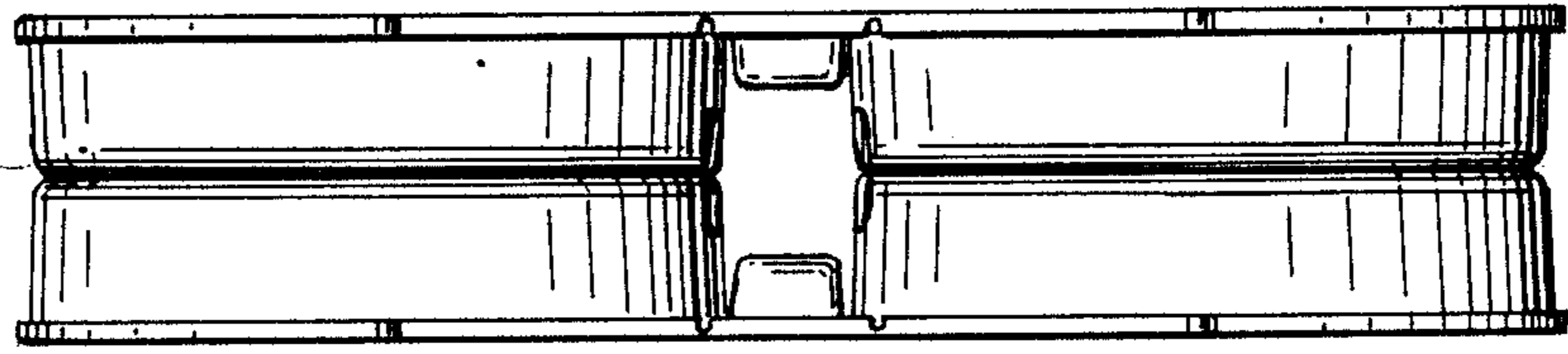

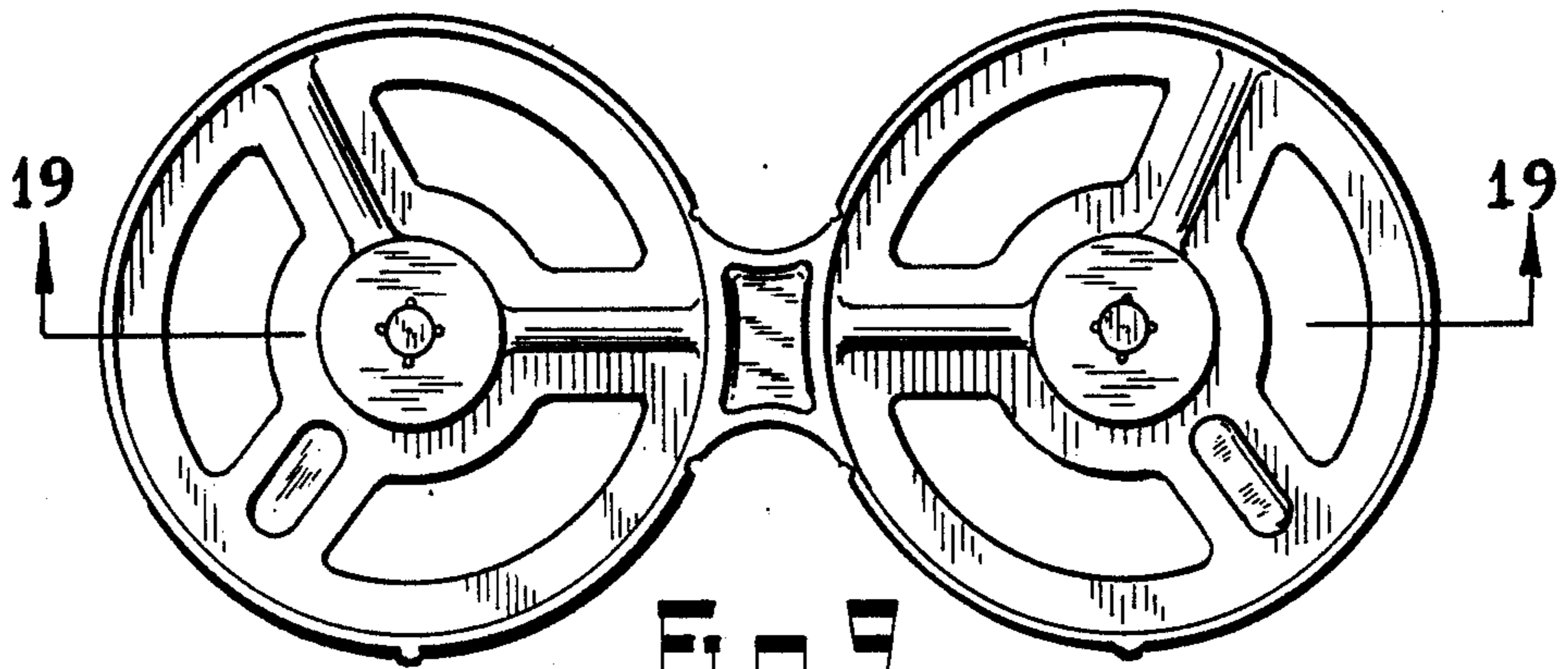

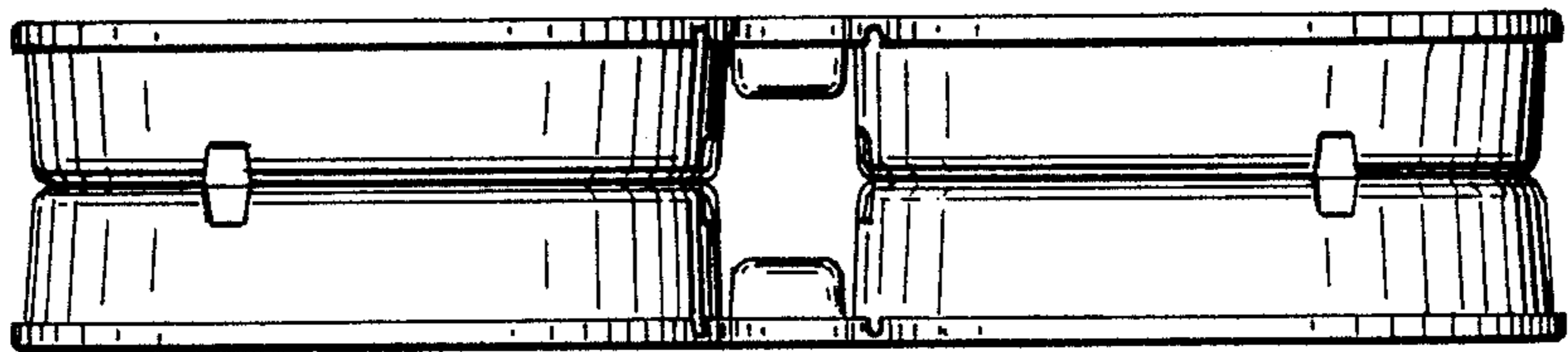

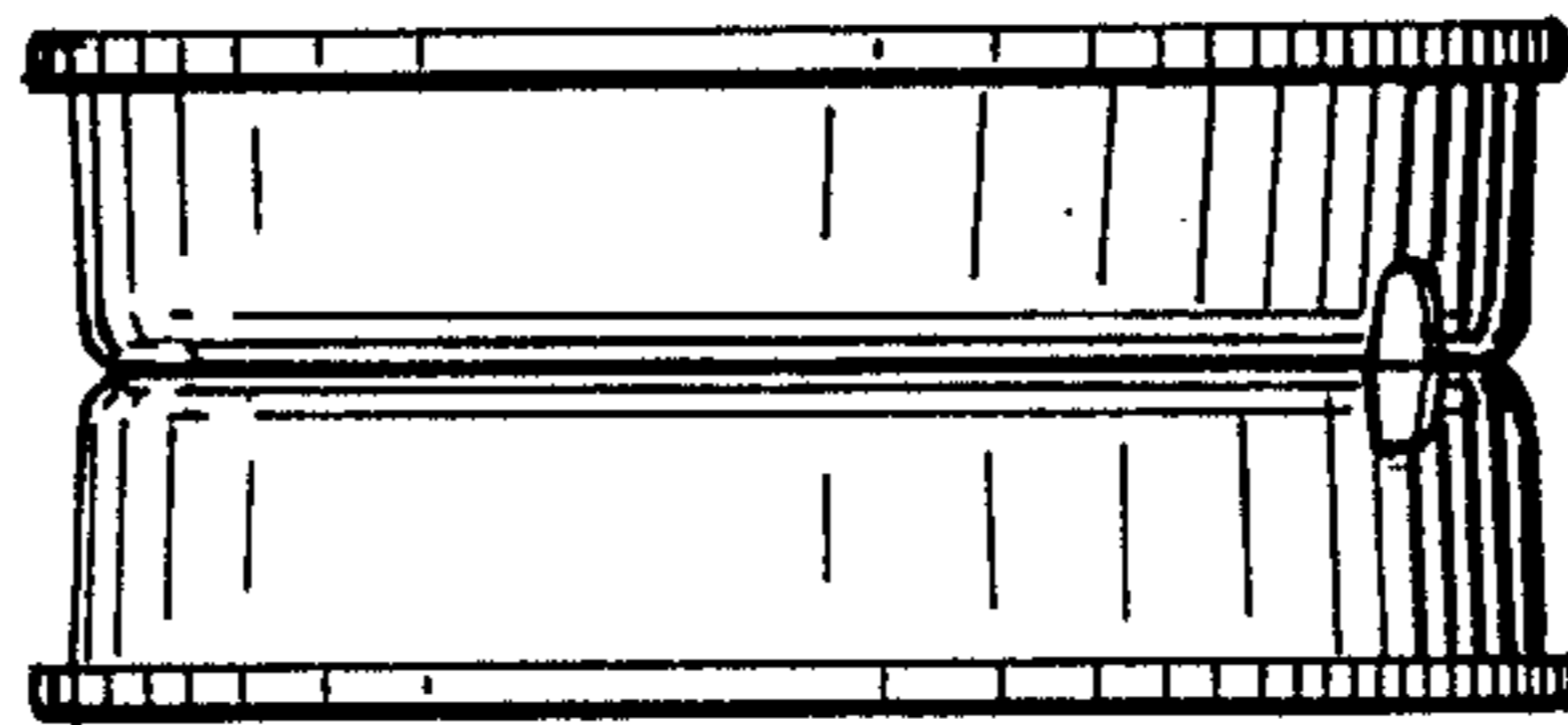

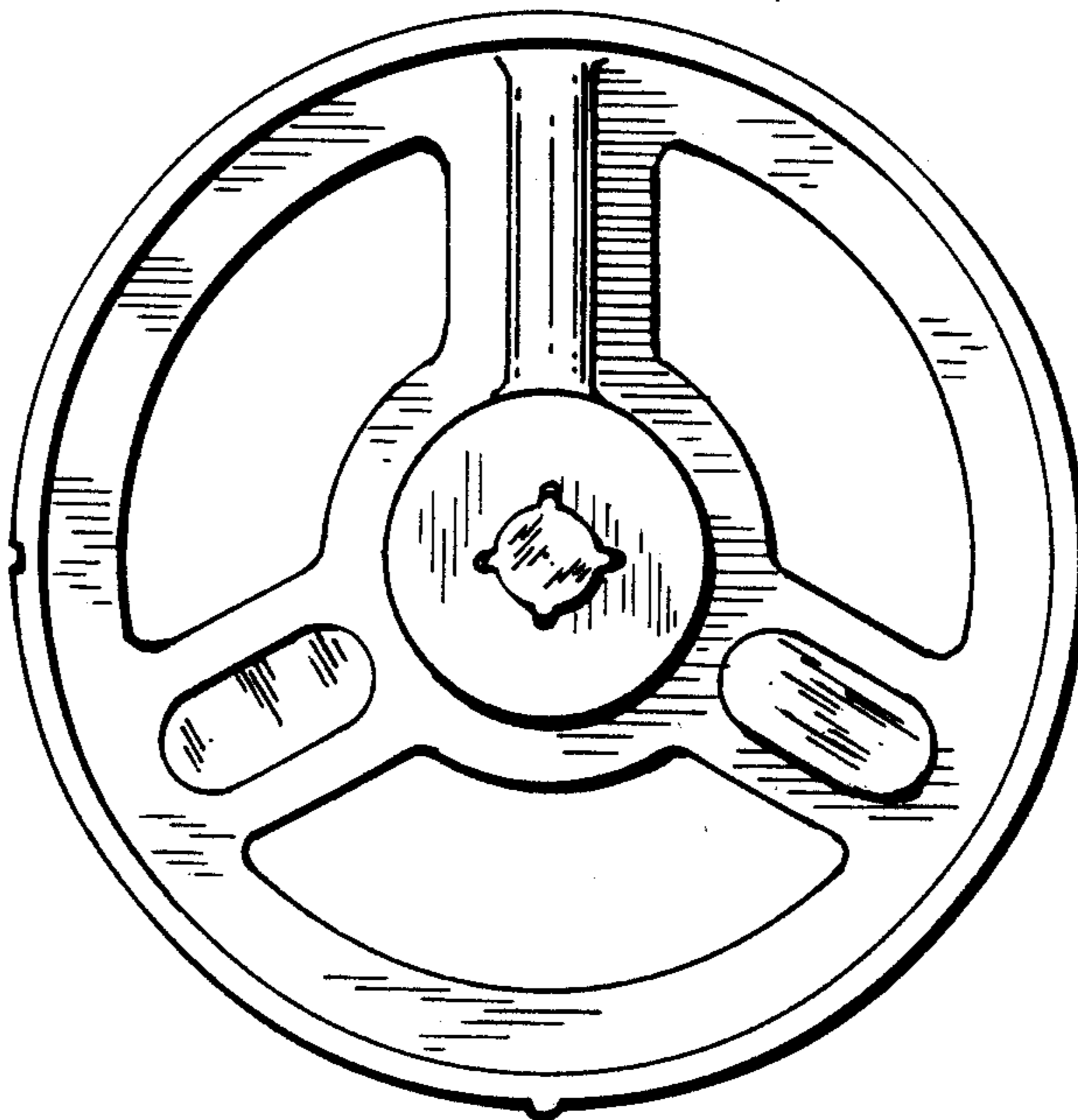

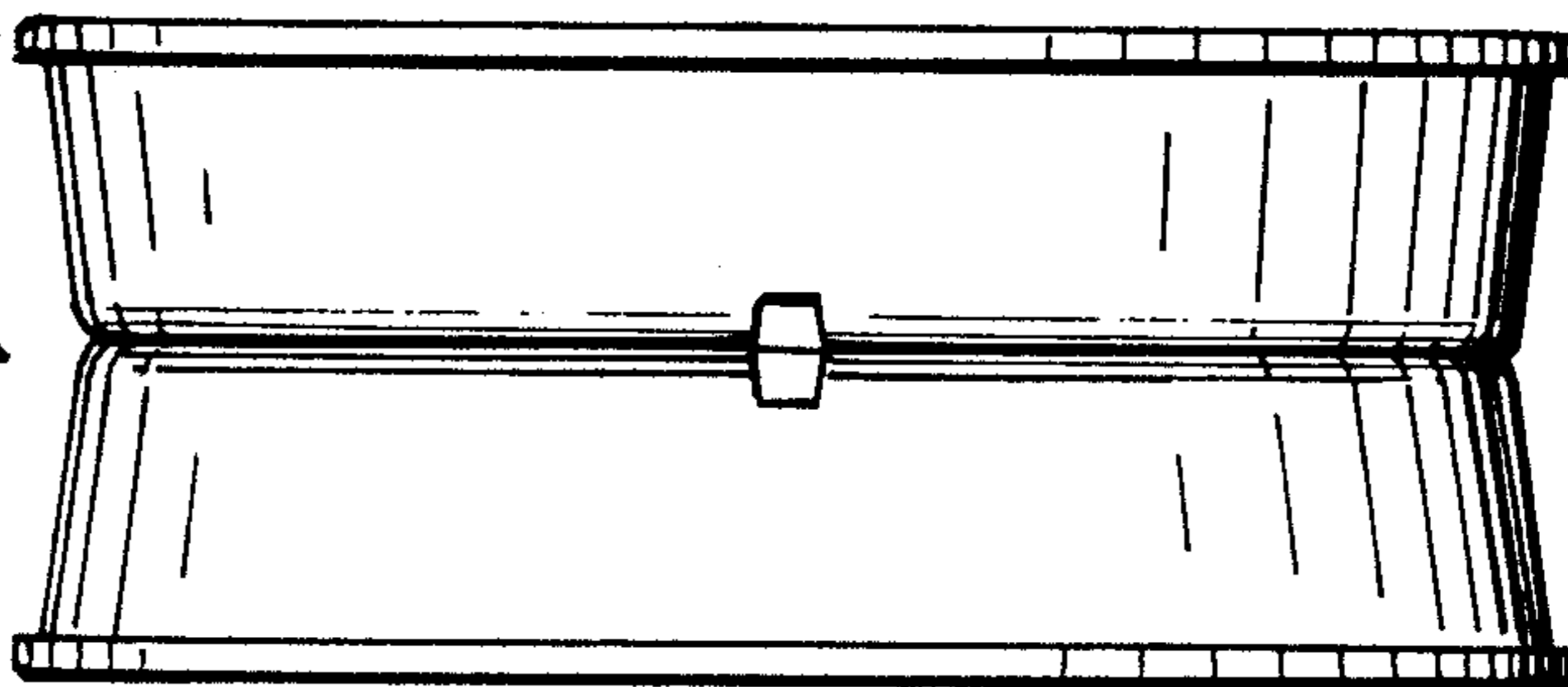

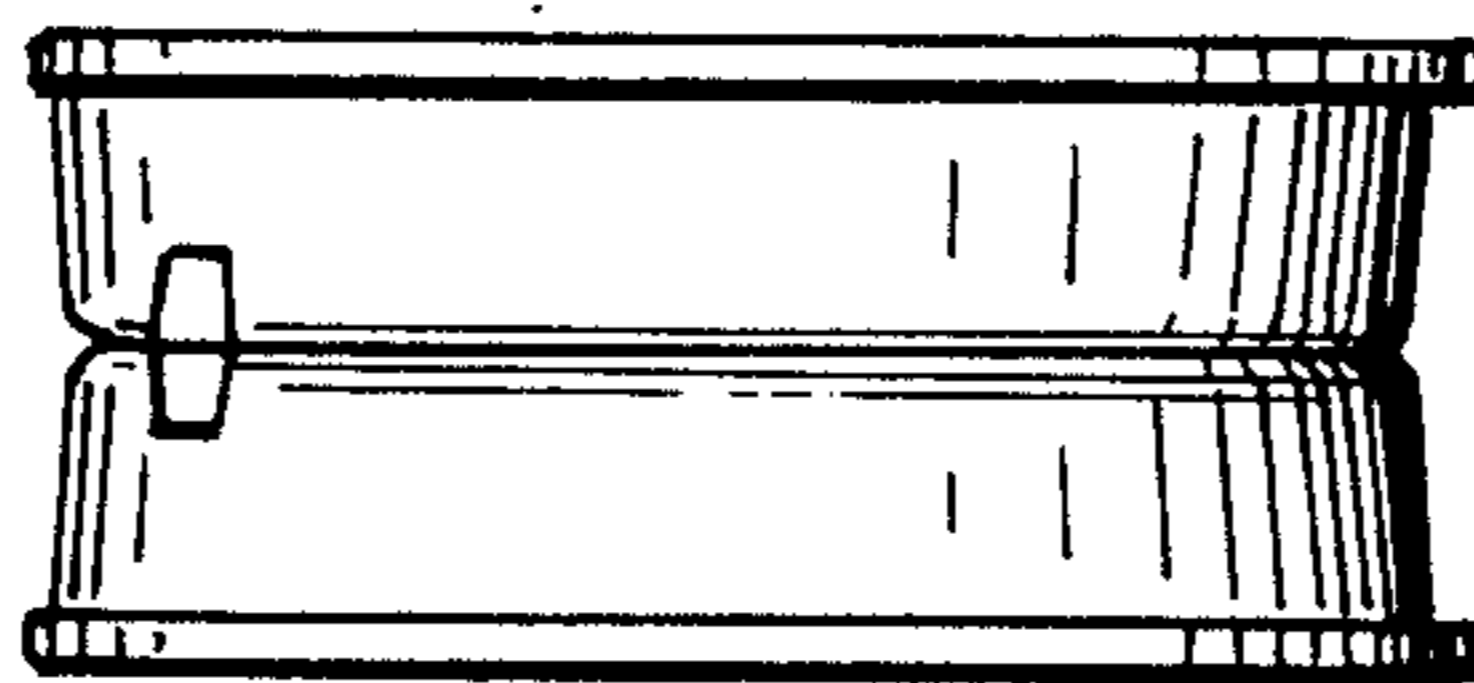

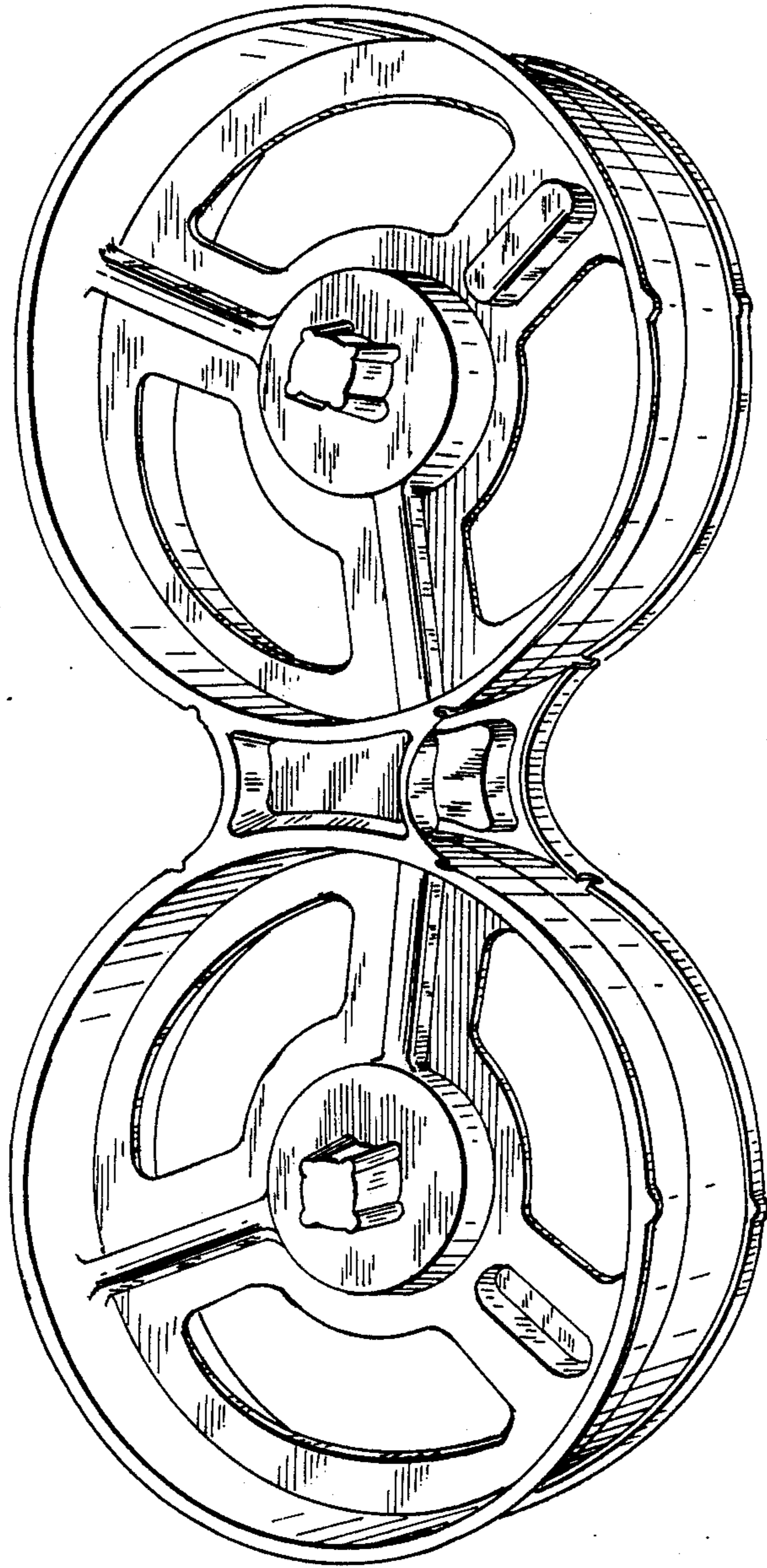
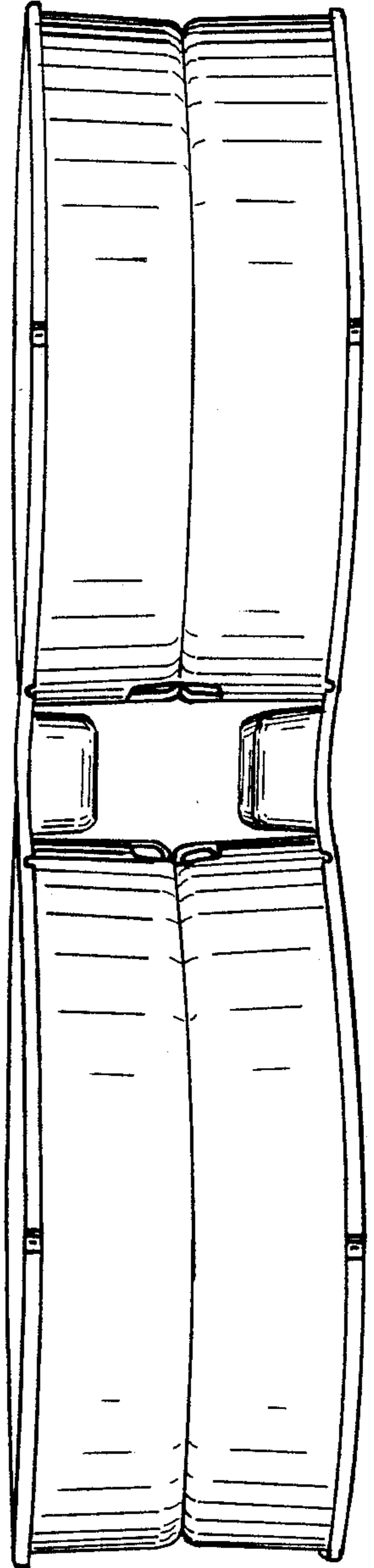

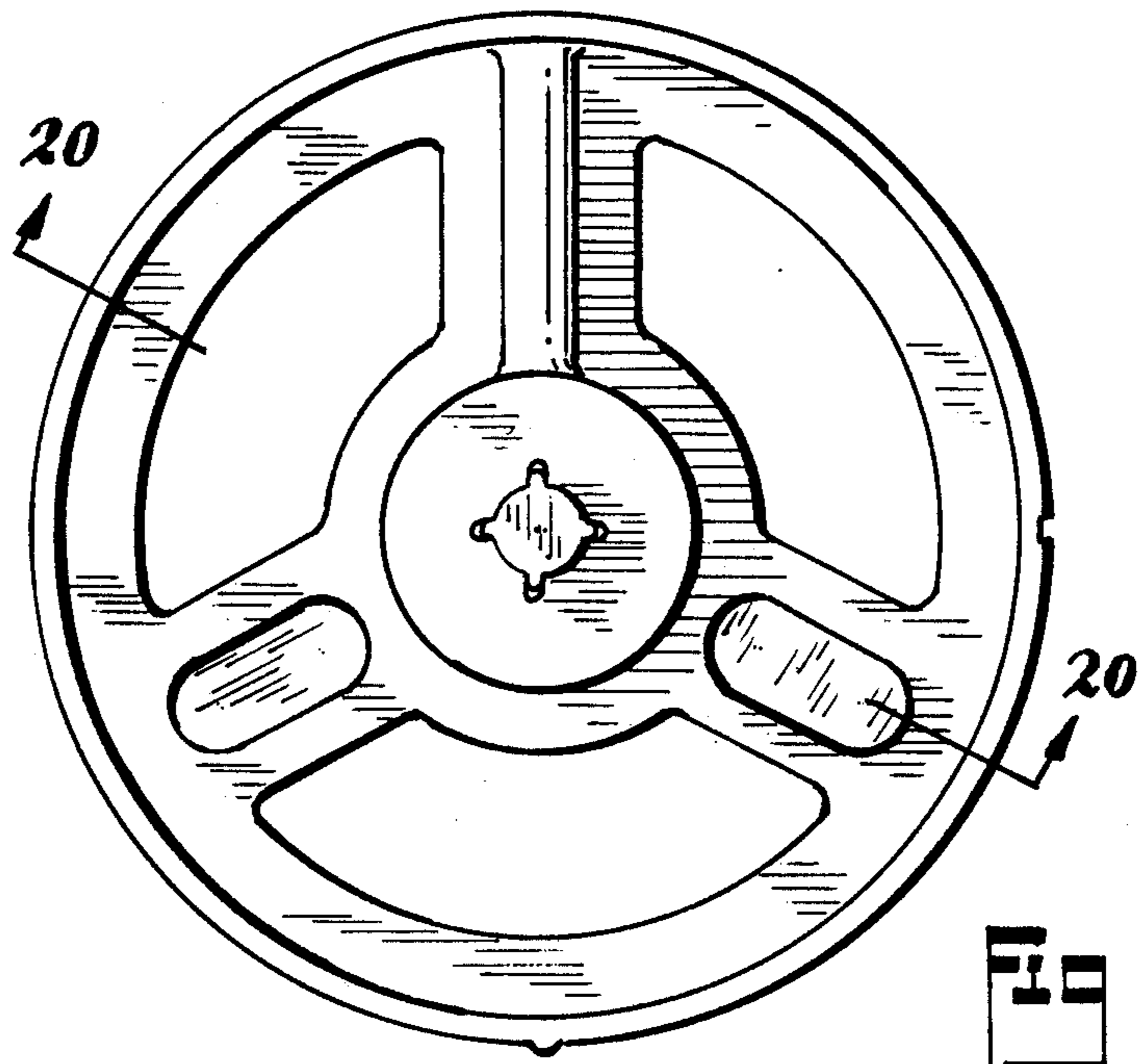

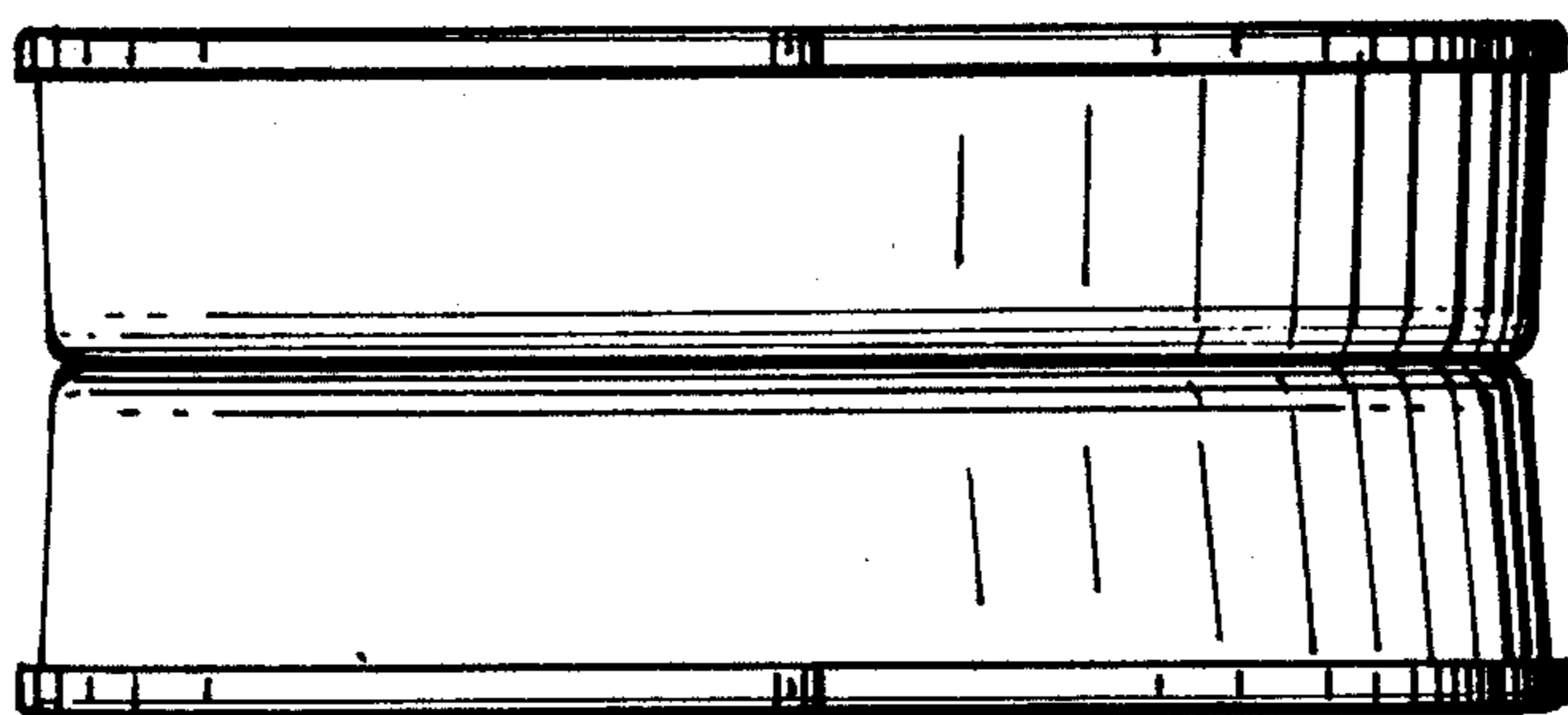

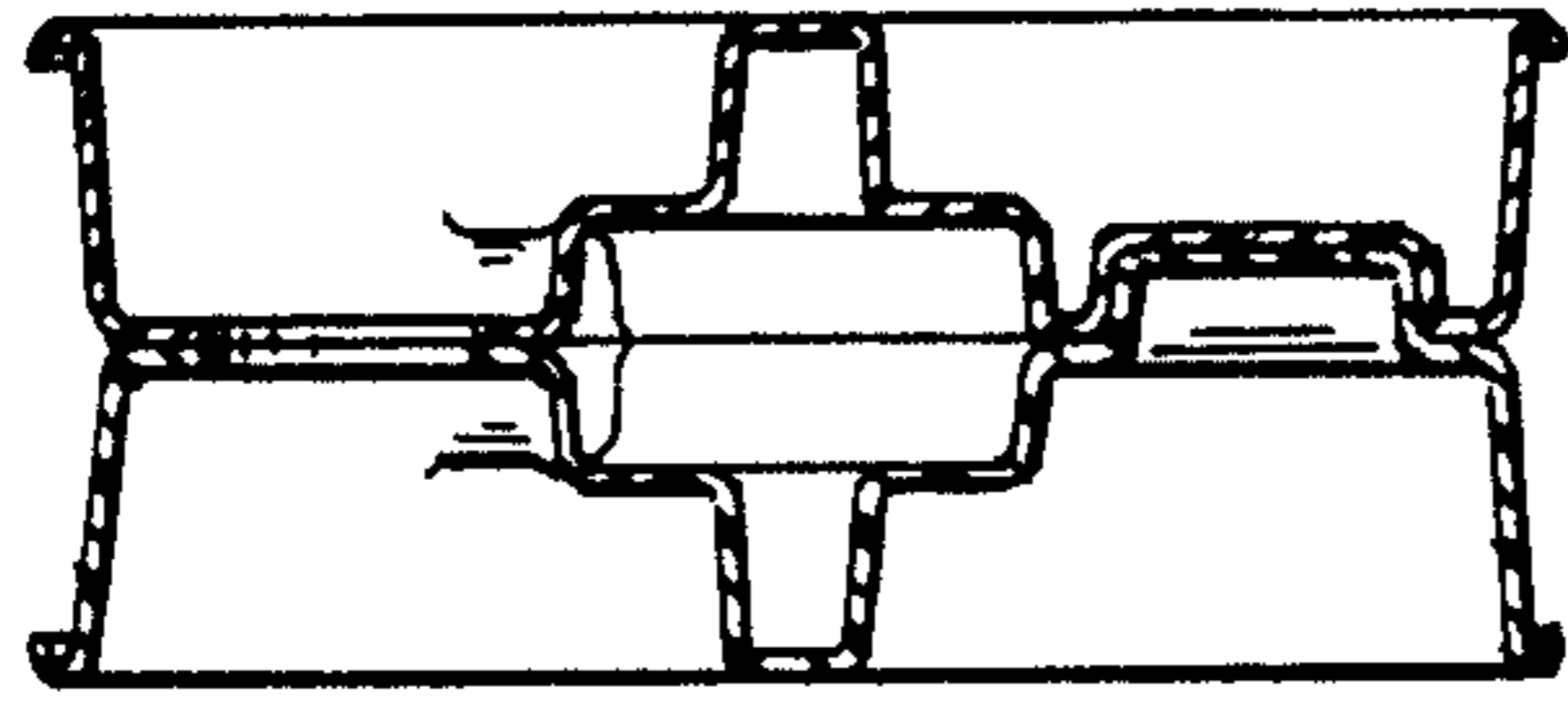

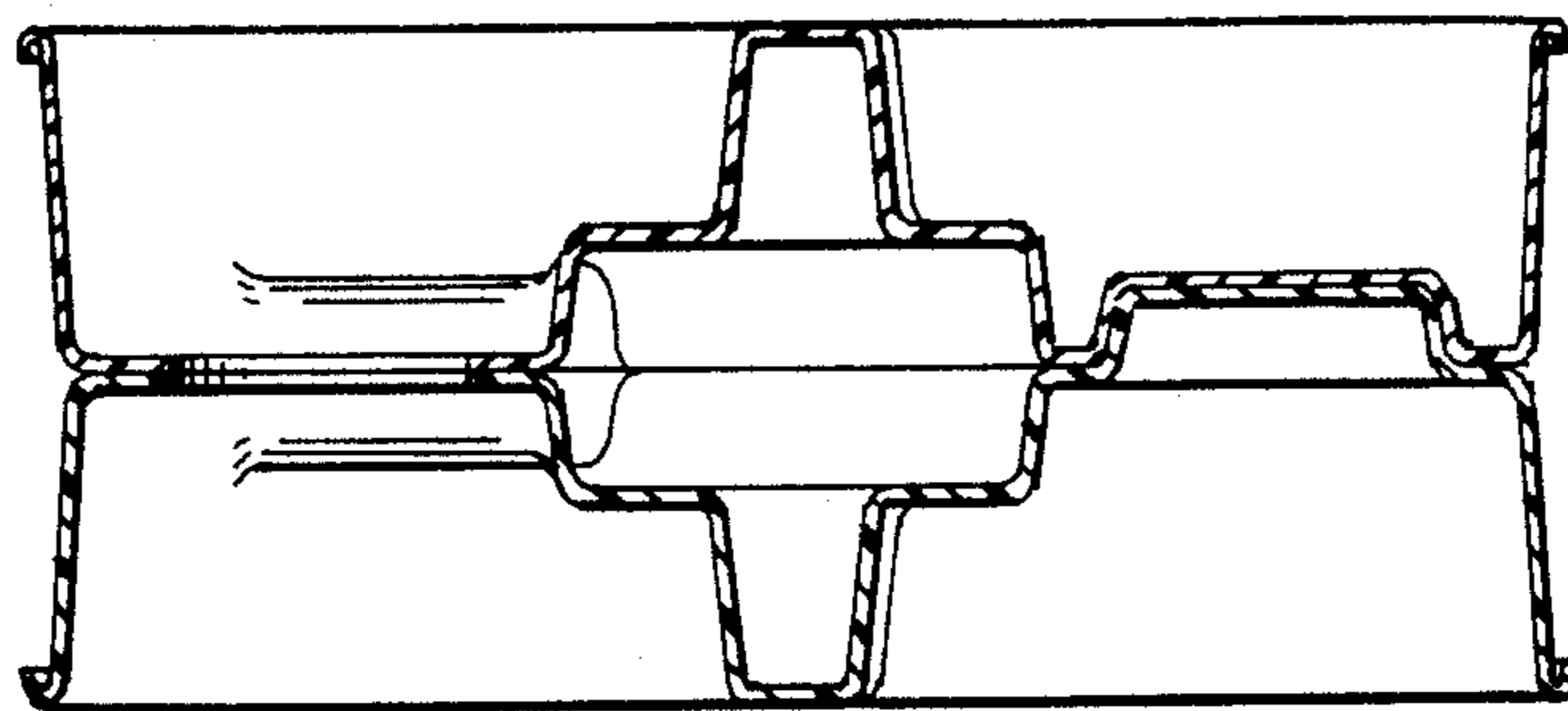
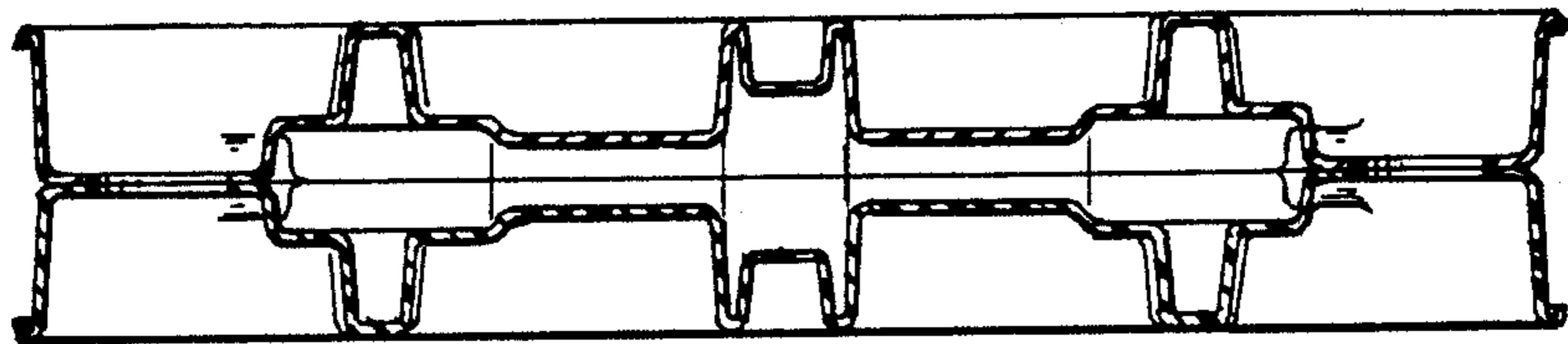
