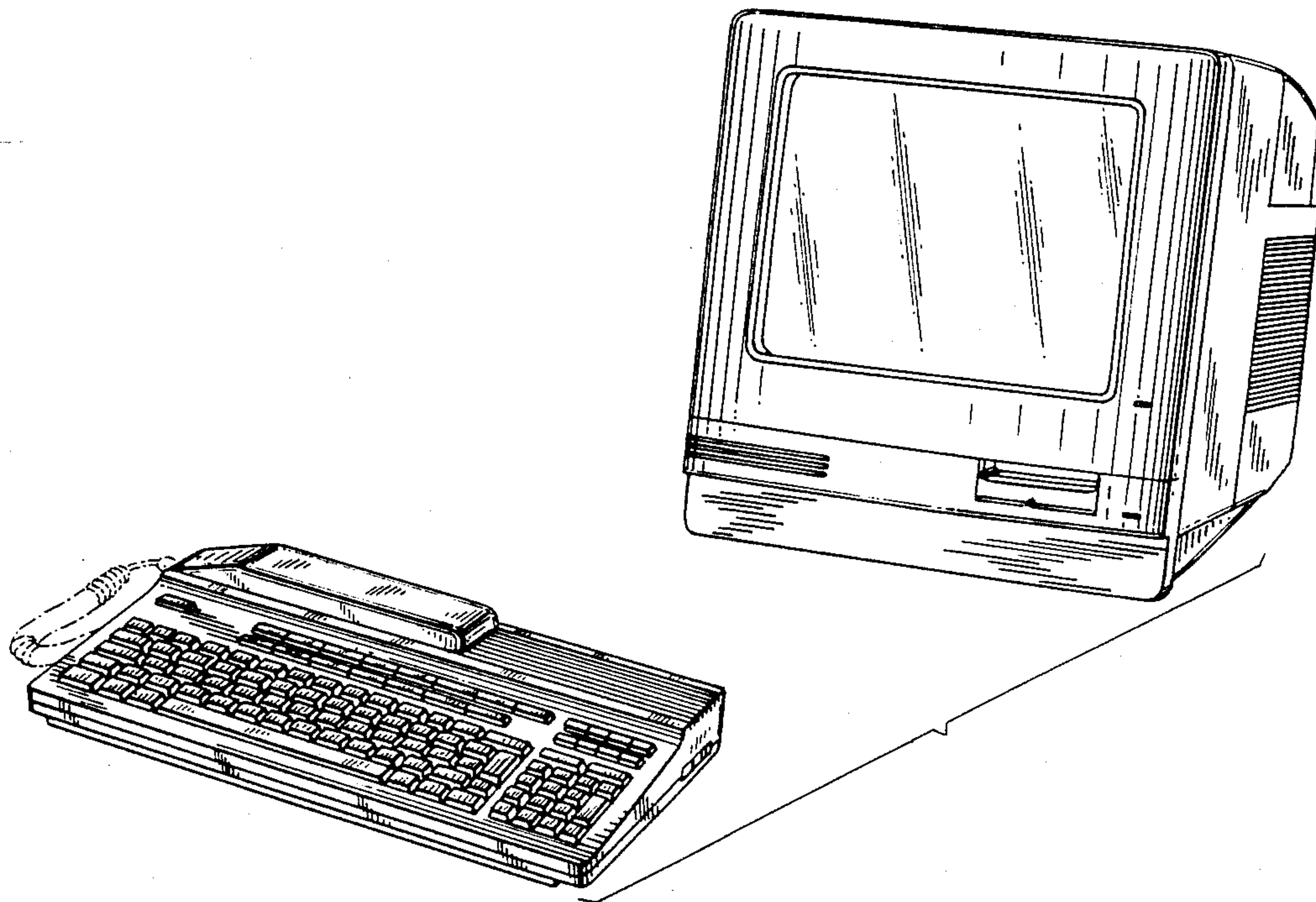

[57] CLAIM

The ornamental design for a videotex terminal, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, right side perspective view of the videotex terminal showing my new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a left side elevational view thereof; FIG. 4 is a right side elevational view thereof; FIG. 5 is a top plan view thereof; FIG. 6 is a rear elevational view thereof; FIG. 7 is a top, front, left side perspective view of the keyboard and handset of the videotex terminal on an enlarged scale; FIG. 8 is a front elevational view thereof; FIG. 9 is a left side elevational view thereof; FIG. 10 is a right side elevational view thereof; FIG. 11 is a rear elevational view thereof; FIG. 12 is a top plan view thereof. The keyboard is omitted from FIGS. 2-6 and the monitor is omitted from FIGS. 7-12 for convenience of illustration. The phone cord is shown in broken lines in FIGS. 1, 7, 8, 9, 11 and 12 for illustrative purposes only and thus forms no part of the claimed design.



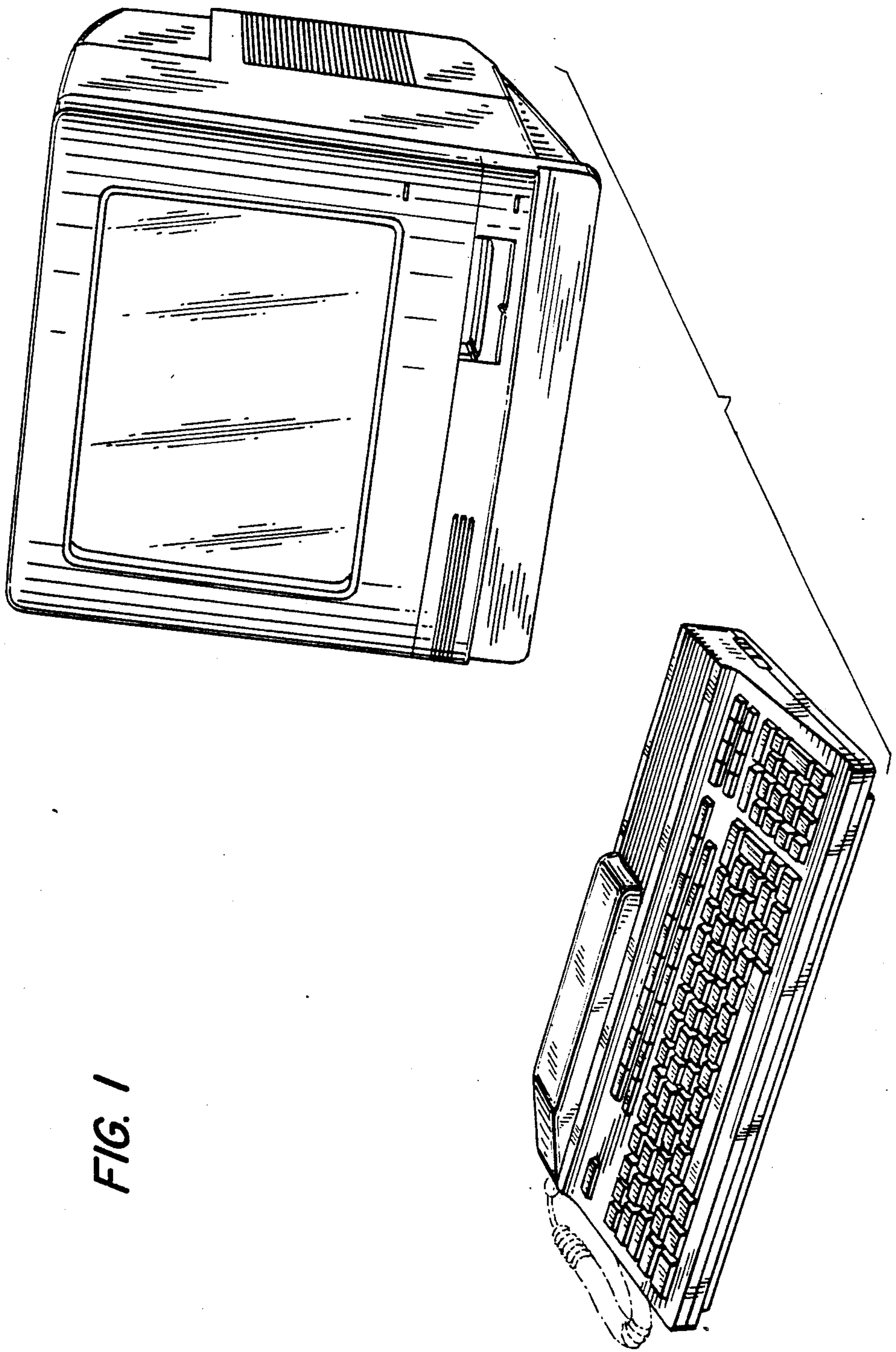

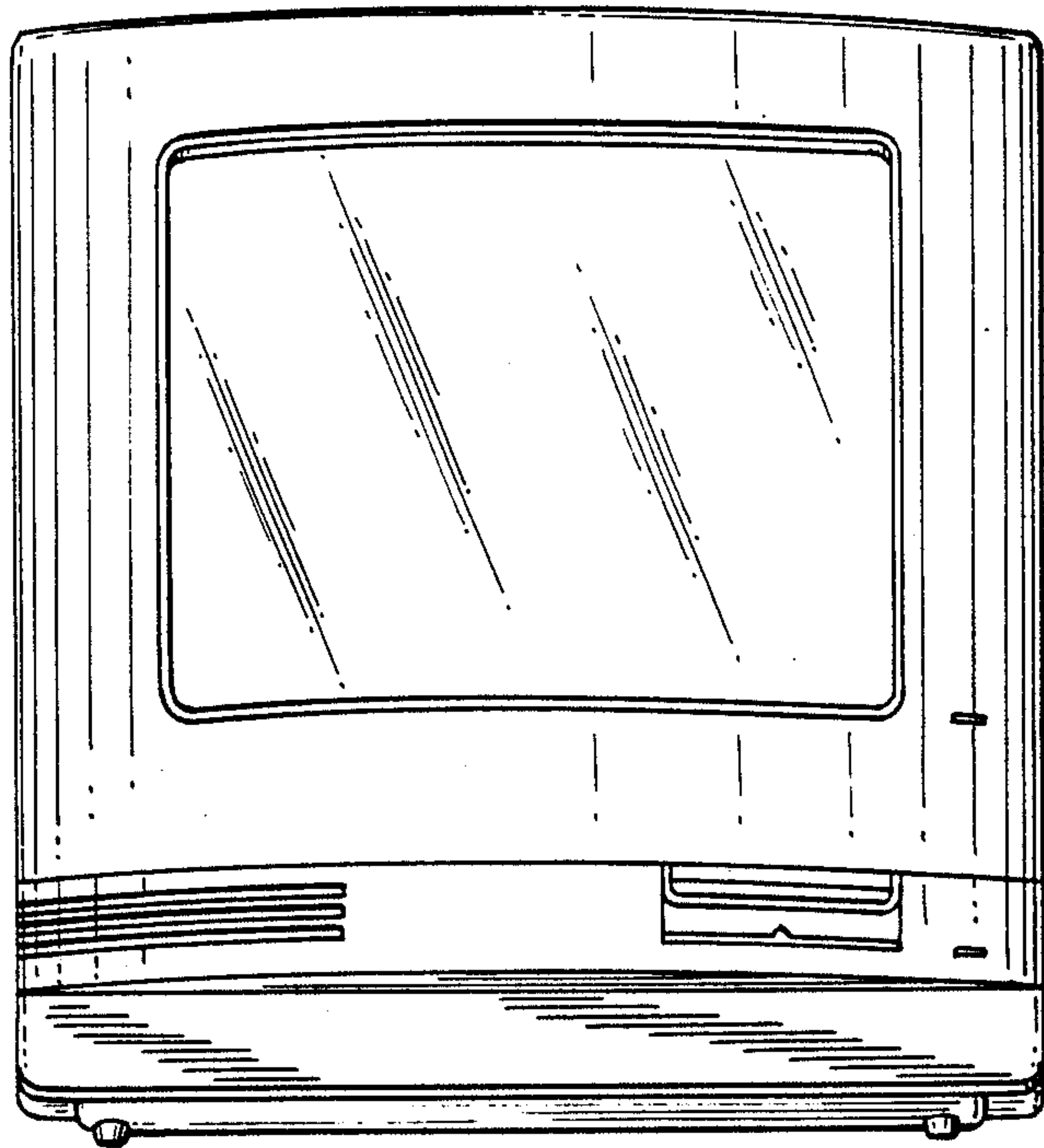

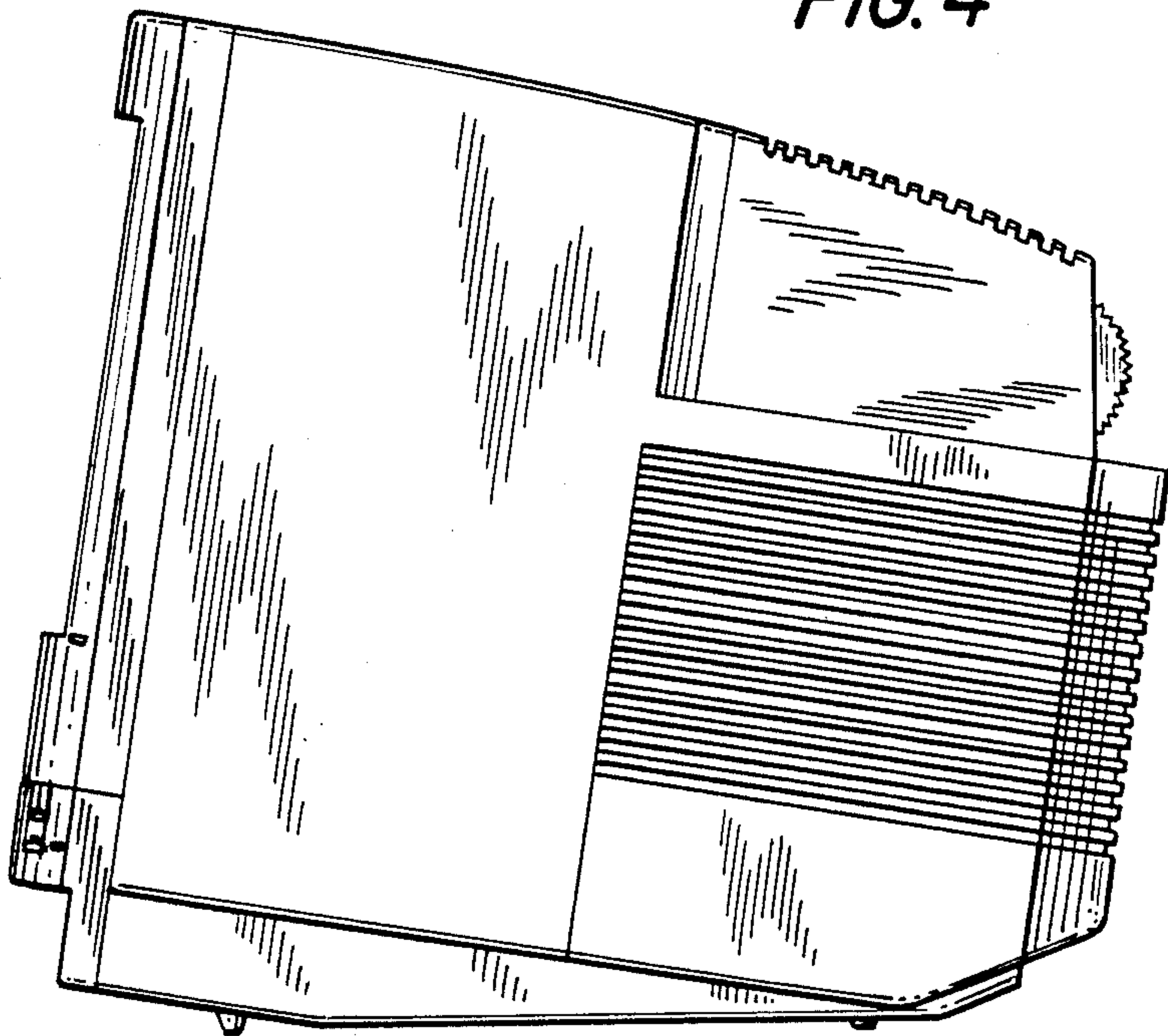

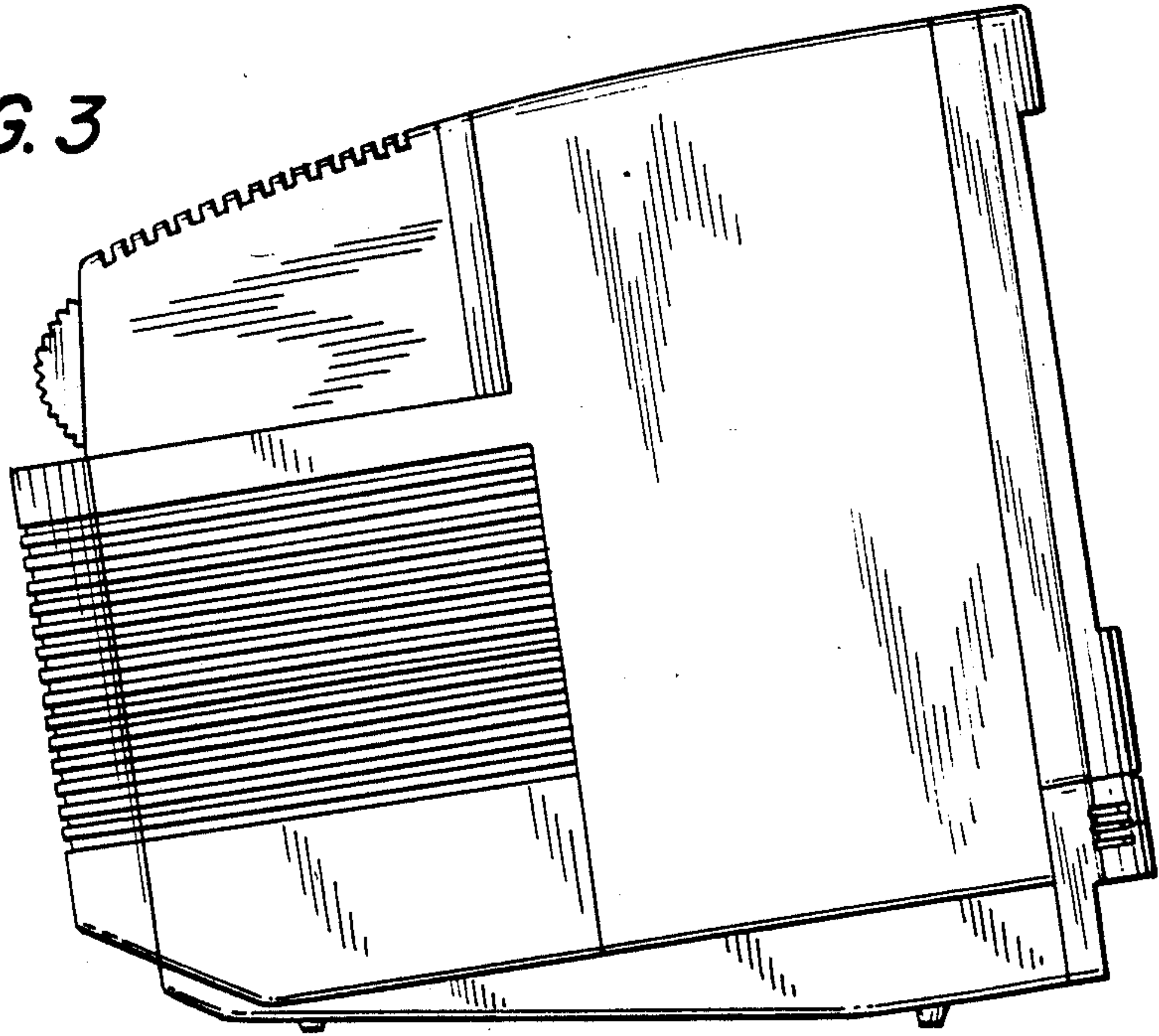
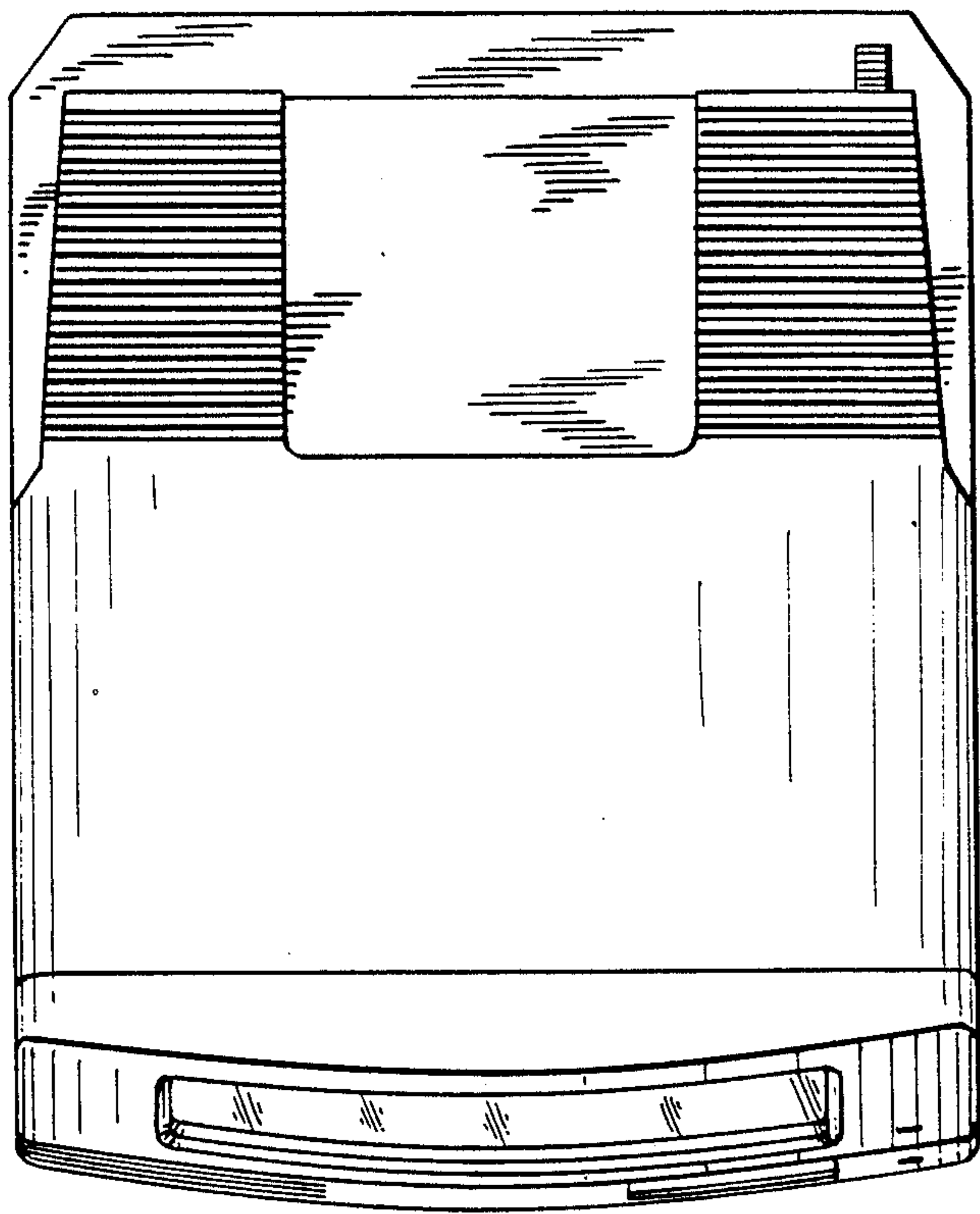

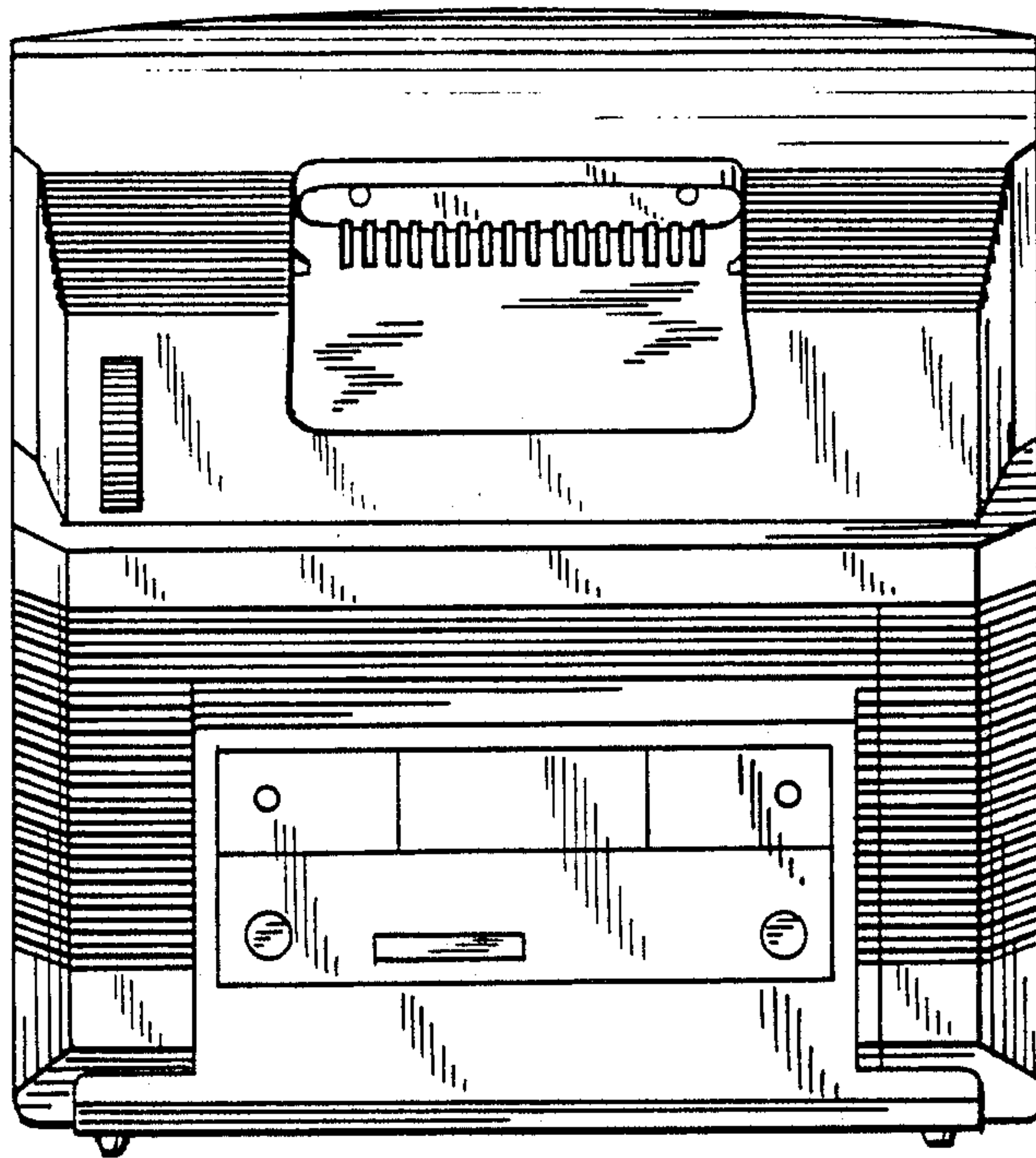

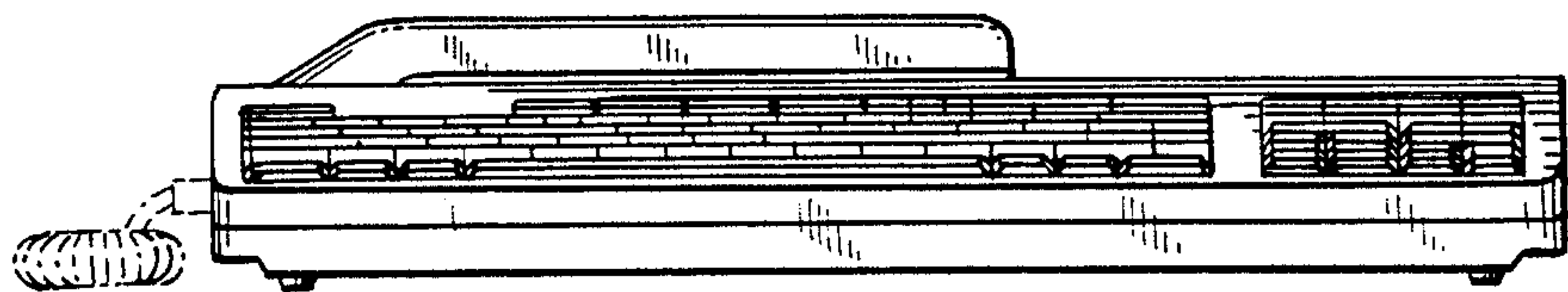

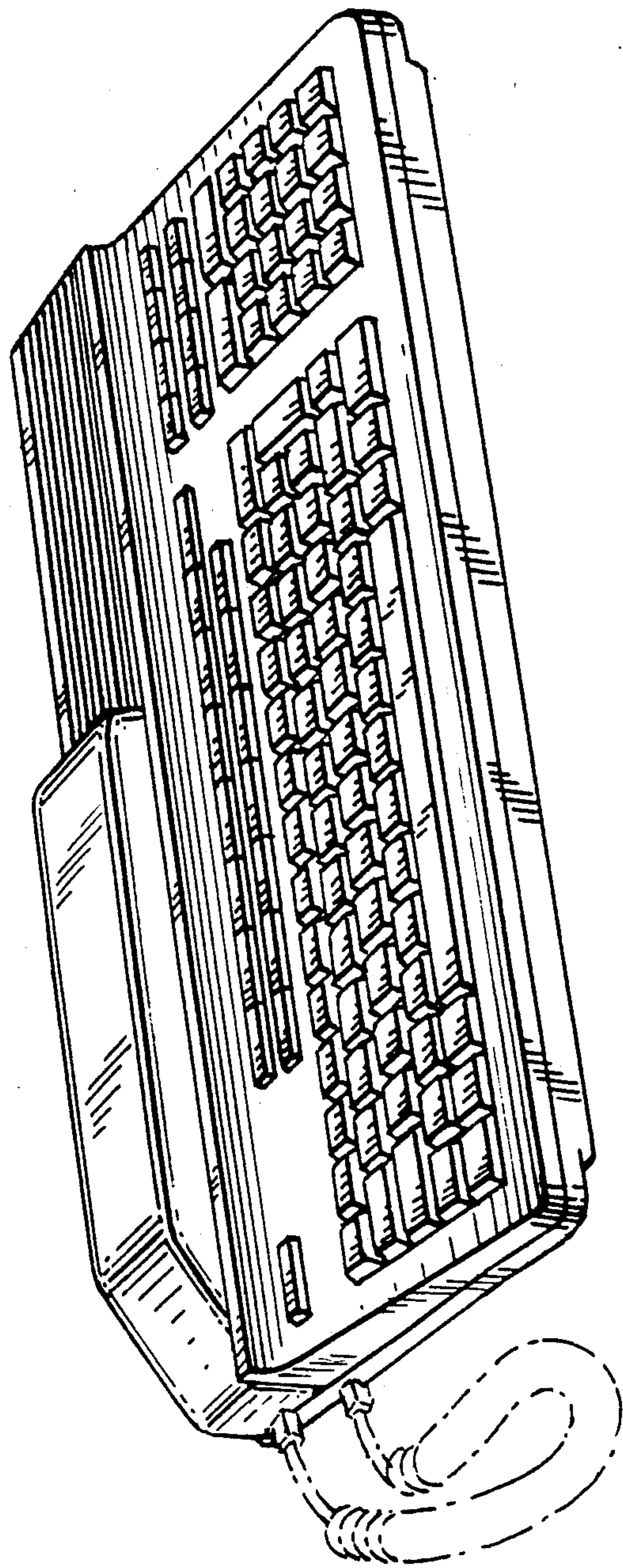

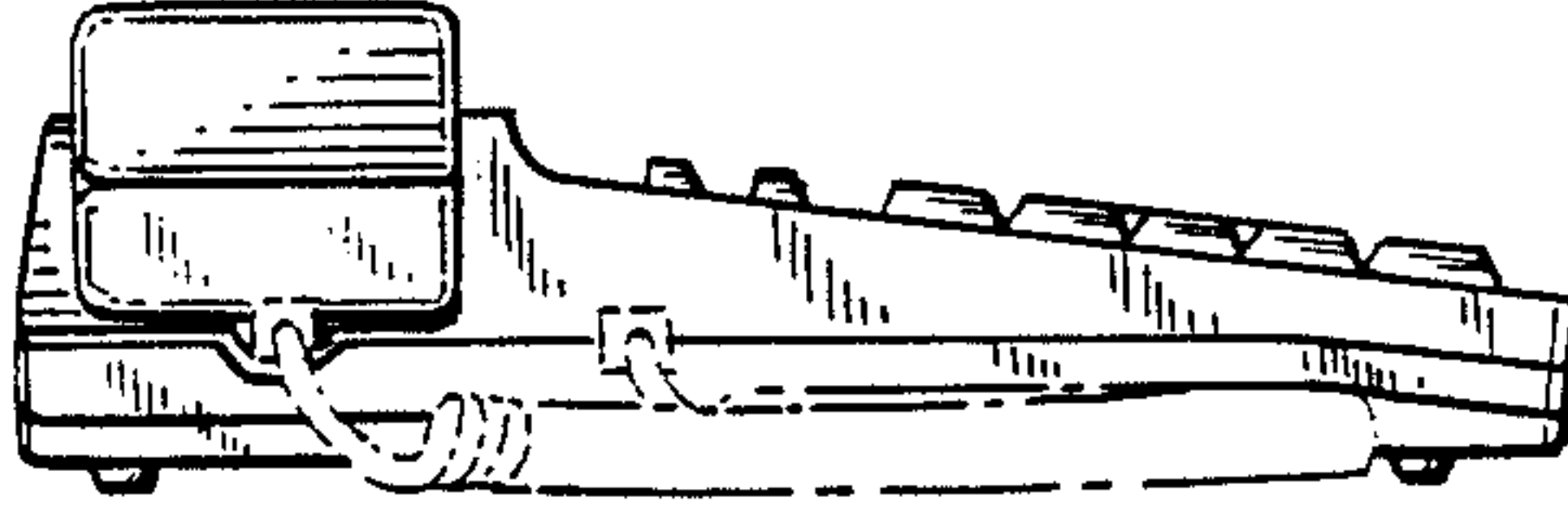

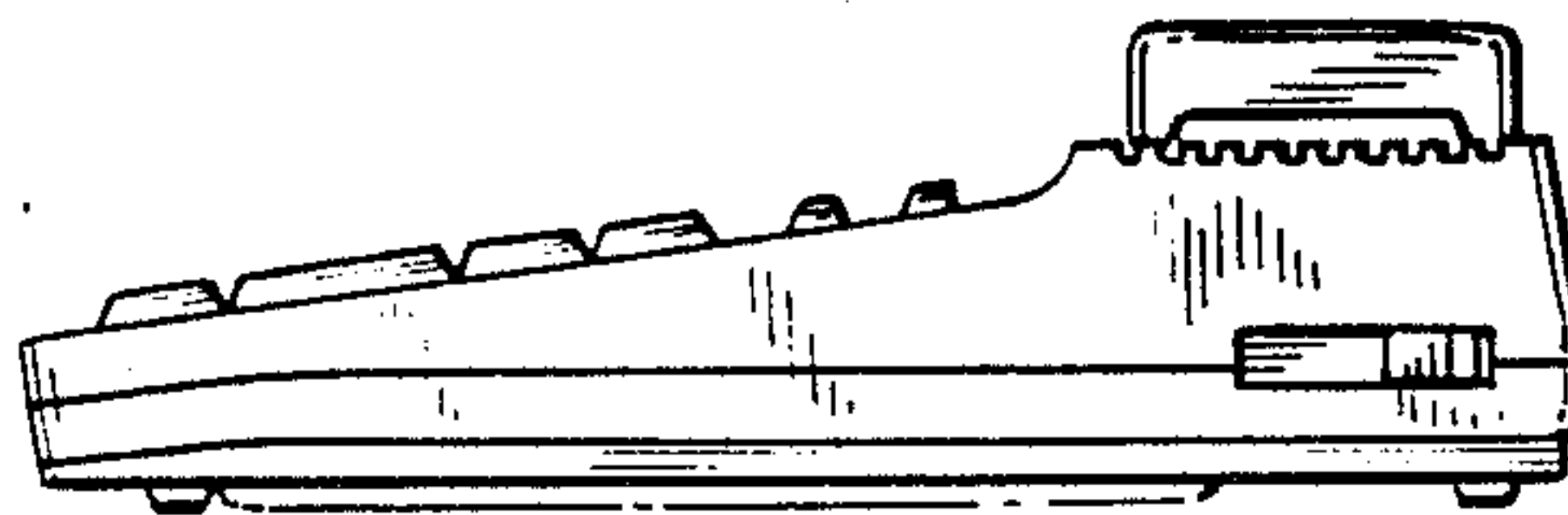

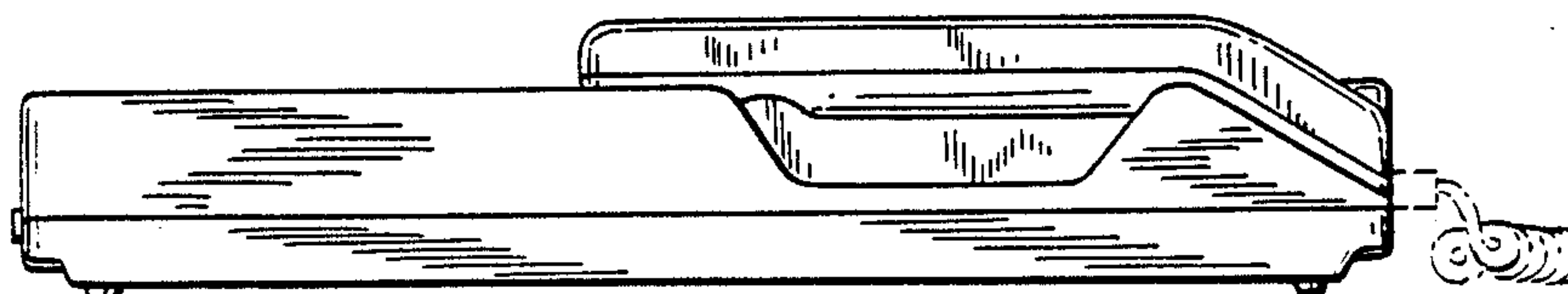
