[57] CLAIM

The ornamental design for a modular personal computer system or similar article, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, right side perspective view of Modular Personal Computer System or Similar Article showing our new design, with two modules extending in the vertical direction;

FIG. 2 is a top, rear, left side perspective view thereof, with two modules extending in the vertical direction;

FIG. 3 is a top, front, right side perspective view thereof, with four modules extending in both the vertical and horizontal directions;

FIG. 4 is a top, front, right side perspective view thereof, with four modules extending in the vertical direction;

FIG. 5 is a top, front, right side perspective view thereof, with six modules extending in both the vertical and horizontal directions.

FIG. 6 is a front elevational view thereof on an enlarged scale;

FIG. 7 is a right side elevational view thereof on an enlarged scale.

The broken lines appearing on the computer in FIGS. 1, 3, 4, 5 and 7 are used for illustrative purposes only and form no part of the claimed design.

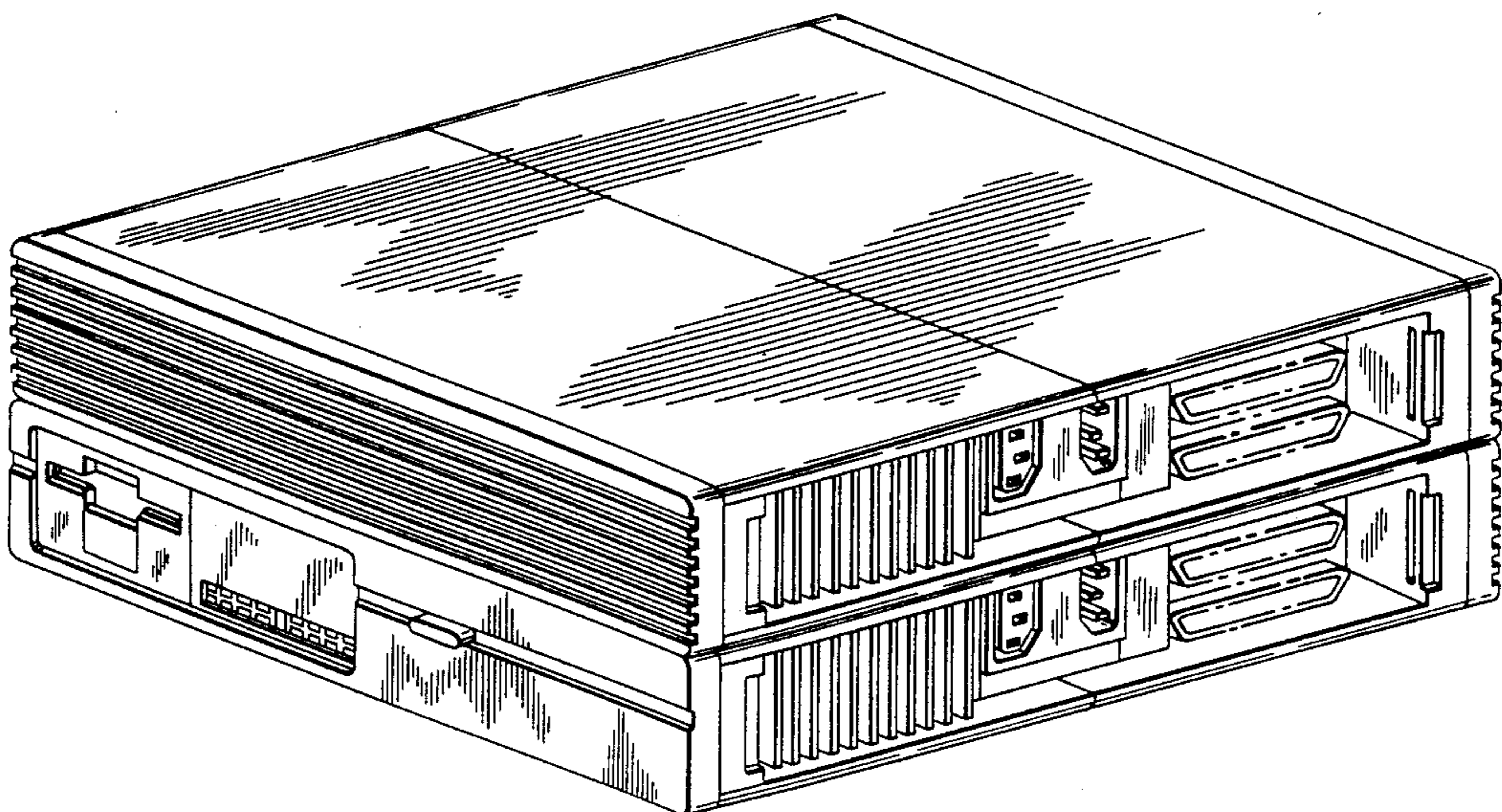

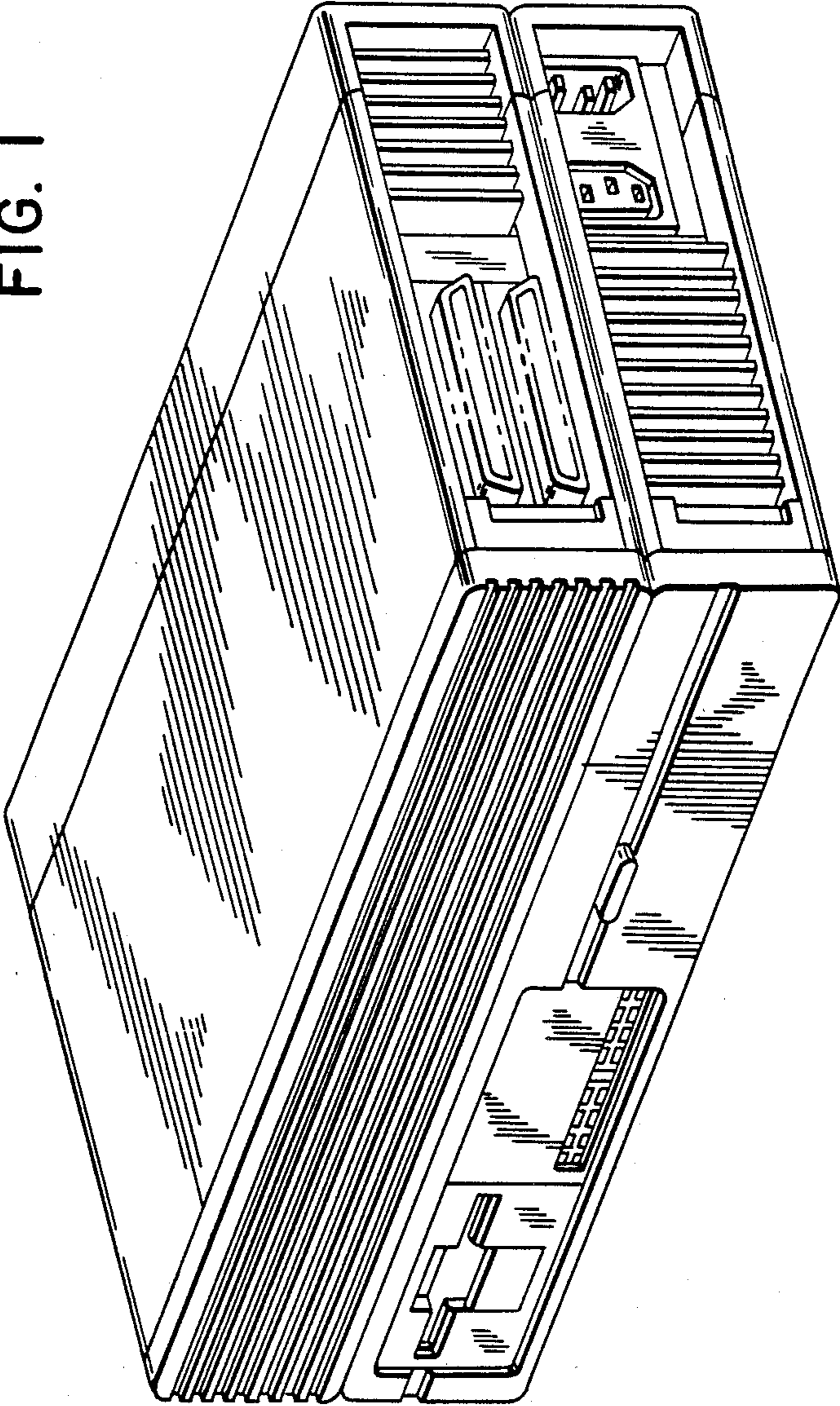
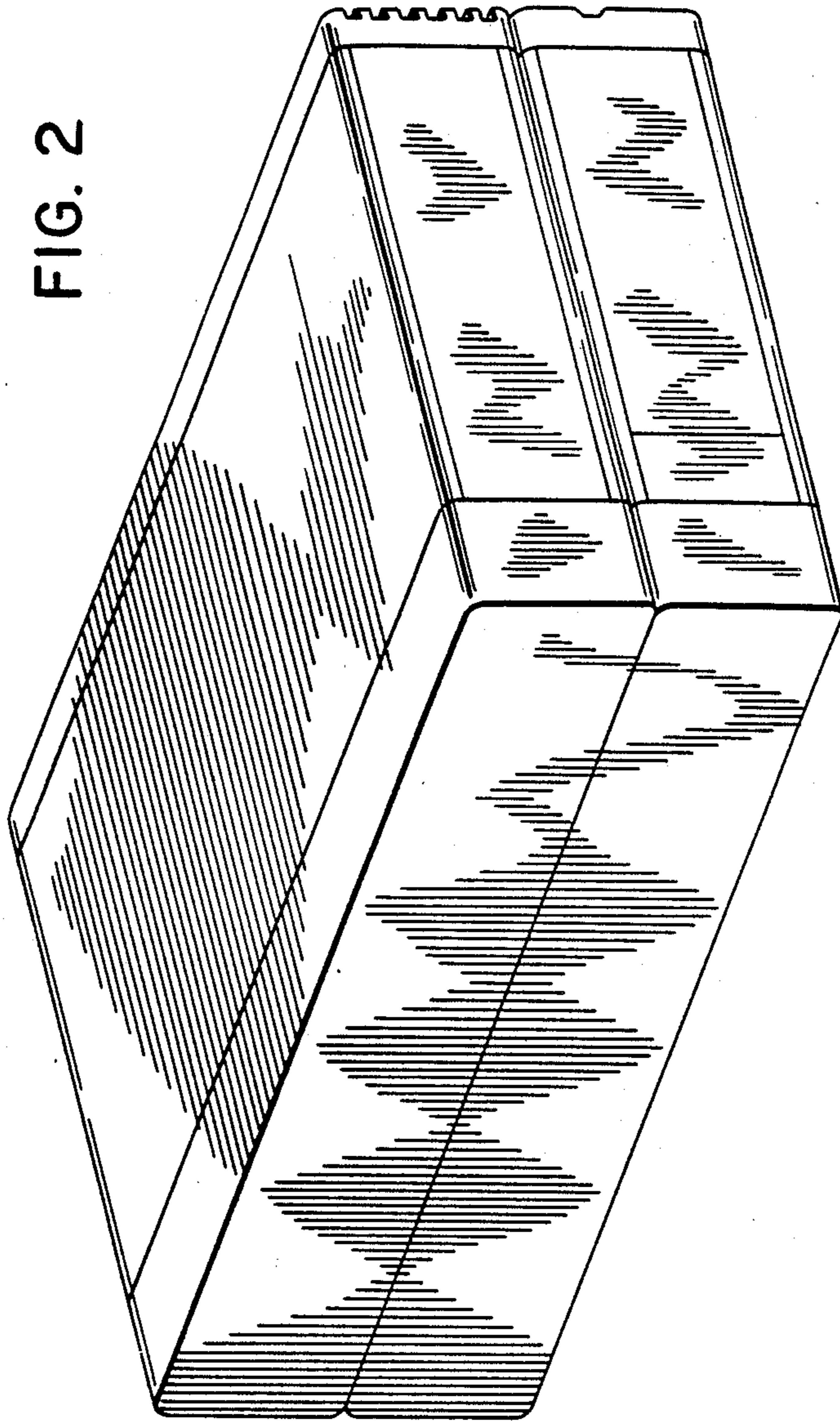

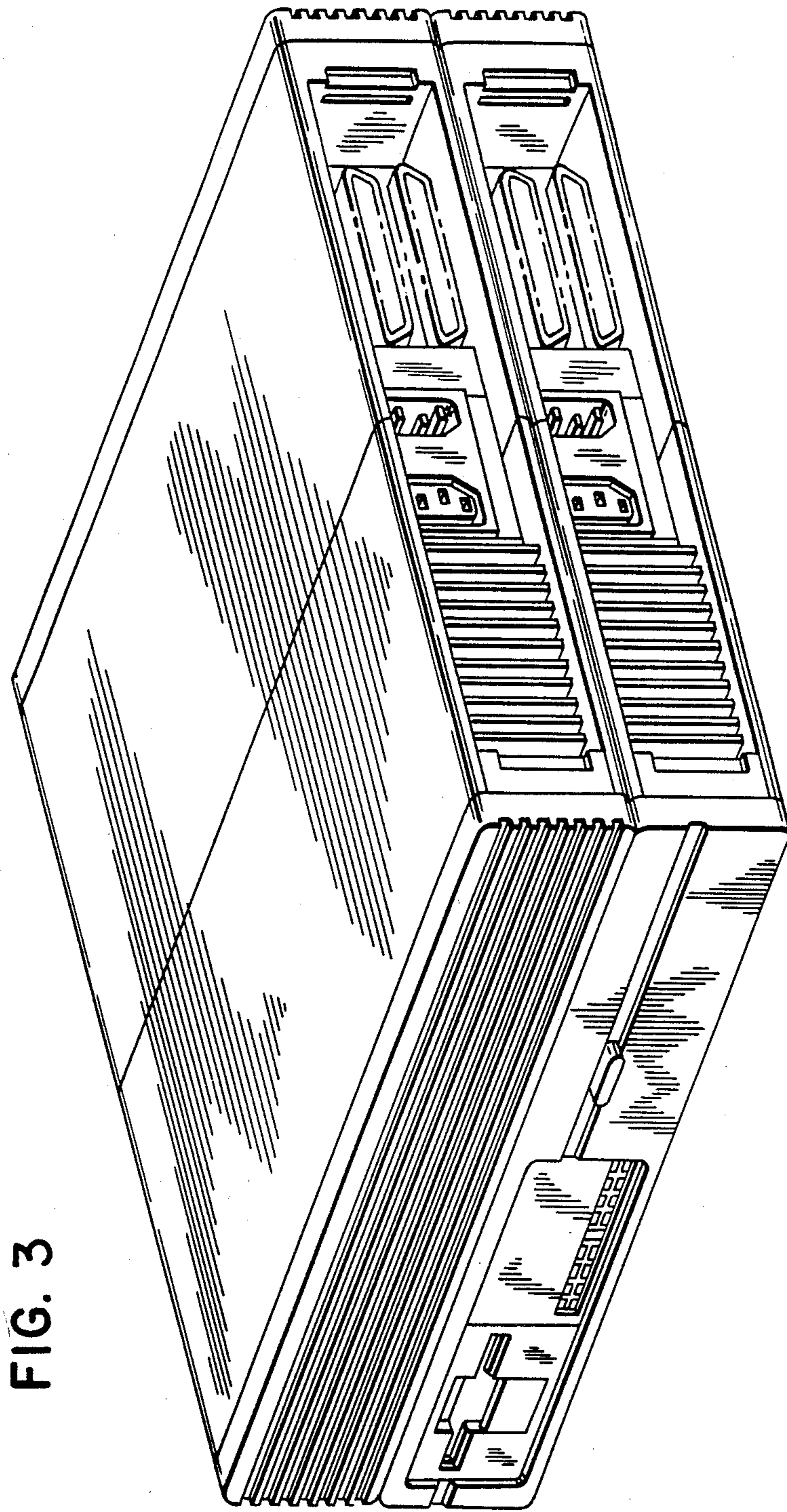

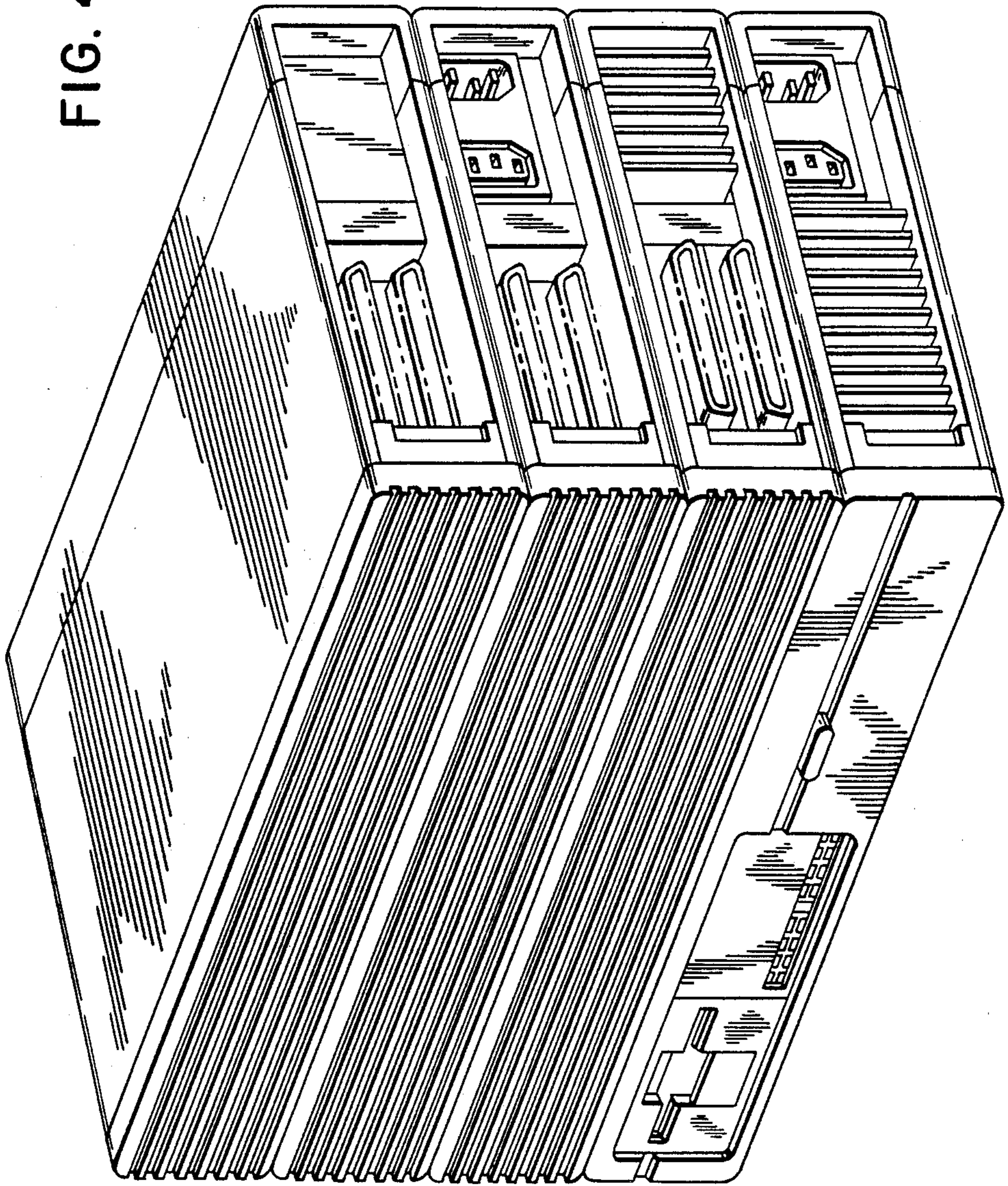

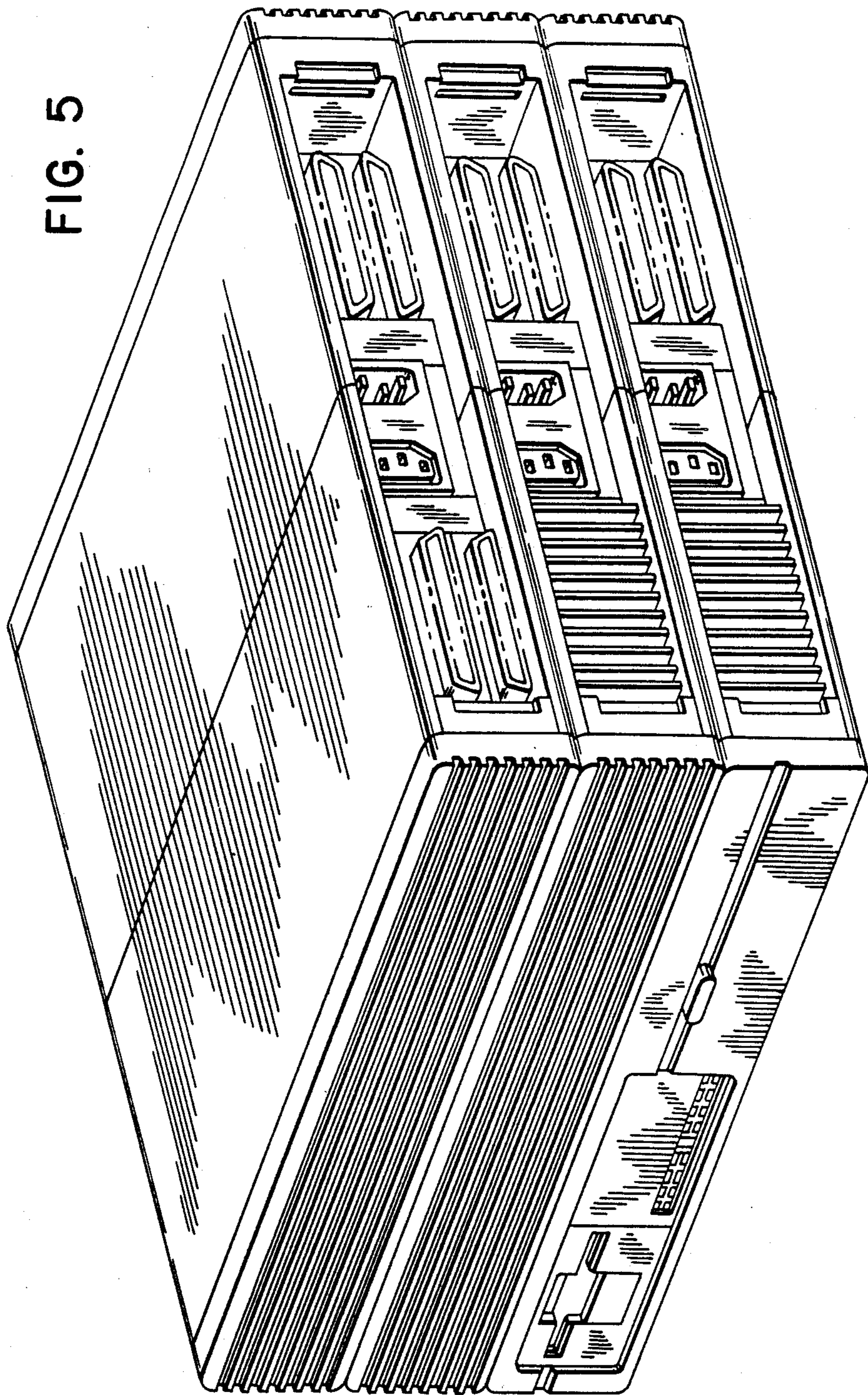

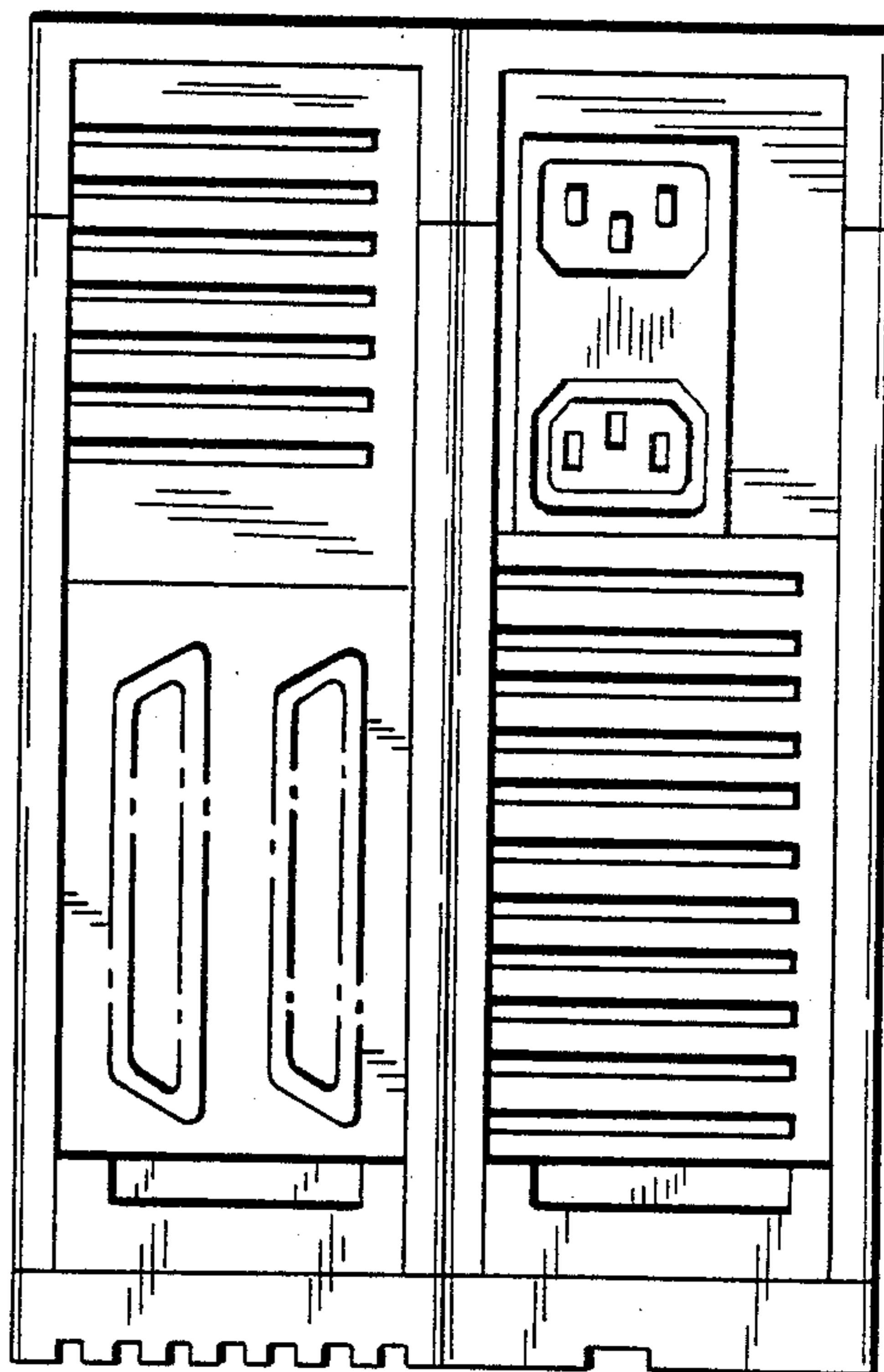
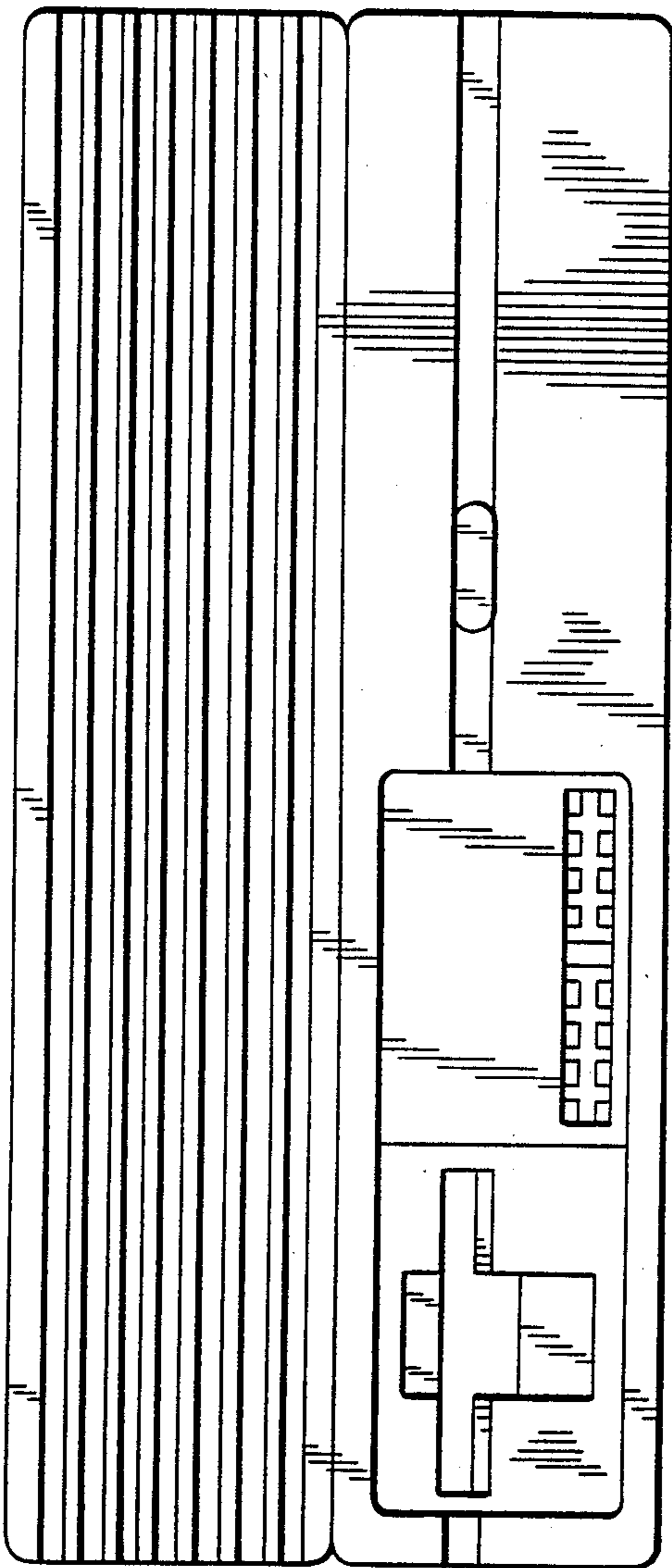
