DESCRIPTION

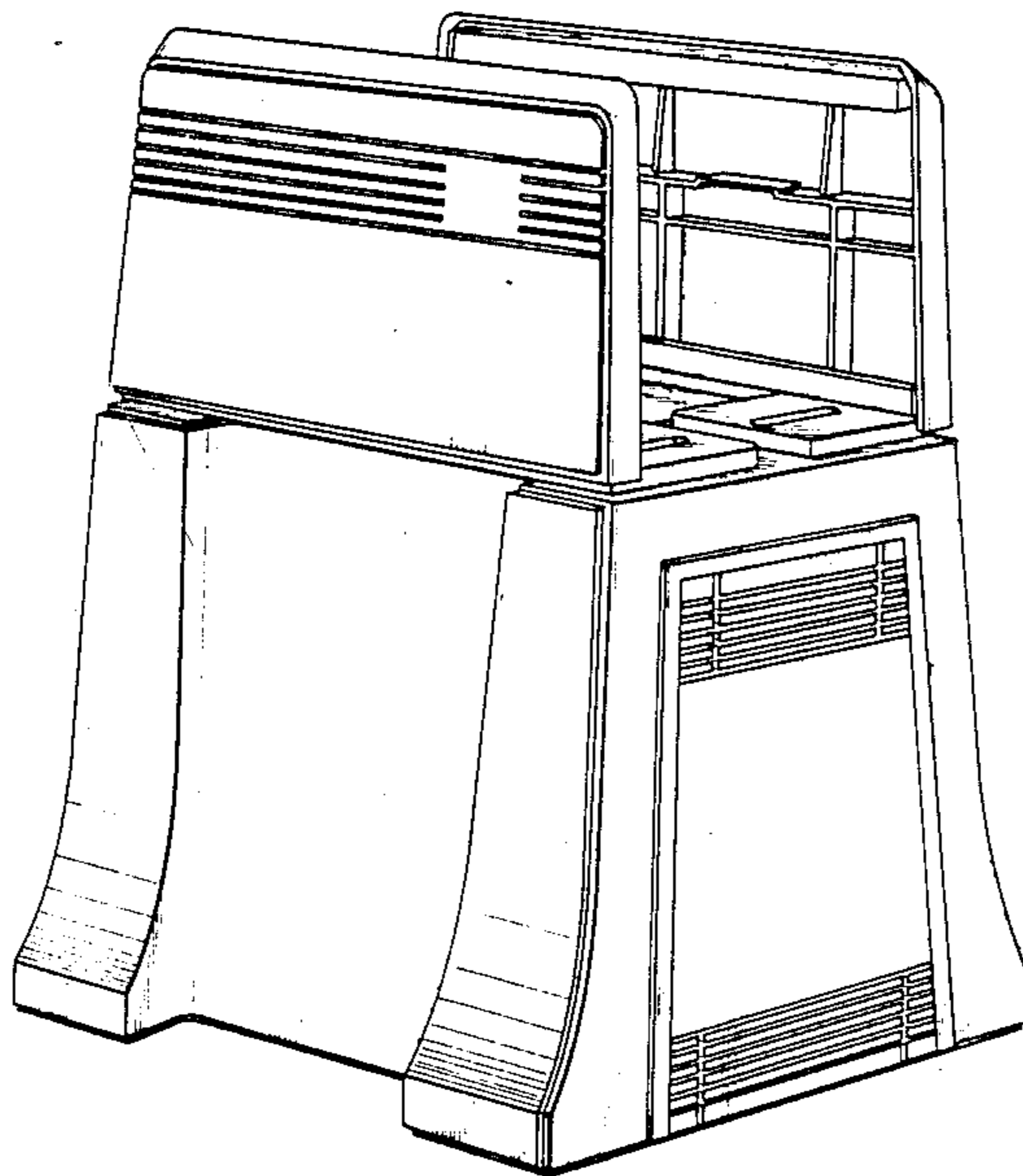
FIG. 1 is a top, front, left side perspective view of a vertical stand for central processing unit showing our new design;

FIG. 5 is a front elevational view thereof on an enlarged scale, the rear elevational view being a mirror image;



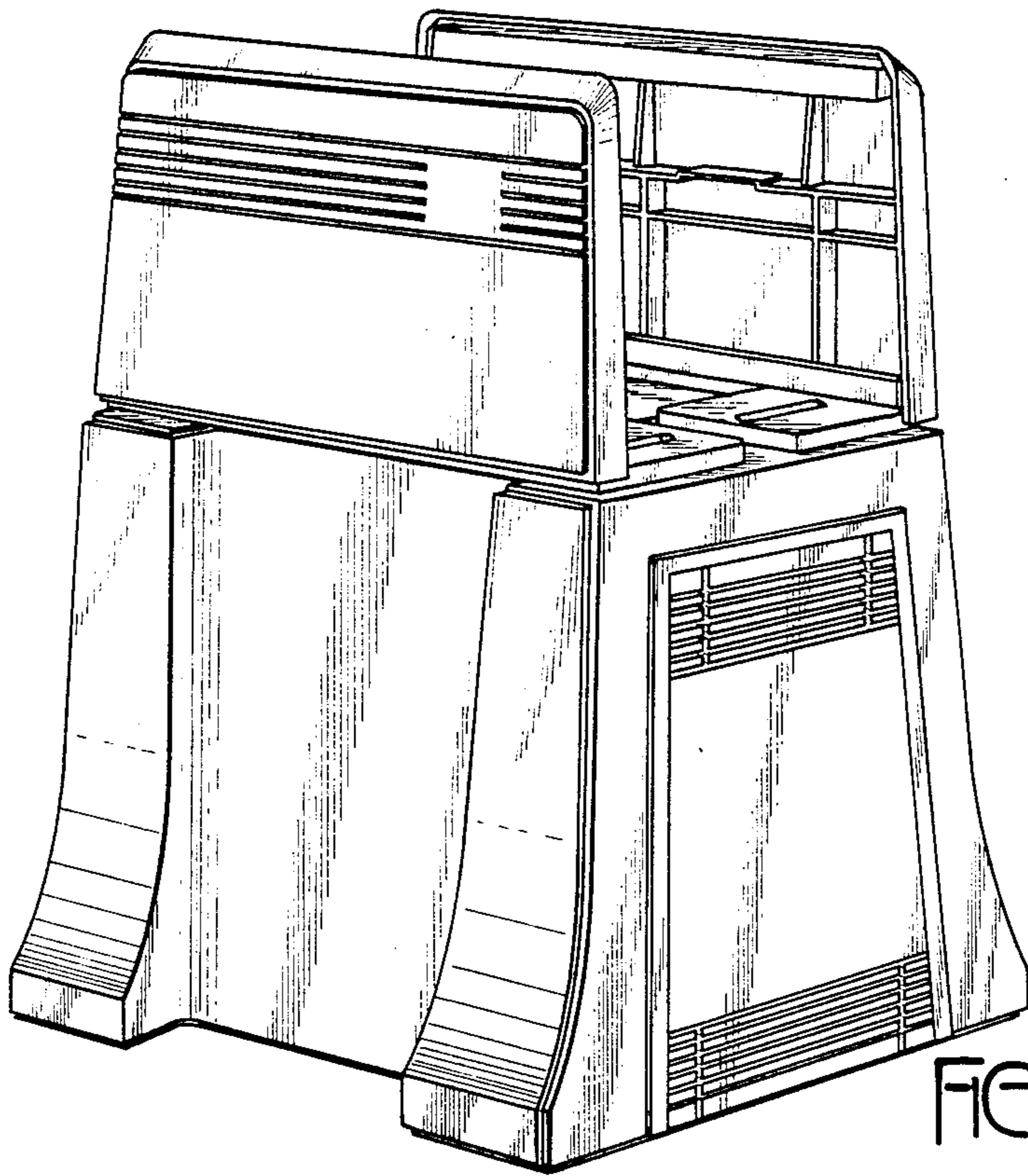

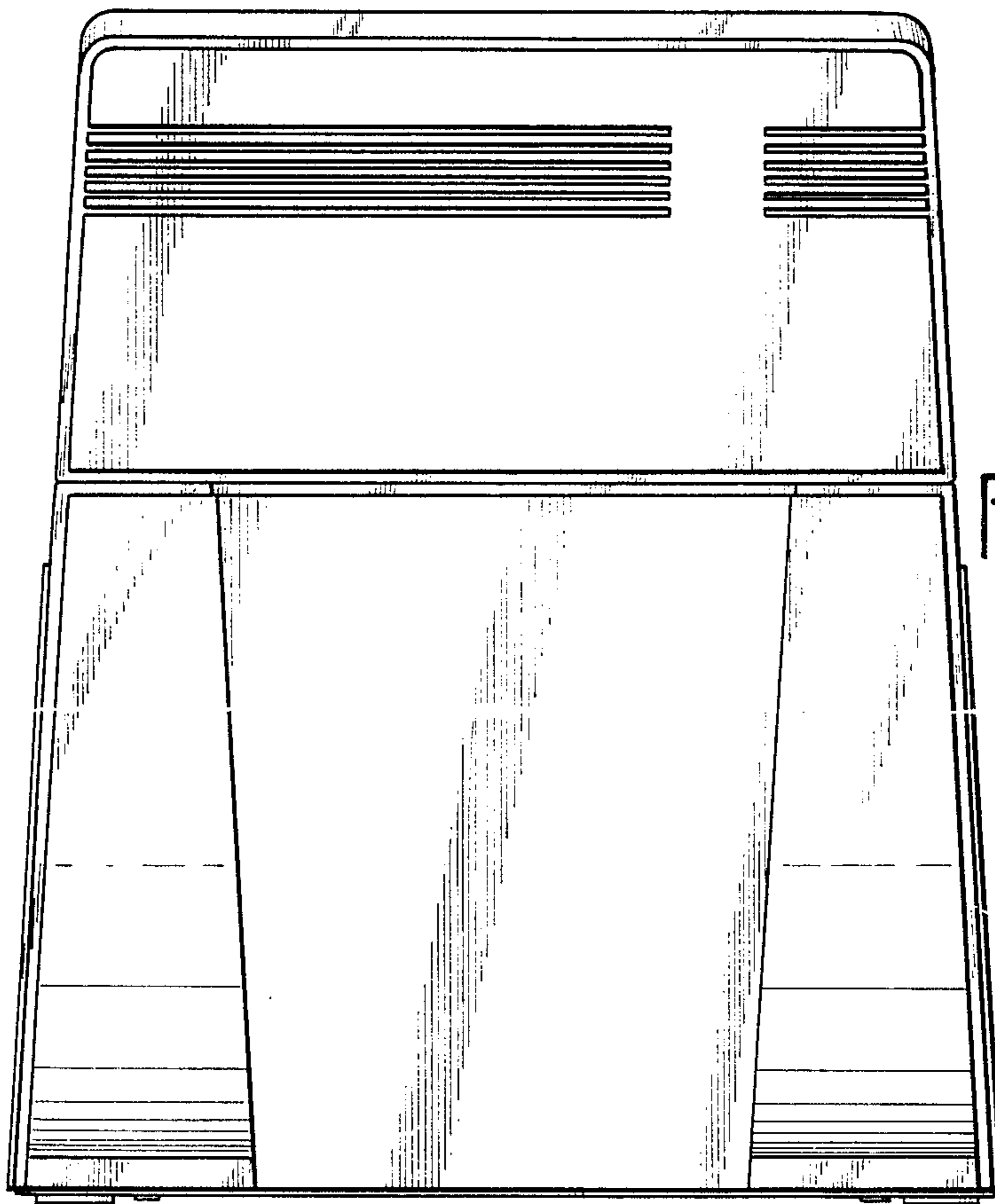

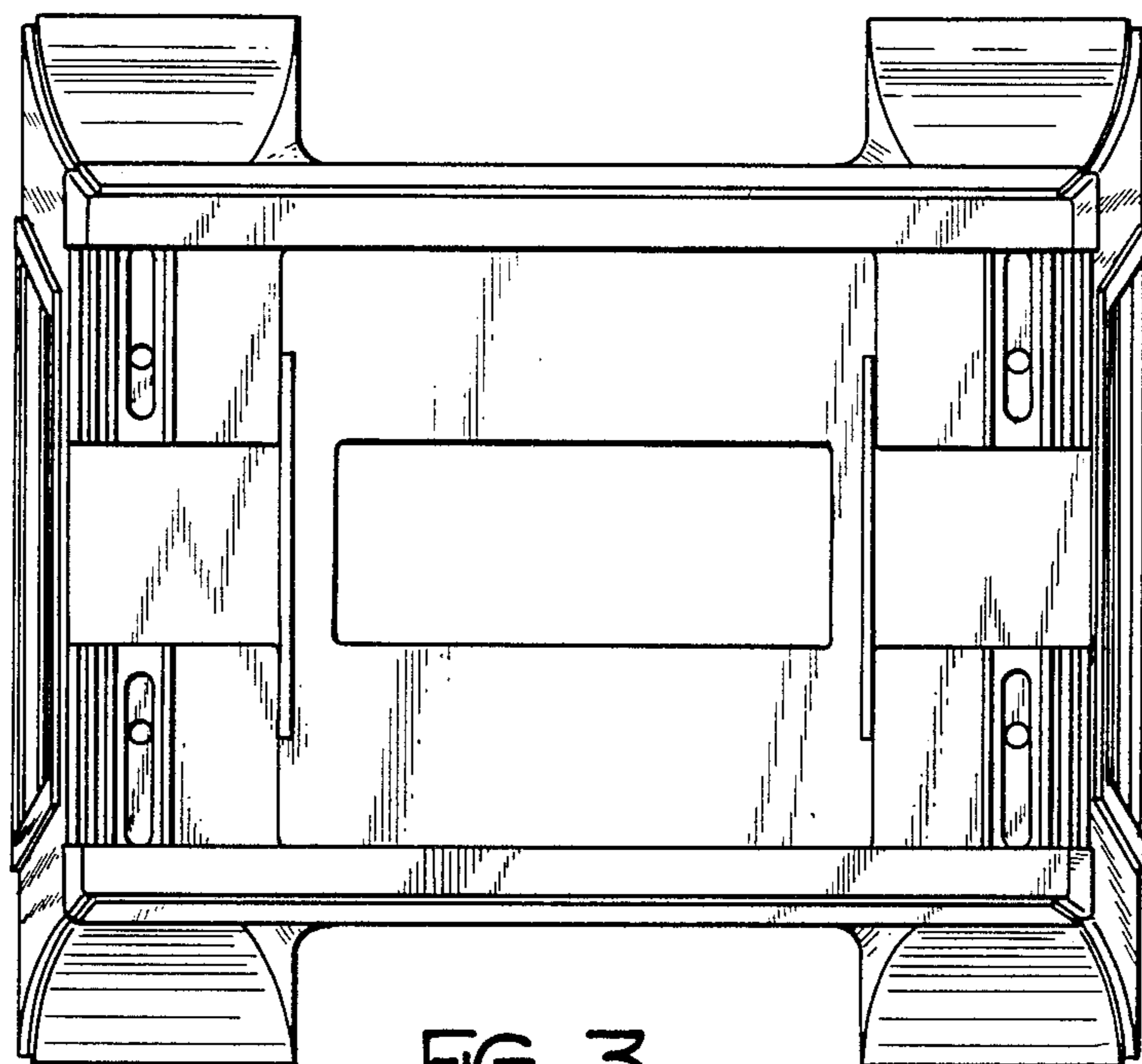

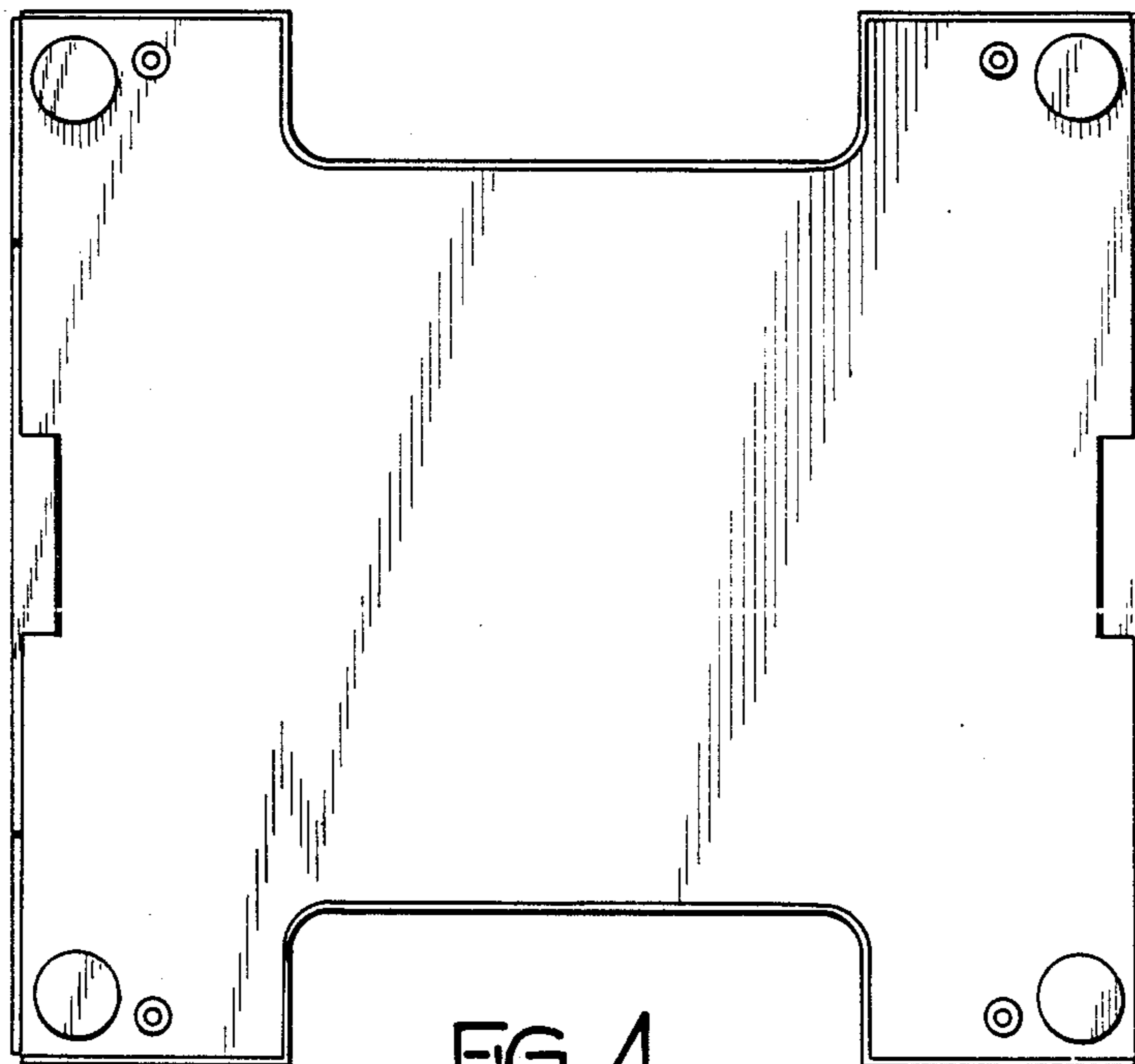

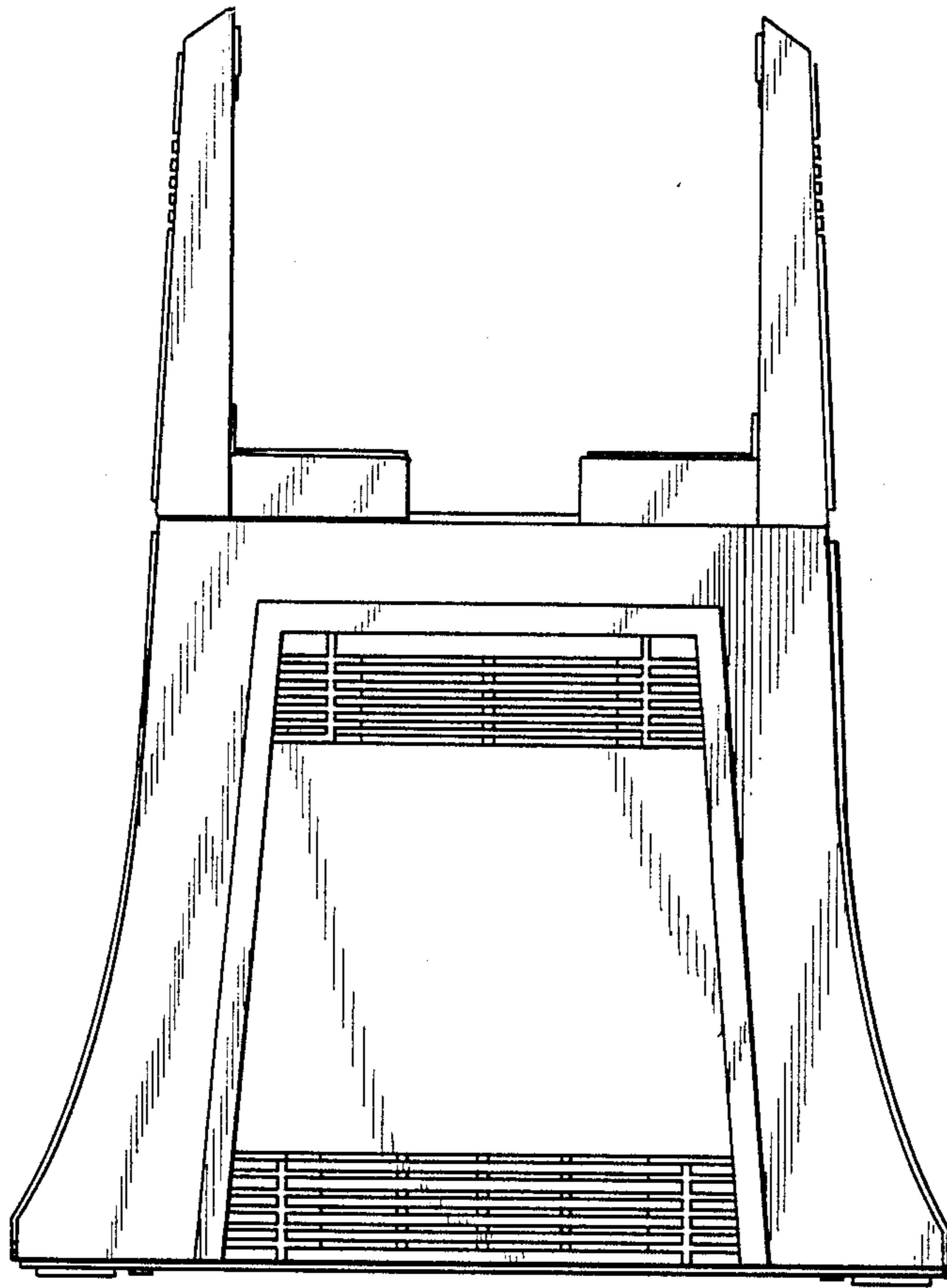
