DESCRIPTION

FIG. 1 is a perspective view of a confection package showing a preferred embodiment of my new design; FIG. 2 is a side view thereof, all sides being substantially identical; FIG. 3 is a top plan view thereof; and FIG. 4 is a bottom plan view thereof; The bottom line showing of a retaining arrangement in FIGS. 1, 2 and 3 are for illustrative purposes only.

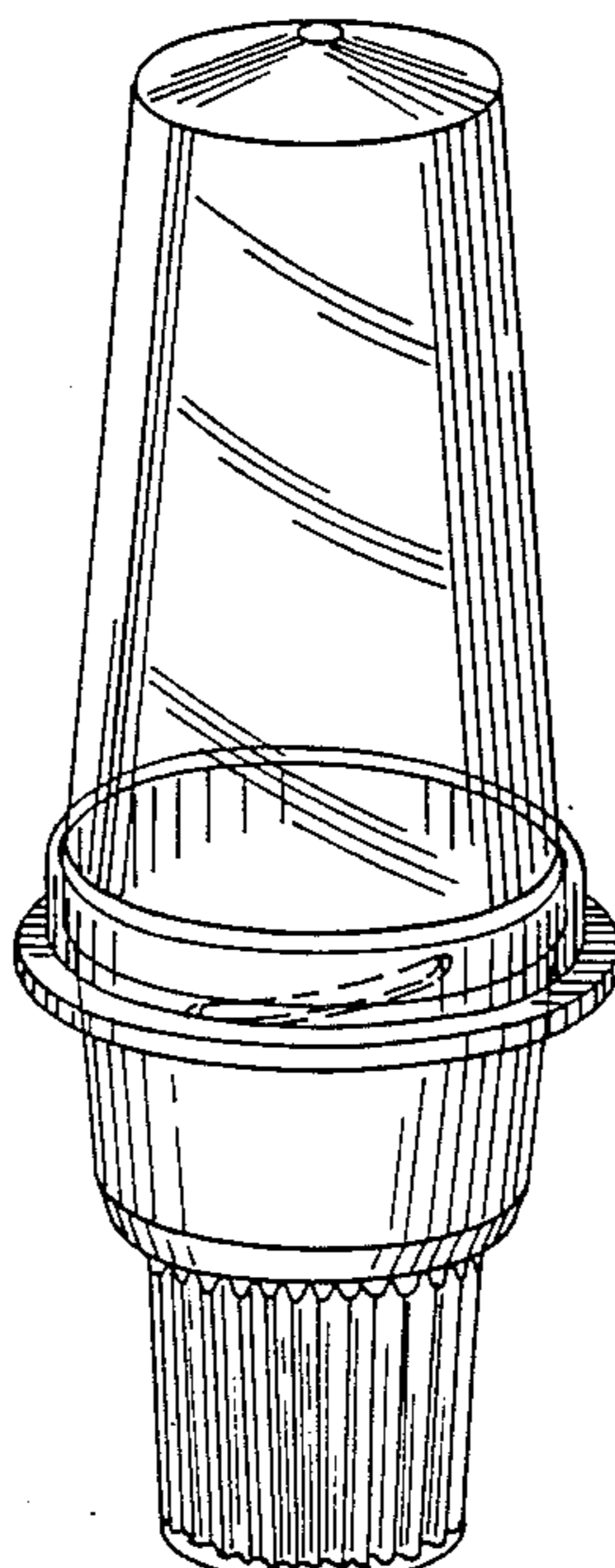

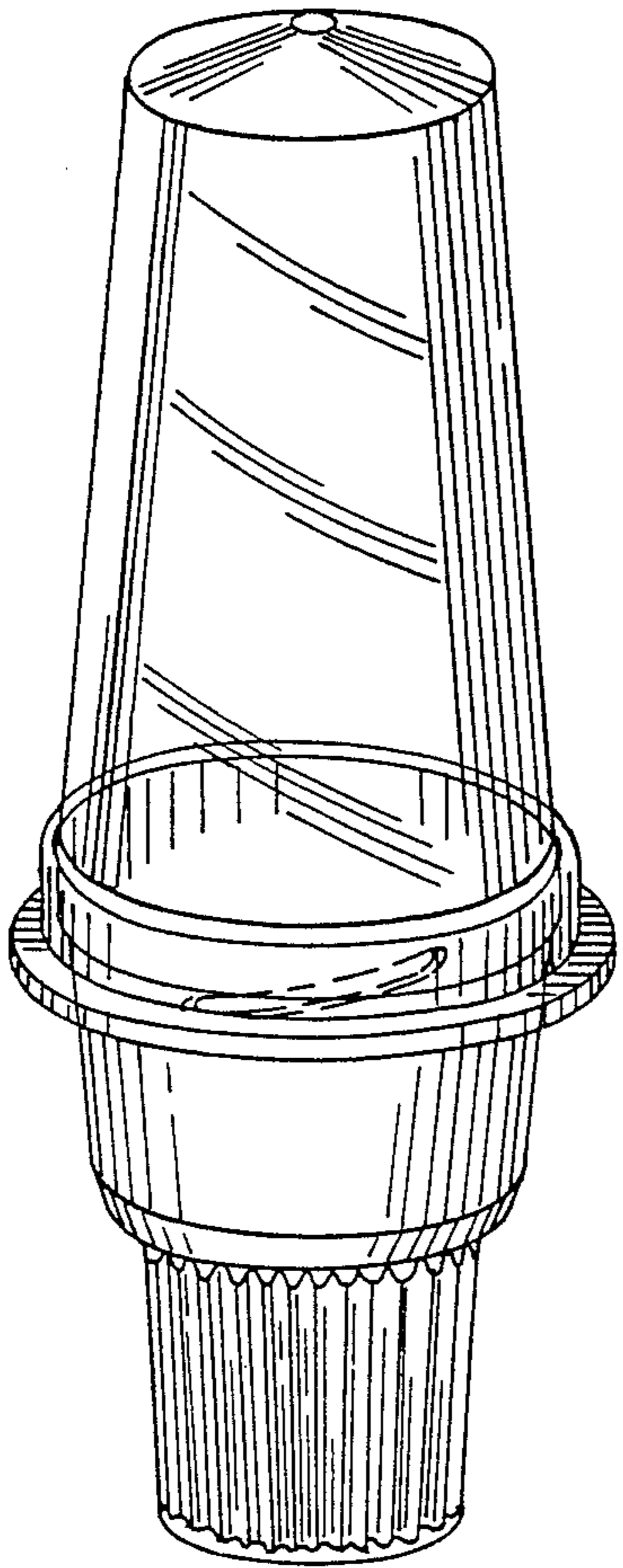

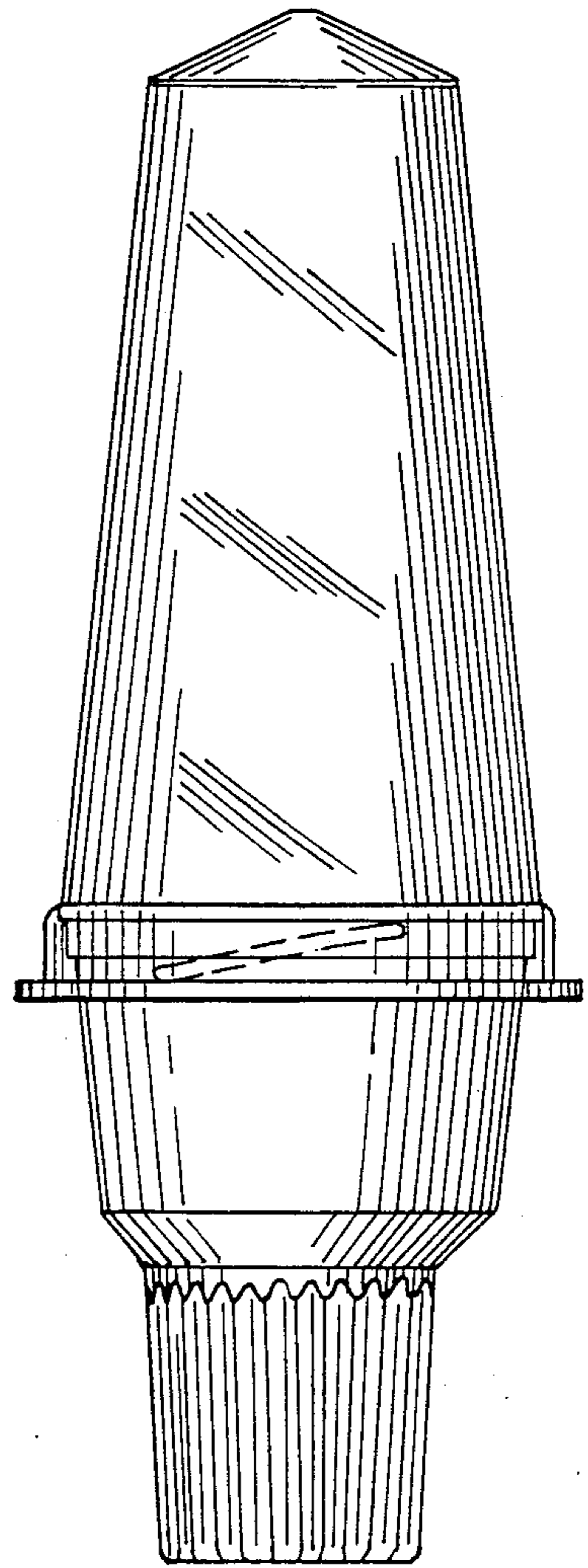

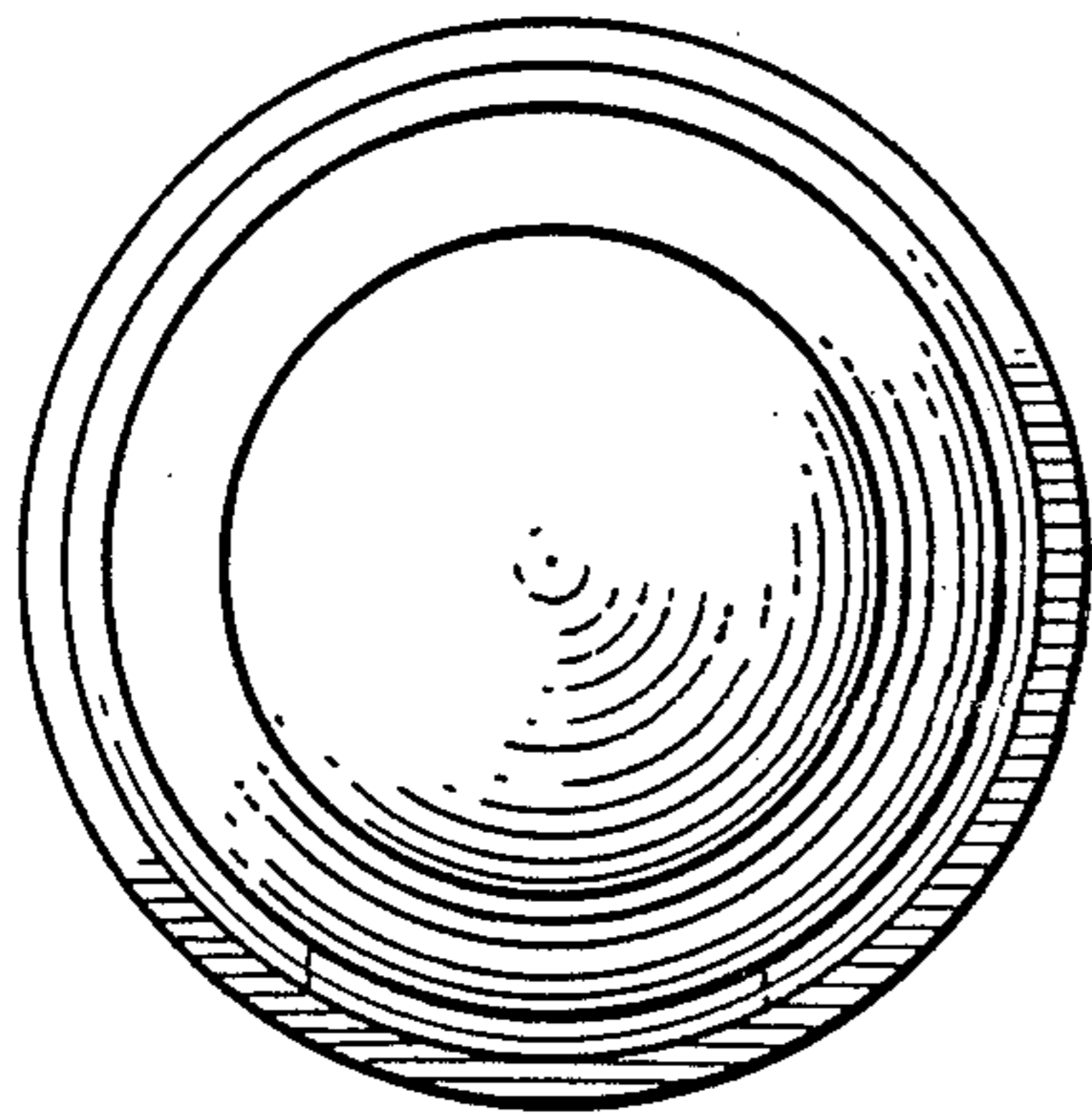
