[57] CLAIM

The ornamental design for a video tape recorder, as shown and described.

DESCRIPTION

FIG. 1 is a top, front and right side perspective view of a video tape recorder showing our new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a top plan view thereof;

FIG. 4 is a left side elevational view thereof;

FIG. 5 is a right side elevational view thereof;

FIG. 6 is a rear elevational view thereof;

FIG. 7 is a bottom plan view thereof;

FIG. 8 is a front elevational view thereof in powered condition;

FIG. 9 is a front elevational view thereof with the cover in an open position; and

FIG. 10 is a top, front and right side perspective view thereof when a tape cassette is loaded, the broken line showing of a cassette being environmental only and forming no part of the claimed design.

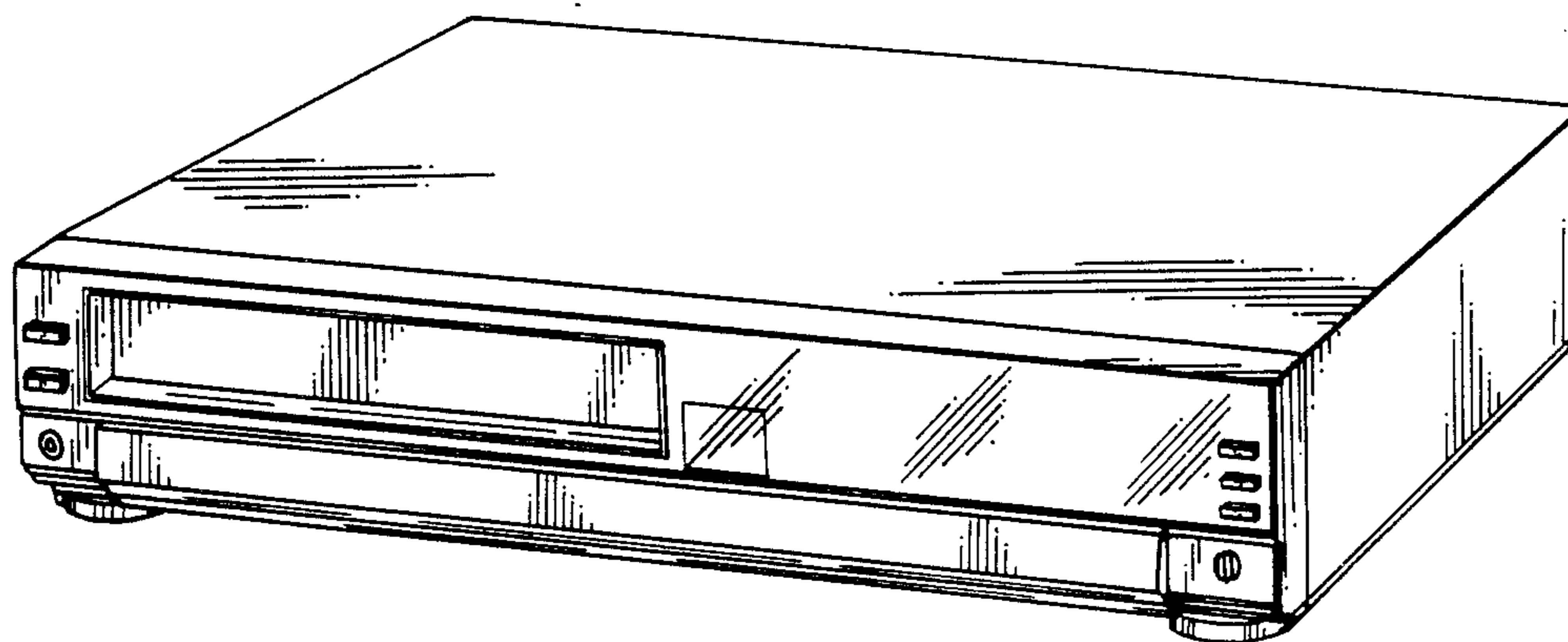

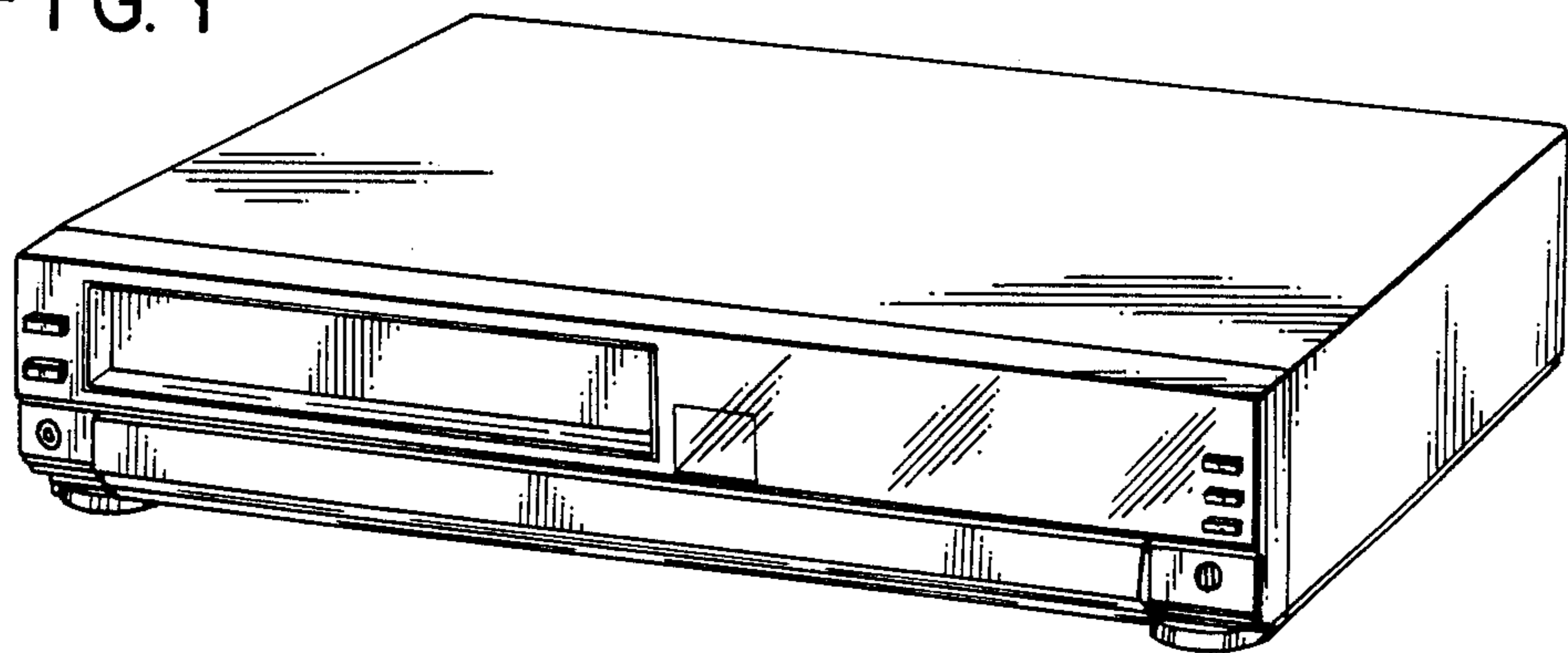

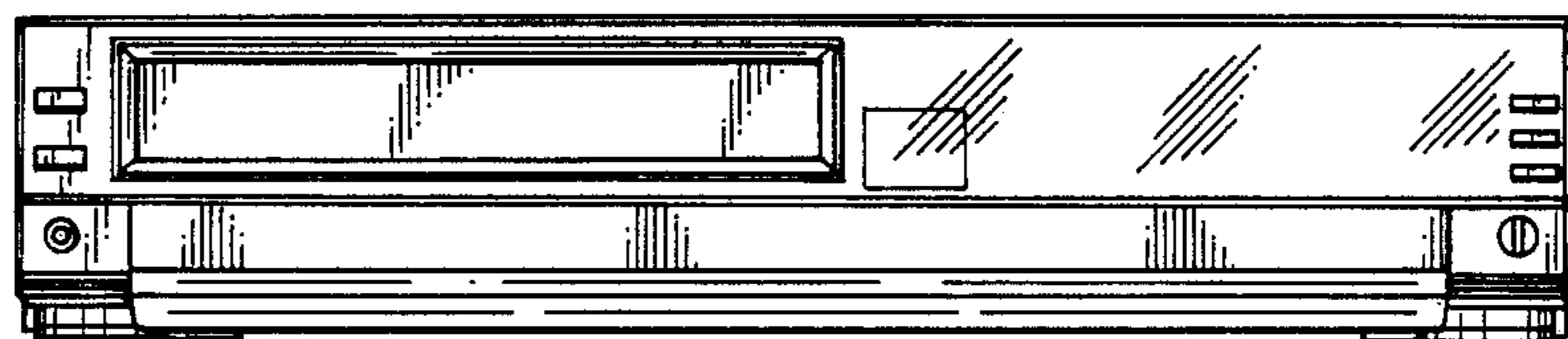

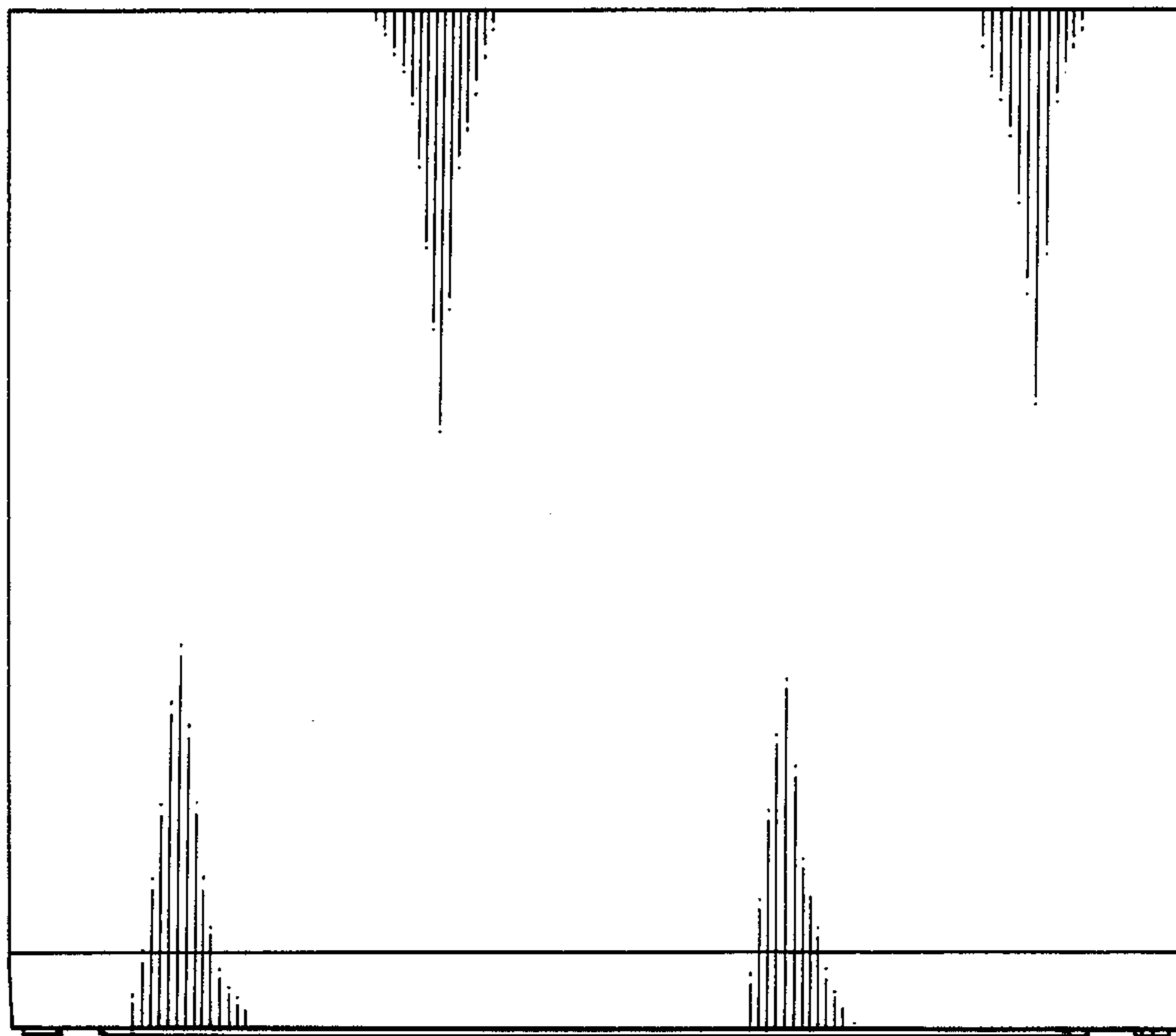

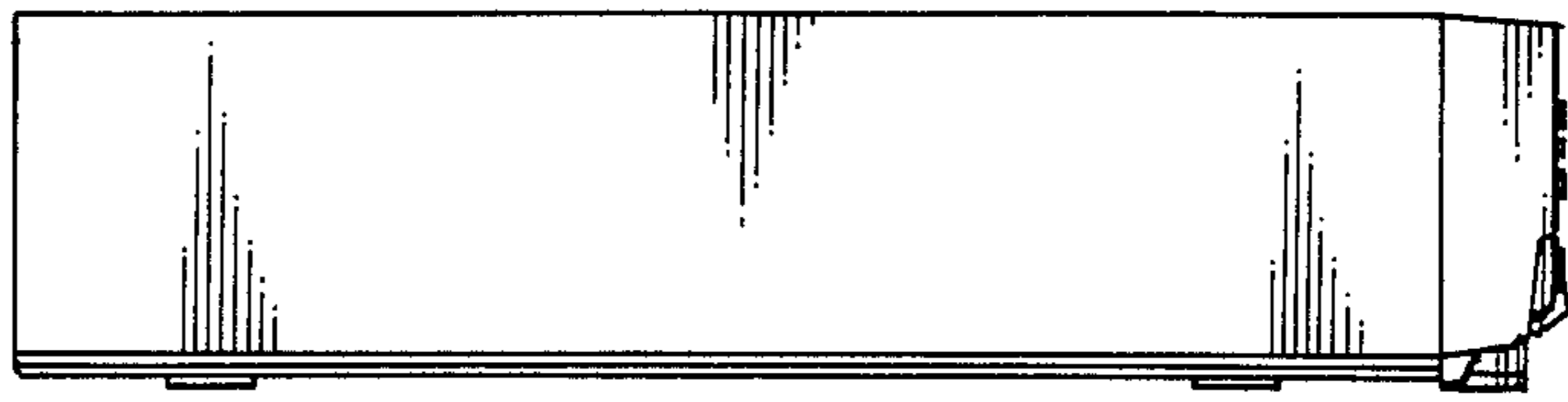

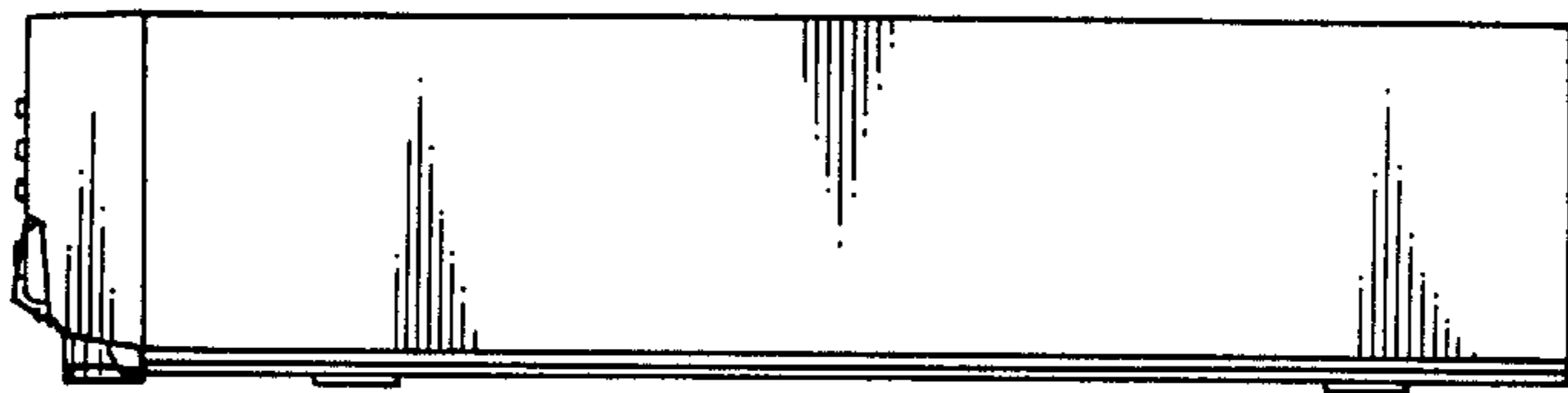

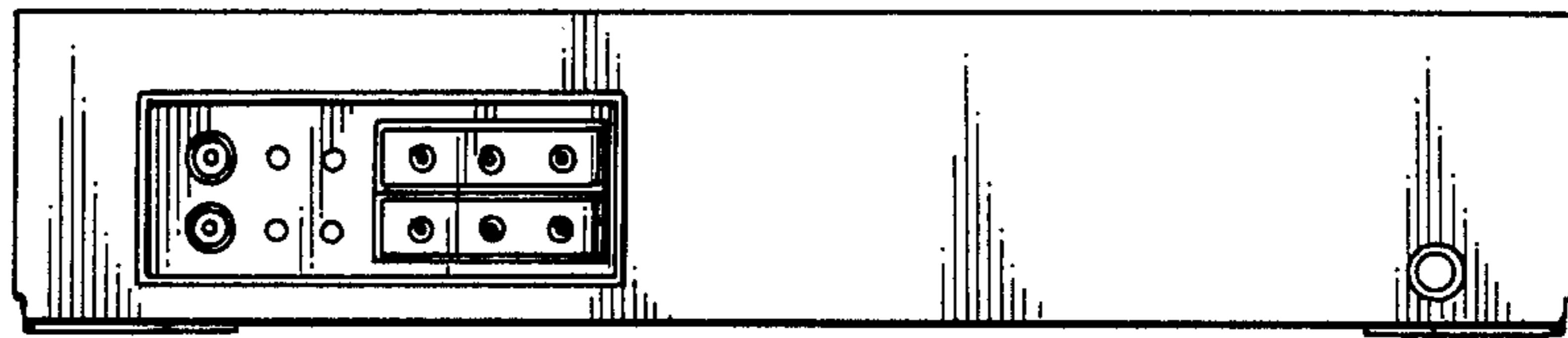

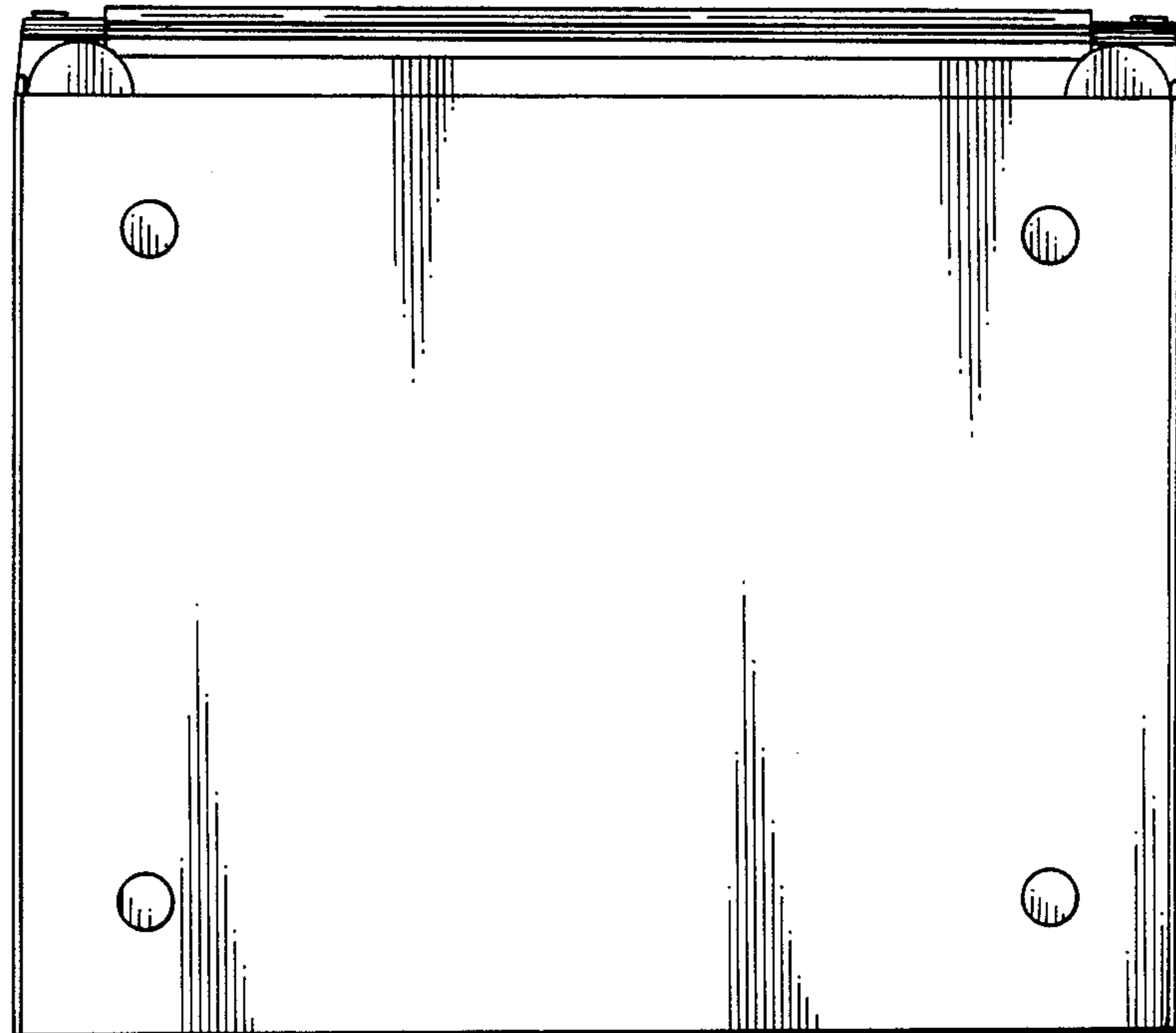

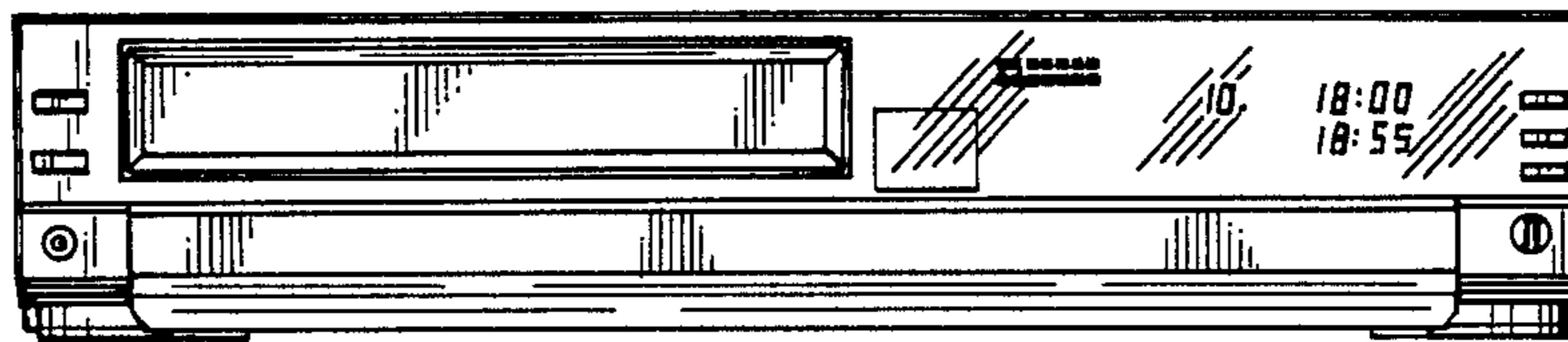

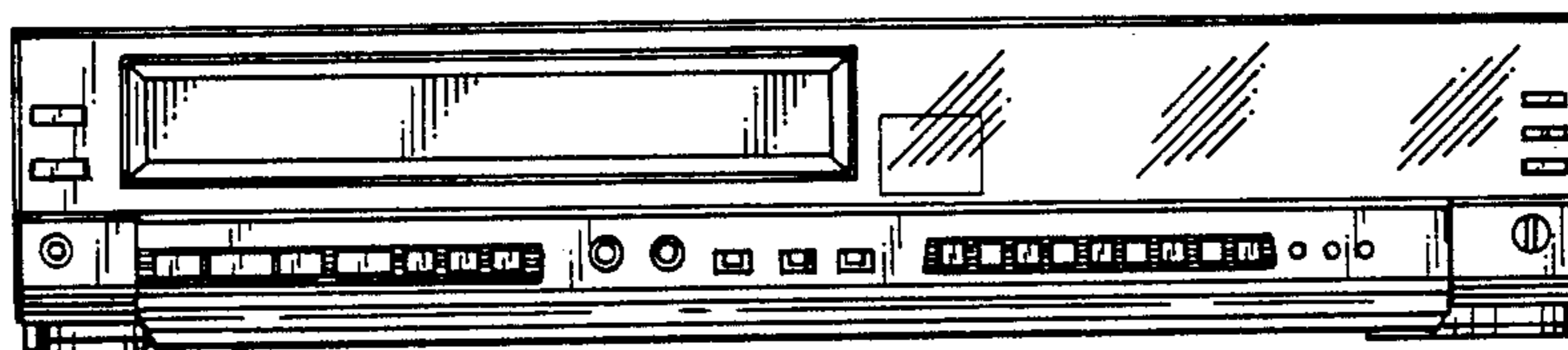
