[57] CLAIM

The ornamental design for a shoe upper, as shown and described.

DESCRIPTION

FIG. 1 is a left side elevational view of the shoe upper showing my new design. The broken line showing a shoe sole is for environmental purposes only and forms no part of the claimed design;

FIG. 2 is a top plan view thereof;

FIG. 3 is a bottom plan view thereof;

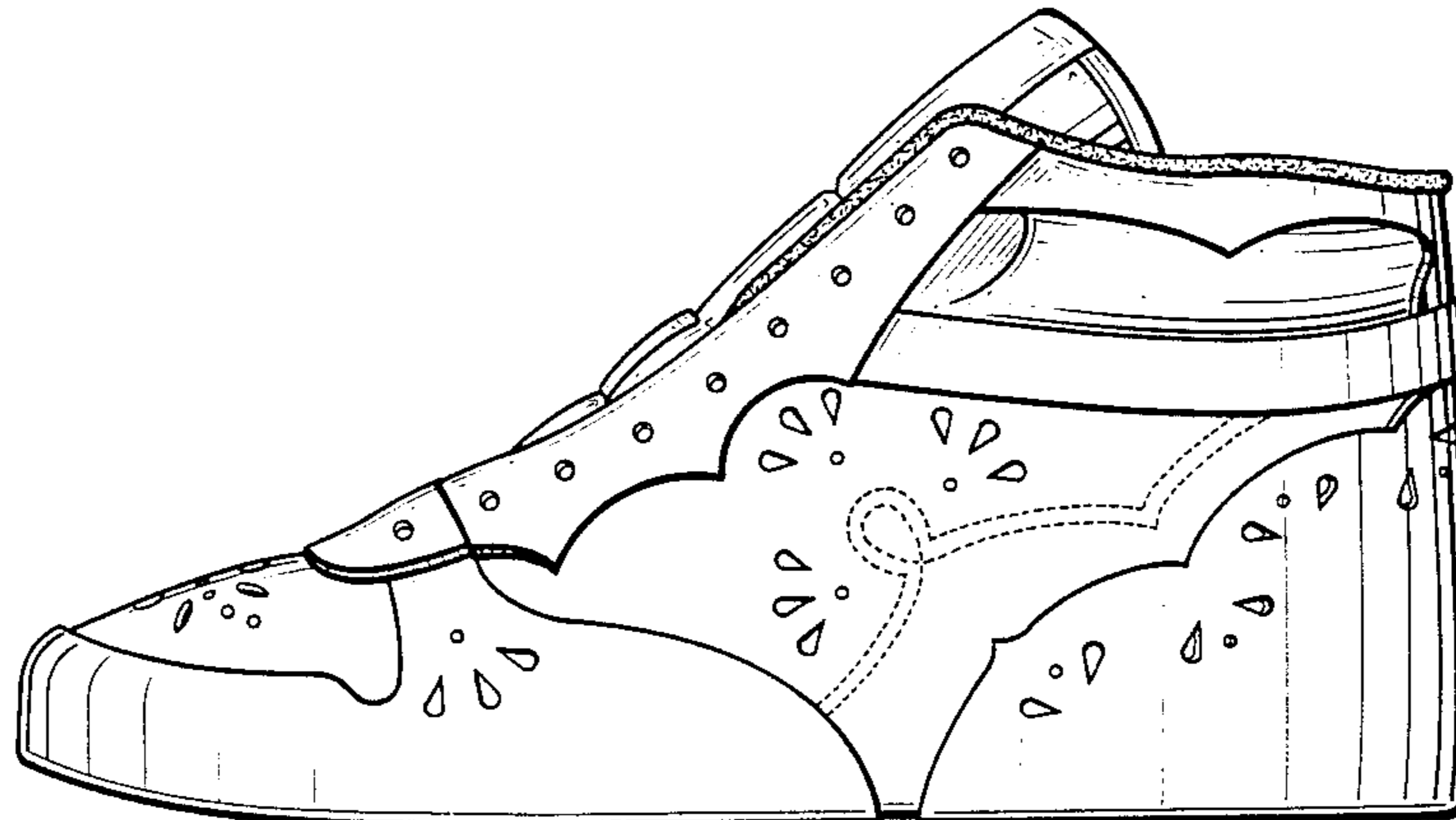
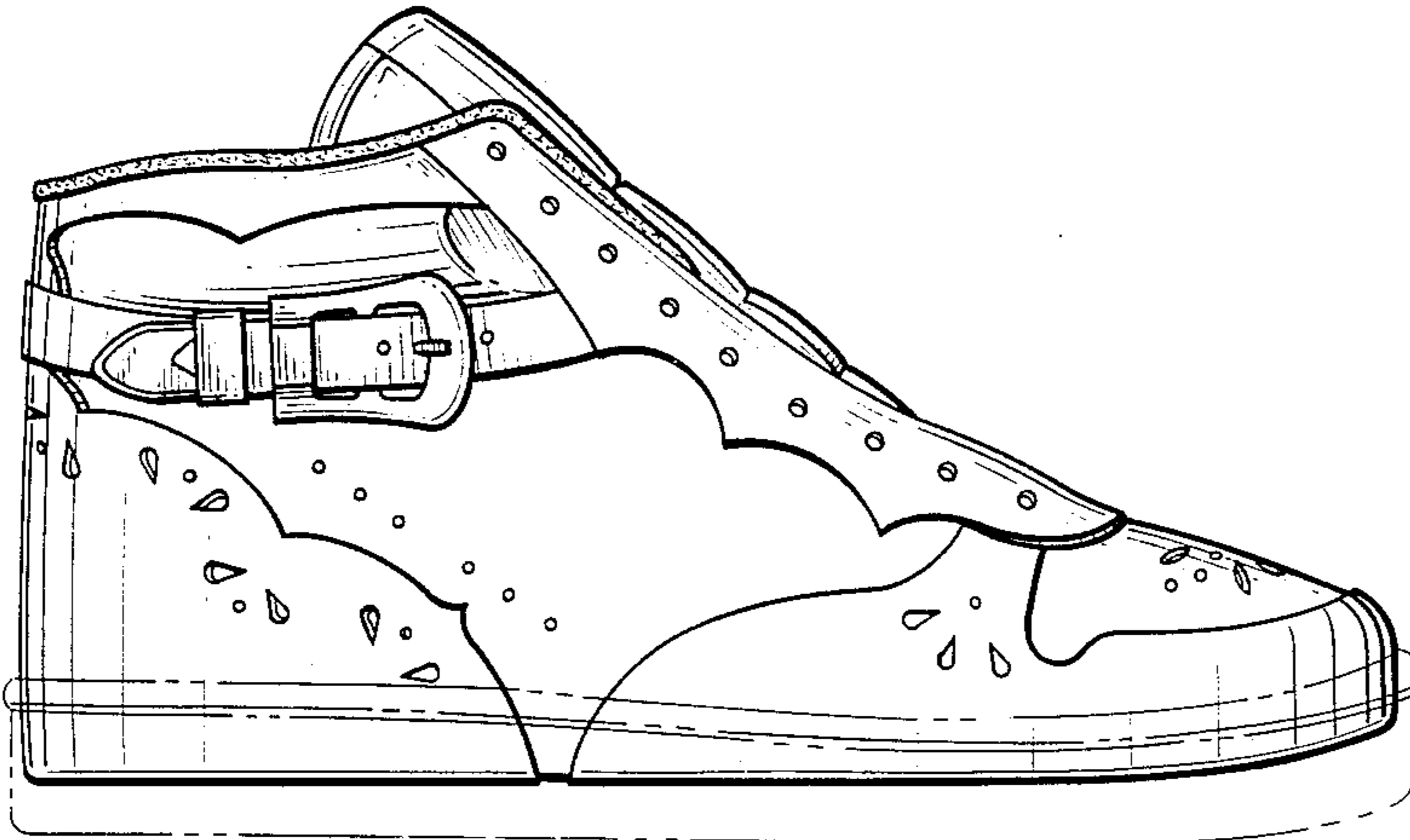
FIG. 4 is a right side elevational view thereof;

A shoe upper having an ornamental design is shown.



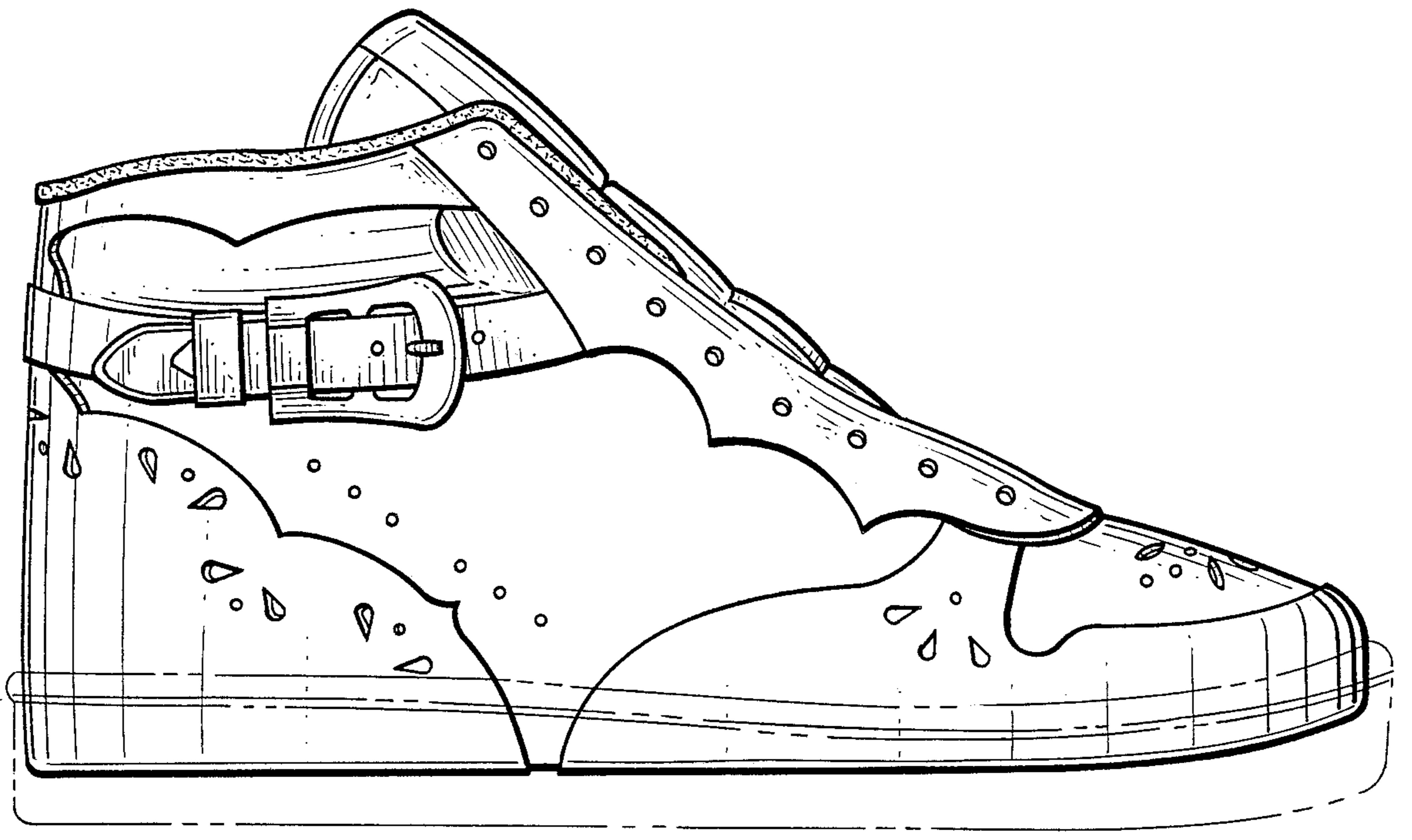

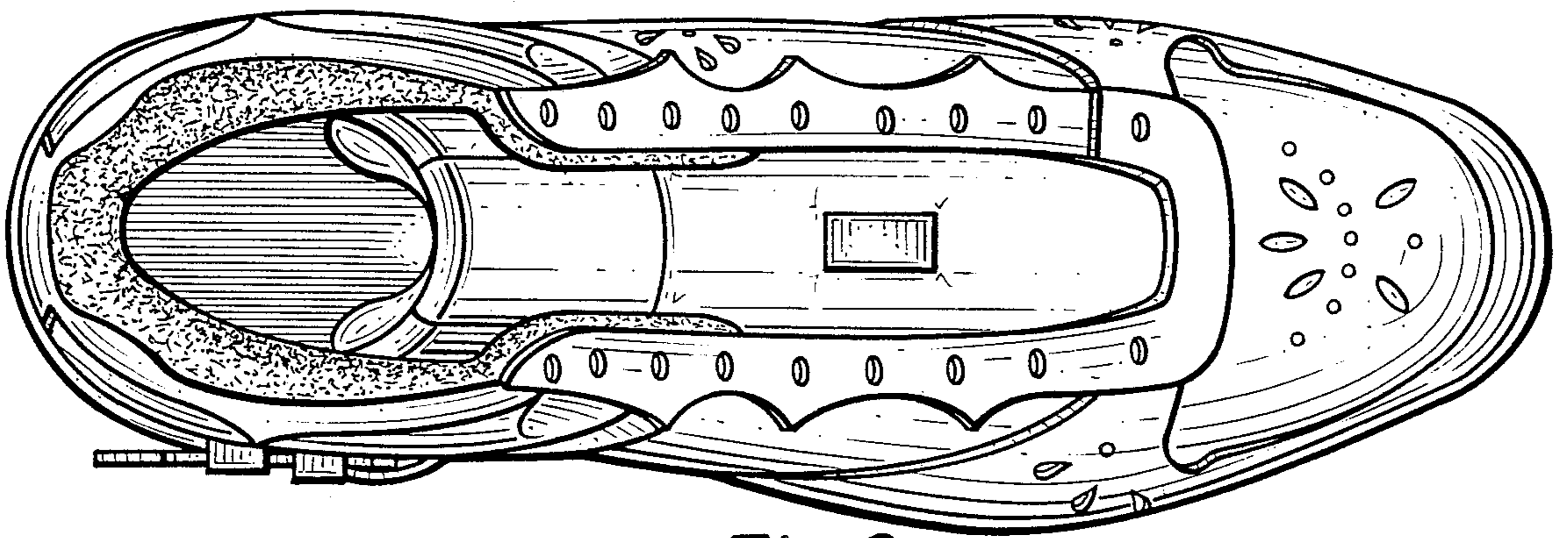

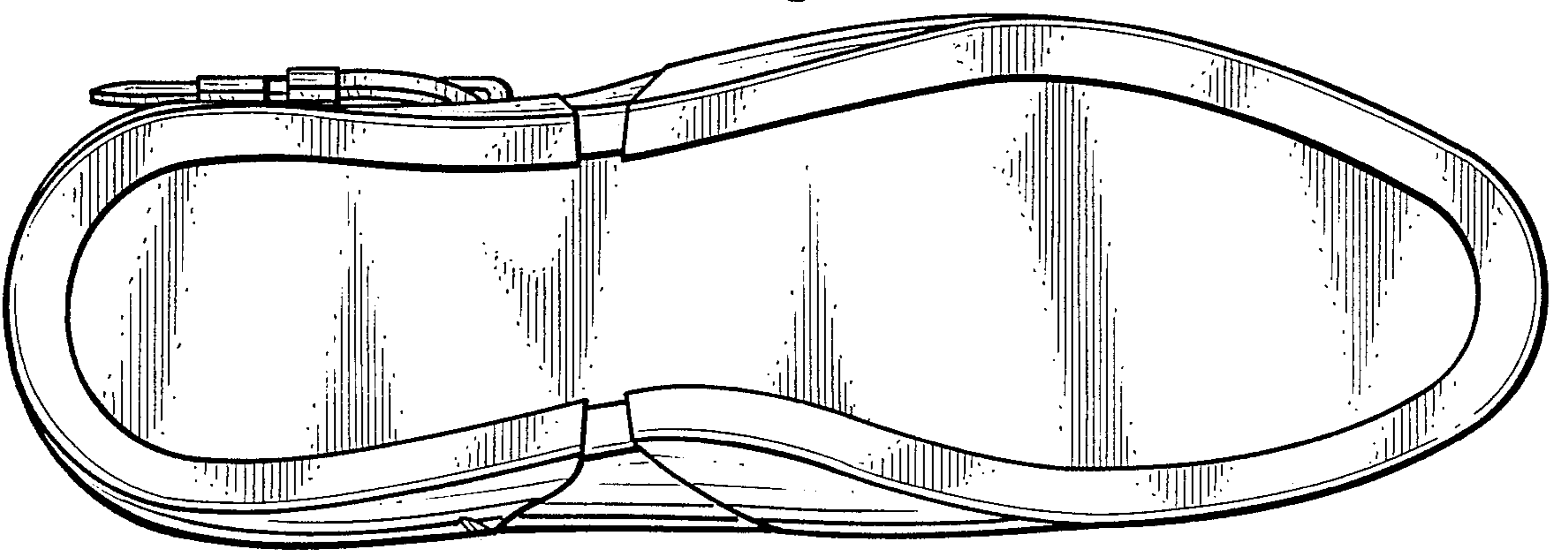

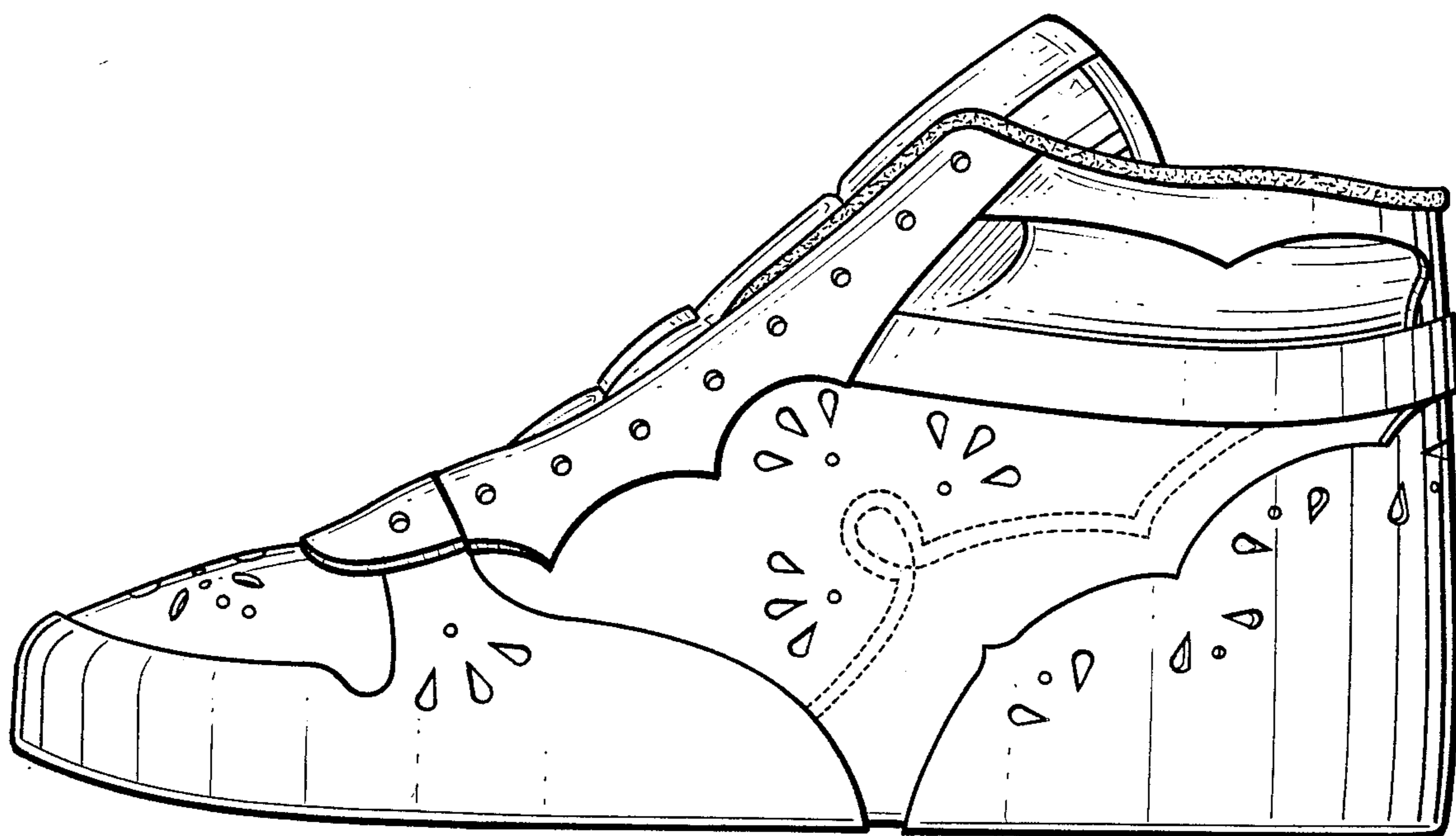

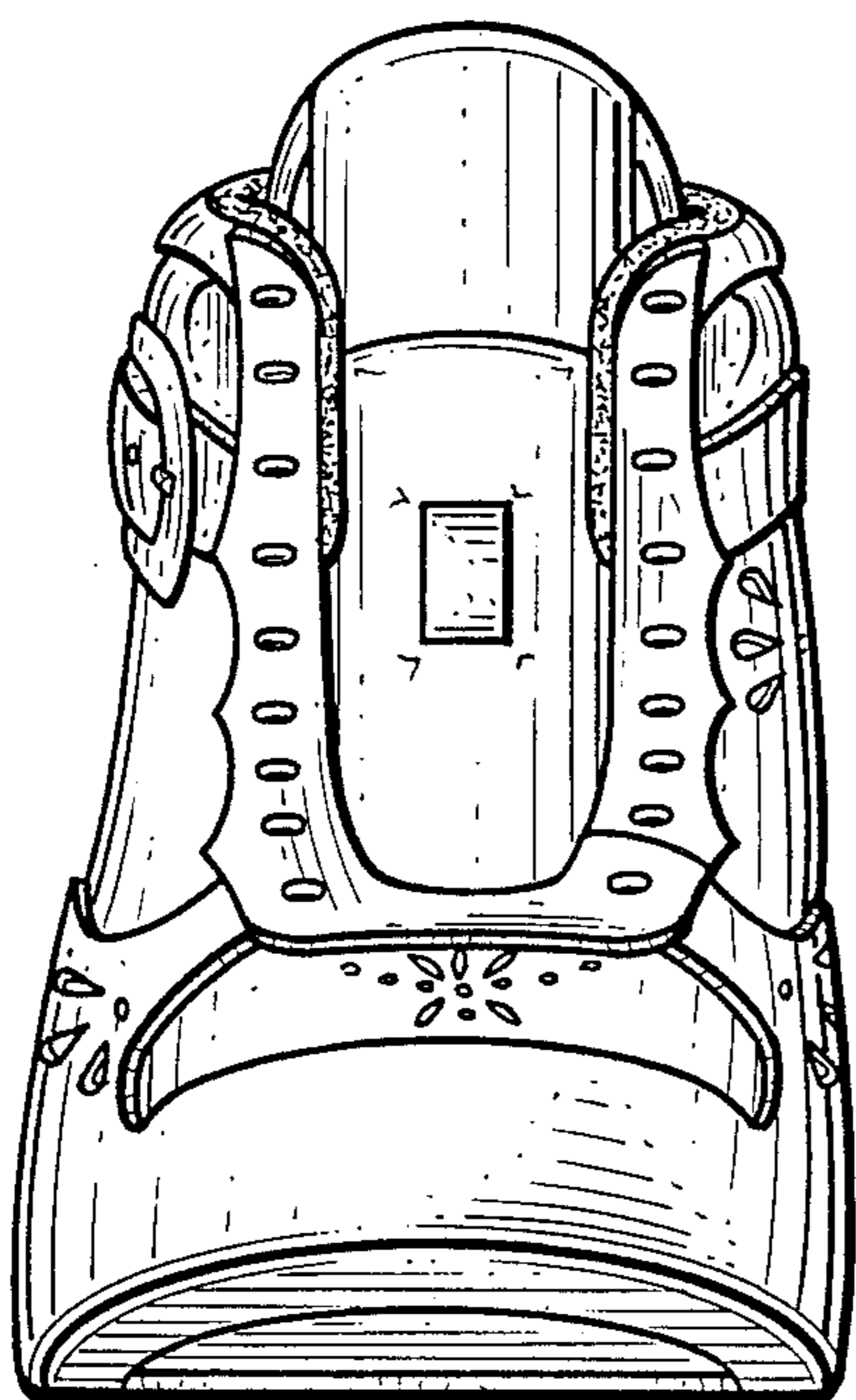

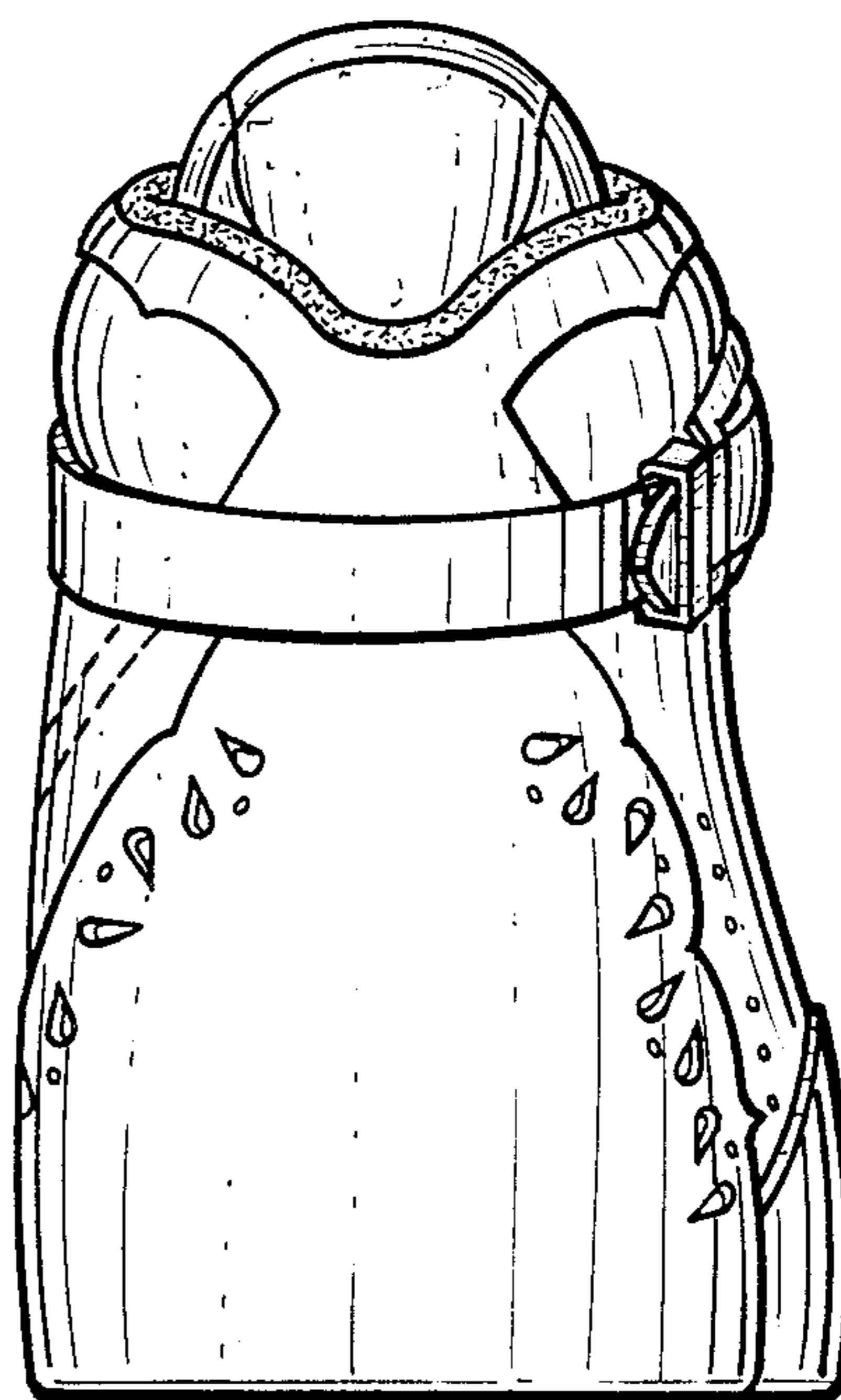
