


The ornamental design for an element for a shoe upper,

DESCRIPTION


FIG. 1 is a left side elevational view of an element for a shoe upper showing my new design;  
FIG. 2 is a right side elevational view thereof;  
FIG. 3 is a top plan view thereof; and  
FIG. 4 is a rear elevational view thereof;  
FIG. 5 is a left side elevational view of an element for a shoe upper showing a second embodiment of my new design;  
FIG. 6 is a right side elevational view of the second embodiment;  
FIG. 7 is a left side elevational view of an element for a shoe upper showing a third embodiment of my new design;  
FIG. 8 is a right side elevational view of the third embodiment;  
FIG. 9 is a left side elevational view of an element for a shoe upper showing a fourth embodiment of my new design;  
FIG. 10 is a right side elevational view of the fourth embodiment;  
FIG. 11 is a left side elevational view of an element for a shoe upper showing a fifth embodiment of my new design; and  
FIG. 12 is a right side elevational view of the fifth embodiment.  
The broken line showing of a shoe upper and sole, including the cupped vertical sides of the sole, is for illustrative purposes only and forms no part of the claimed design.




















