 FIG. 21 is a bottom plan view thereof.

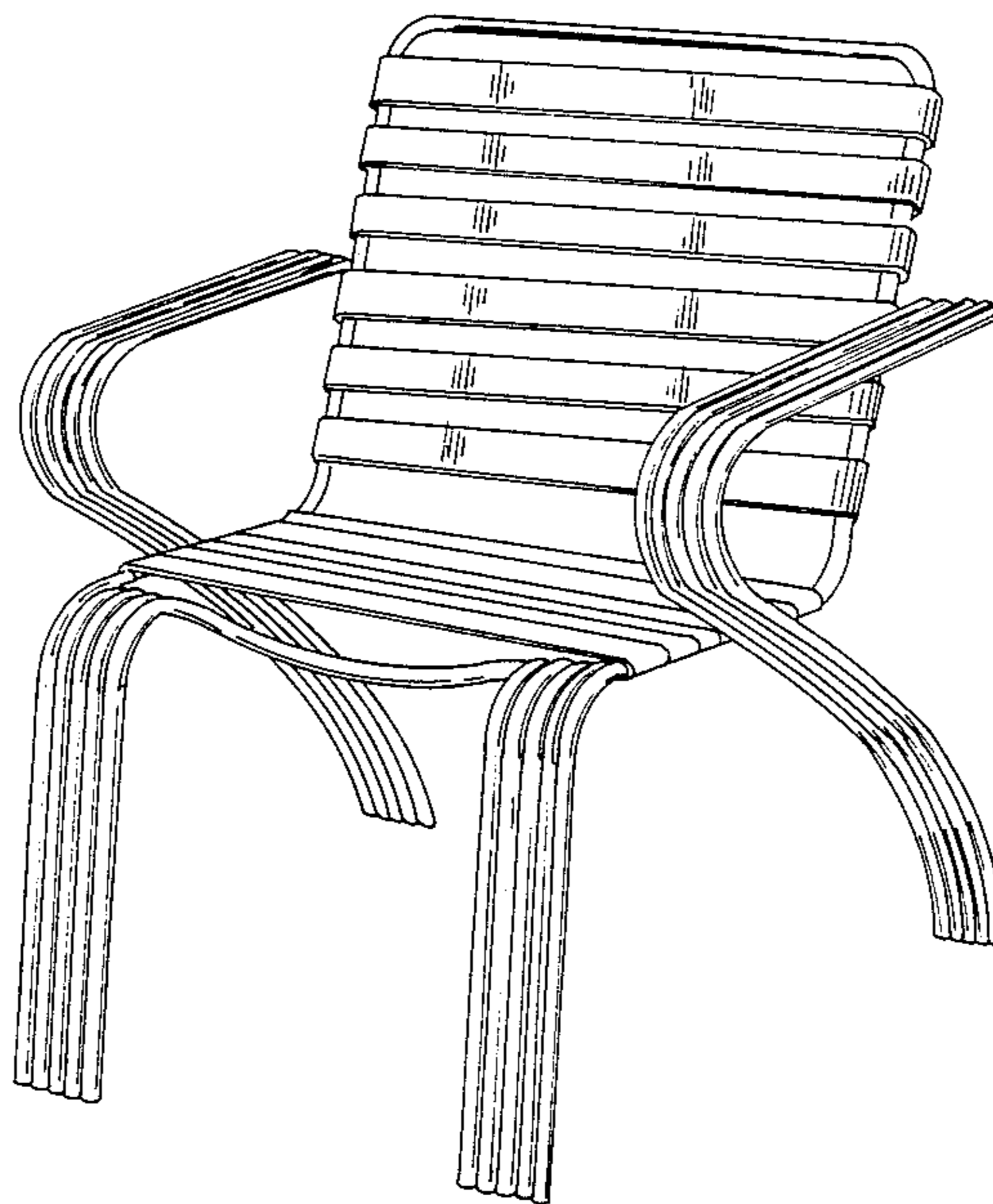

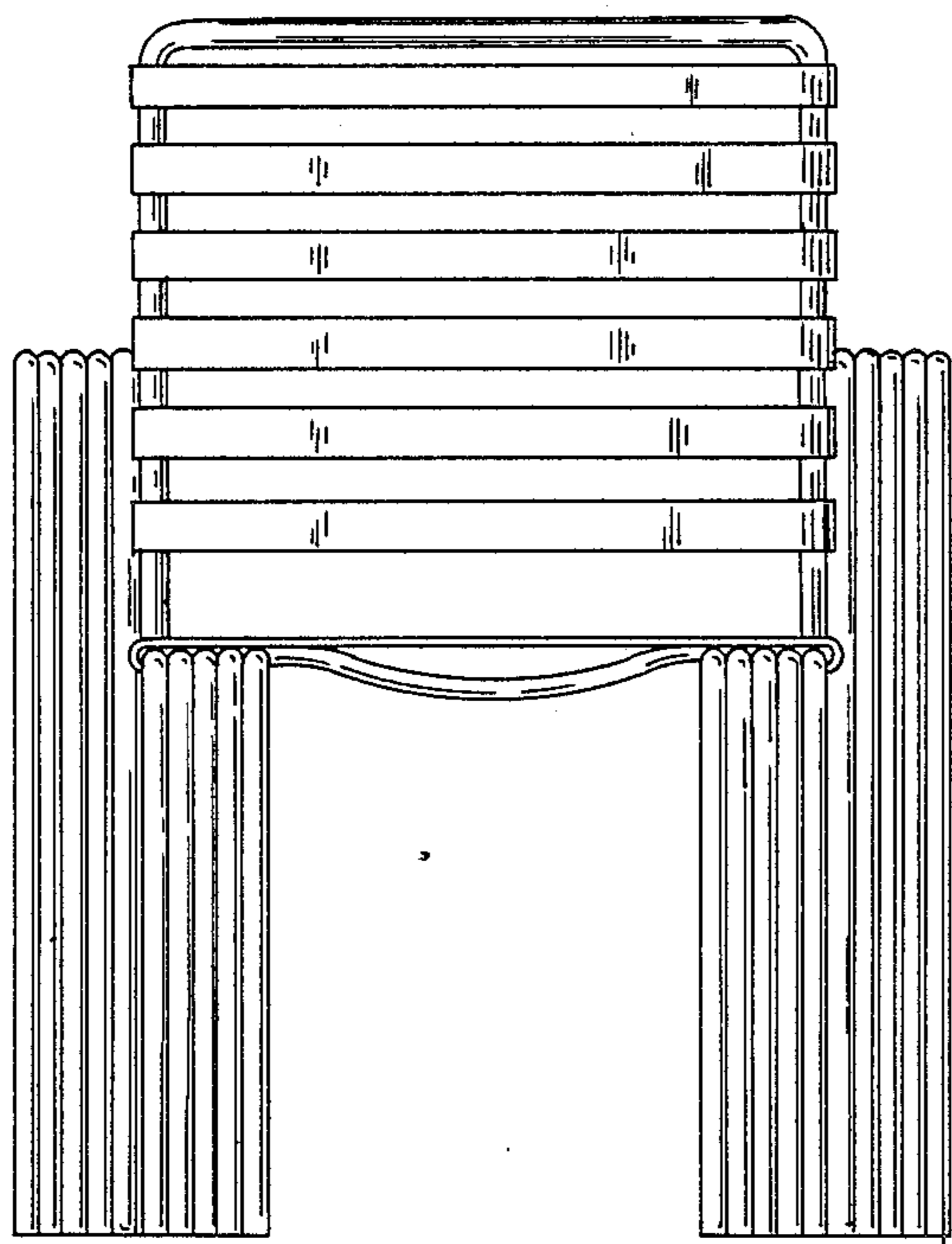
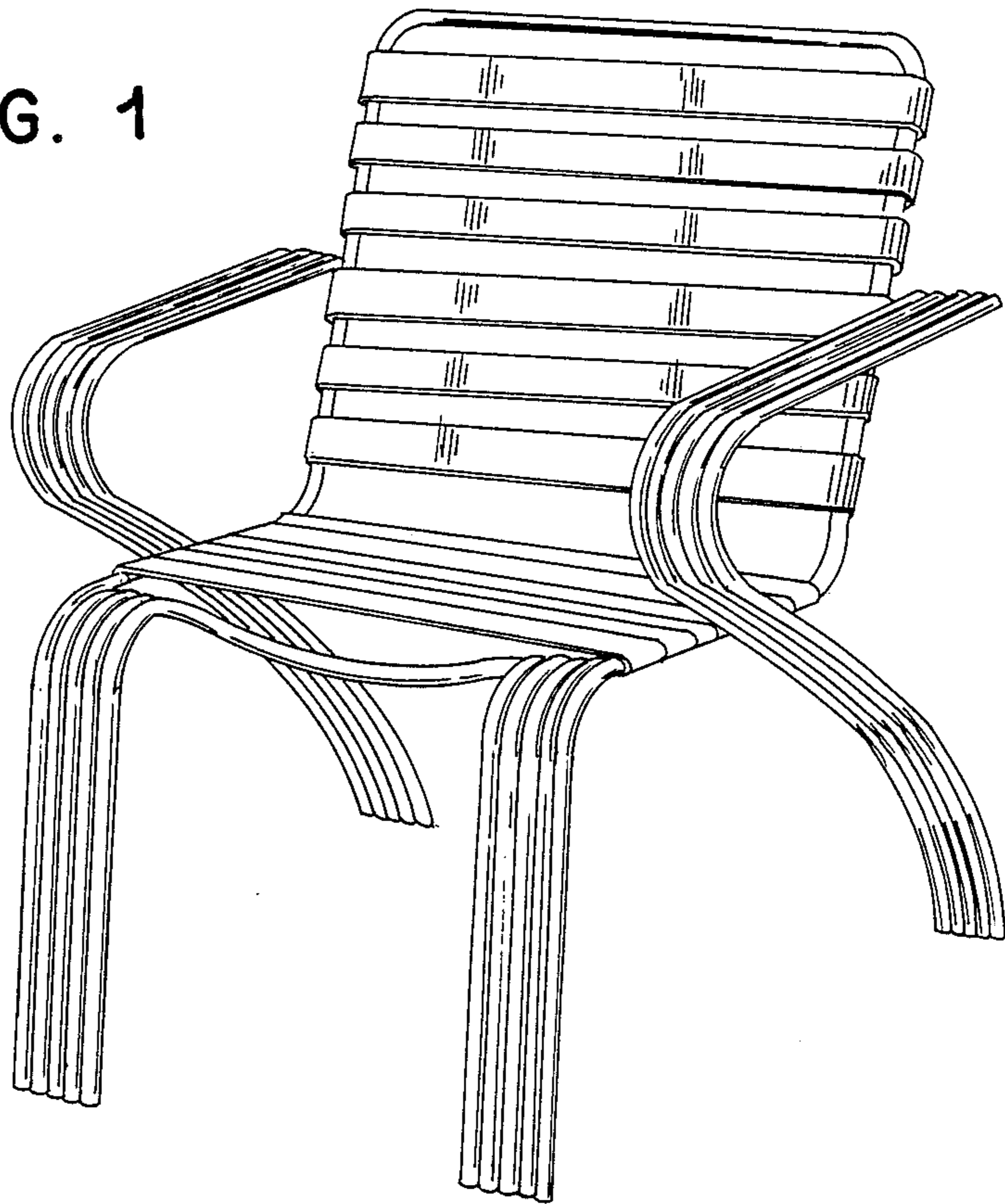

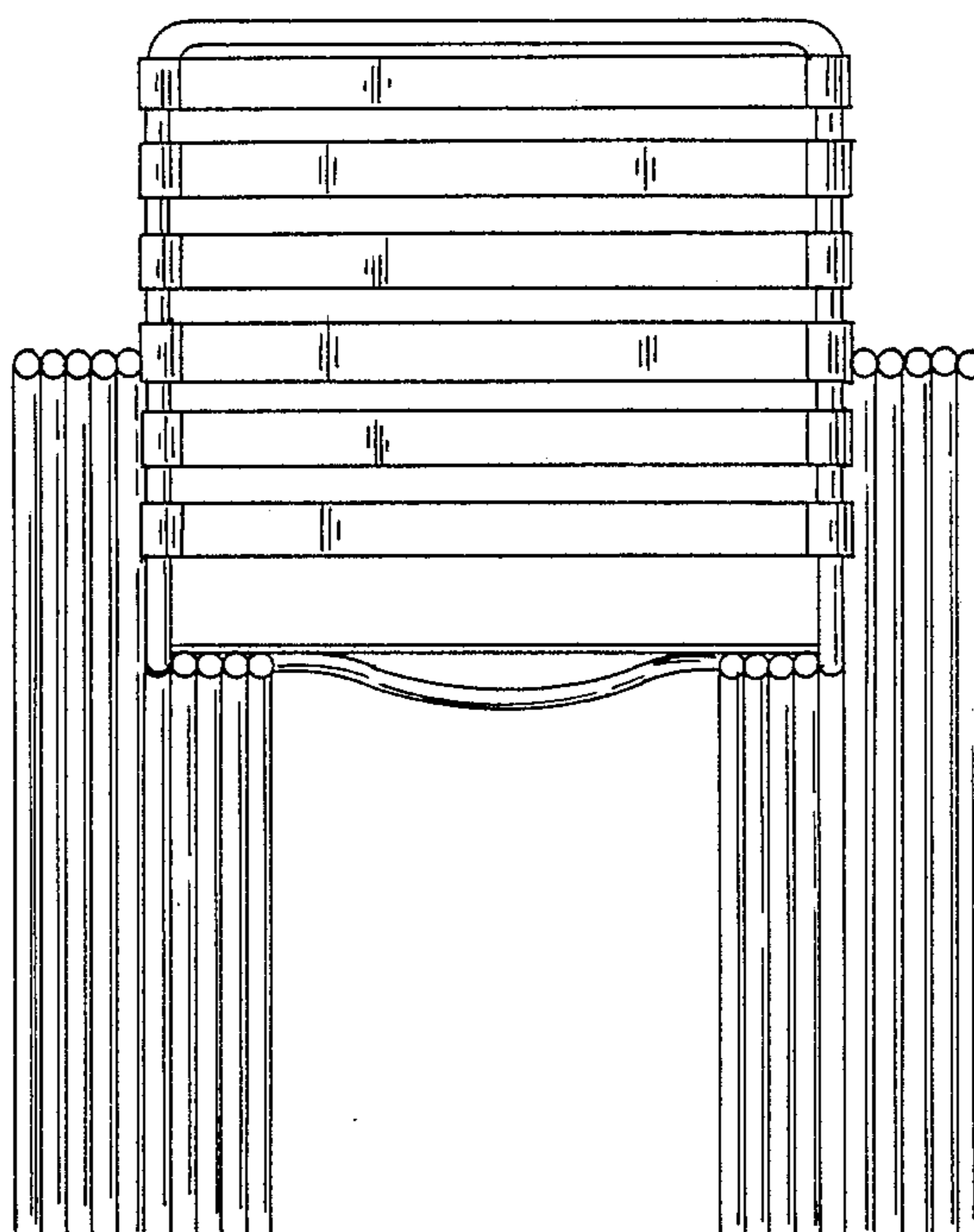

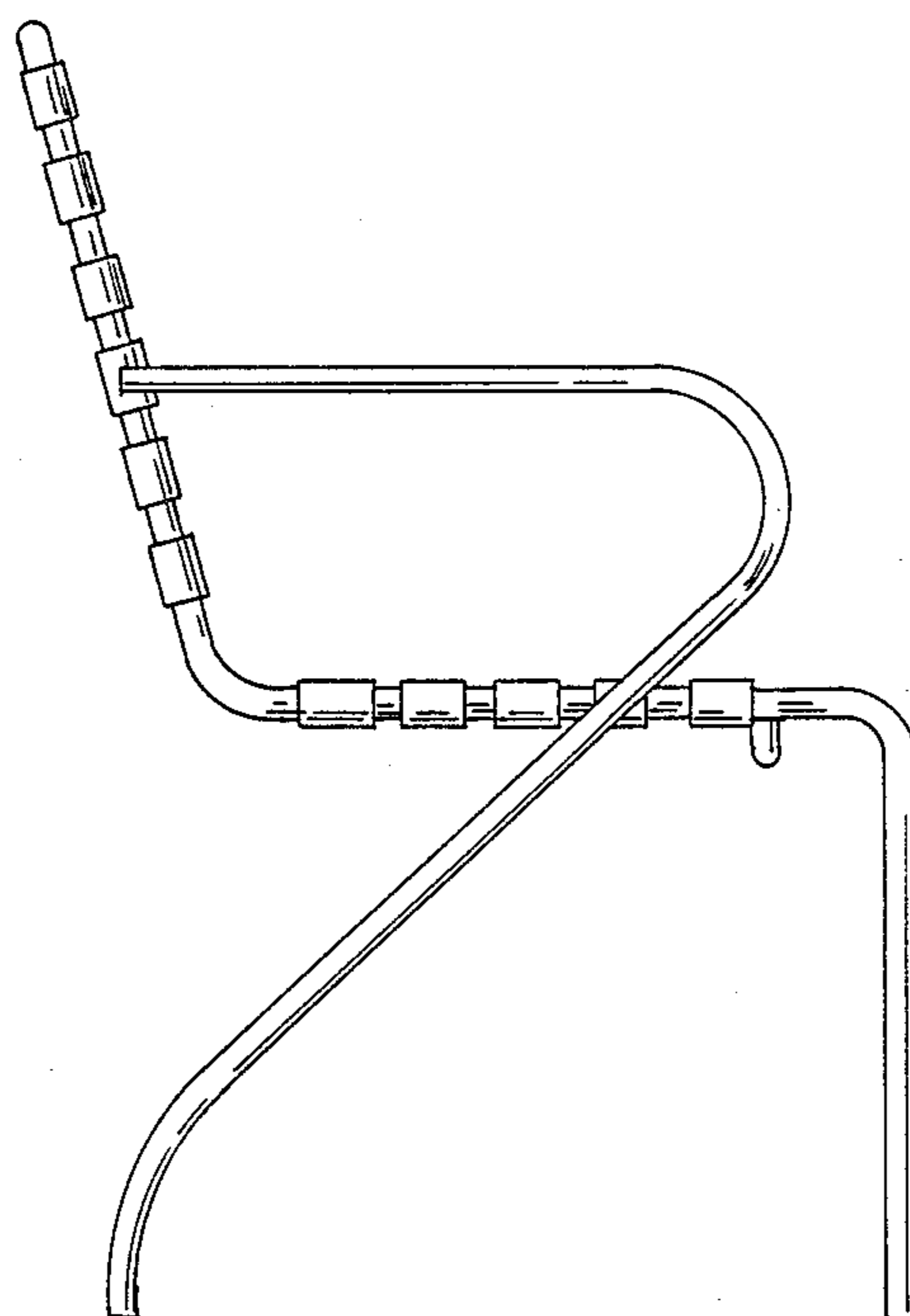

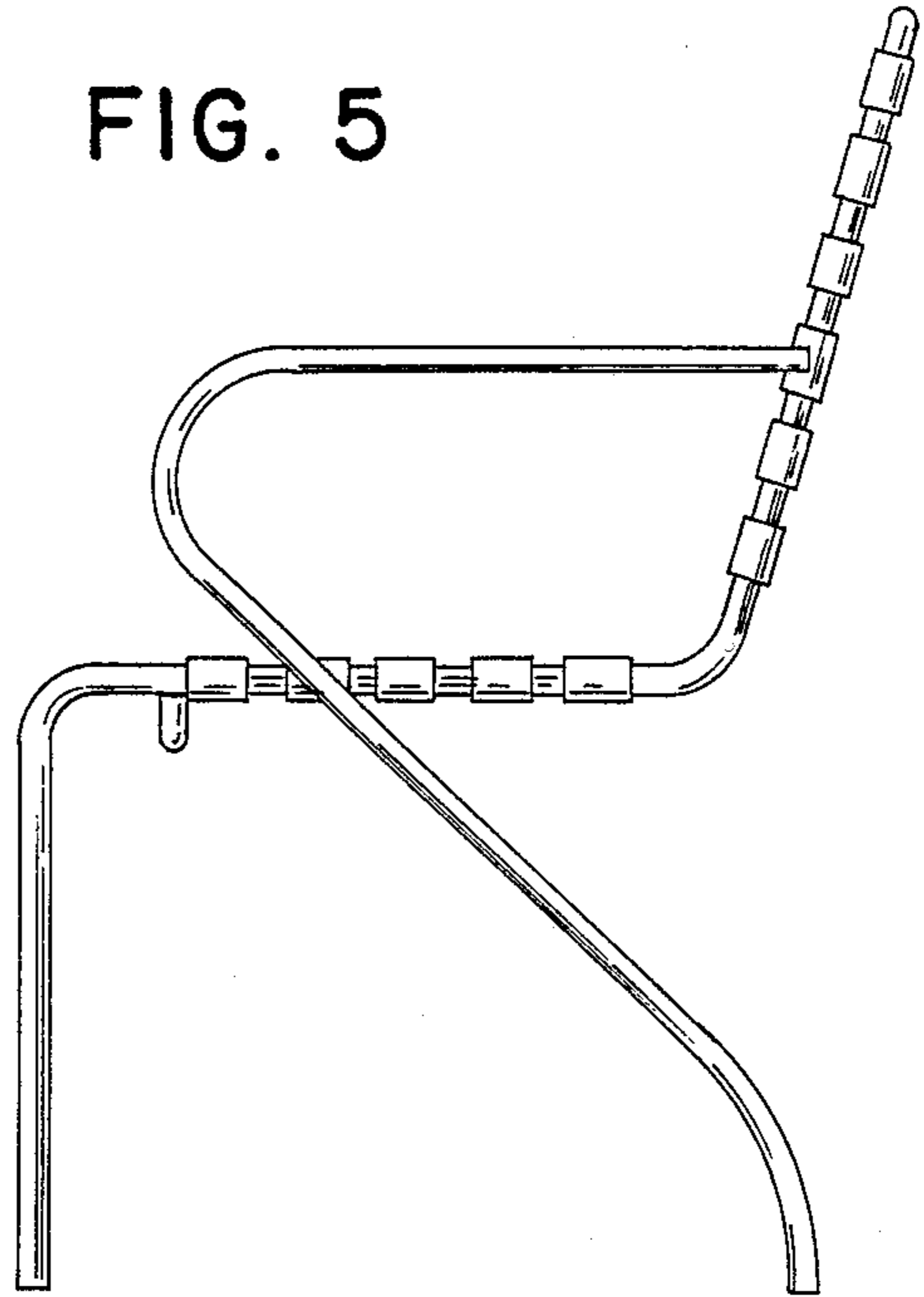

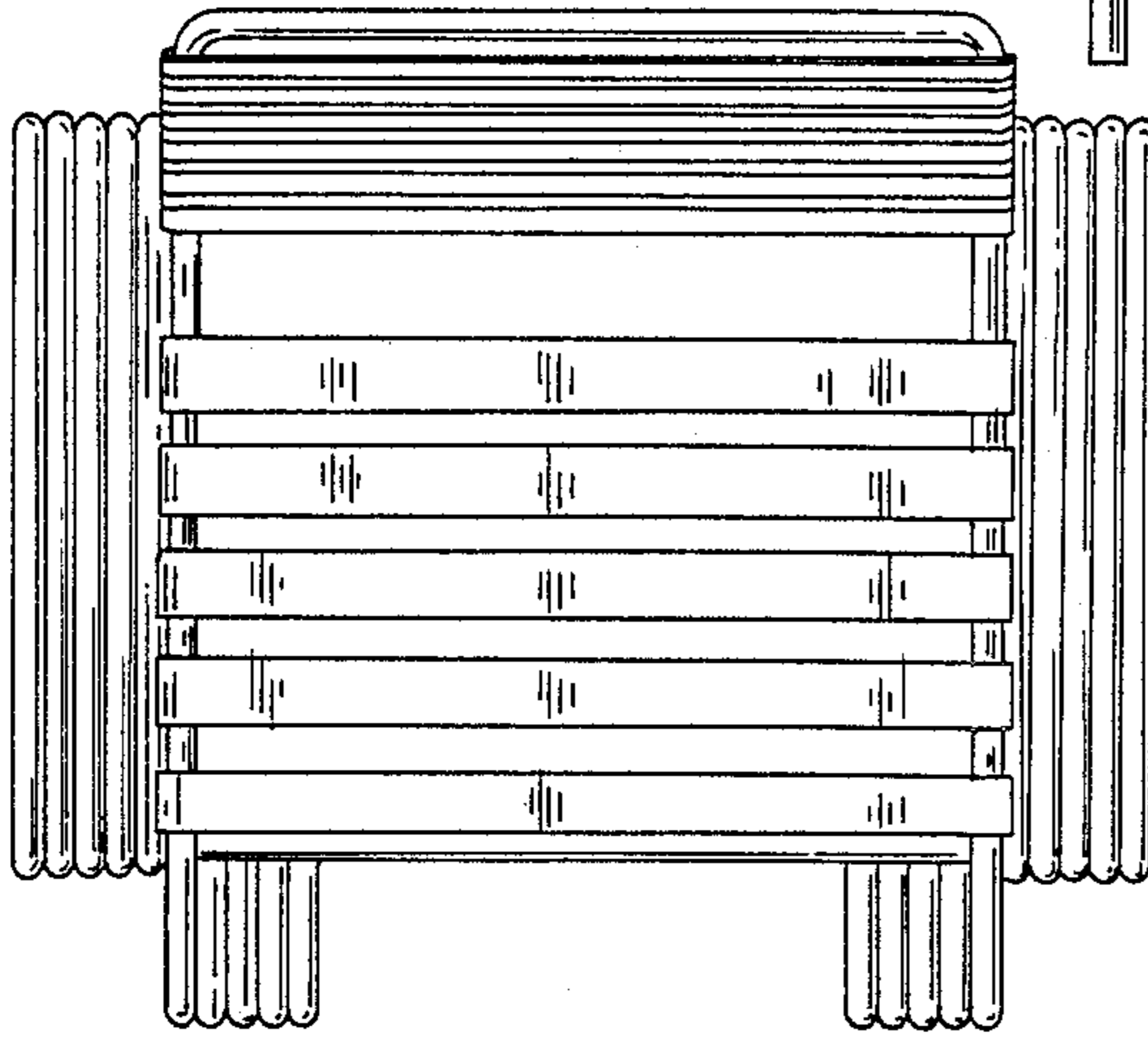

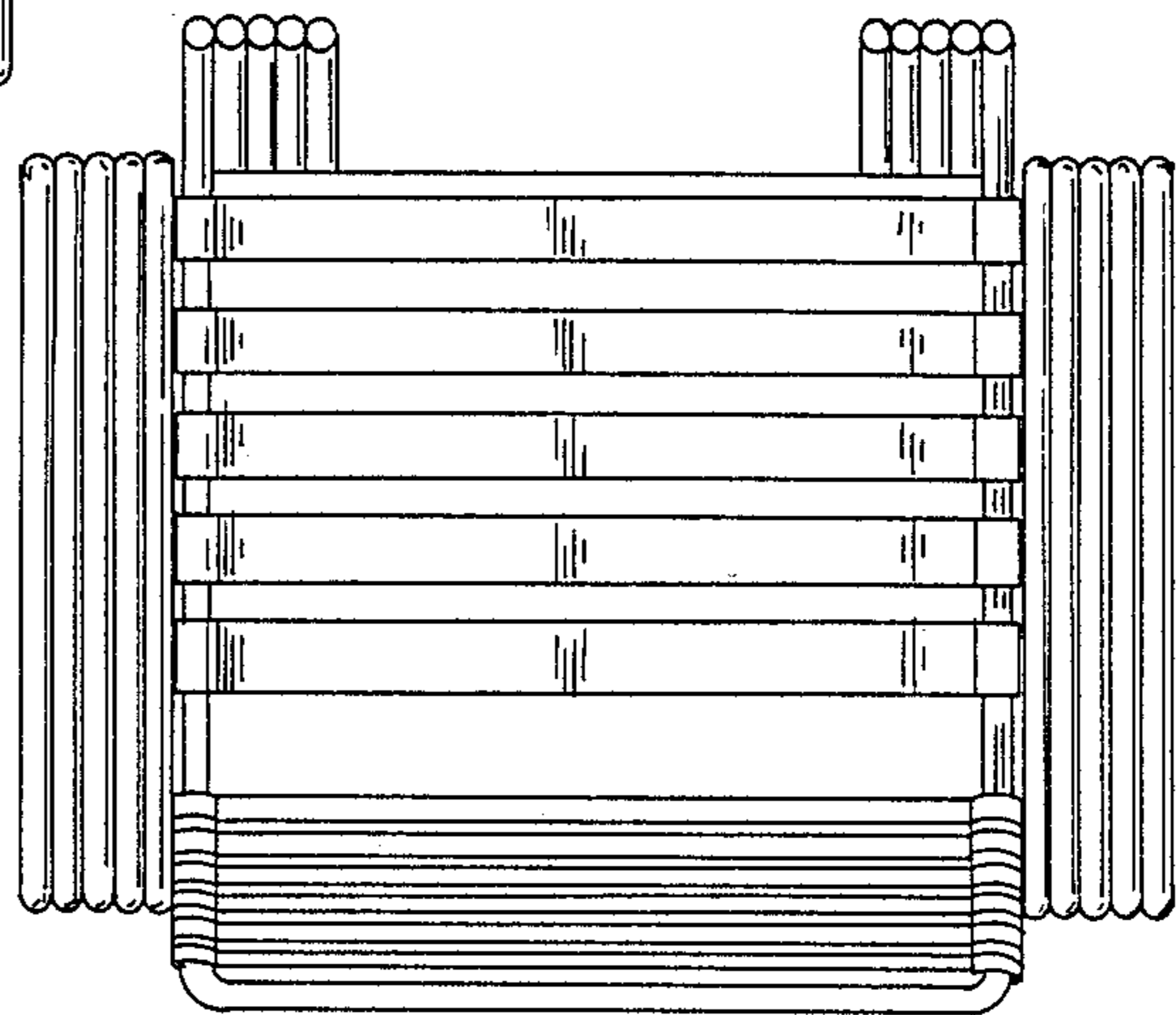

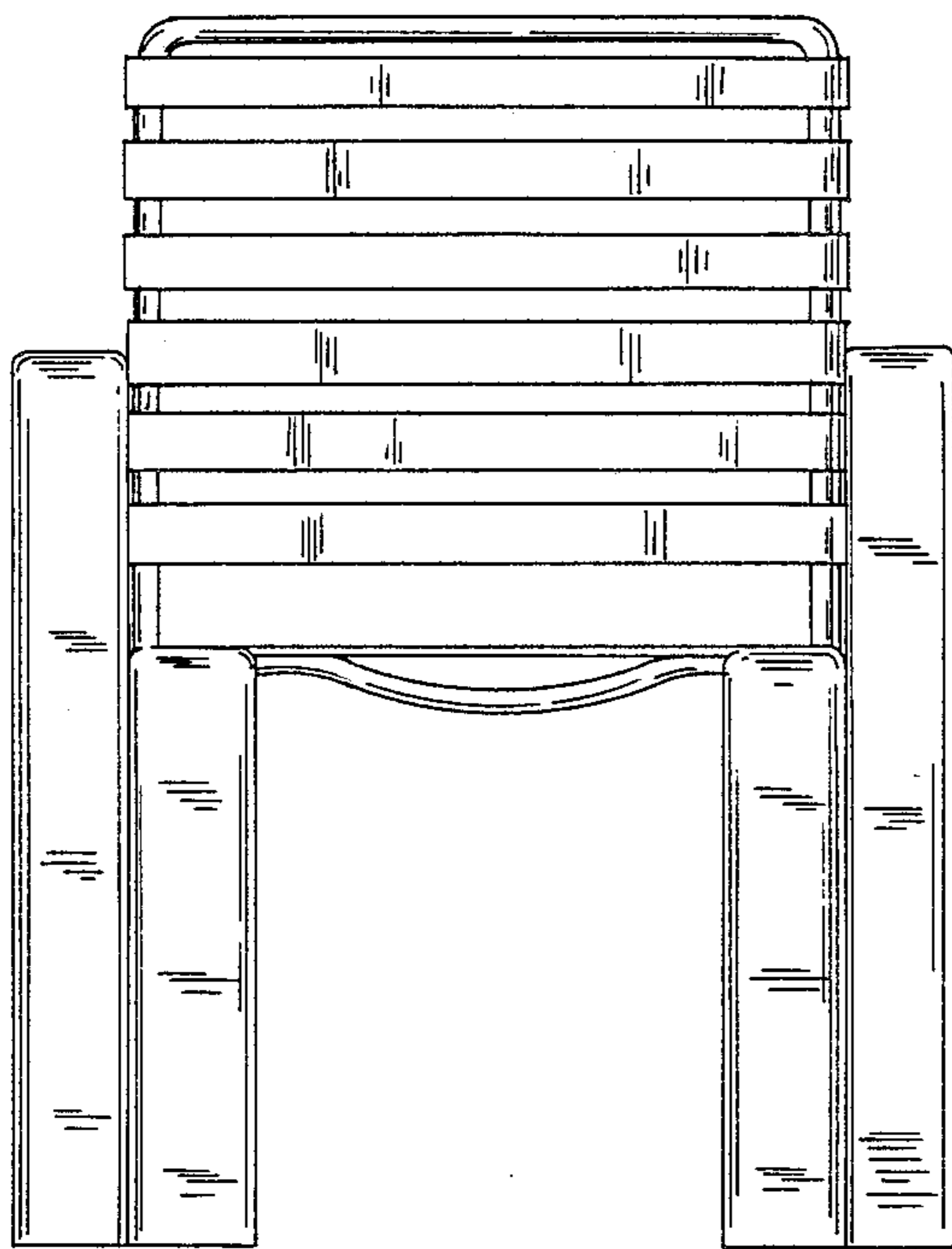
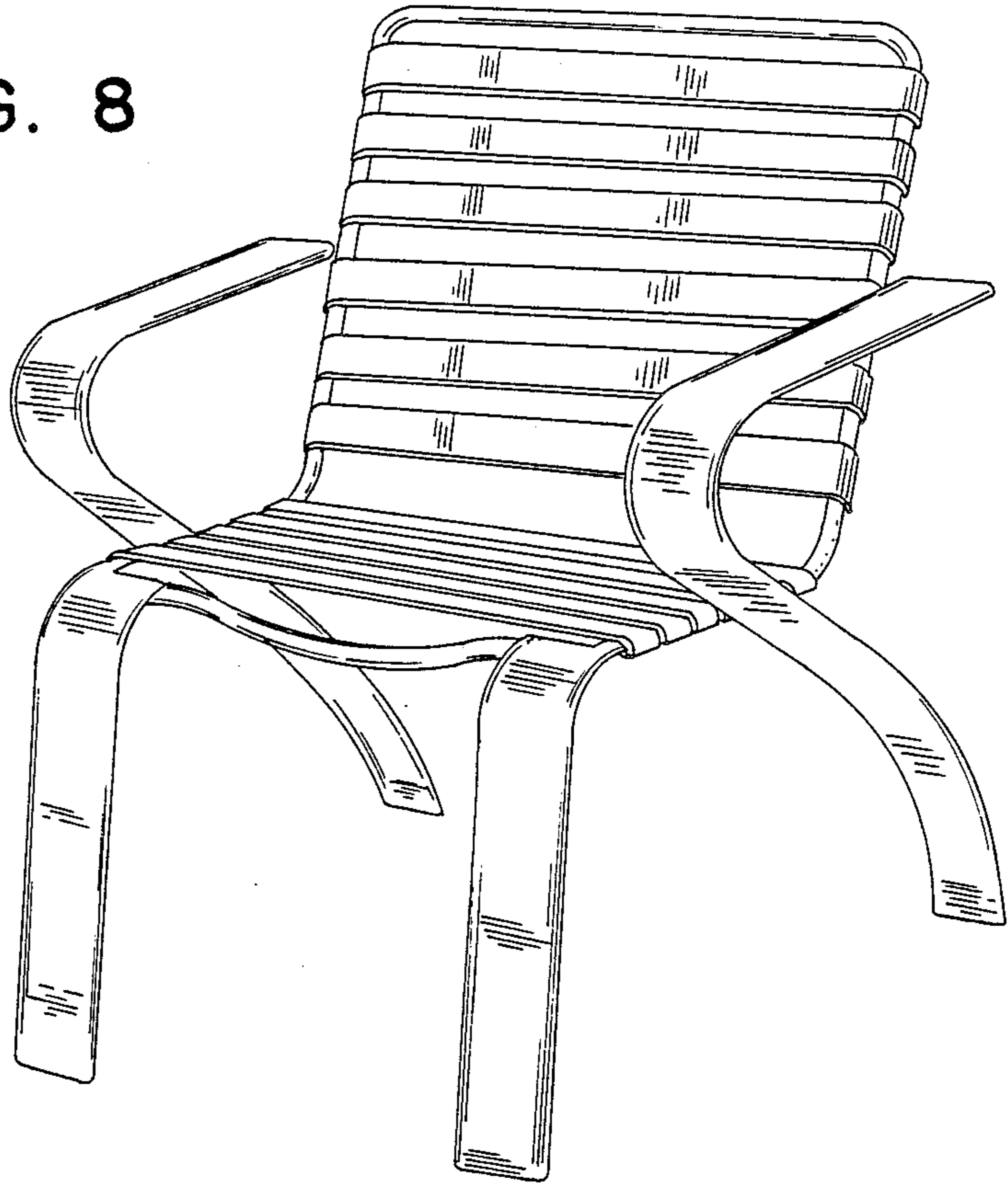

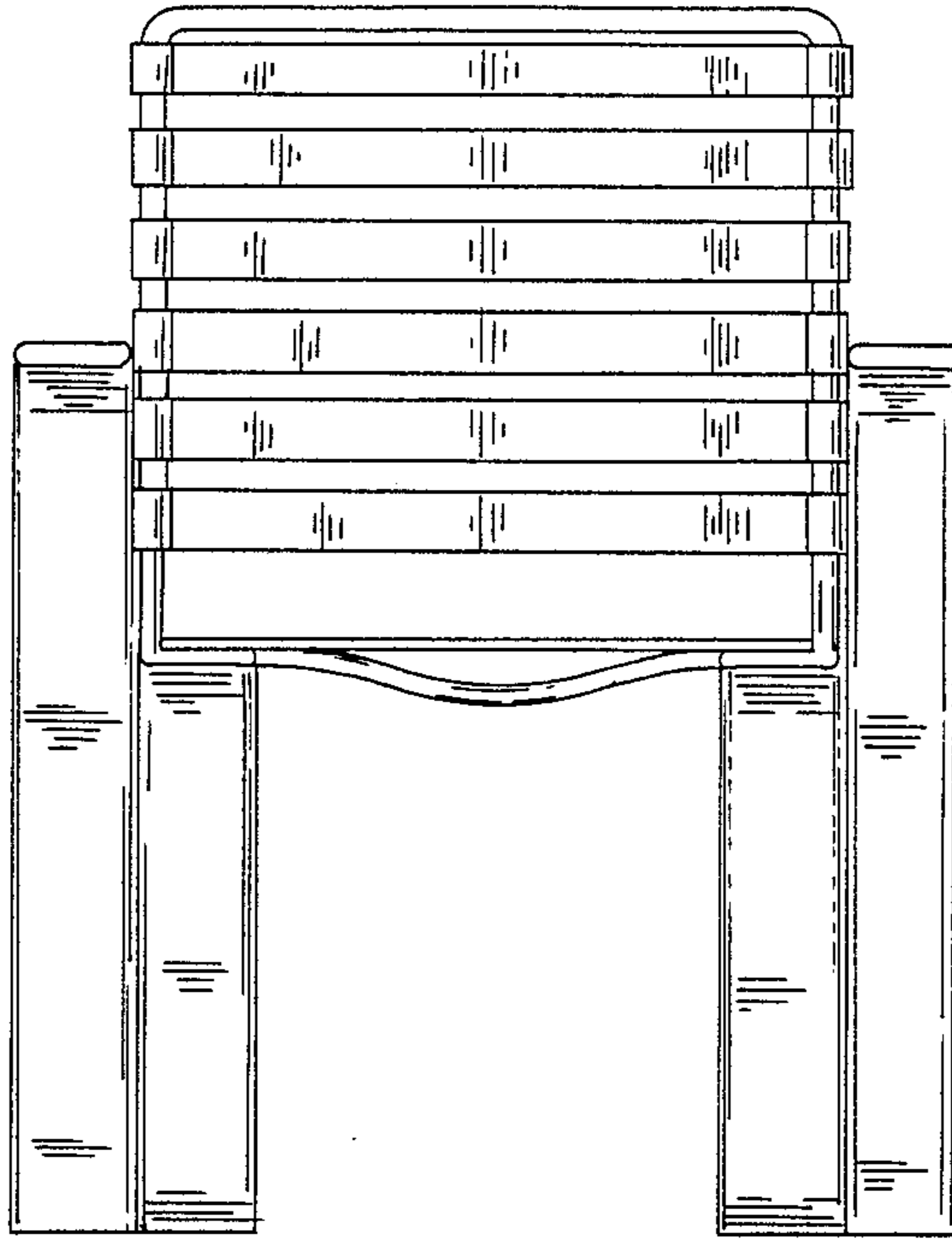

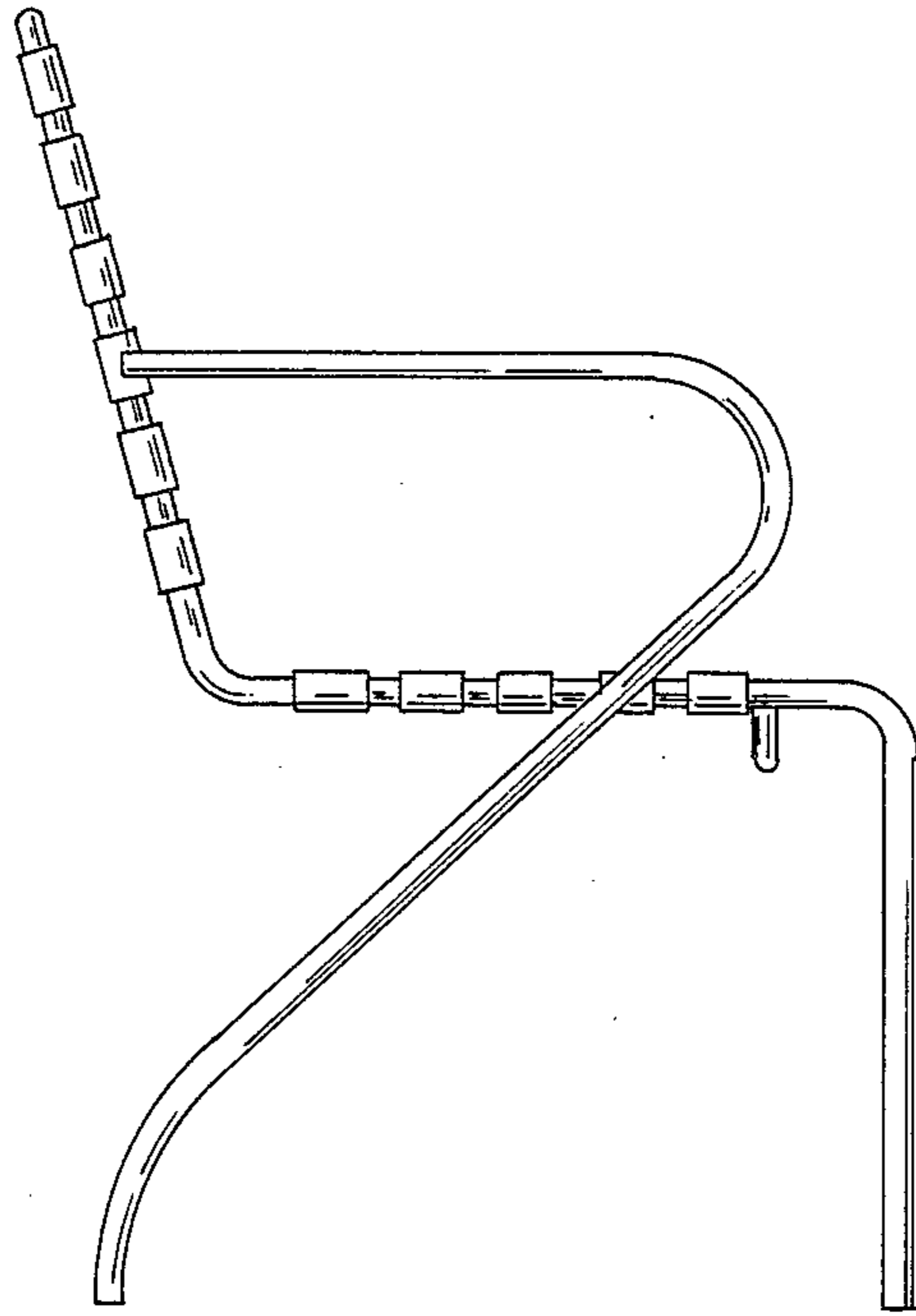

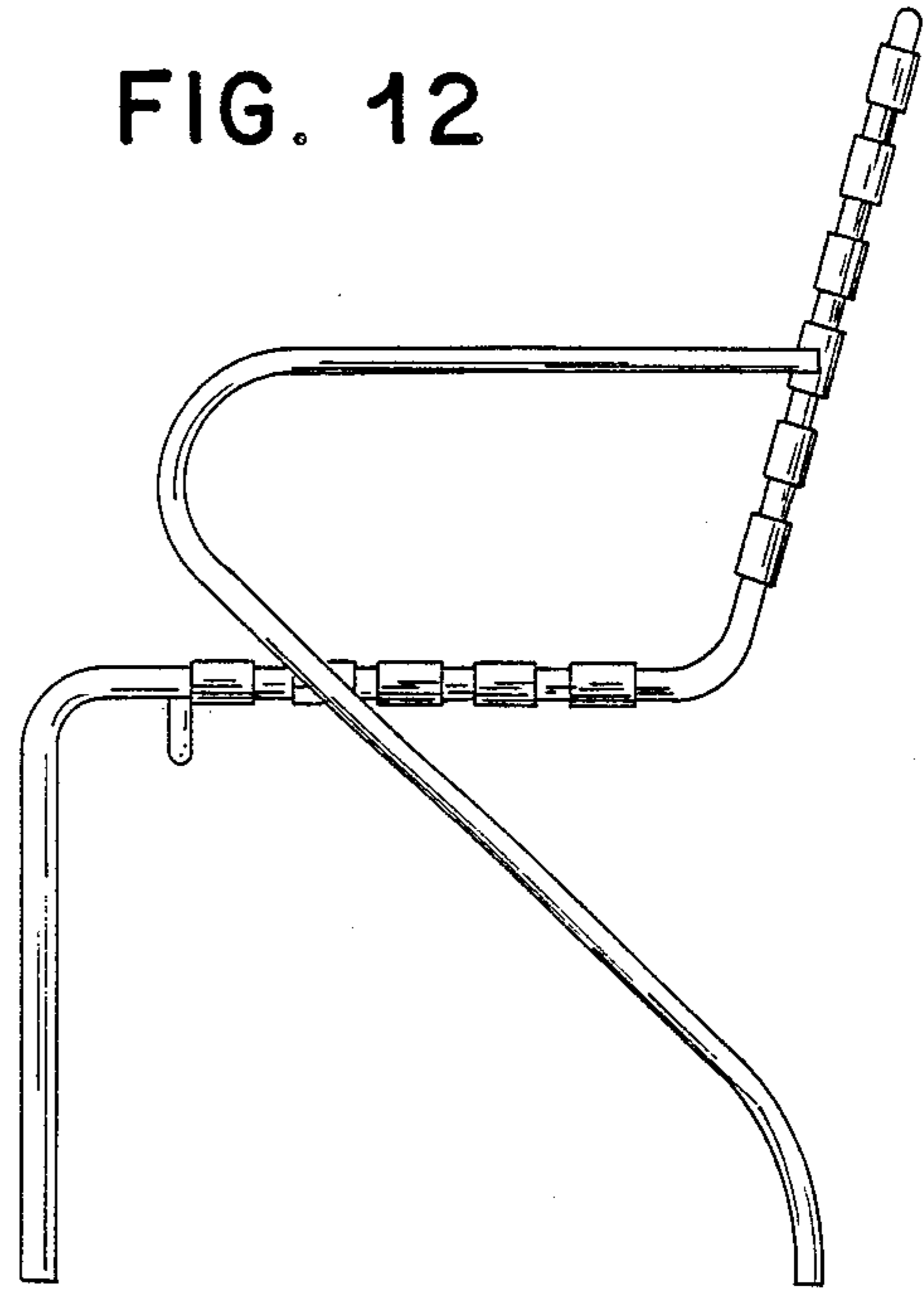

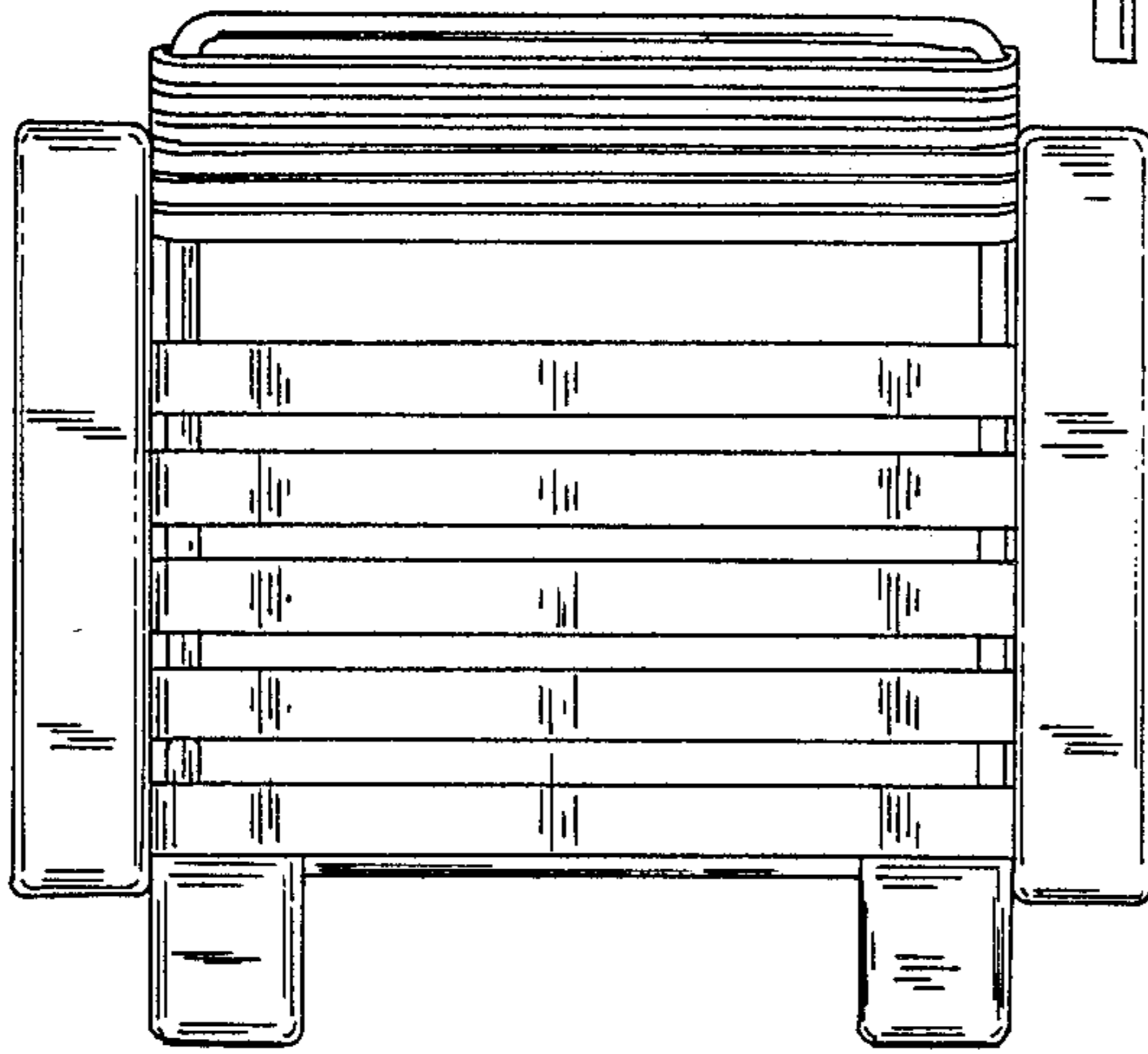

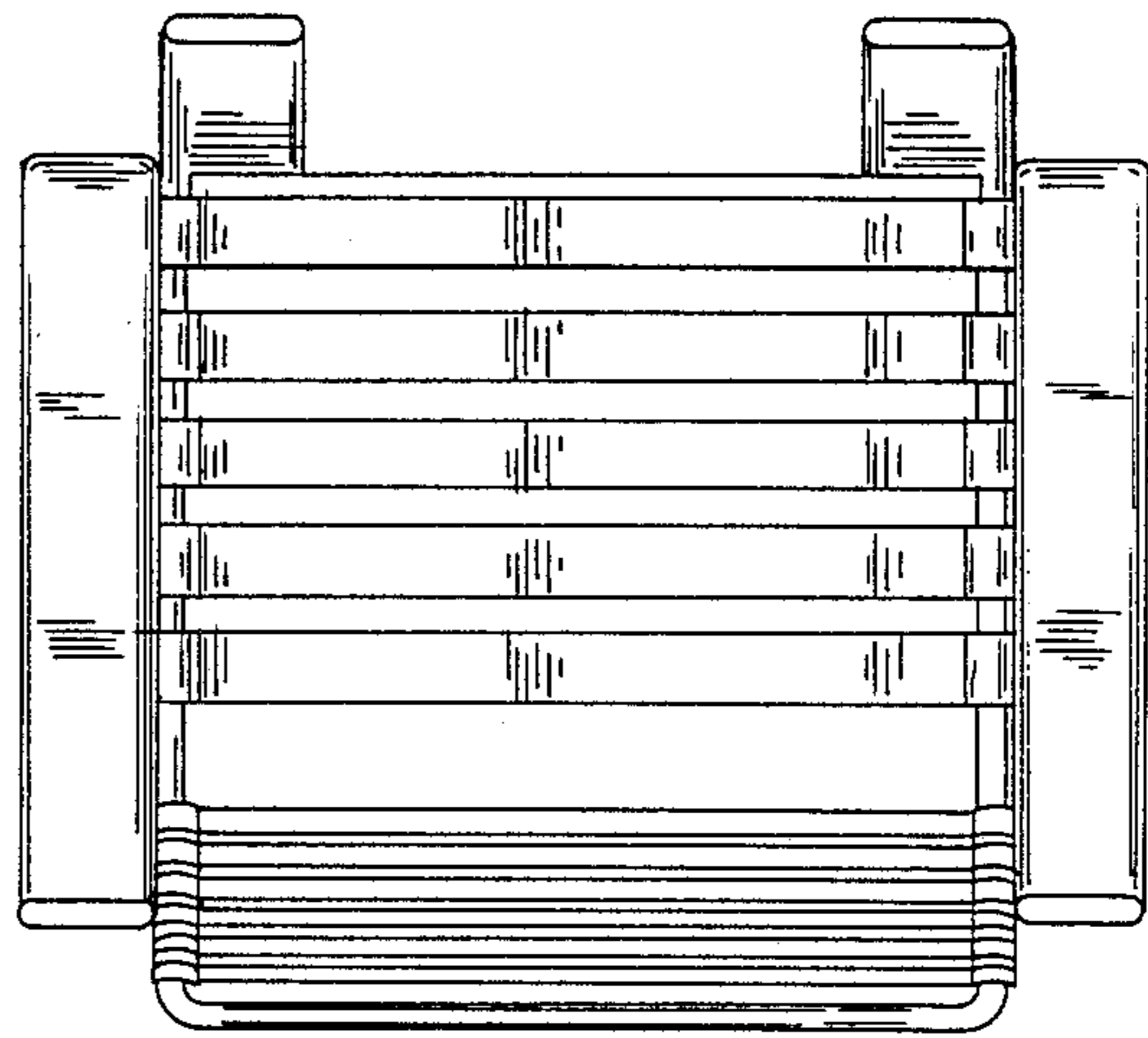

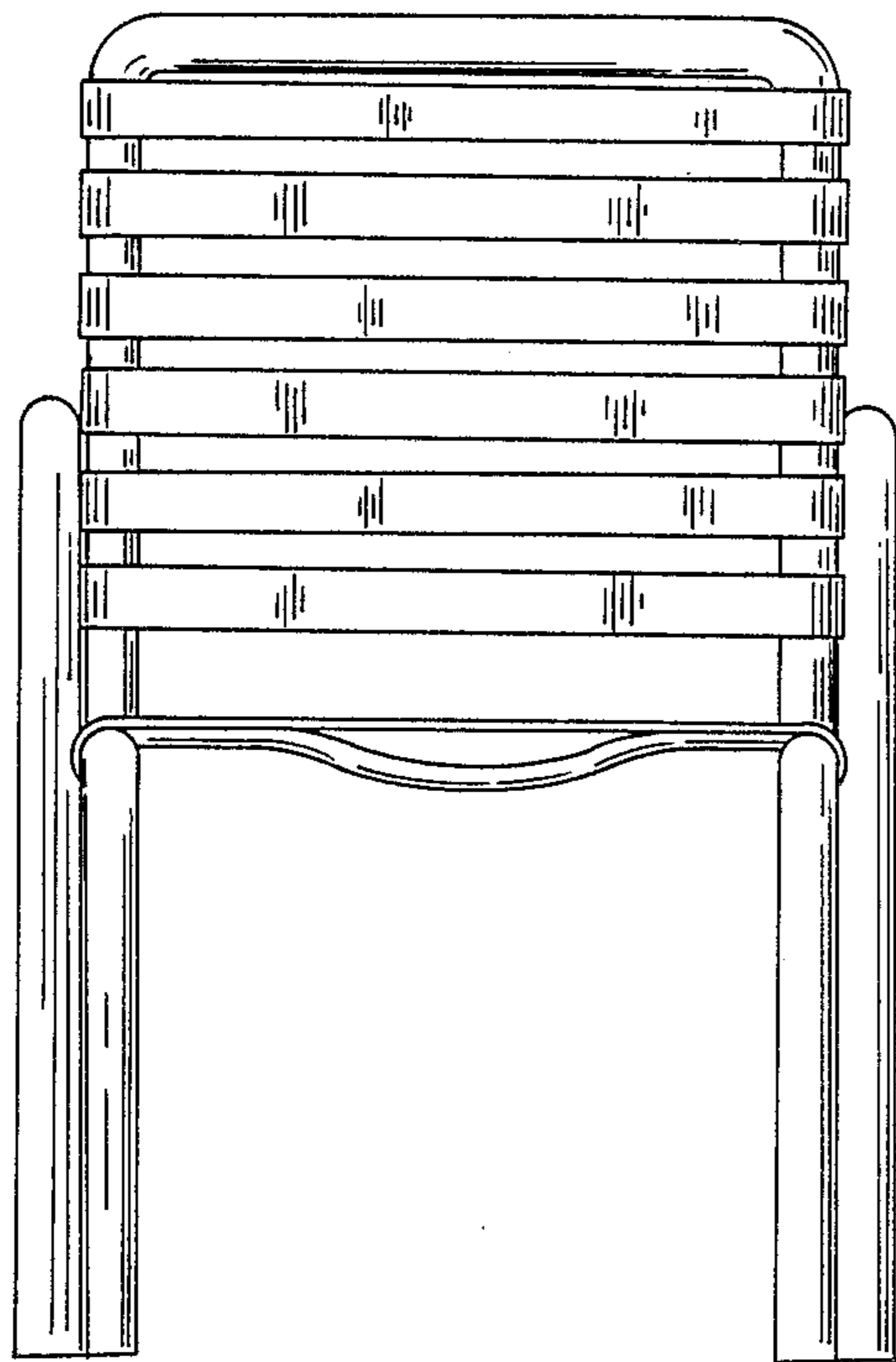
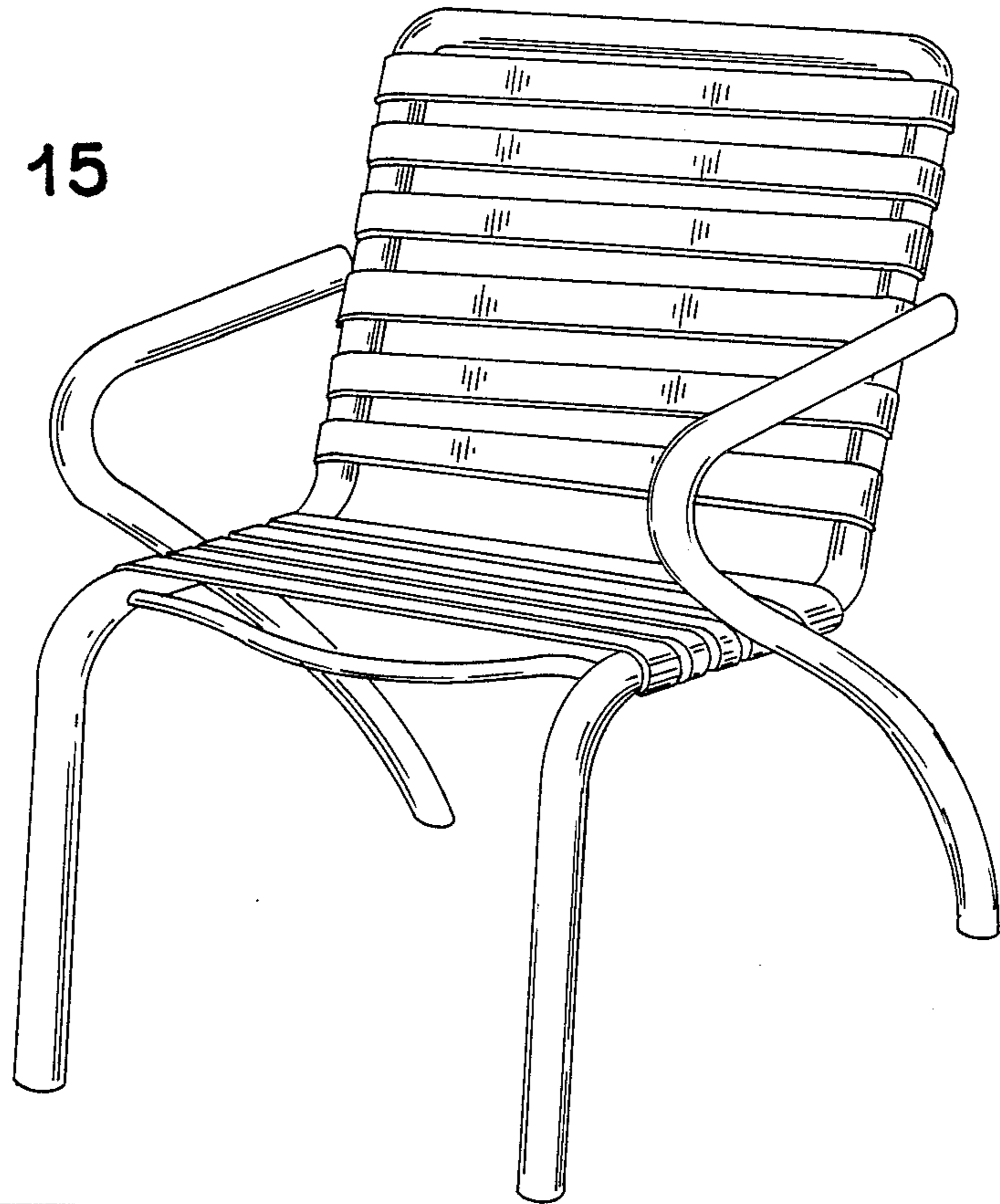

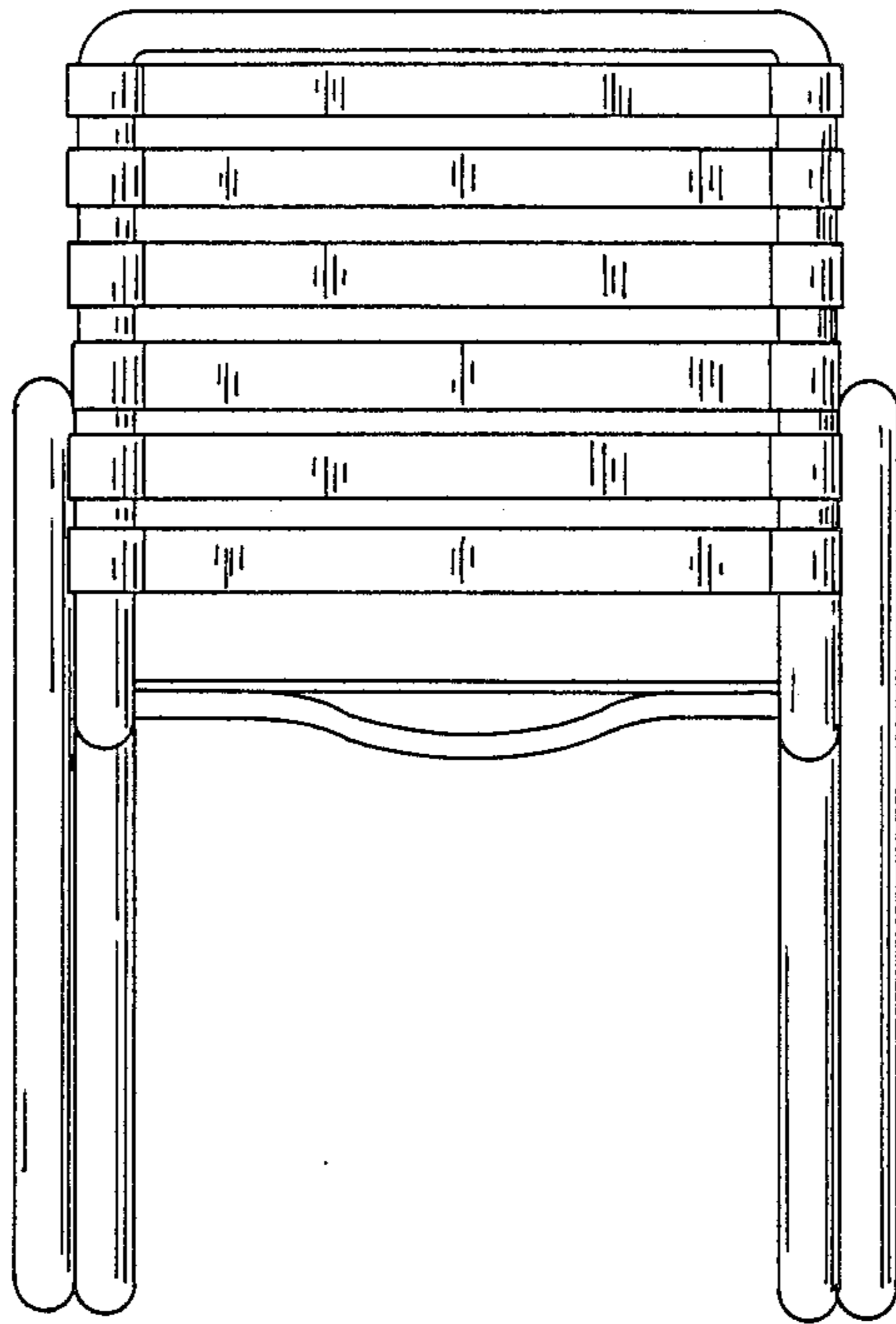

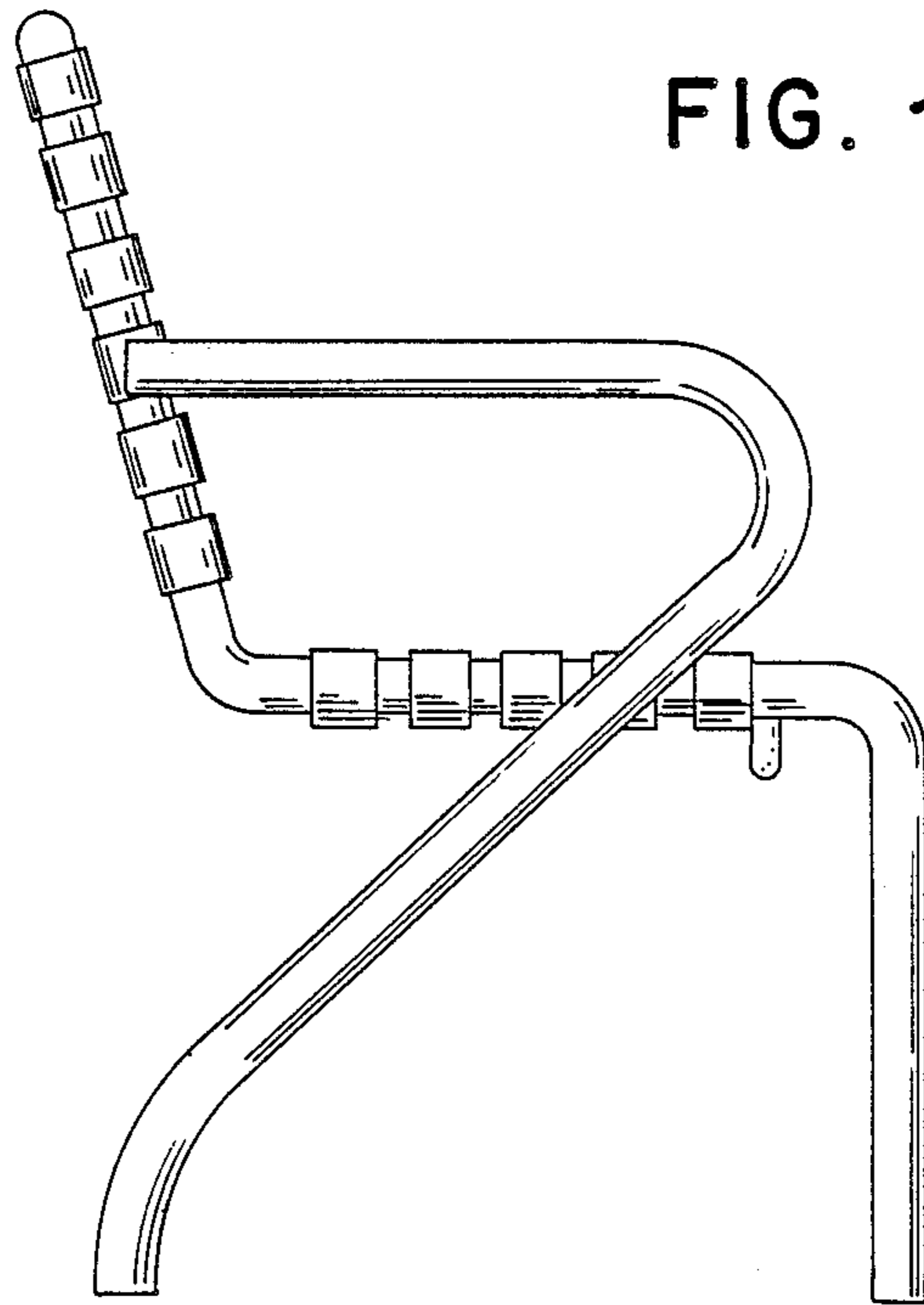

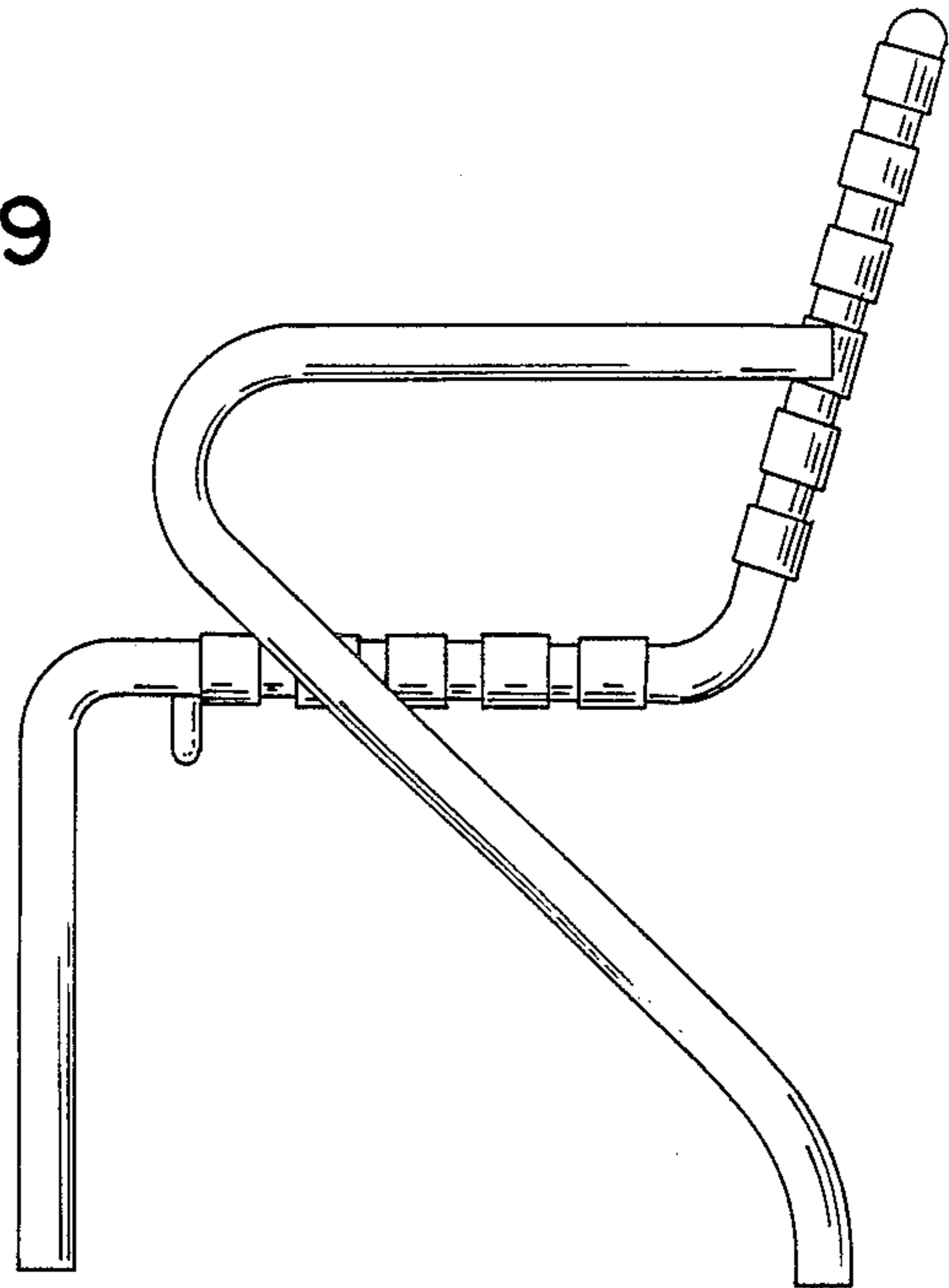

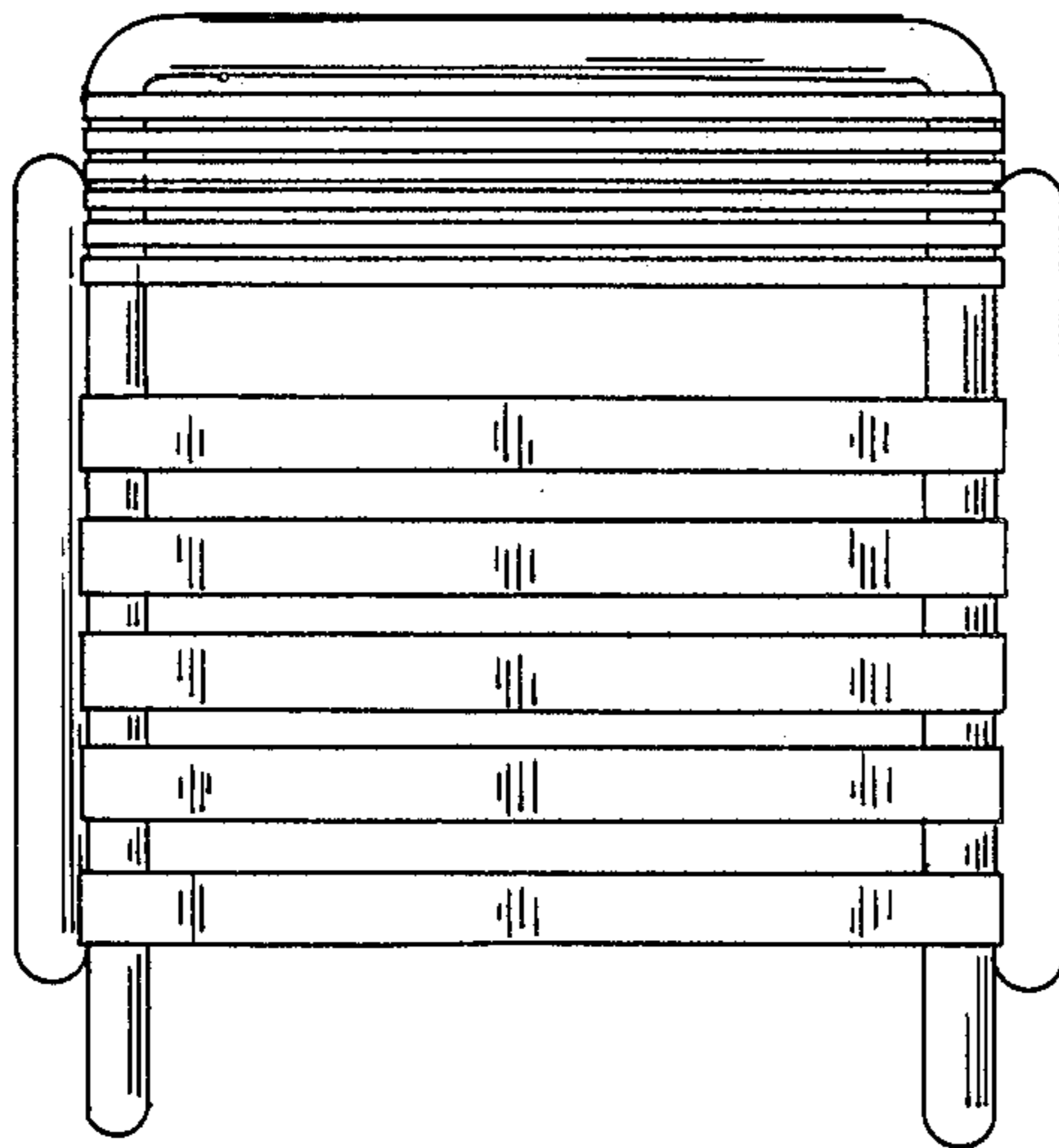
