The ornamental design for a cosmetic and perfume bottle, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of a cosmetic and perfume bottle showing my new design;

 FIG. 3 is a rear elevational view thereof;

 FIG. 6 is a perspective view thereof.

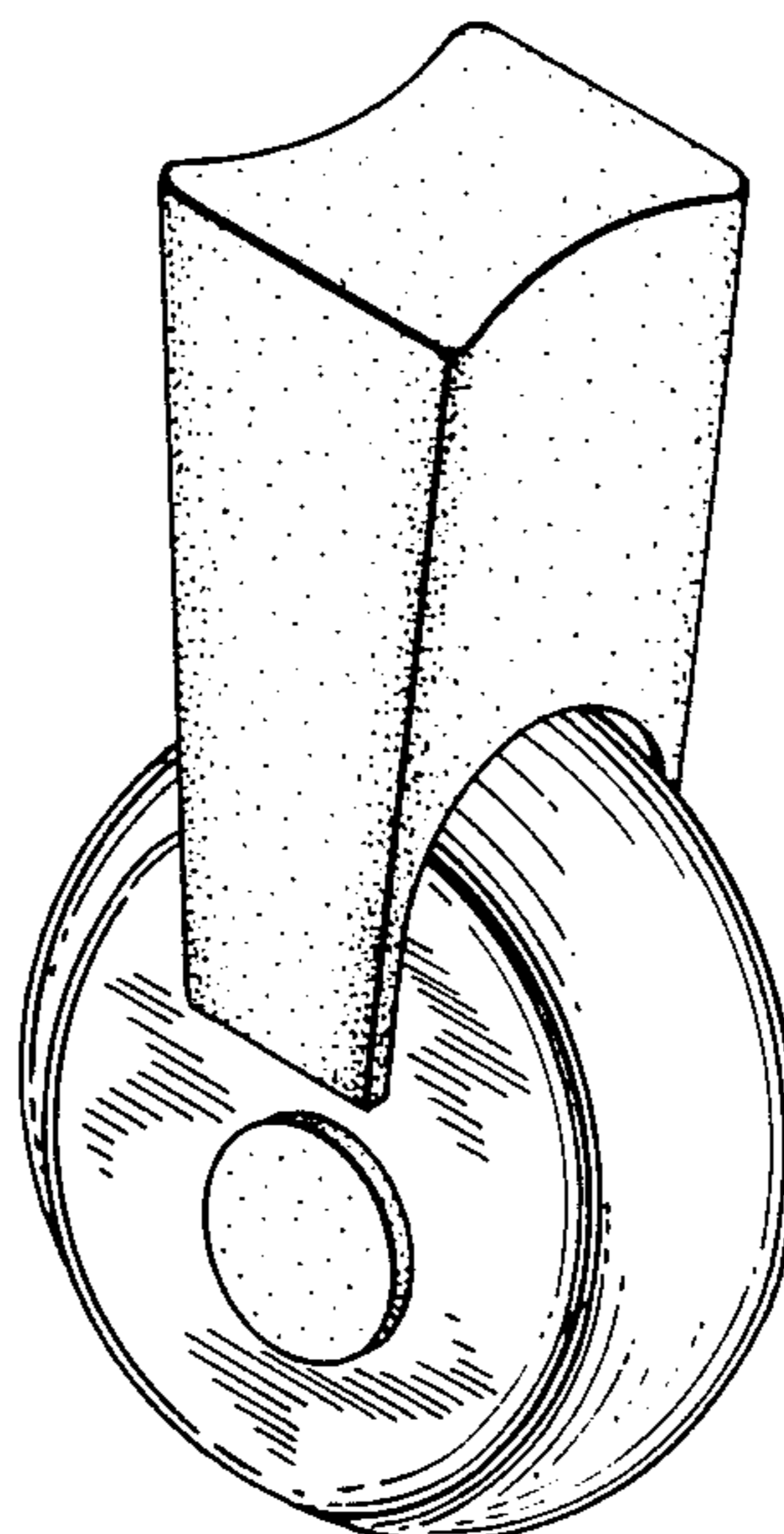

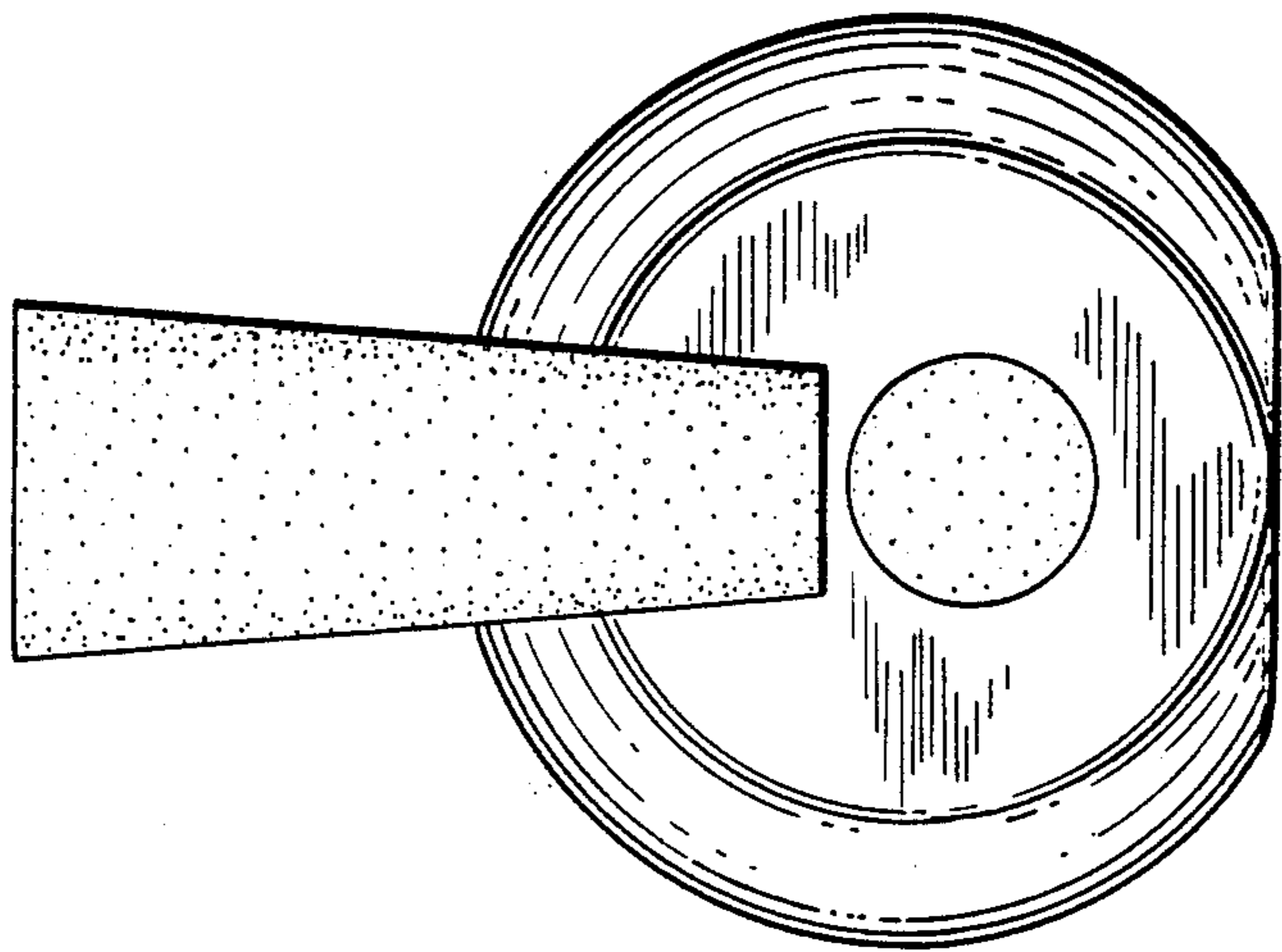

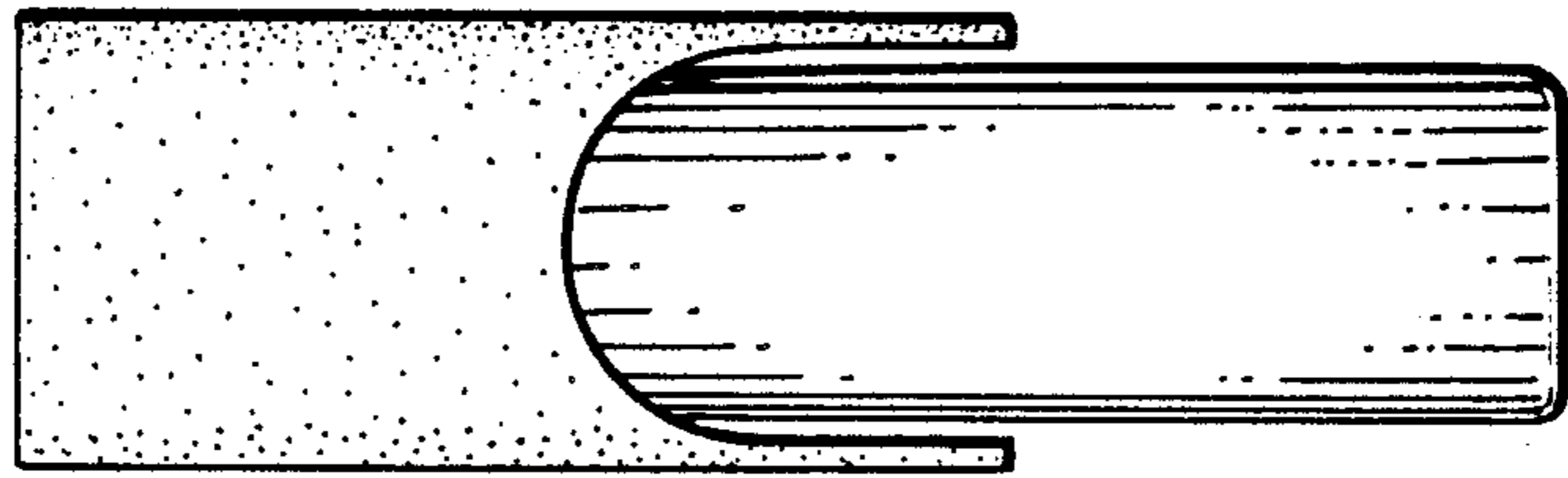
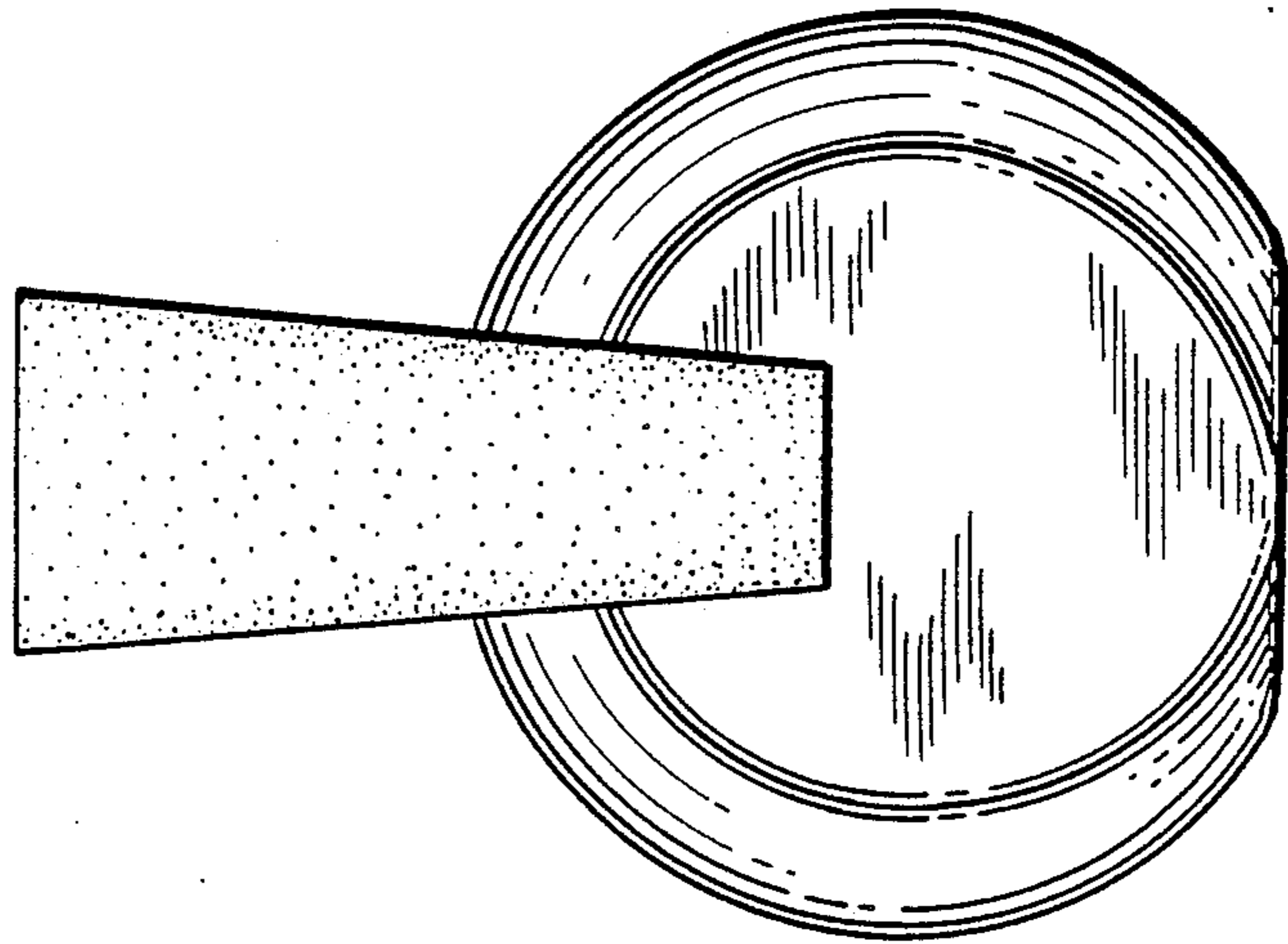

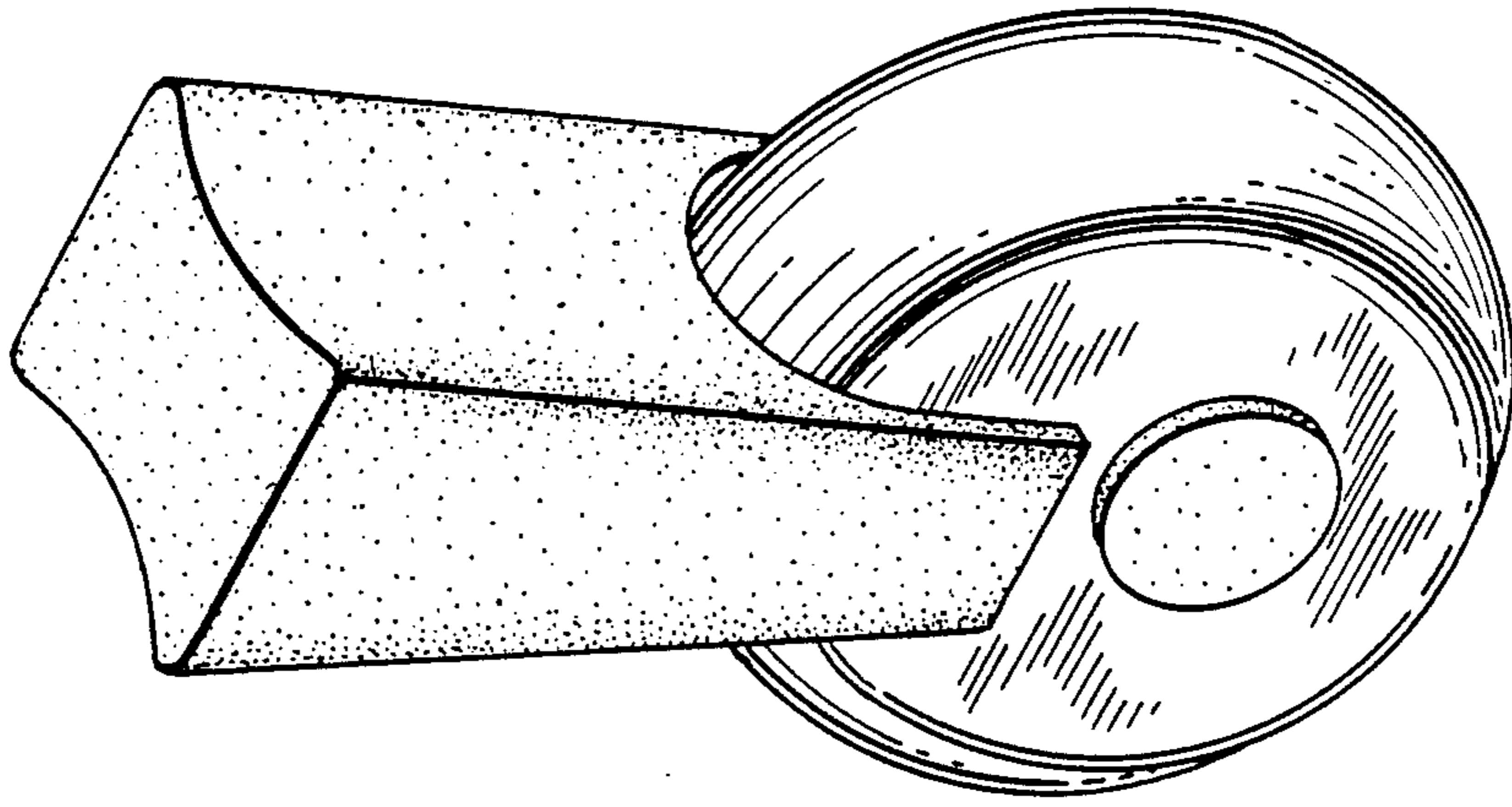

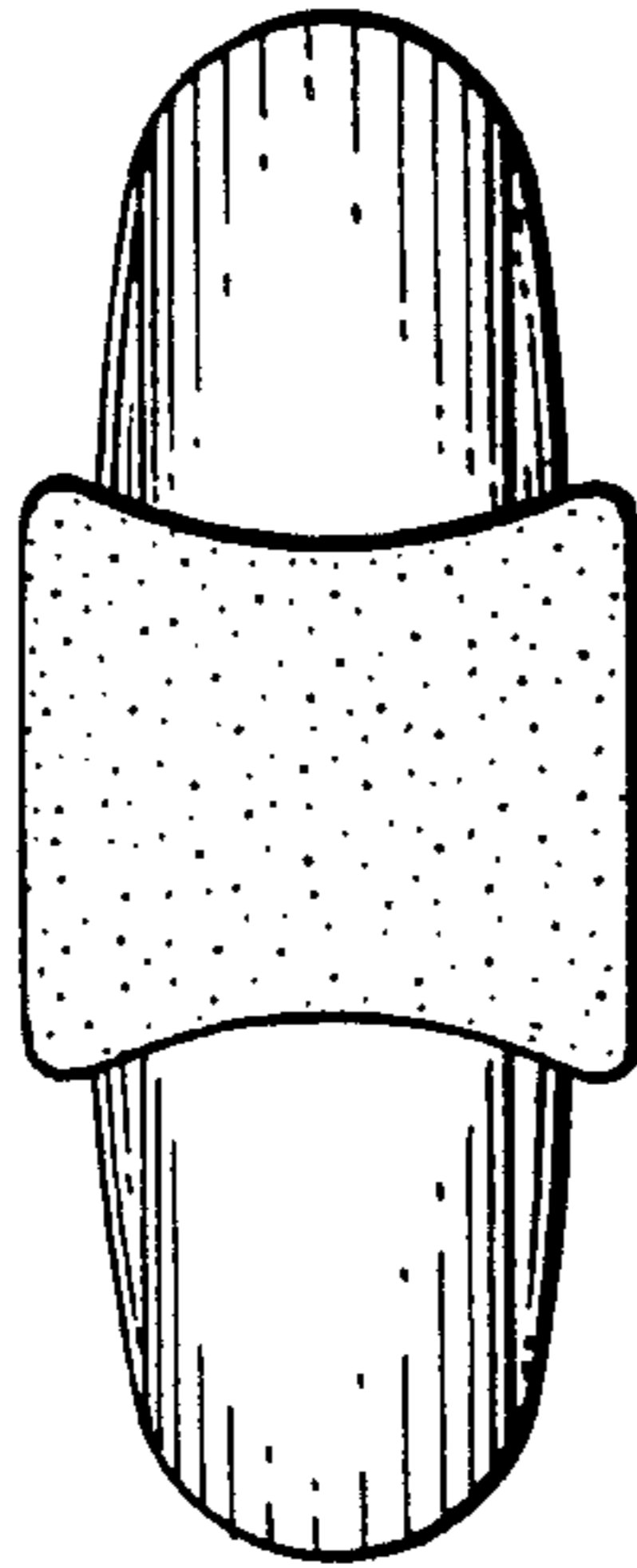

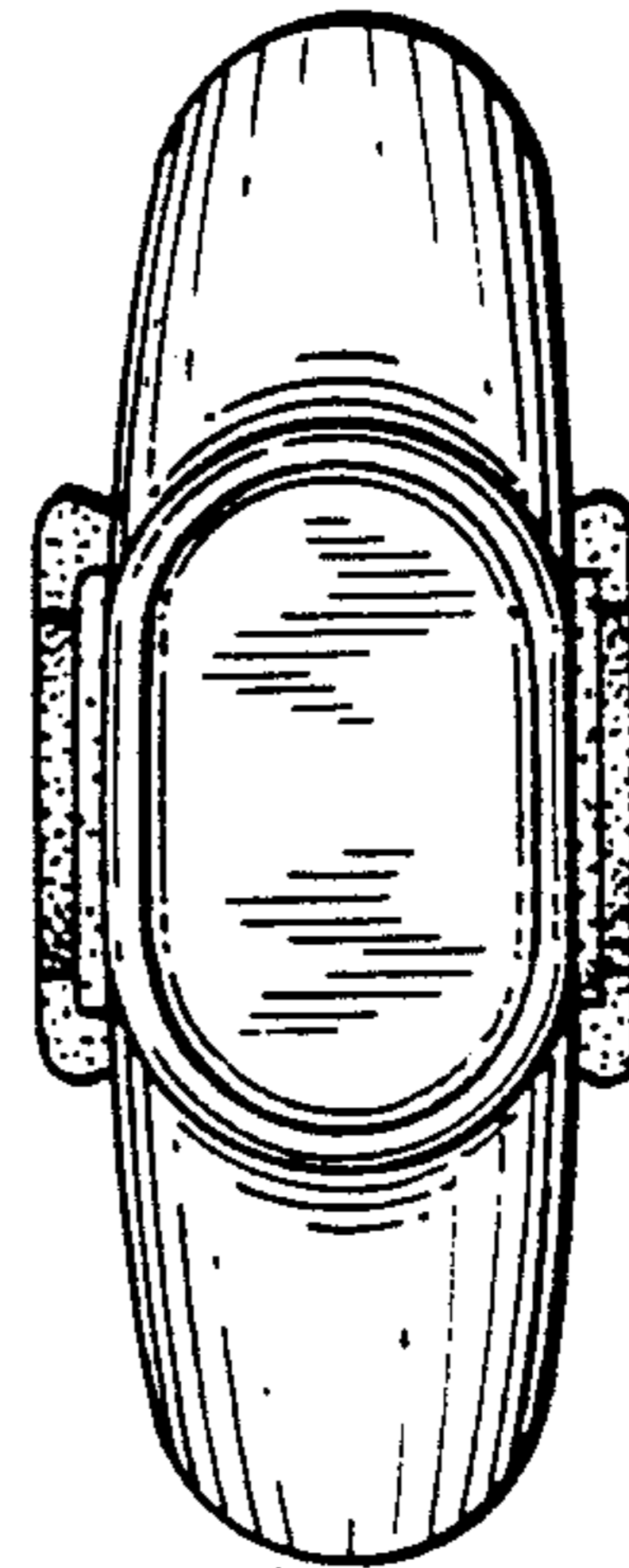
