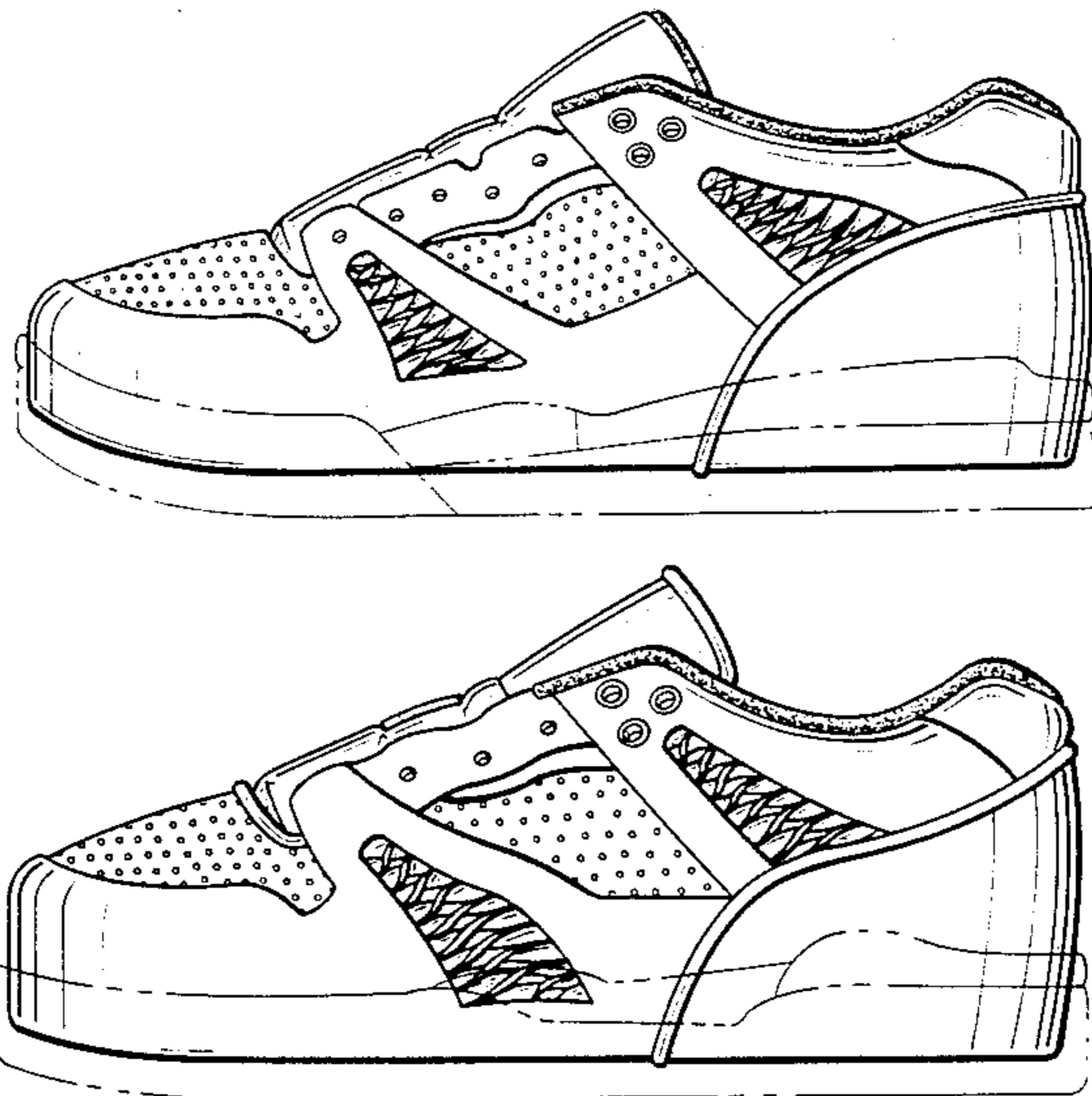

[57] **CLAIM**

The ornamental design for a shoe upper, as shown and described.

DESCRIPTION

FIG. 1 is a right side elevational view of a shoe upper showing my new design which is the subject of this invention. The broken line showing a shoe sole is for environmental purposes only and forms no part of the claimed invention.
 FIG. 2 is a top plan view thereof;
 FIG. 3 is a bottom plan view thereof;
 FIG. 4 is a left side elevational view thereof;
 FIG. 5 is a front elevational view thereof; and
 FIG. 6 is a rear elevational view of the present invention.
 FIG. 7 is a right side elevational view of an alternate embodiment of my invention; and
 FIG. 8 is a top plan view of the alternate embodiment thereof;
 FIG. 9 is a bottom plan view of the alternate embodiment thereof;
 FIG. 10 is a left side elevational view of the alternate embodiment thereof;
 FIG. 11 is a front elevational view of the alternate embodiment thereof; and
 FIG. 12 is a rear elevational view of the alternate embodiment thereof;



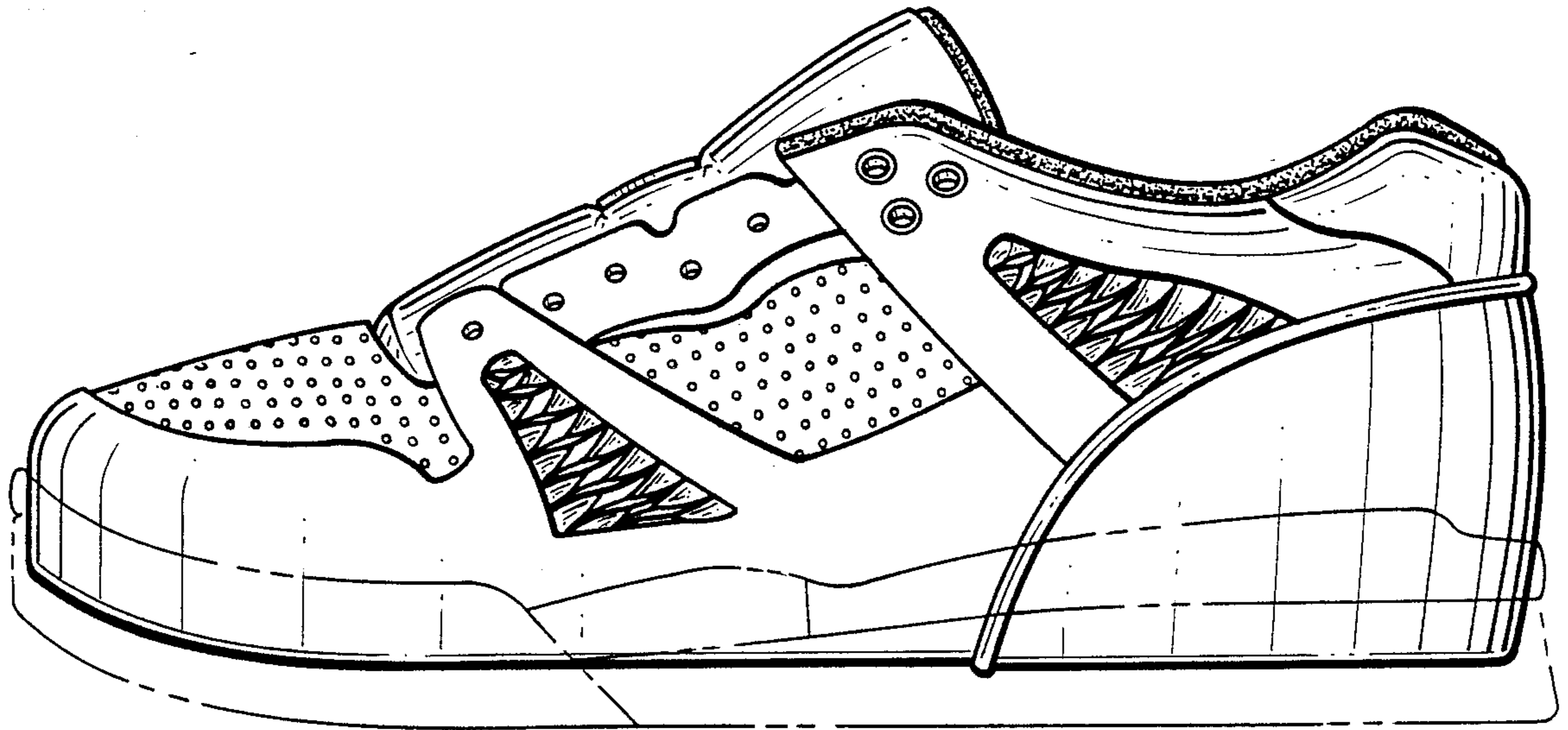

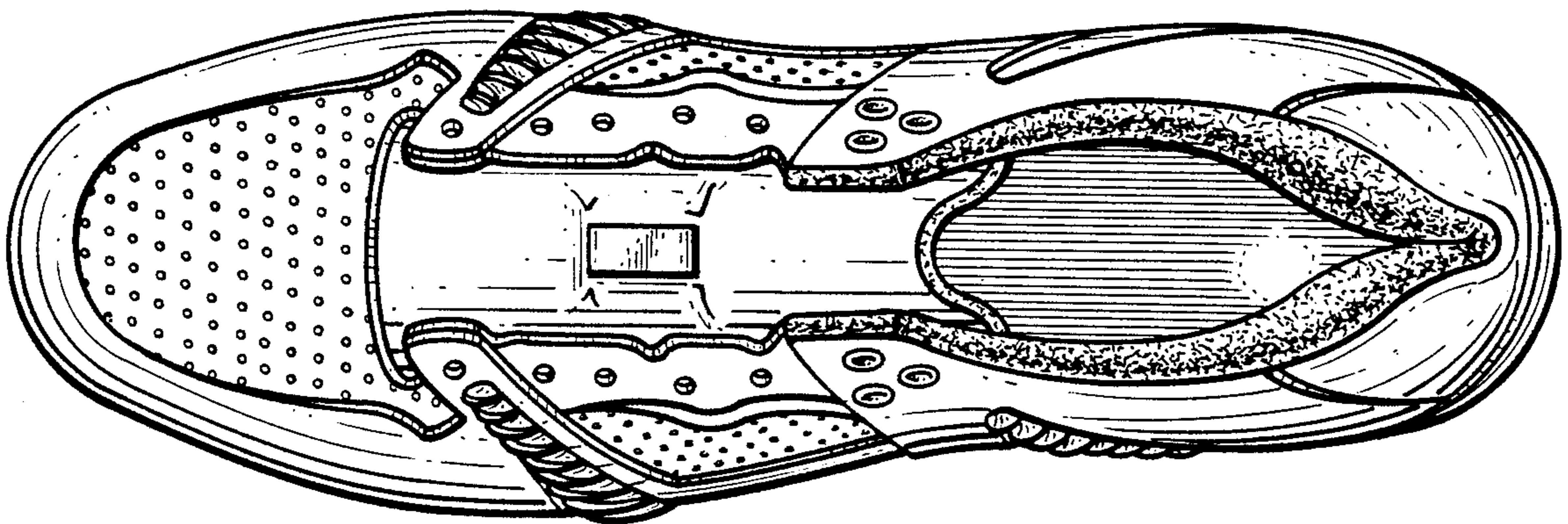

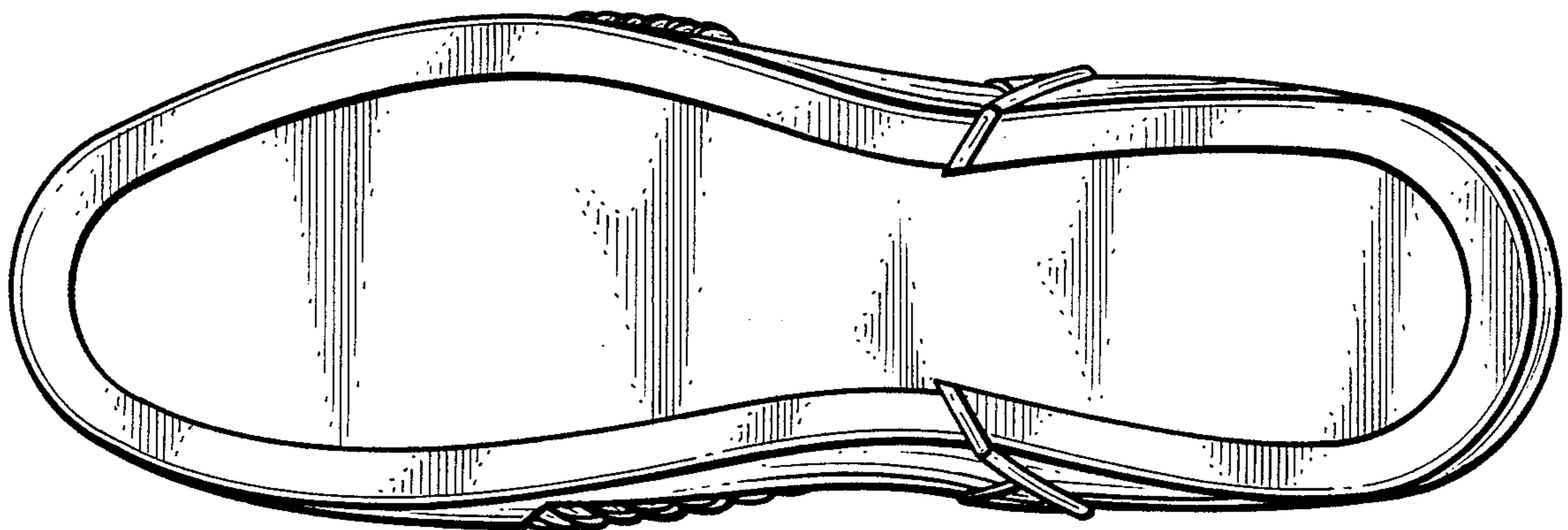

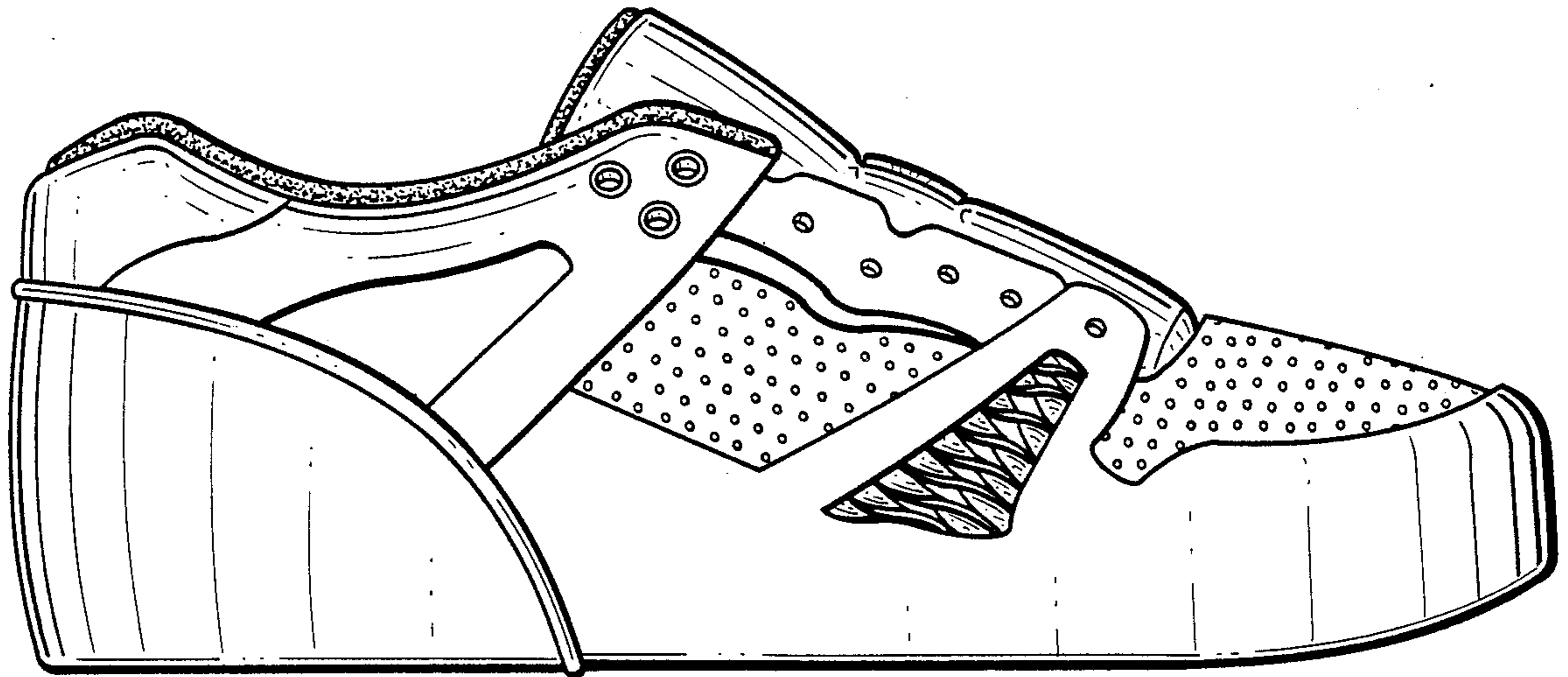

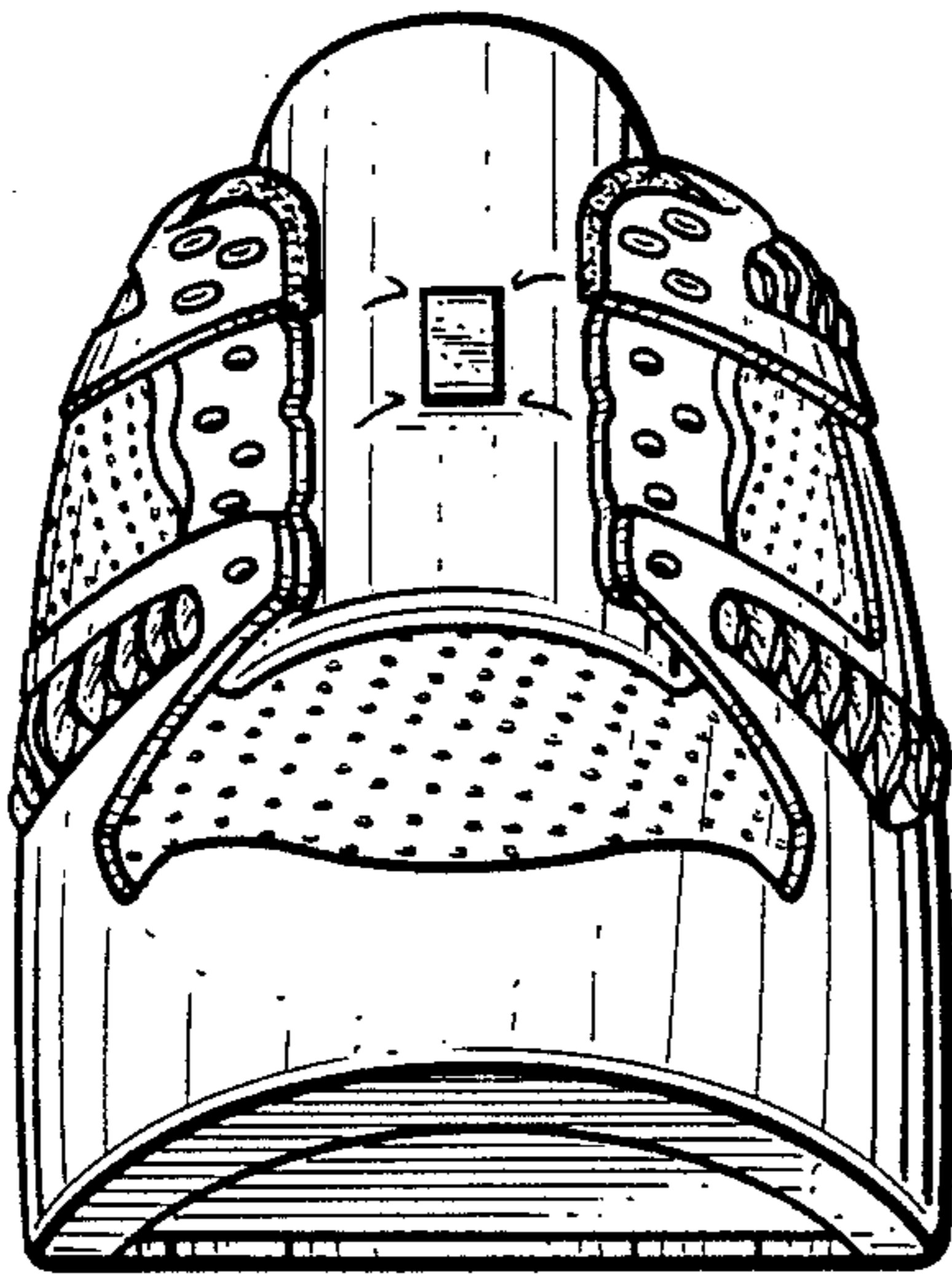

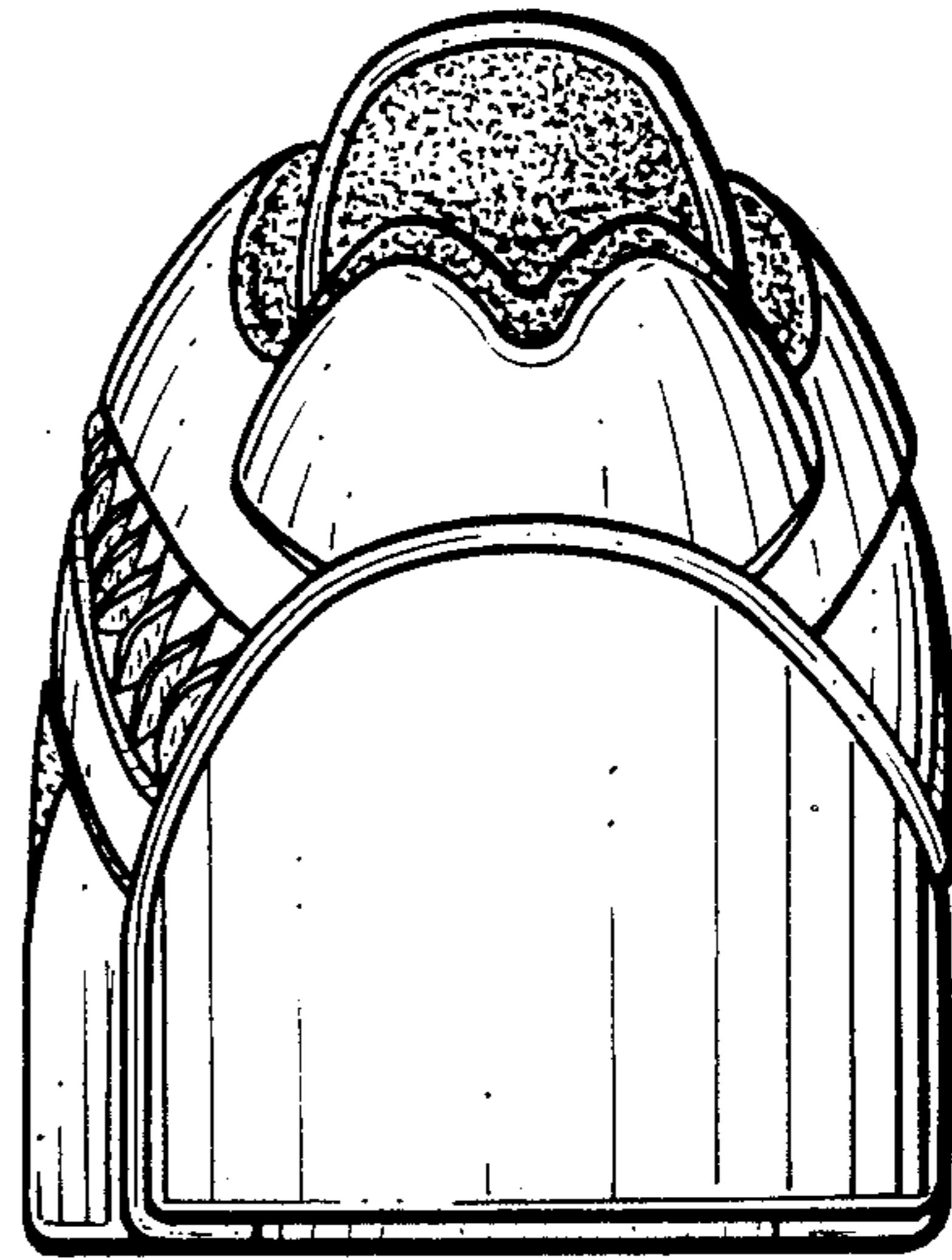

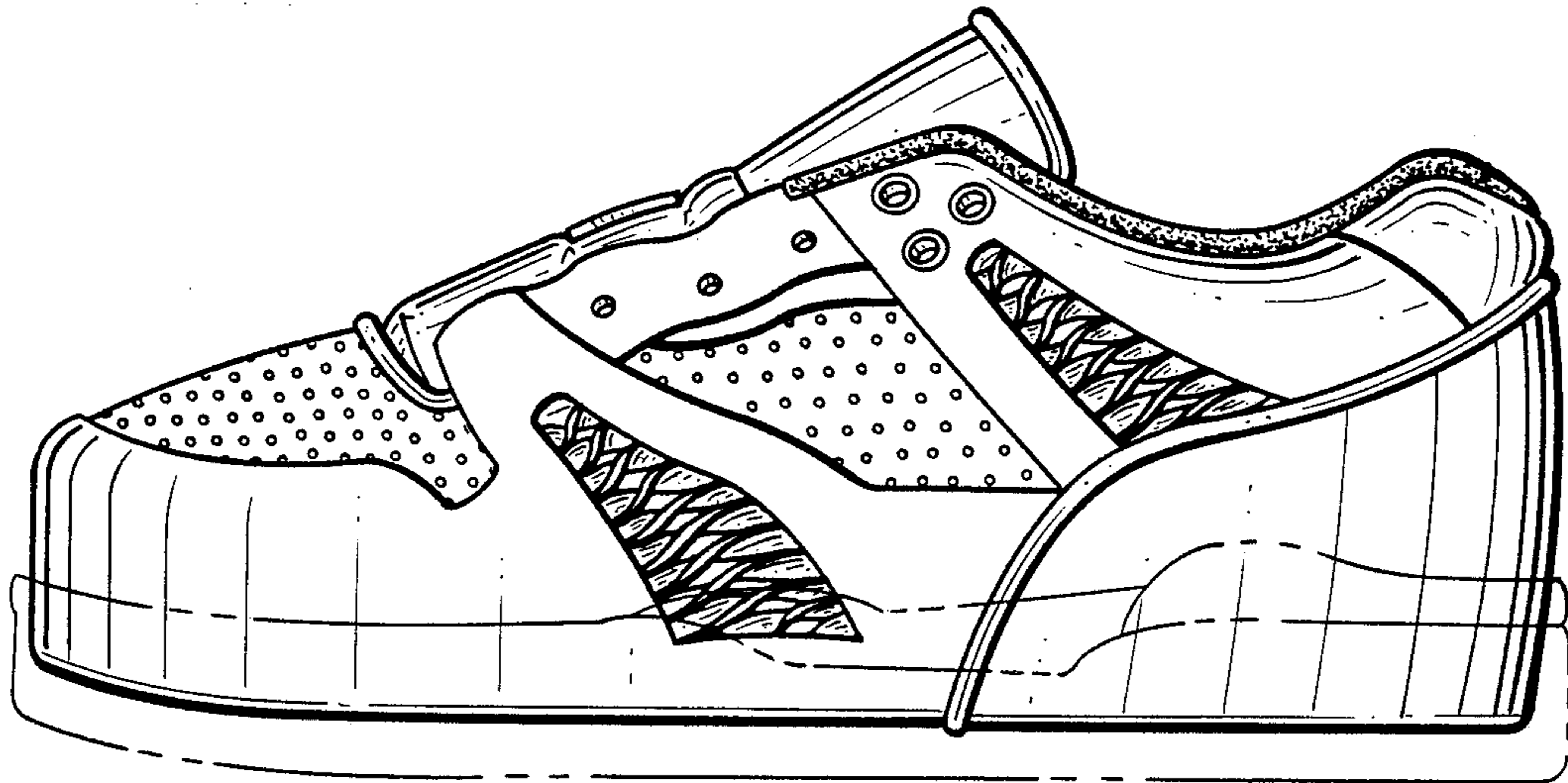

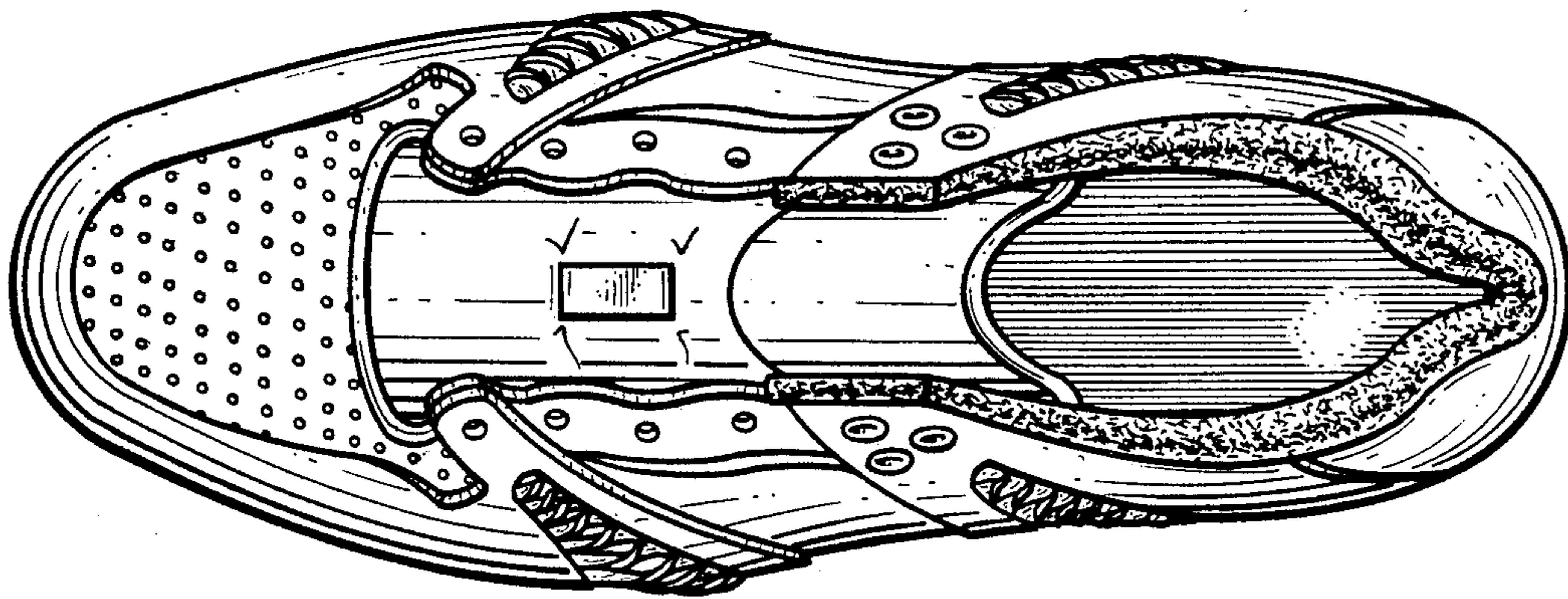

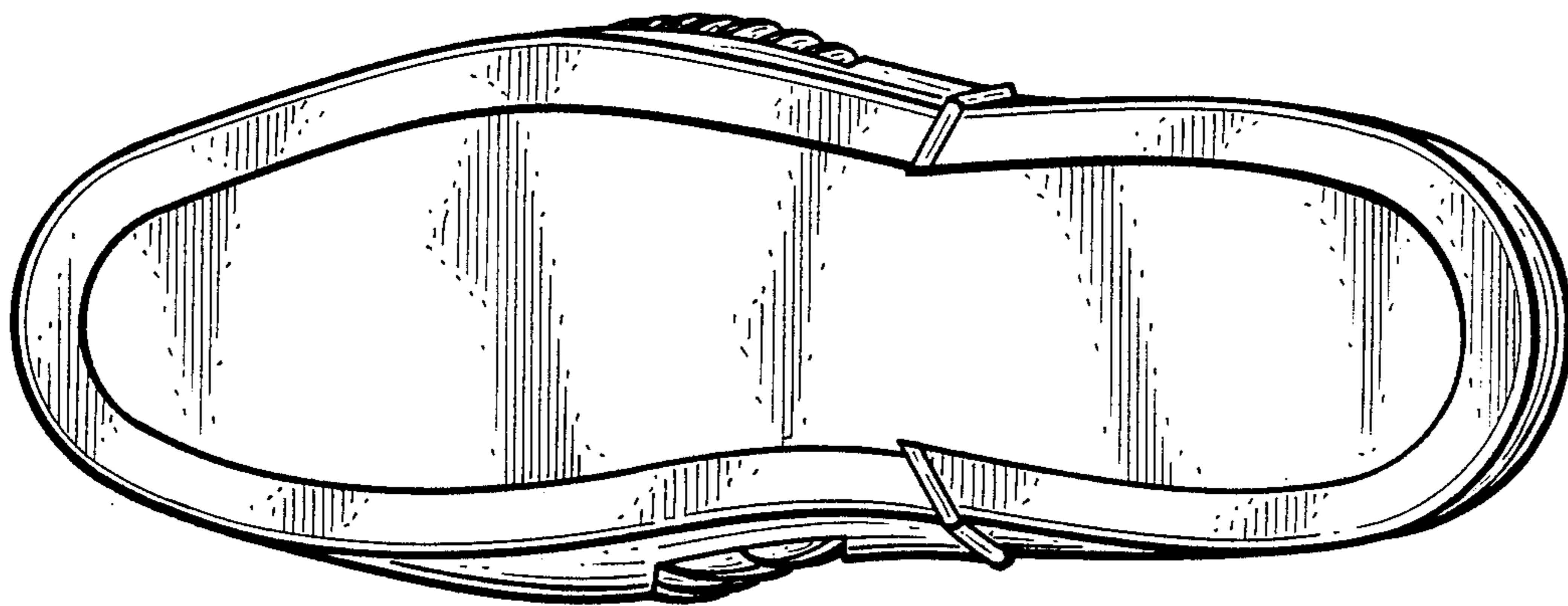

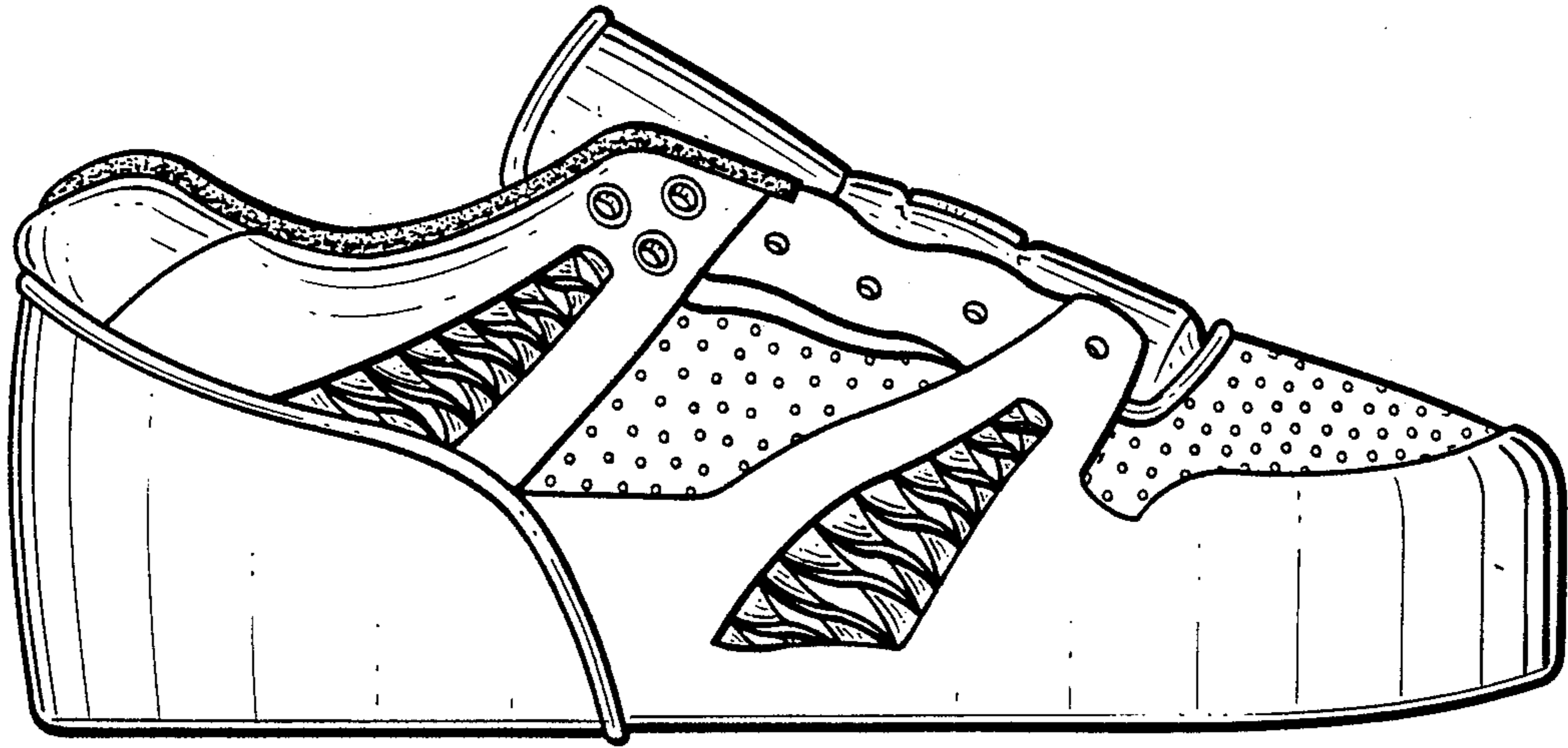

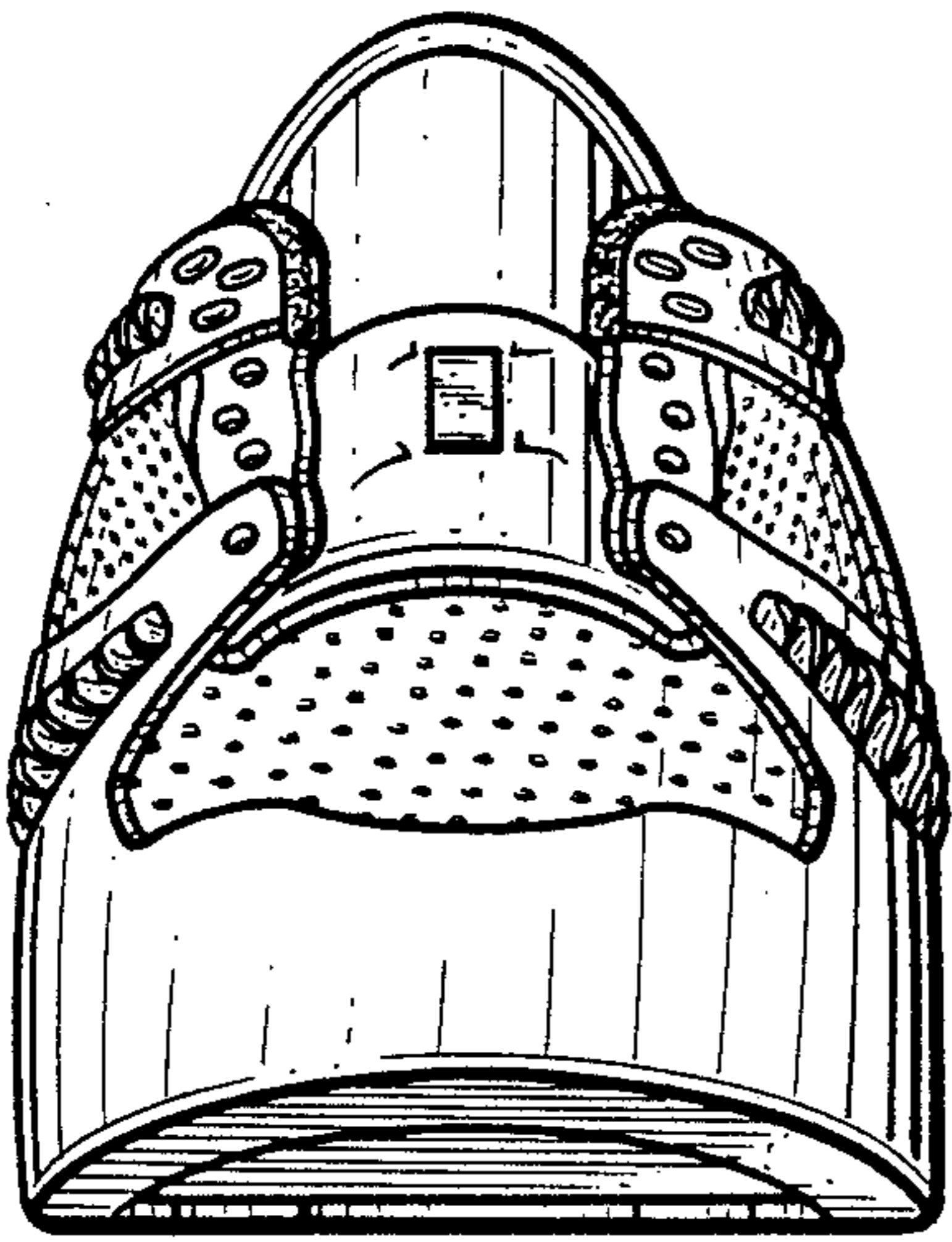

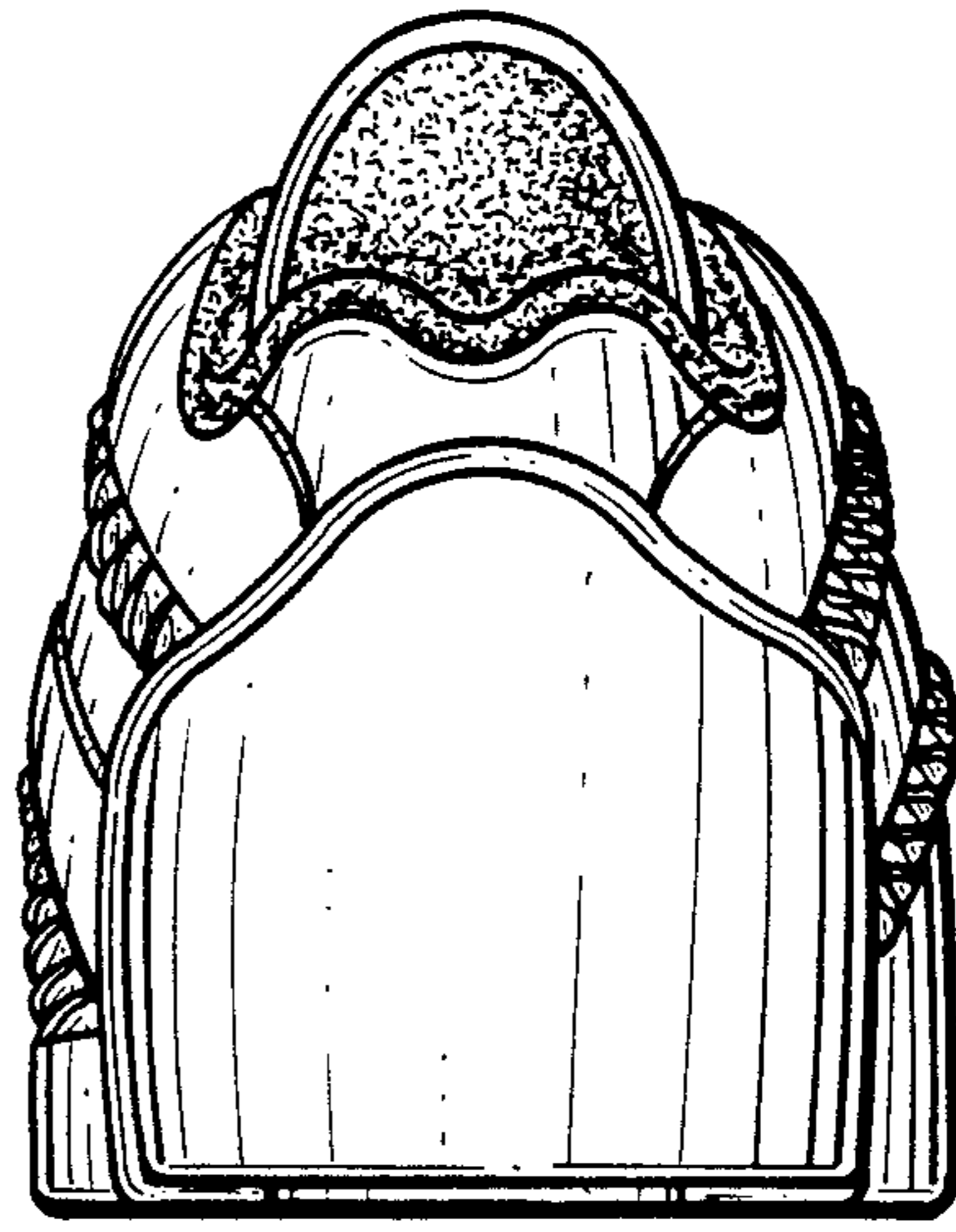
