[57] **CLAIM**

The ornamental design control housing for a valve housing, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view taken from the top, front and right side of a control housing for a valve showing my new design;  
 FIG. 2 is a right side elevational view thereof;  
 FIG. 3 is a left side elevational view thereof;  
 FIG. 4 is a top plan view thereof;  
 FIG. 5 is a bottom plan view thereof;  
 FIG. 6 is a front elevational thereof; and  
 FIG. 7 is a rear elevational thereof.  
 The broken line representation of a valve in FIGS. 3 and 4 is for purposes of illustration only and forms no part of the claimed design.

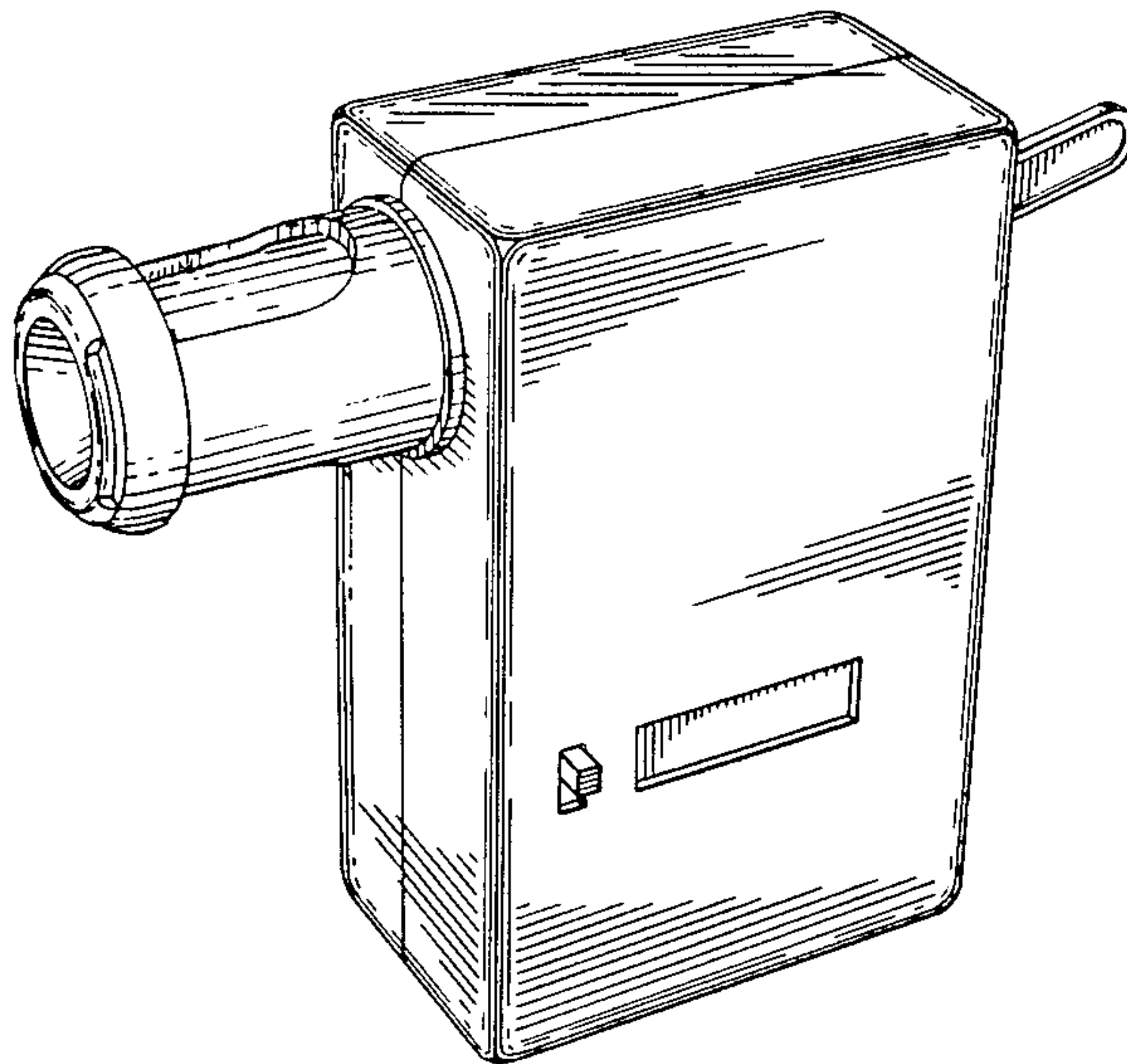

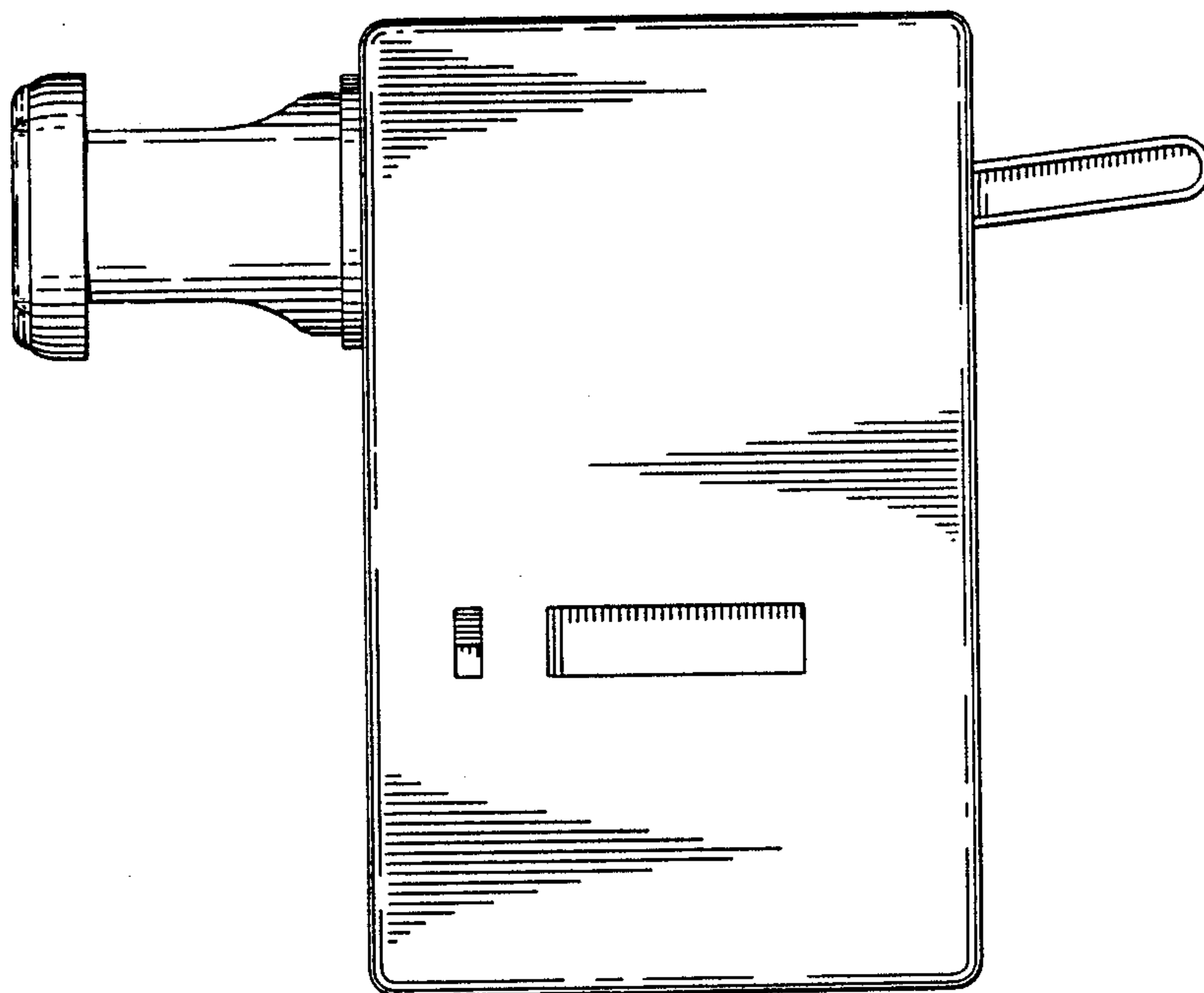
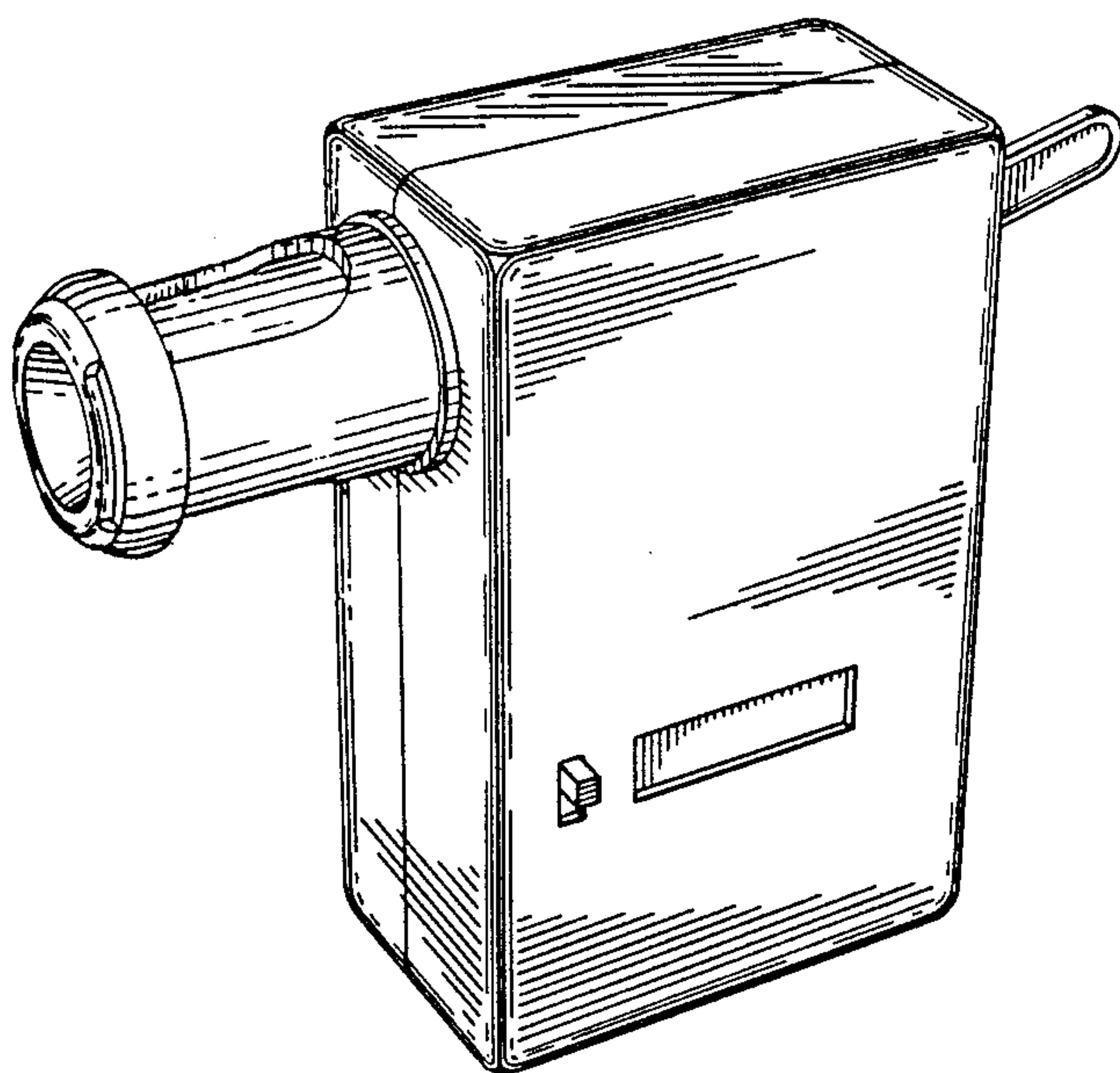

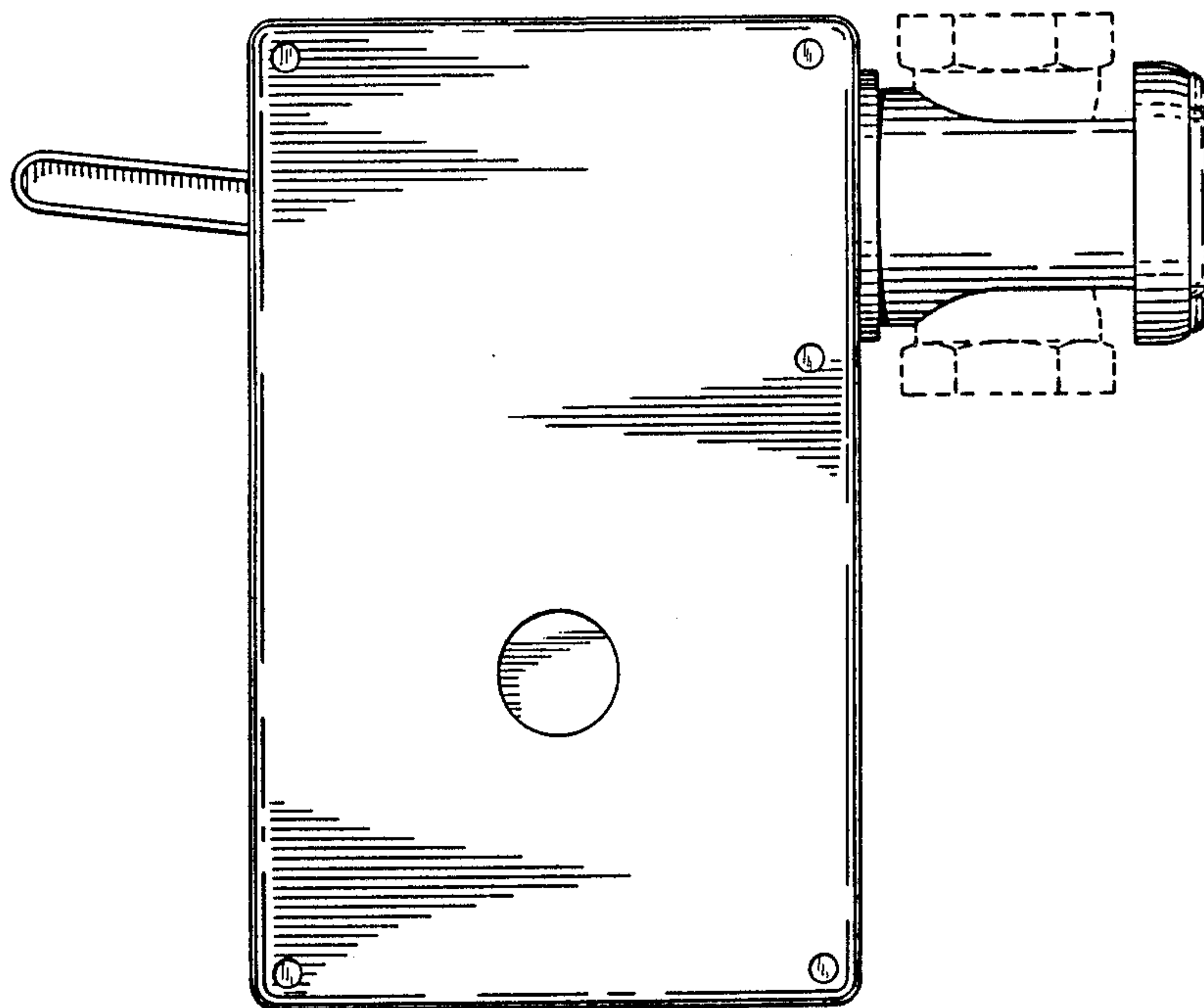

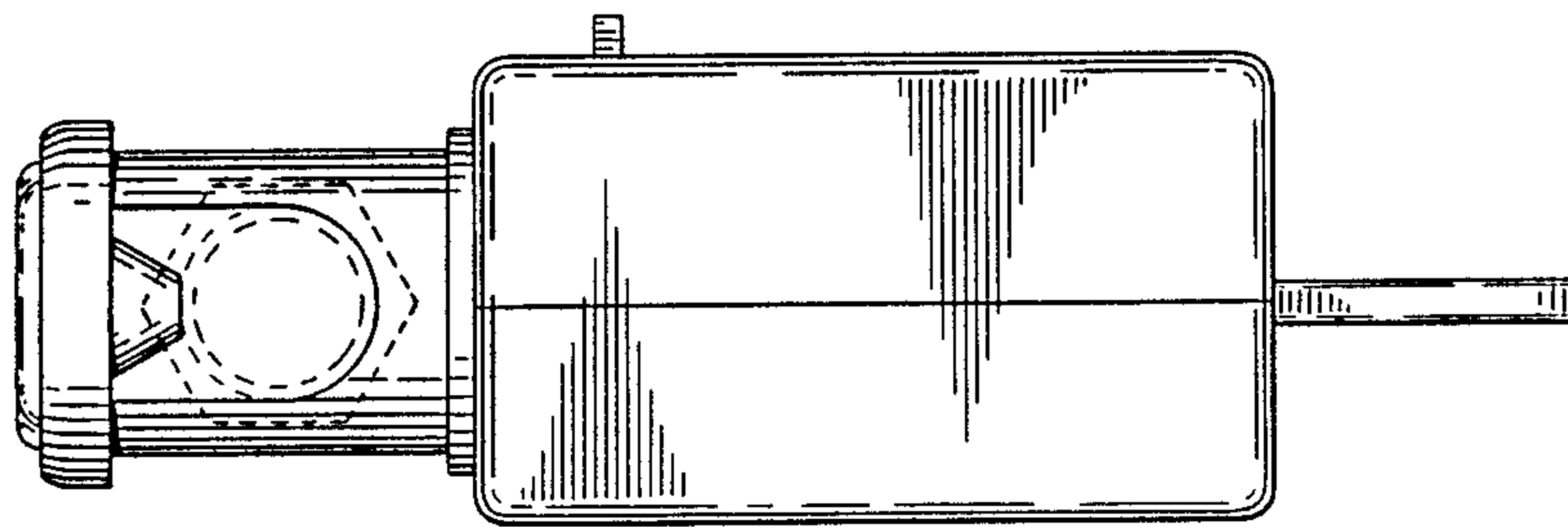

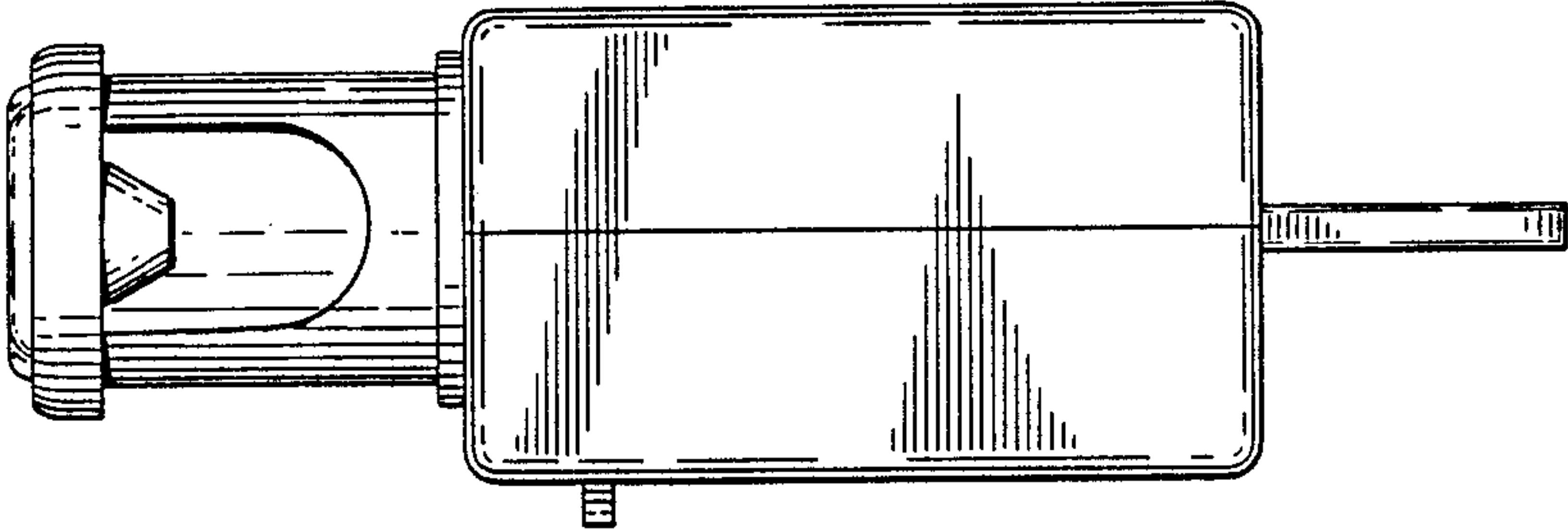

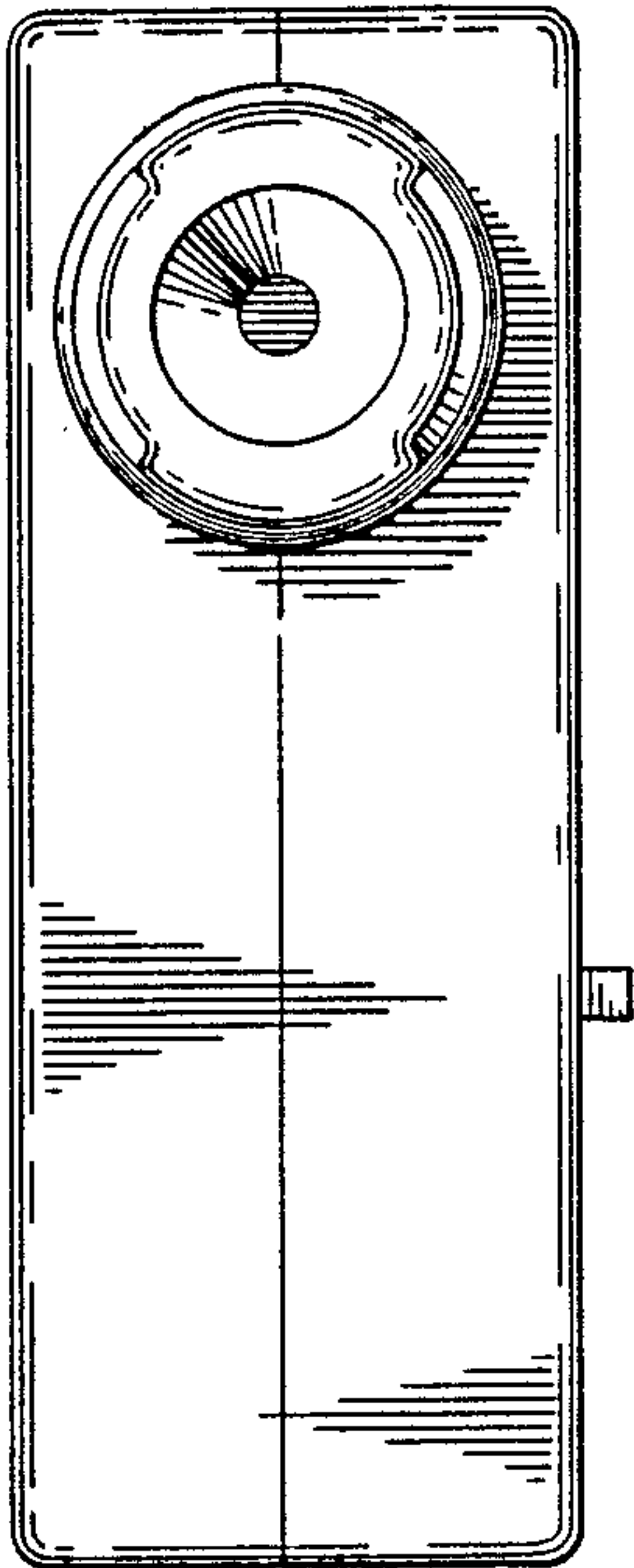

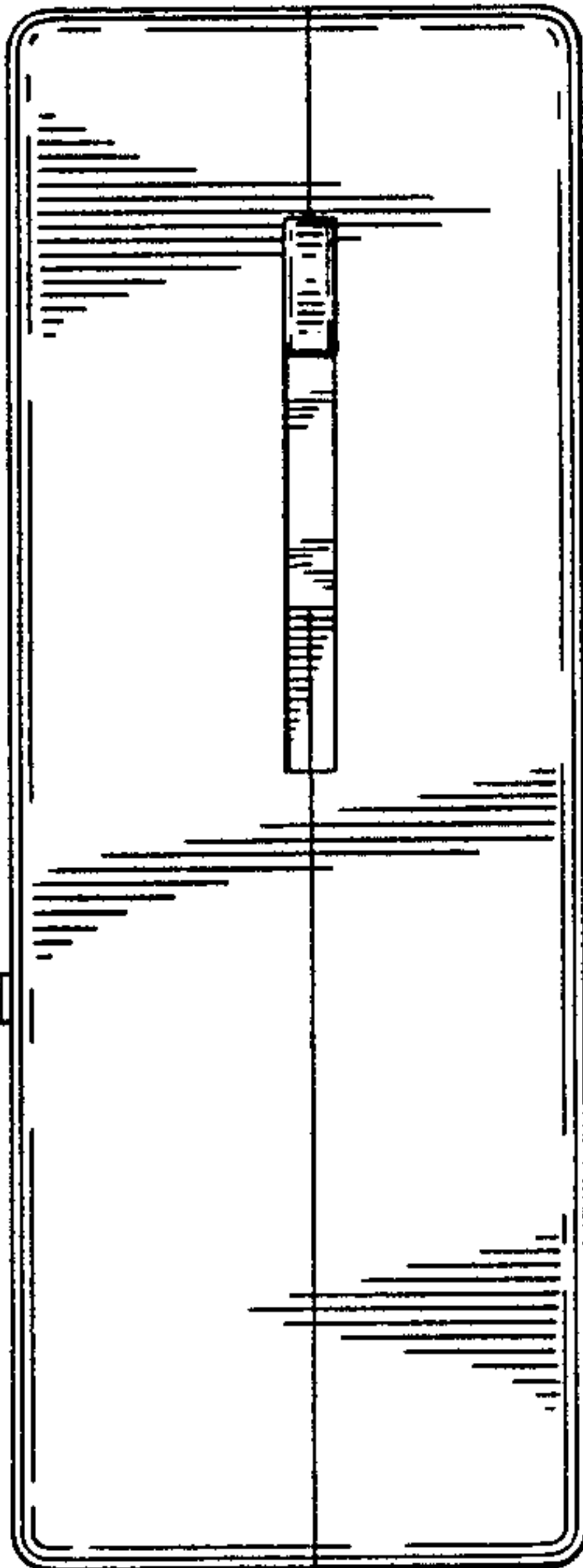
