DESCRIPTION

FIG. 1 is a perspective view of a single valance bracket showing my new design;
 FIG. 2 is a top plan view thereof;
 FIG. 3 is a front elevational view thereof;
 FIG. 4 is a right side elevational view, with the opposite side being a mirror image thereof;
 FIG. 5 is a rear elevational view thereof;
 FIG. 6 is a bottom plan view thereof.

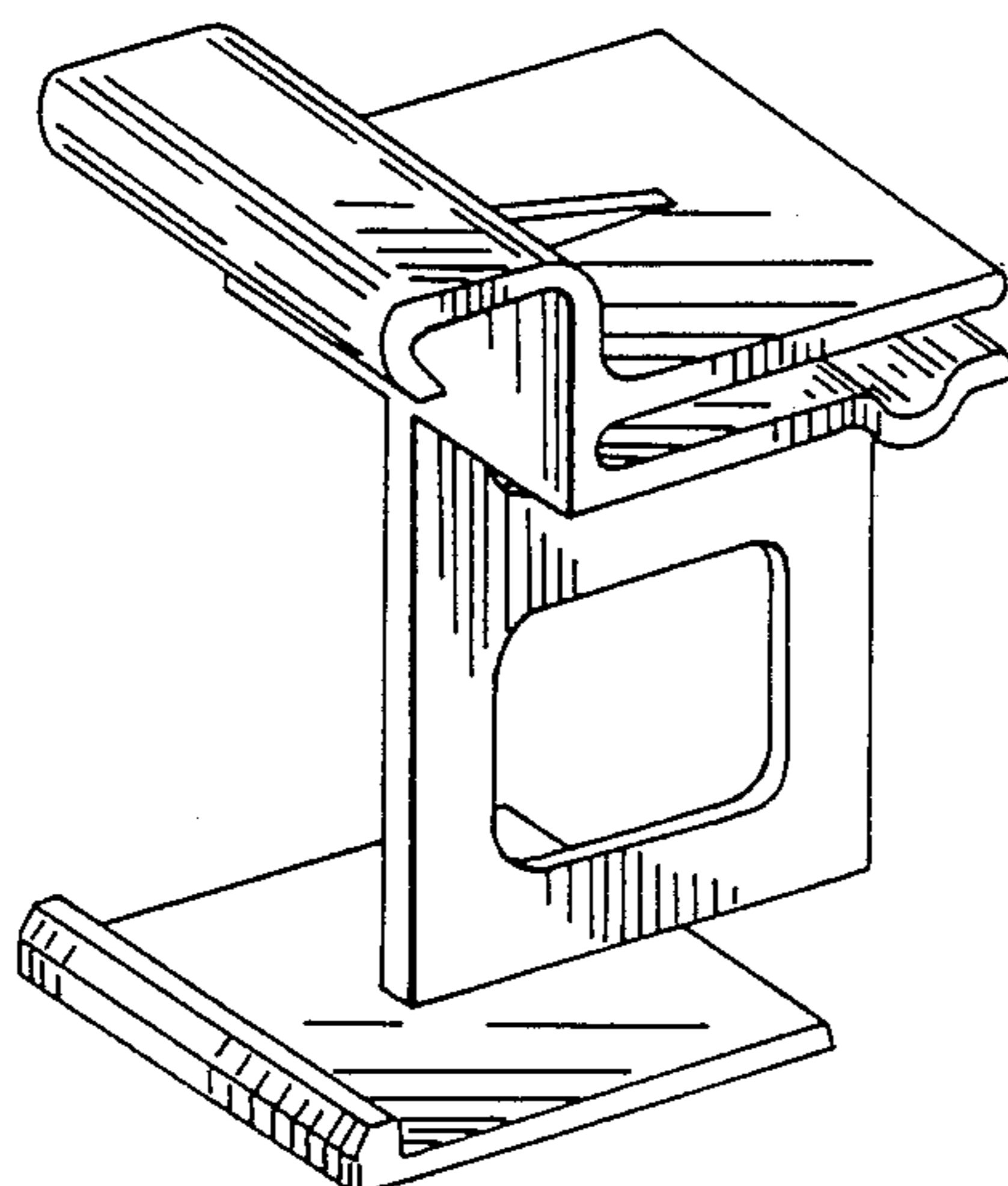

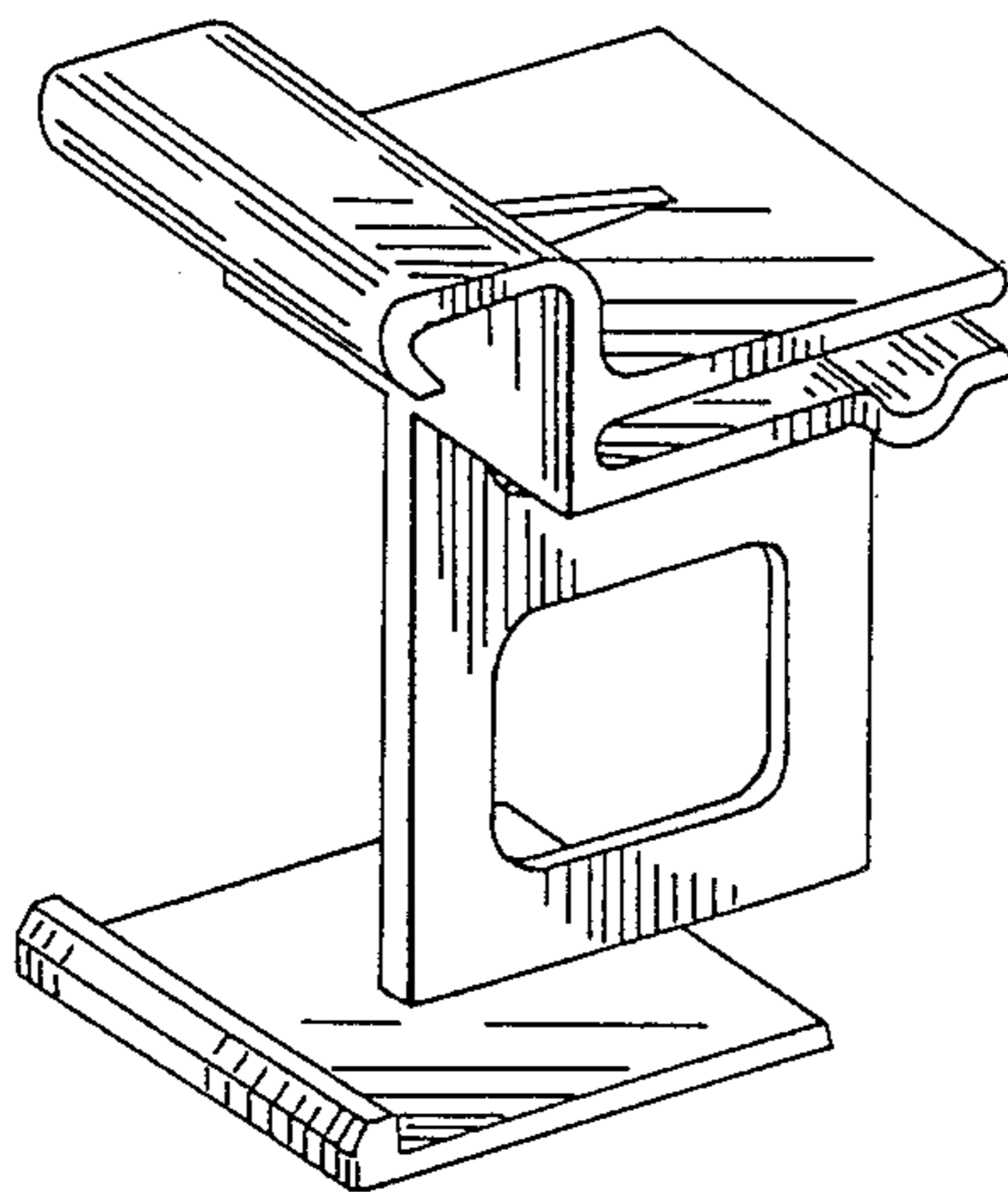

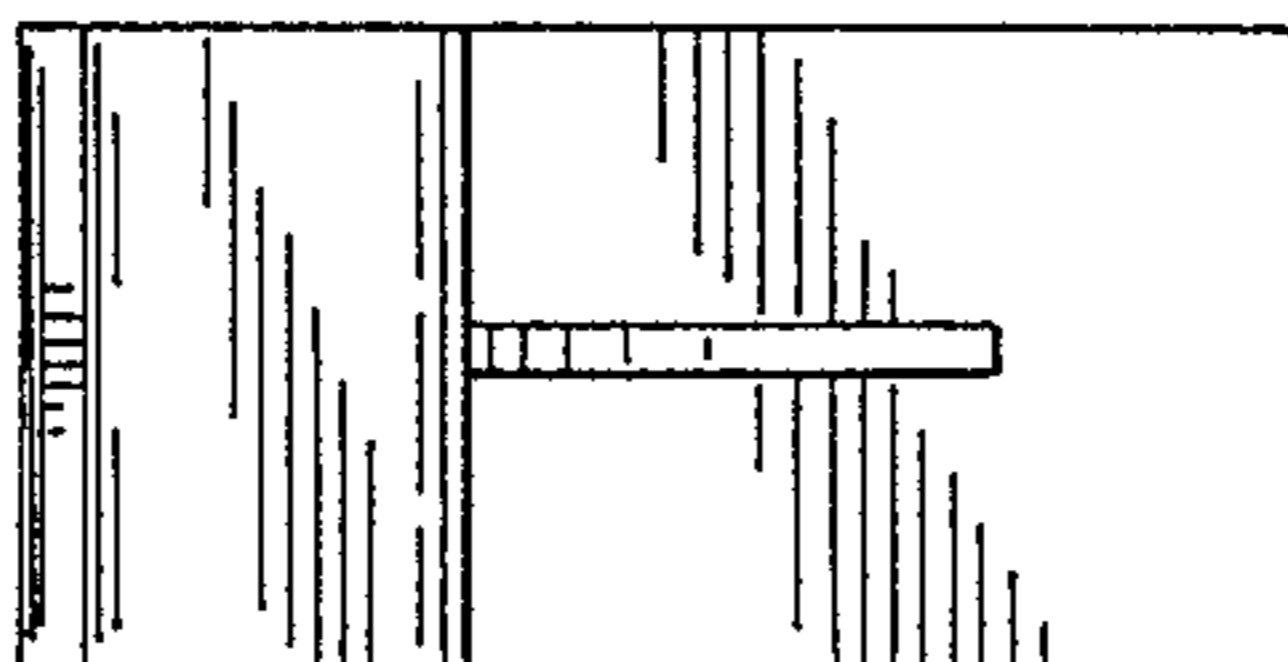

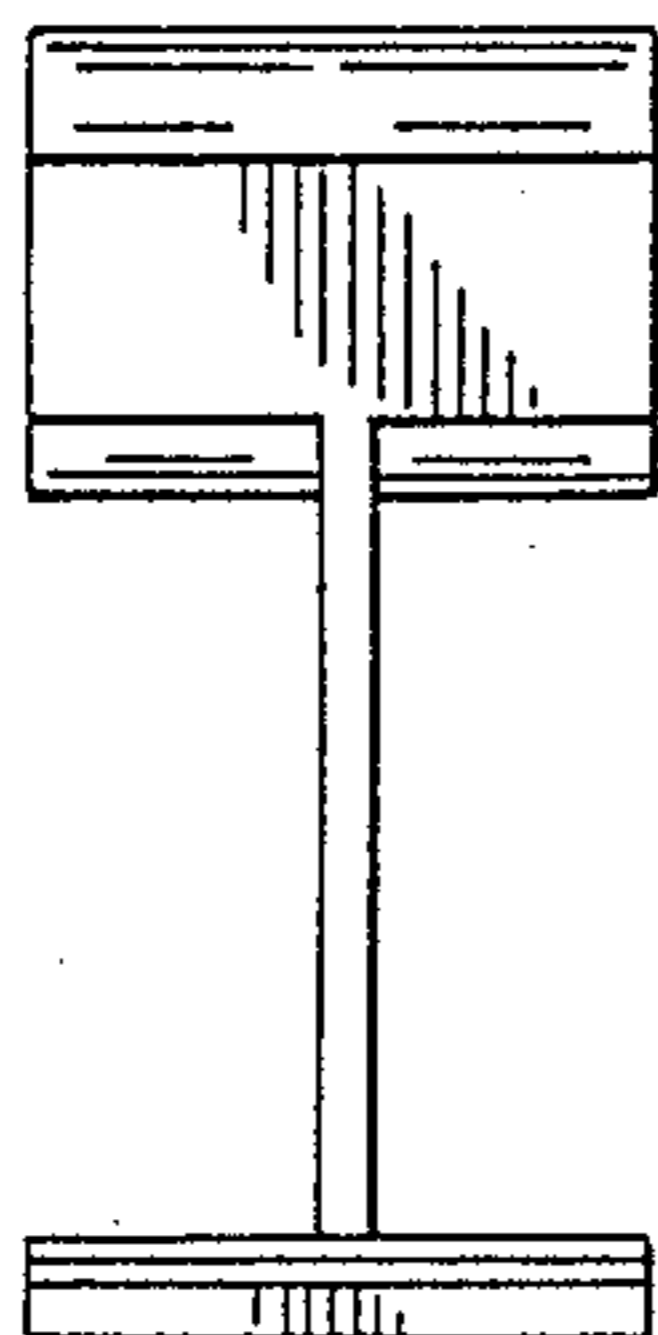

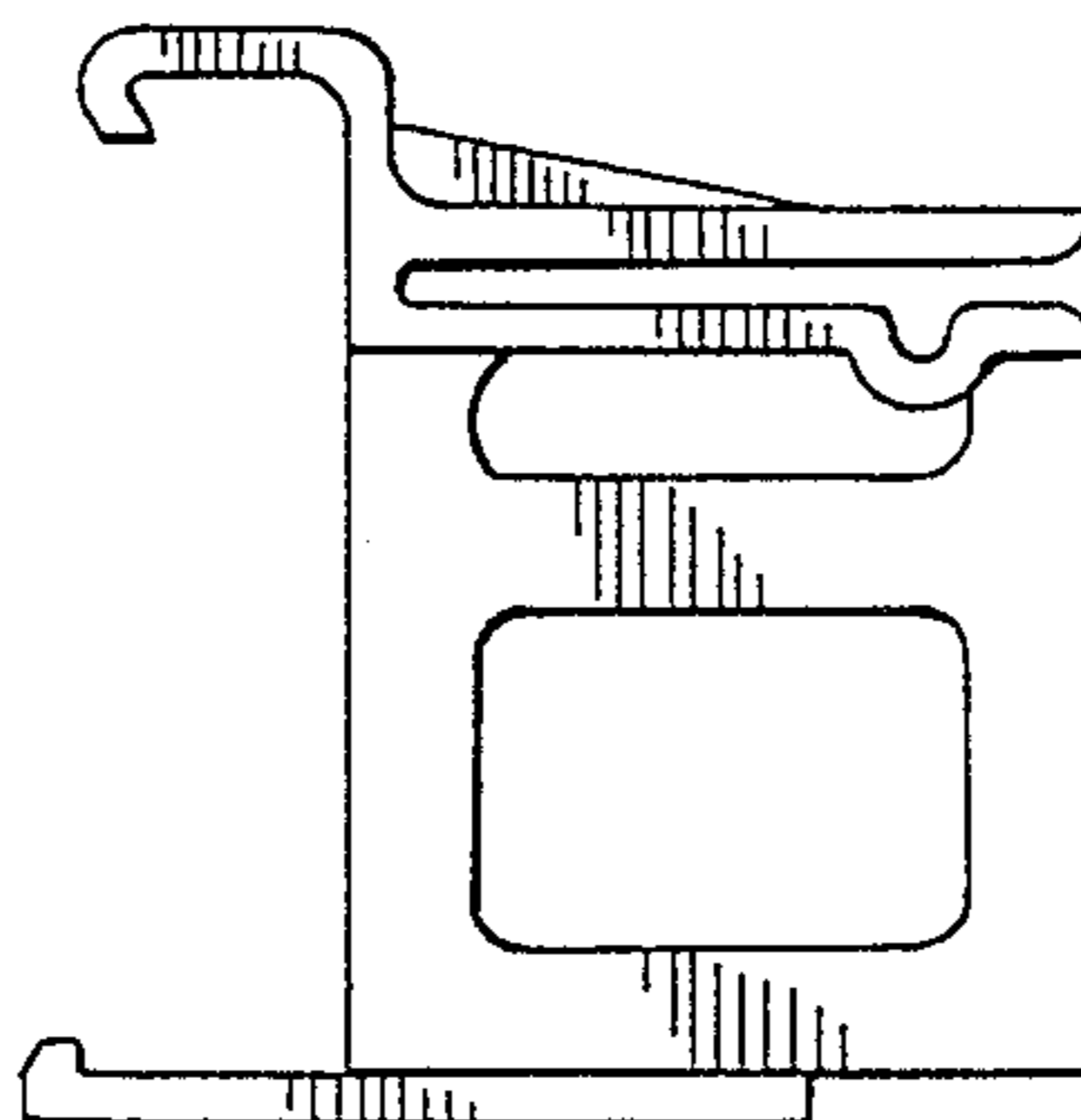

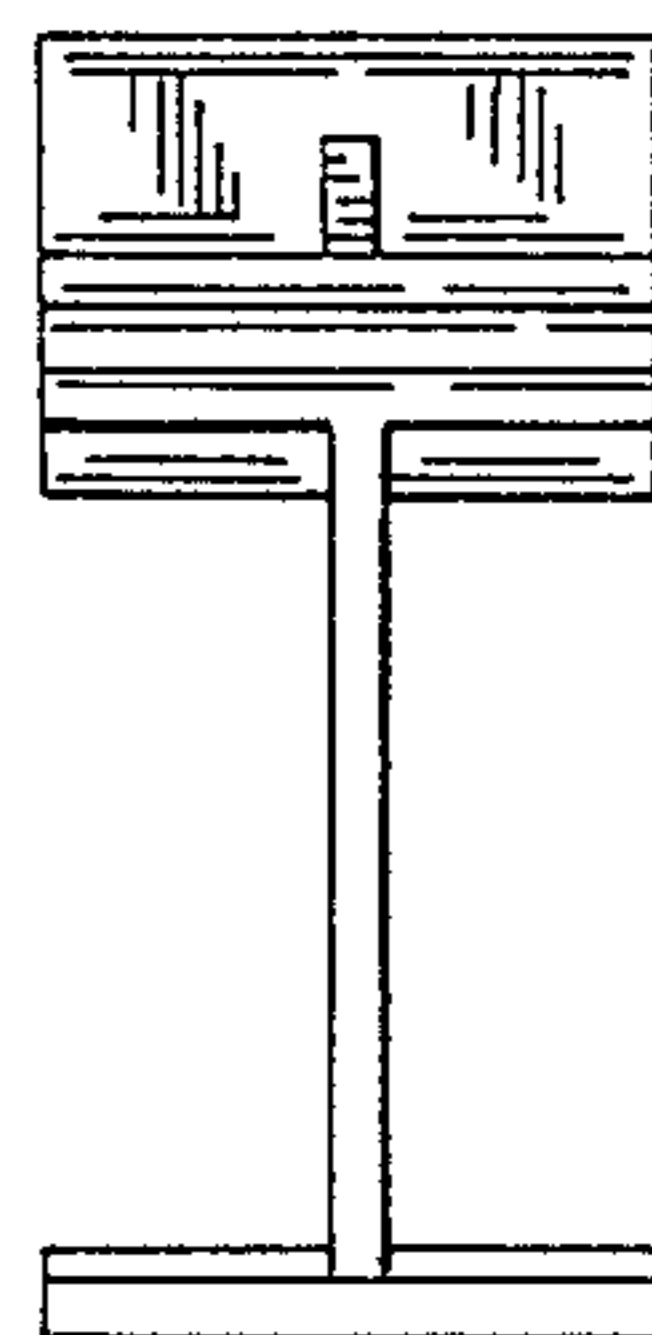
