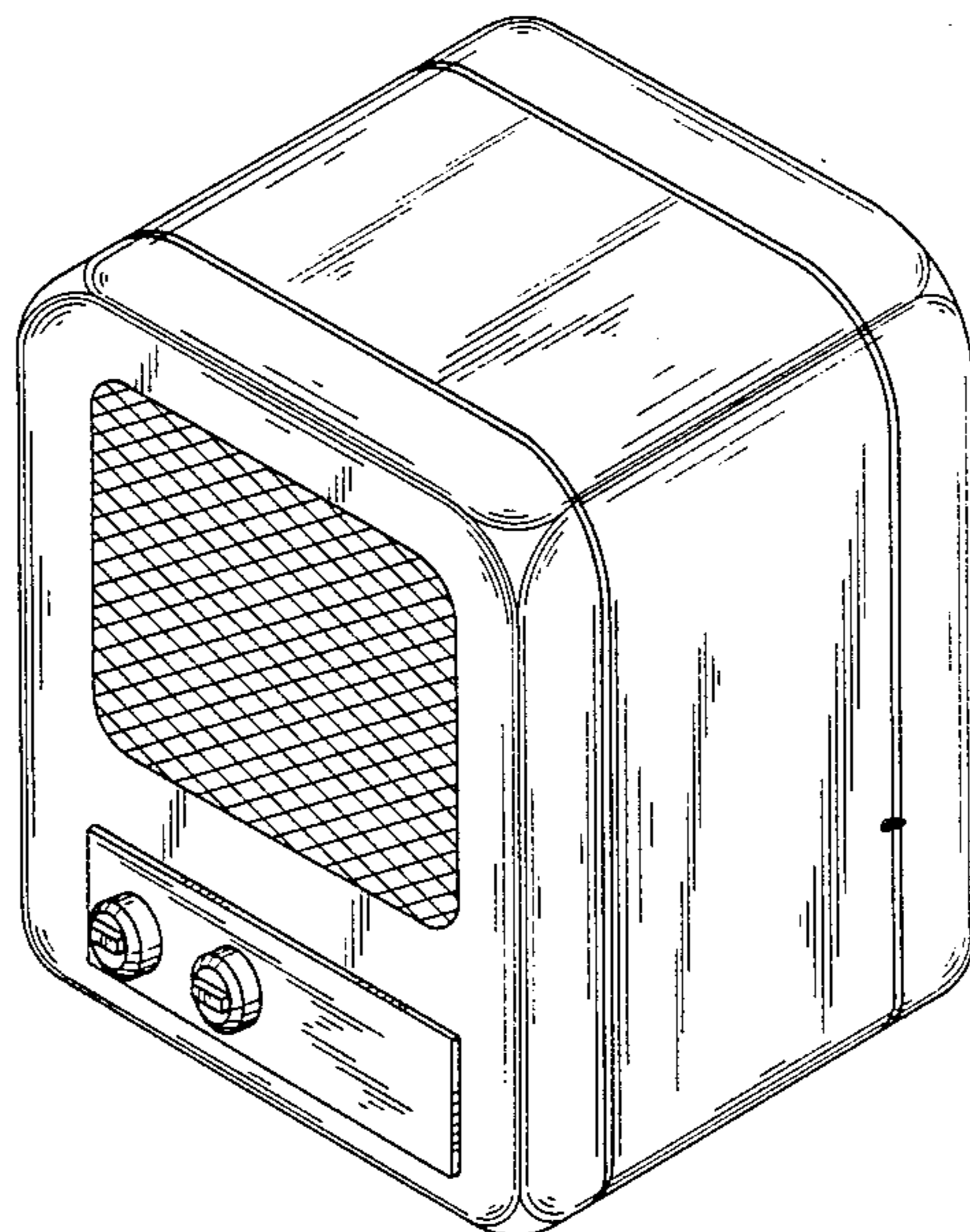

 FIG. 7 is a bottom plan view thereof, on a reduced scale;



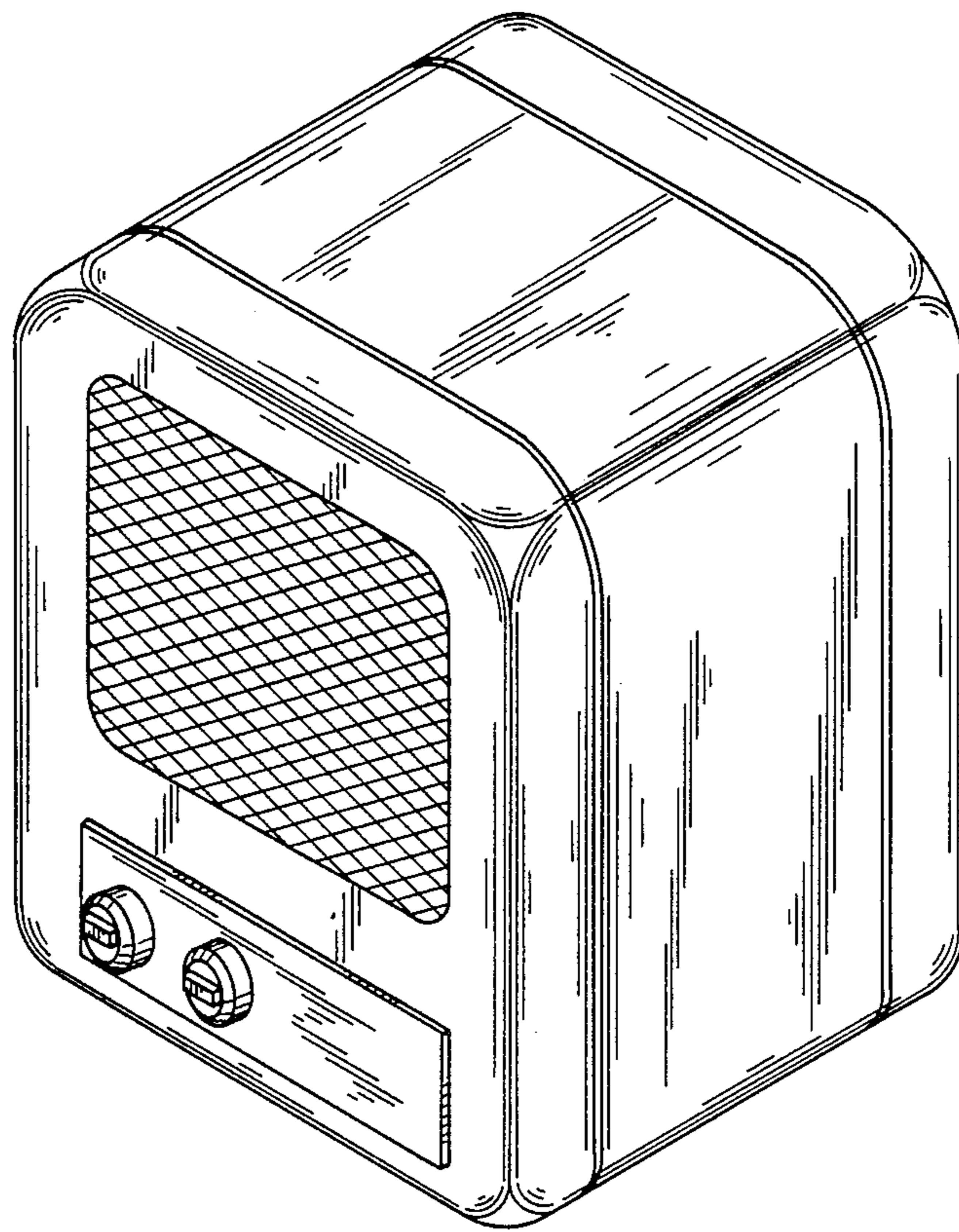

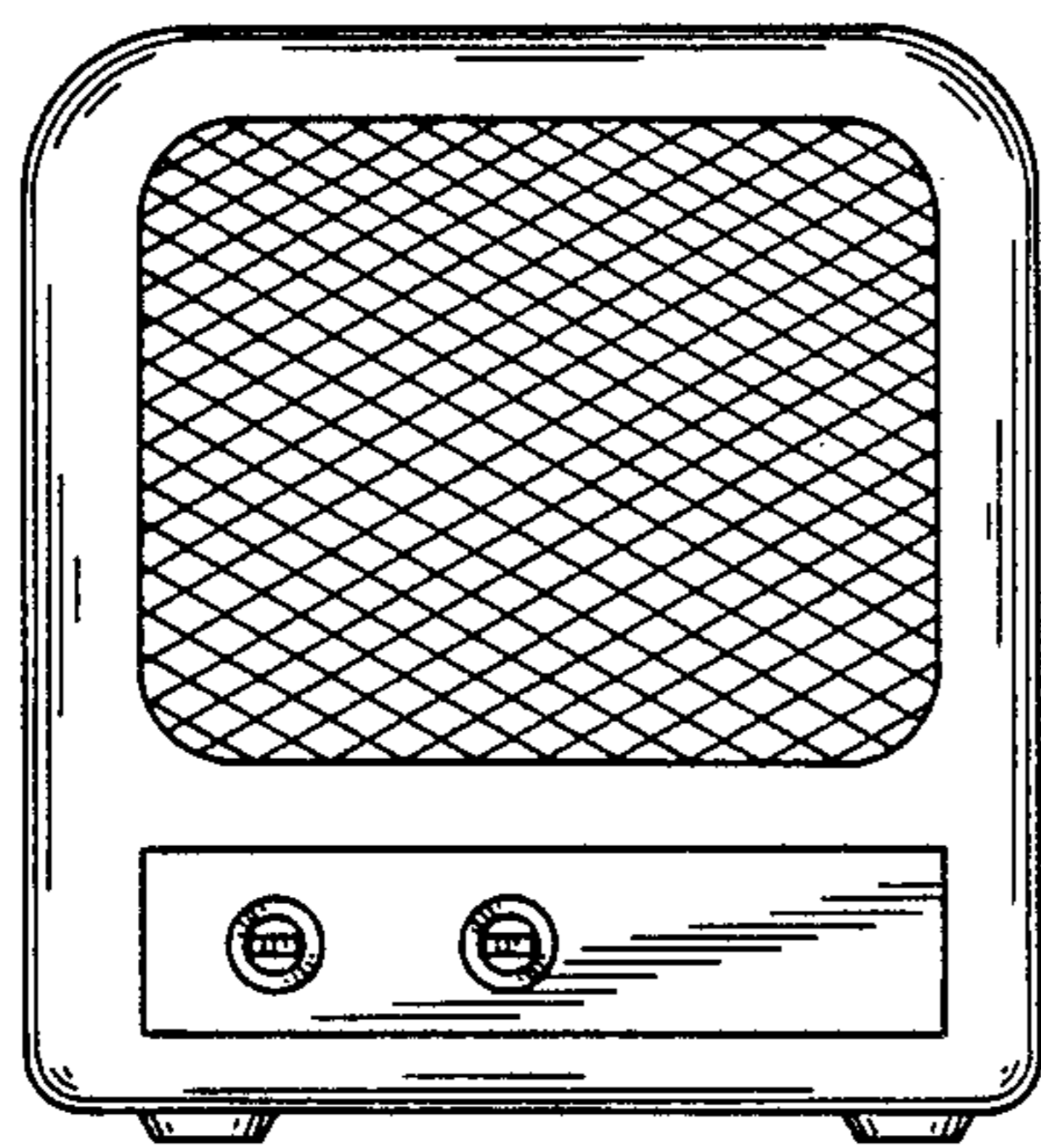

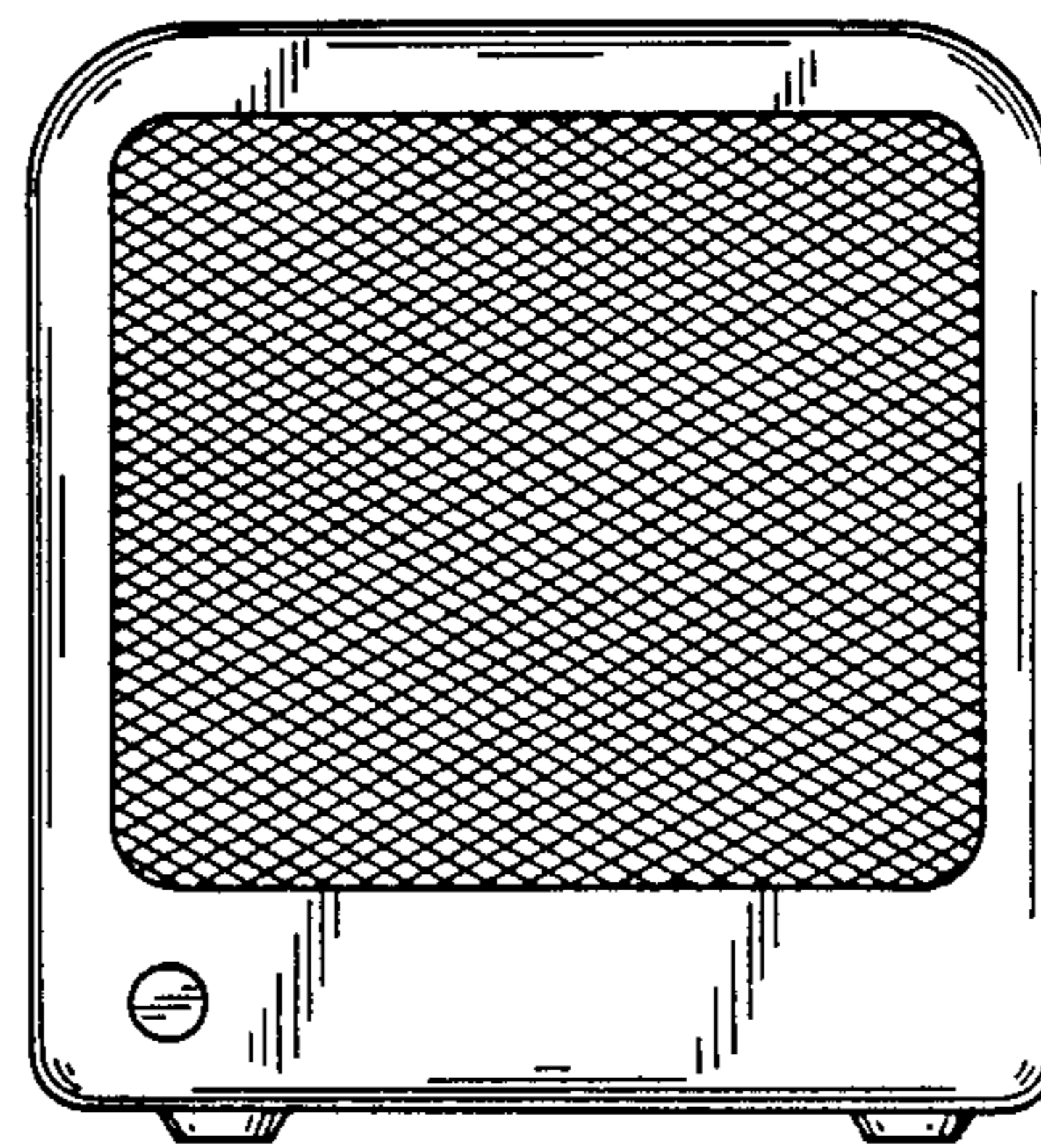

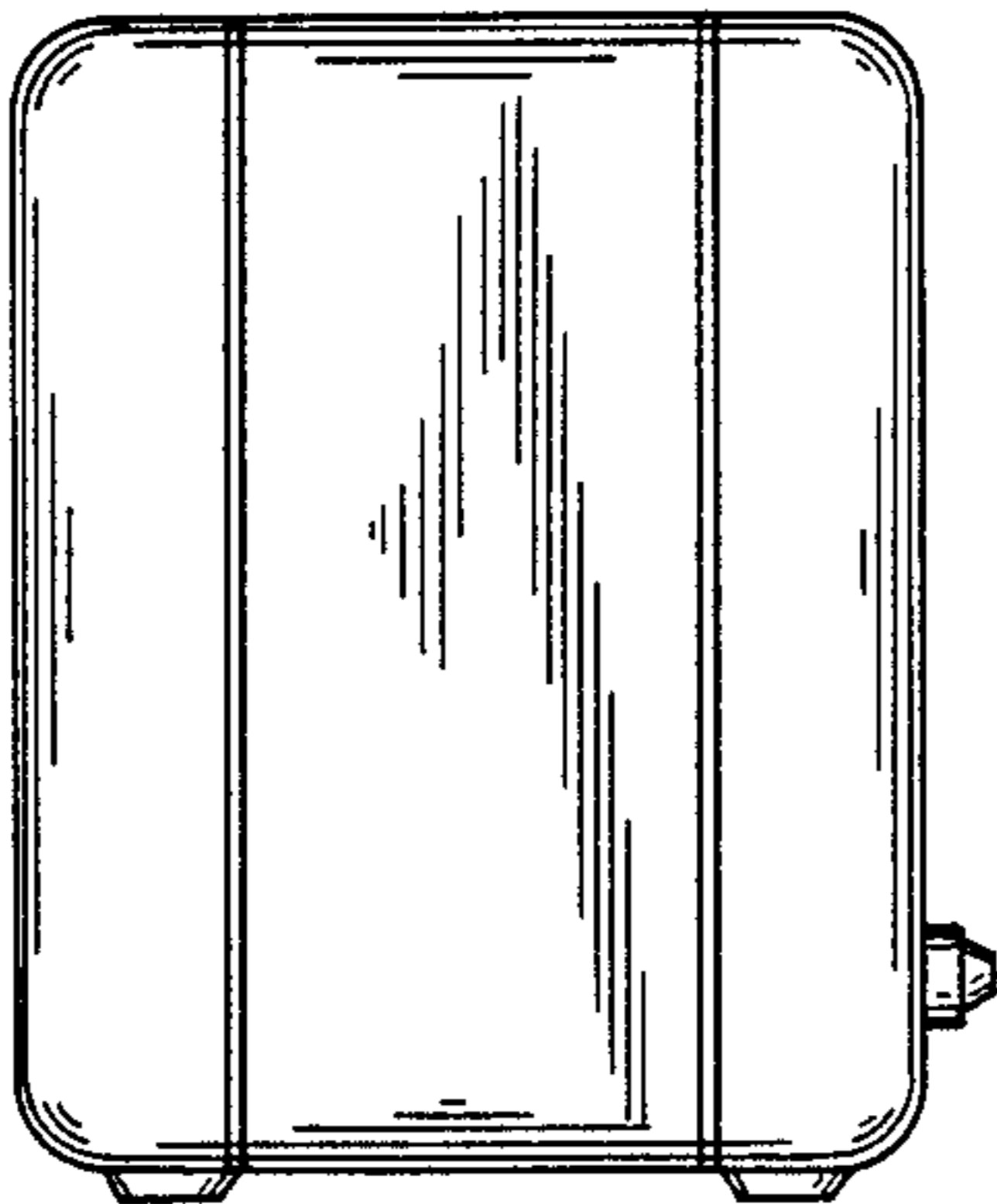

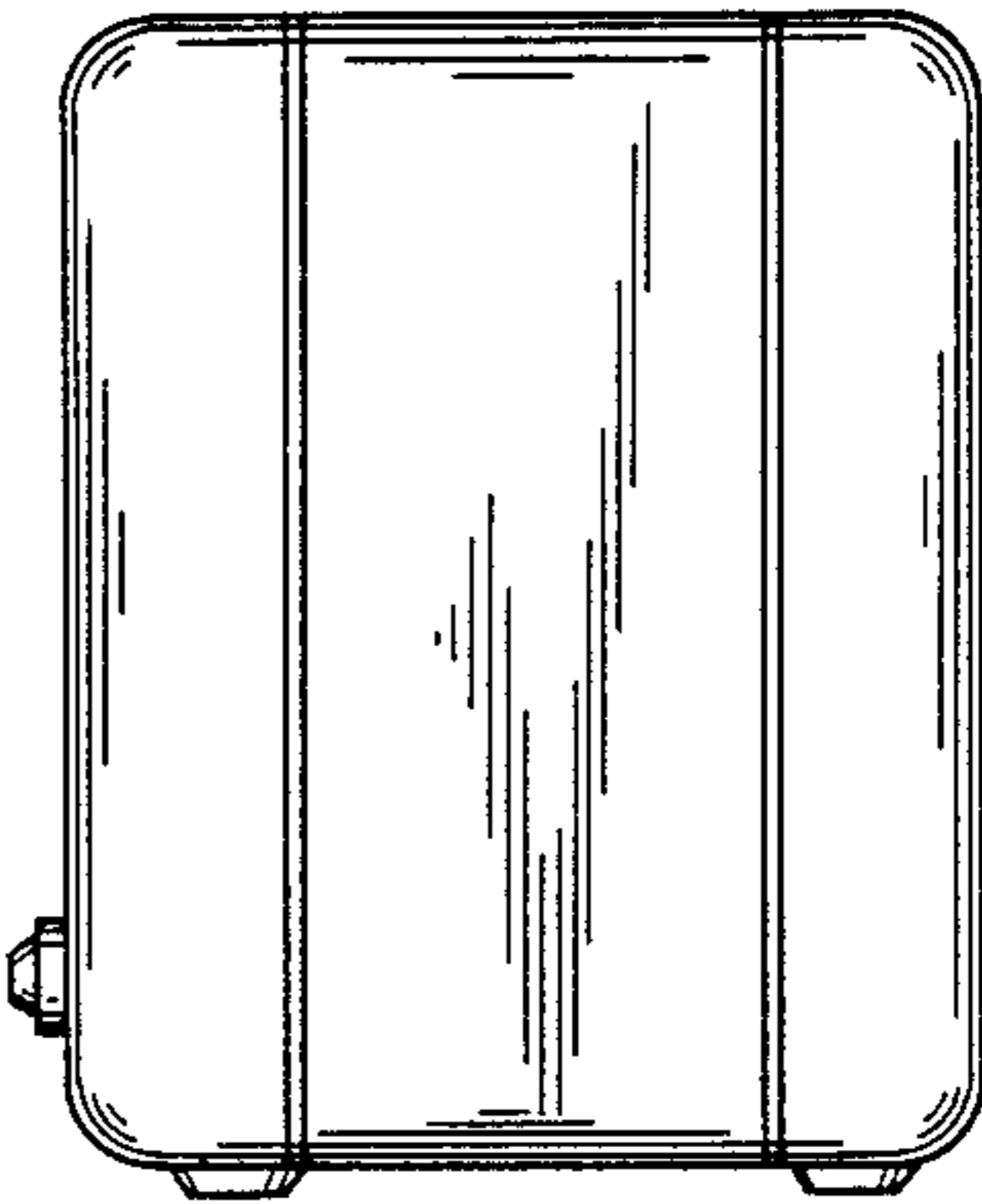

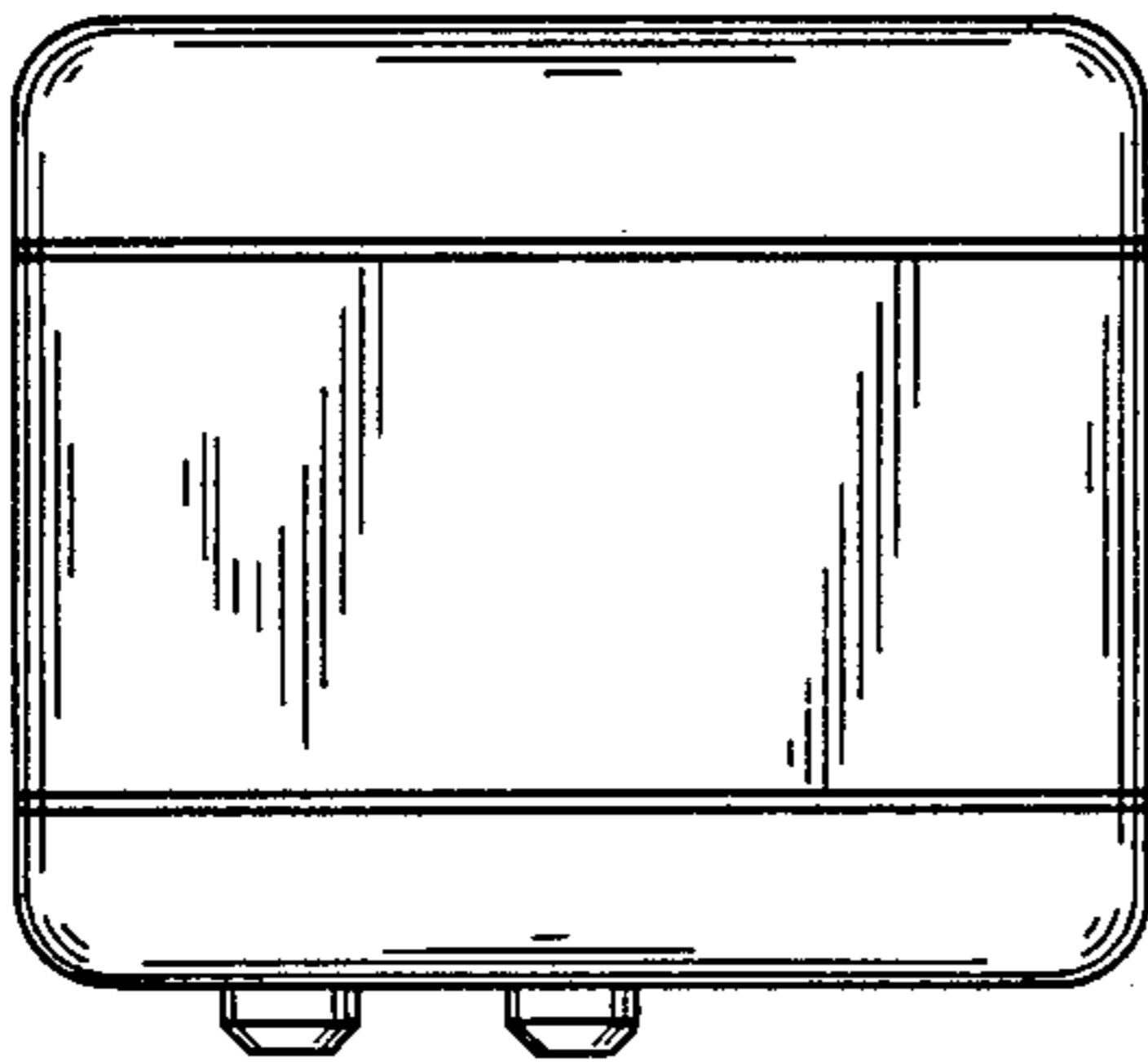

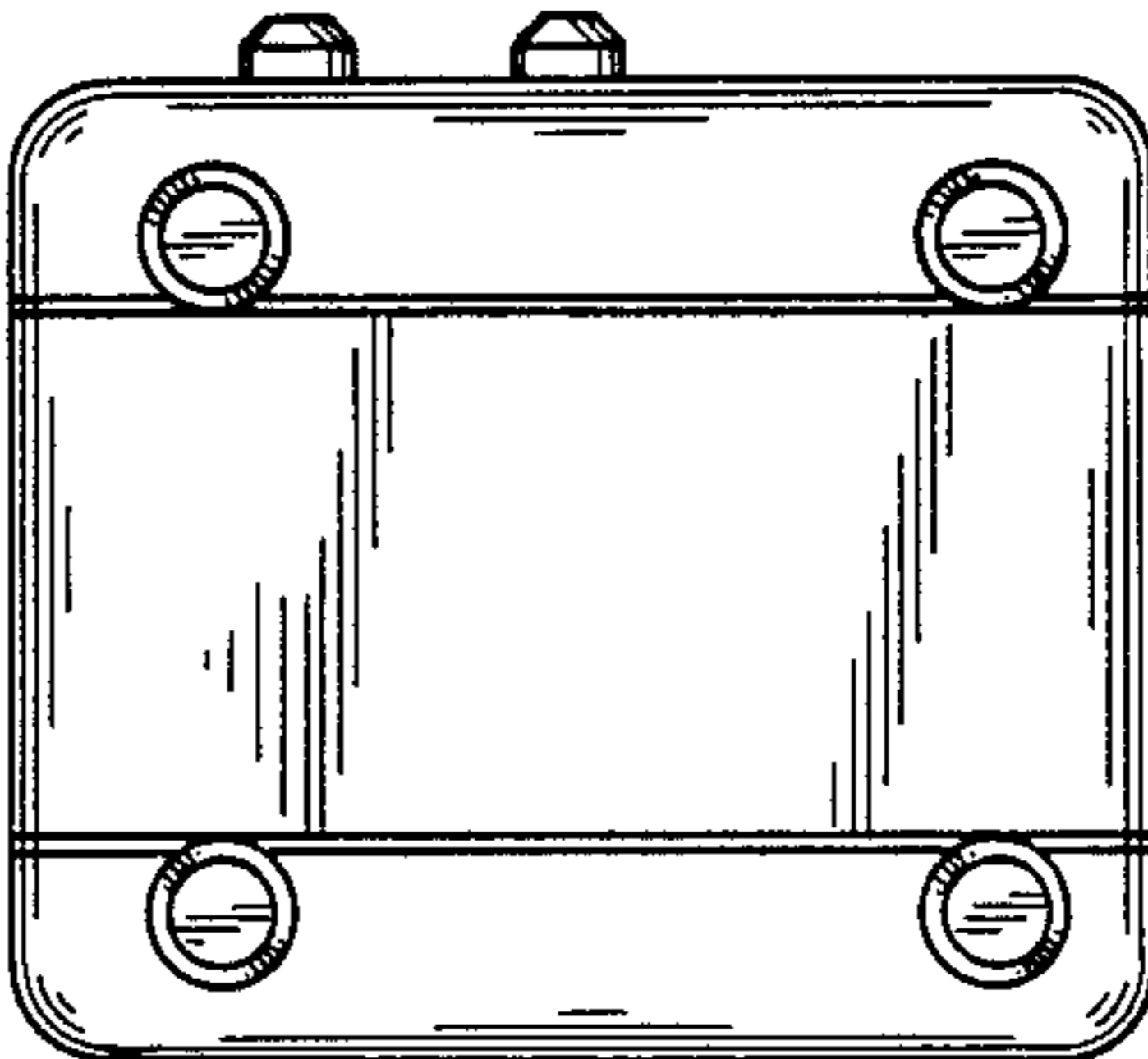
