The ornamental design for a clock with display area, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a clock with display area showing my new design;

FIG. 5 is a top plan view, with the bottom being a mirror image thereof.

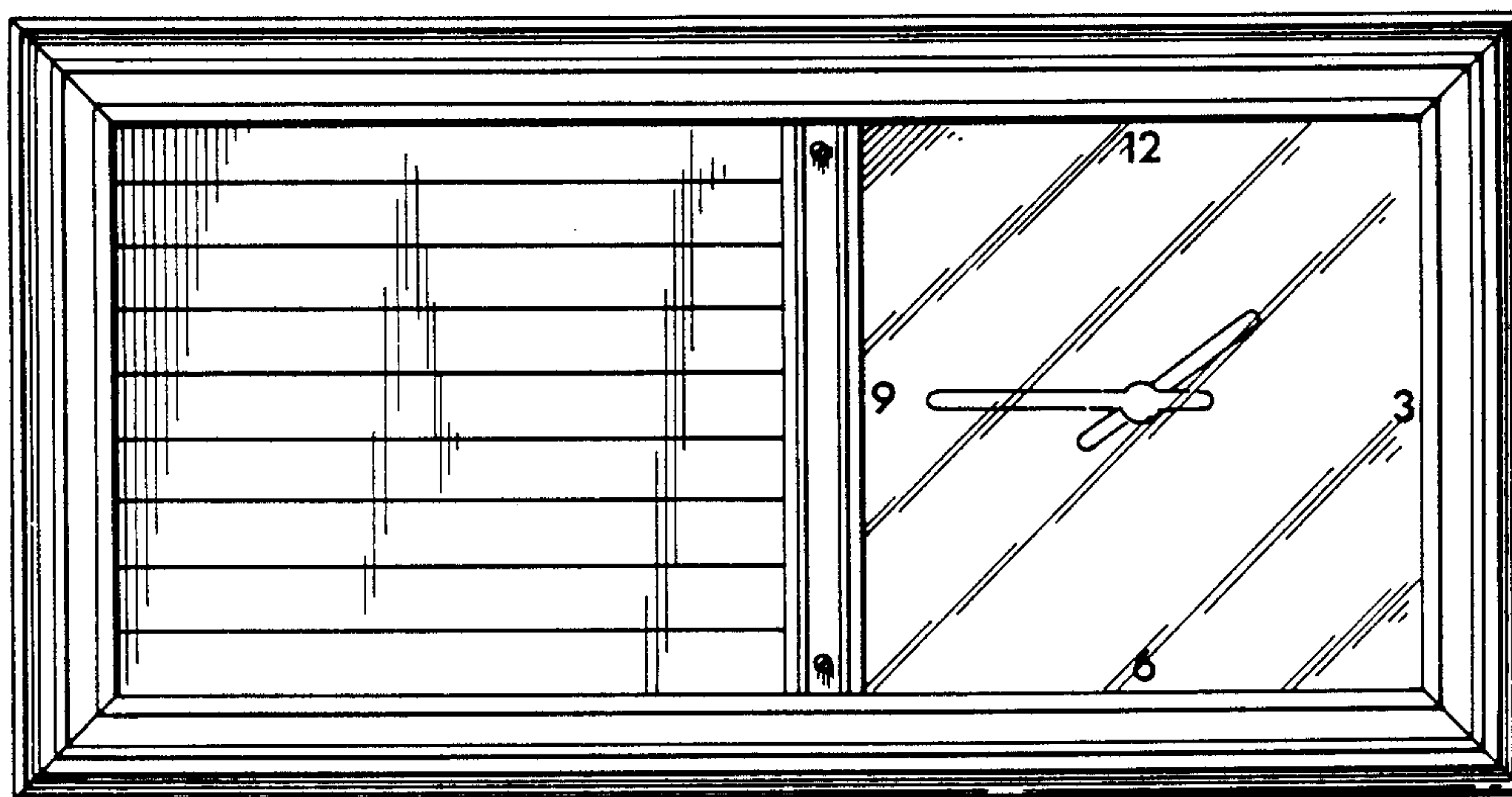

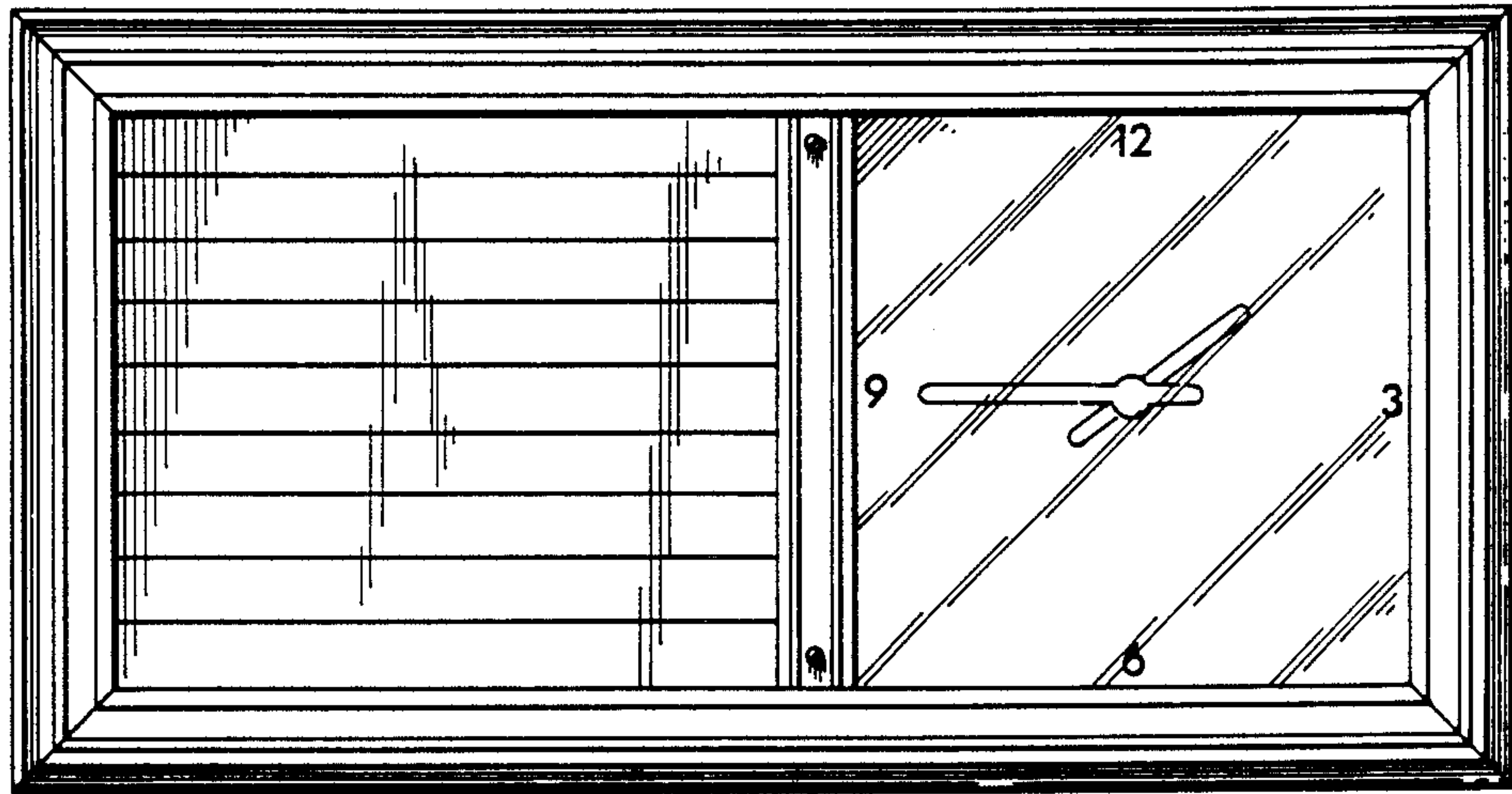
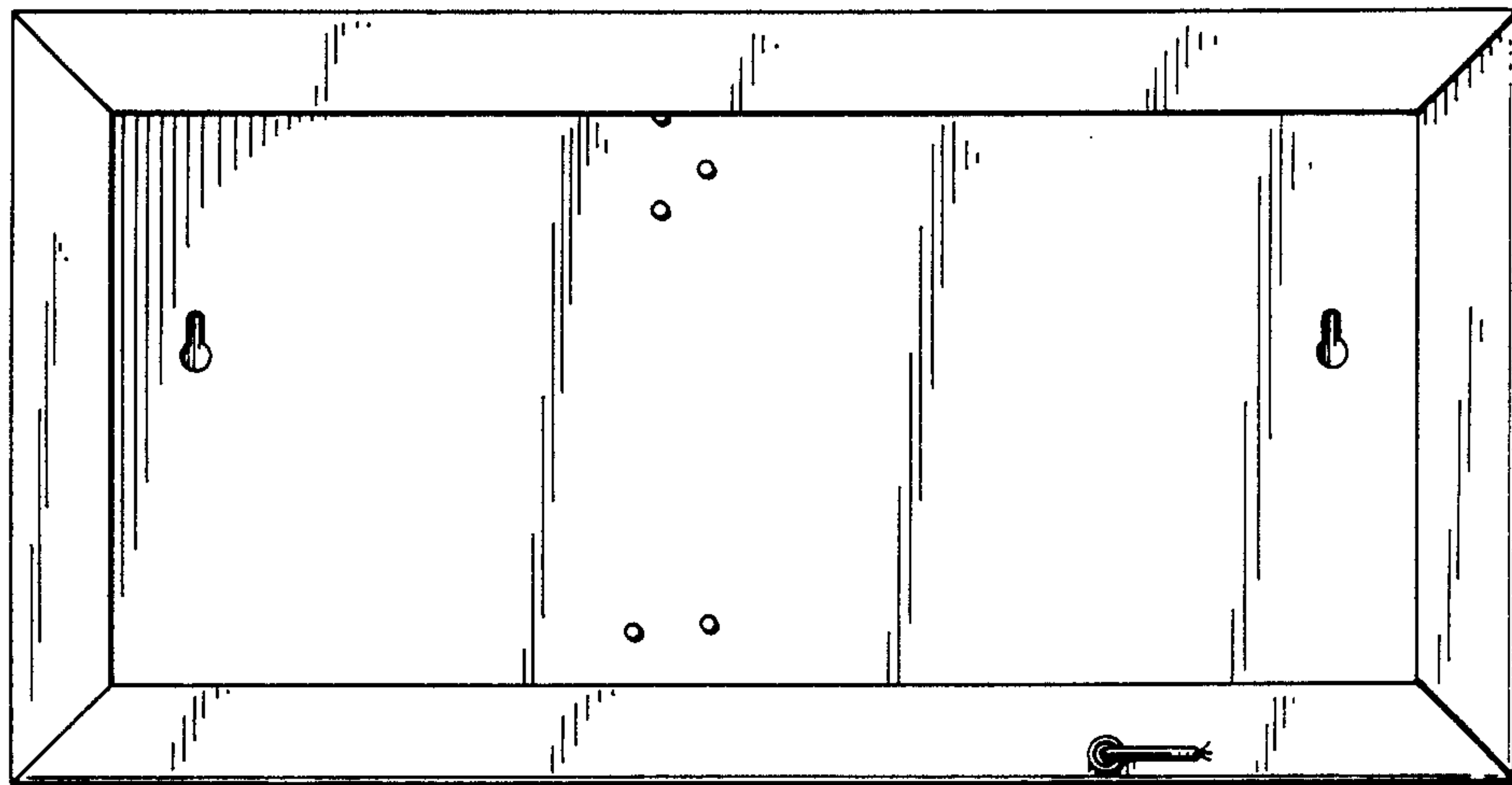

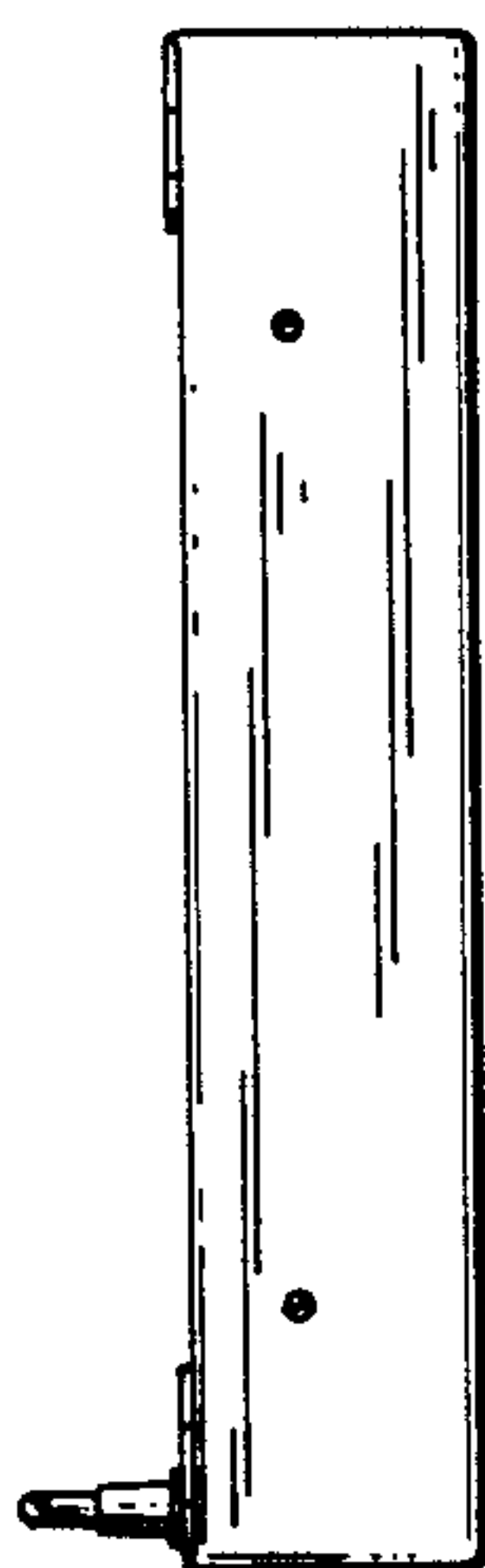

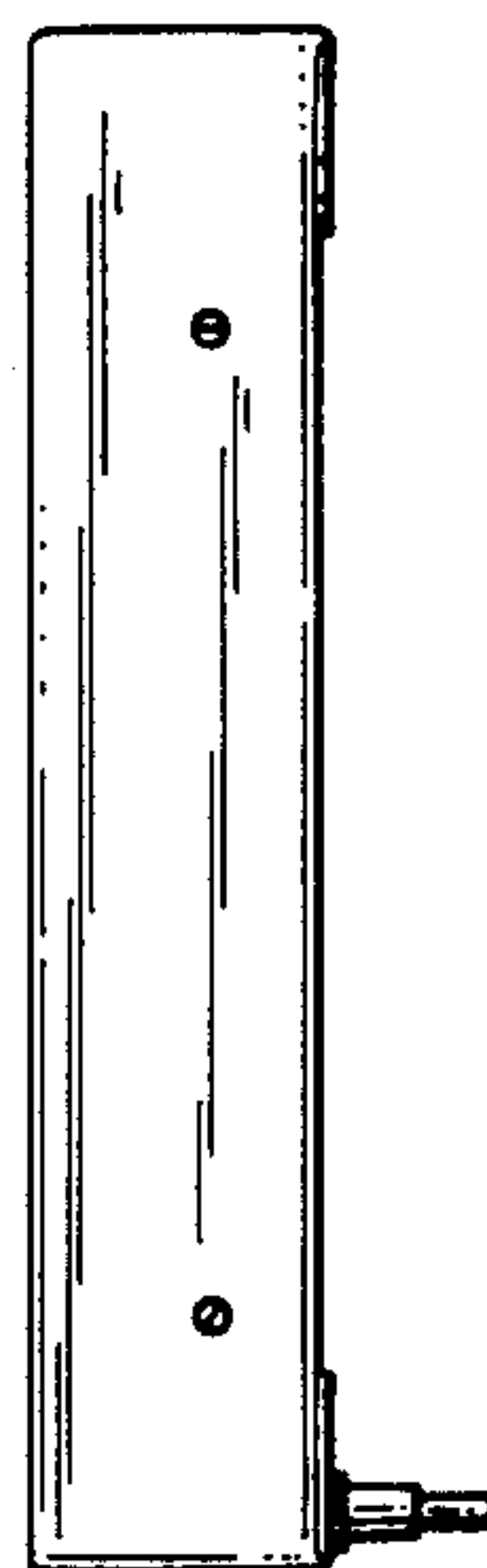
