The ornamental design for a covered pitcher or the like, as shown and described.

DESCRIPTION

FIG. 1 is a top, front perspective view of a covered pitcher or the like showing a first embodiment of our new design;

FIG. 13 is a top plan view of FIG. 8;

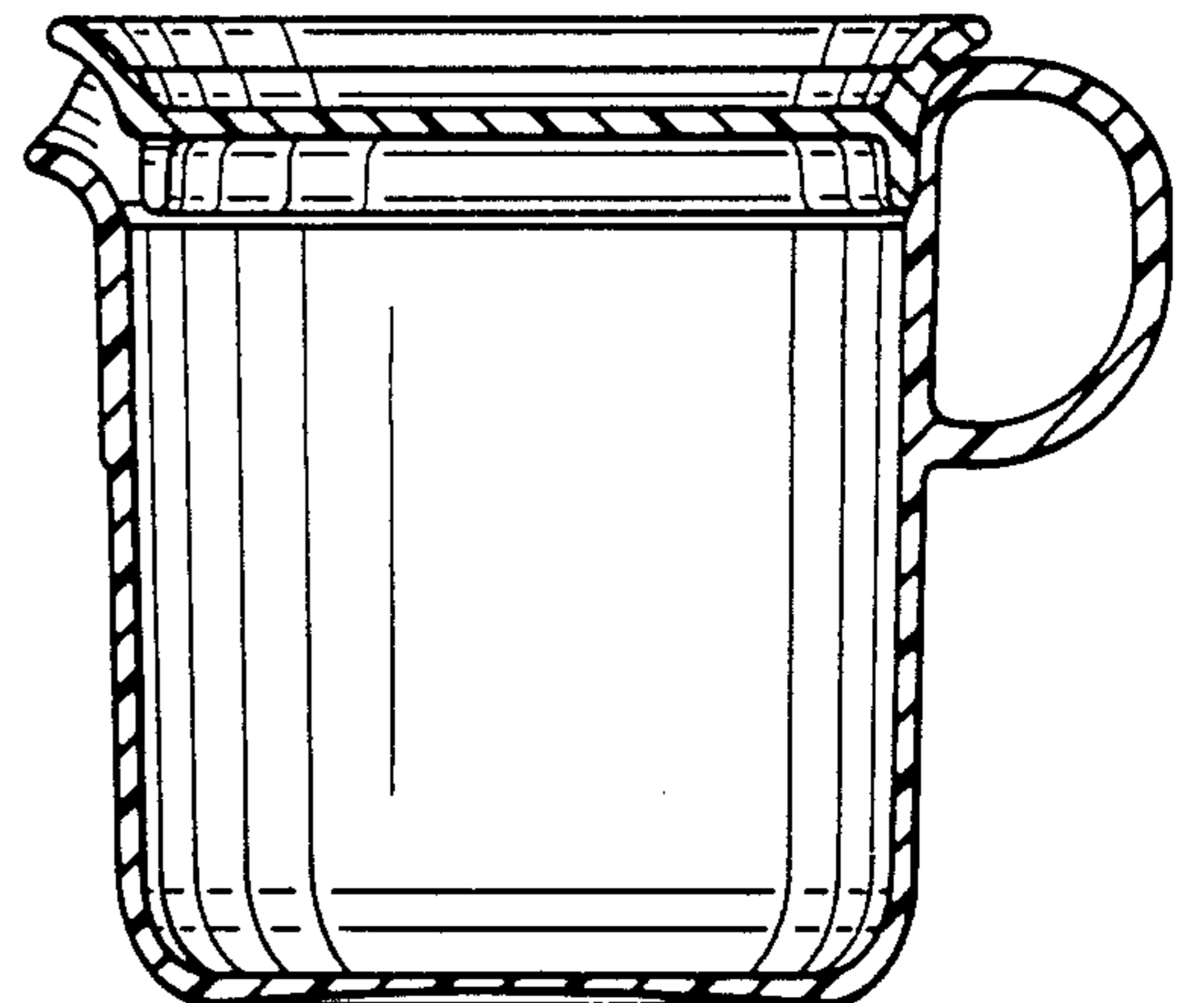
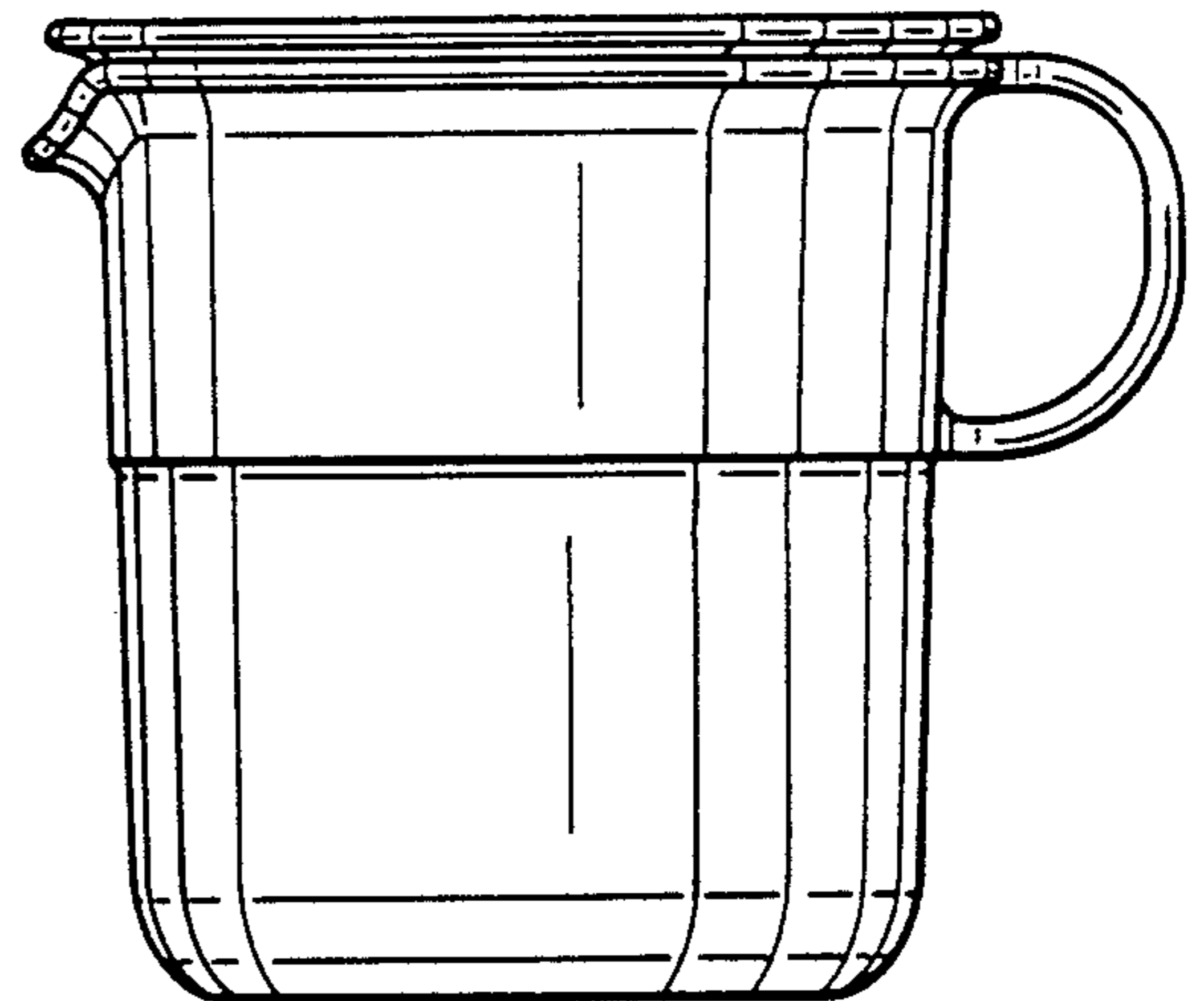
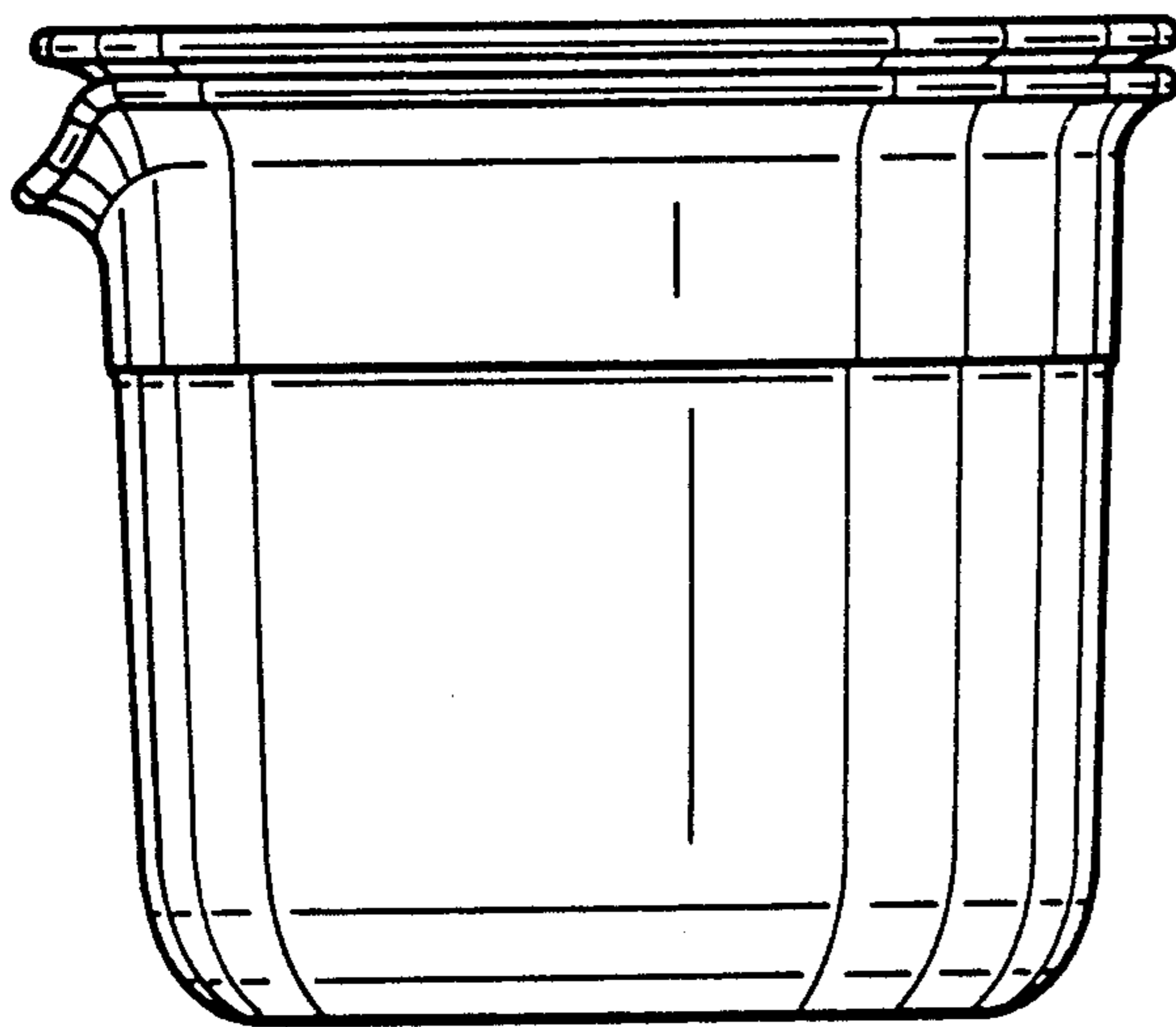
FIG. 14 is a bottom plan view of FIG. 8;

FIG. 18 is a cross-sectional view taken along line 18—18 of FIG. 13.



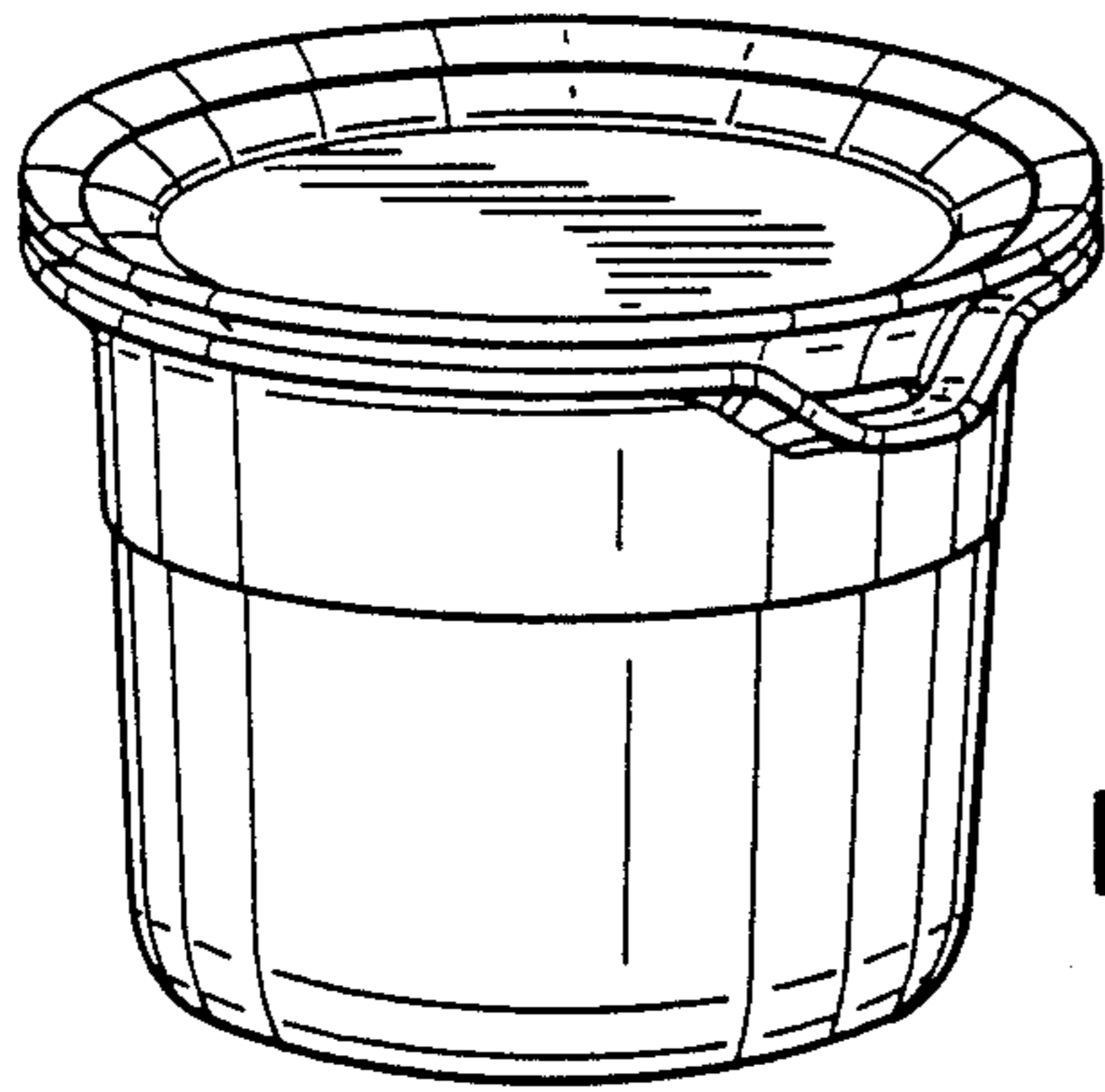

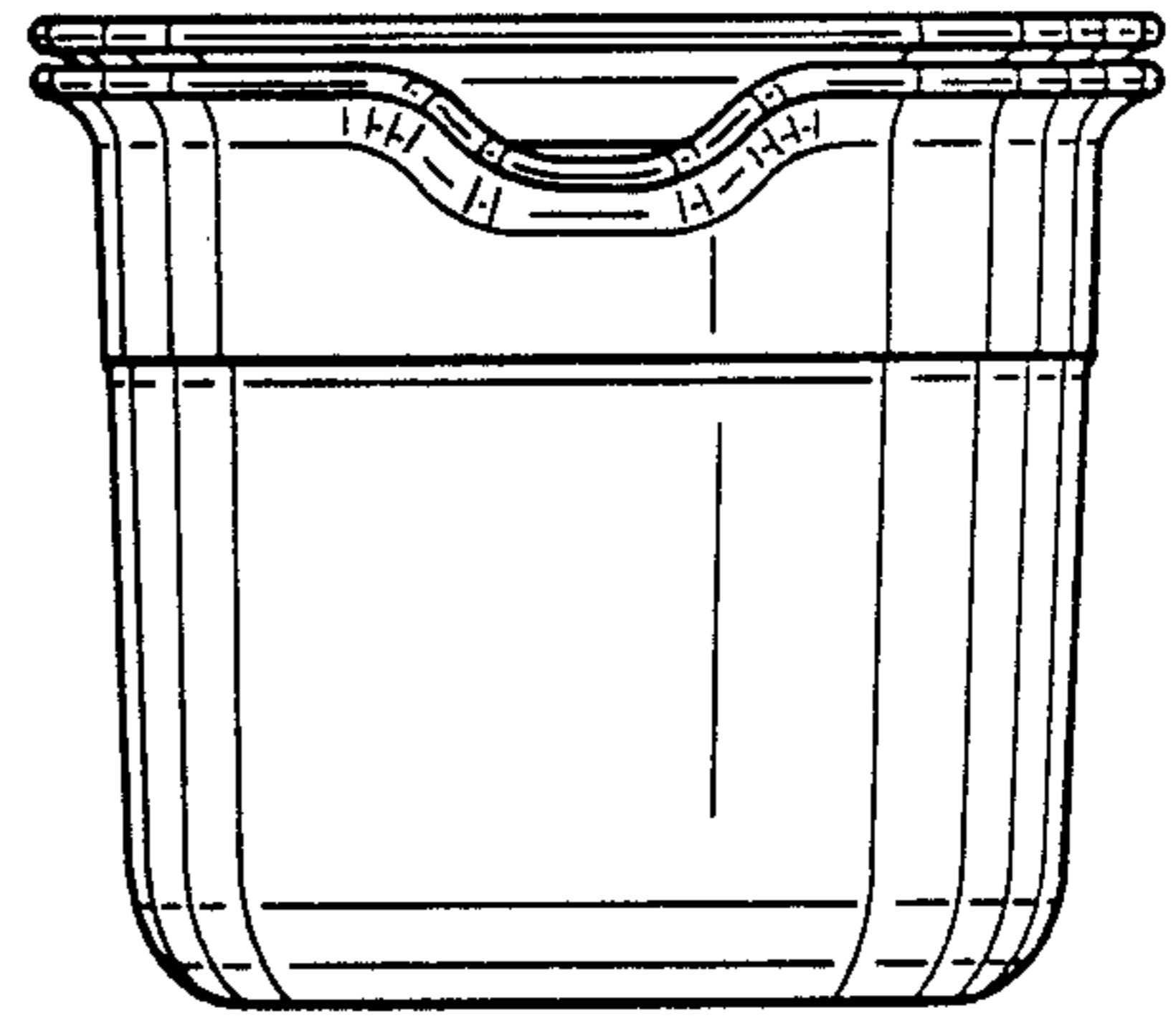

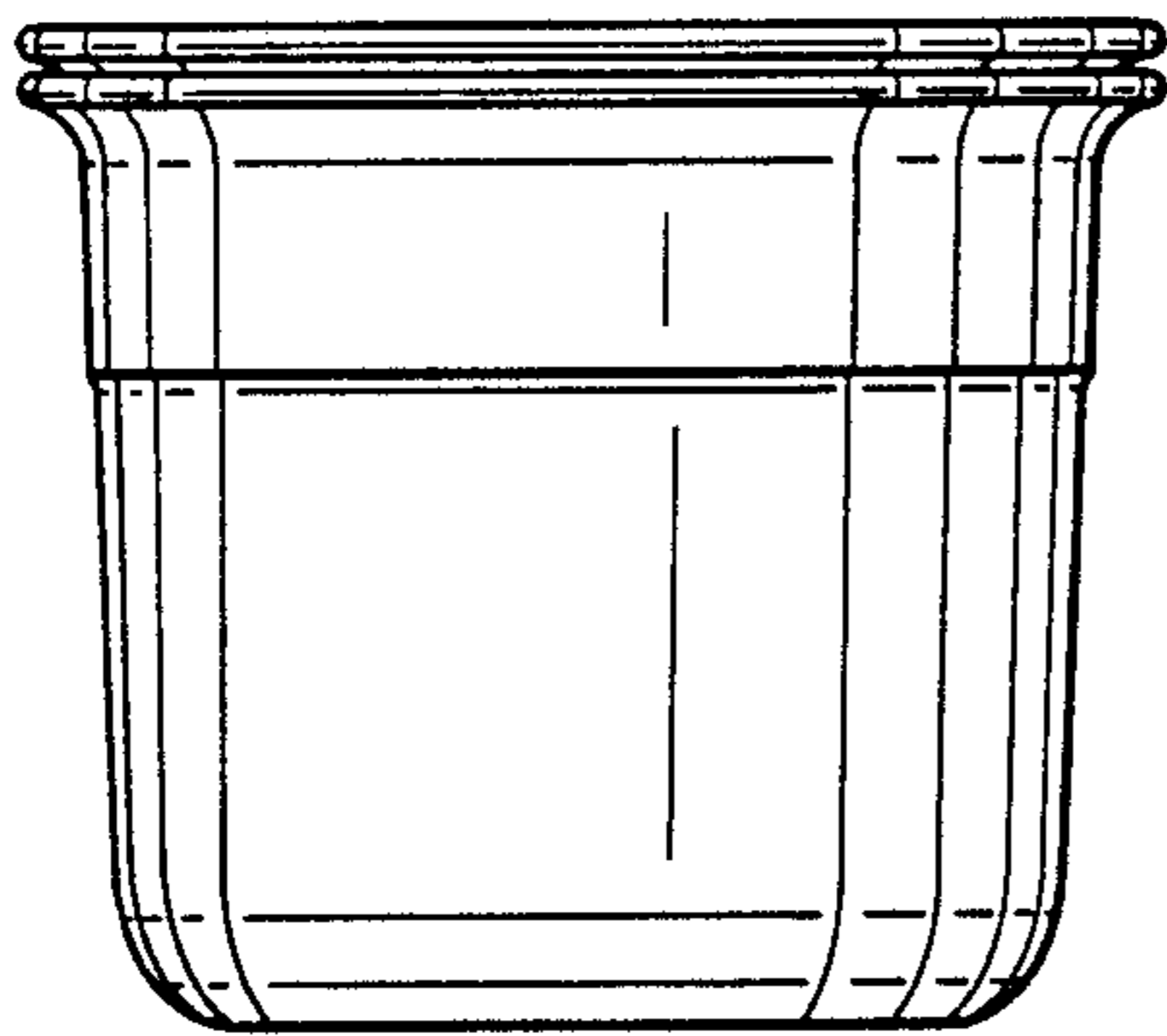

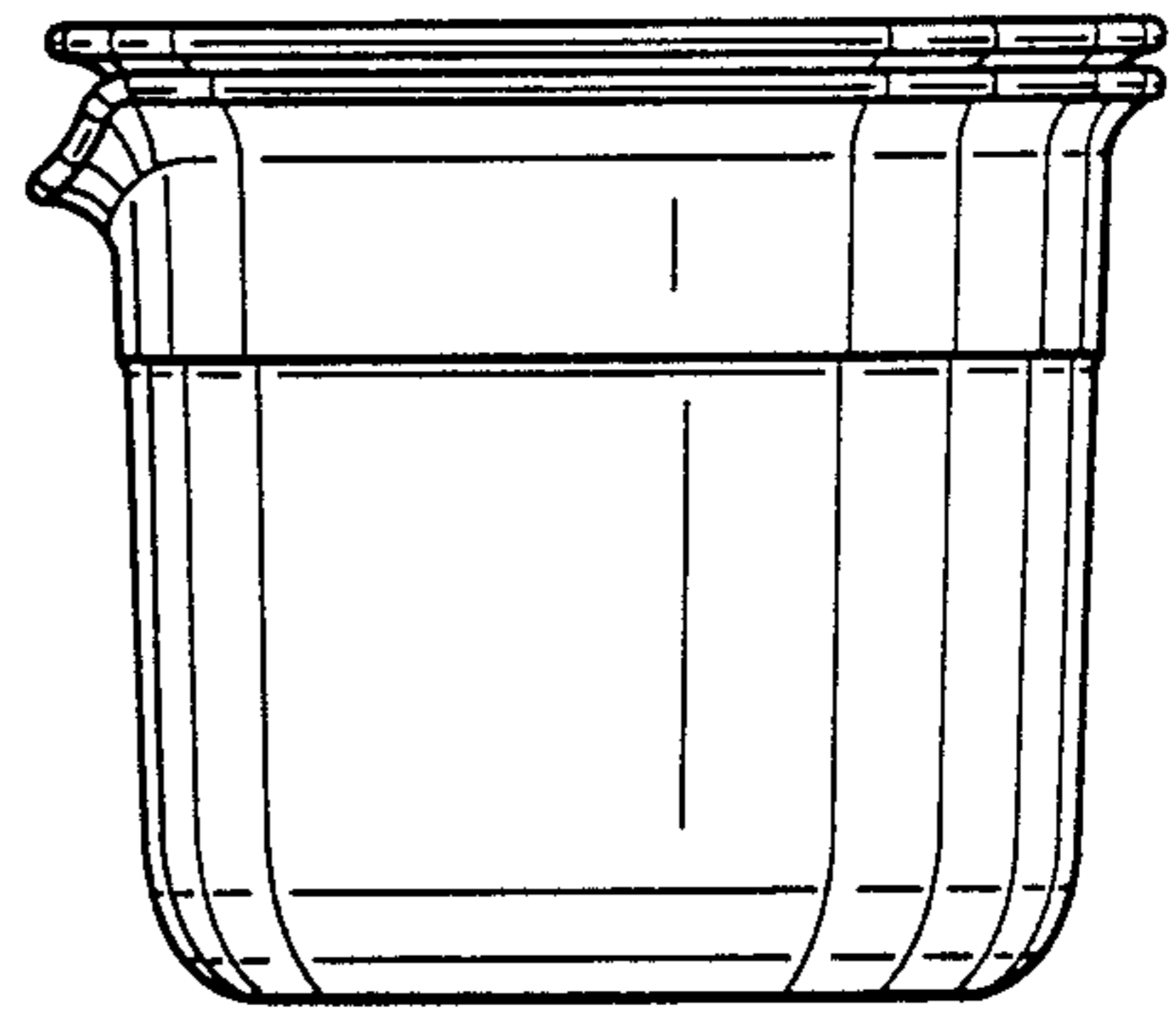

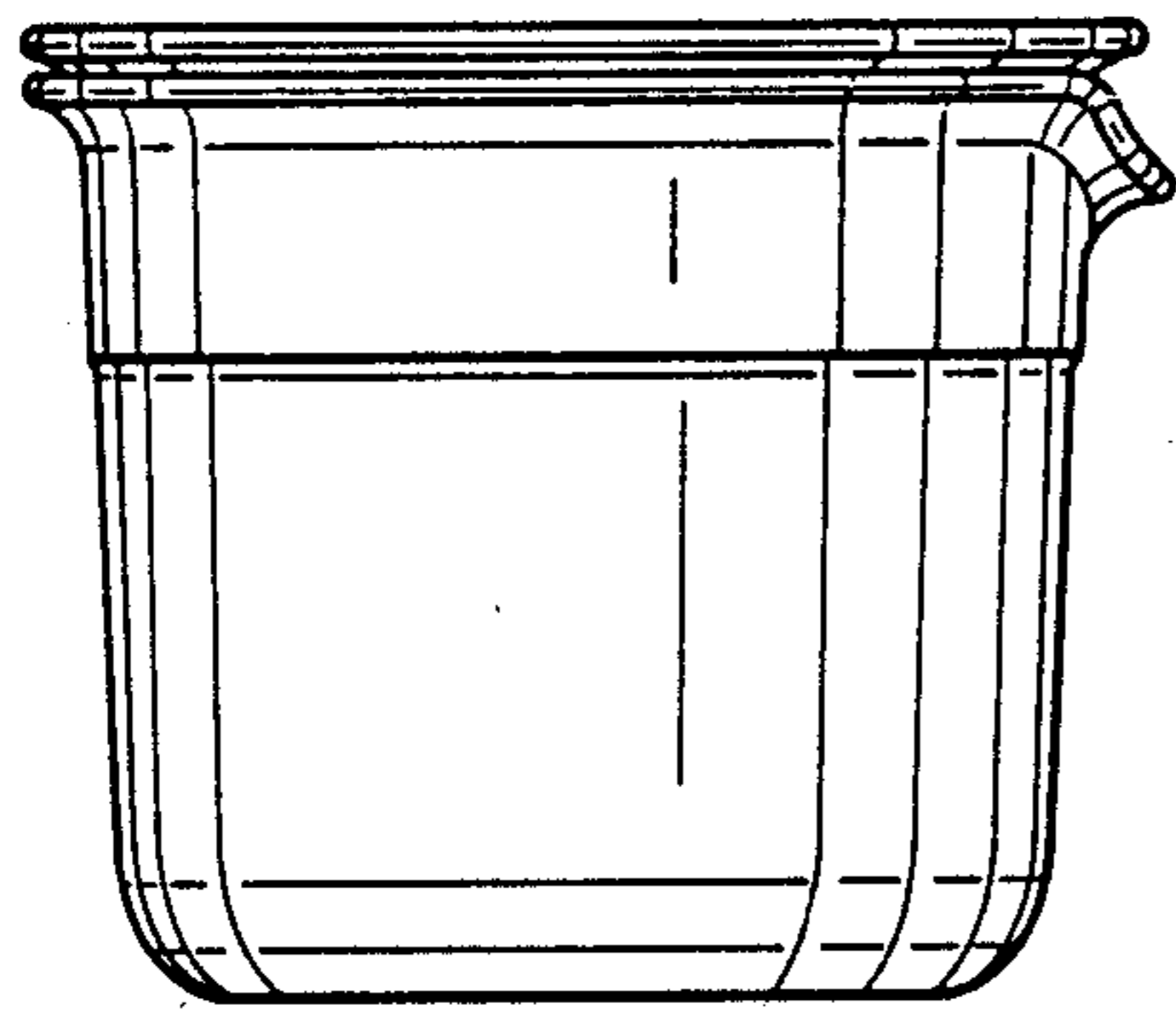

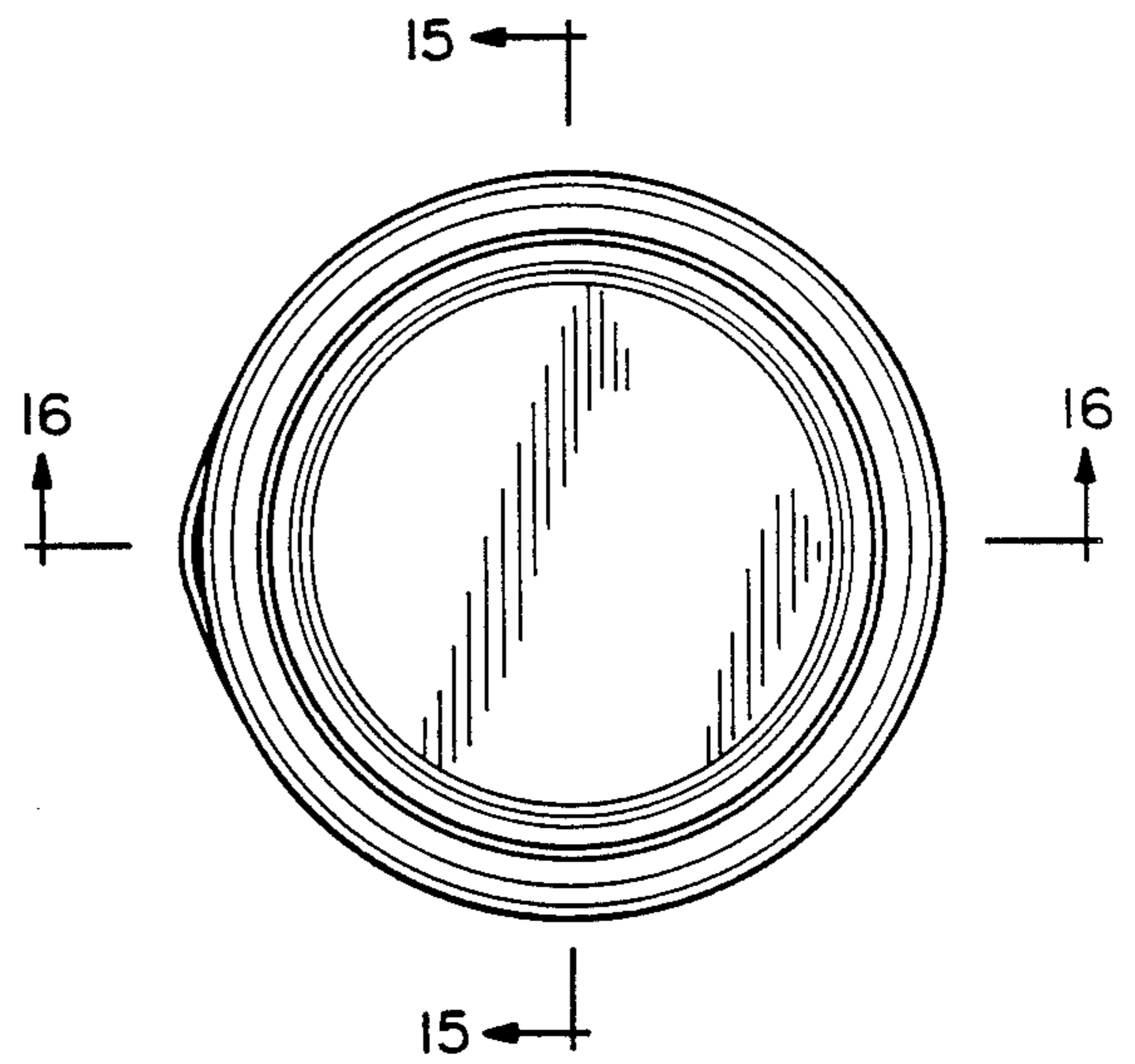

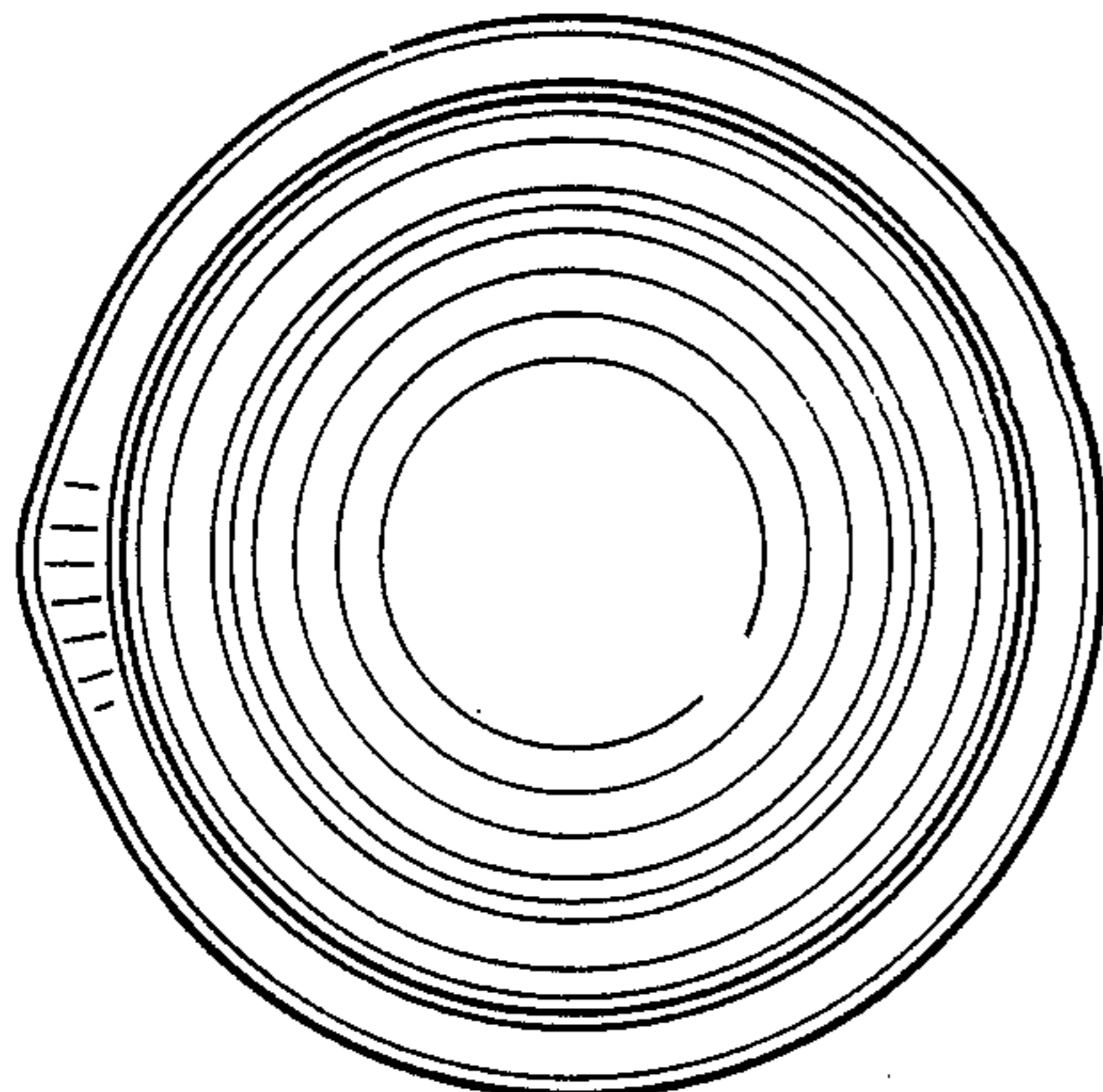

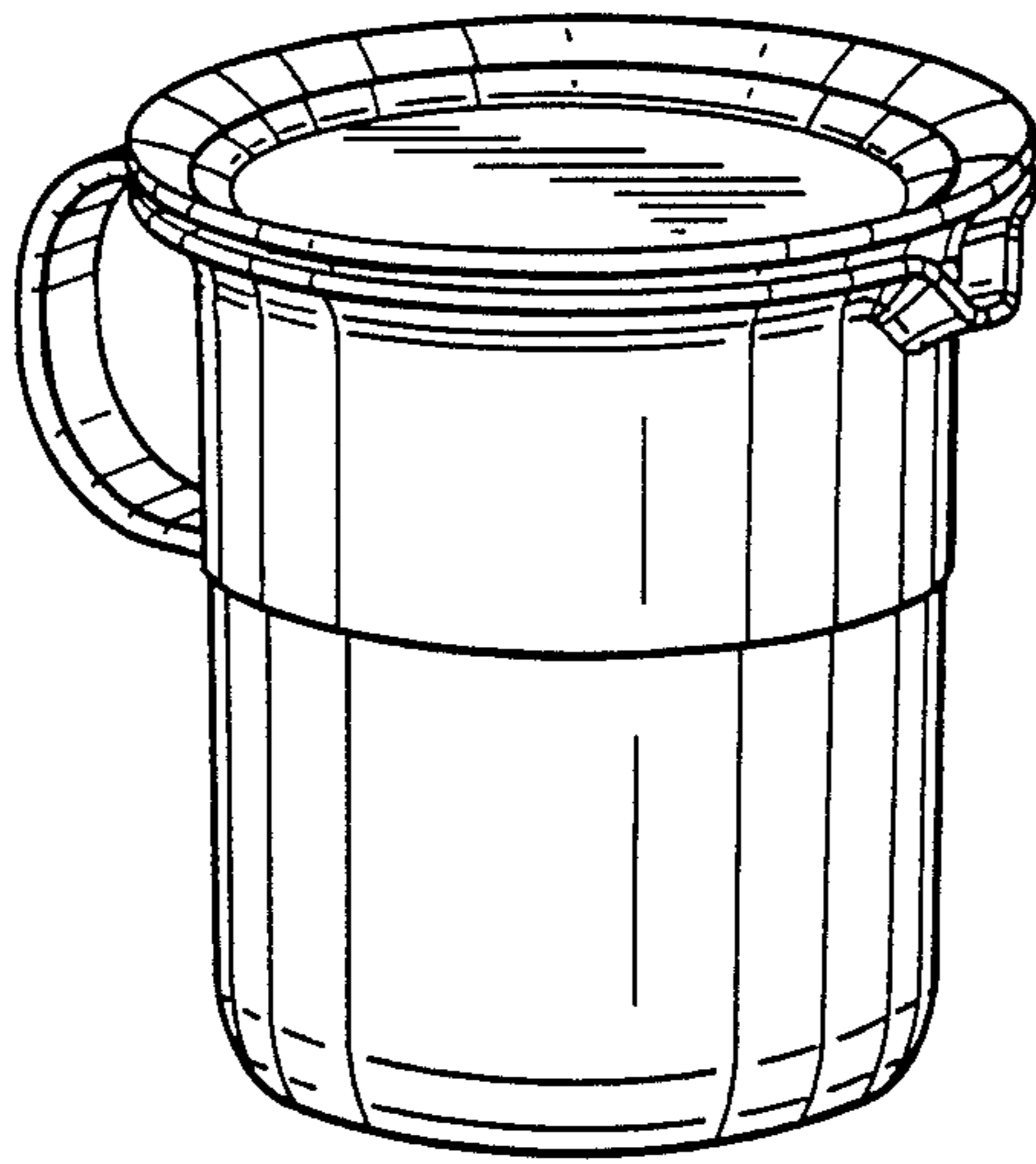

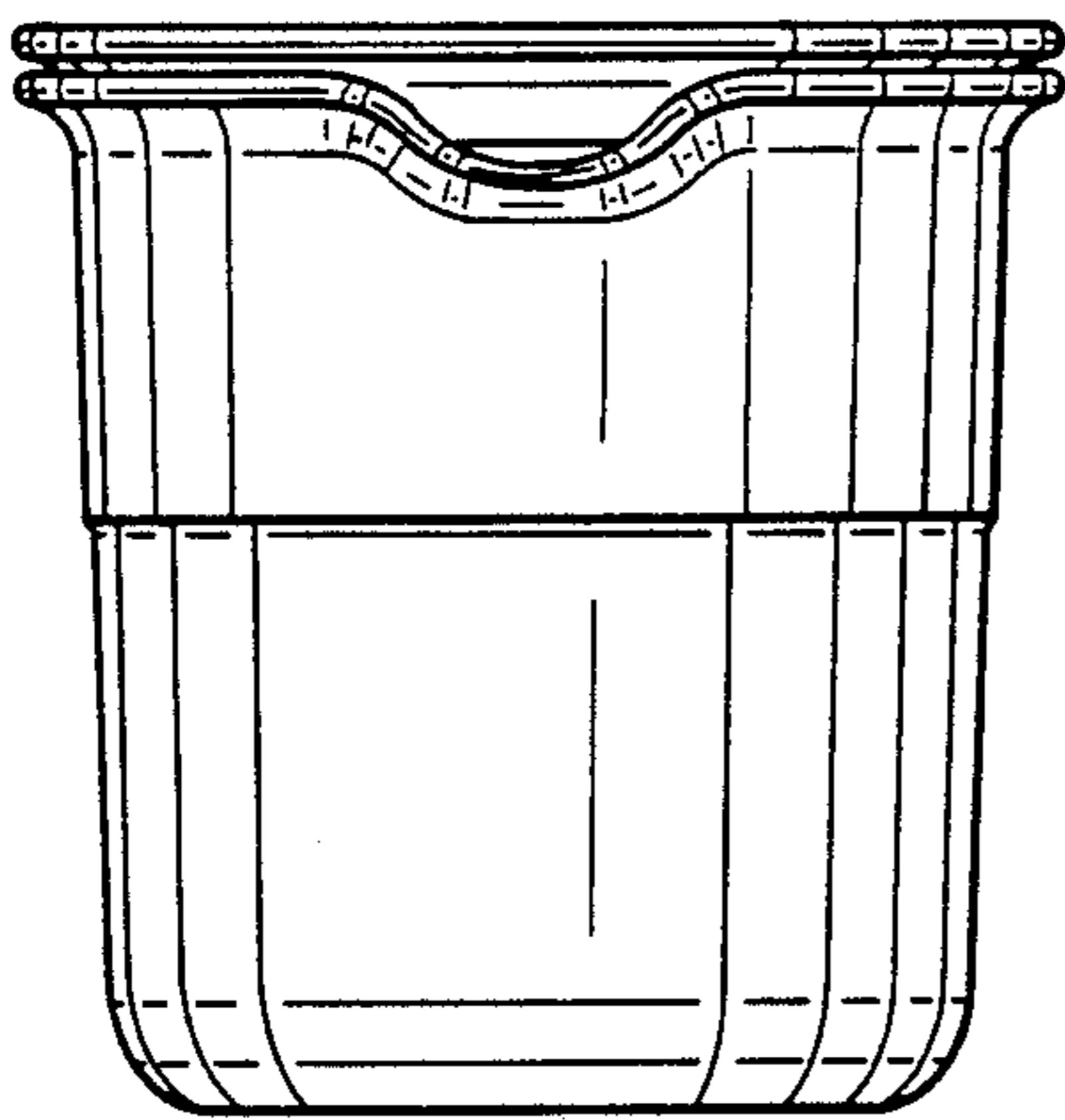

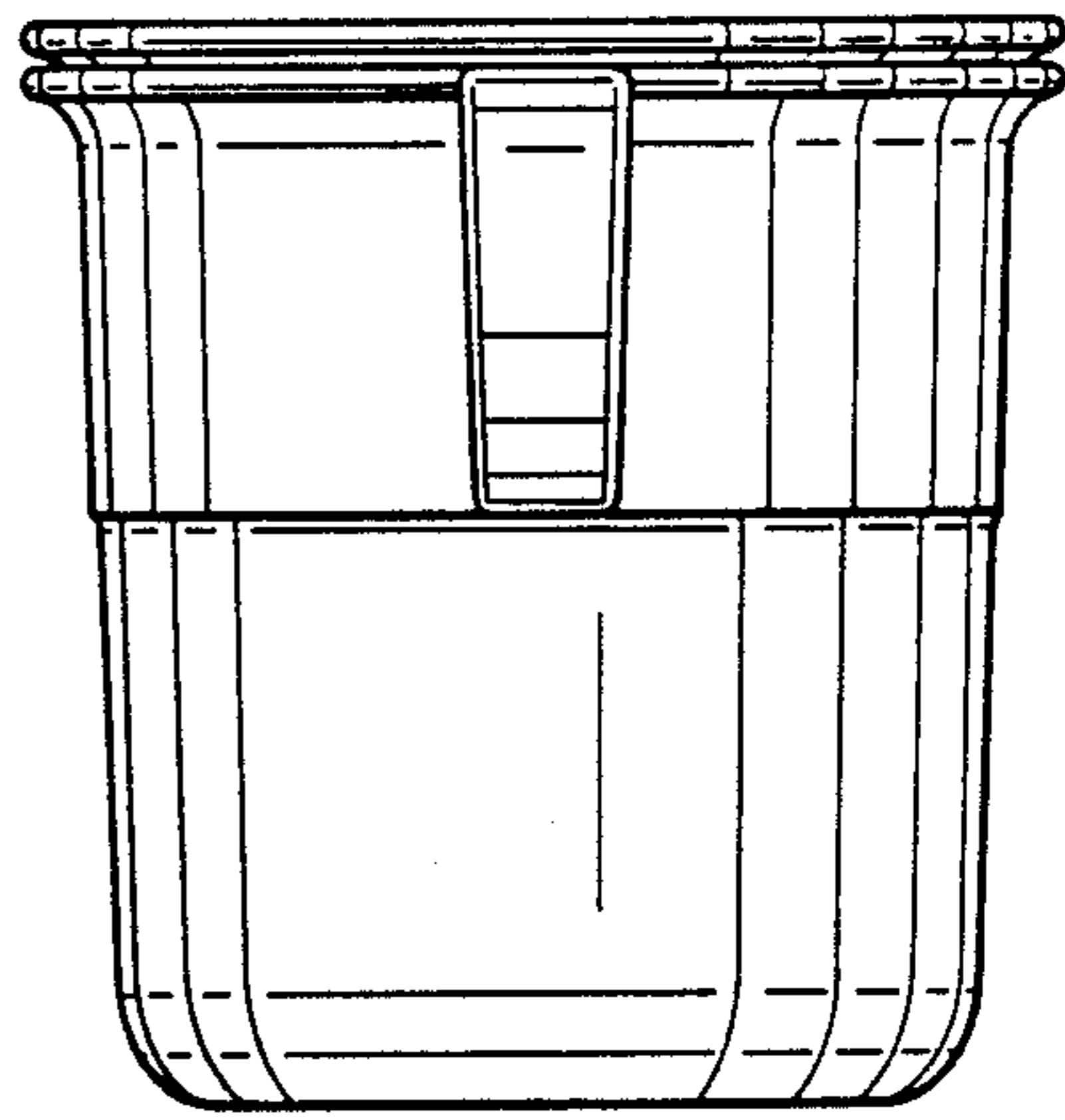

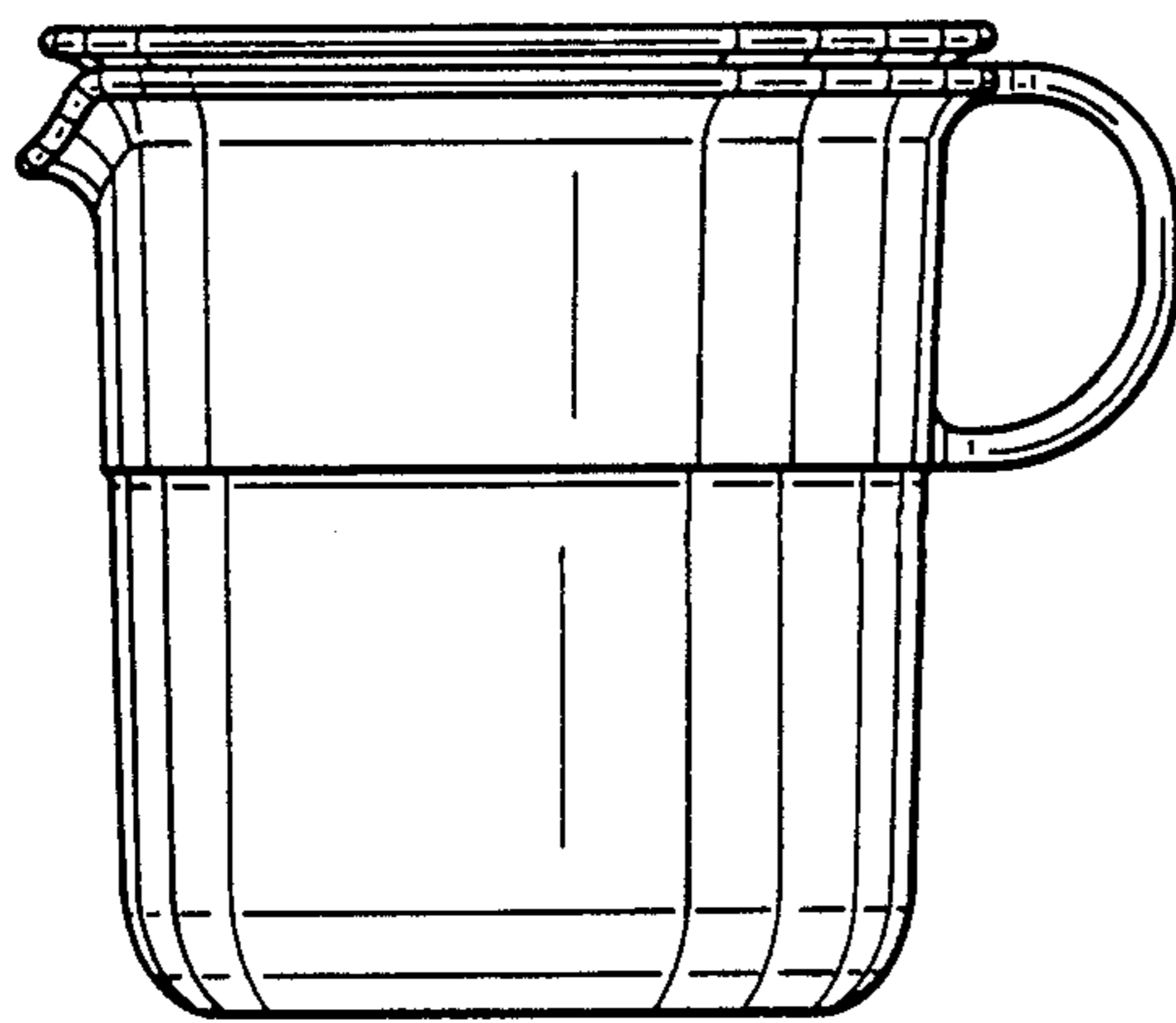

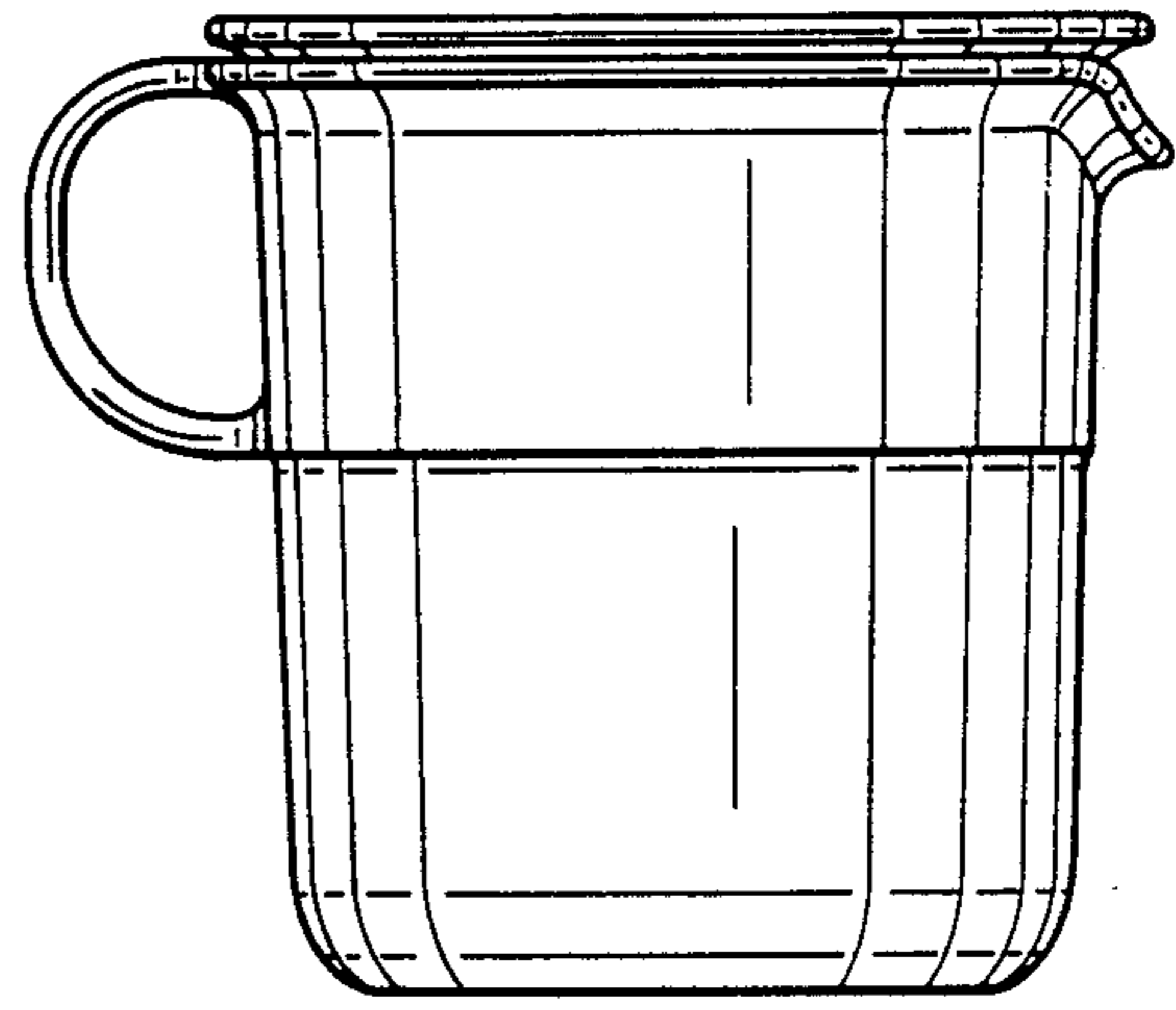

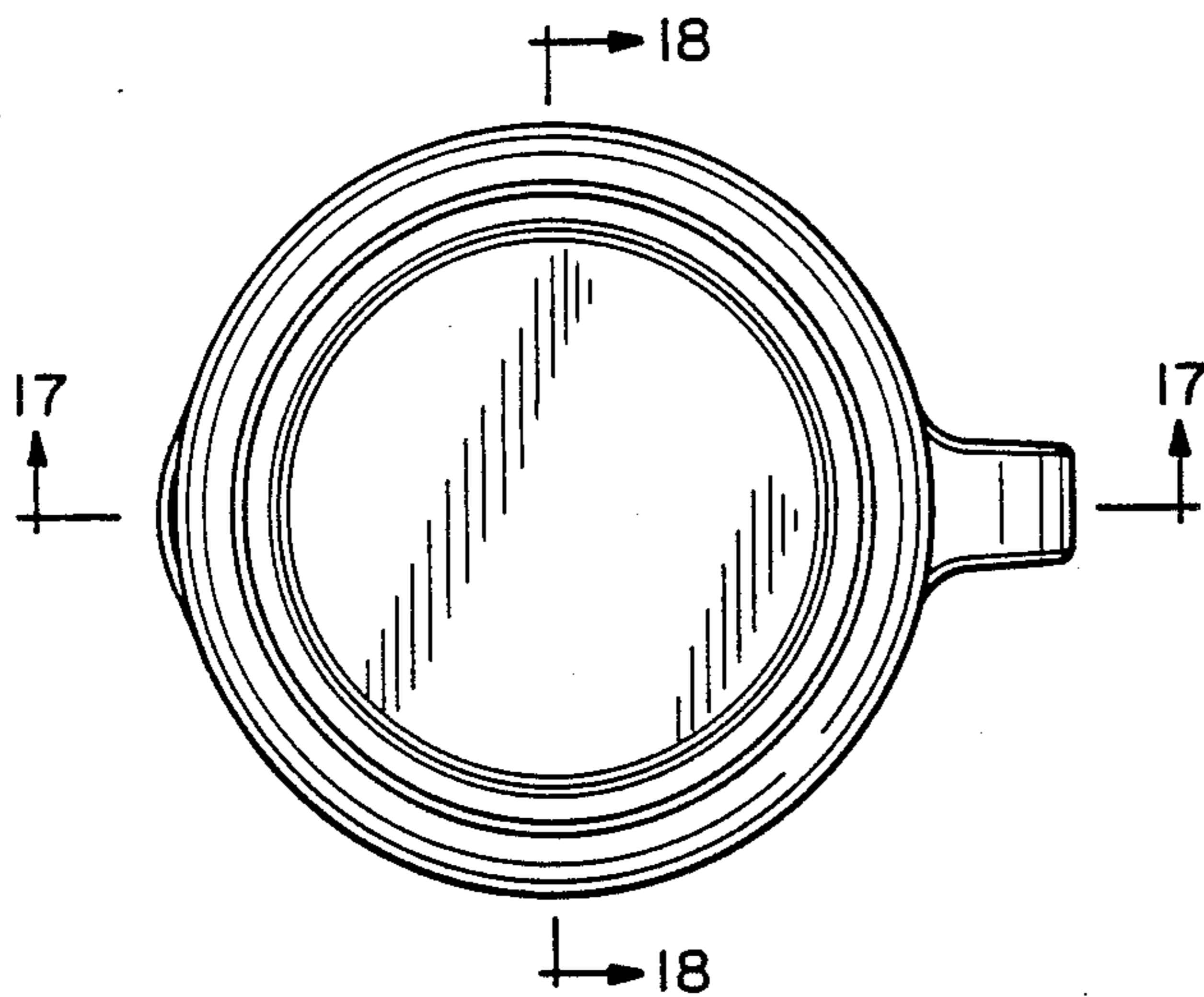

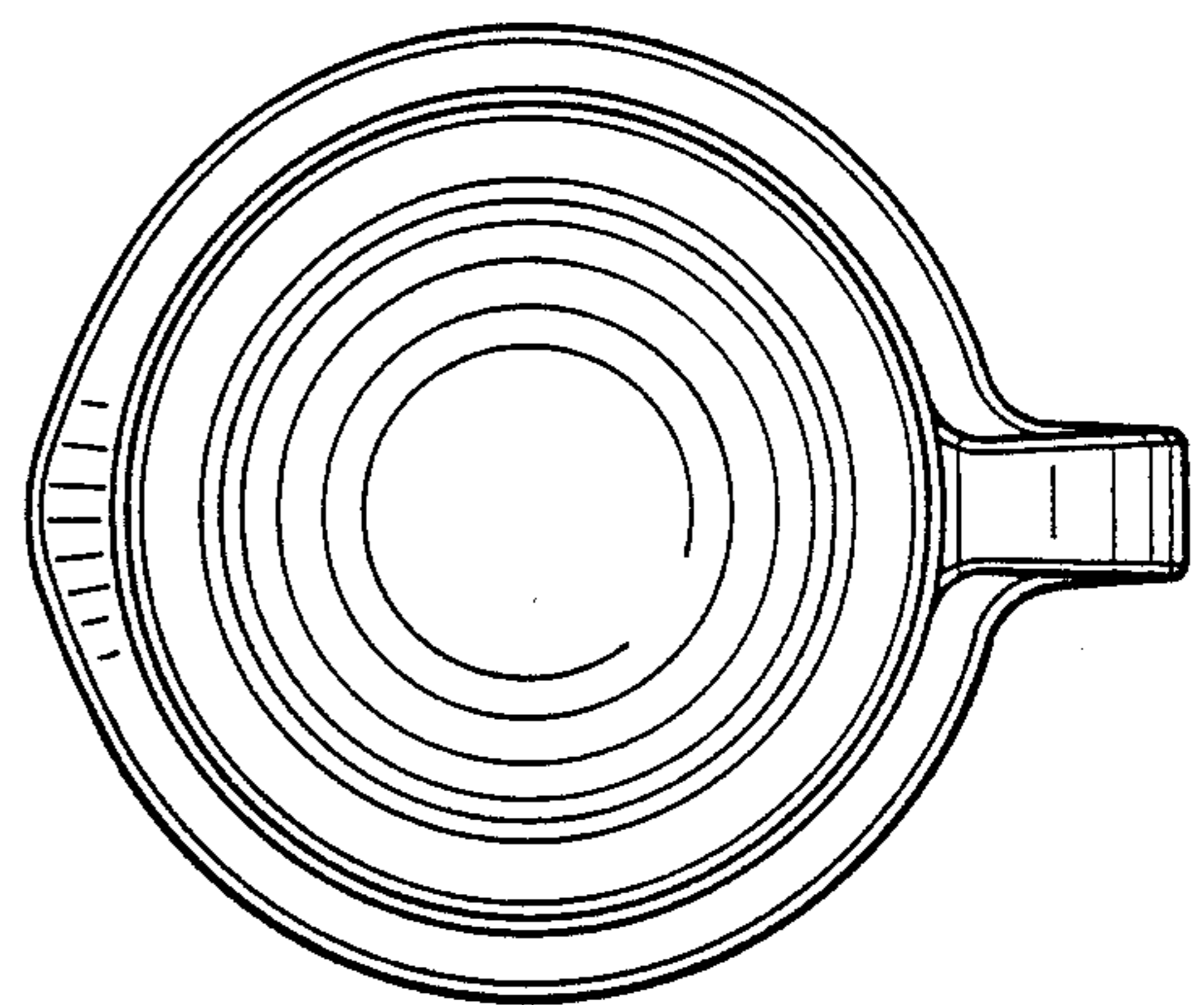

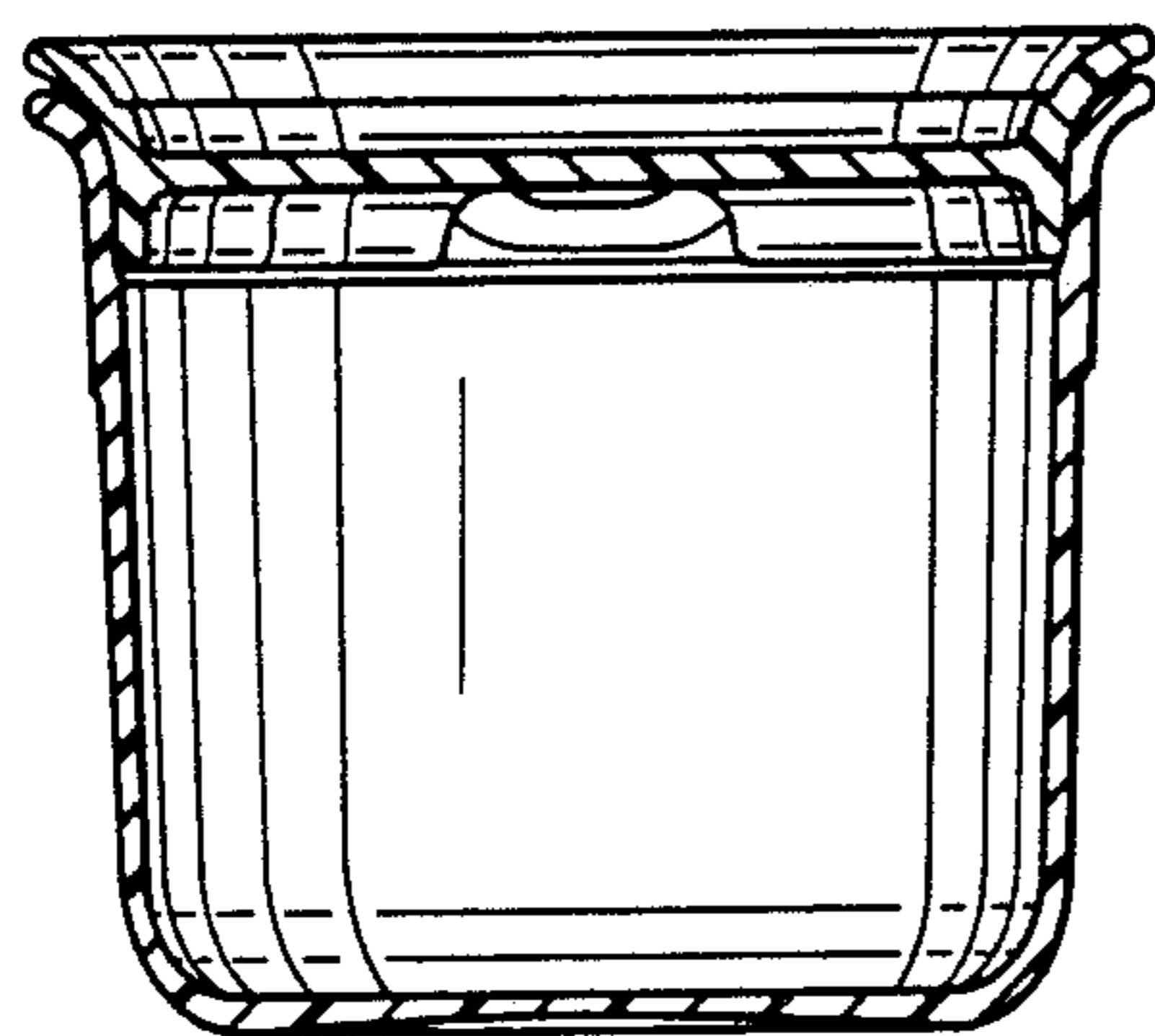

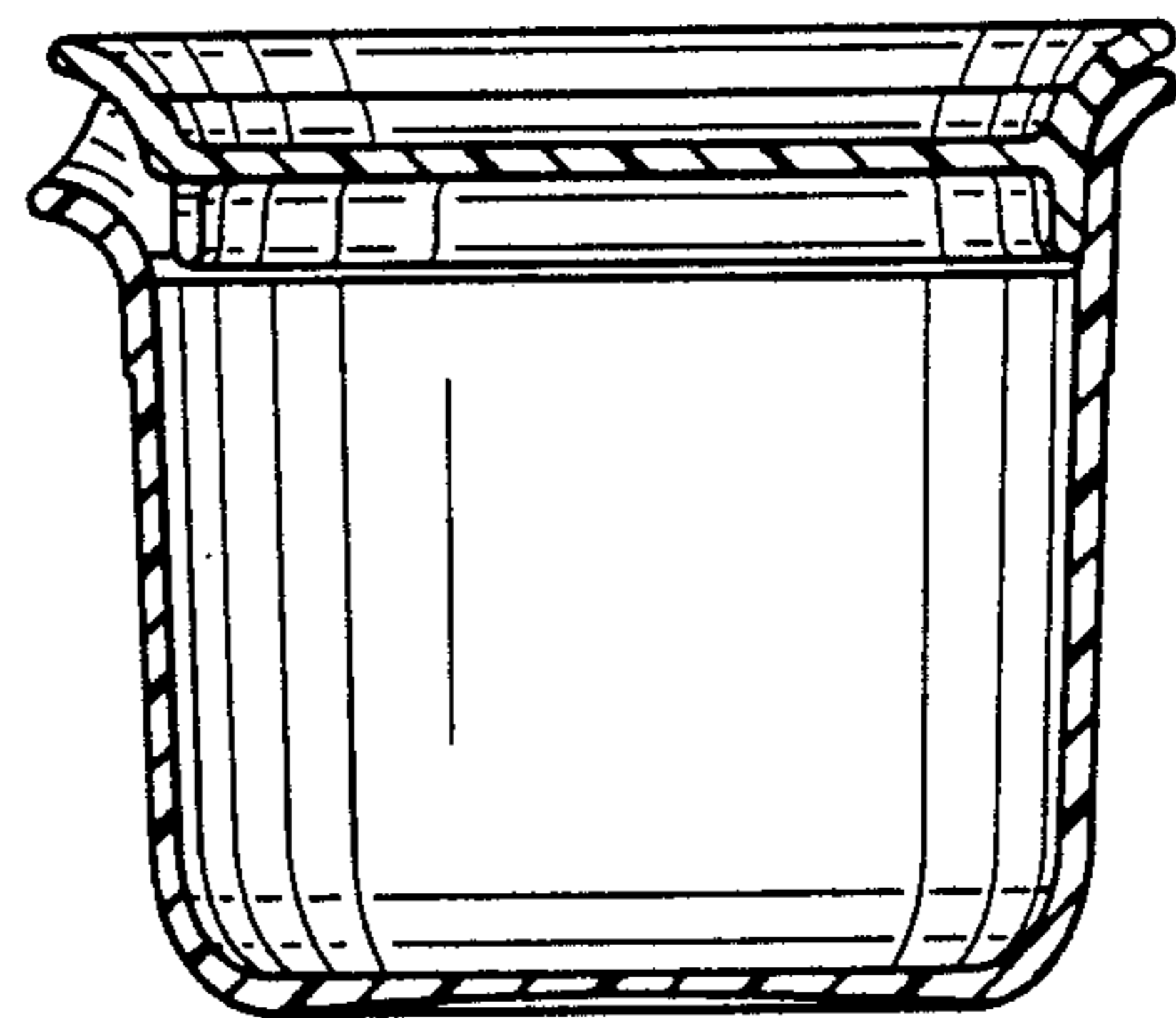

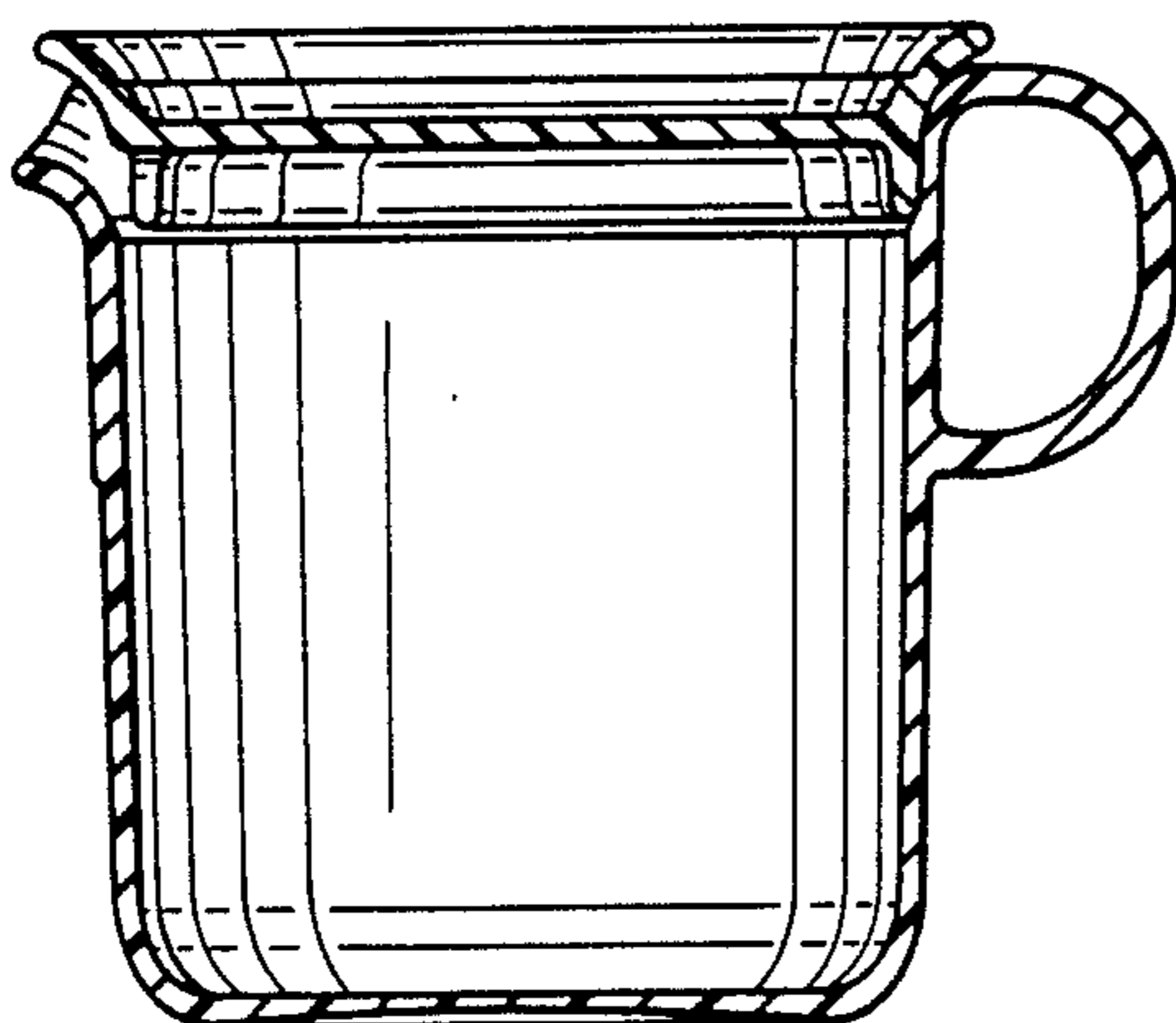

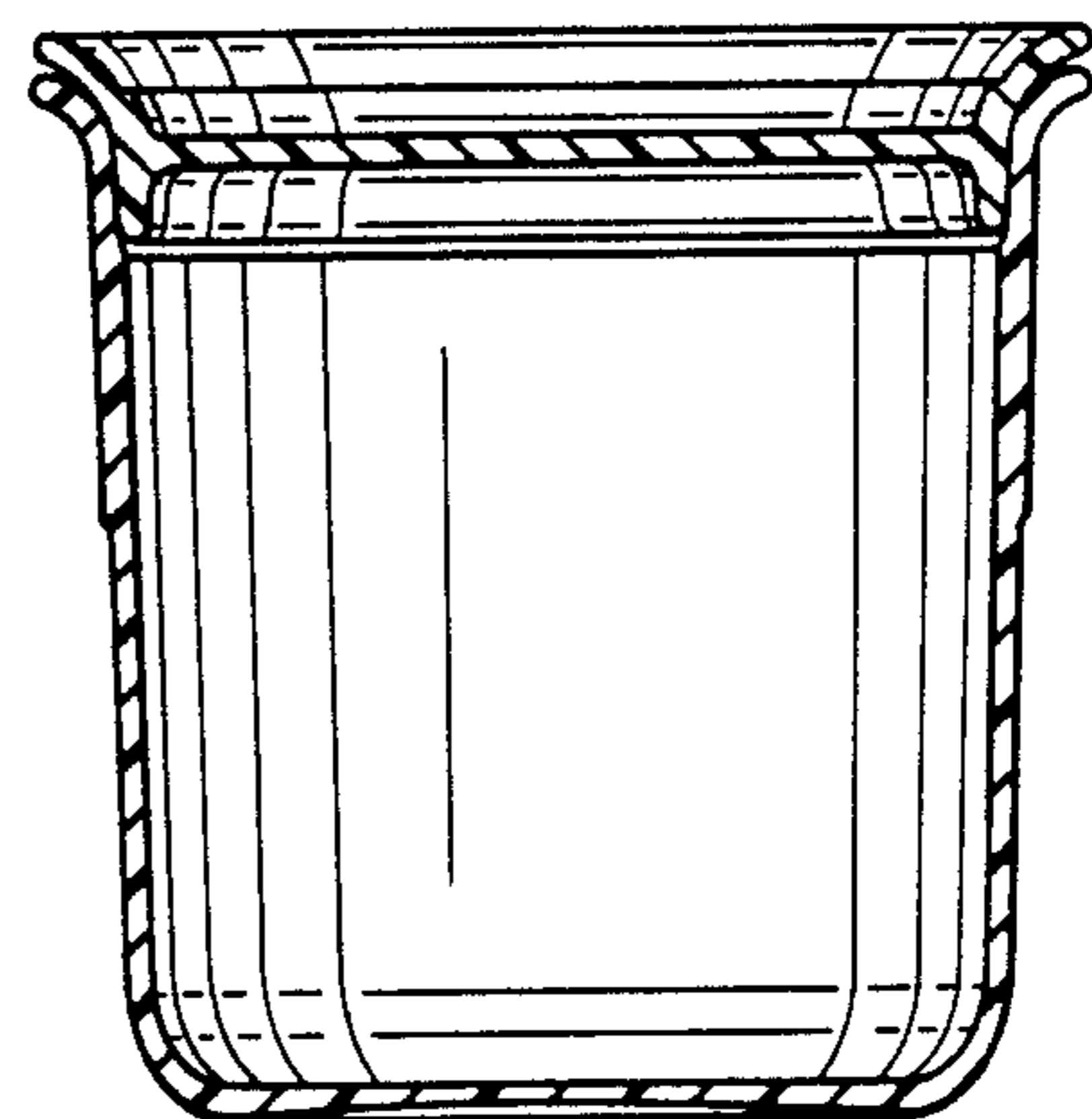
