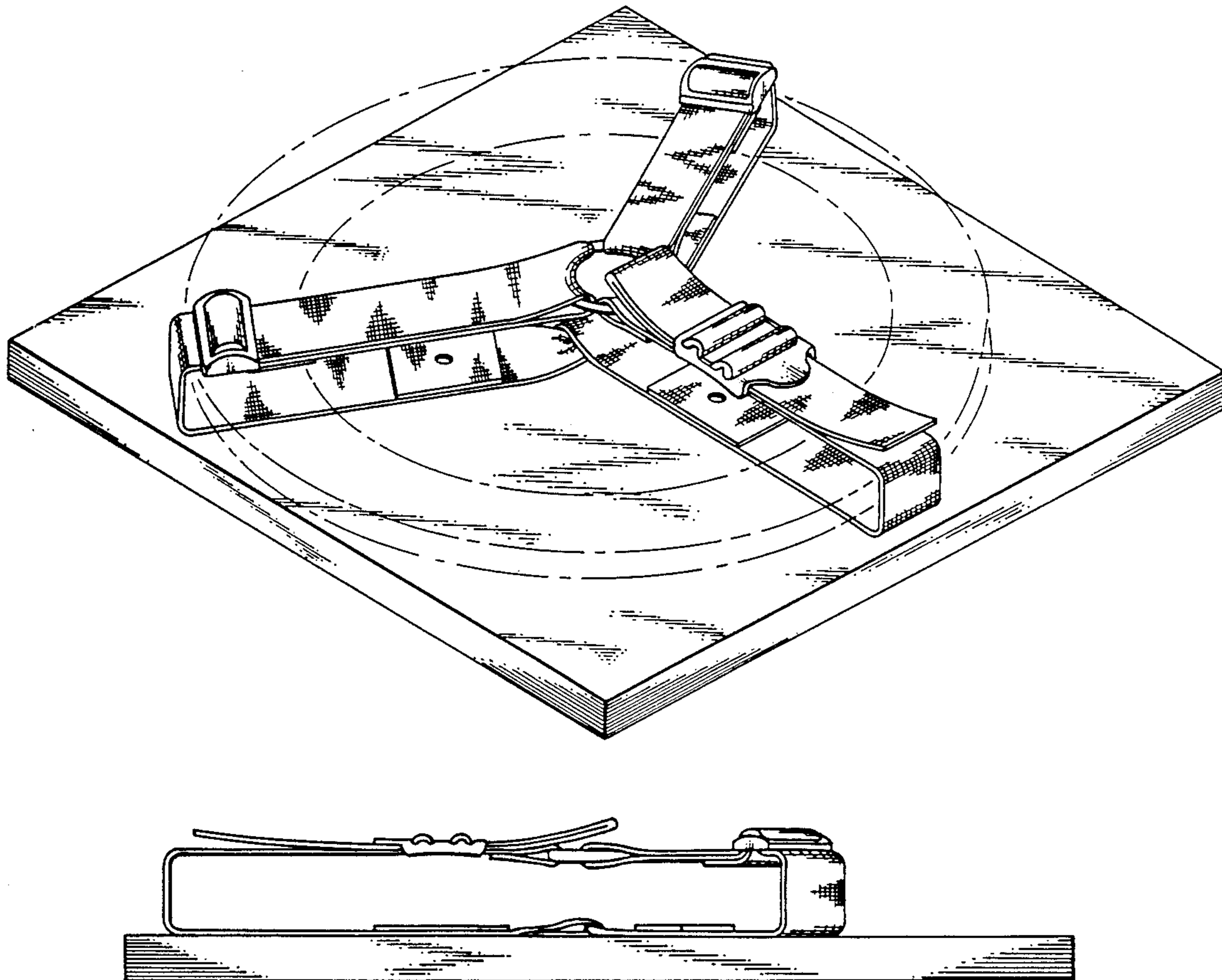

FIG. 1 is a perspective view of a combined flexible web, buckles and mounting panel for immobilizing objects; FIG. 2 is a front elevational view thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is a bottom end elevational view thereof; FIG. 5 is a top end elevational view thereof; FIG. 6 is an elevational view of one side thereof, the opposite side being a mirror image of the figure shown; FIG. 7 is a perspective view of a modification thereof; FIG. 8 is a front elevational view of the modification; FIG. 9 is a top end elevational view of the modification, the bottom end elevational view being a mirror image of the figure shown; FIG. 10 is an elevational view of the left-hand side of the article, as it appears in FIG. 8; FIG. 11 is an elevational view of the right-hand side of the article as it appears in FIG. 8; and, FIG. 12 is a rear elevational view of the modification. The broken line representations of a platter in FIG. 1 and tins in FIG. 7 are shown to illustrate the environment and form no part of the design.



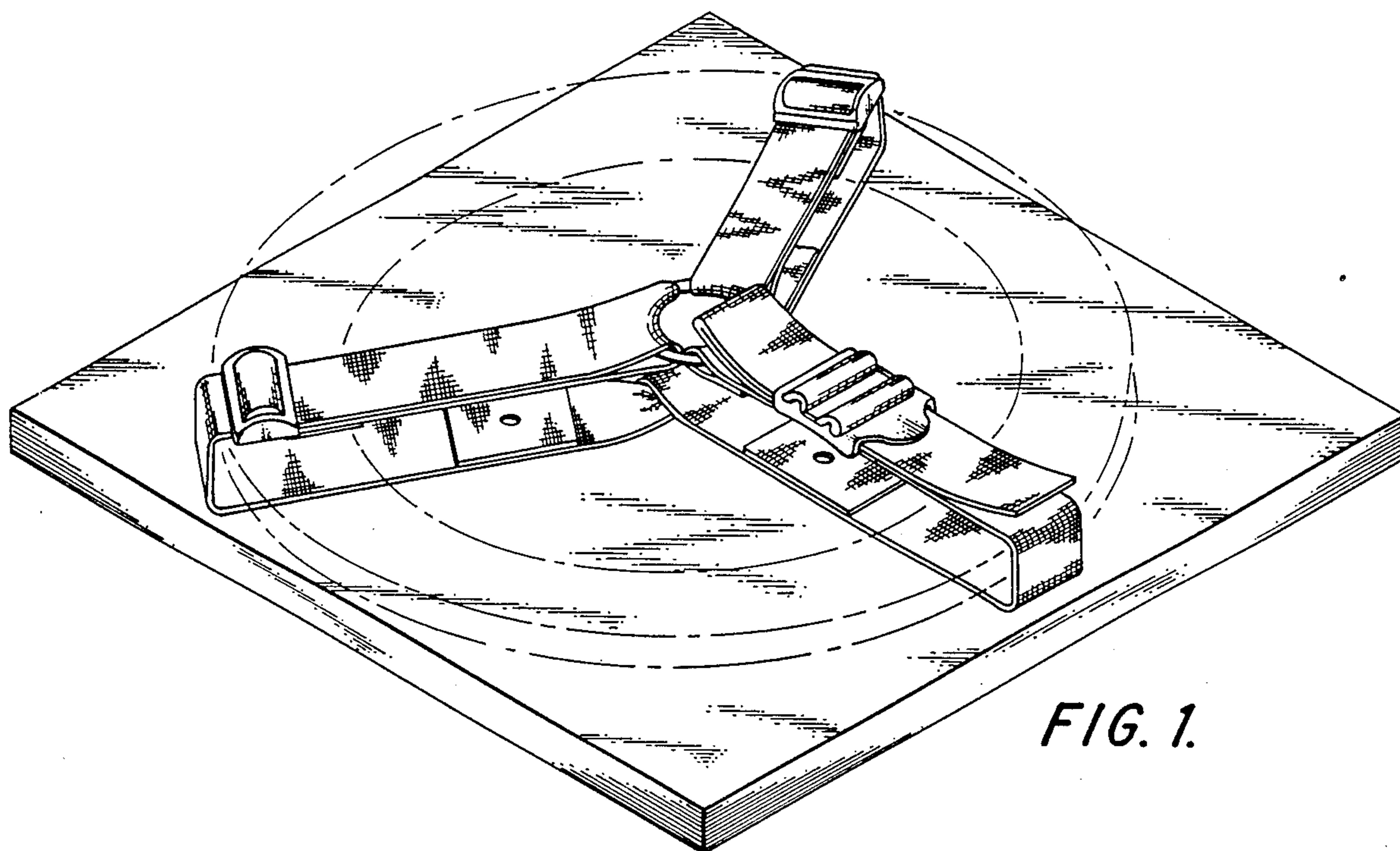
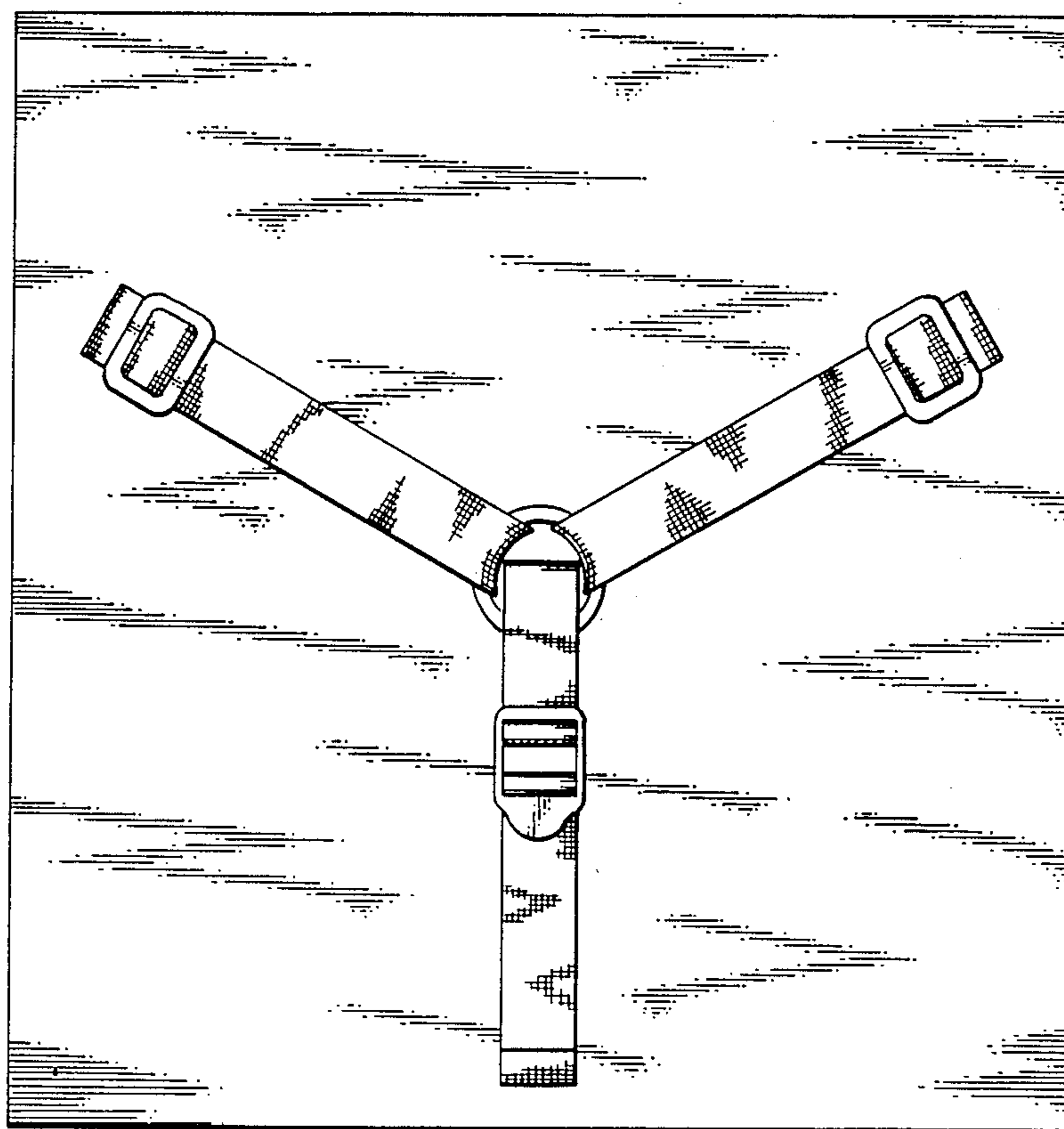

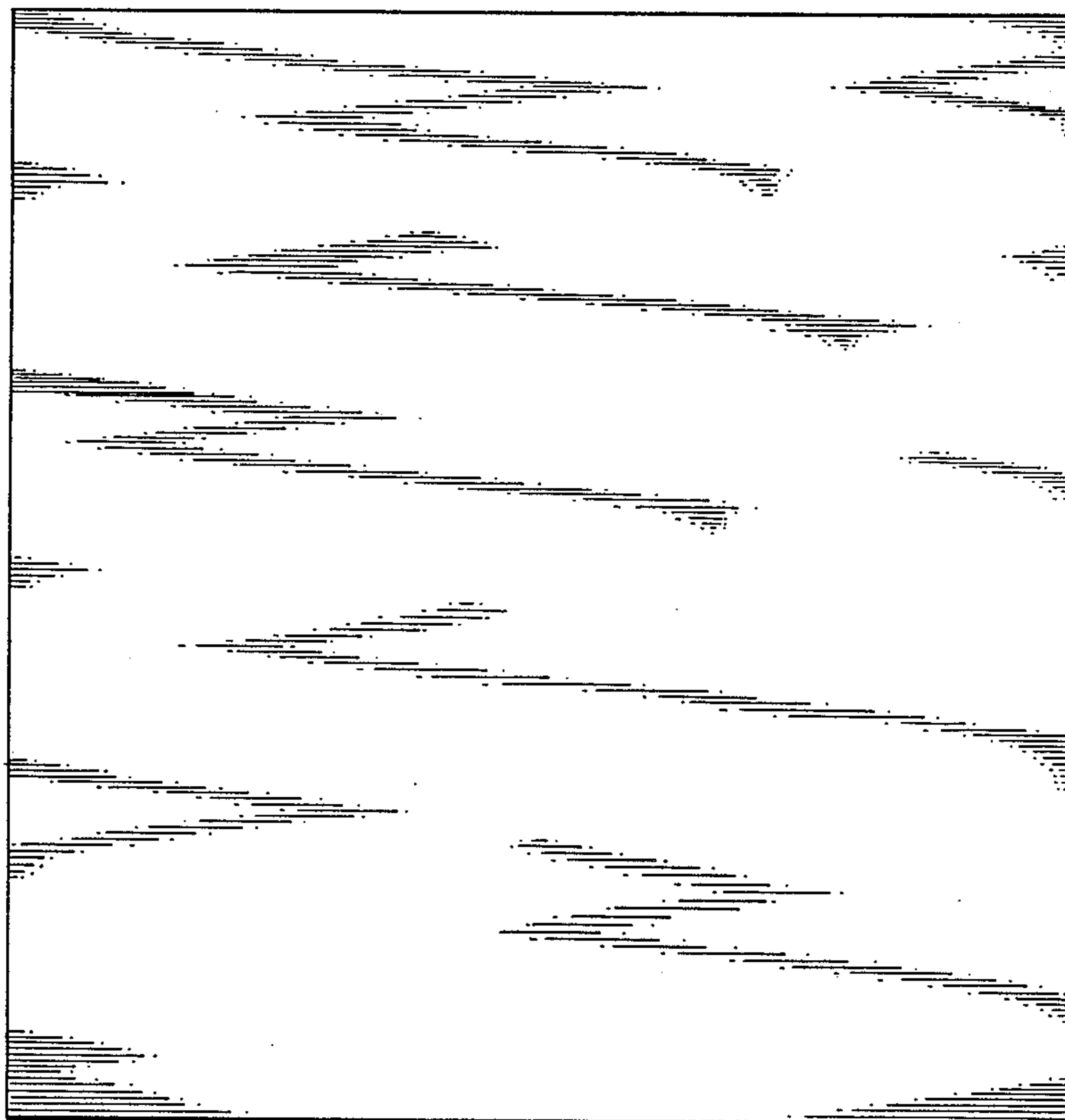

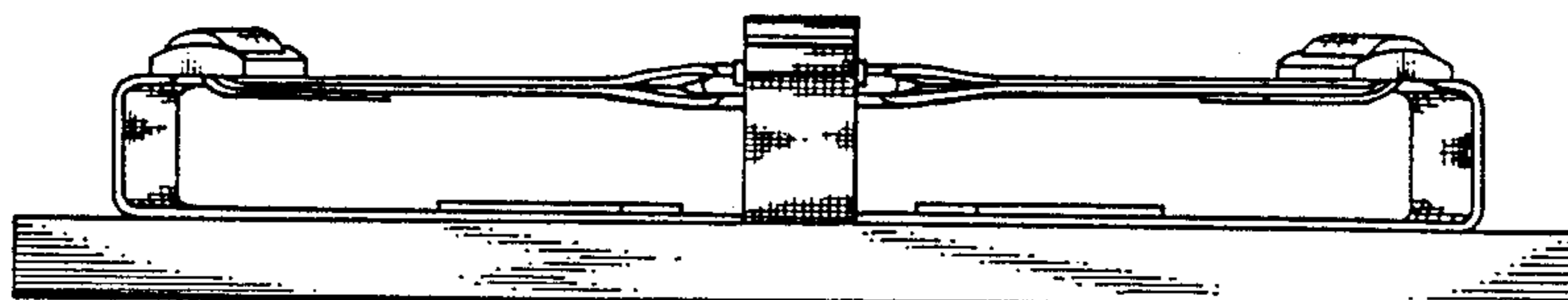

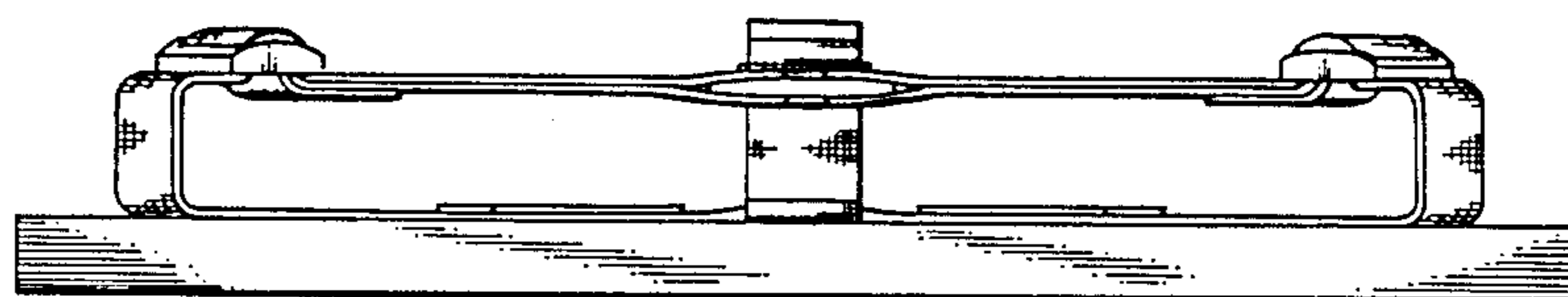

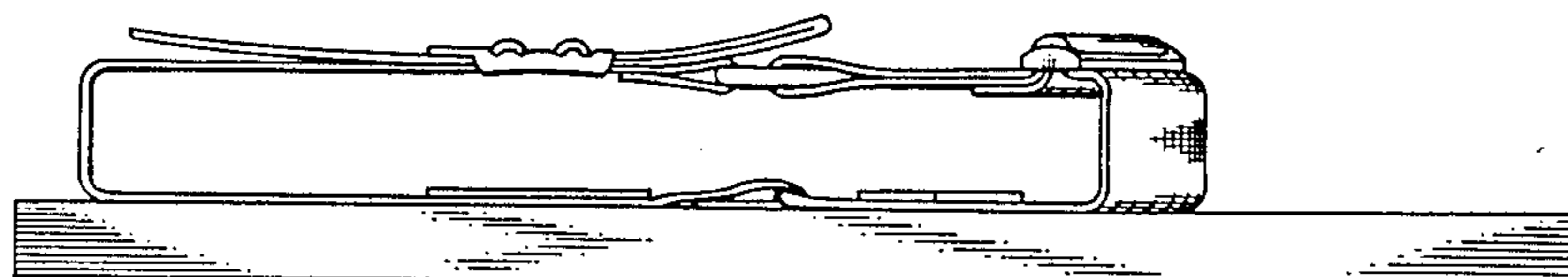

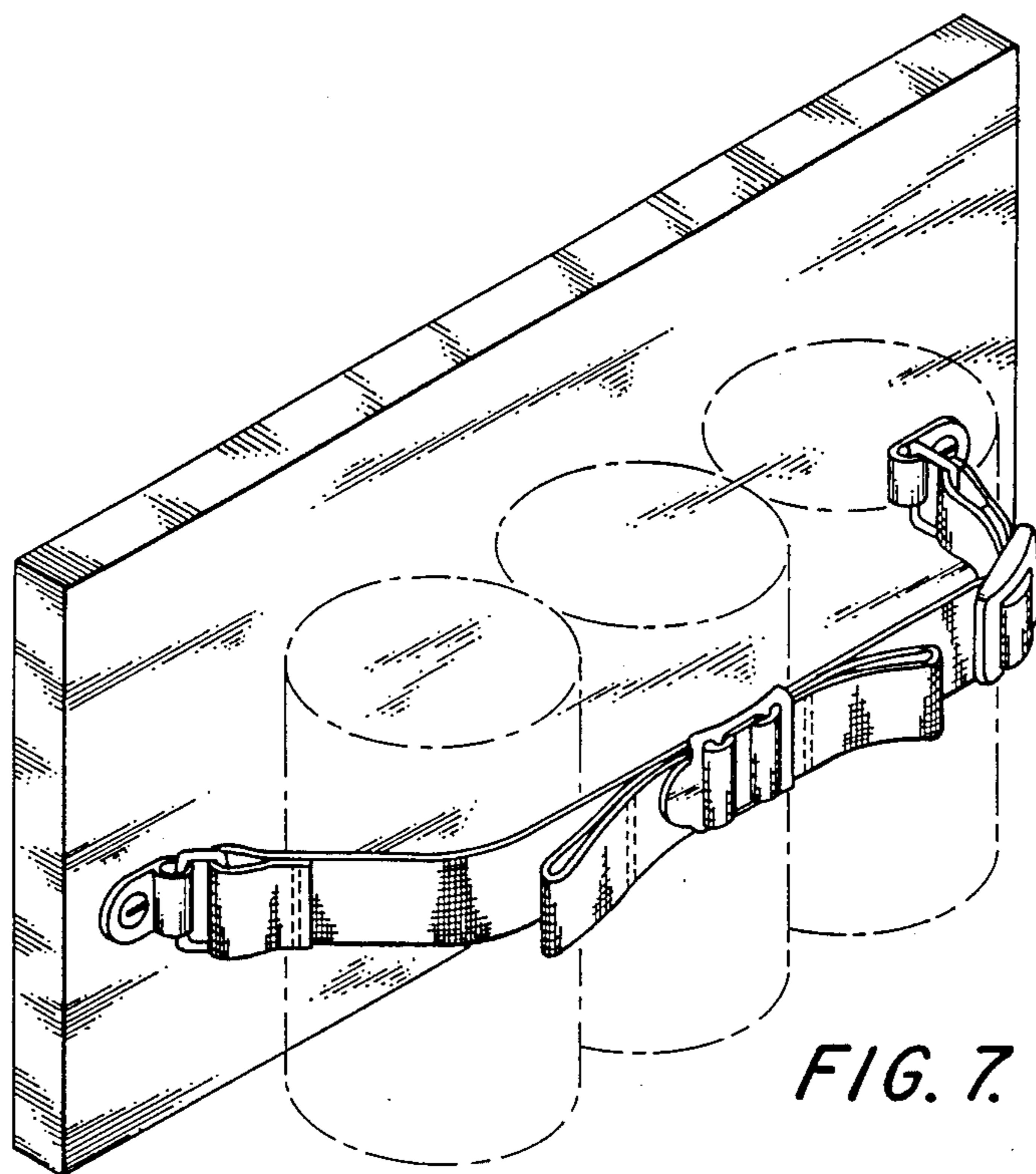

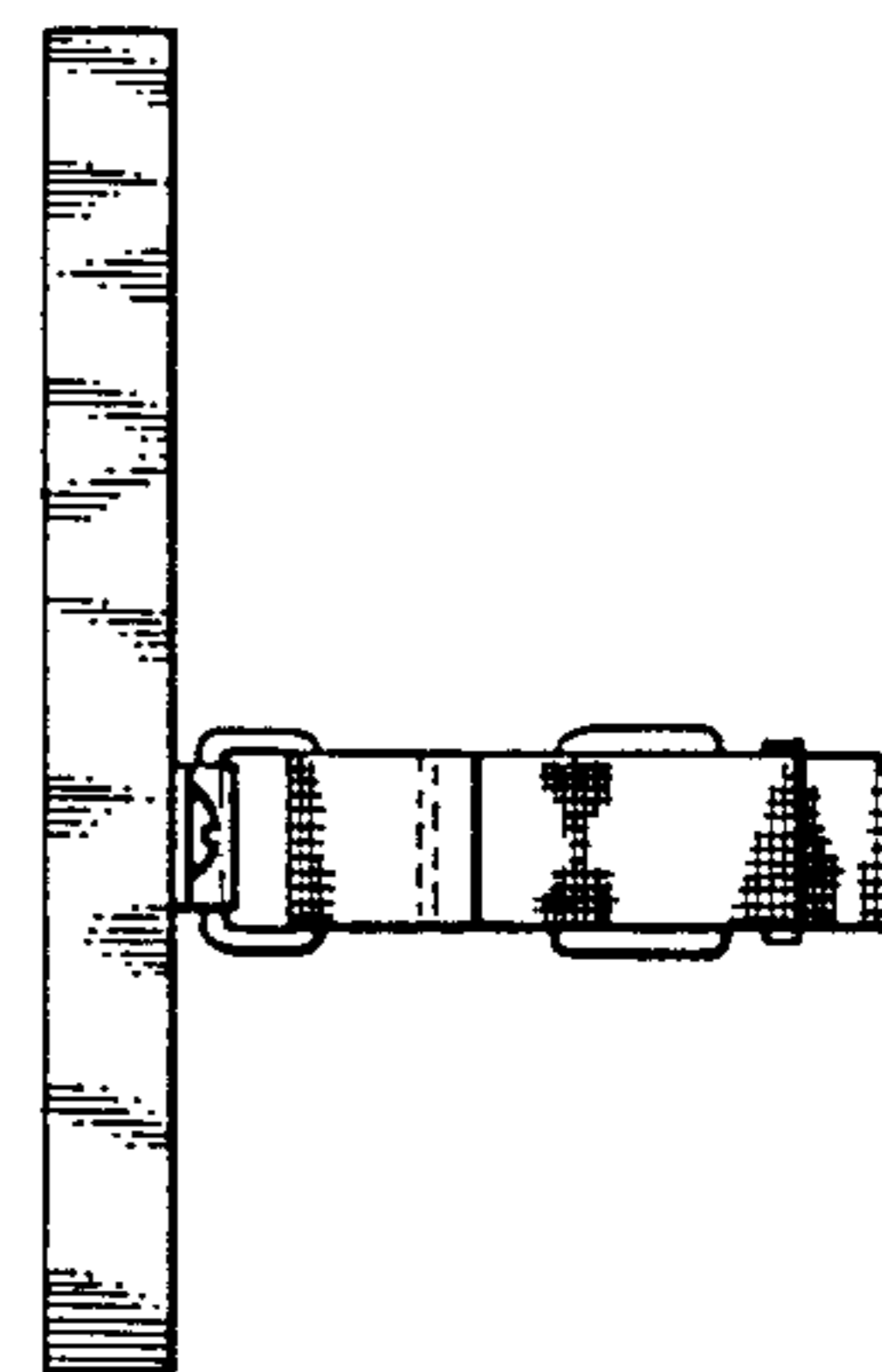

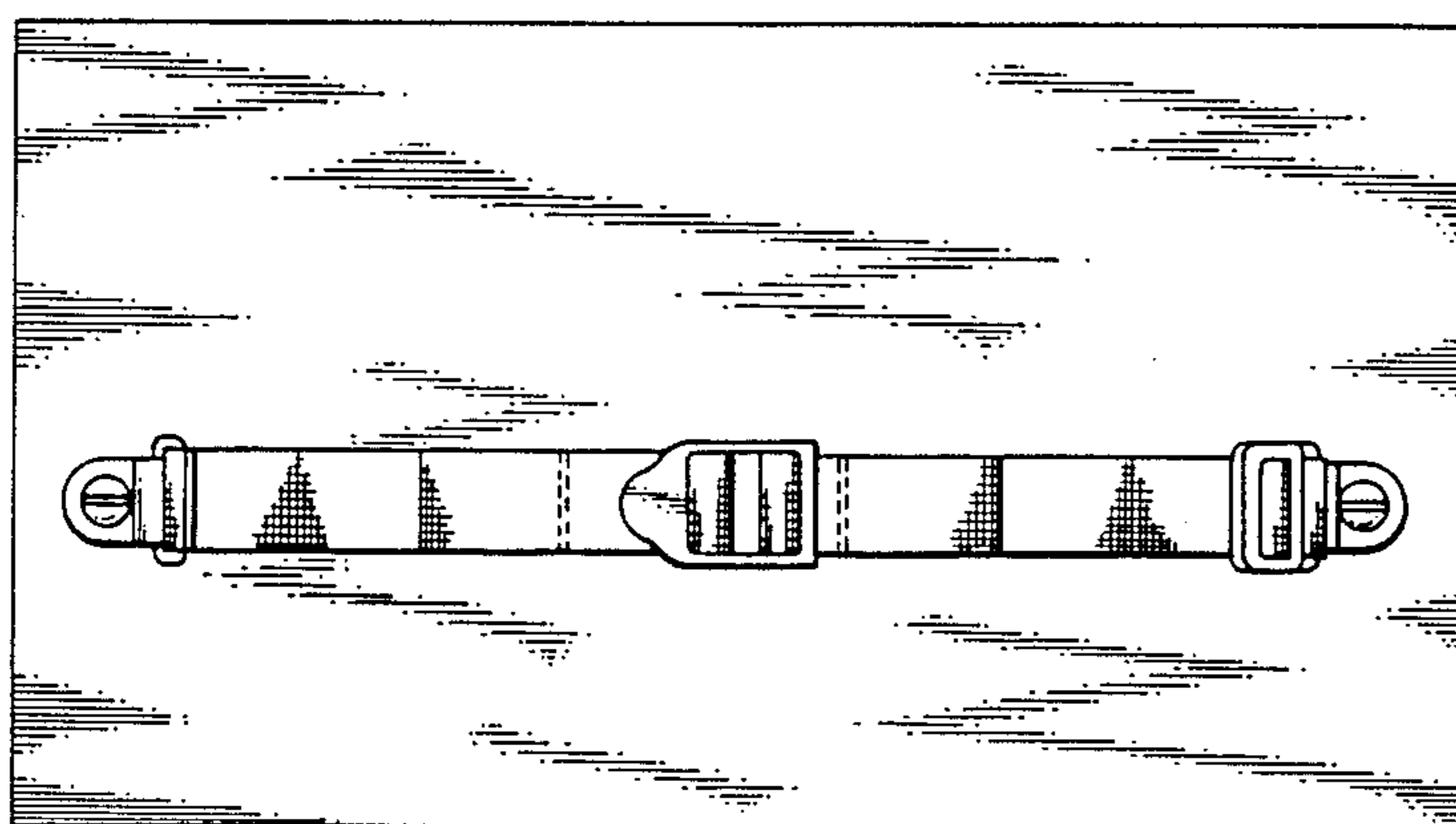

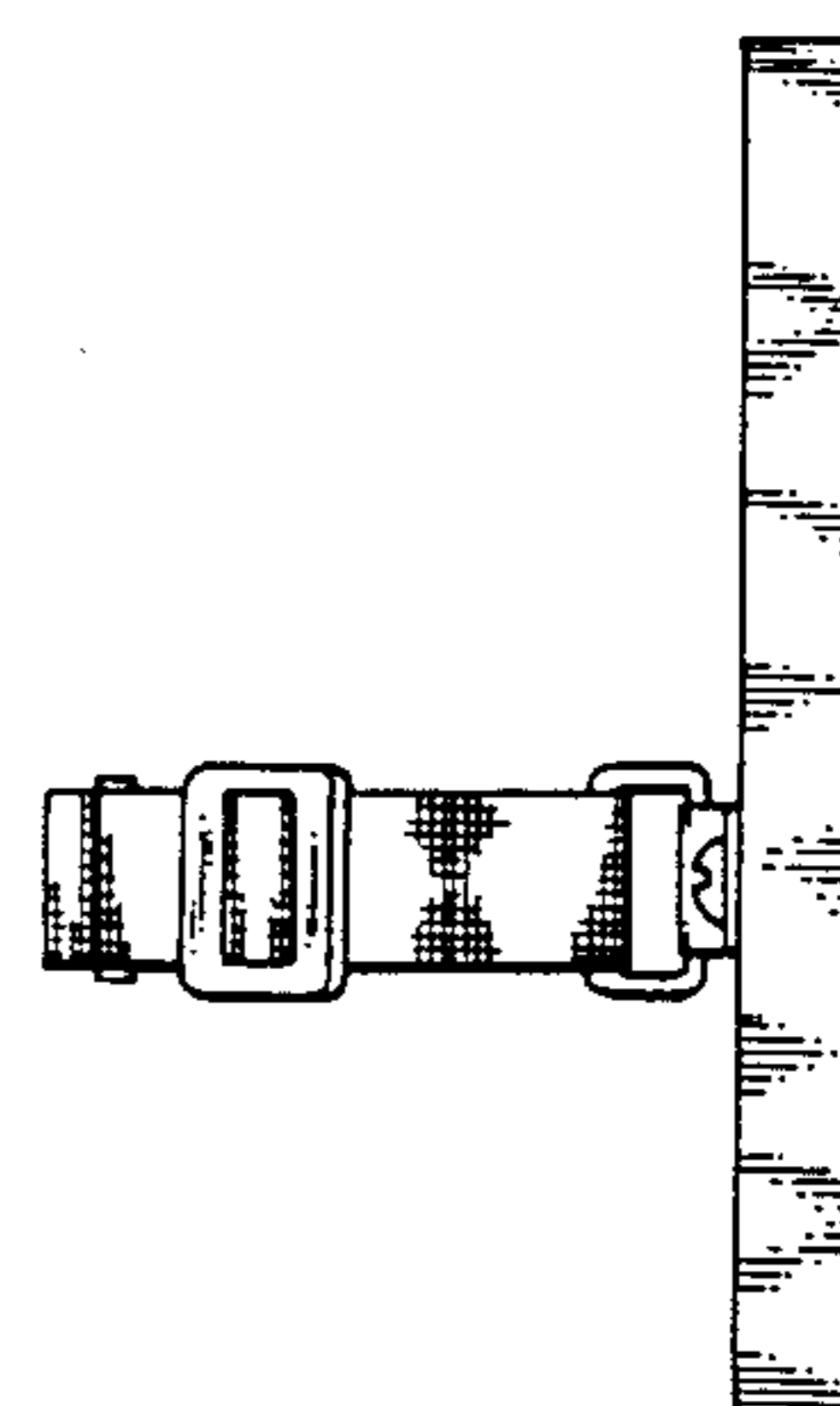
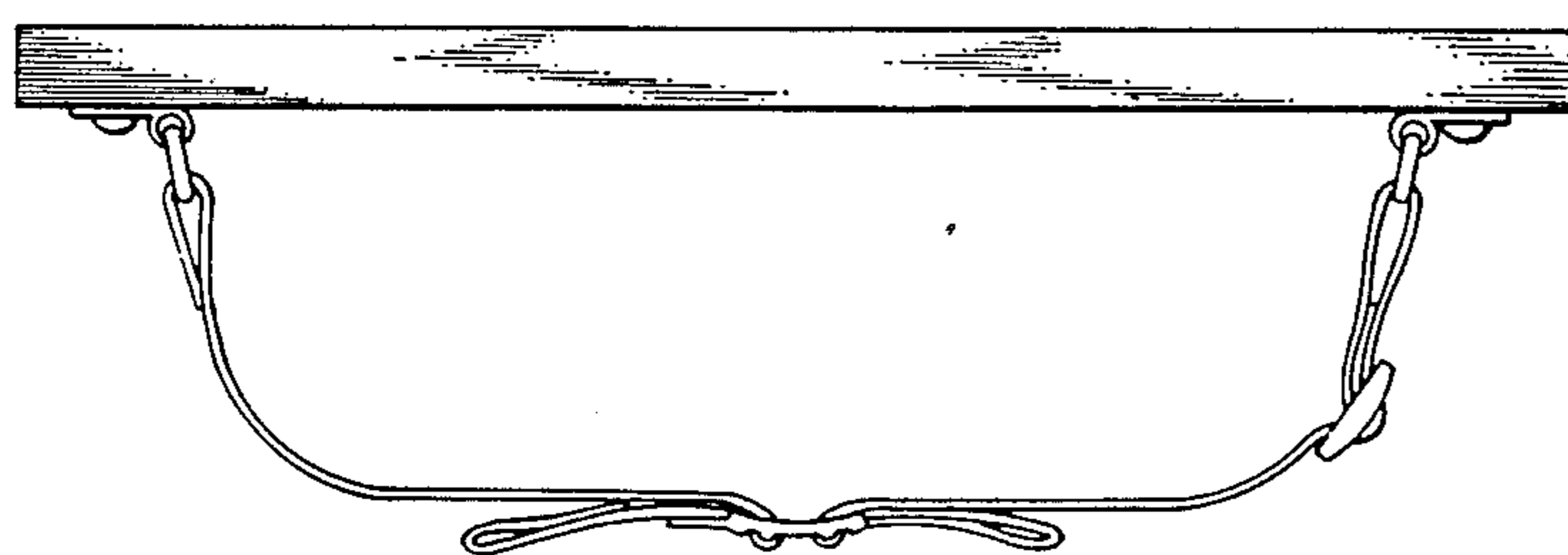

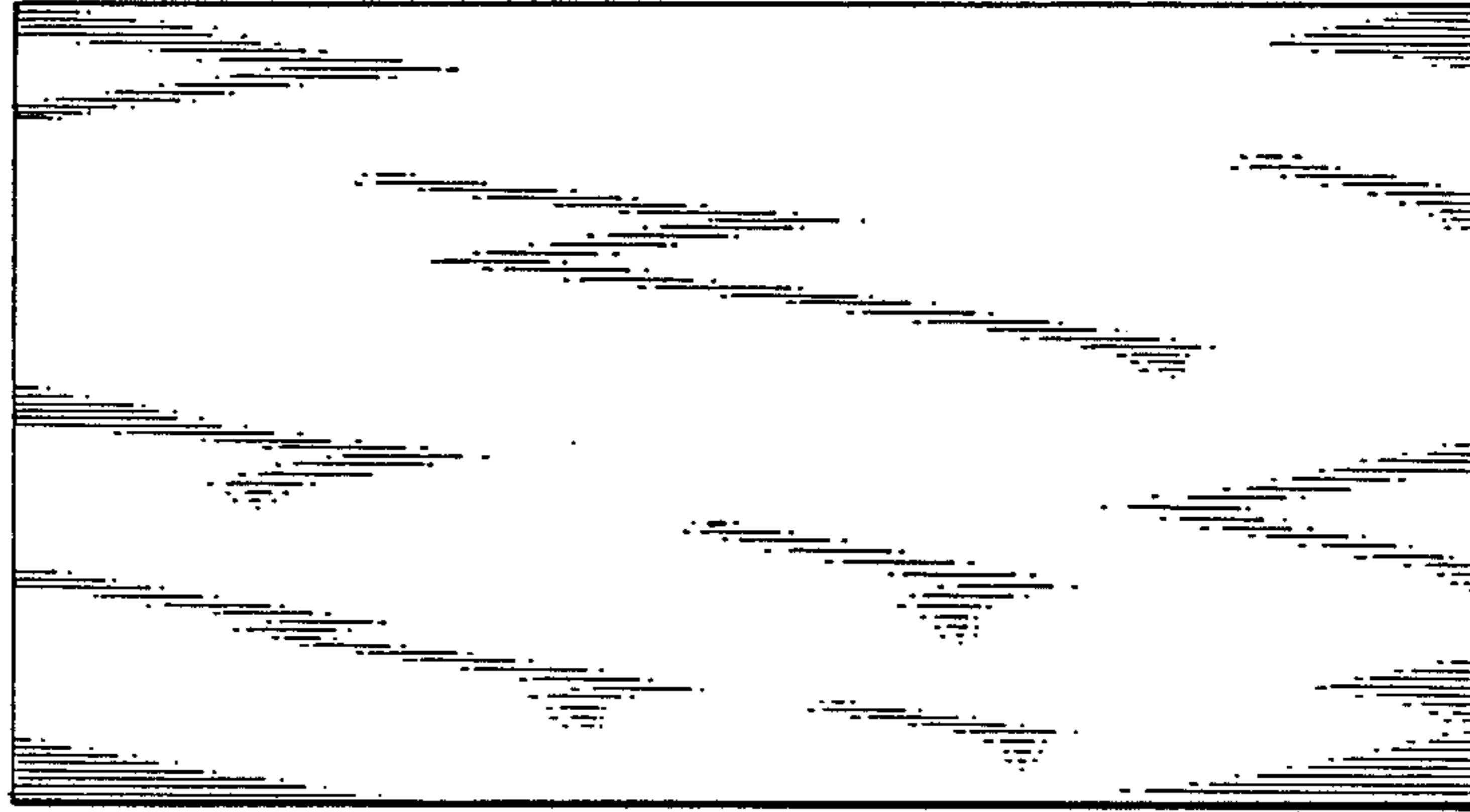
