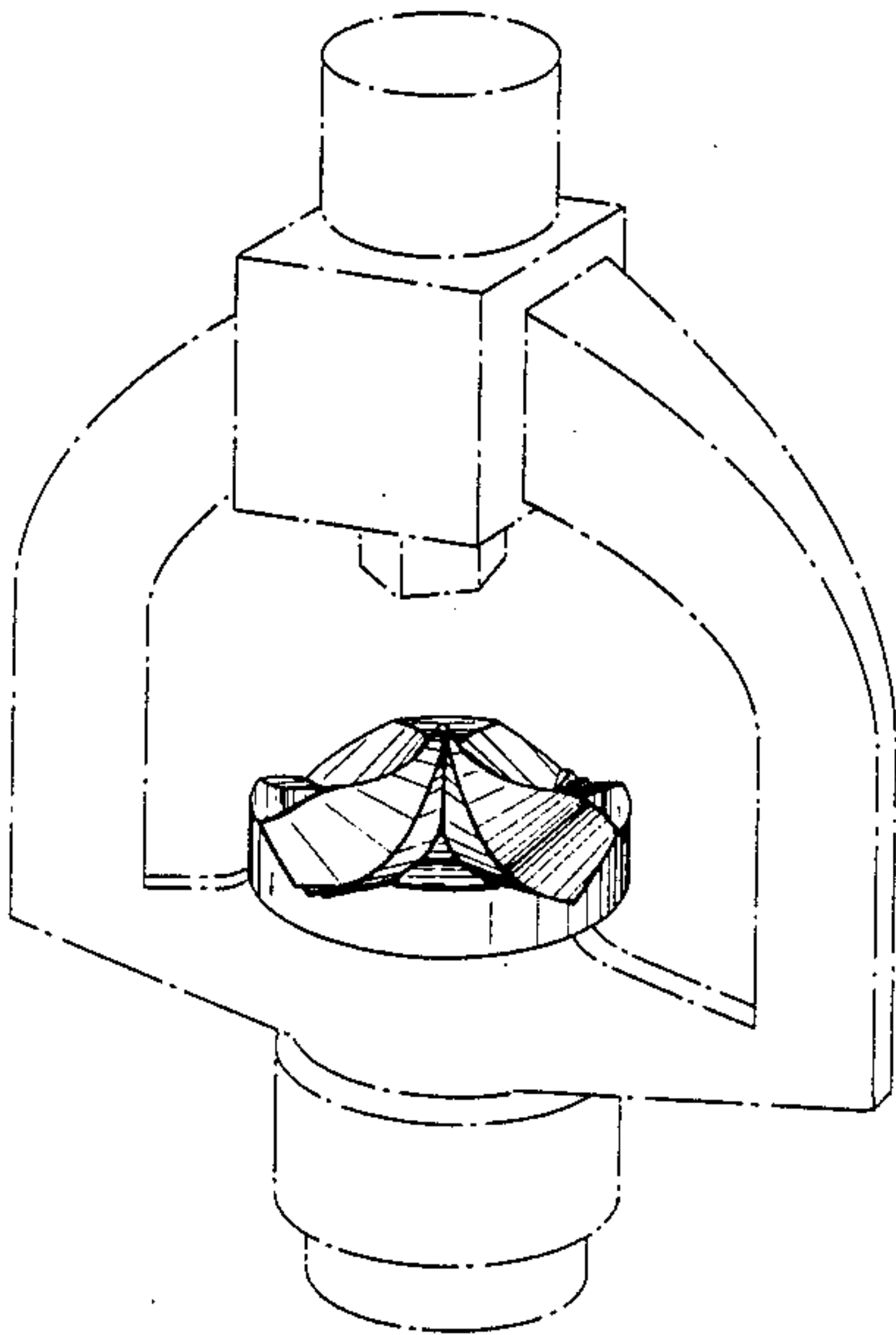

The ornamental design for a sprinkler water distributor,  
as shown and described.

DESCRIPTION

FIG. 1 is a top, right perspective view of a sprinkler water distributor showing my new design, on a reduced scale;  
FIG. 2 is a top plan view thereof;  
FIG. 3 is a front elevational view thereof, the rear view being a mirror image;  
FIG. 4 is a right side elevational view thereof, the left side being a mirror image;  
FIG. 5 is a cross sectional view thereof, taken on line 5—5 of FIG. 2;  
FIG. 6 is a cross sectional view thereof, taken on line 6—6 of FIG. 2;  
FIG. 7 is a top, right perspective view of a second embodiment thereof on a reduced scale;  
FIG. 8 is a top plan view thereof;  
FIG. 9 is a front elevational view thereof, the rear view being a mirror image;  
FIG. 10 is a cross sectional view thereof taken on line 10—10 of FIG. 8;  
FIG. 11 is a bottom, left perspective view of a third embodiment thereof, on a reduced scale;  
FIG. 12 is a bottom plan view thereof;  
FIG. 13 is a front elevational view thereof, the rear being a mirror image;  
FIG. 14 is a left side elevational view thereof, the right side being a mirror image; and  
FIG. 15 is a cross sectional view thereof, taken on line 15—15 of FIG. 12.  
The broken line representation of a sprinkler body and nozzle in FIGS. 1, 7 and 11 is for purposes of illustration only and forms no part of the claimed design.



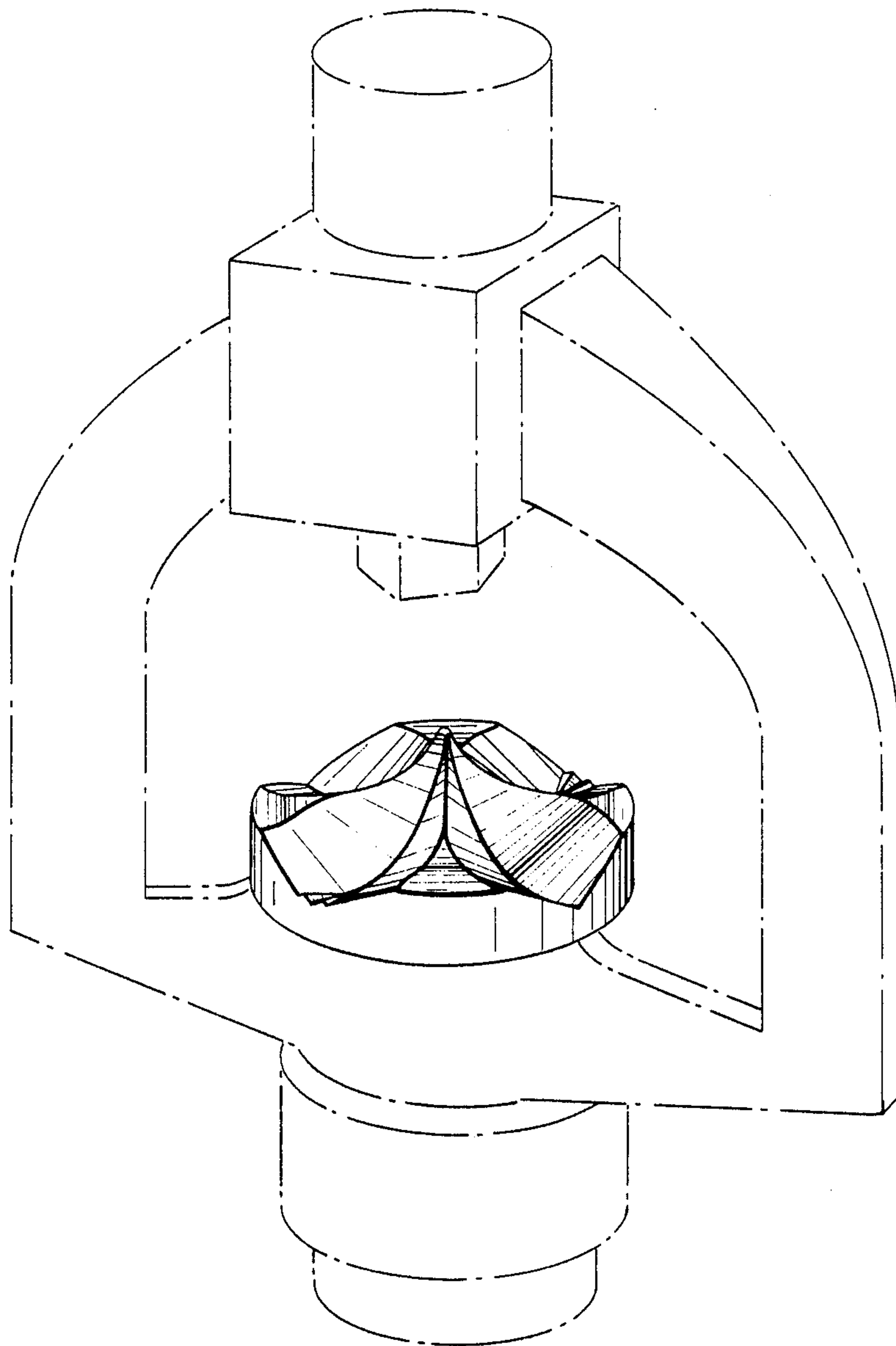

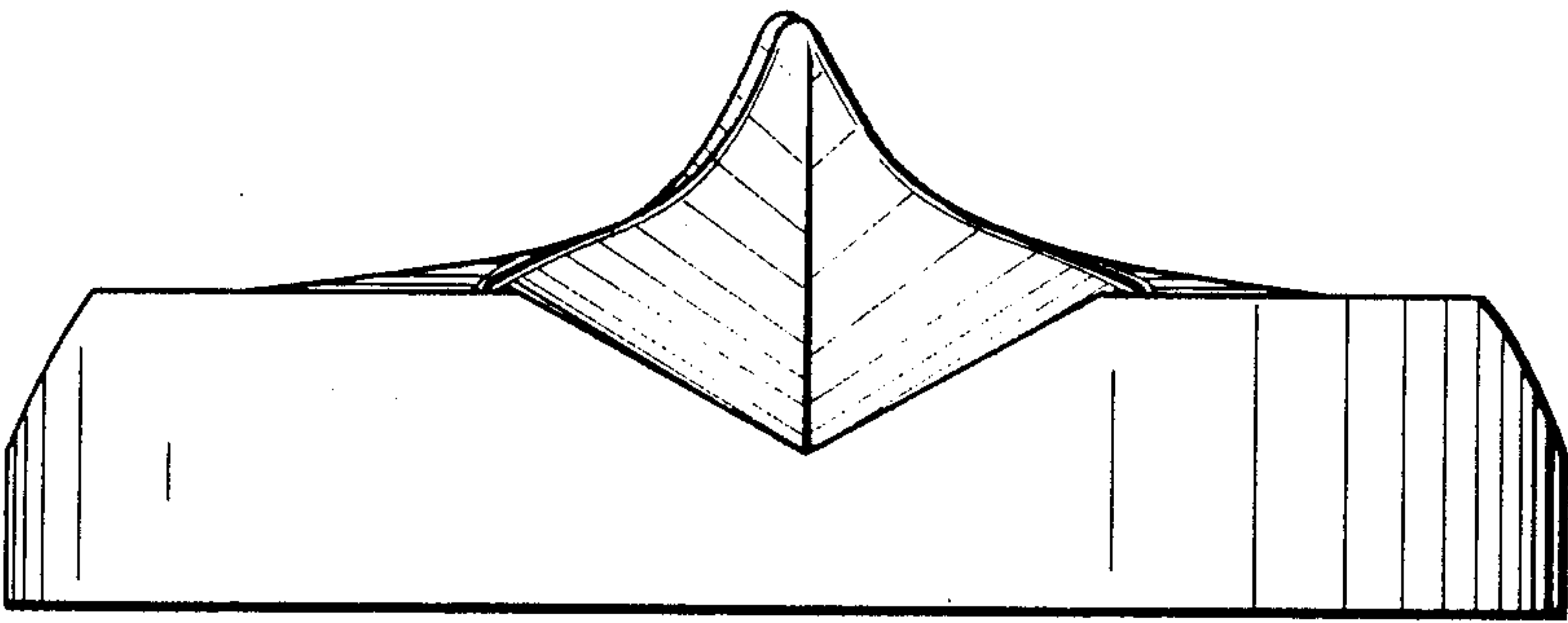
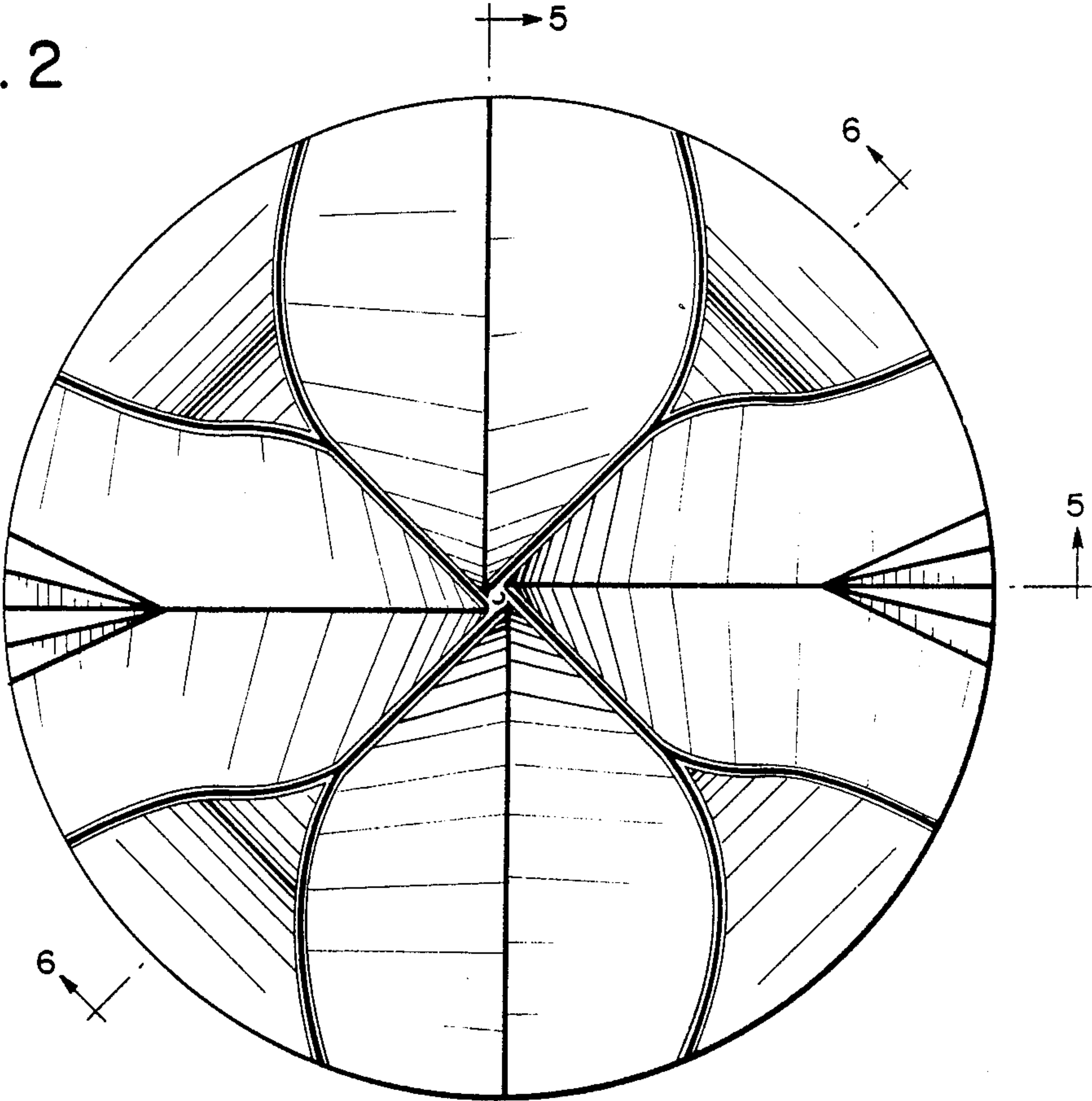

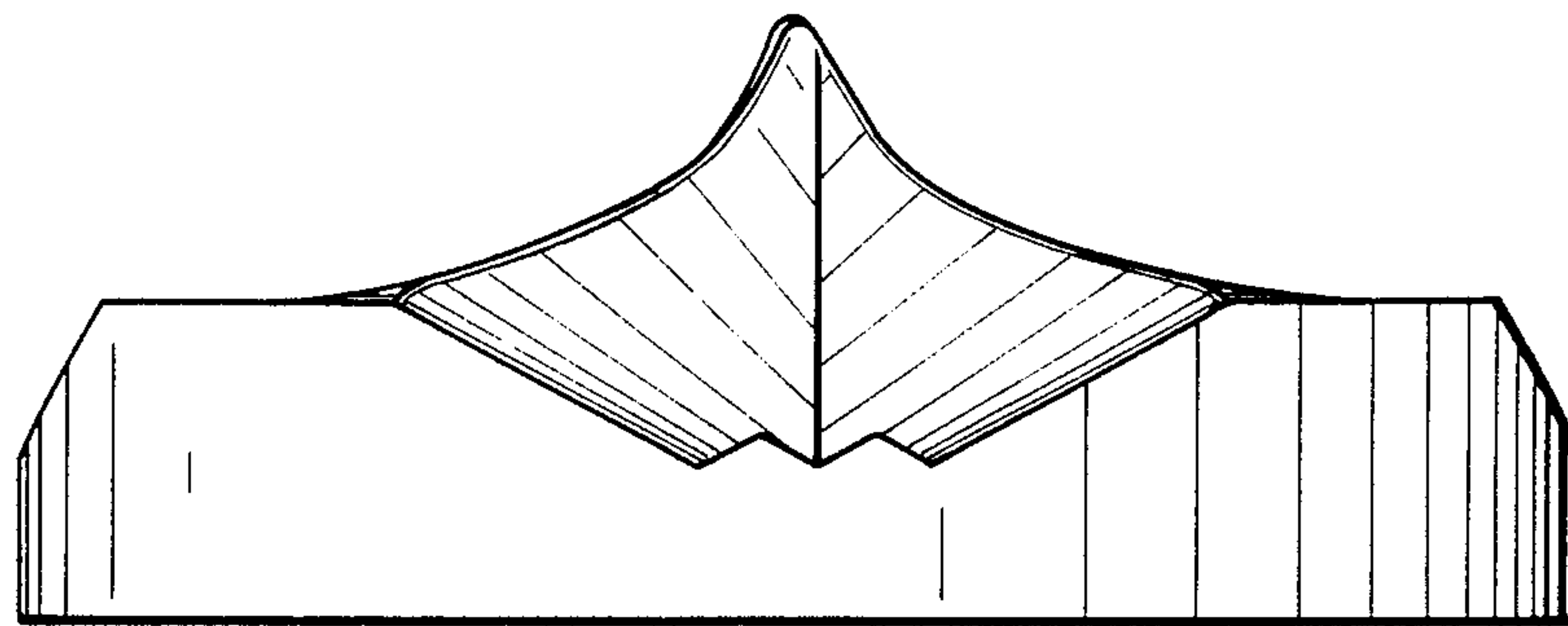

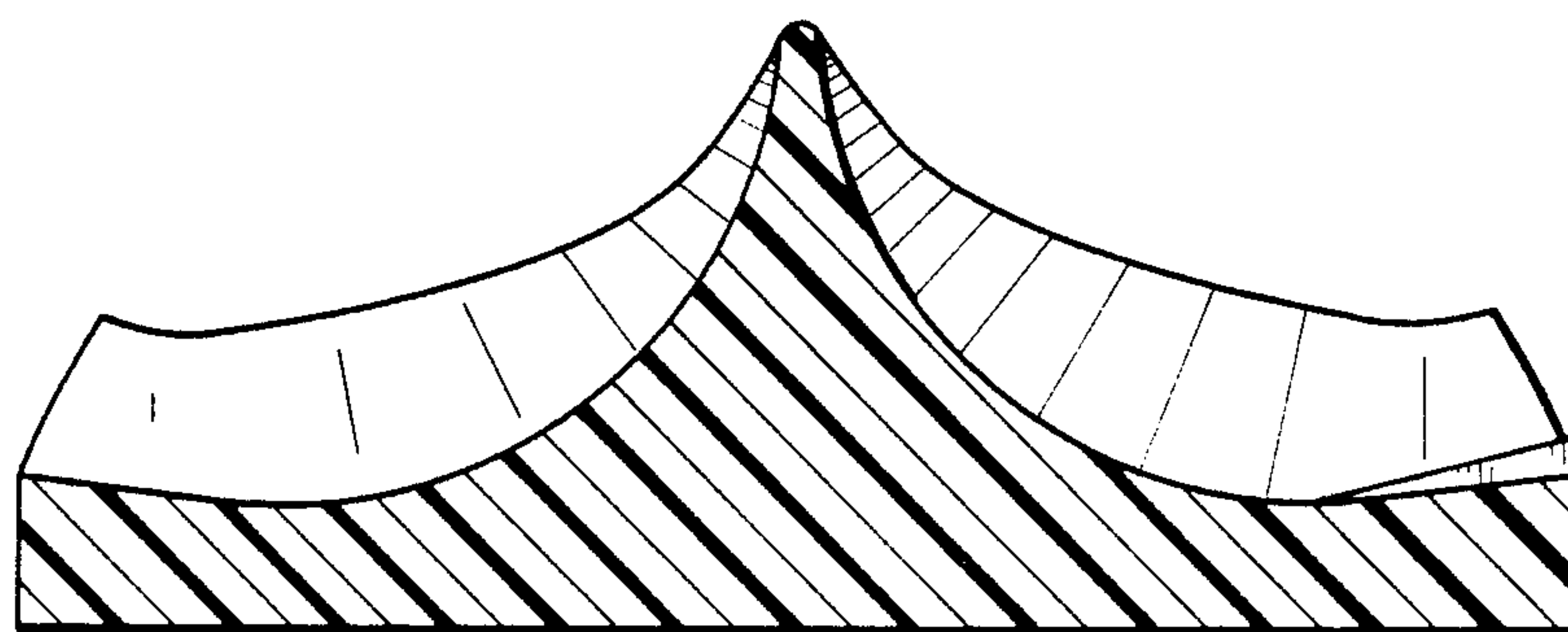

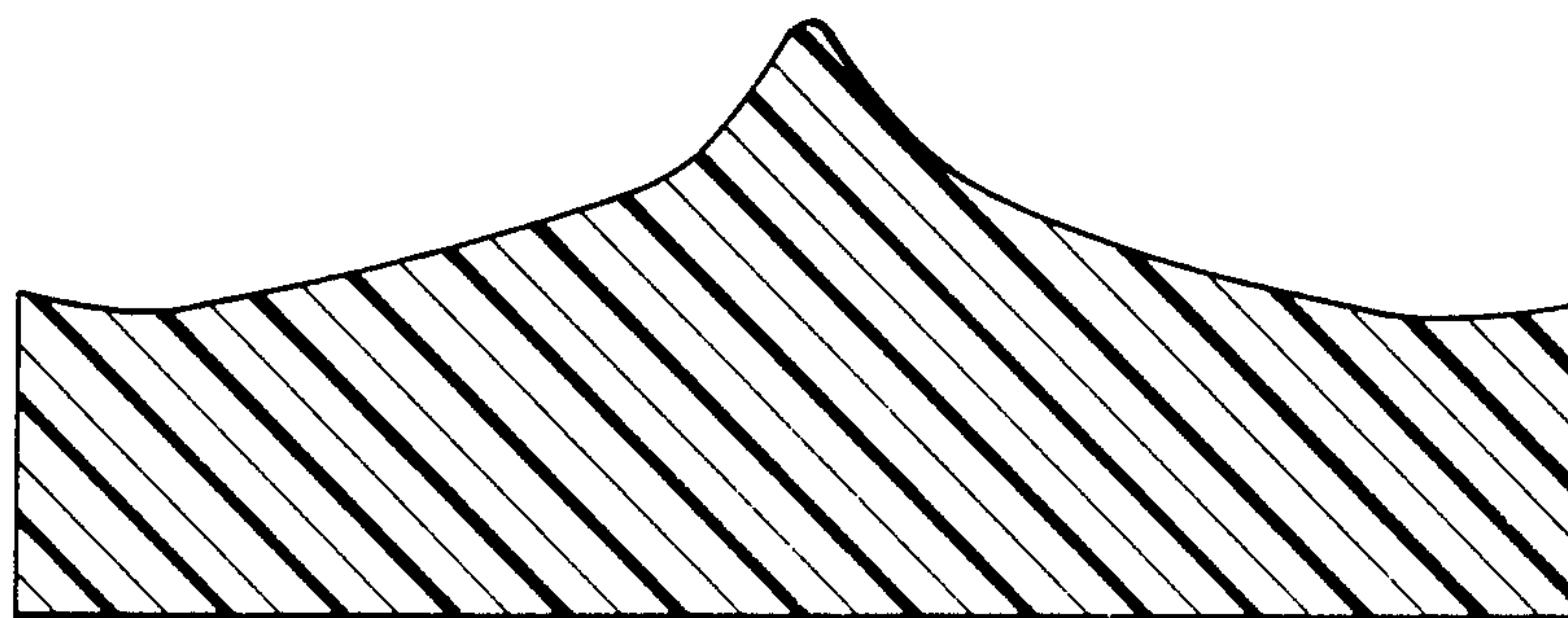

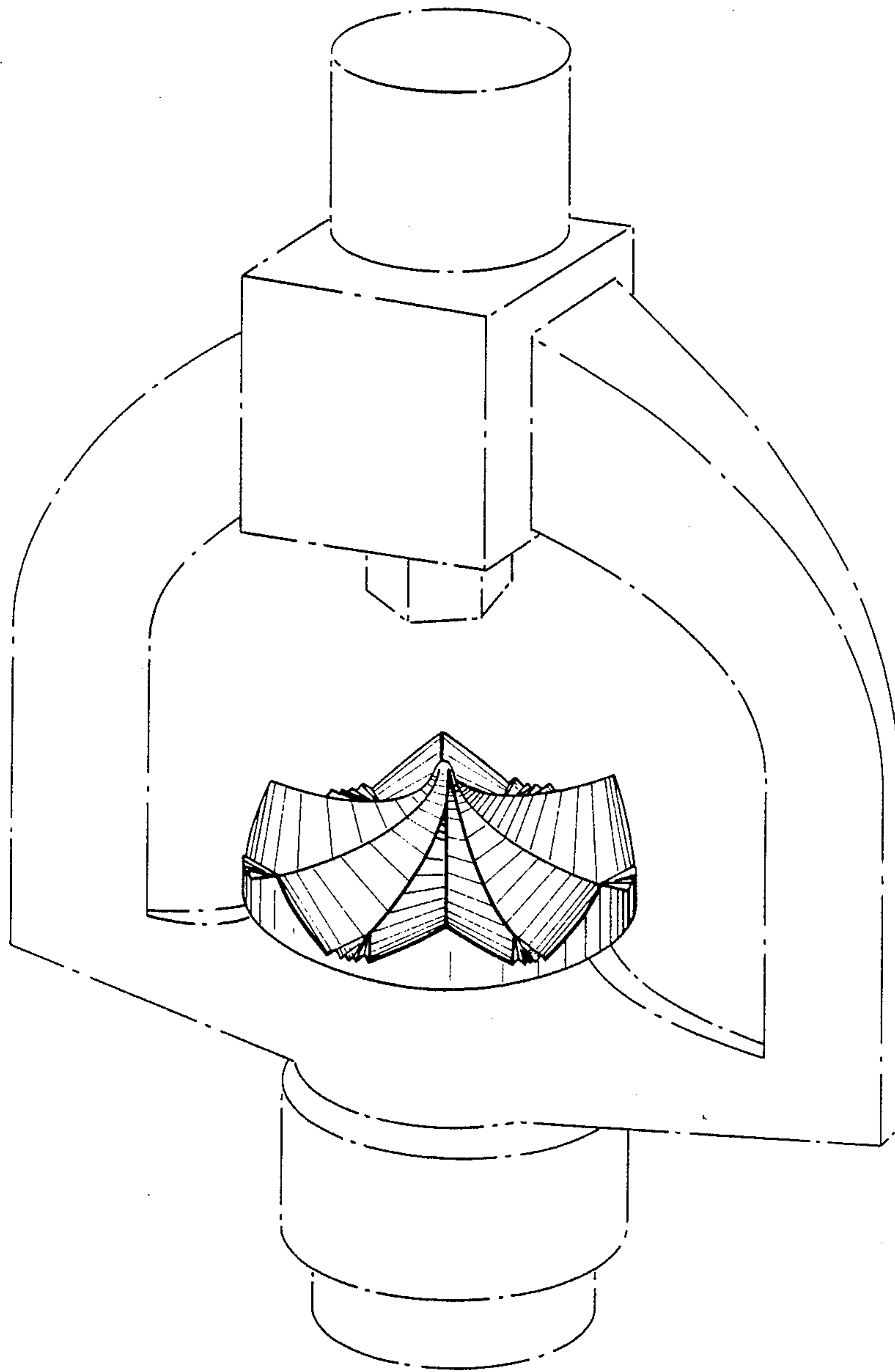

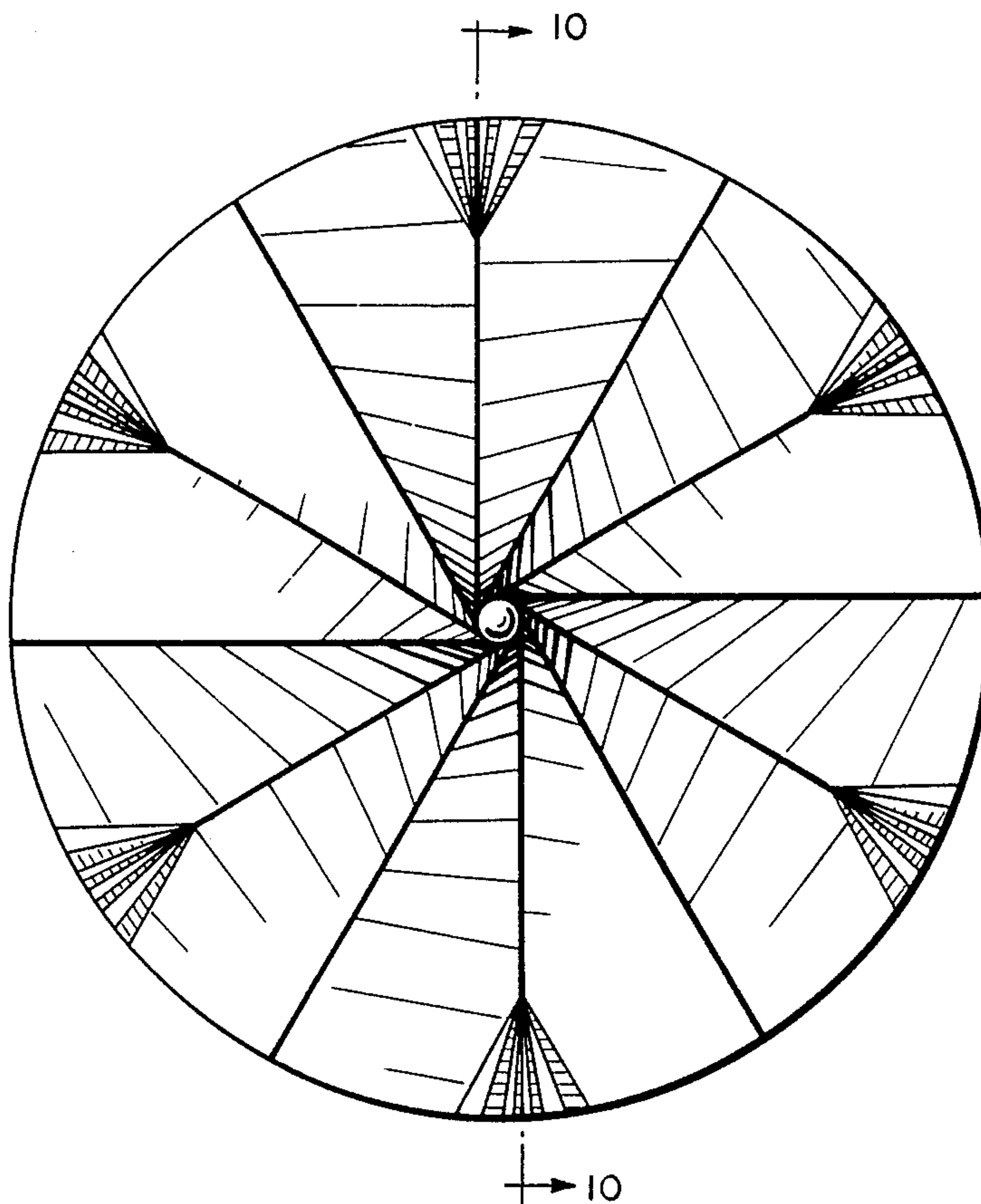

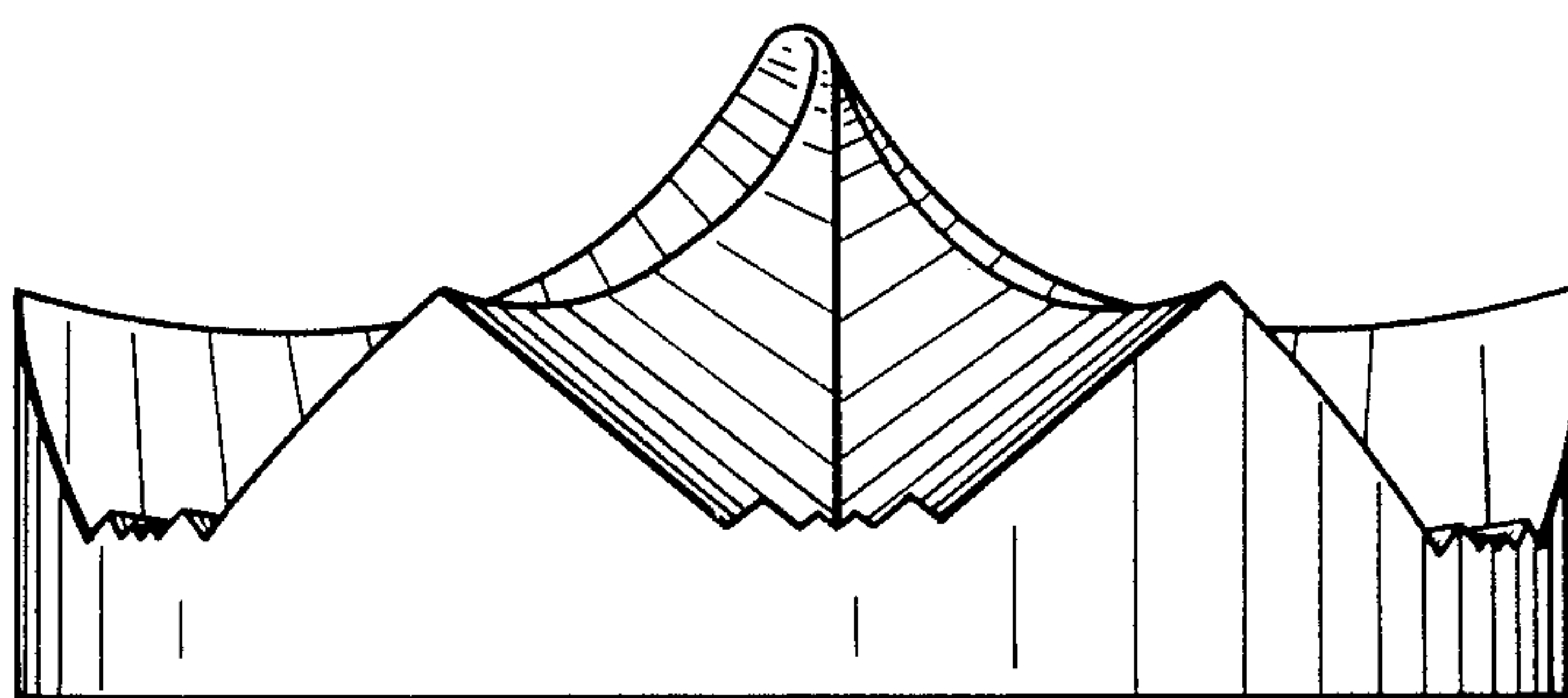
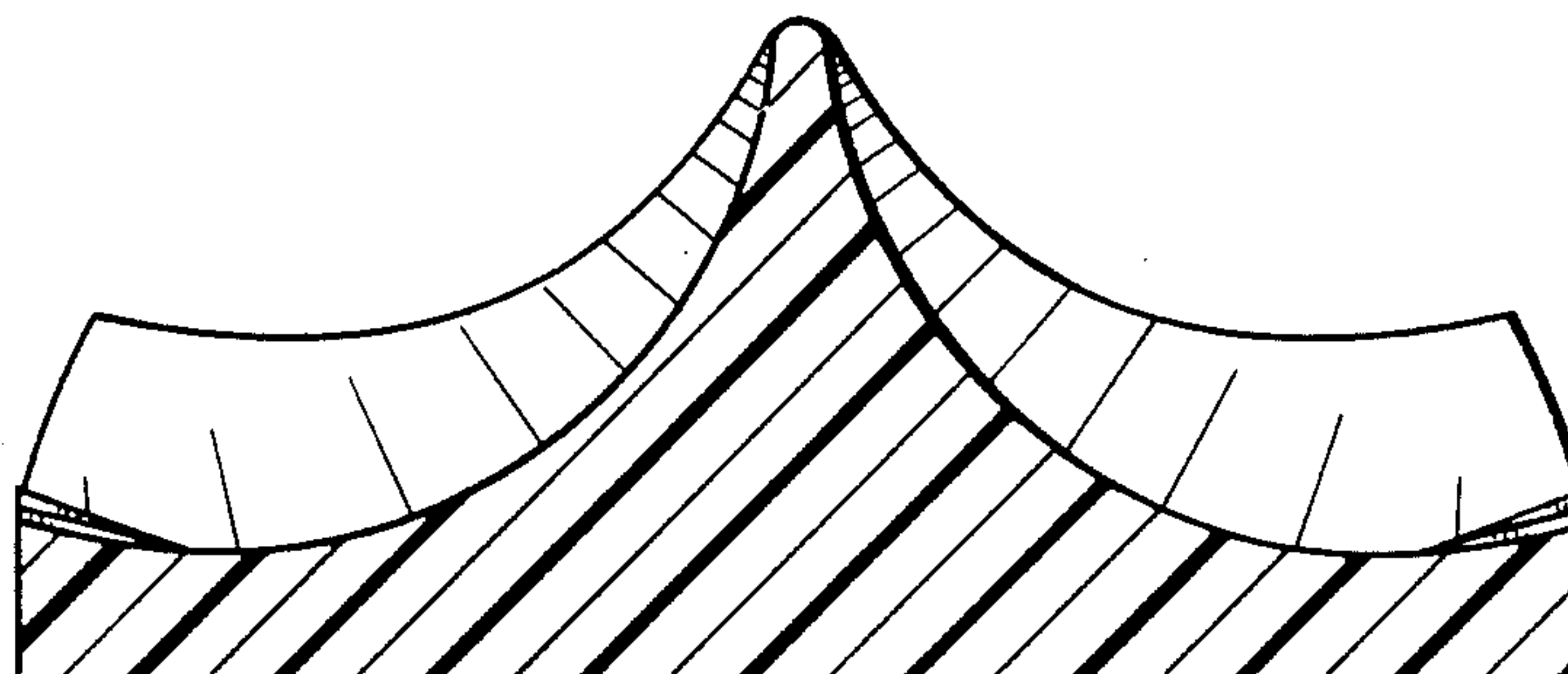

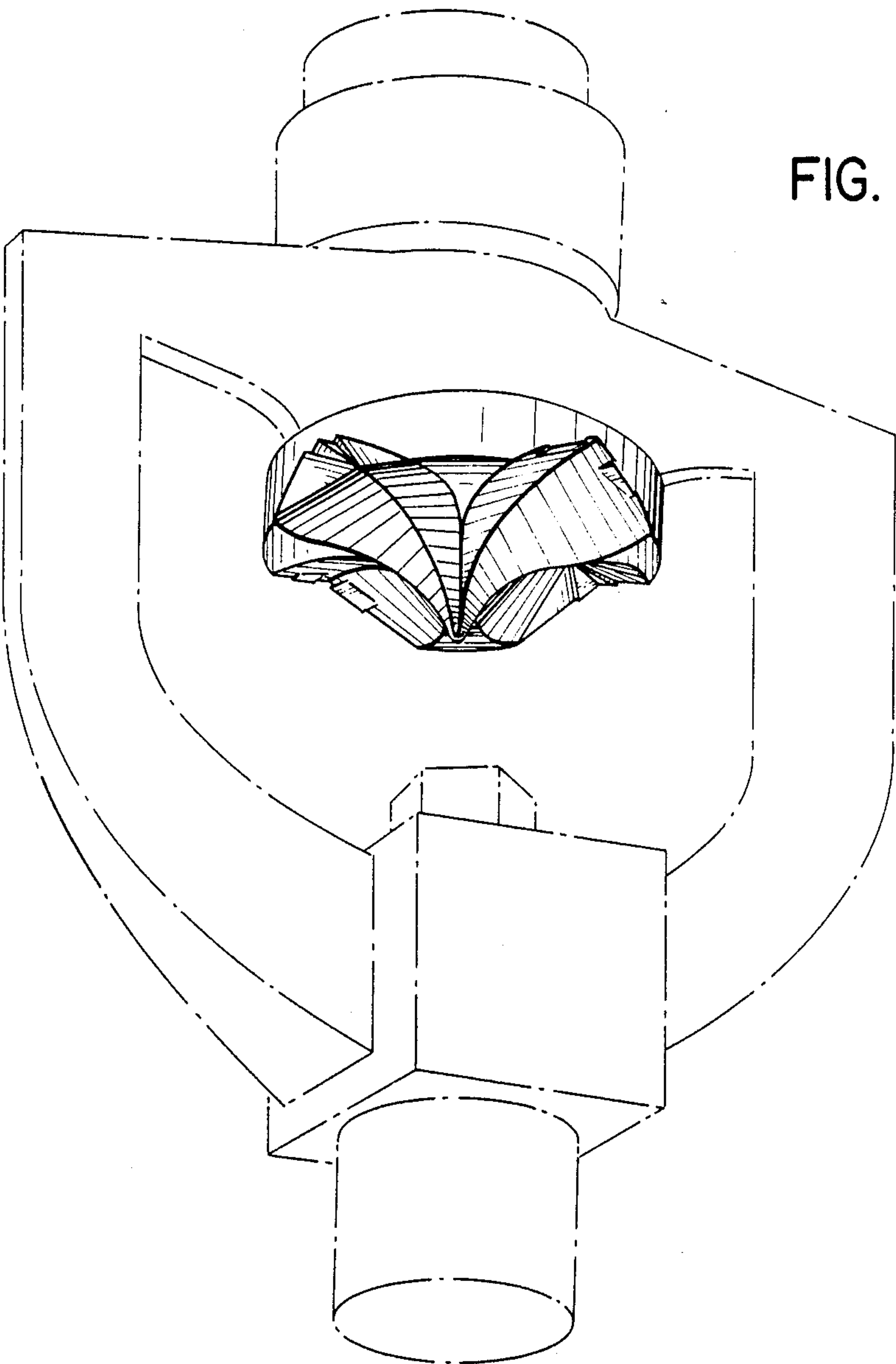
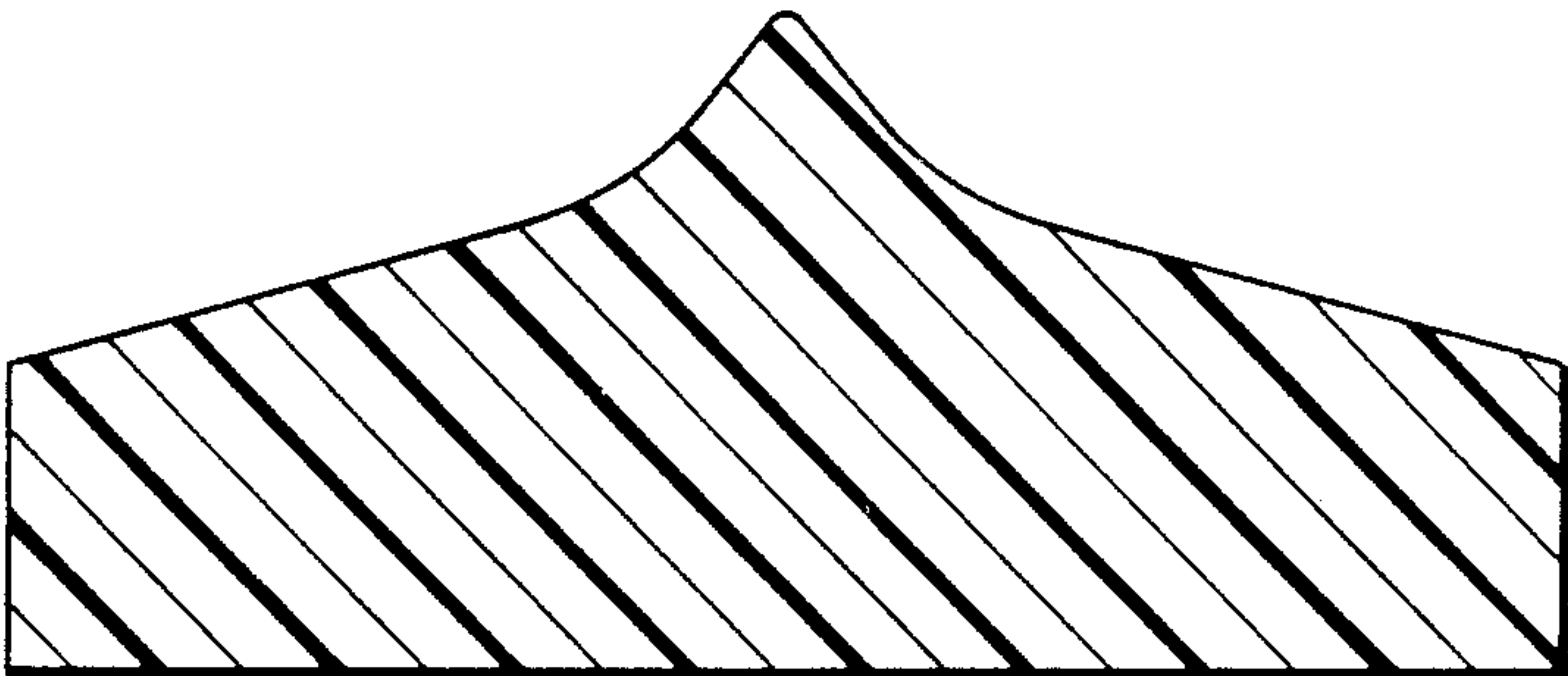

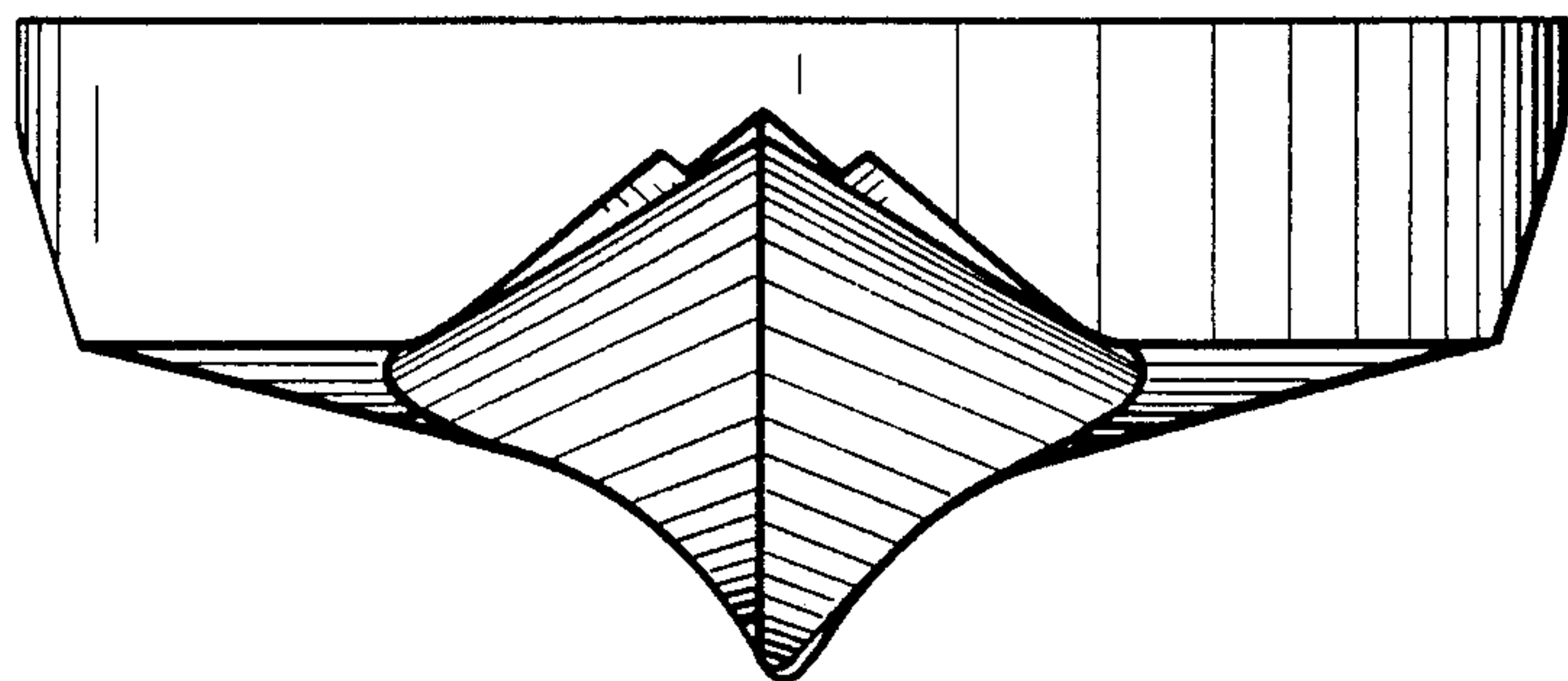

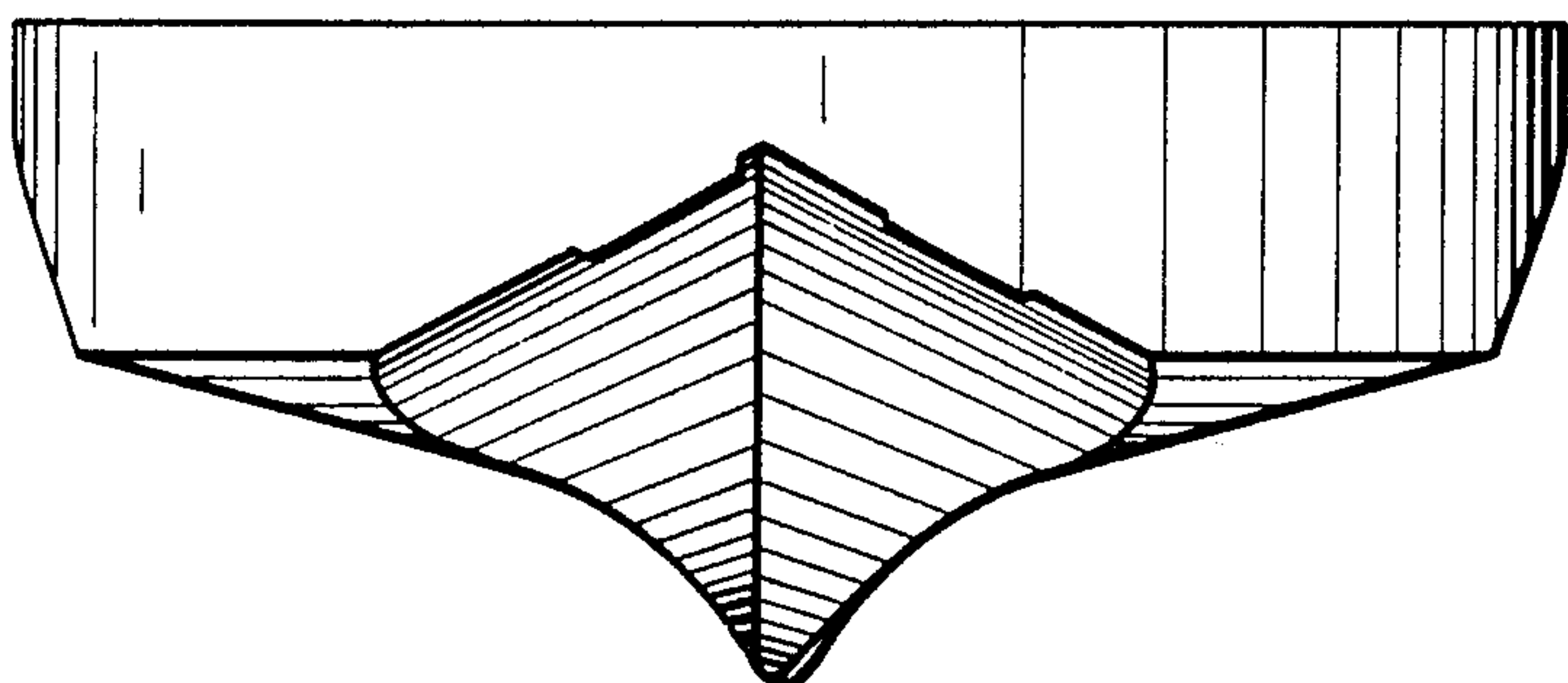

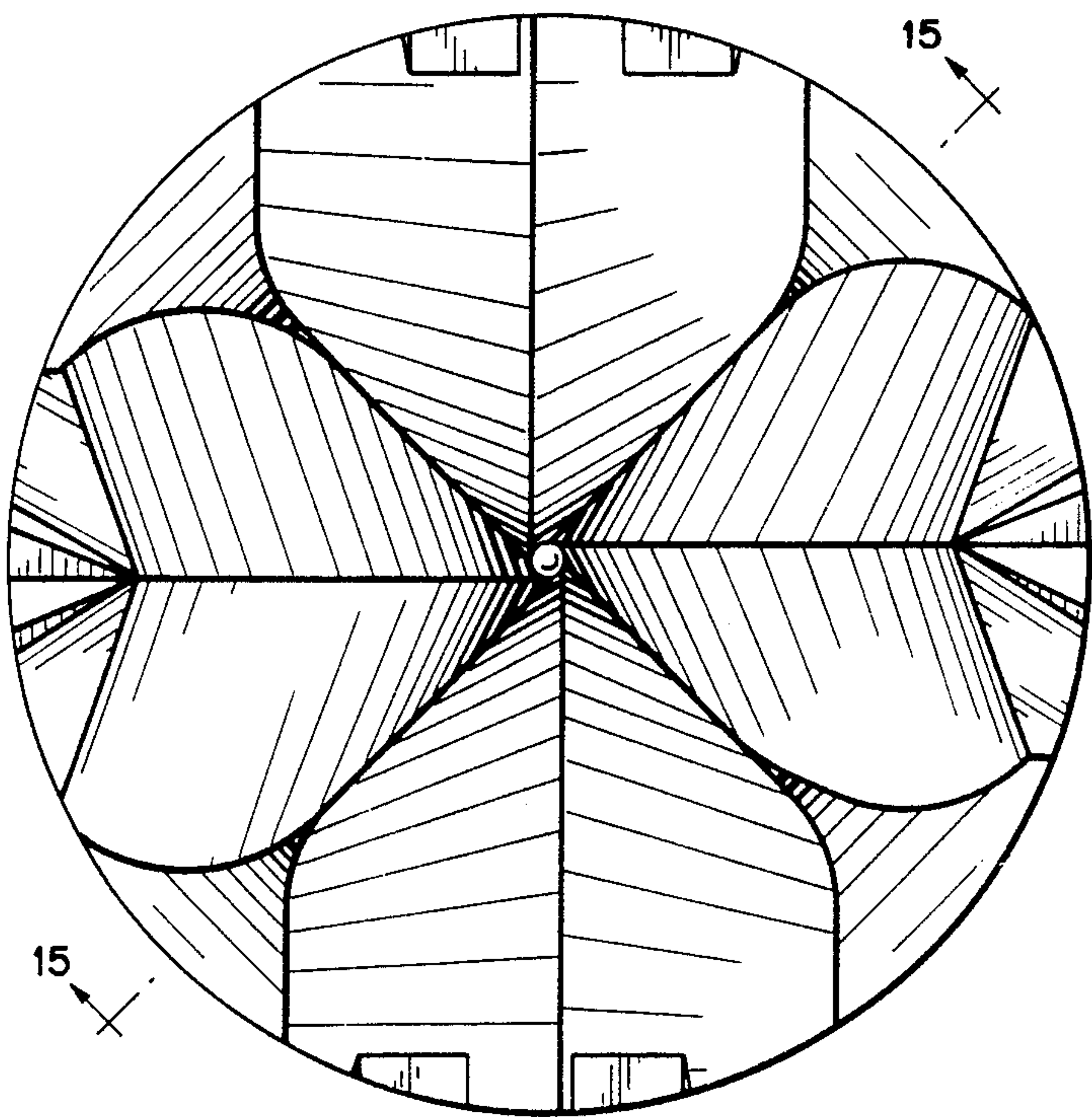
