[57] **CLAIM**
 The ornamental design for a garment drying bag, as shown and described.

DESCRIPTION
 FIG. 1 is a rear perspective view of a garment drying bag showing my new design with the bag rolled up for storage;
 FIG. 2 is a front perspective view showing the bag in an unrolled position;
 FIG. 3 is a front perspective view showing the bag partially open and the handles extended;
 FIG. 4 is a rear perspective view; and
 FIG. 5 is a bottom plan view.
