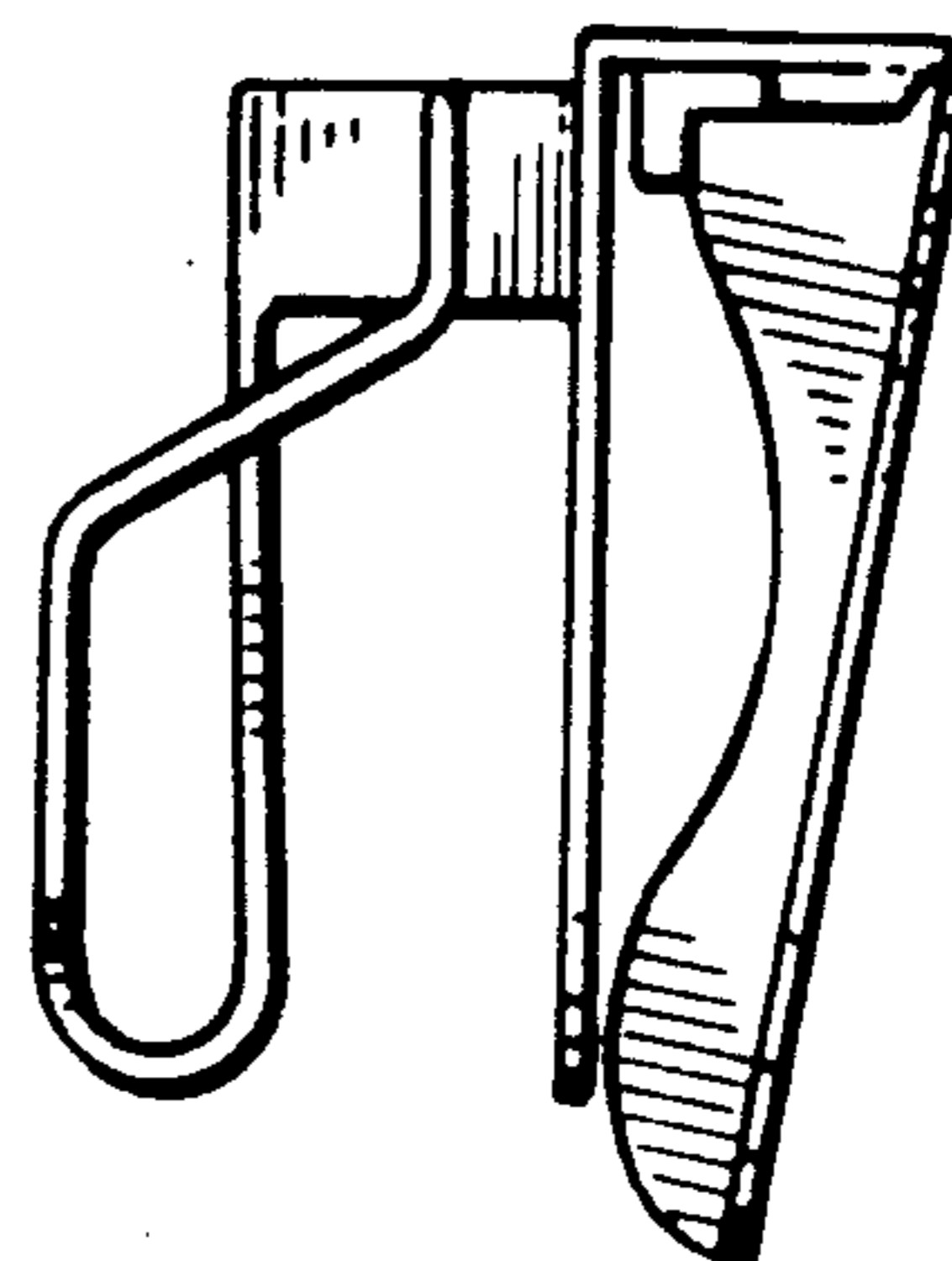
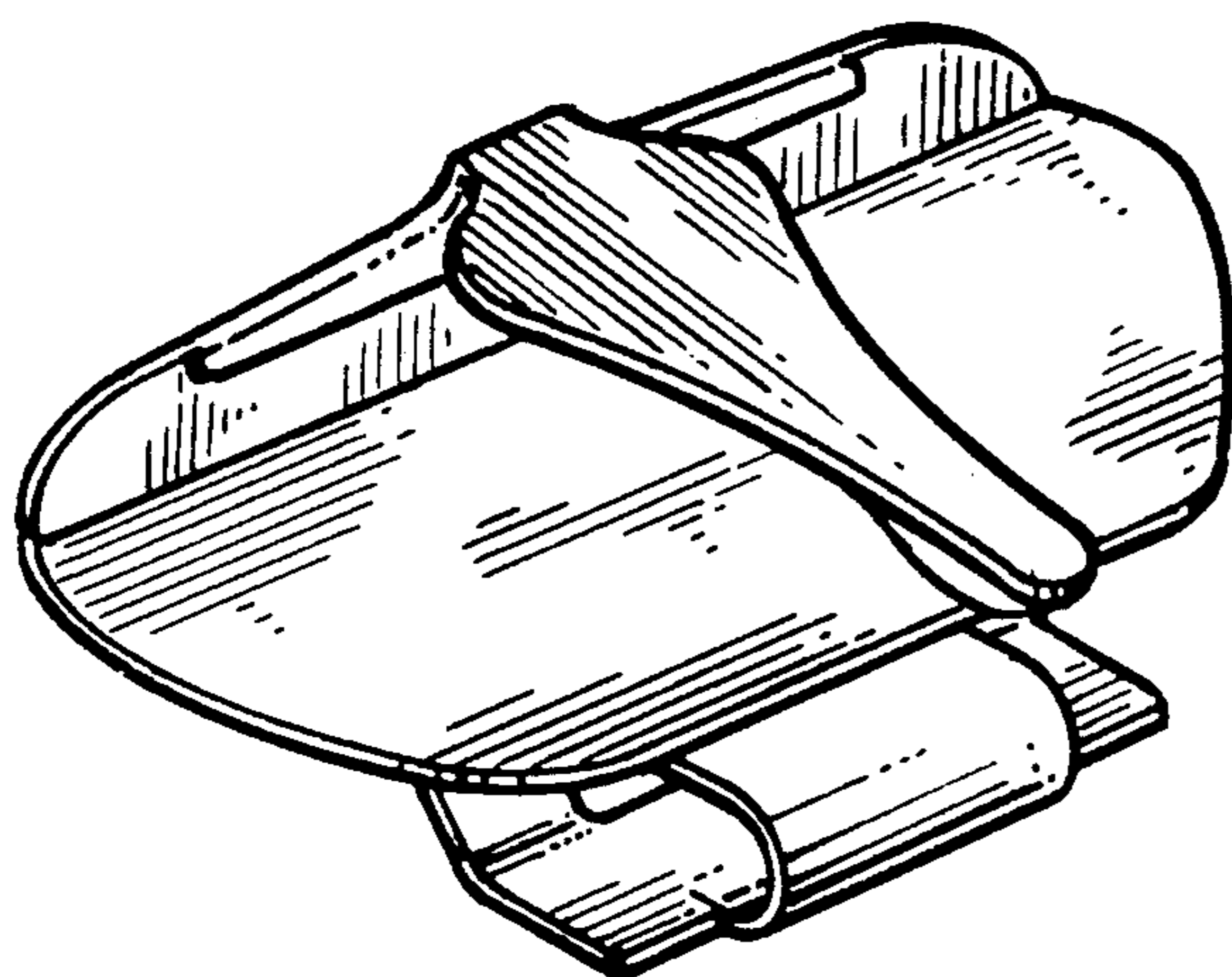

[57] **CLAIM**

The ornamental design for a holder for eyeglasses, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a holder for eyeglasses showing my new design;
FIG. 2 is an end elevational view thereof;
FIG. 3 is a front elevational view thereof;
FIG. 4 is an end elevational view showing the opposite end of FIG. 2;
FIG. 5 is a rear elevational view thereof;
FIG. 6 is a top plan view thereof;
FIG. 7 is a bottom plan view thereof; and
FIG. 8 is a rear perspective view thereof.



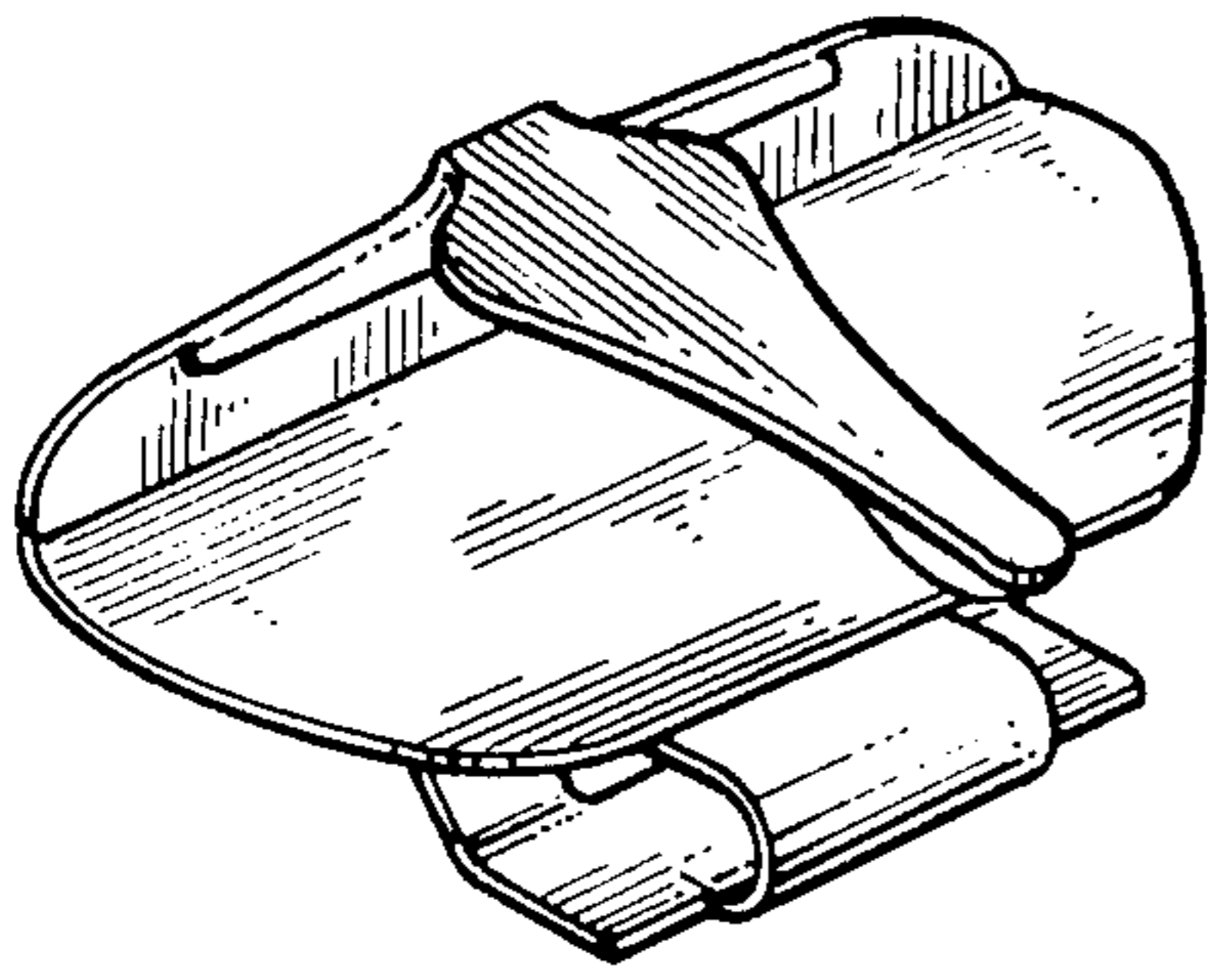

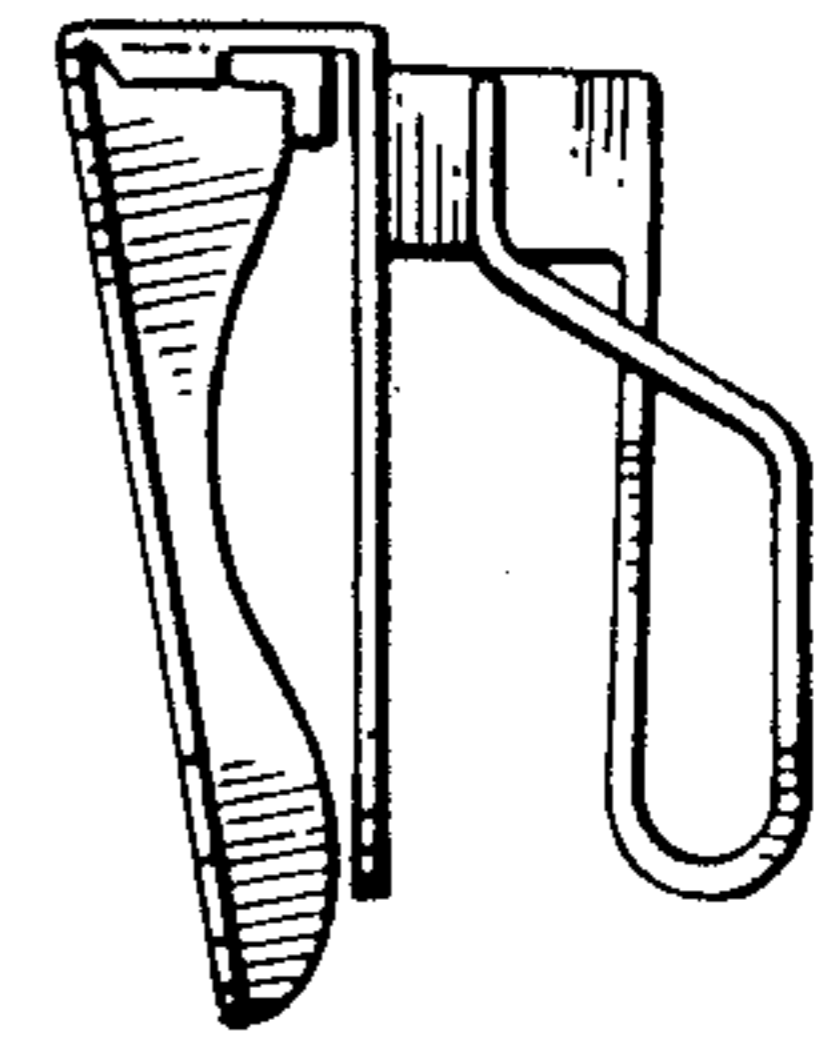
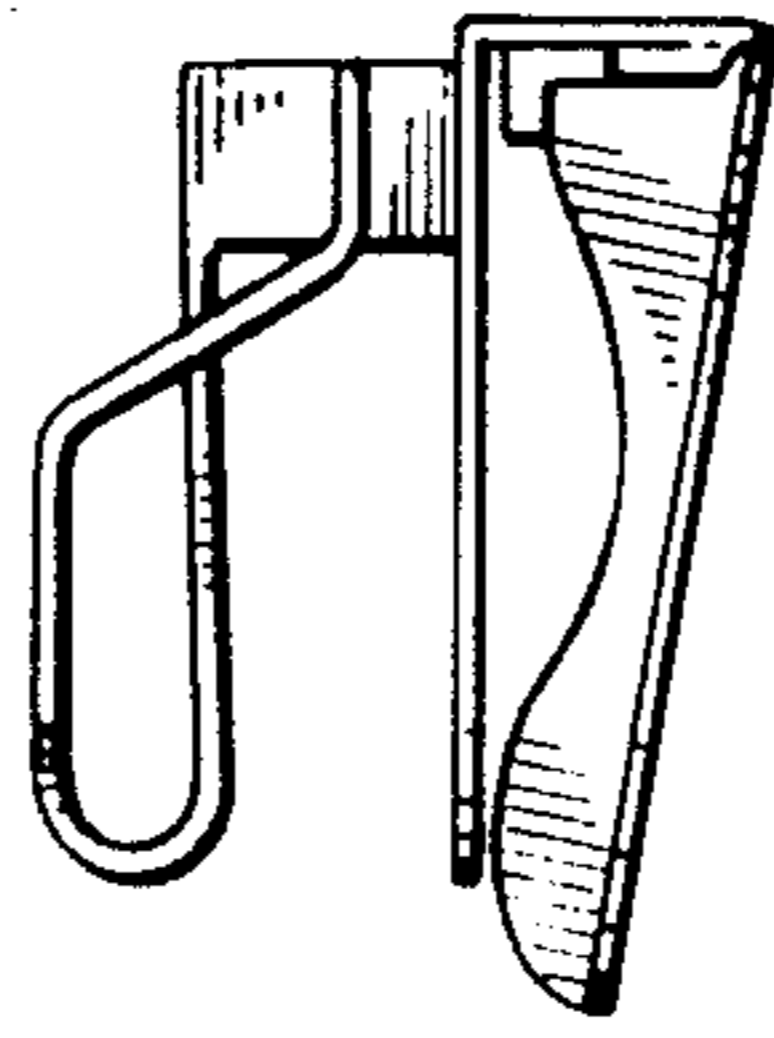

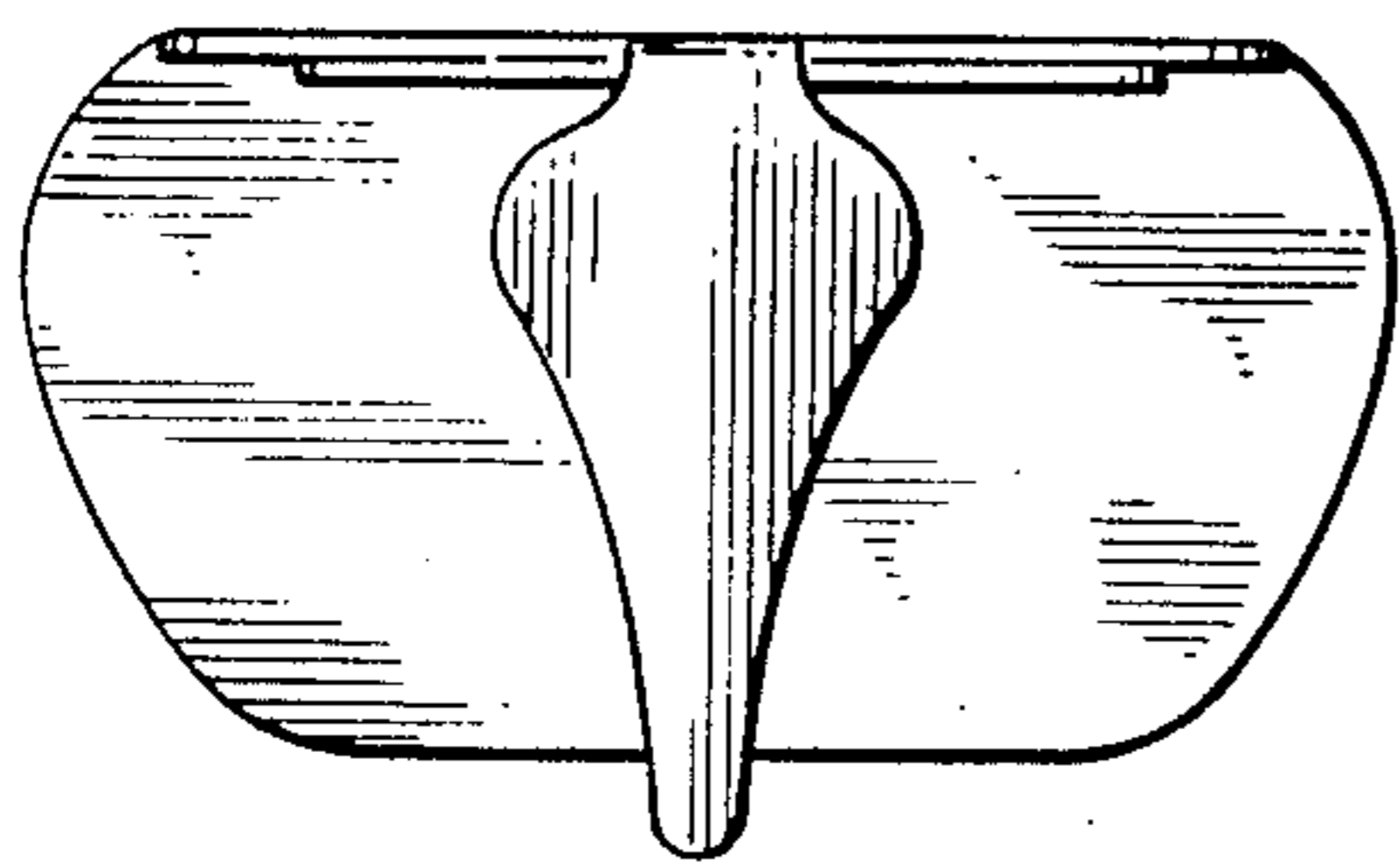

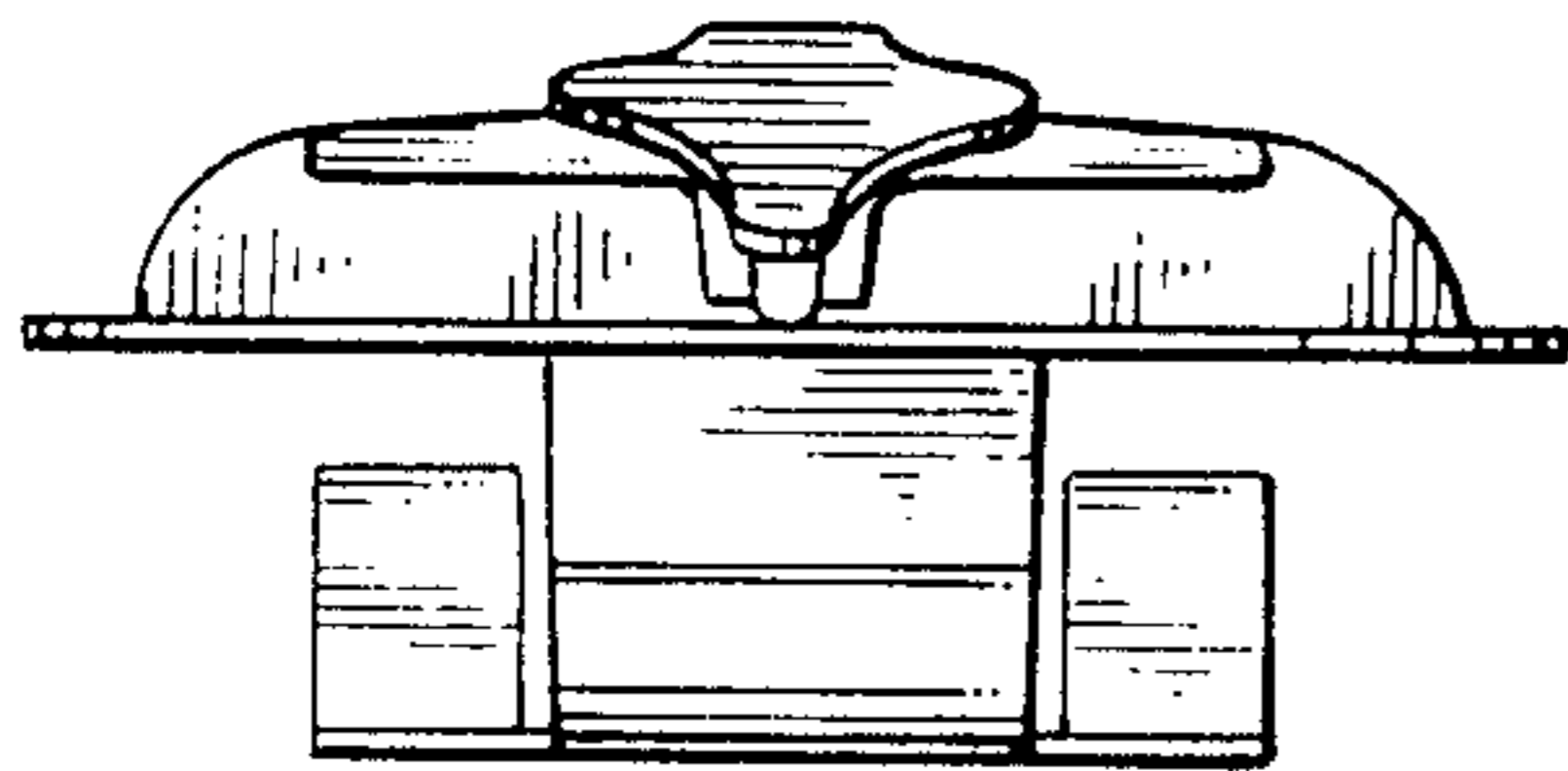
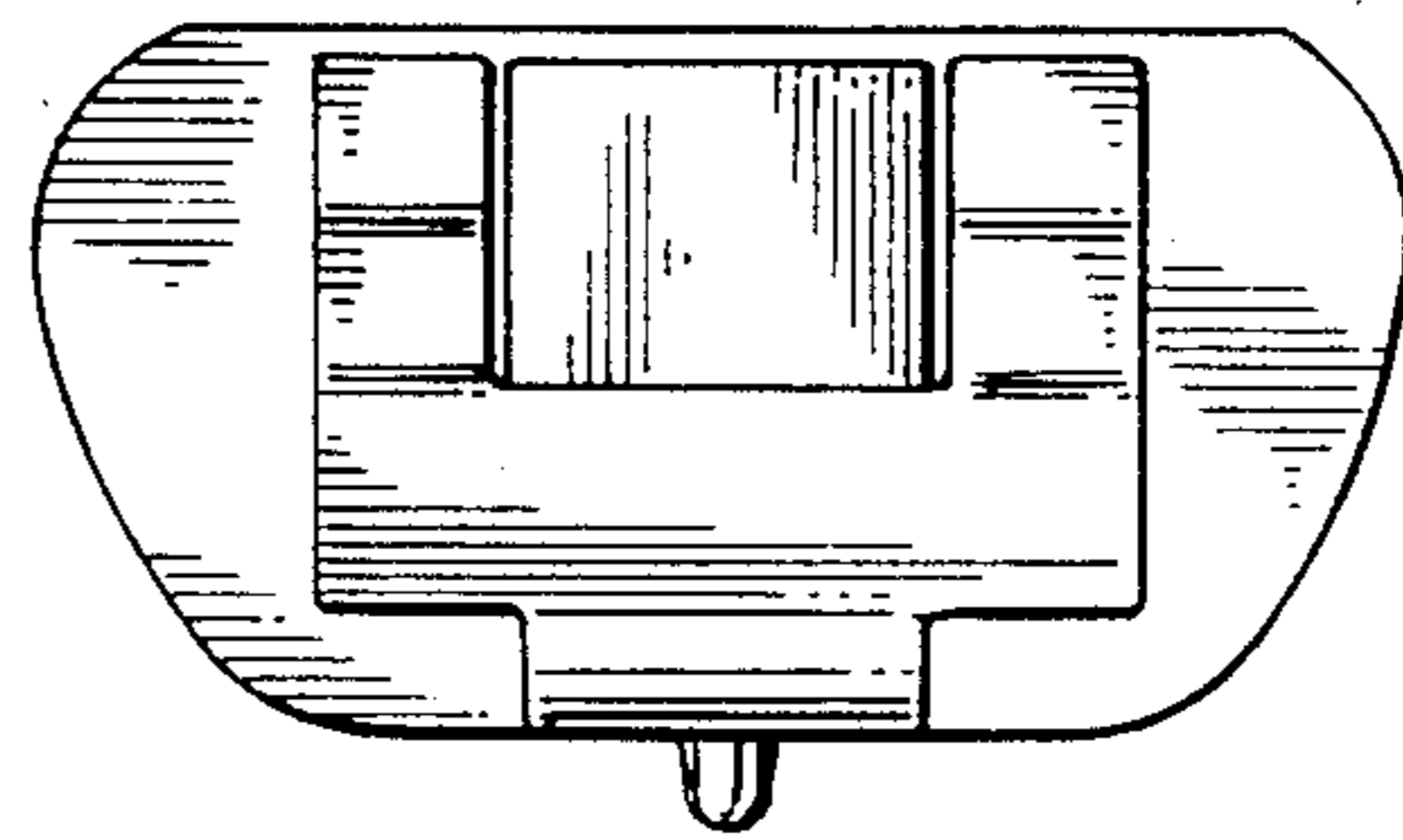

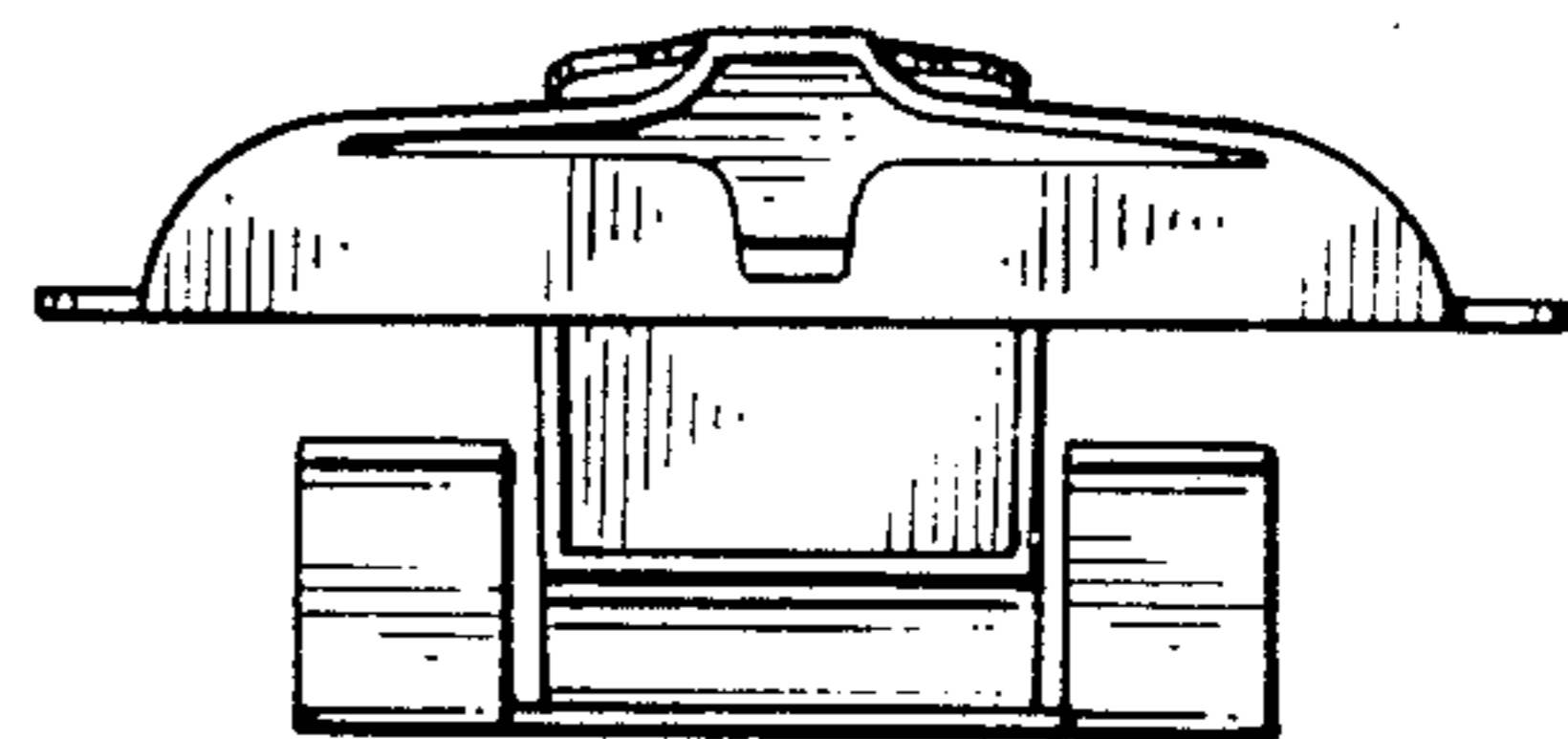

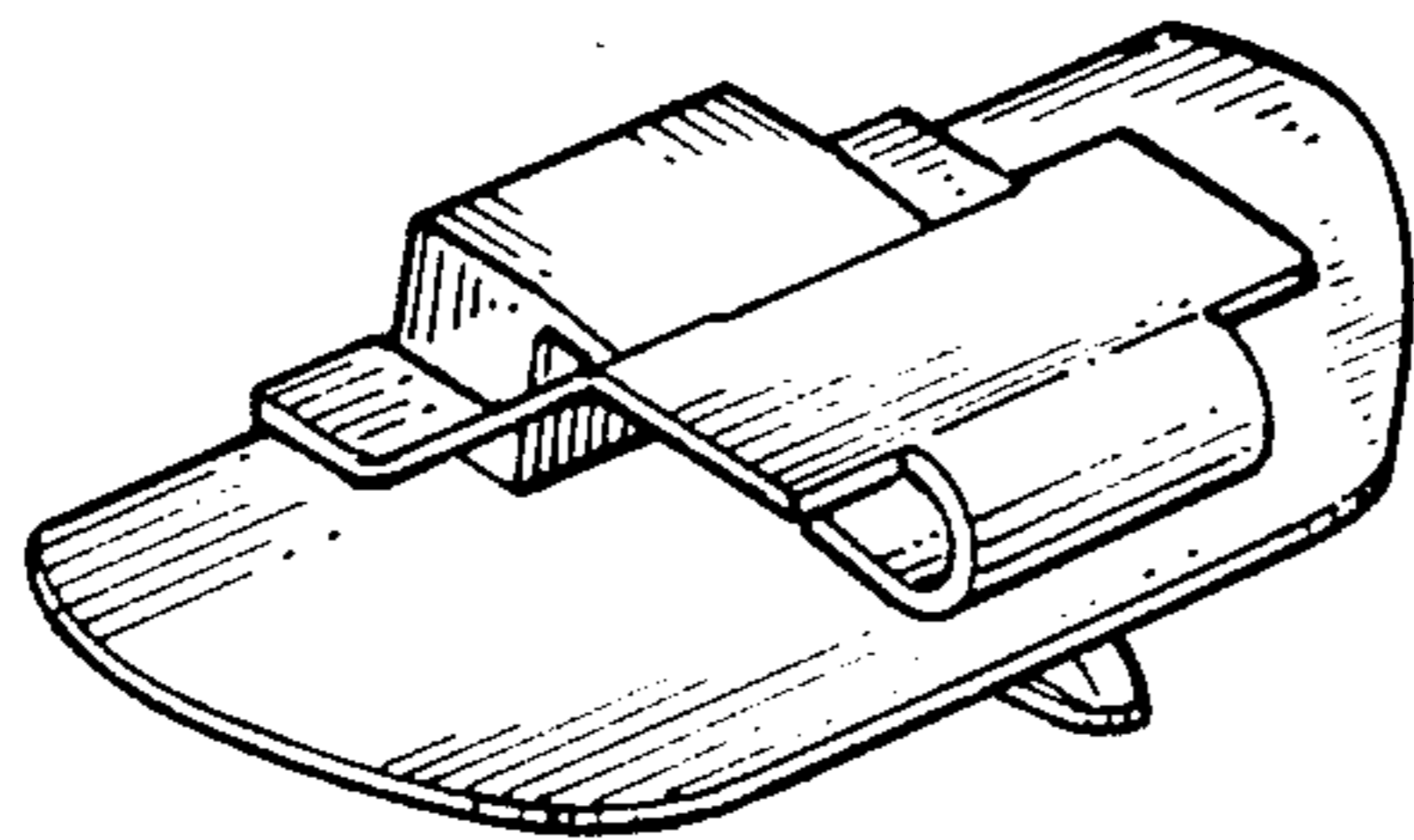
