

[57] CLAIM

The ornamental design for a front panel for a water temperature controller, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a front panel for a water temperature controller showing our new design;
FIG. 2 is a rear elevational view;
FIG. 3 is a left side sectional view, taken along line 1-1 in FIG. 1;
FIG. 4 is a right side sectional view, taken along line 1—1 in FIG. 1;
FIG. 5 is a top plan view;
FIG. 6 is a bottom plan view;
FIG. 7 is a front and right side perspective view;
FIG. 8 is a front elevational view of another embodiment of FIGS. 1-7;
FIG. 9 is a rear elevational view;
FIG. 10 is a left side sectional view, taken along line 7—7 in FIG. 7;
FIG. 11 is a right side sectional view, taken along line 7—7 in FIG. 7;
FIG. 12 is a top plan view;
FIG. 13 is a bottom plan view; and
FIG. 14 is a front and right side perspective thereof.


























