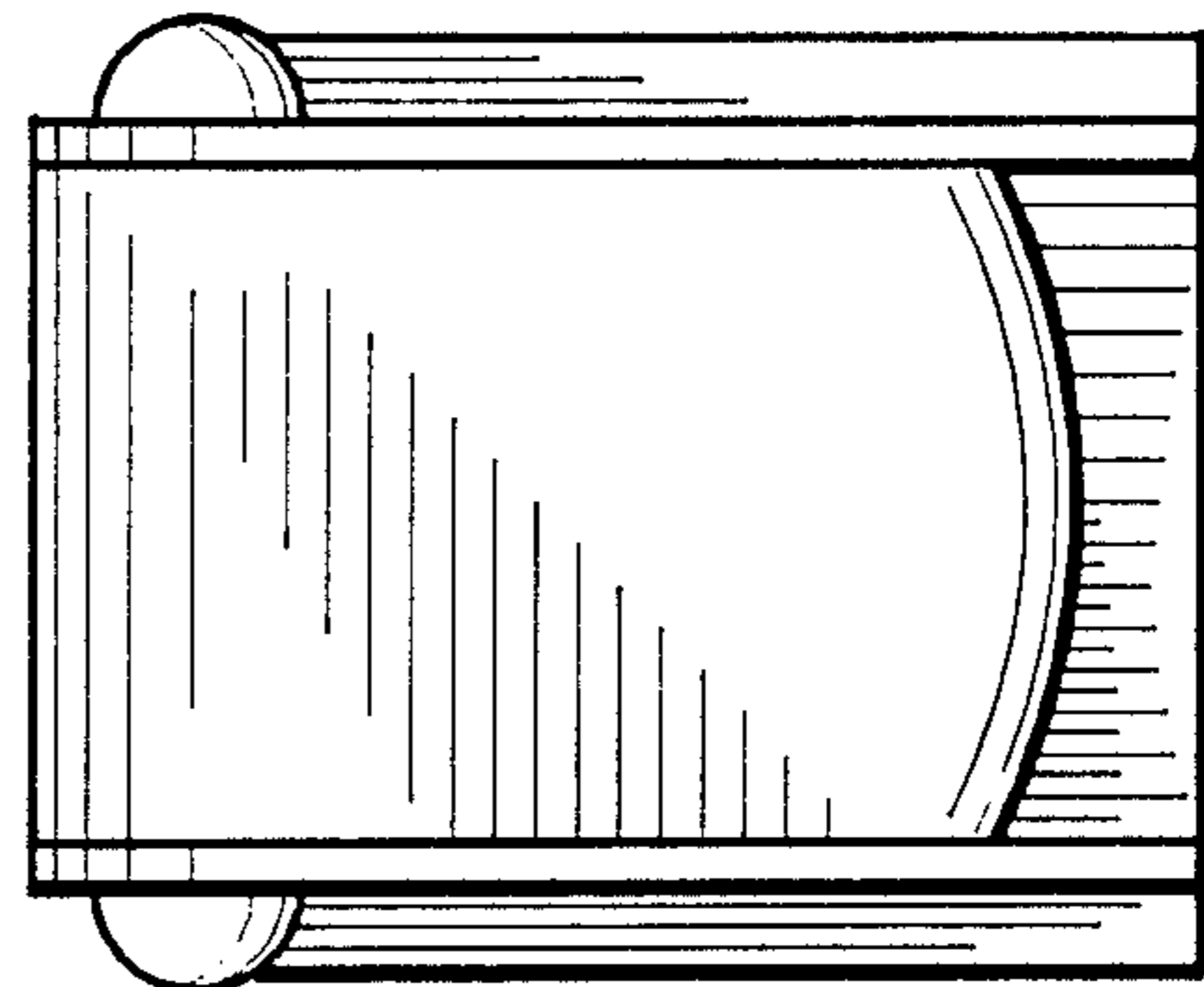
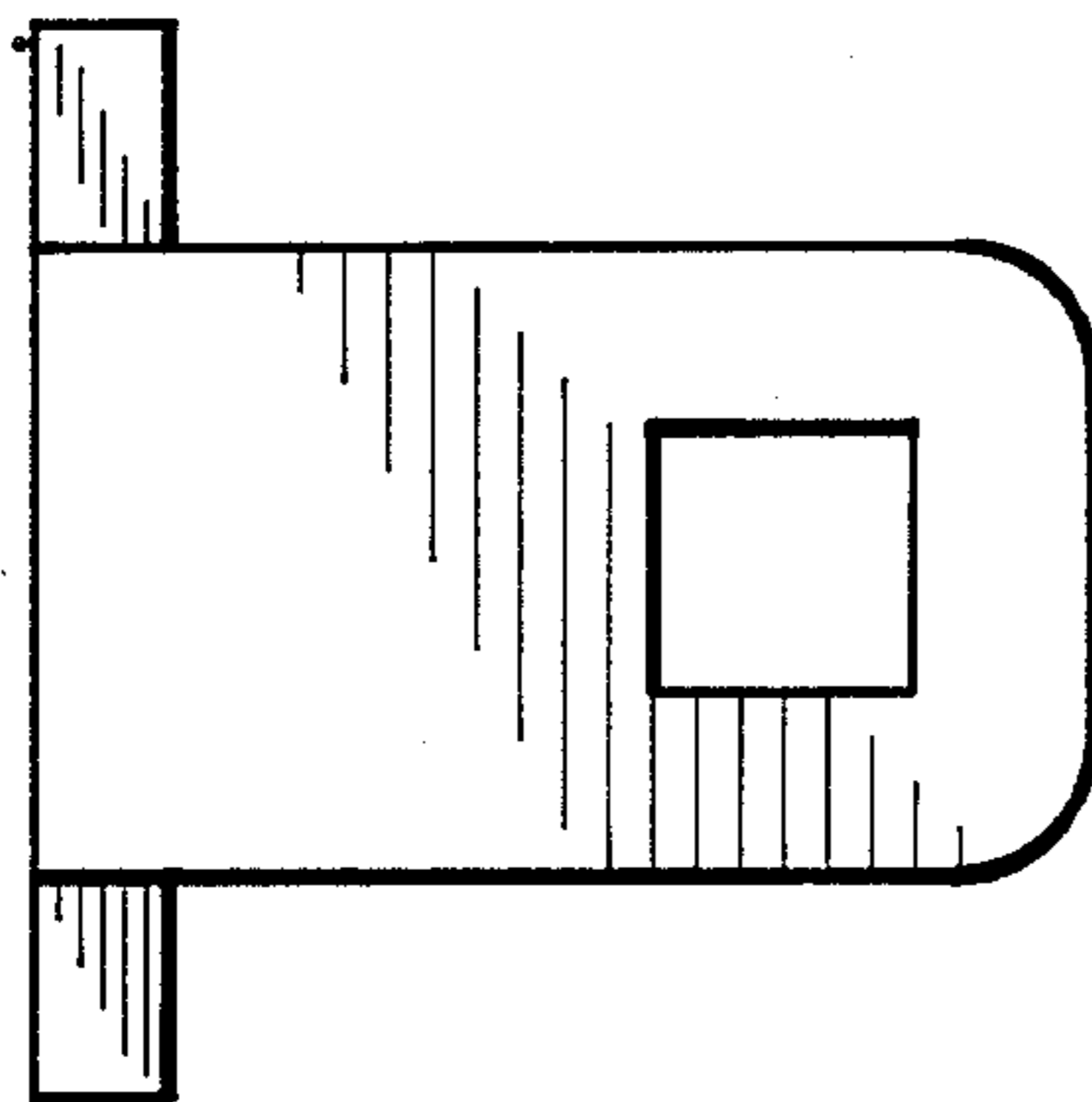

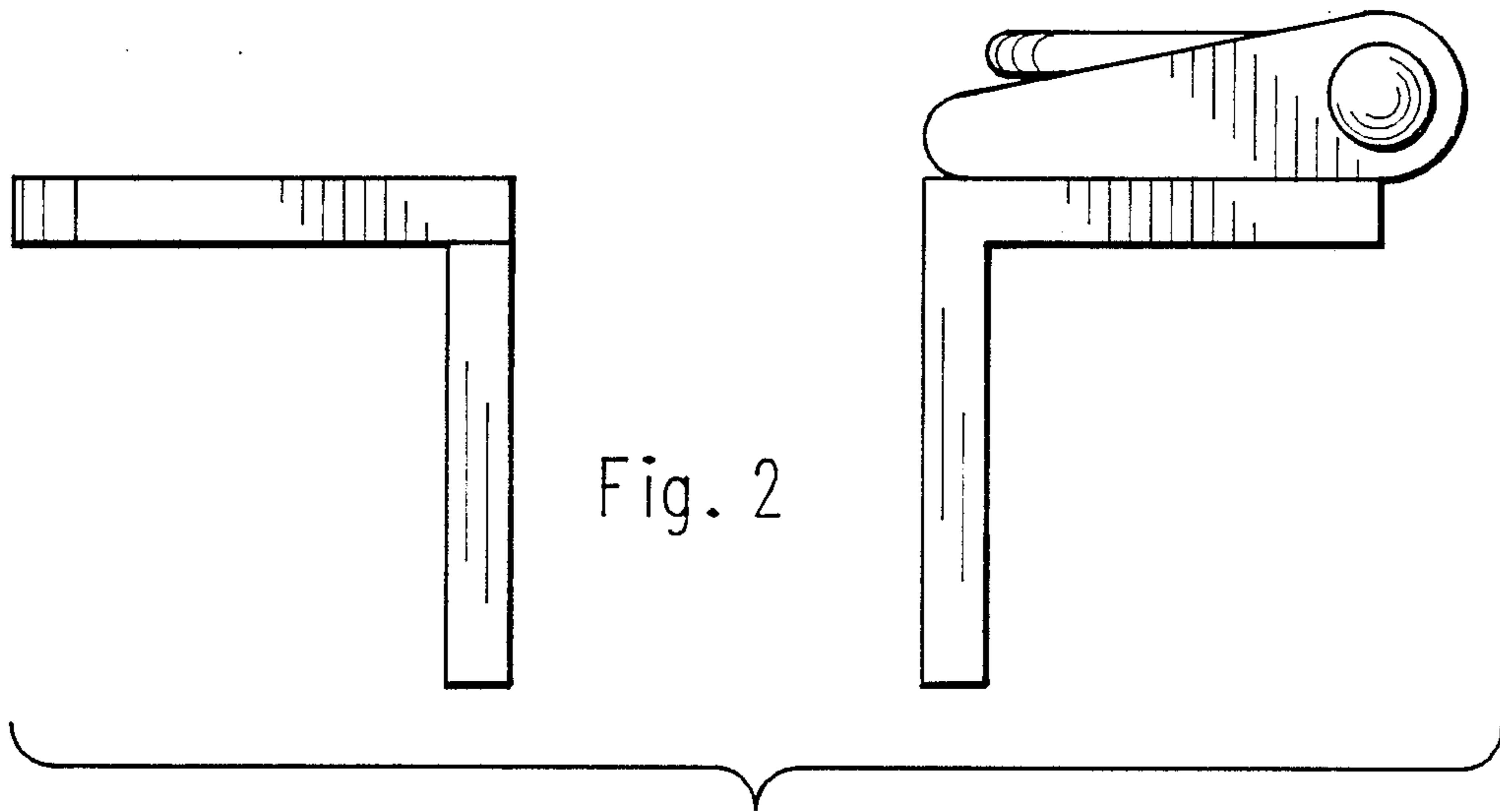
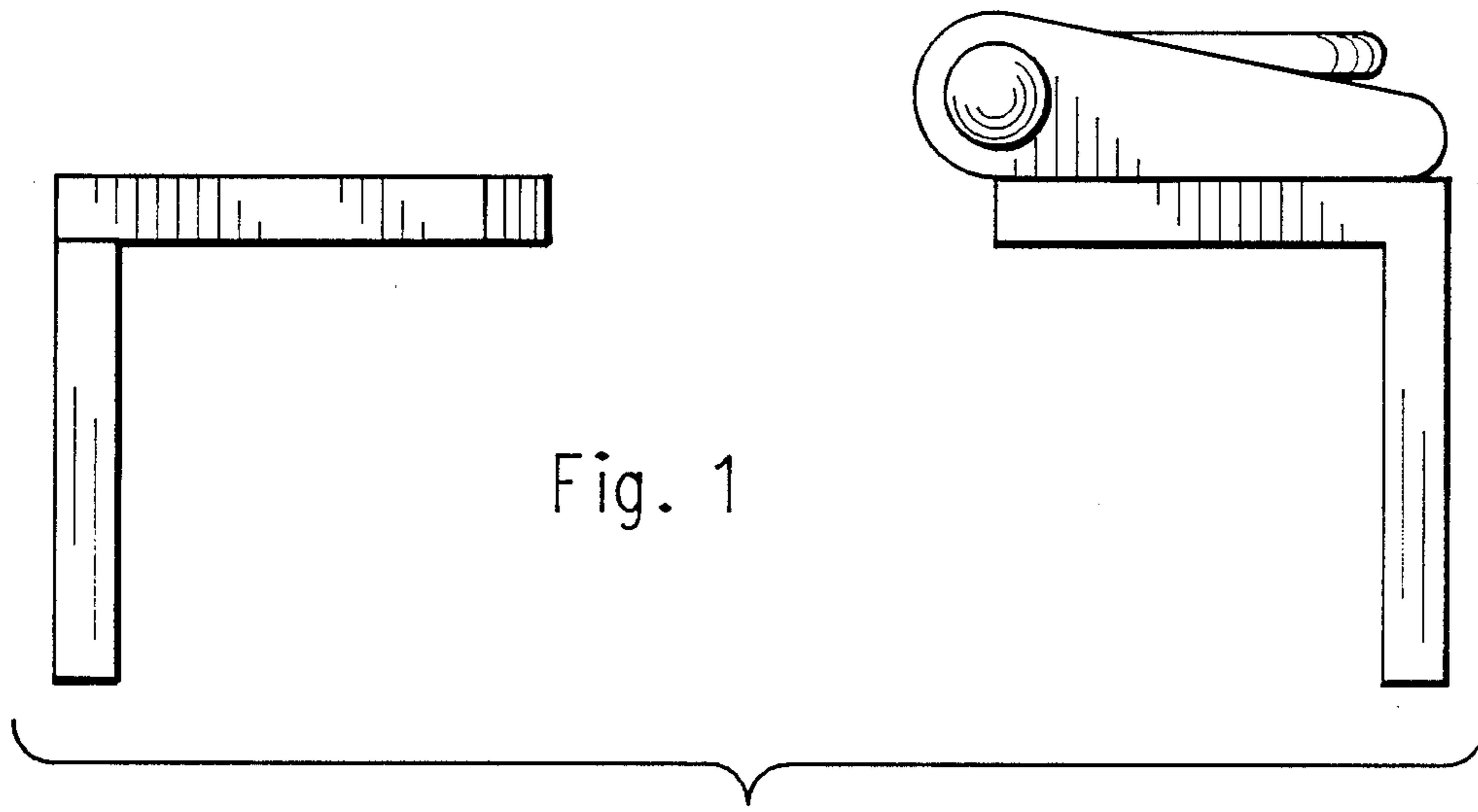
[57] **CLAIM**

The ornamental design for a tractor seat belt holder set, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a bracket associated view of bolt components of a tractor seat belt holder set showing my new design;
 FIG. 2 is a bracketed rear elevational view thereof;
 FIG. 3 is a bracketed left side elevational view thereof;
 FIG. 4 is a bracketed right side elevational view thereof;
 FIG. 5 is a bracketed top plan view thereof; and
 FIG. 6 is a bracketed bottom plan view thereof.





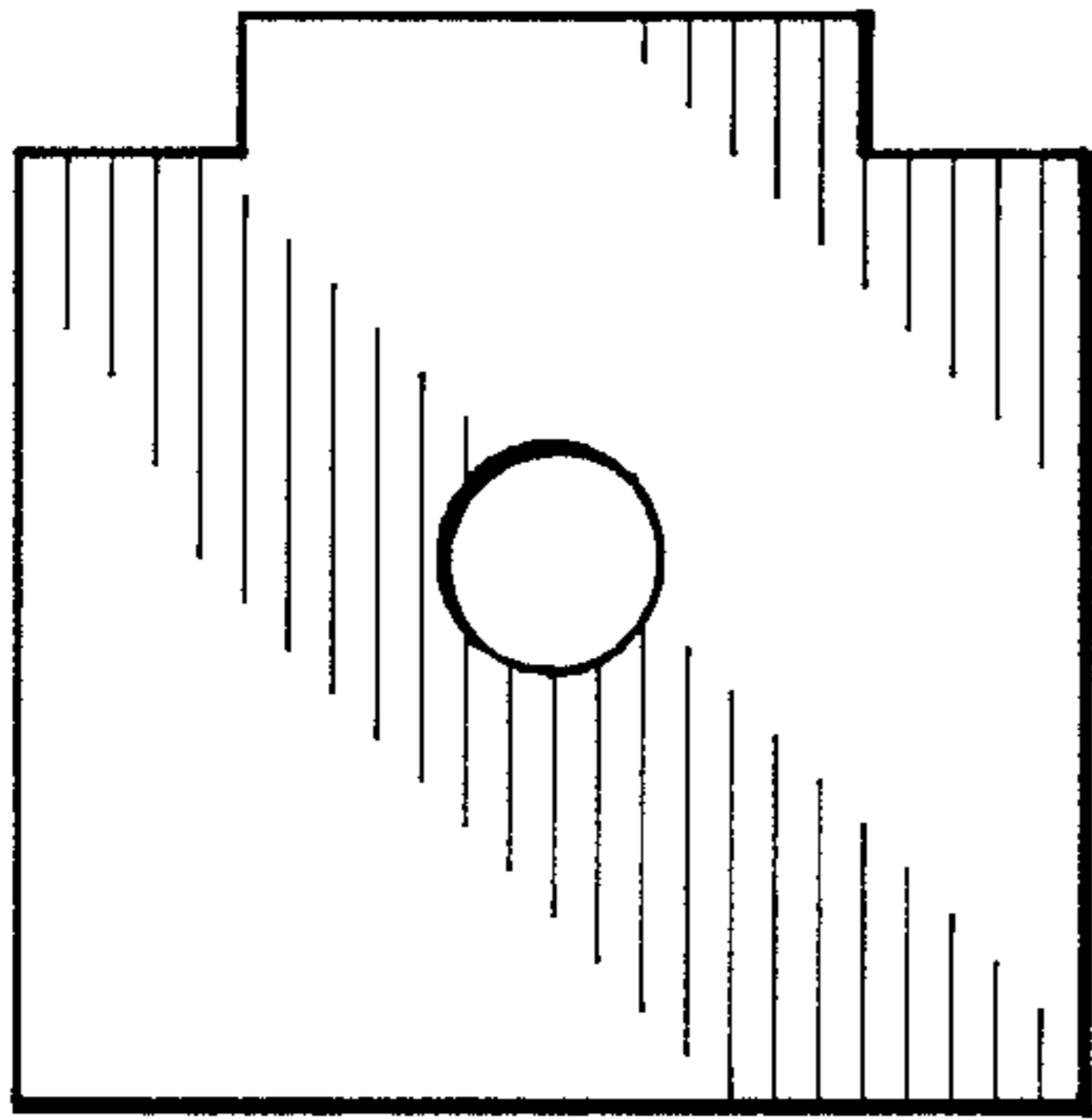

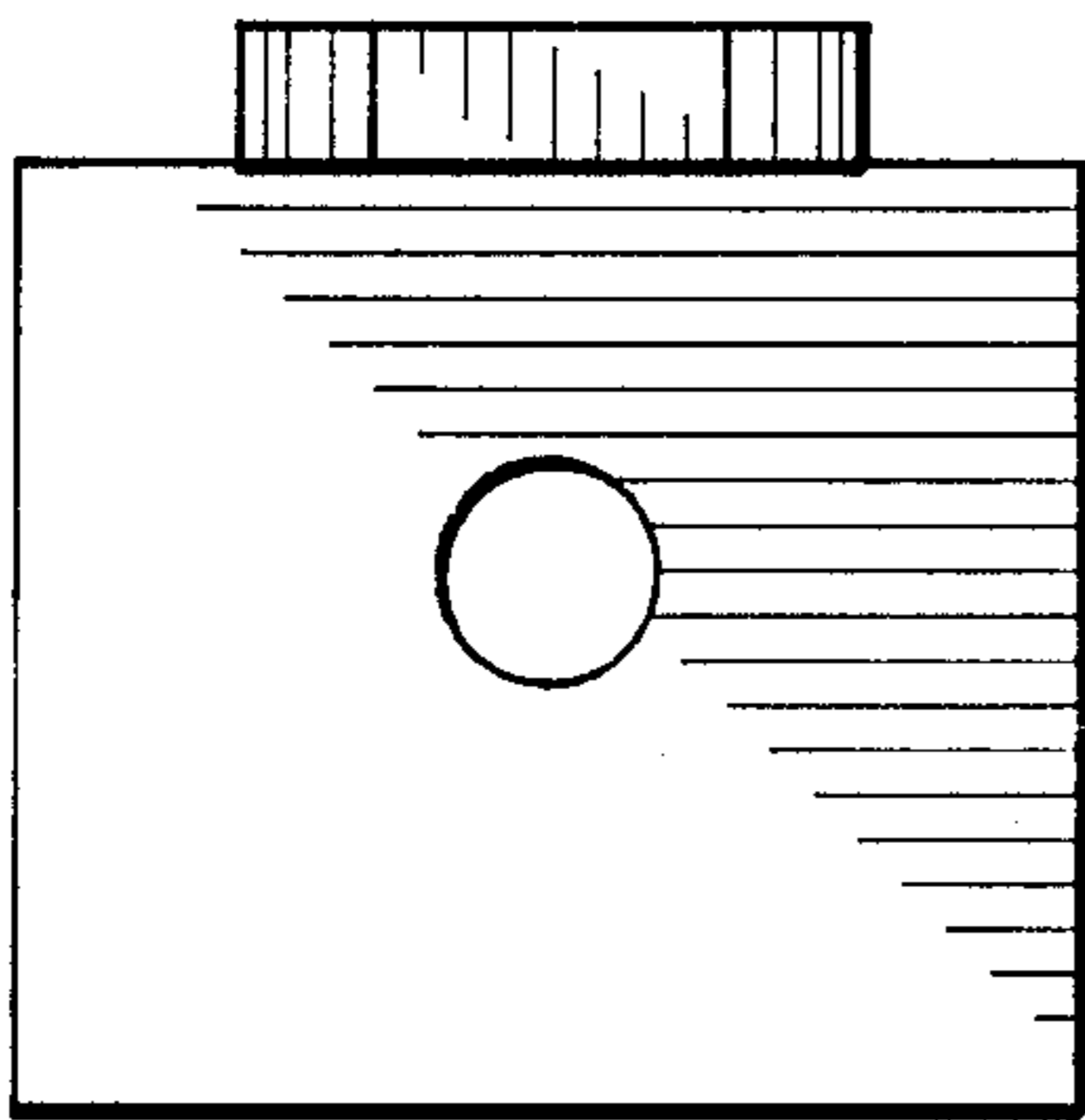
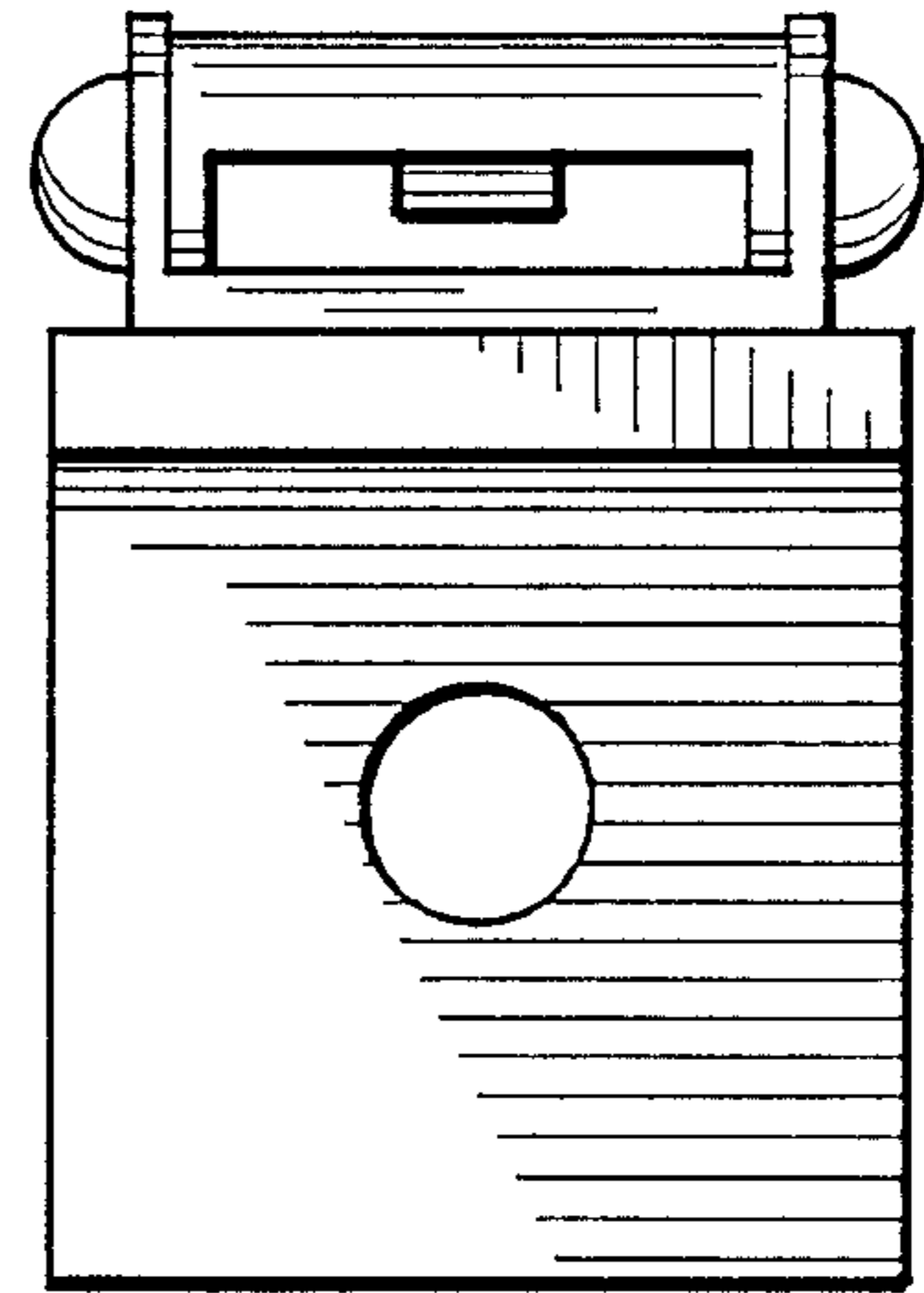
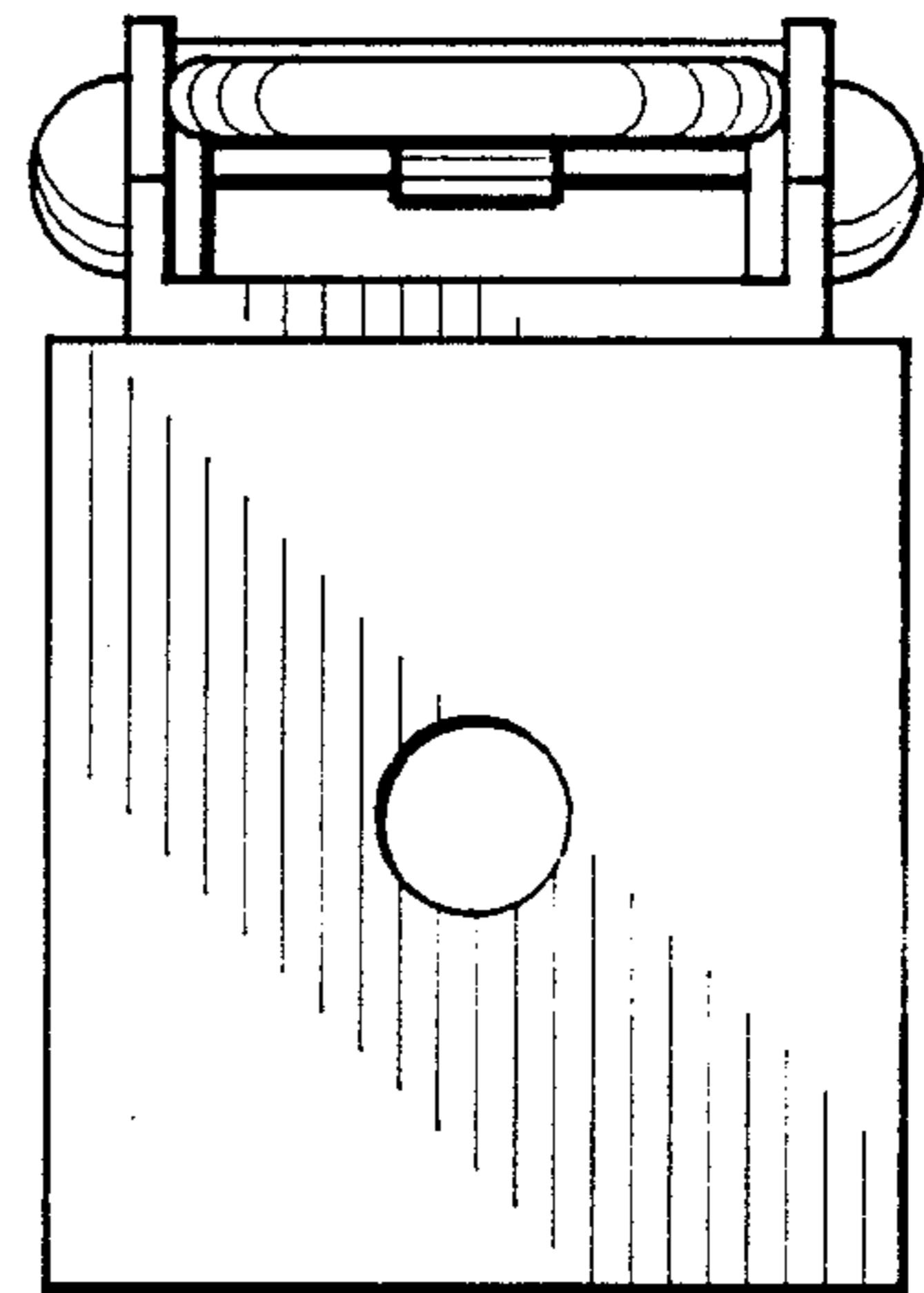

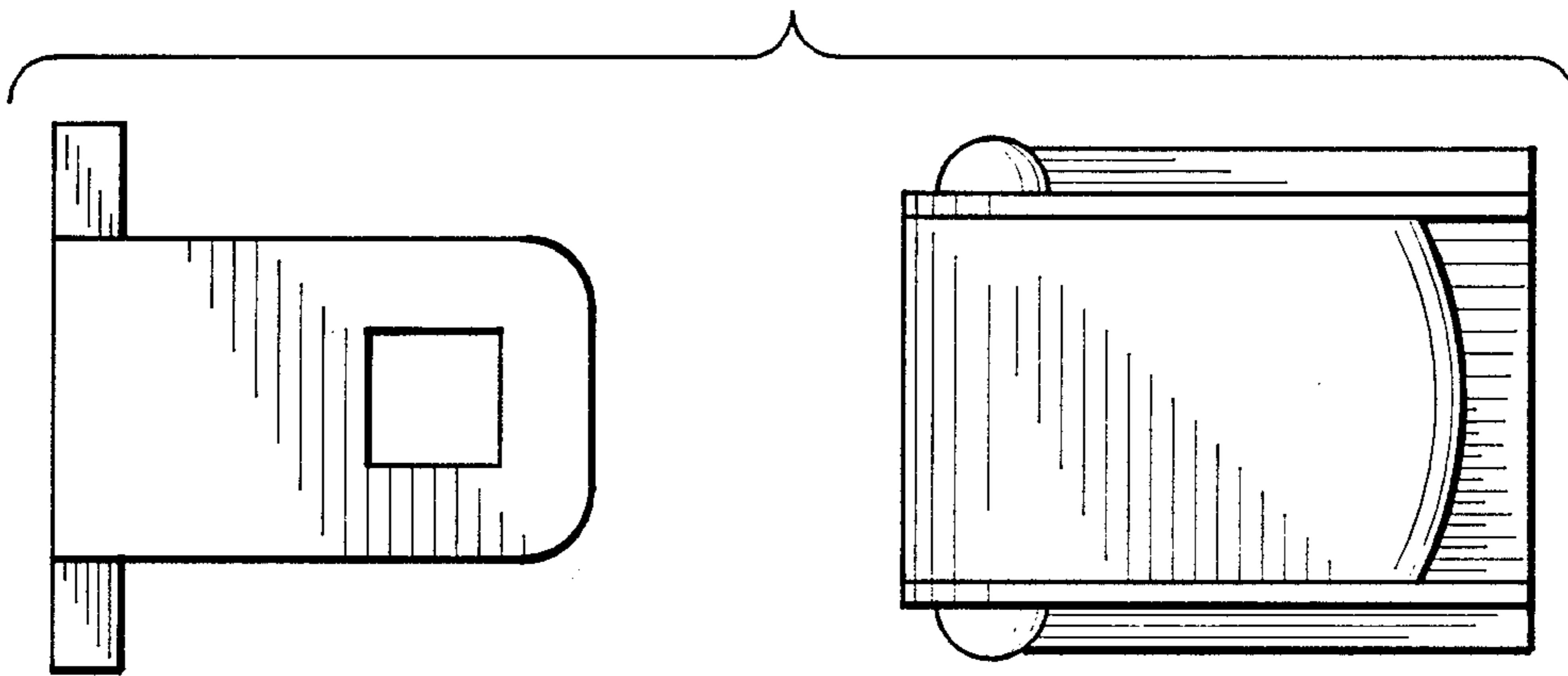

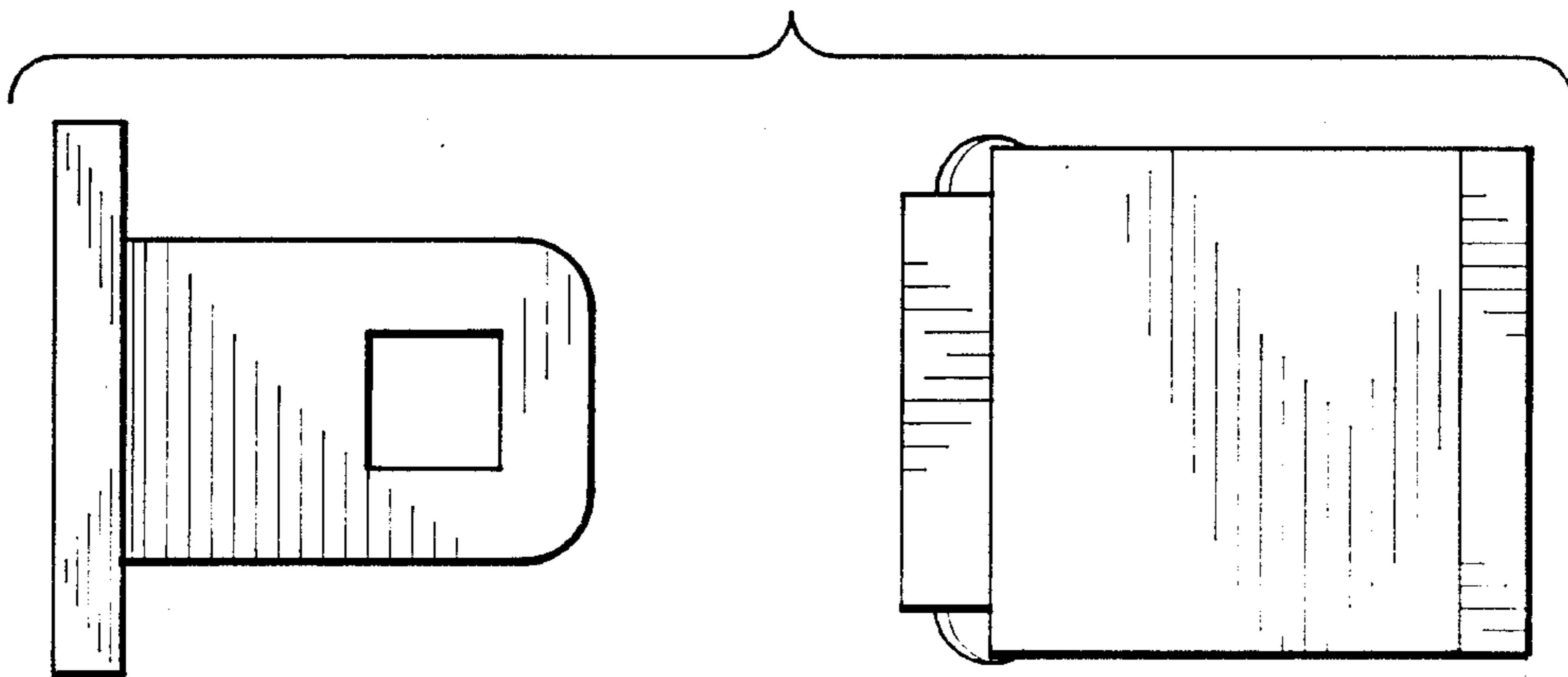
