DESCRIPTION

FIG. 1 is a front perspective combined random number electronic gaming and coupon dispensing machine;

 FIG. 7 is a front elevational view thereof.

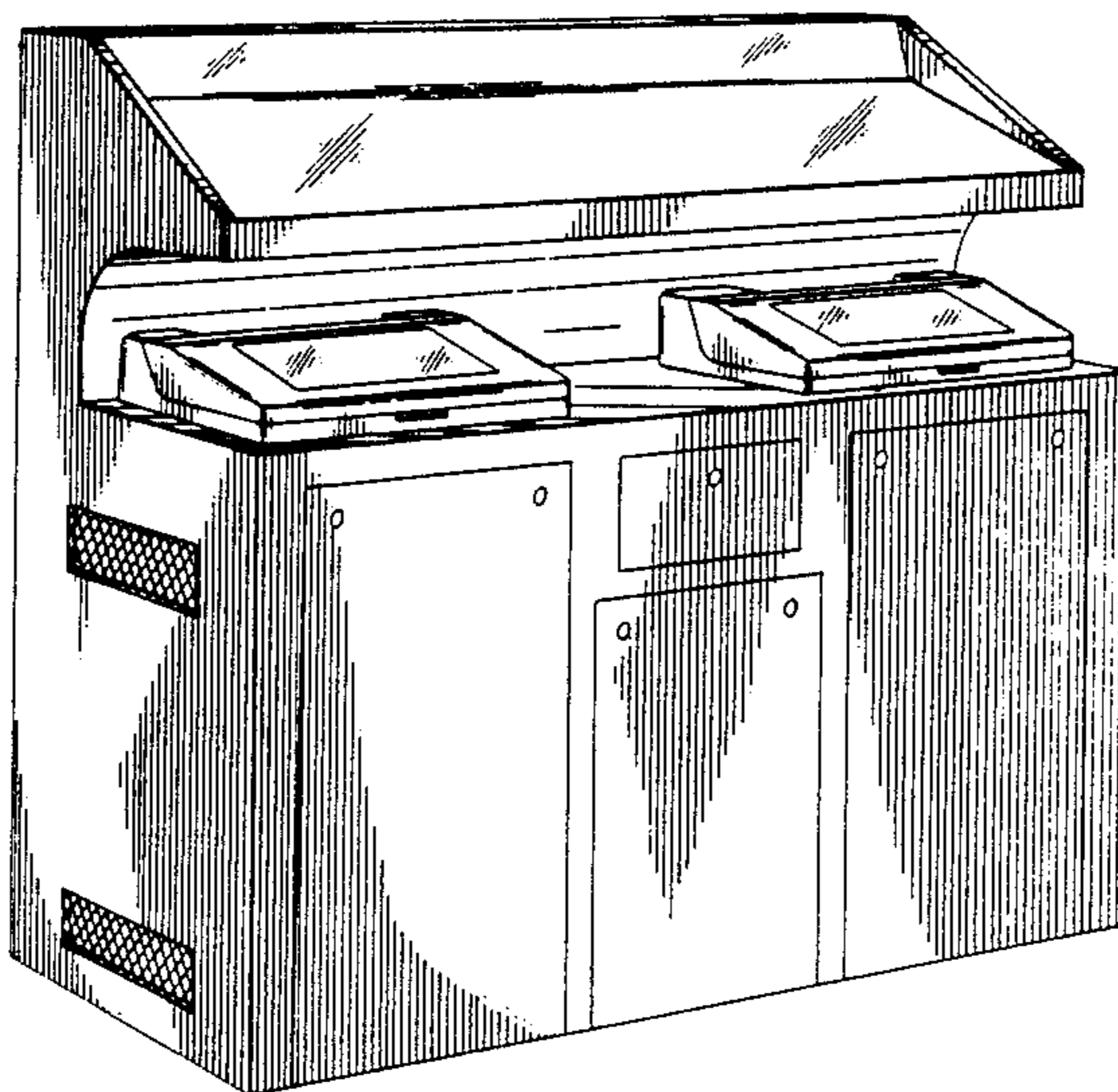

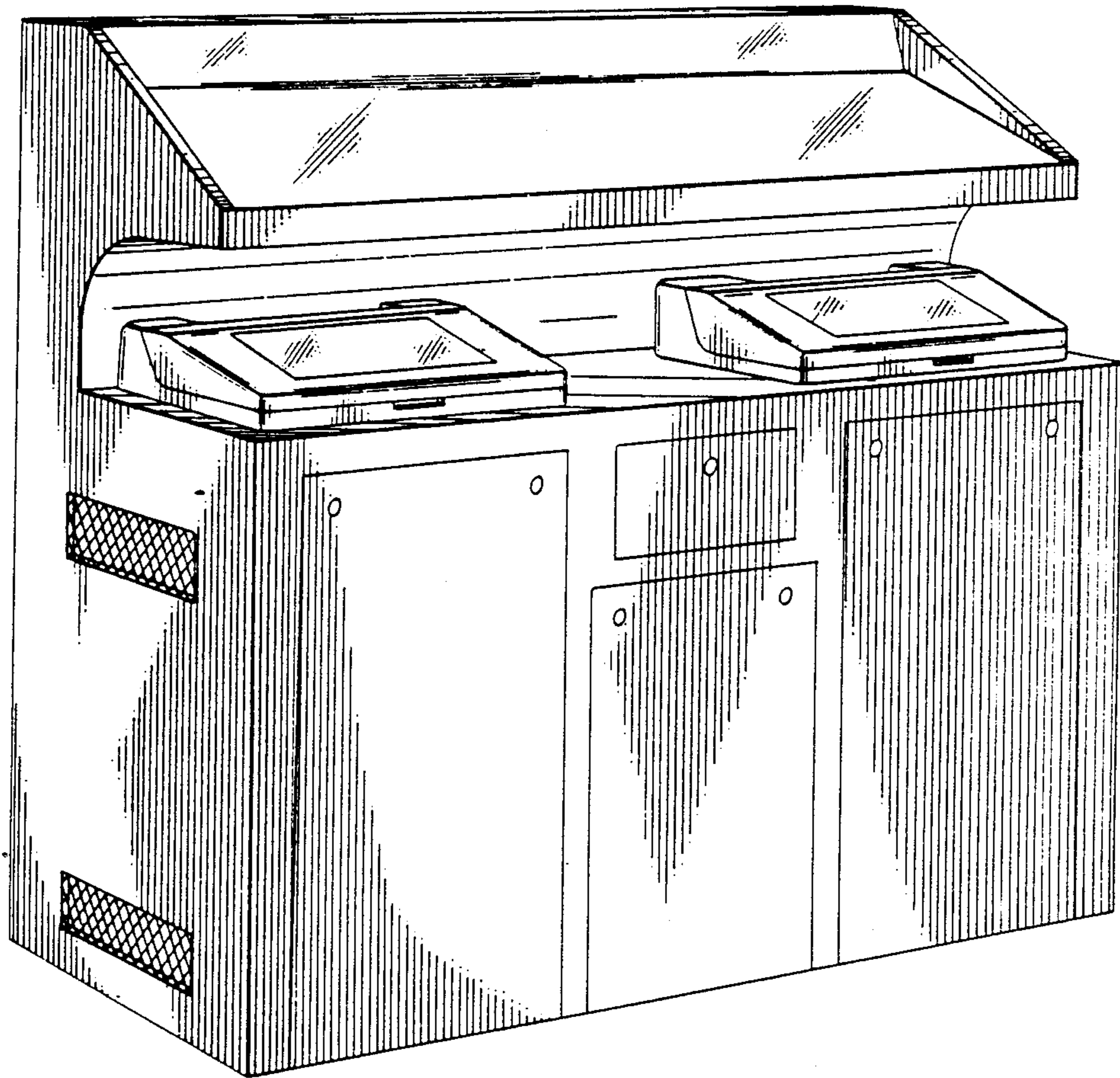

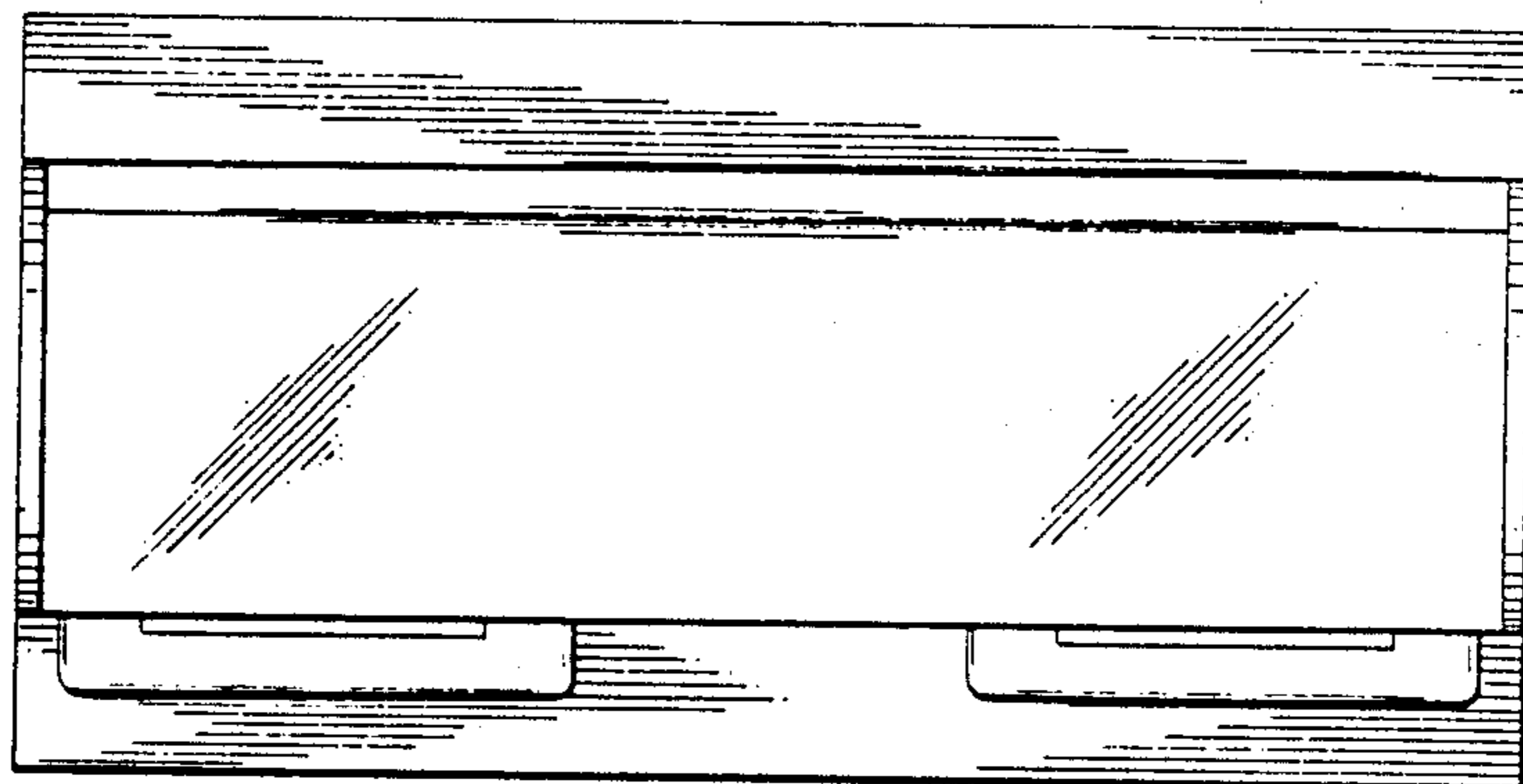

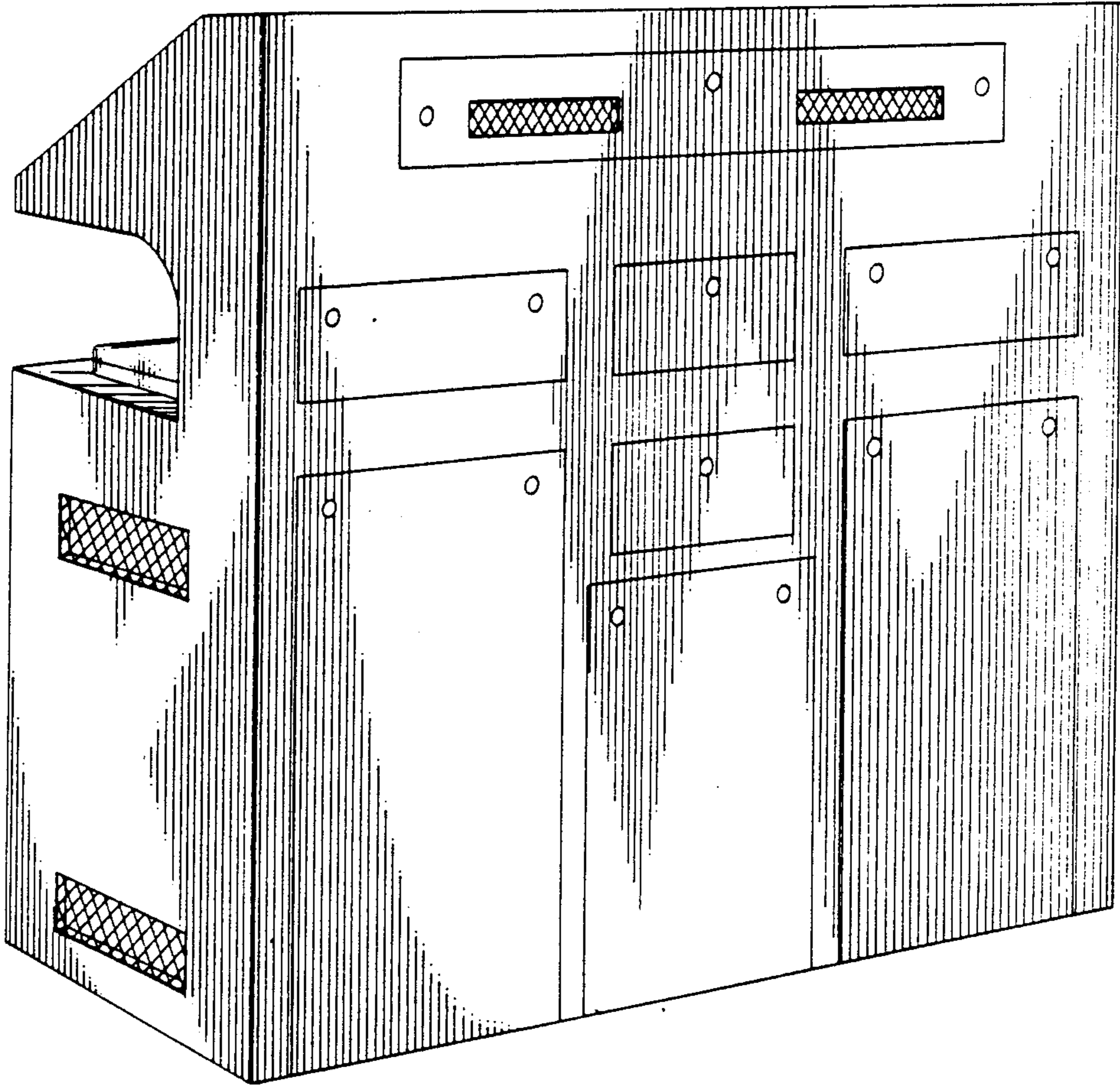

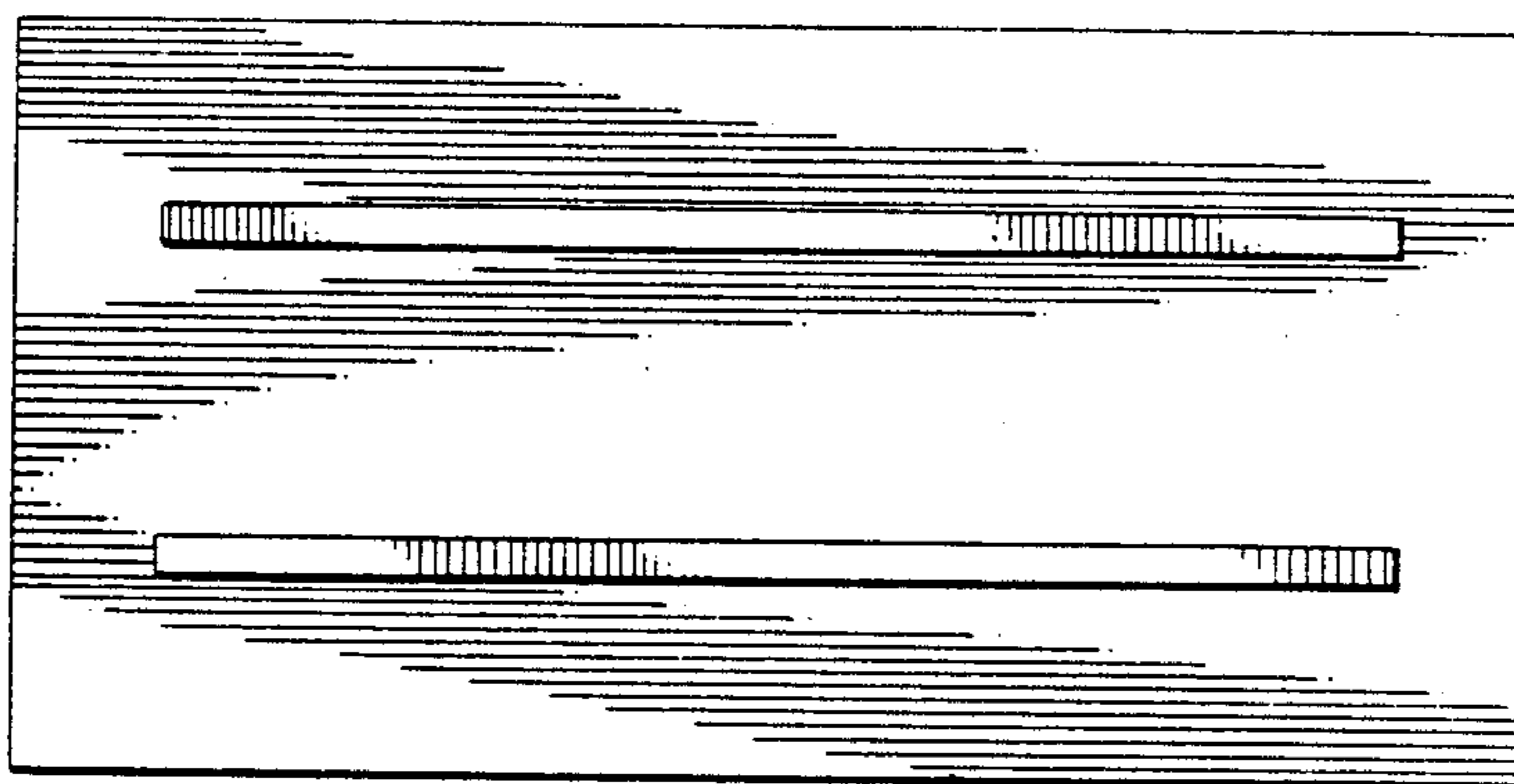

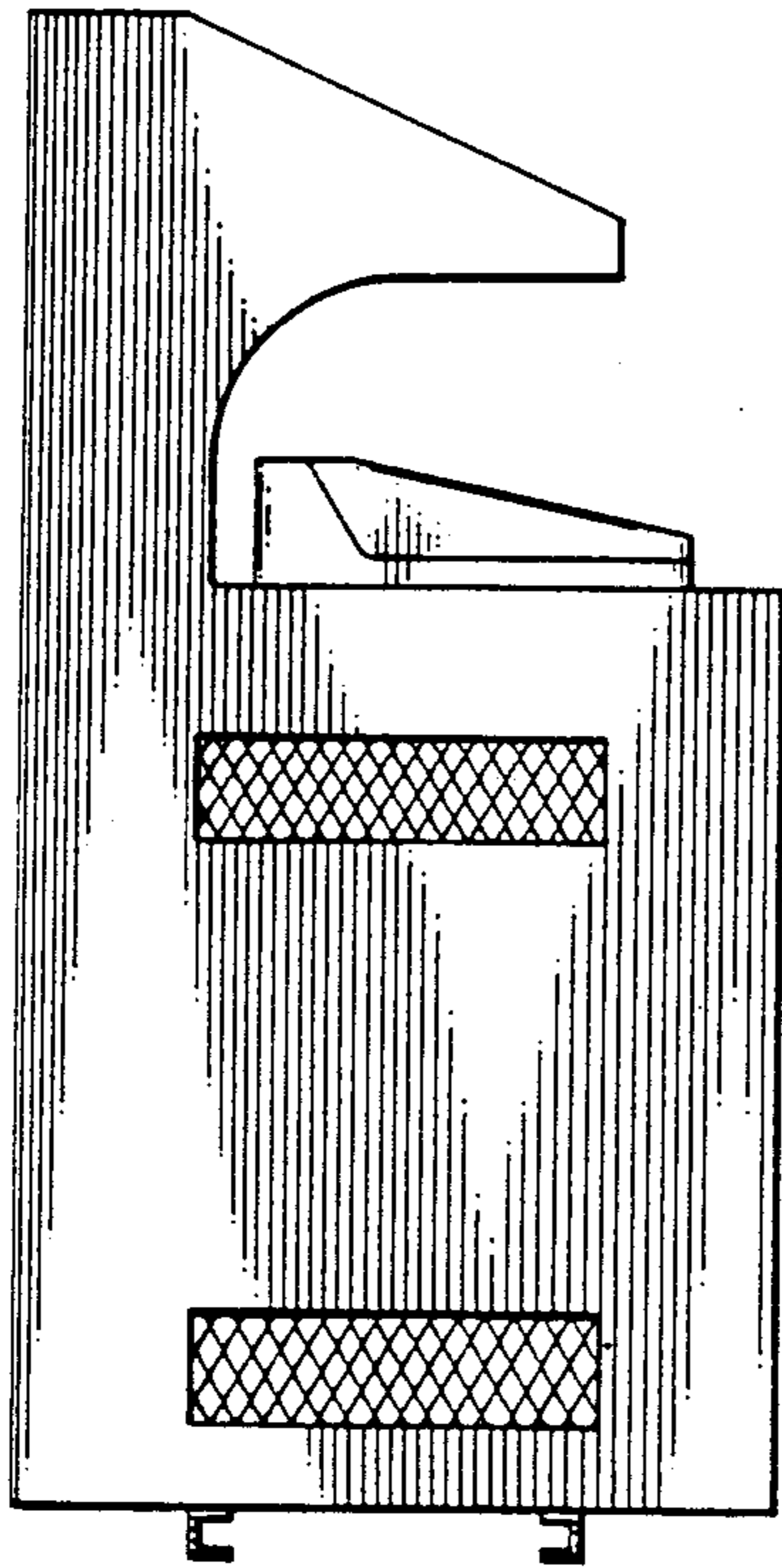

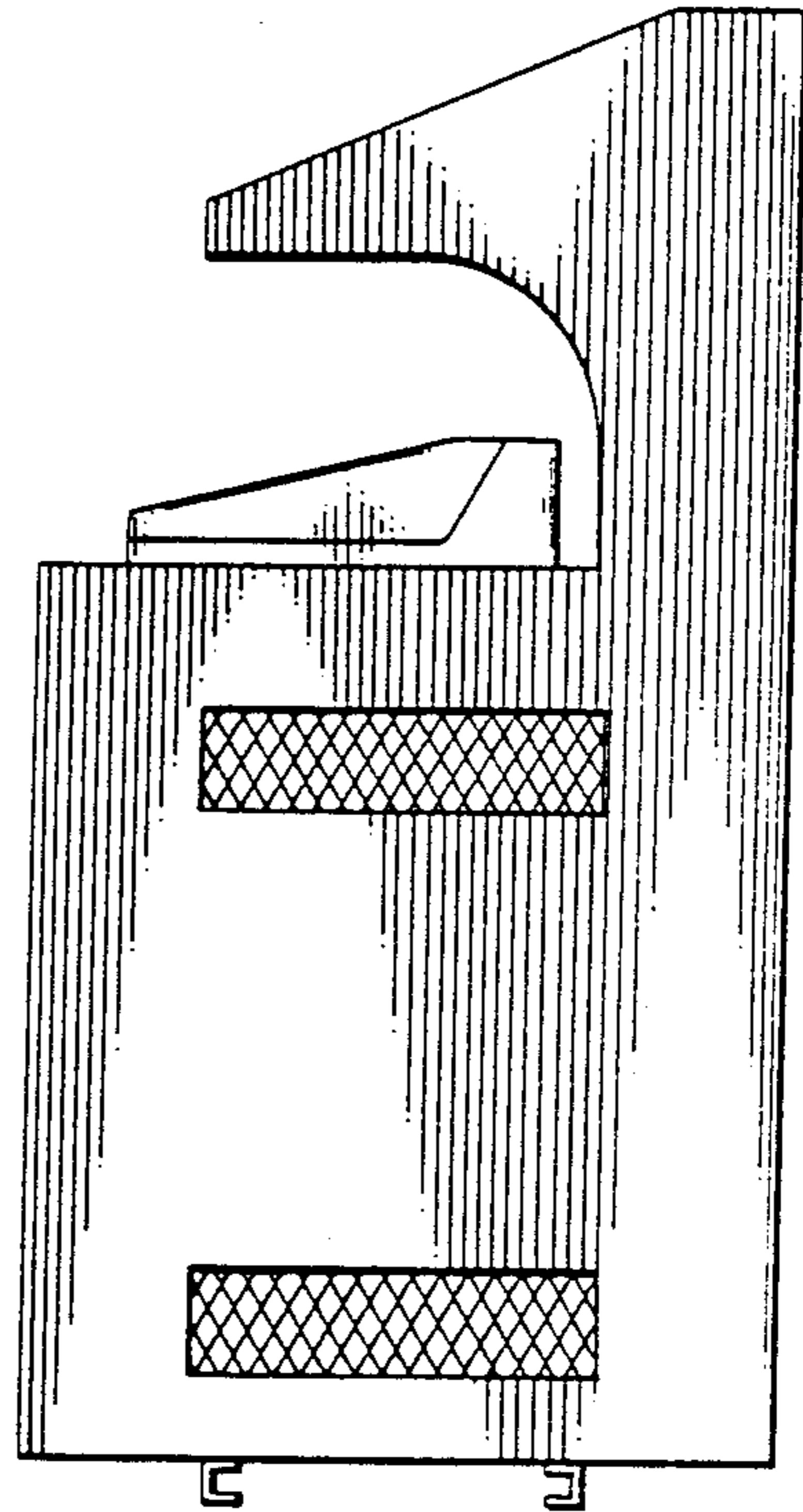
