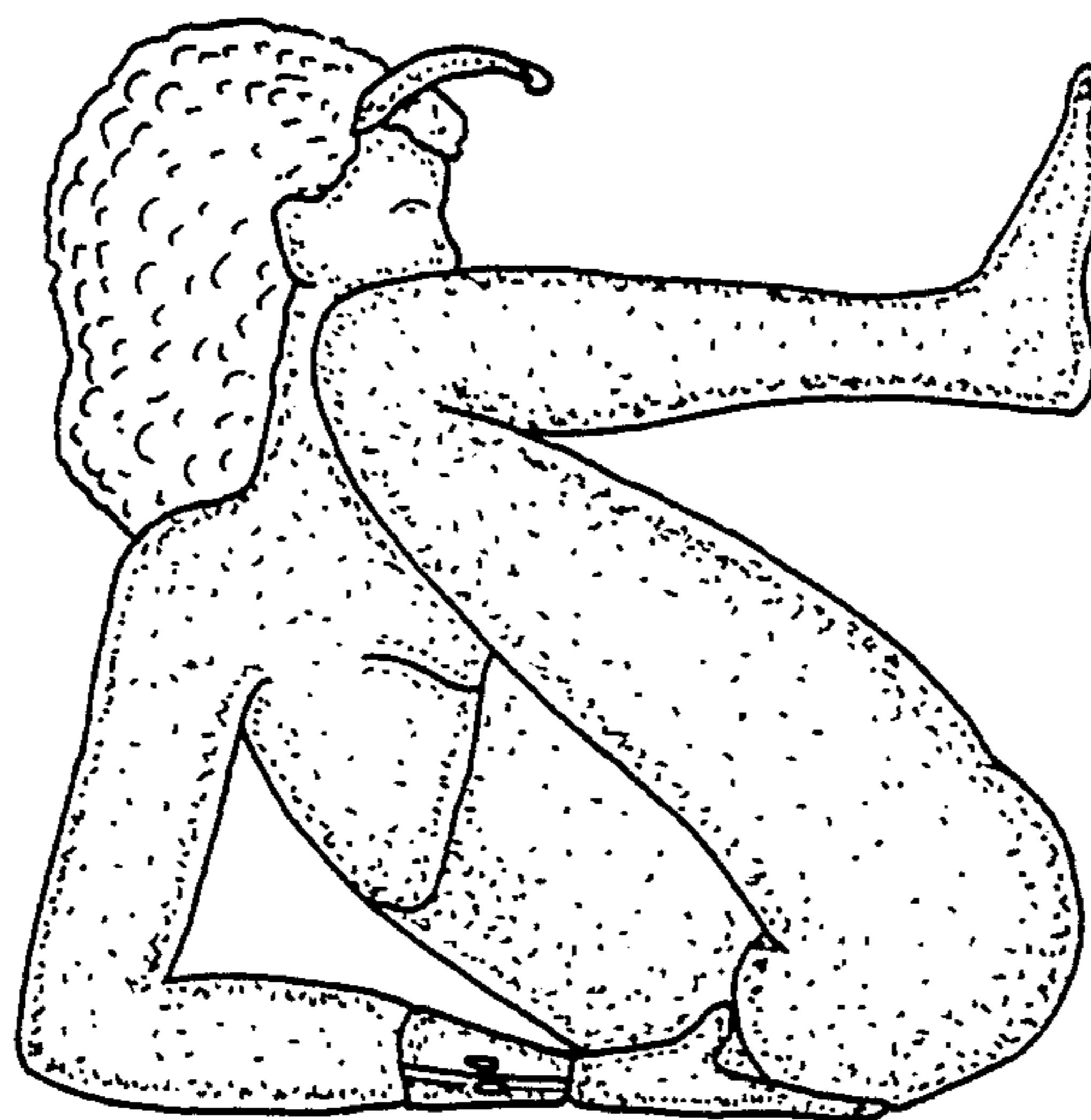

DESCRIPTION

FIG. 1 is a front elevational view of a human game die figure showing my new design;
 FIG. 2 is a top plan view thereof;
 FIG. 3 is a bottom plan view thereof;
 FIG. 4 is a rear elevational view thereof;
 FIG. 5 is a side elevational view thereof;
 FIG. 6 is a side elevational view opposite to the side elevational view of FIG. 5;
 FIG. 7 is a front elevational view of a modified form of the human figure game die described in FIG. 1;
 FIG. 8 is a top plan view thereof;
 FIG. 9 is a bottom plan view thereof;
 FIG. 10 is a rear elevational view thereof;
 FIG. 11 is a side elevational view thereof;
 FIG. 12 is a side elevational view opposite to the side elevational view of FIG. 11;
 FIG. 13 is a front elevational view of another modified form of a human figure game die described in FIG. 1;

 FIG. 18 is a side elevational view opposite to the side elevational view of FIG. 17.



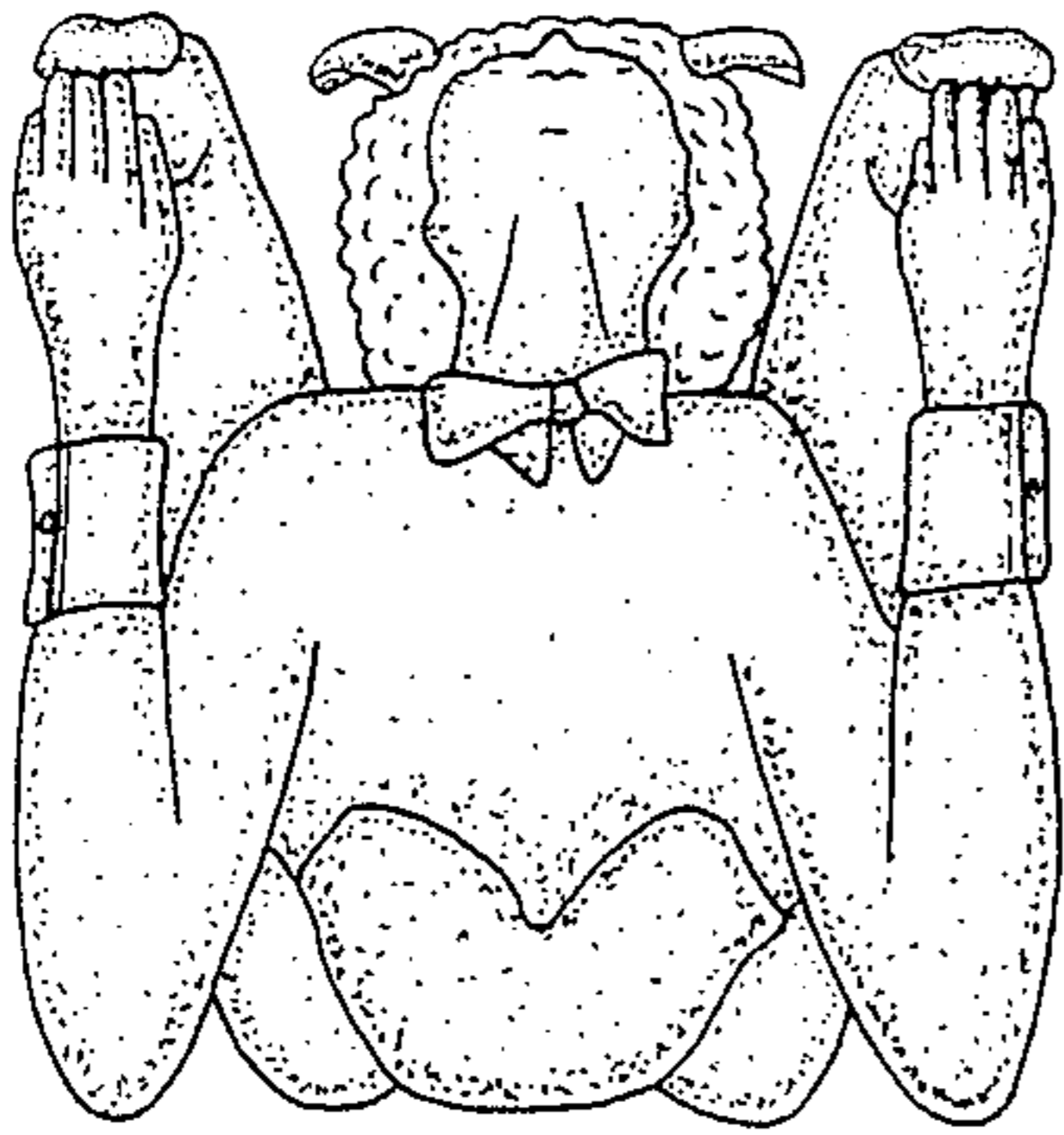

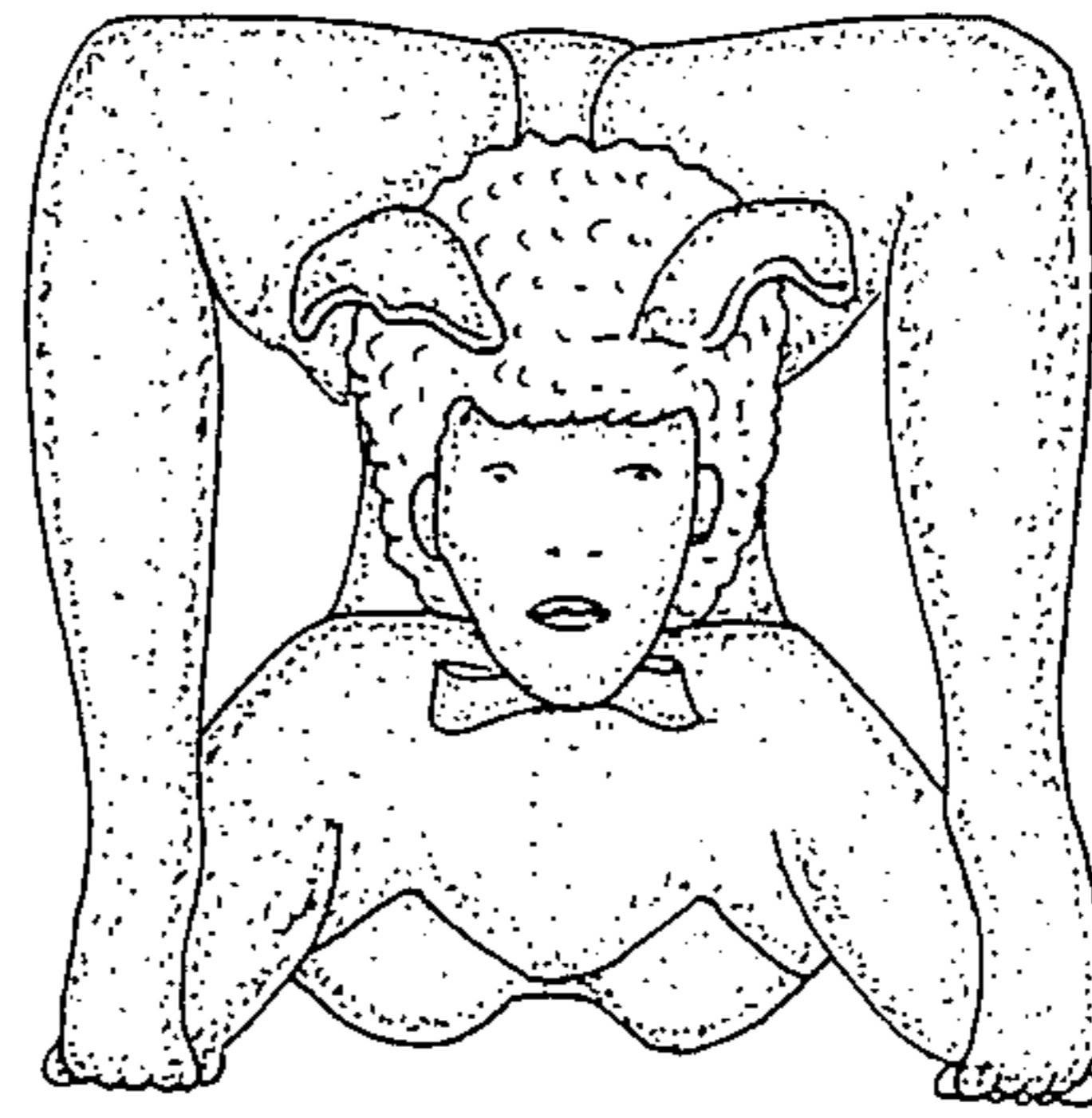

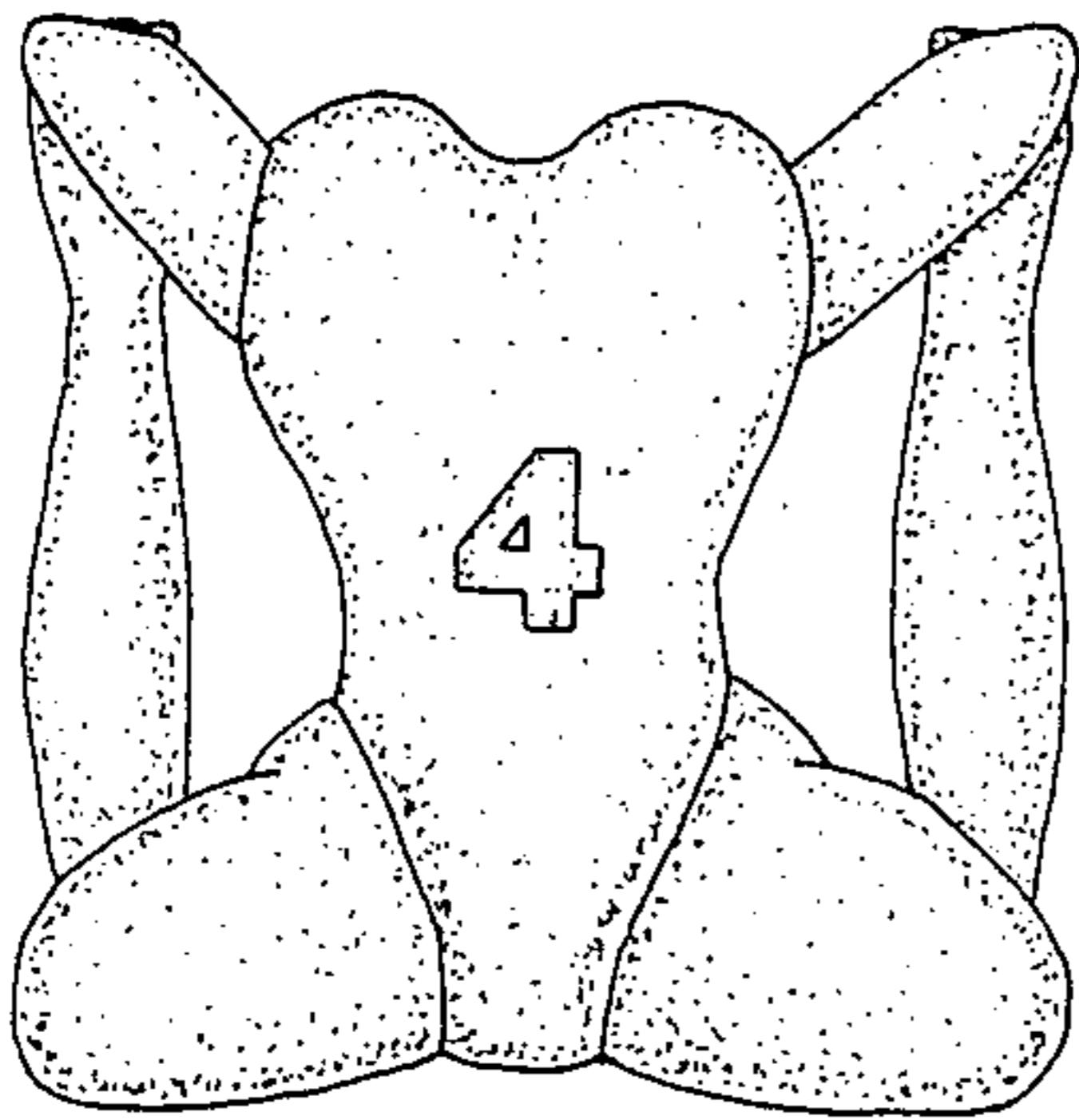

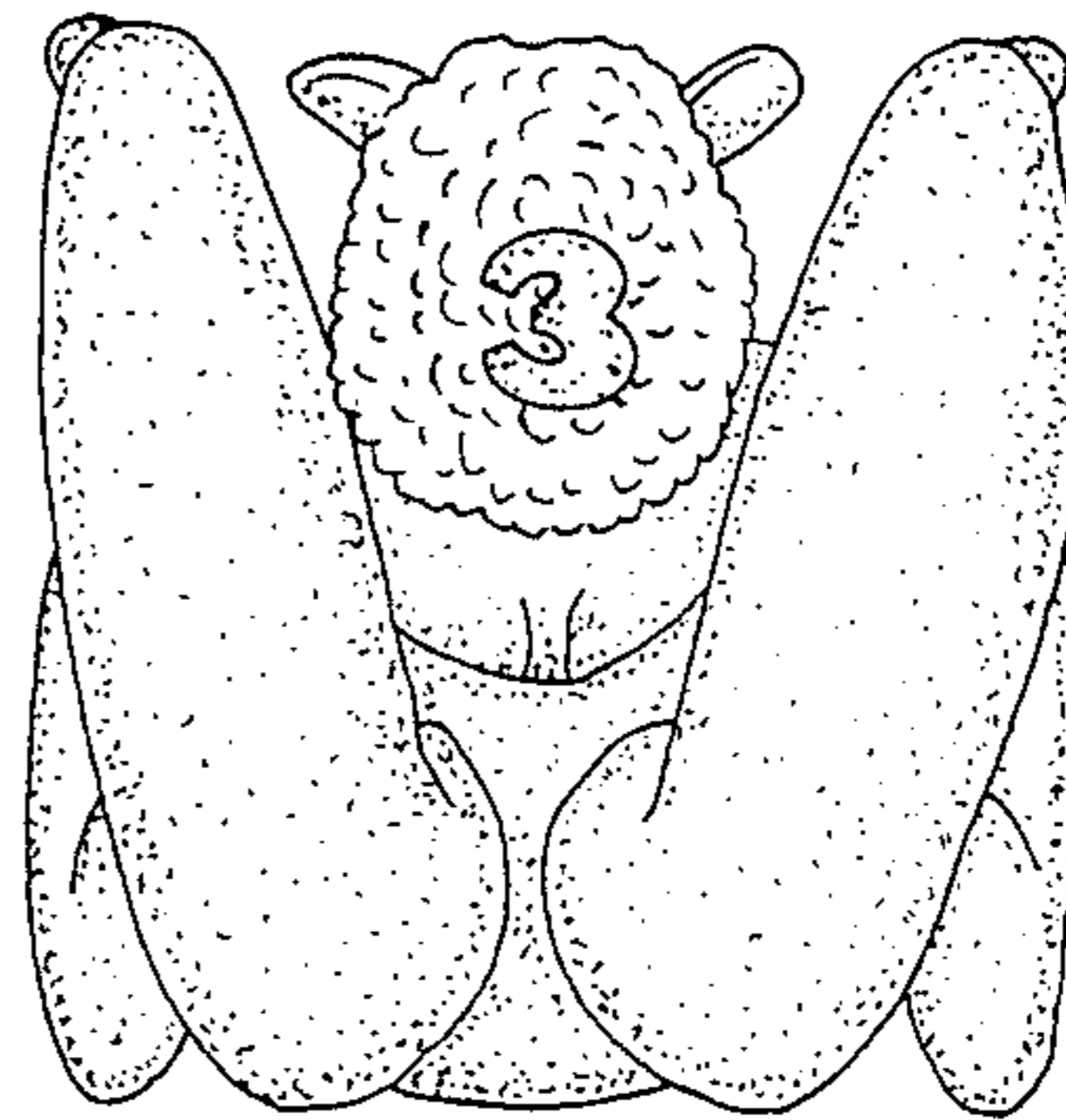

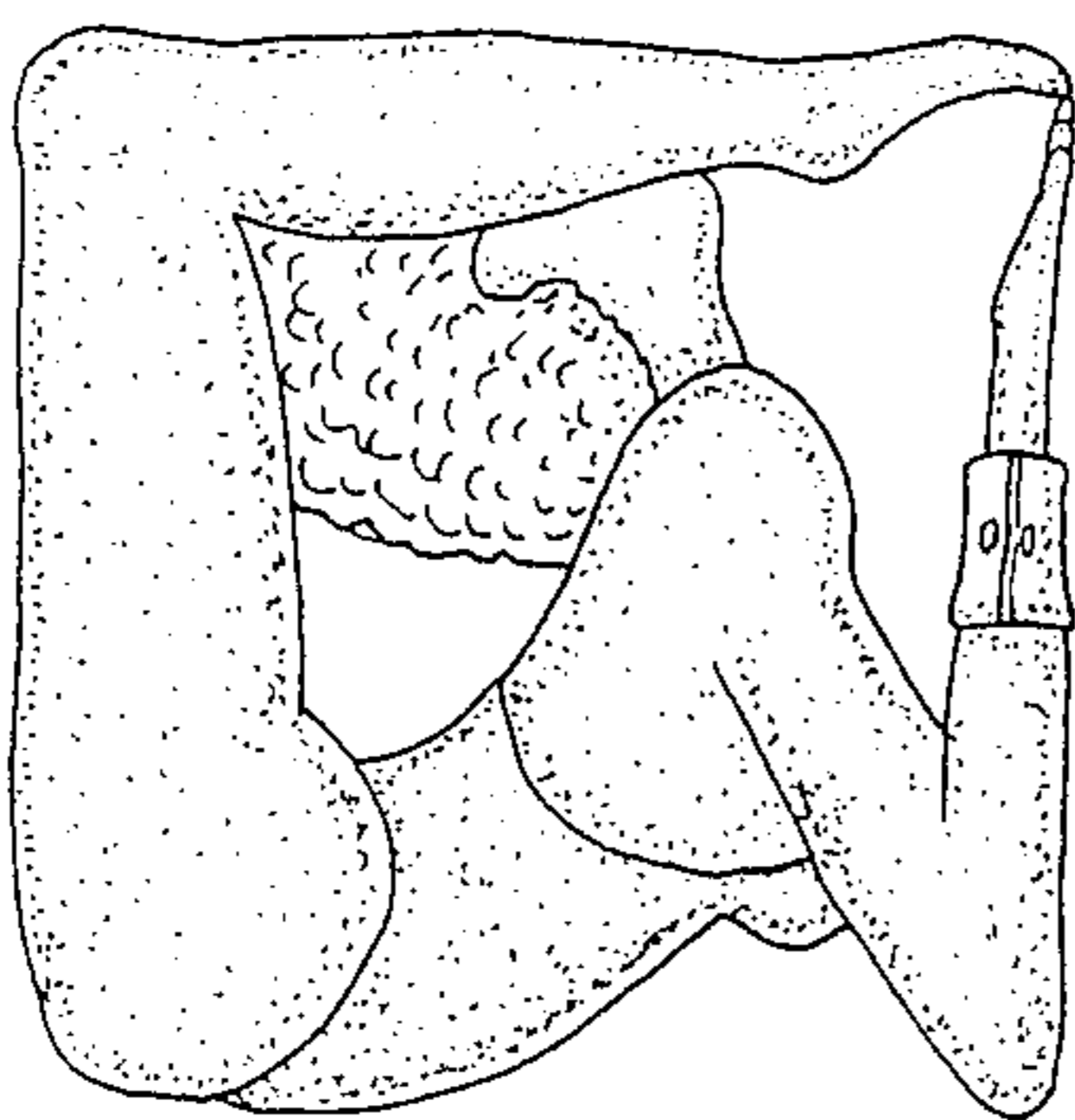

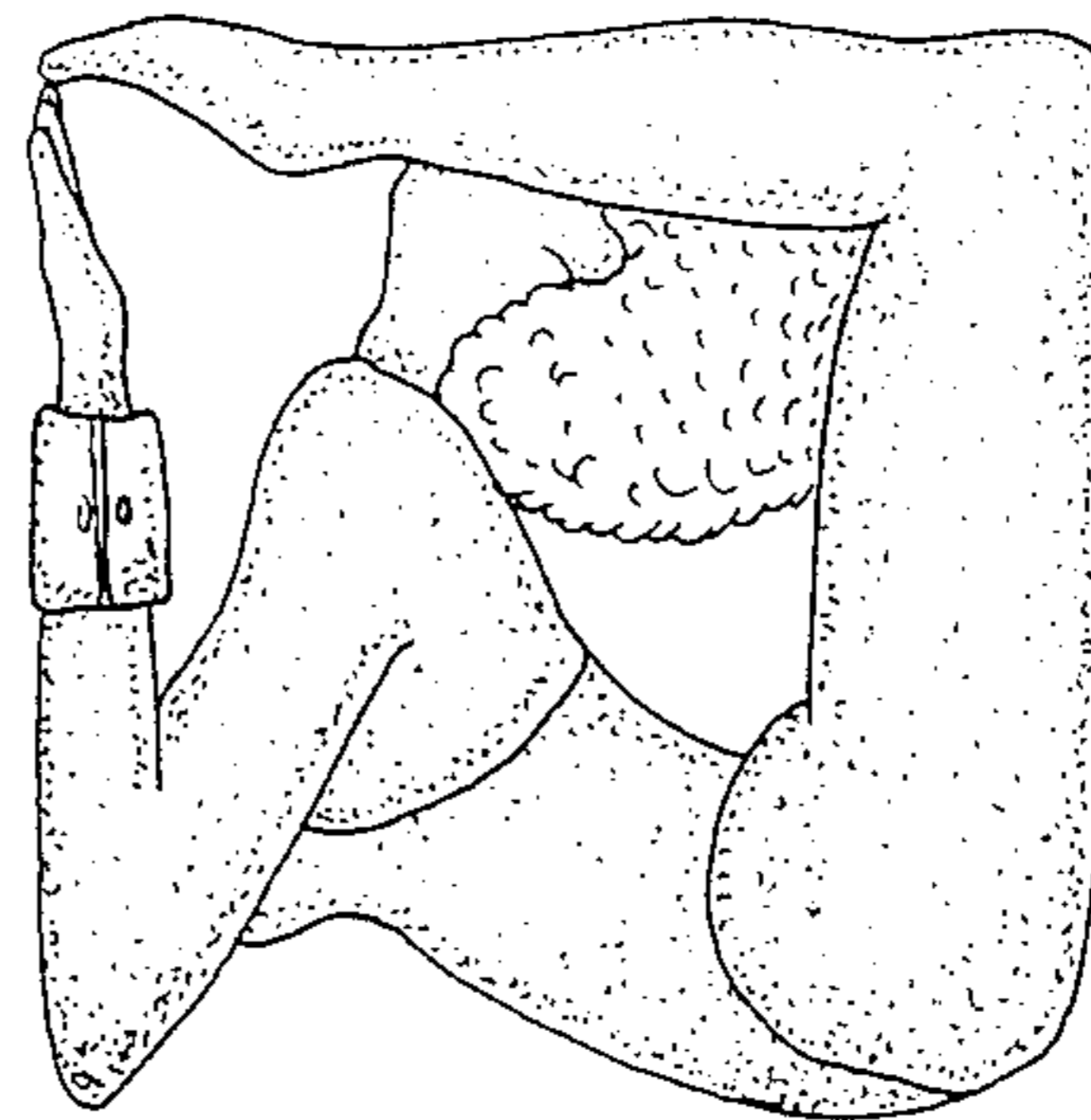

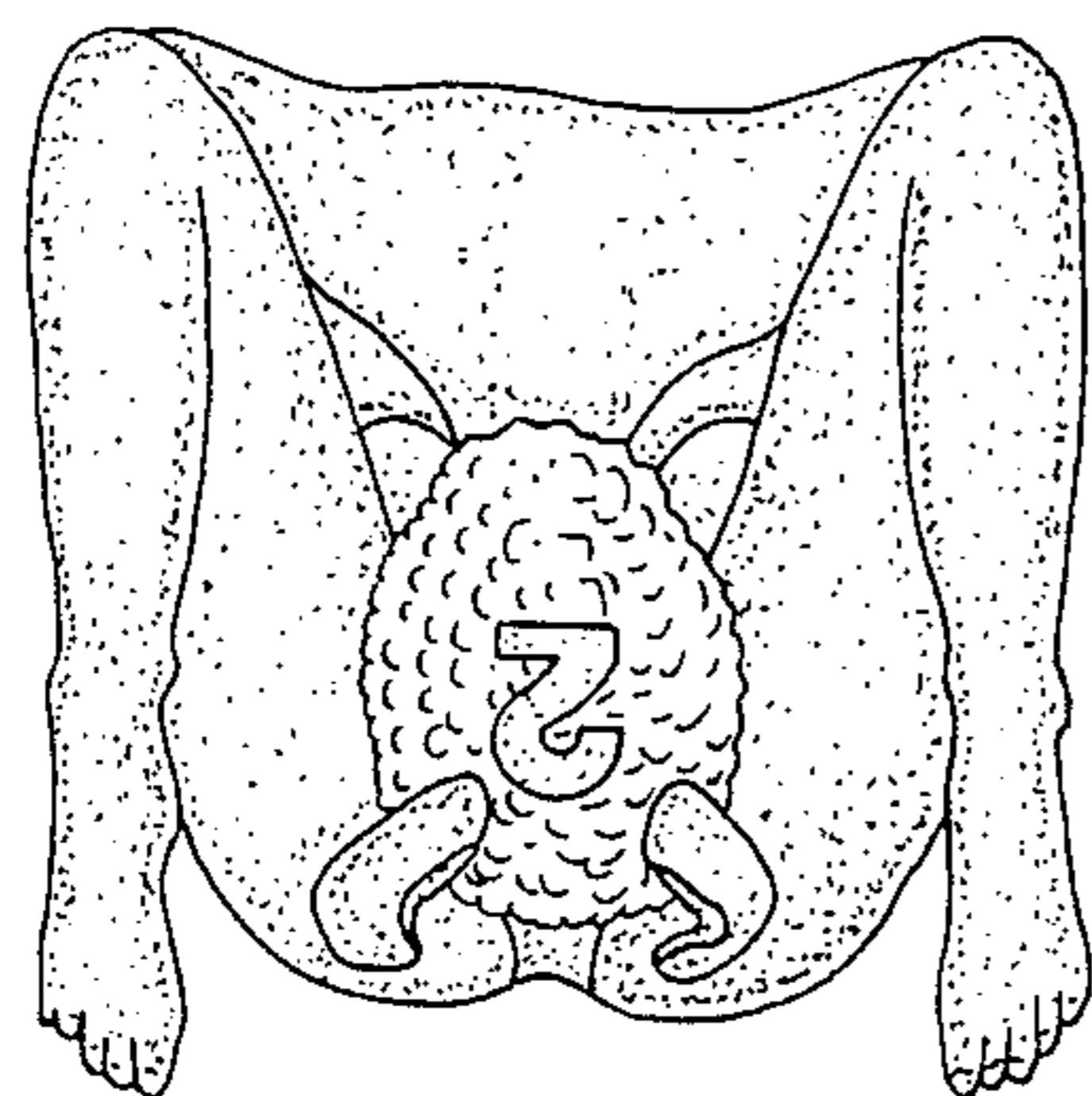

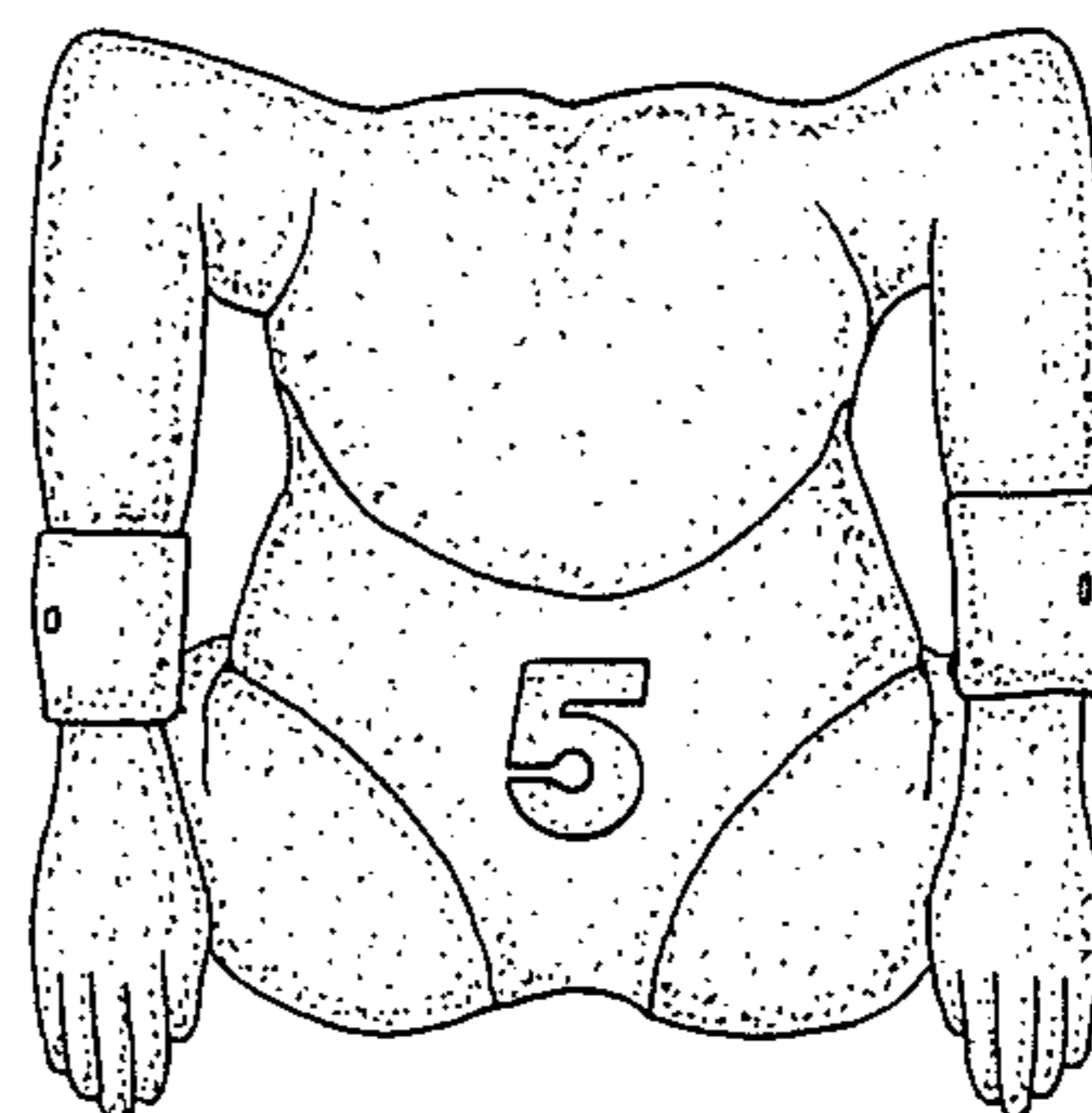

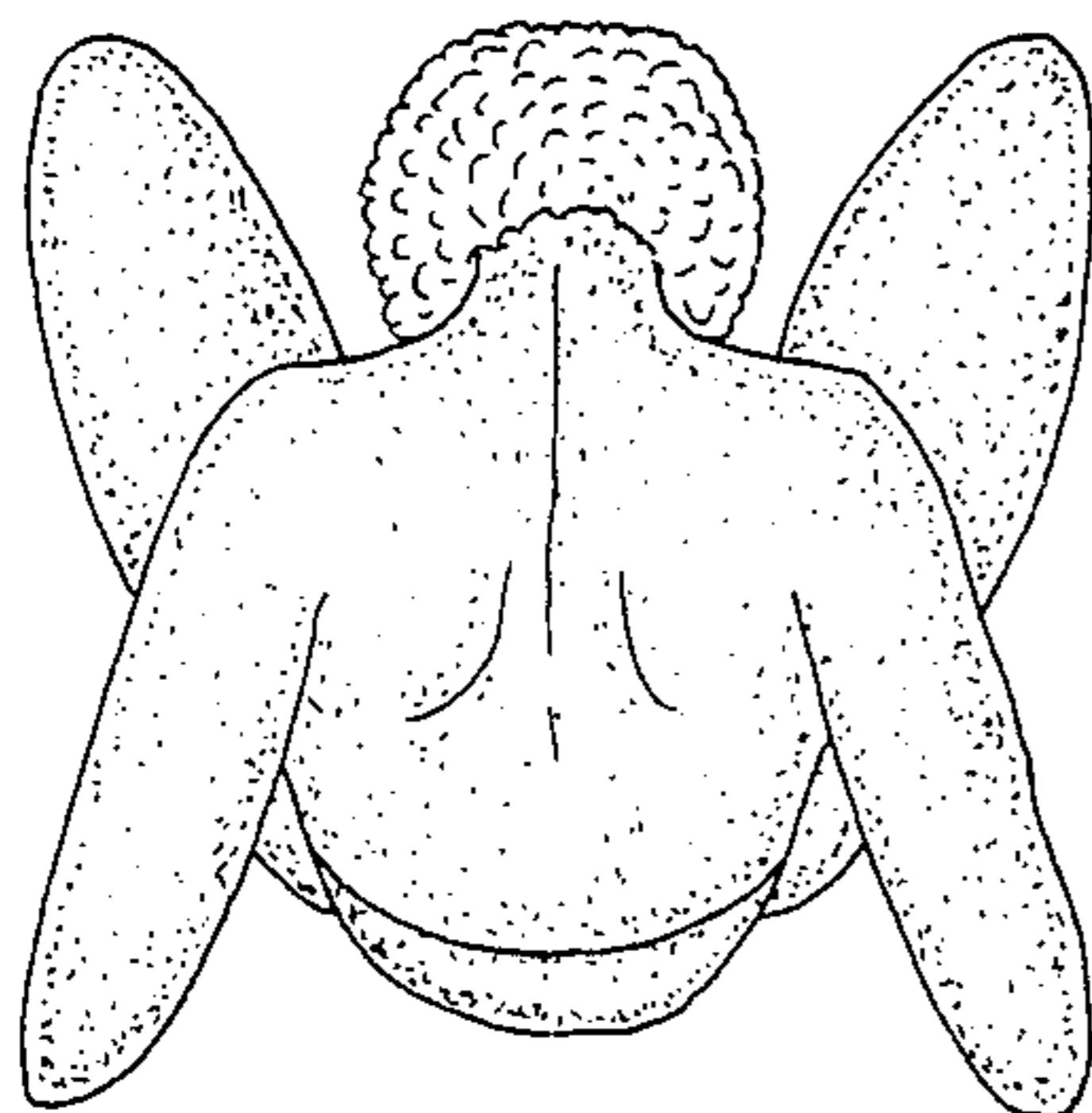

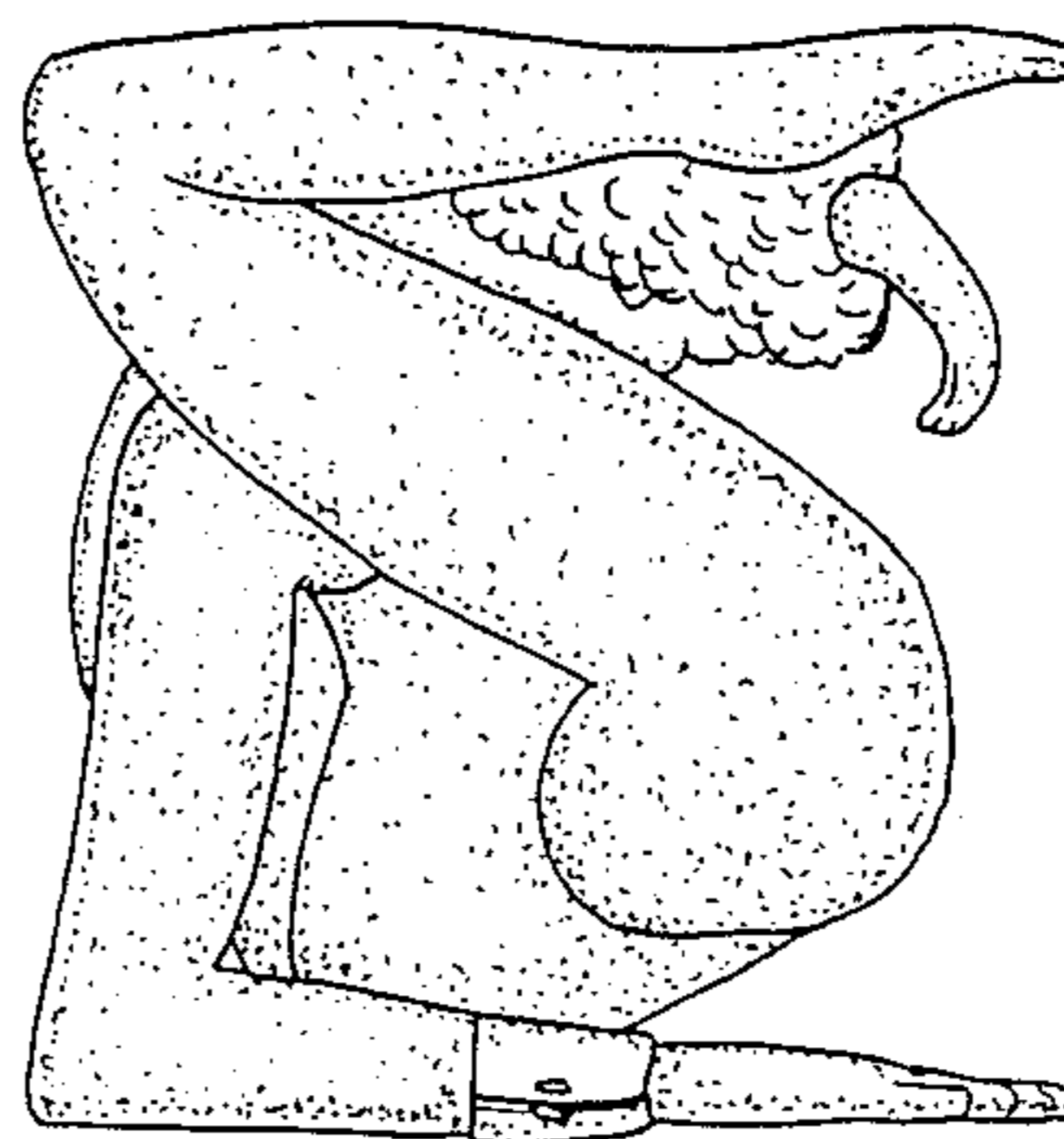

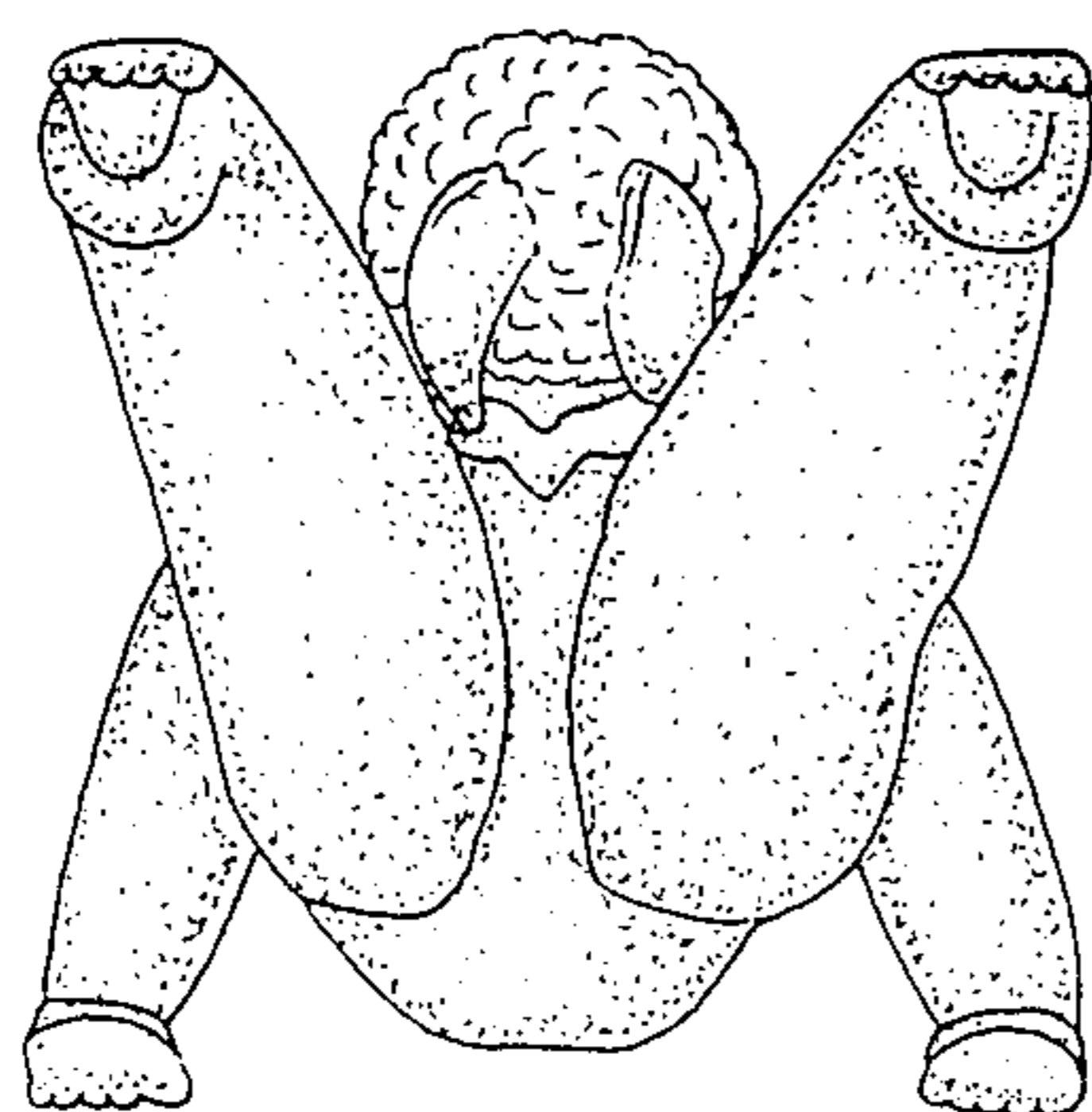

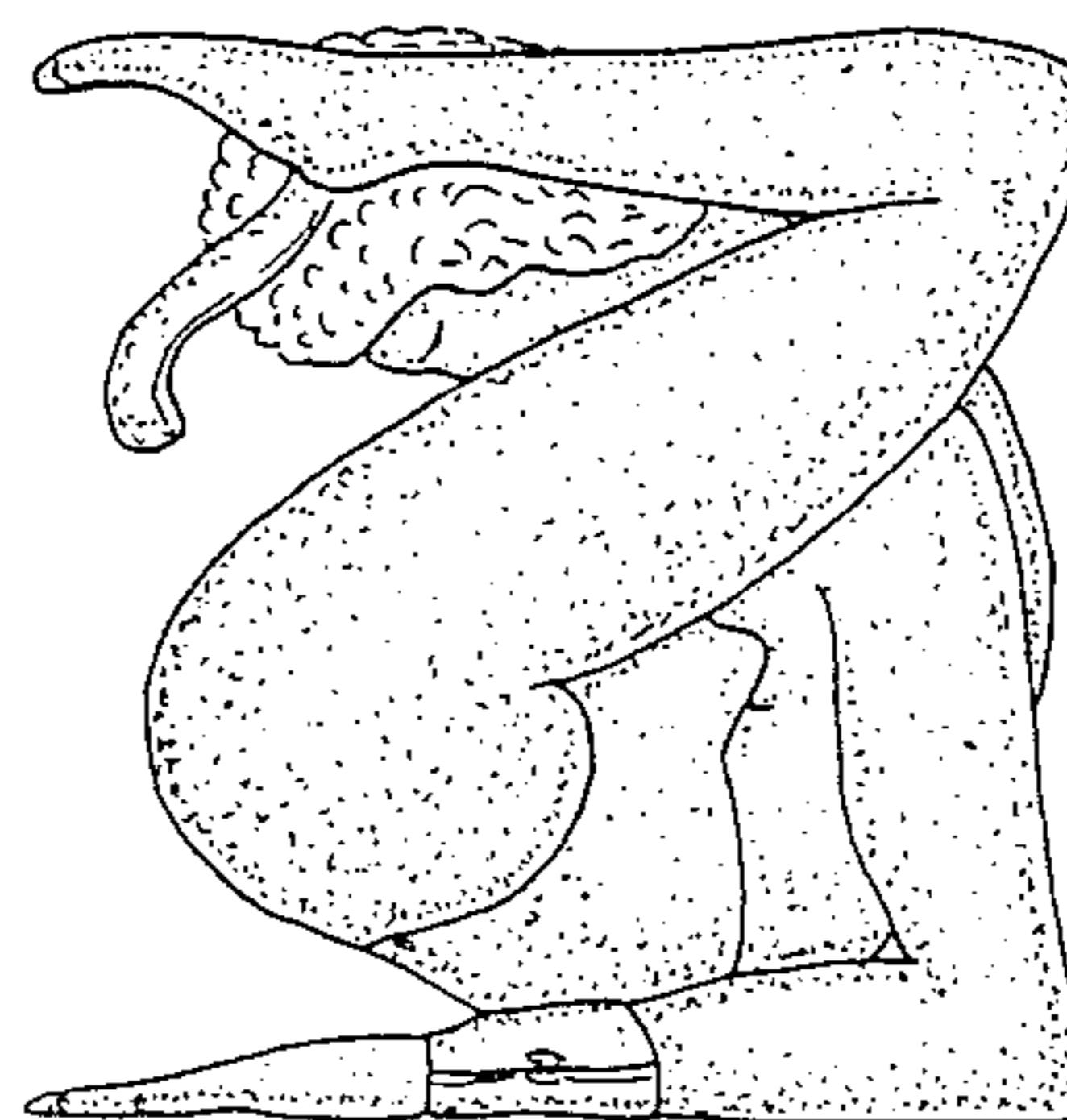

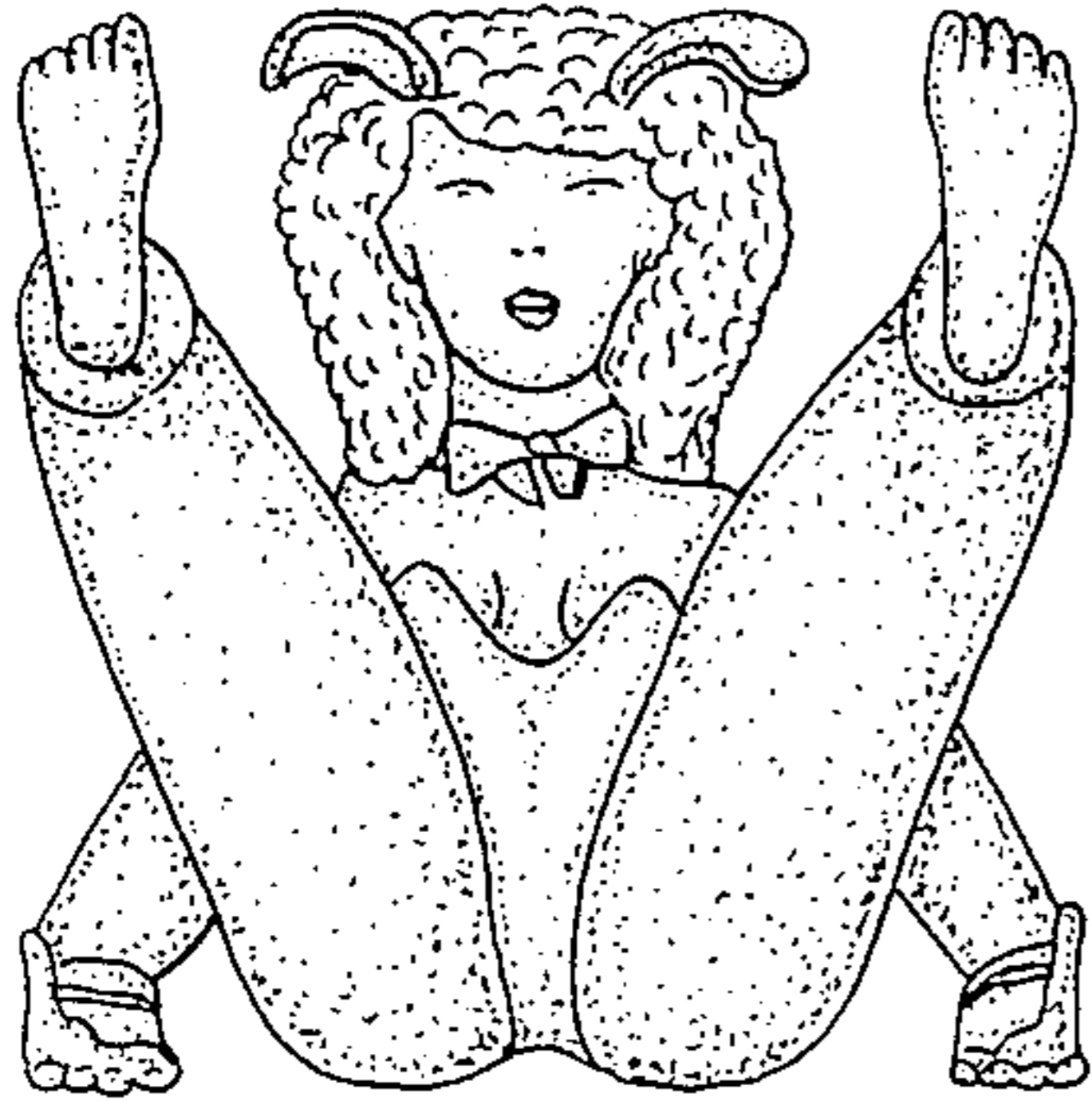

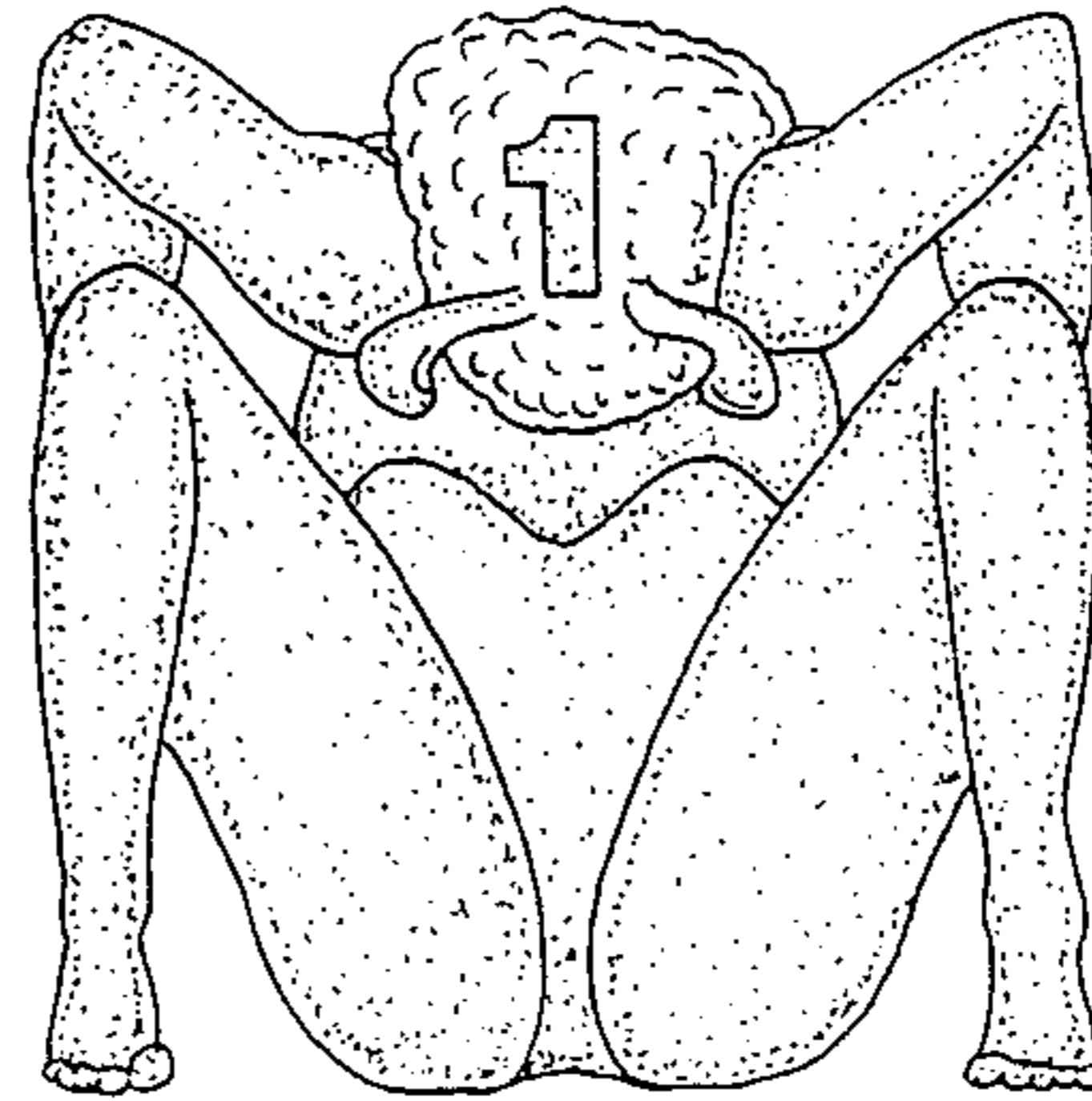

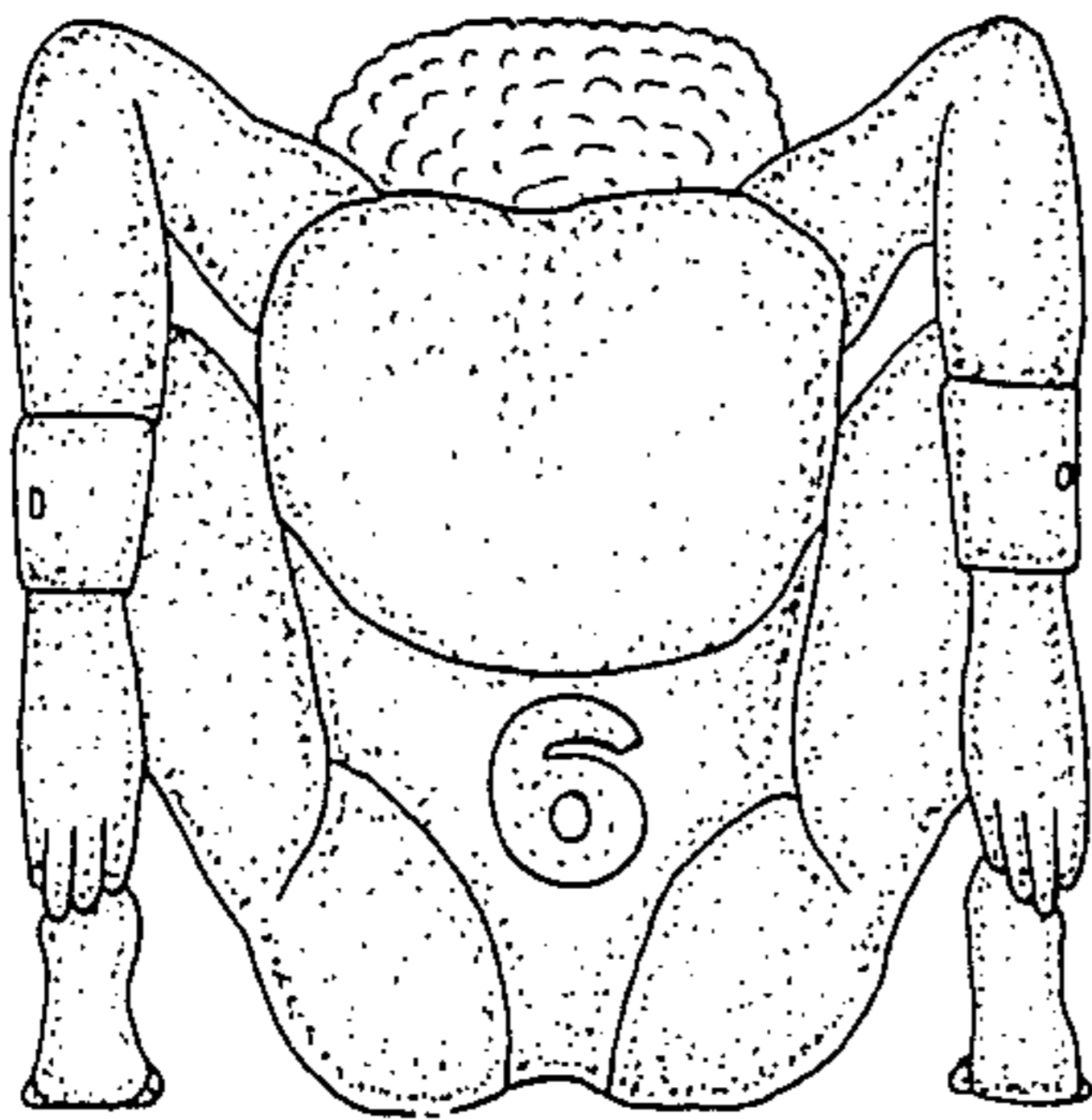

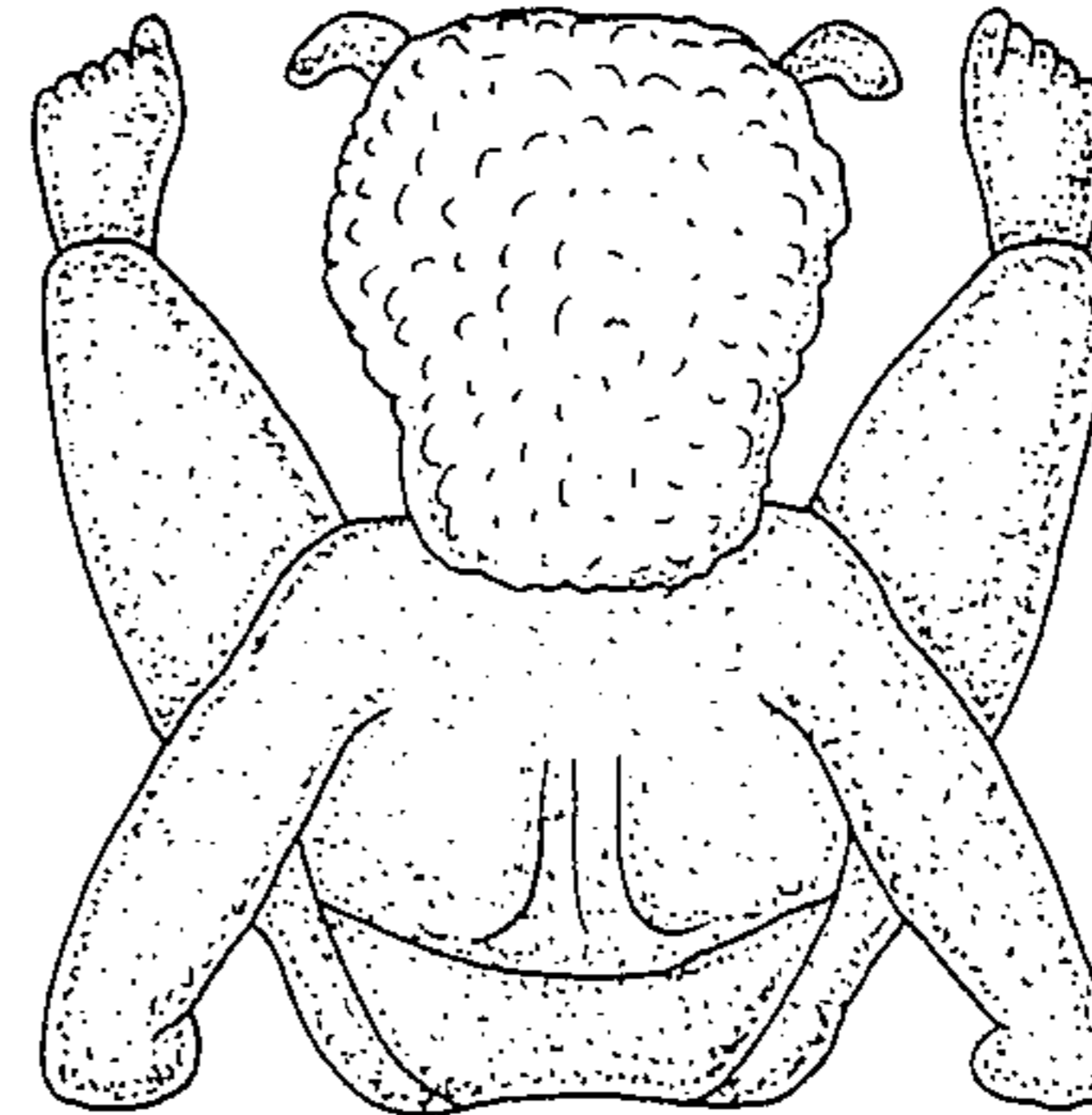

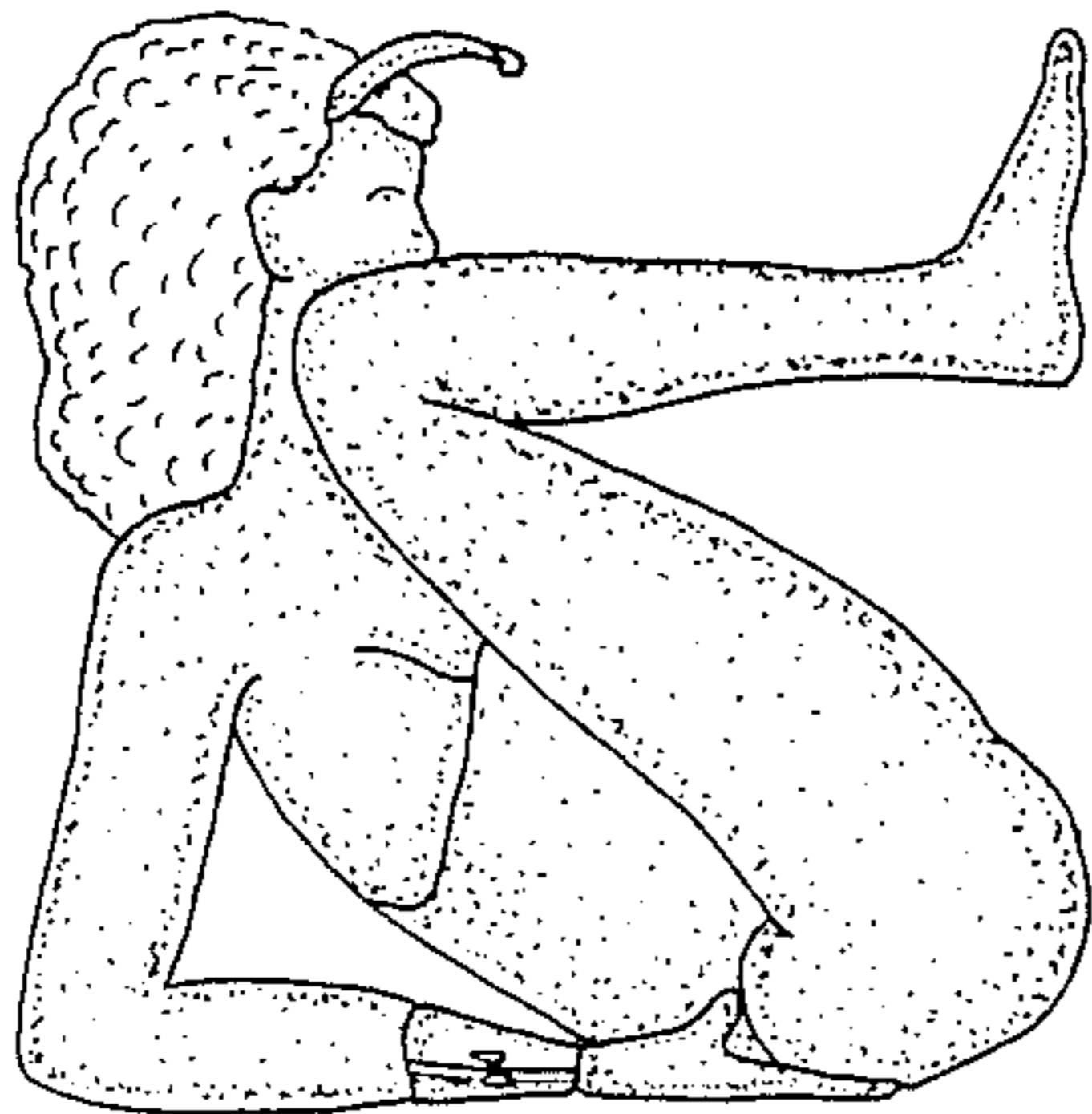

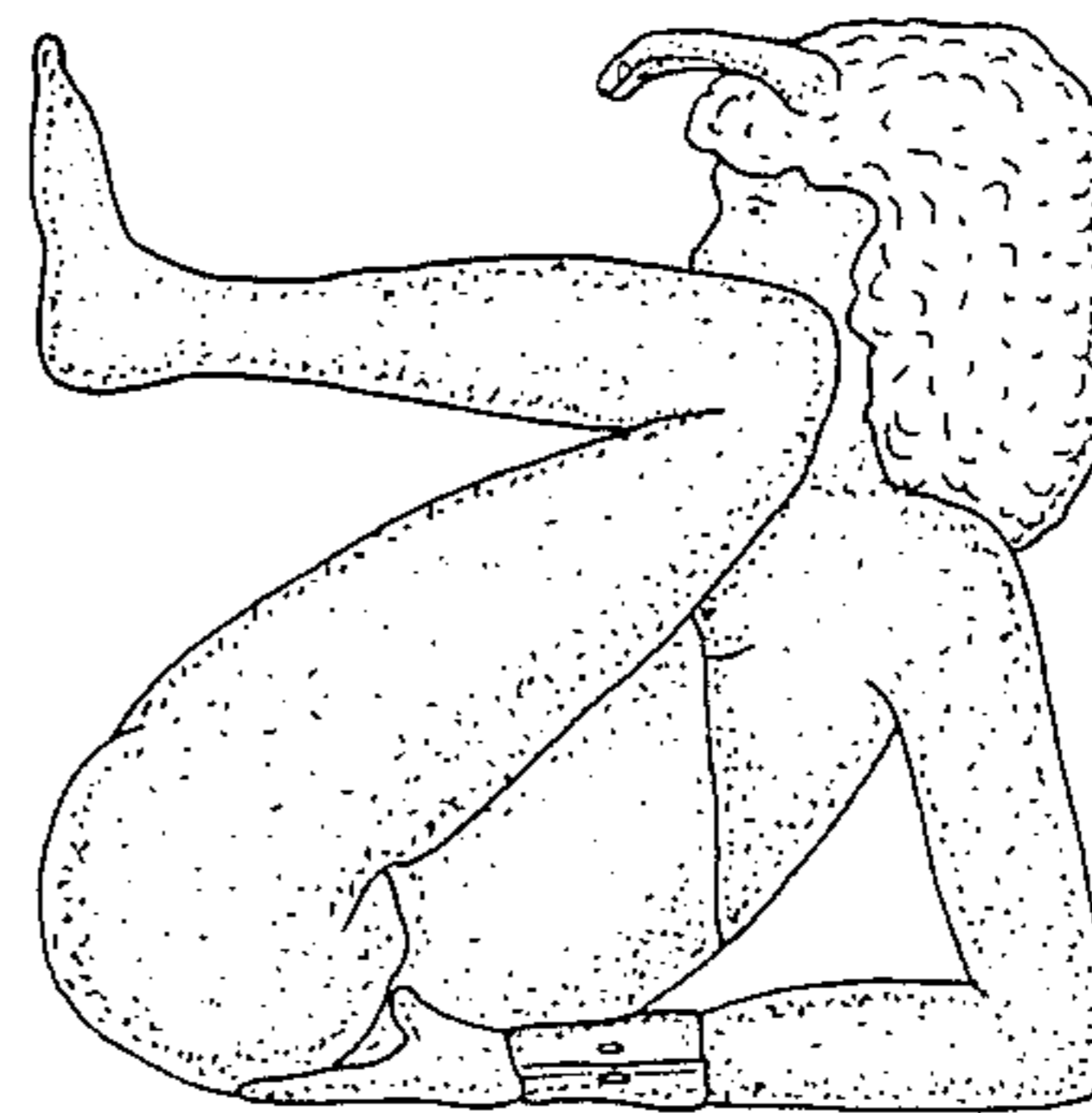
