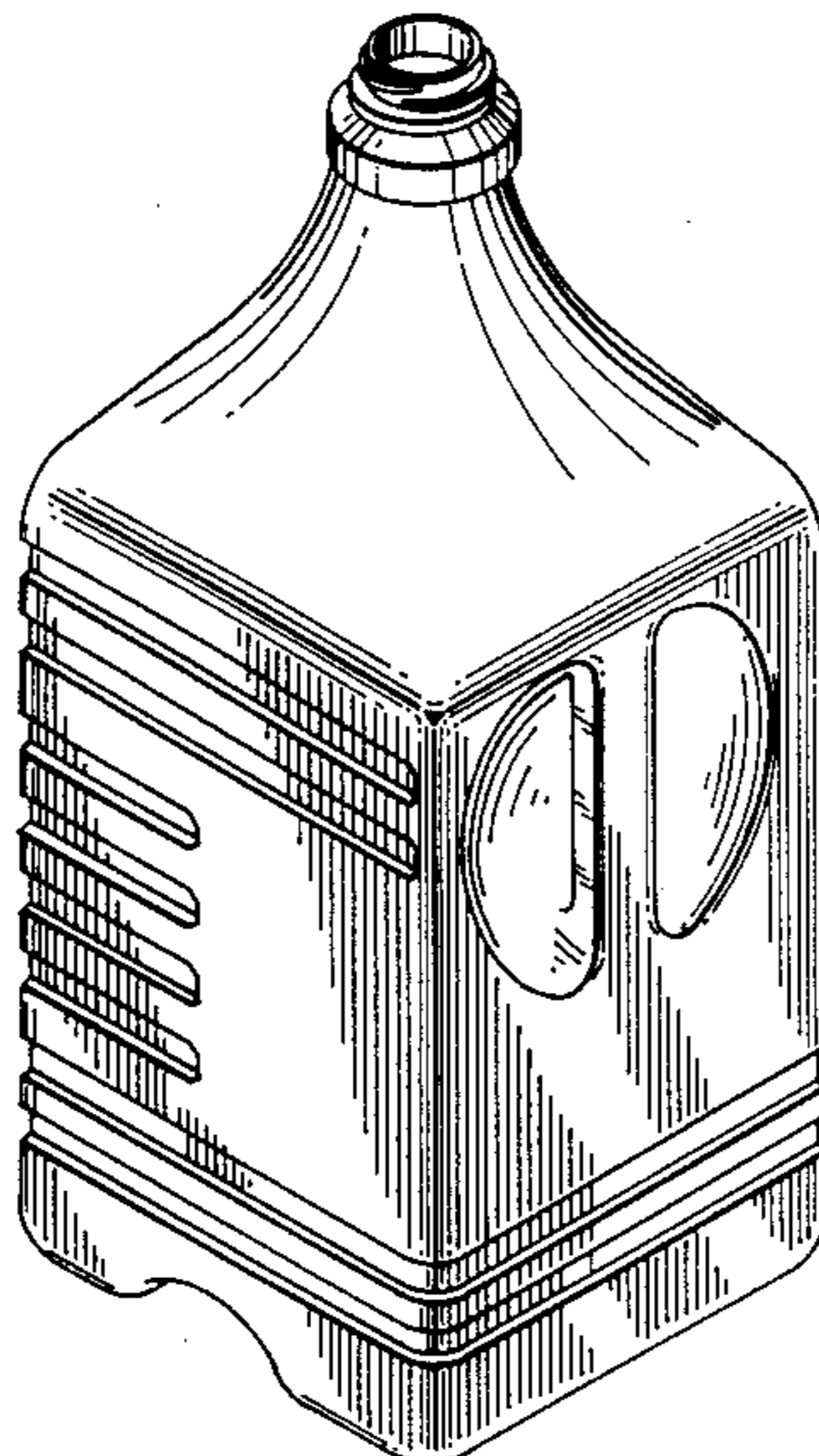

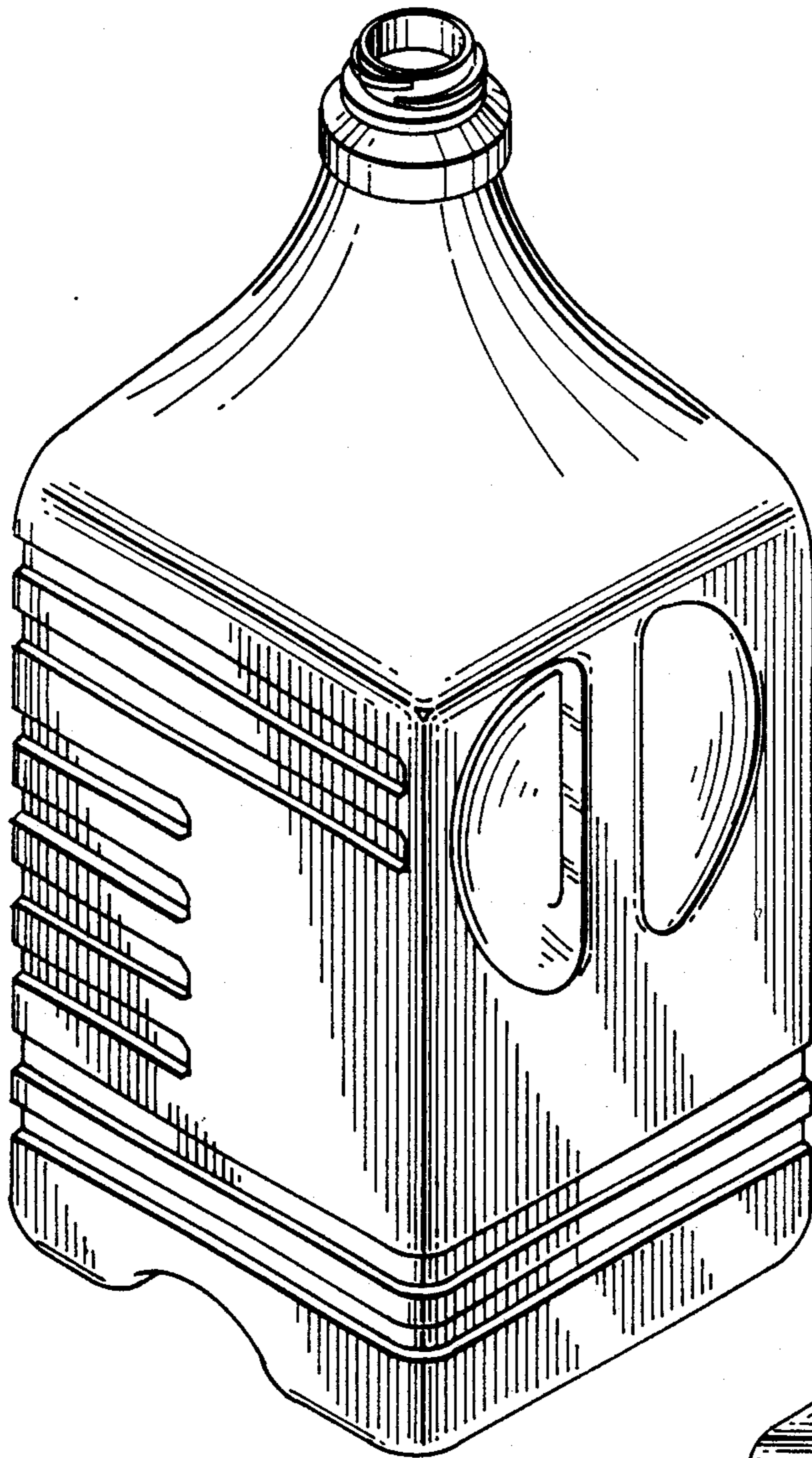
[57] **CLAIM**

The ornamental design for a bottle, as shown and described.

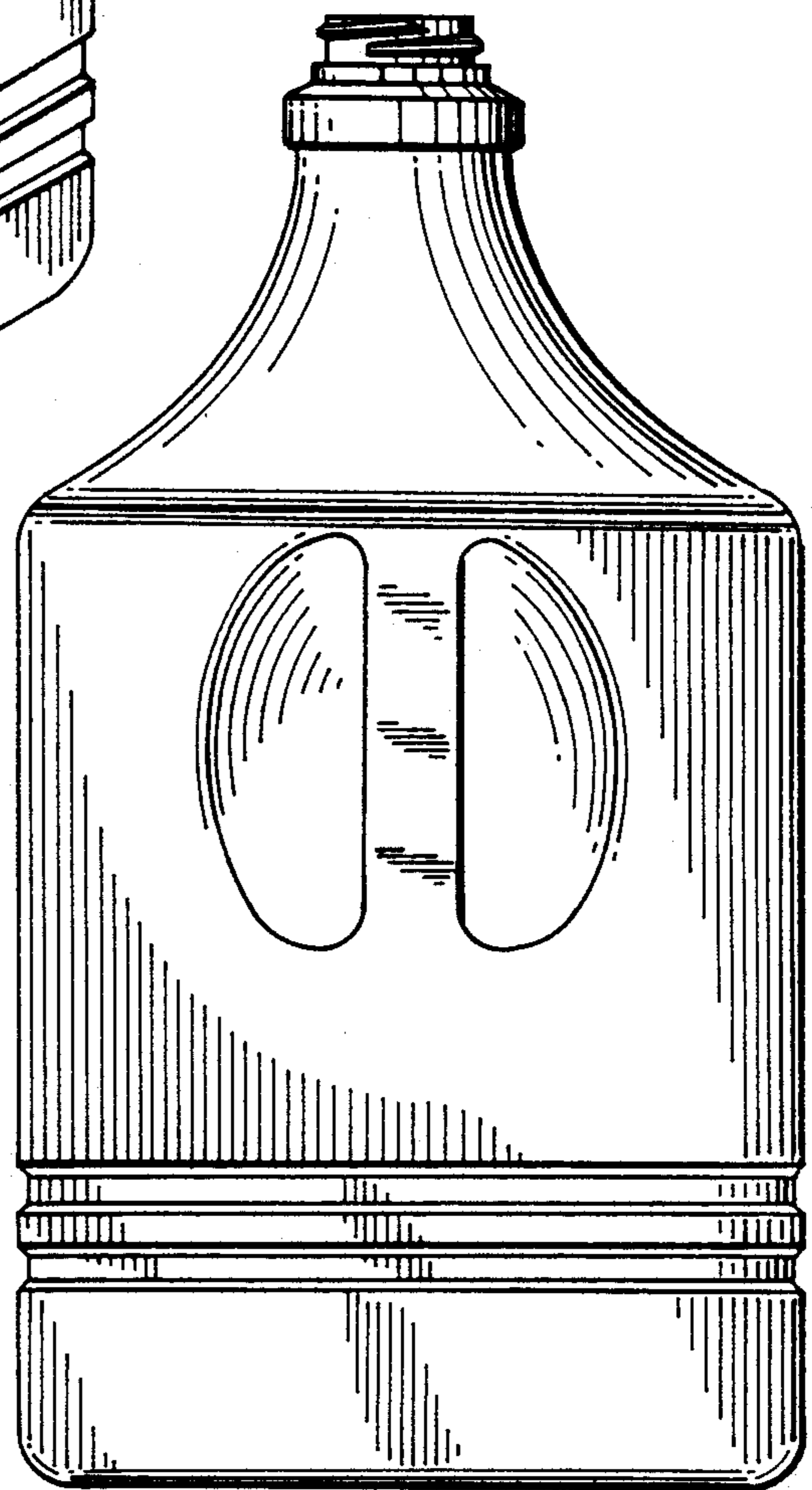
**DESCRIPTION**

FIG. 1 is a perspective view of a bottle showing my new design;  
 FIG. 2 is a side elevational view of the right side thereof;  
 FIG. 3 is a front elevational view thereof; the rear elevational view being a mirror image thereof;  
 FIG. 4 is a side elevation view of the left side thereof;  
 FIG. 5 is a top view thereof;  
 FIG. 6 is a bottom view thereof;  
 FIG. 7 is a perspective view of a first modified form of the bottle;  
 FIG. 8 is a rear elevational view of FIG. 7;  
 FIG. 9 is a front elevational view of FIG. 7;  
 FIG. 10 is a side elevational view of the left side of FIG. 7;  
 FIG. 11 is a side elevational view of the right side of FIG. 7;  
 FIG. 12 is a top view of FIG. 7;  
 FIG. 13 is a bottom view of FIG. 7;  
 FIG. 14 is a perspective view of a second modified form of the bottle;  
 FIG. 15 is a bottom view of FIG. 14;  
 FIG. 16 is a front elevational view of FIG. 14, the rear elevational view being a mirror image thereof;  
 FIG. 17 is a side elevational view of the left side of FIG. 14;  
 FIG. 18 is a side elevational view of the right side of FIG. 14; and  
 FIG. 19 is a top view of FIG. 14.

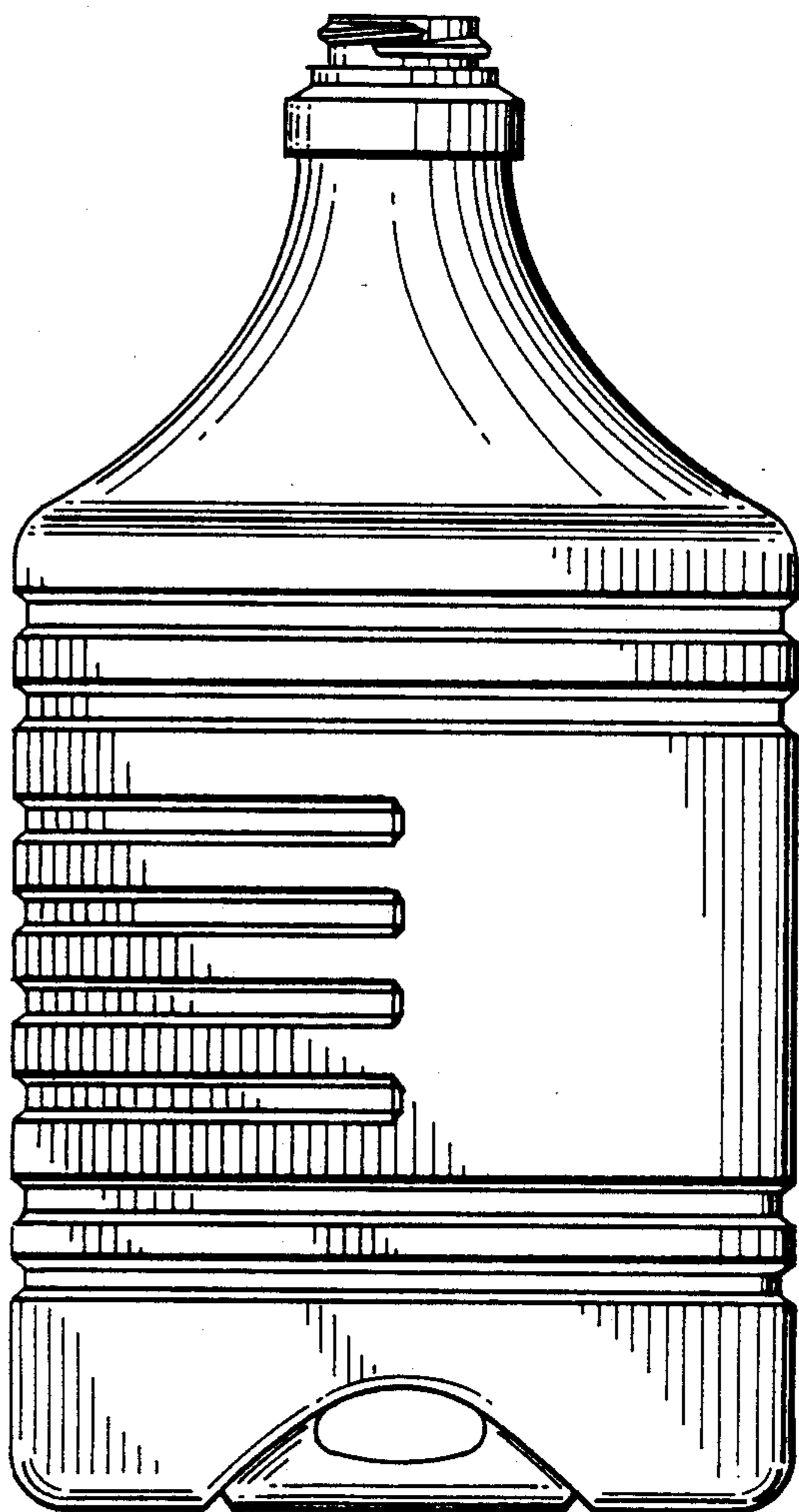




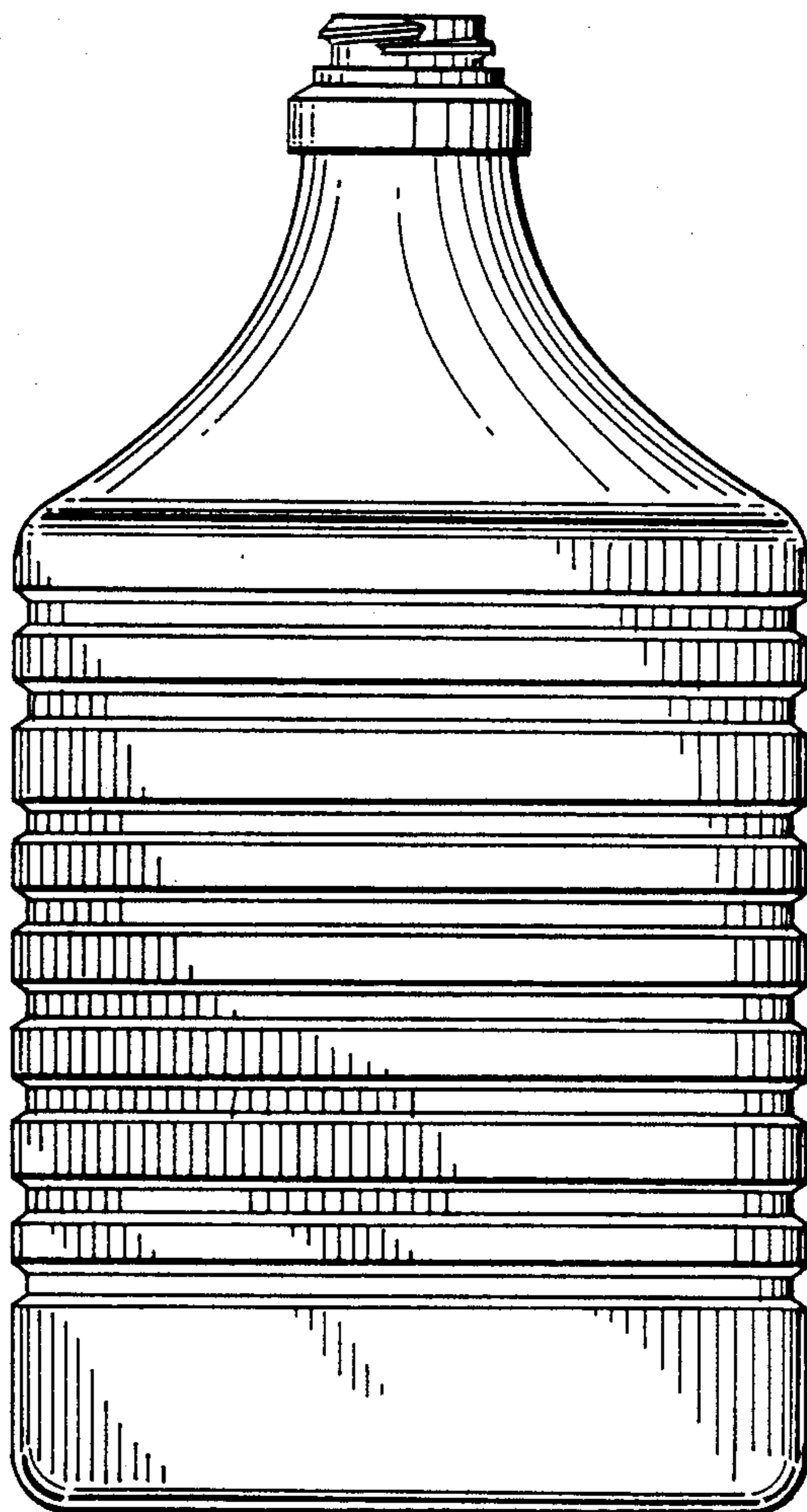

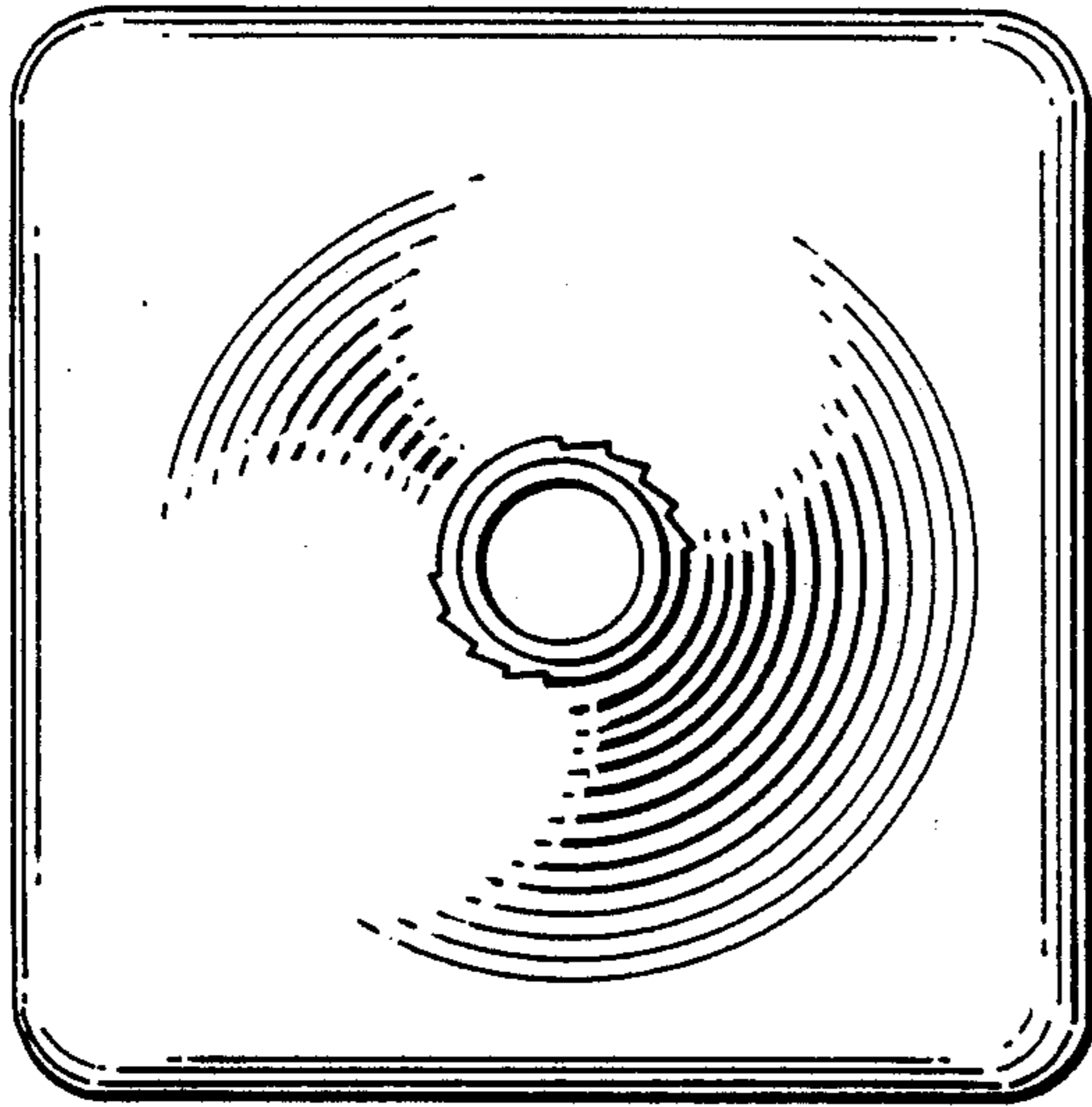

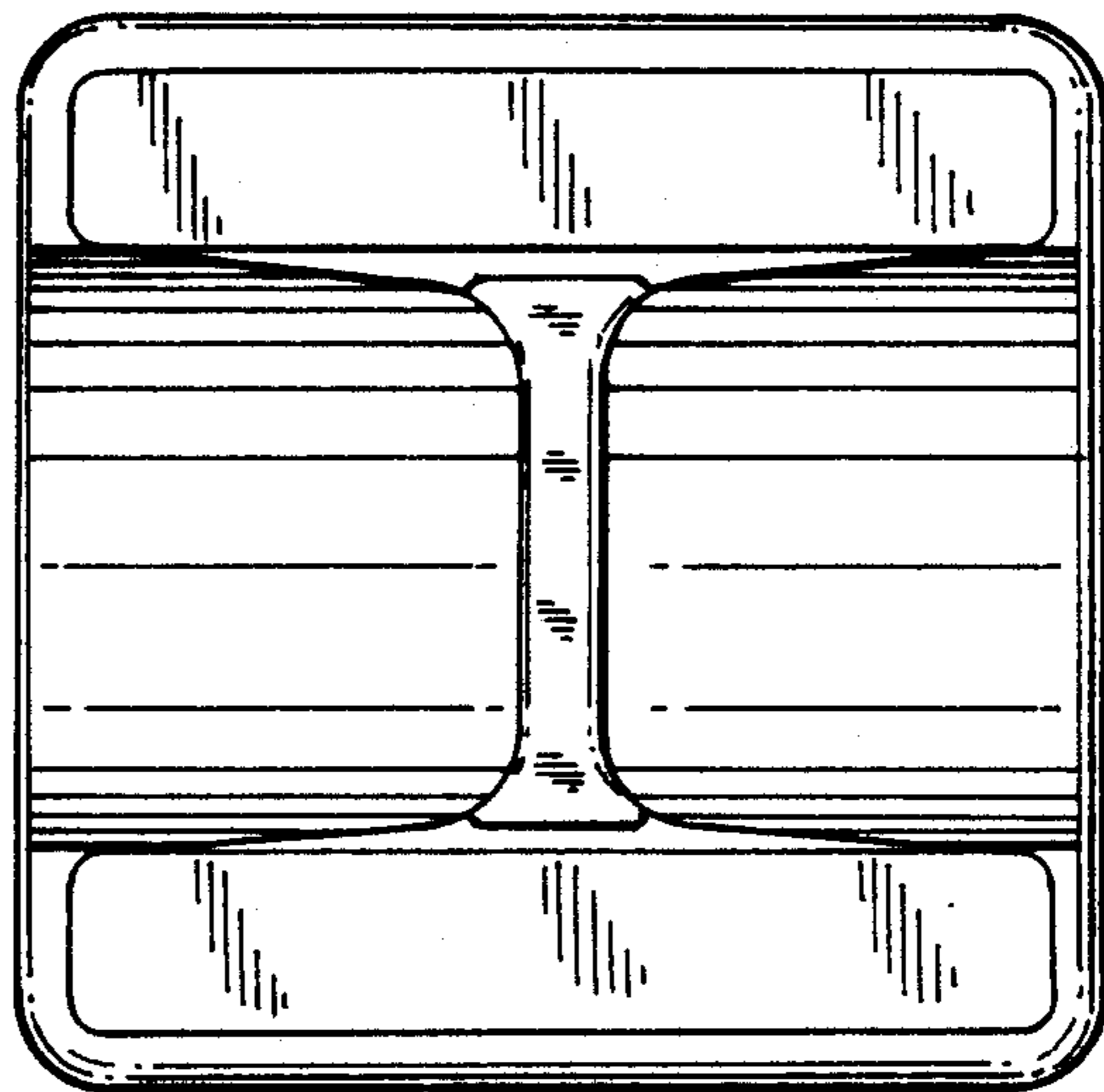

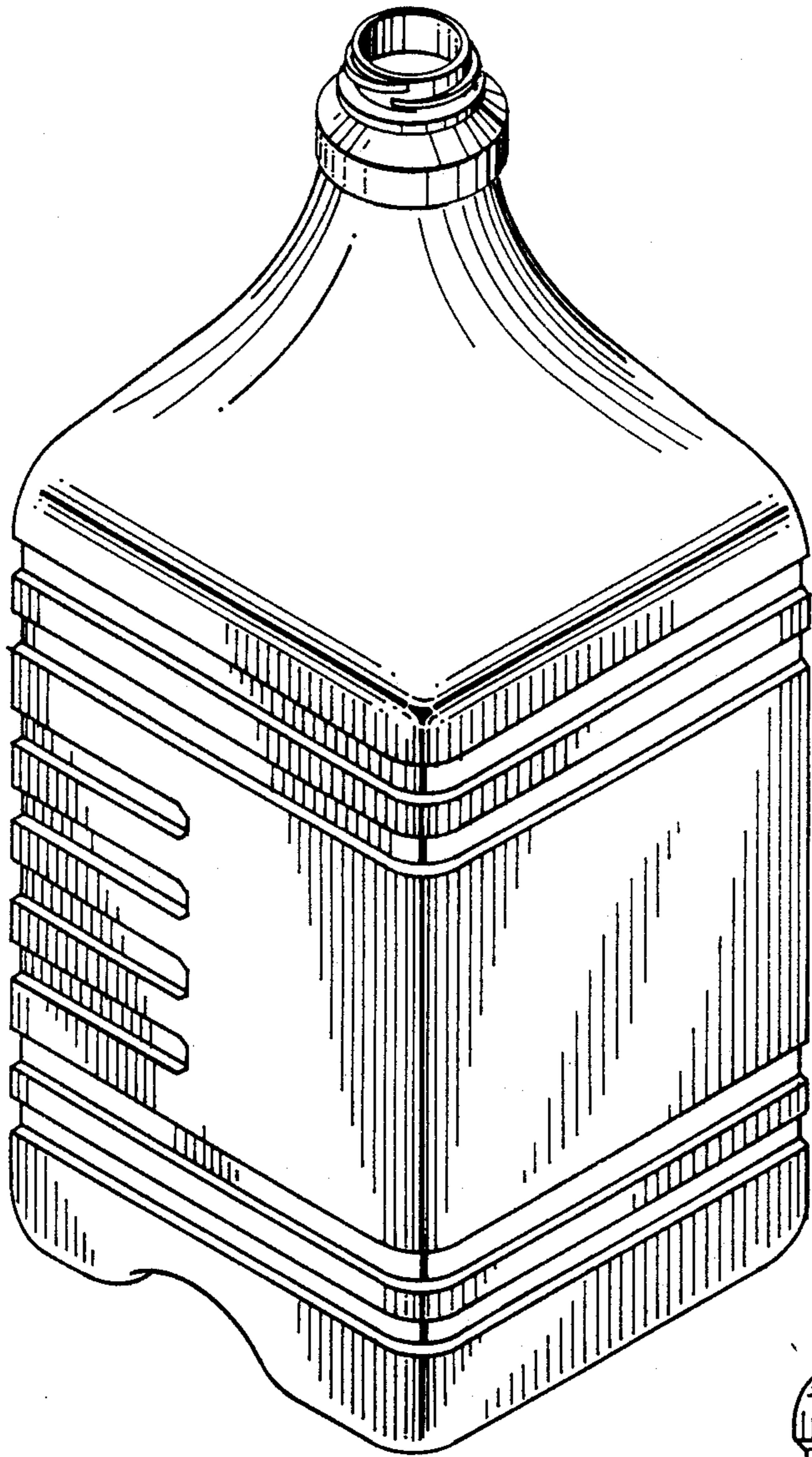

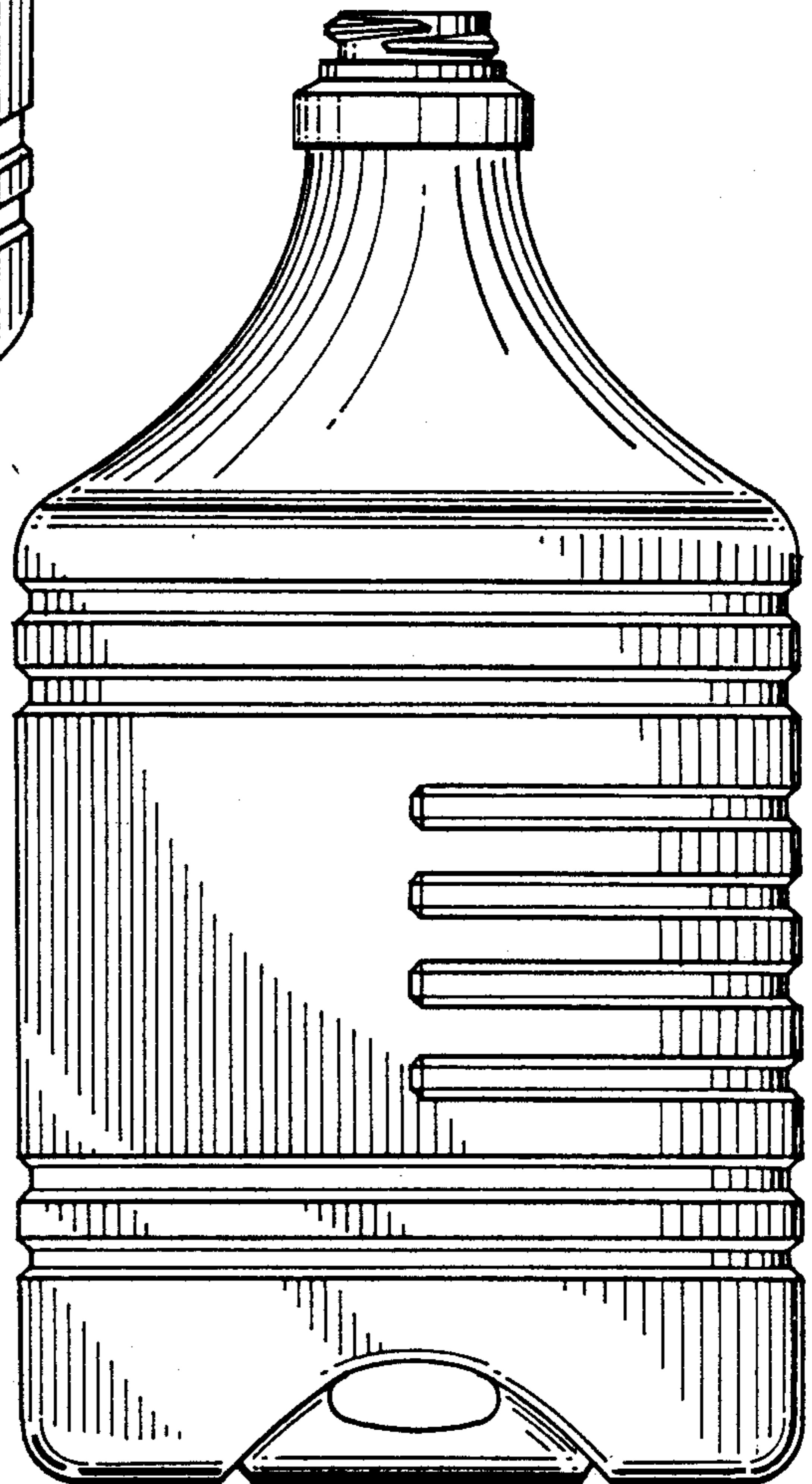

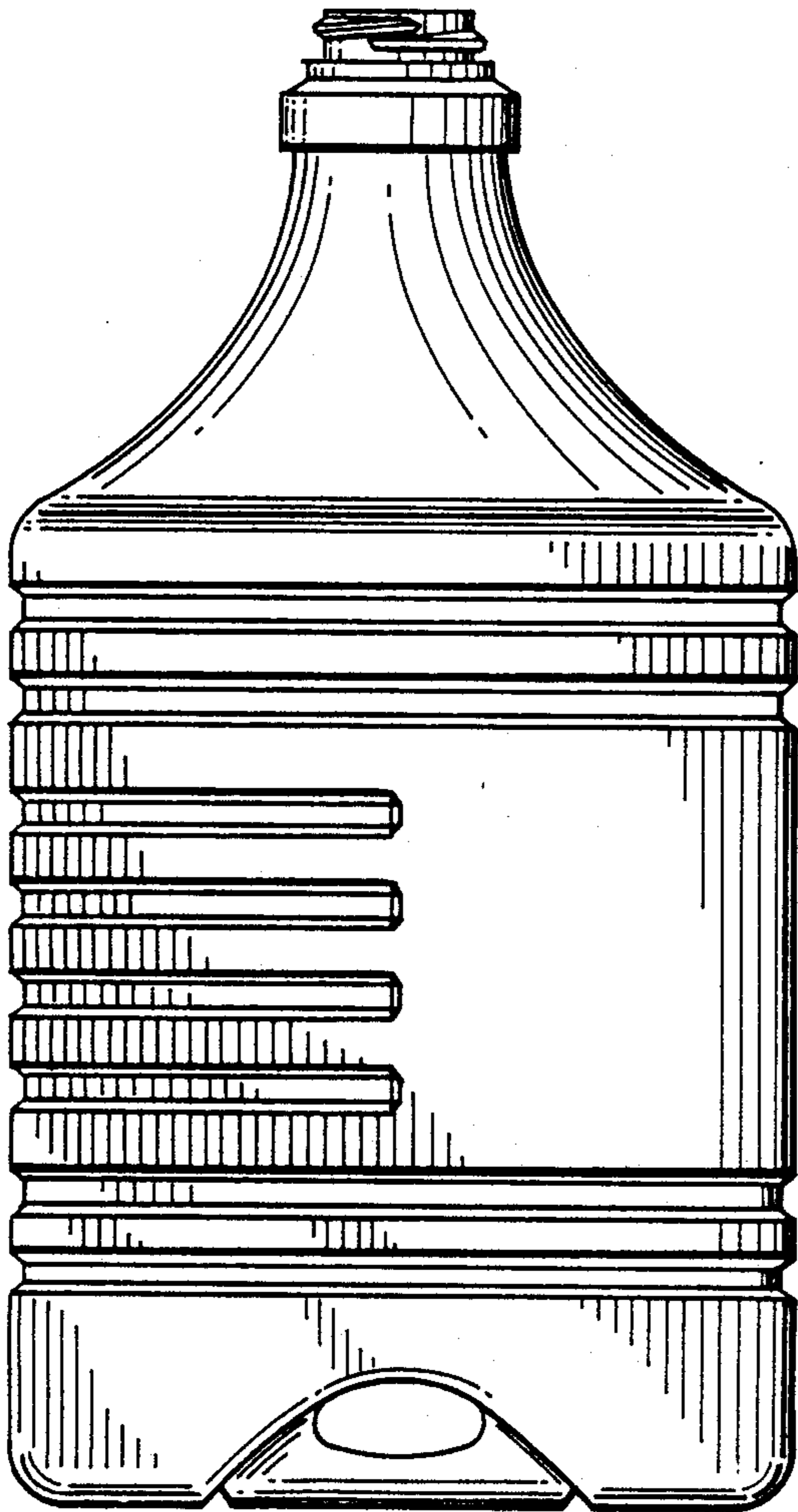

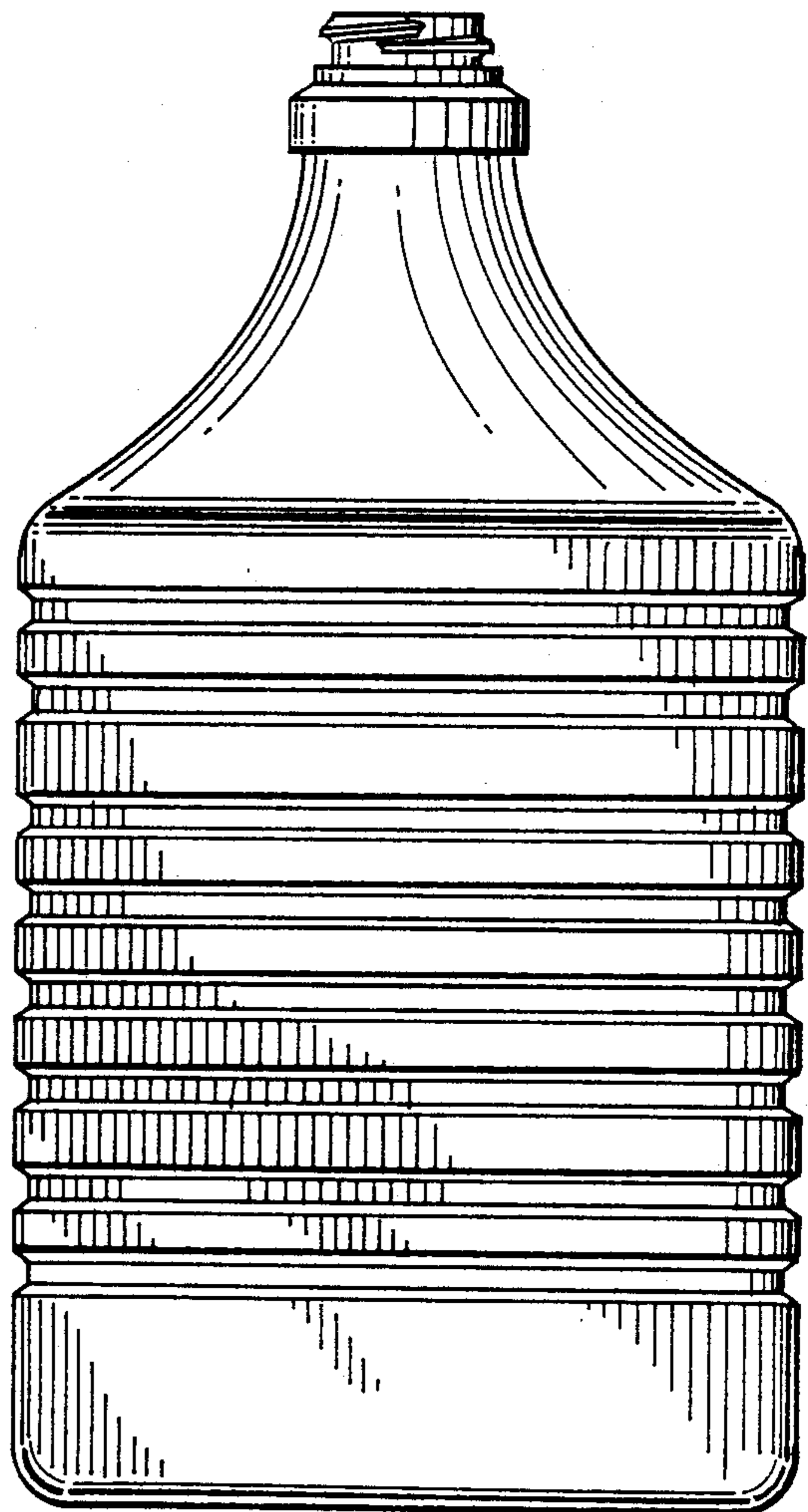

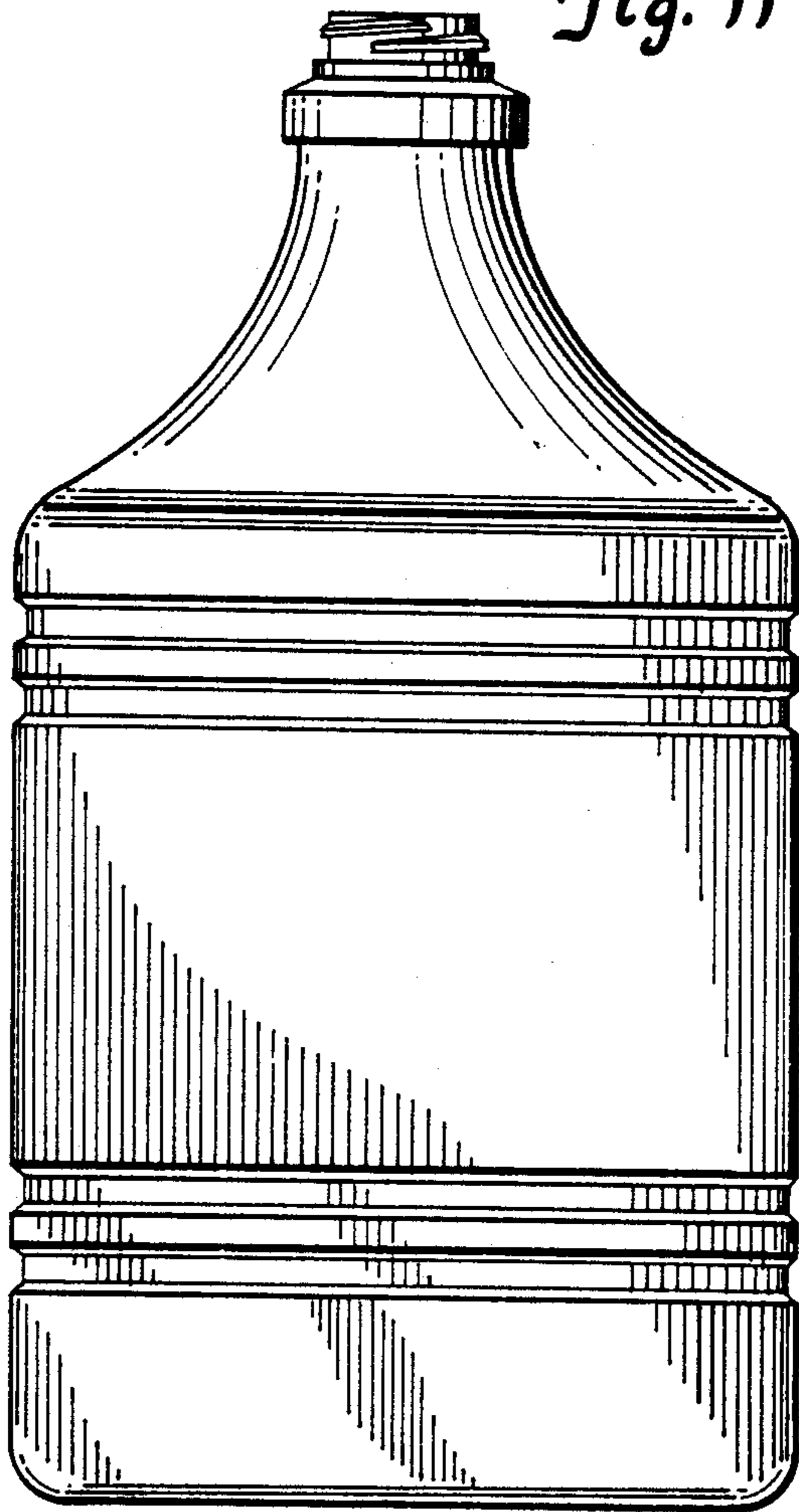


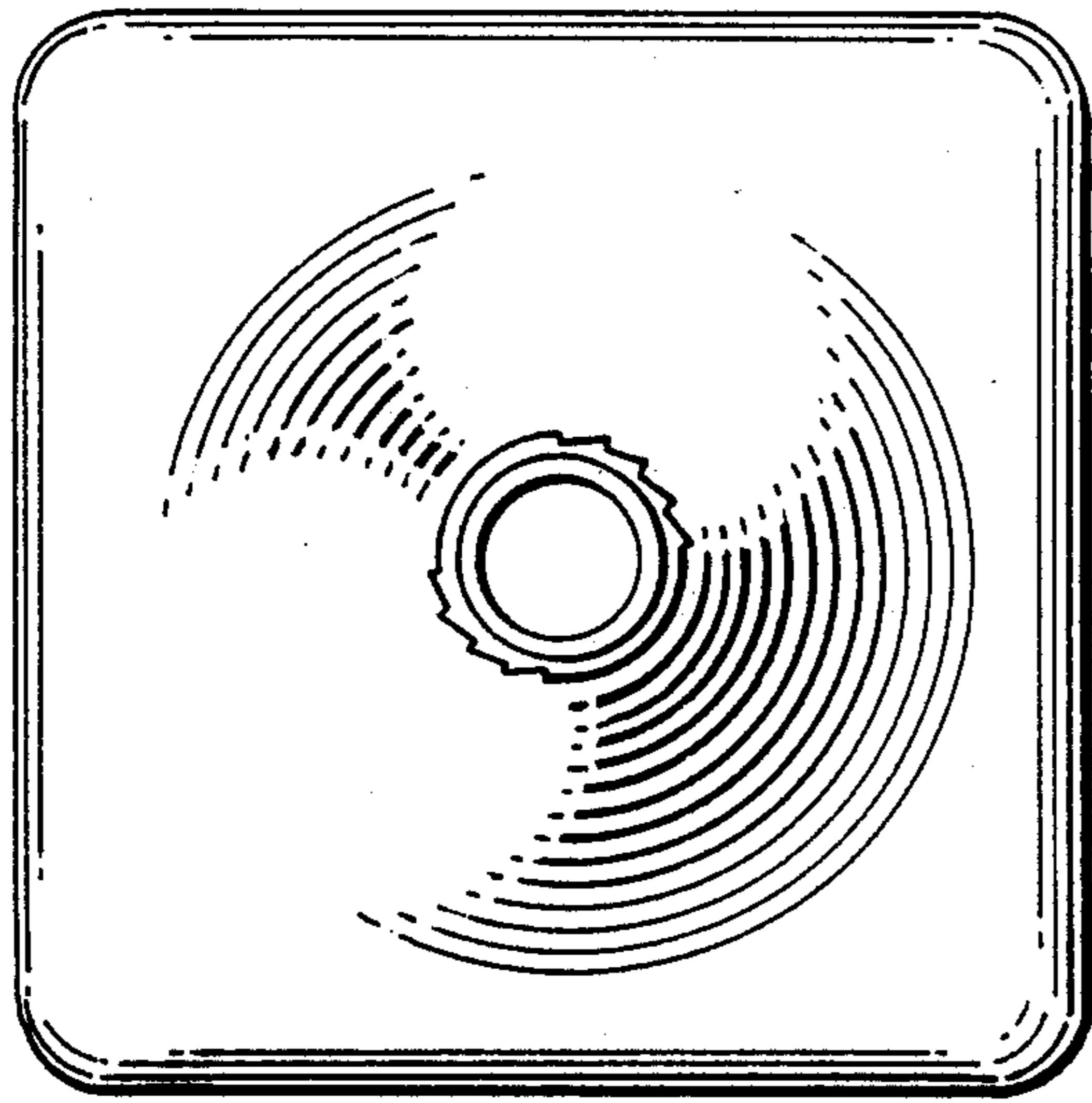

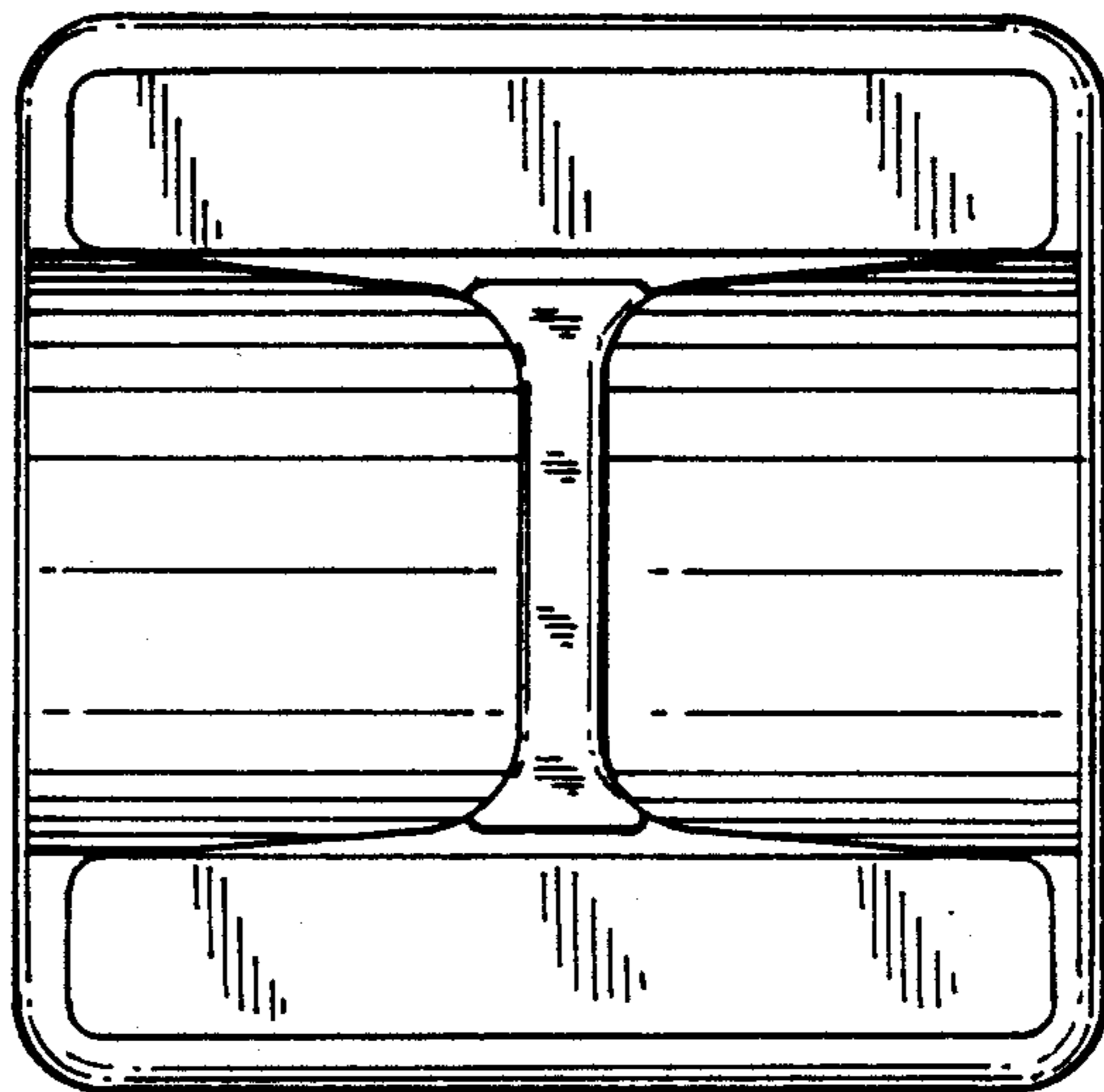

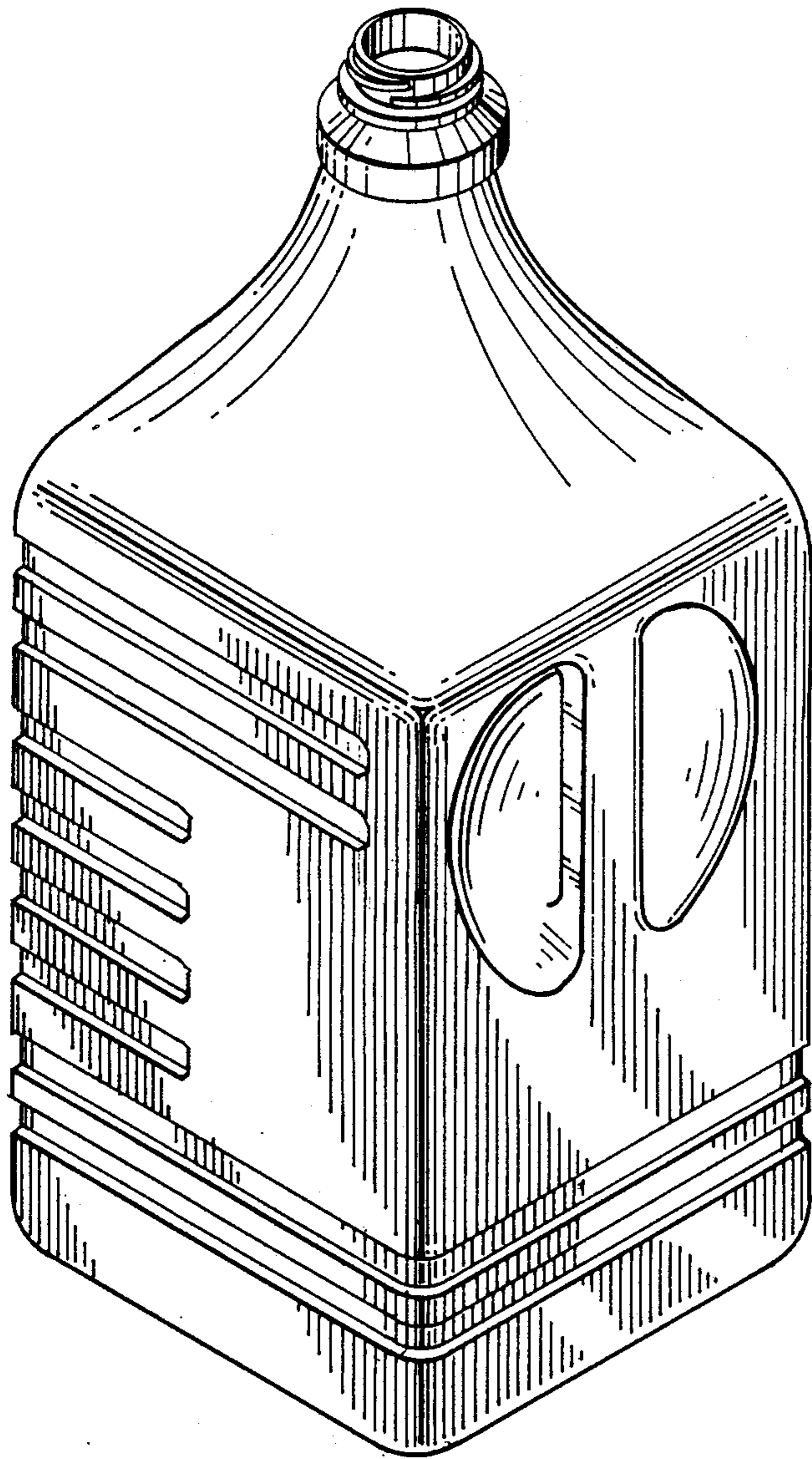

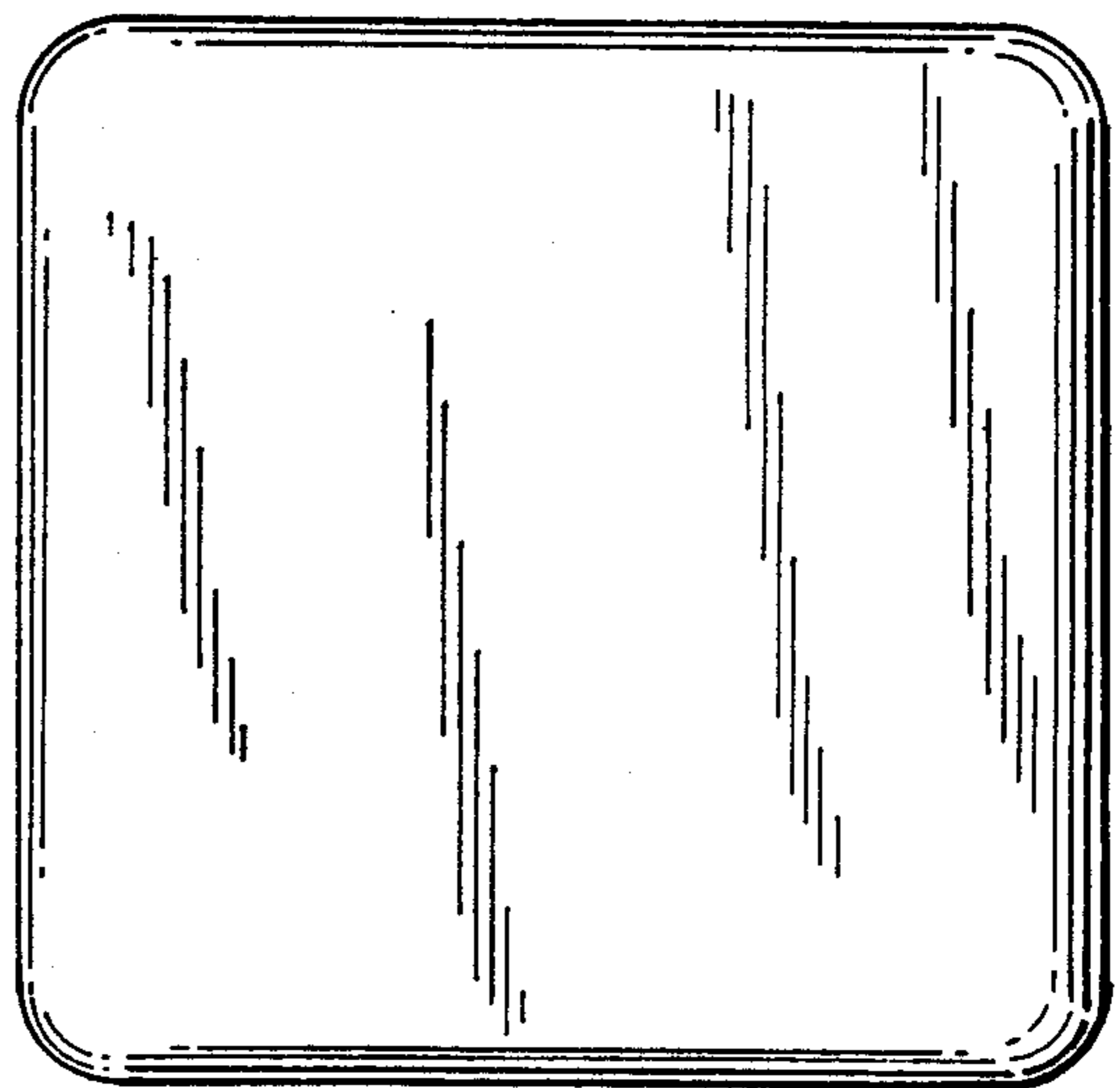

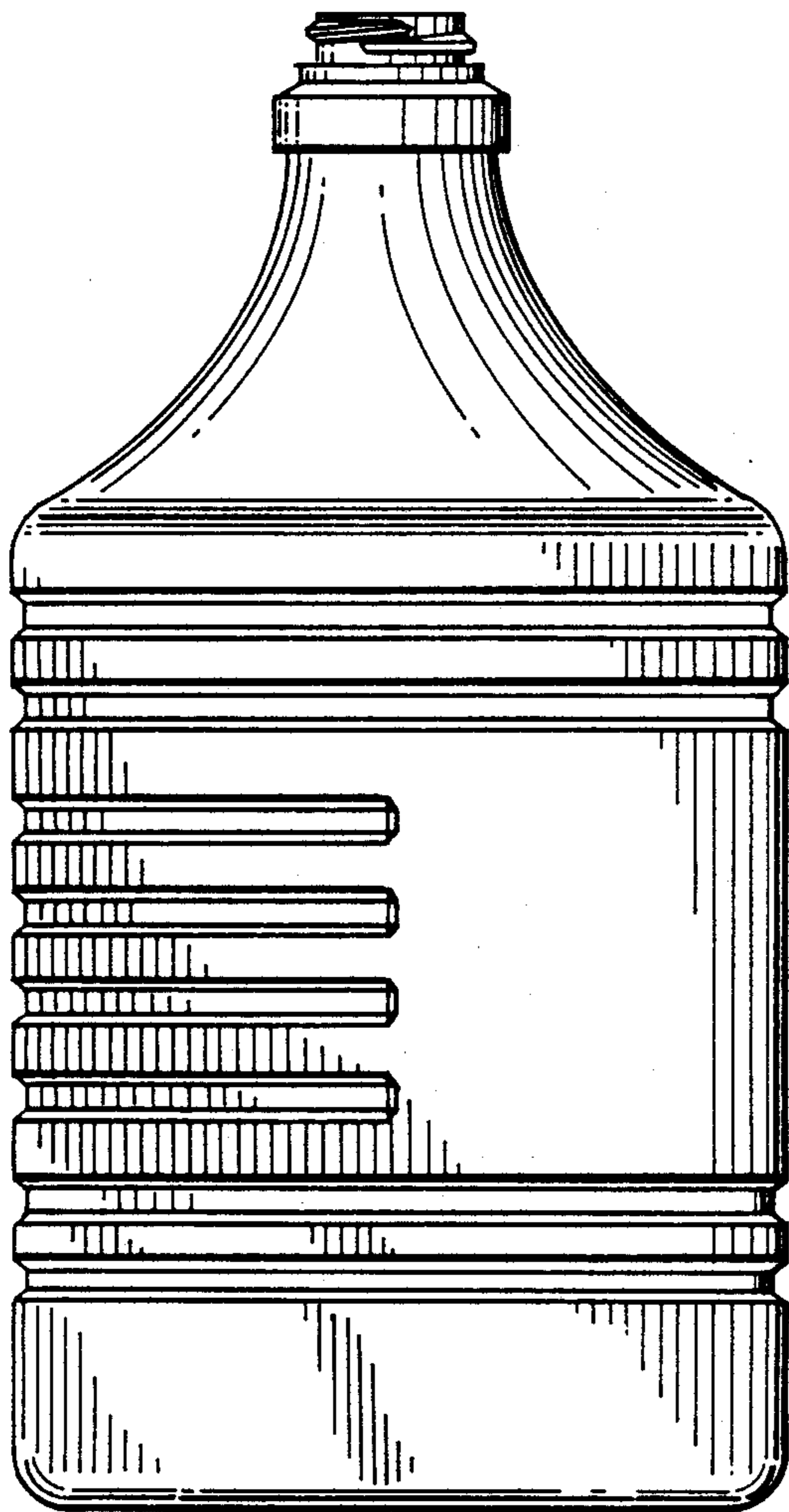




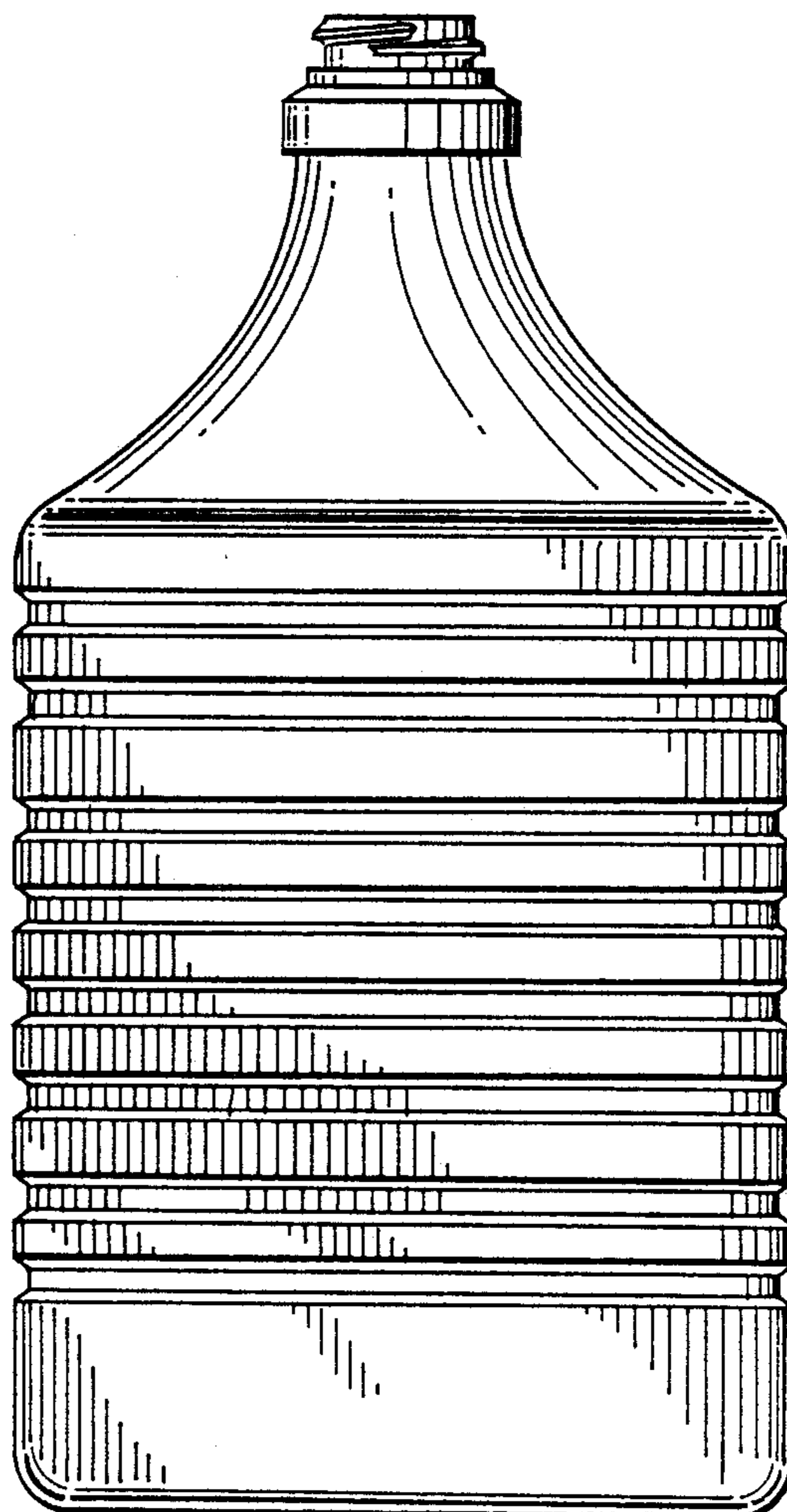

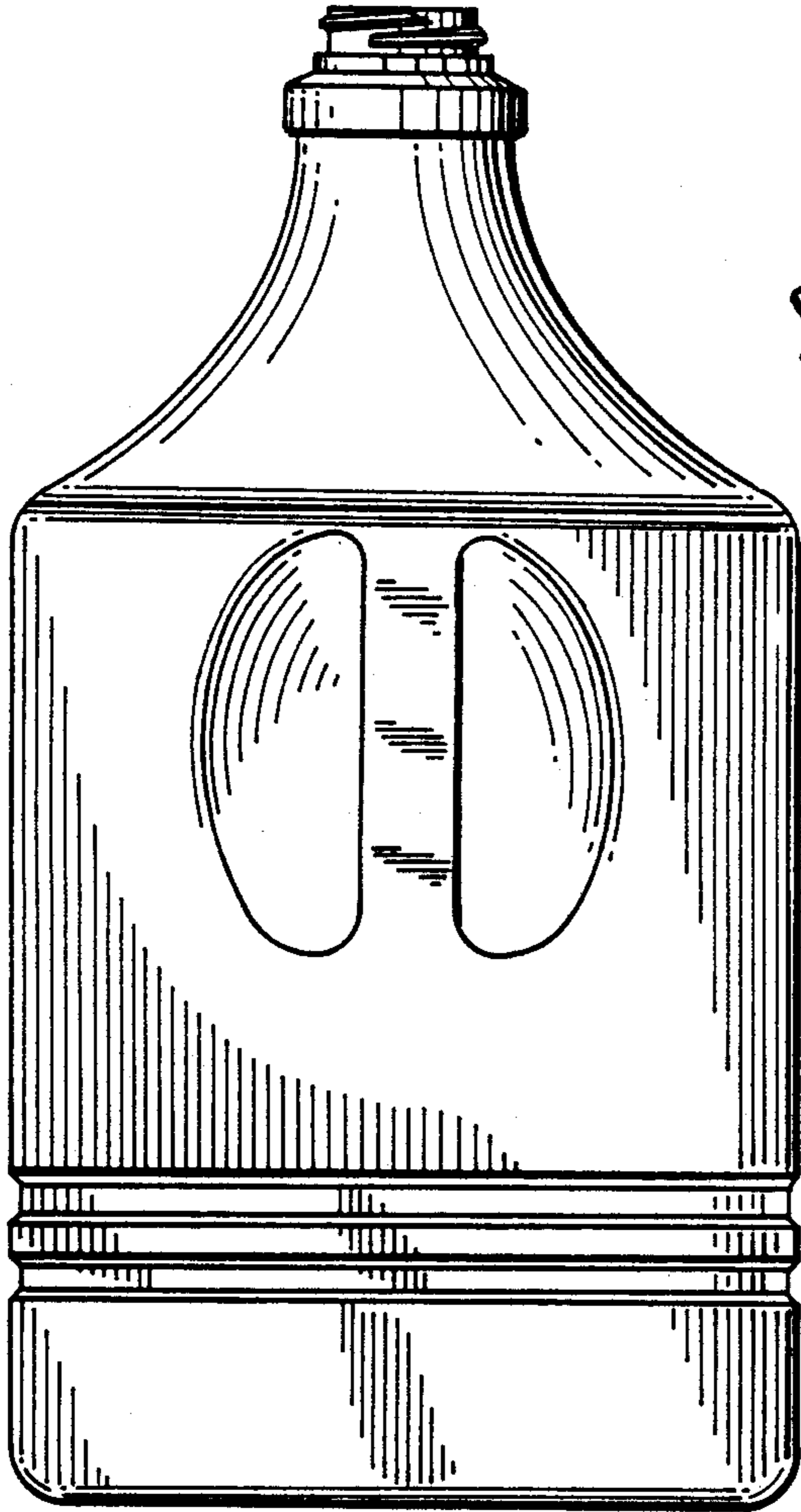

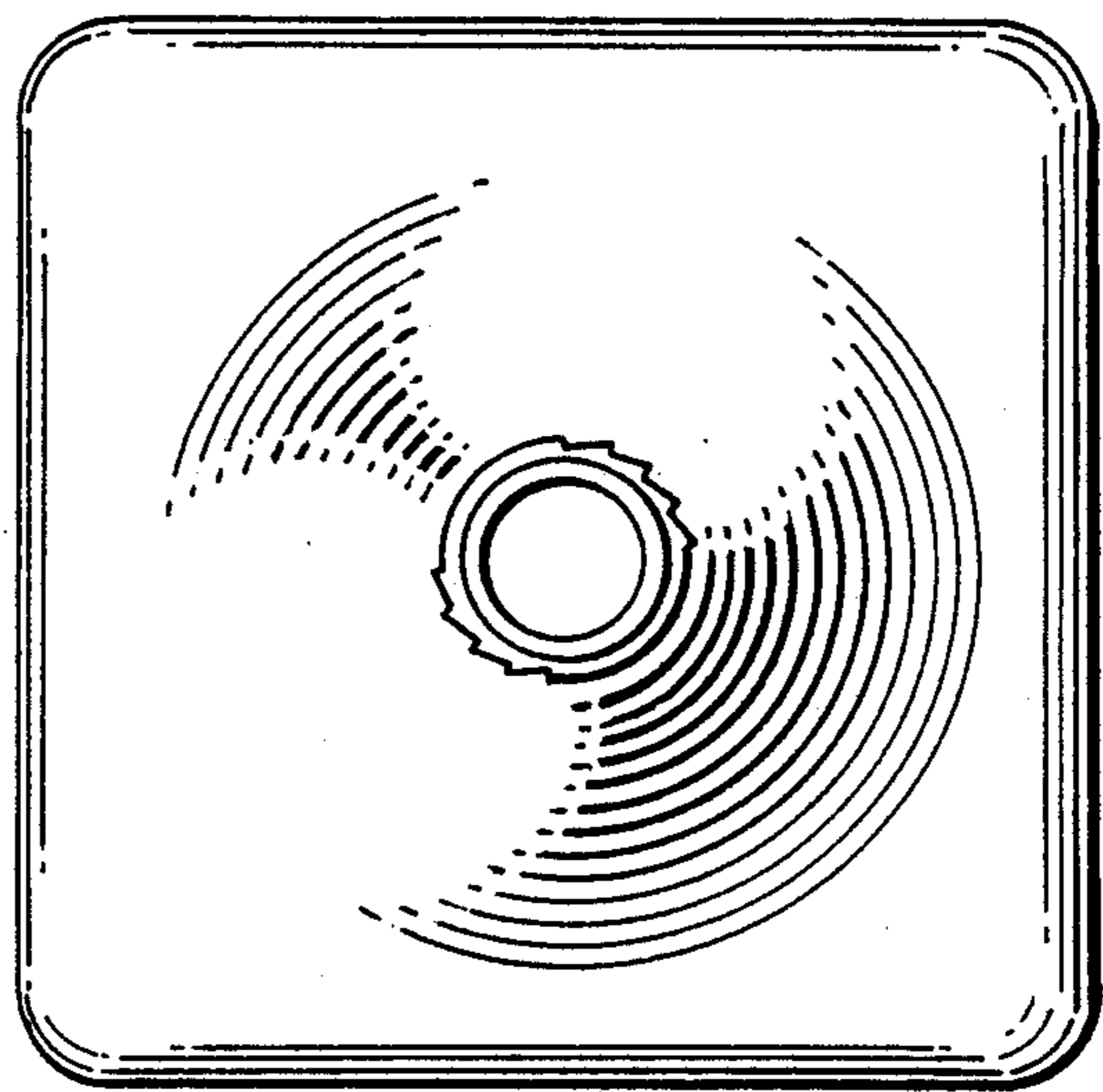
