[57] **CLAIM**

The ornamental design for a cord access grommet set for office furniture use, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the cord access grommet set for office furniture use as assembled, showing the top surface of the cap and base of our new design;

FIG. 2 is an exploded perspective view showing the cap and base;

FIG. 3 is a top plan view of the cap;

FIG. 4 is a bottom plan view thereof;

FIG. 5 is a right side elevational view thereof;

FIG. 6 is a left side elevational view thereof;

FIG. 7 is a front elevational view thereof;

FIG. 8 is a rear elevational view thereof;

FIG. 9 is a top plan view of the base;

FIG. 14 is a rear elevational view thereof.

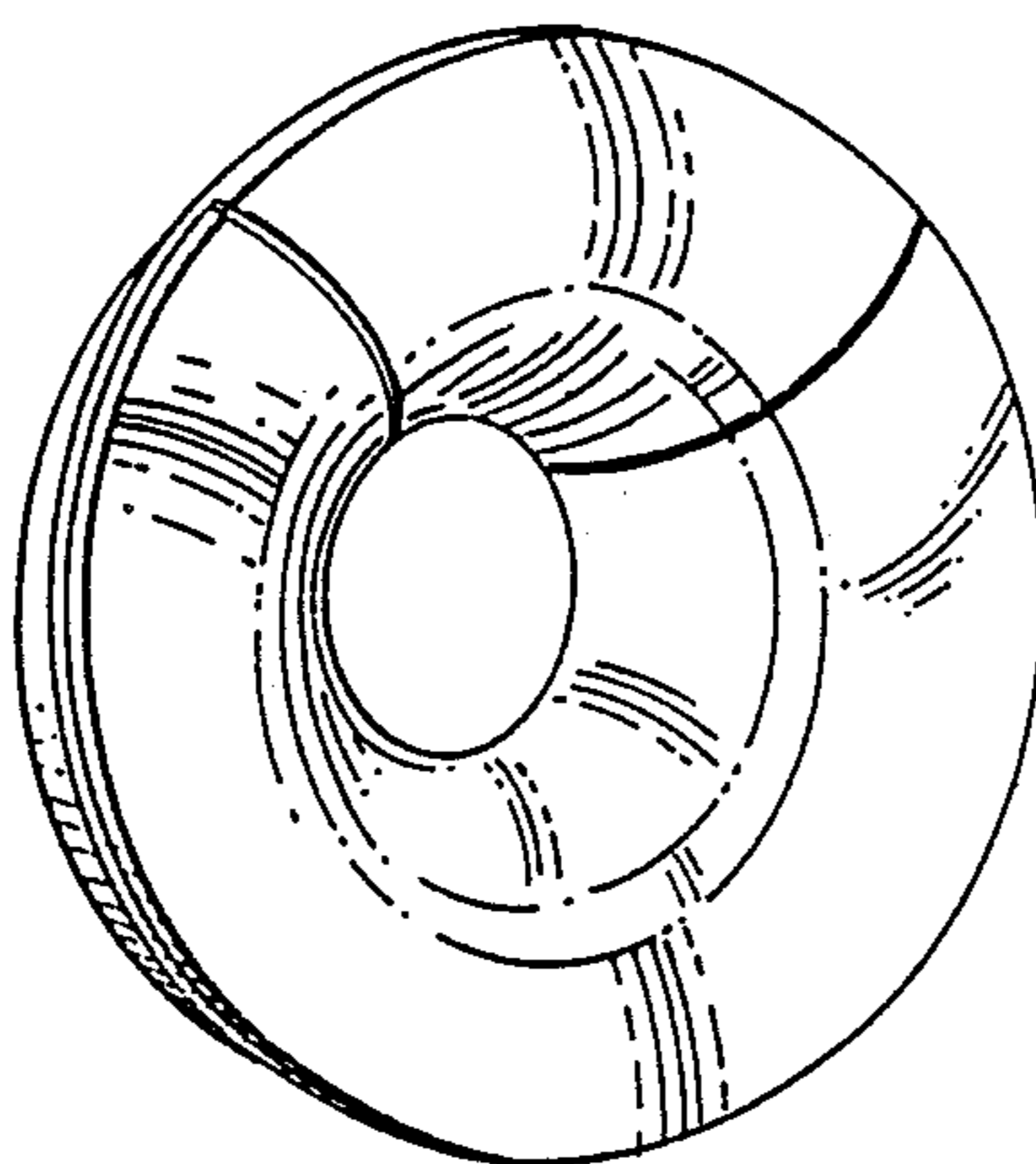

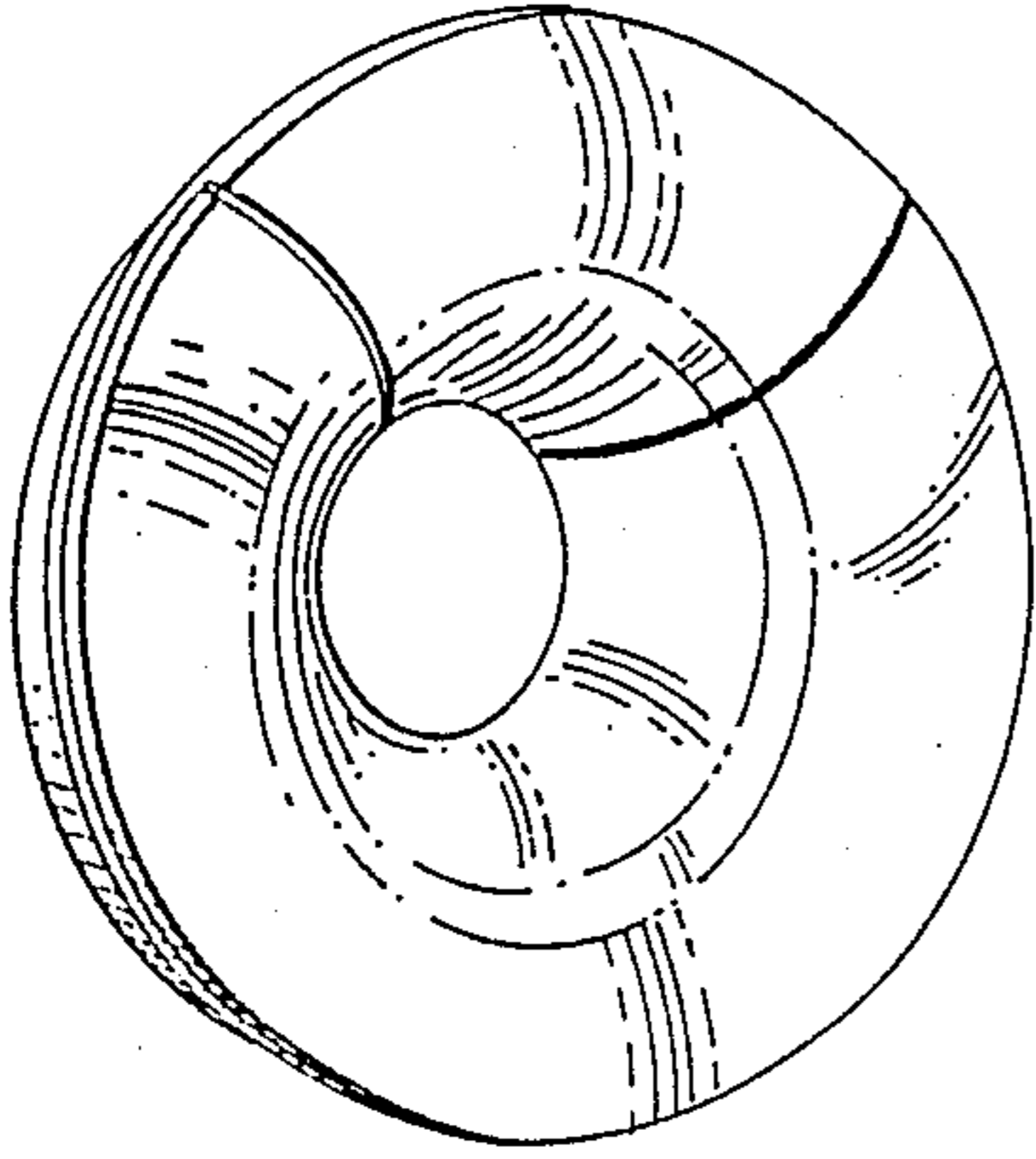

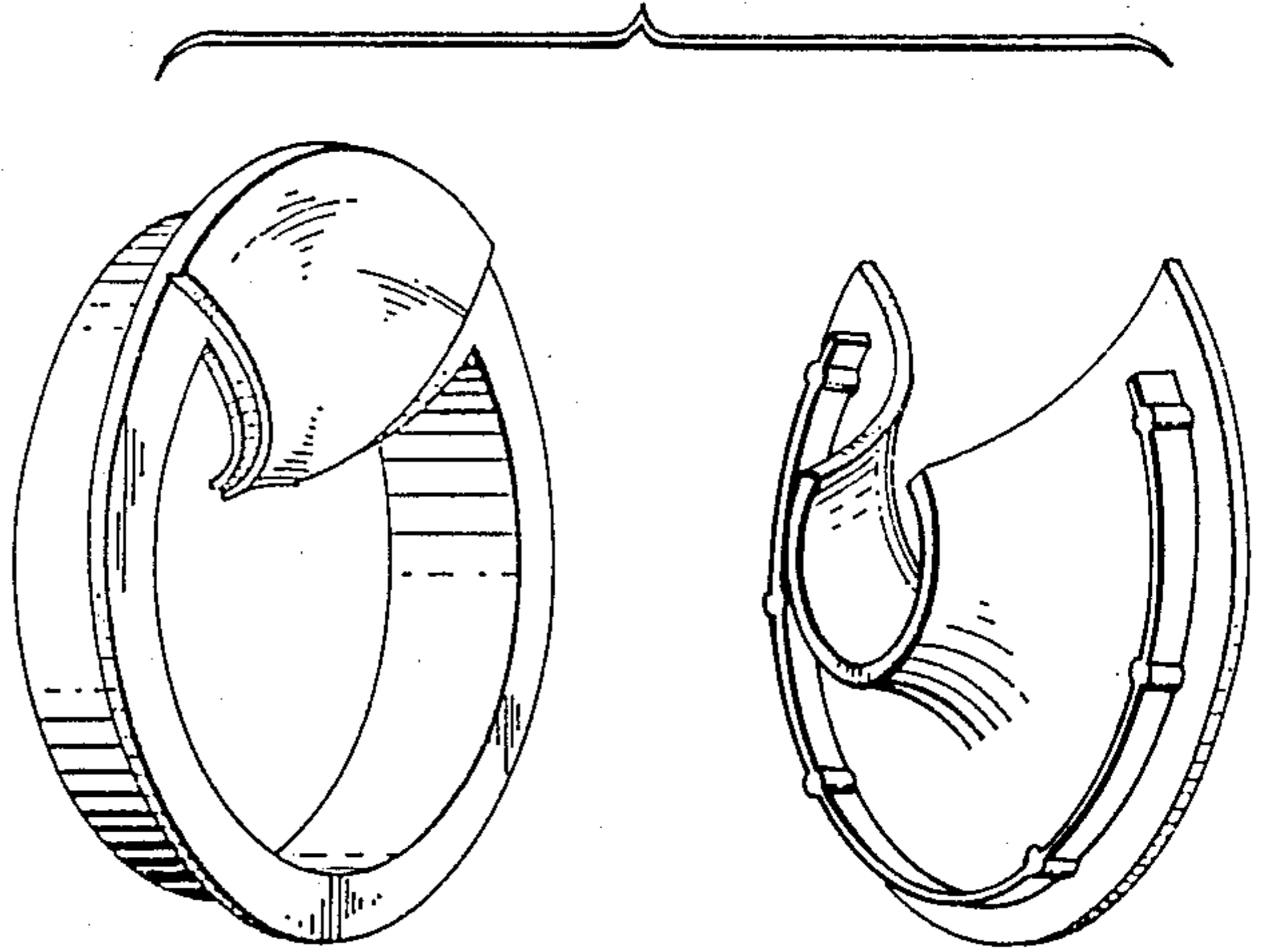

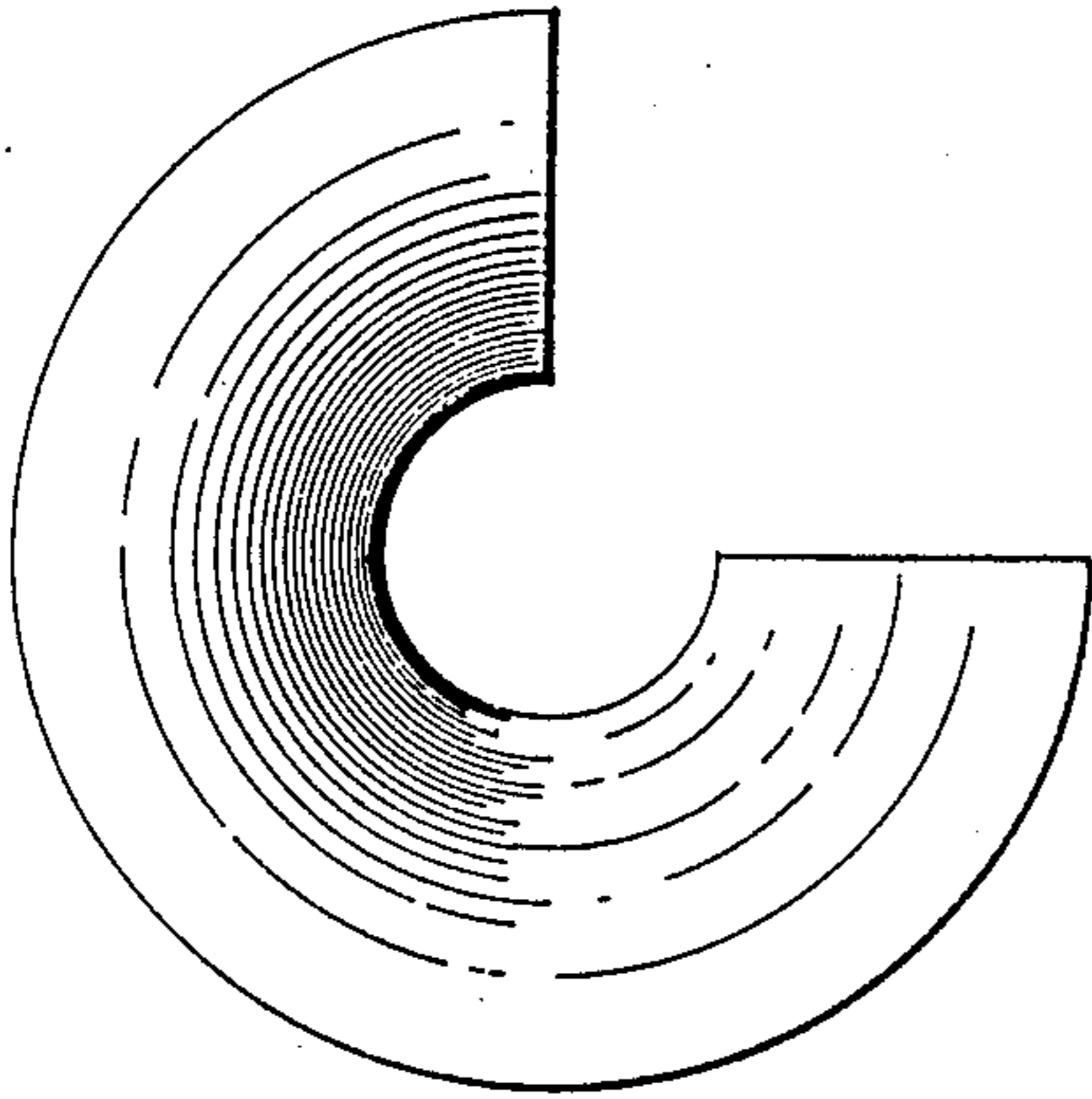

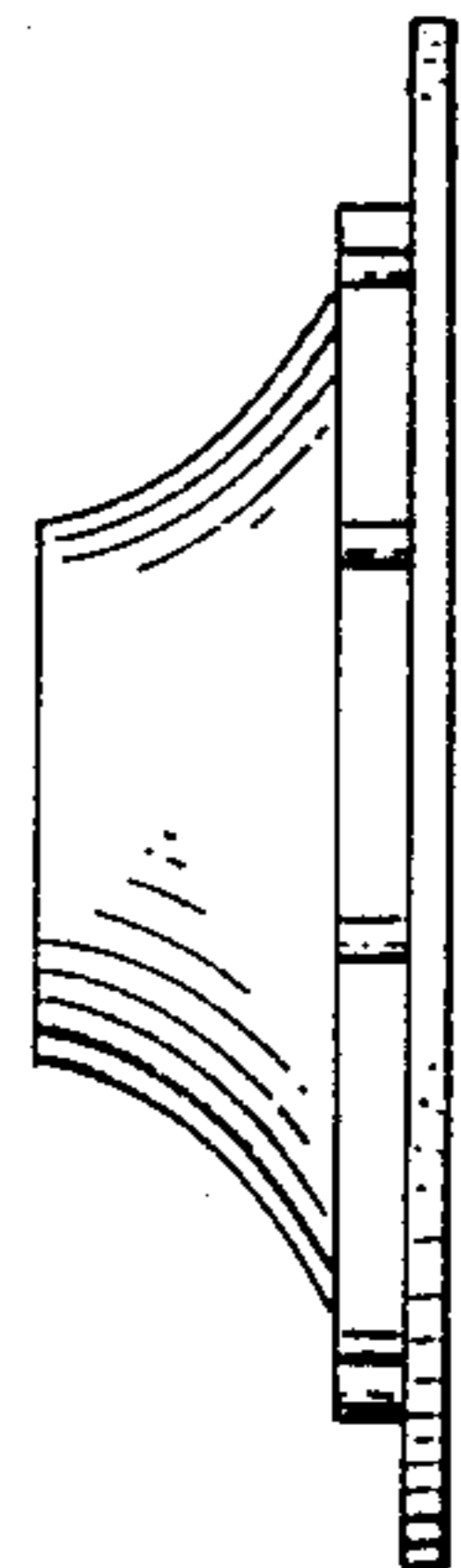
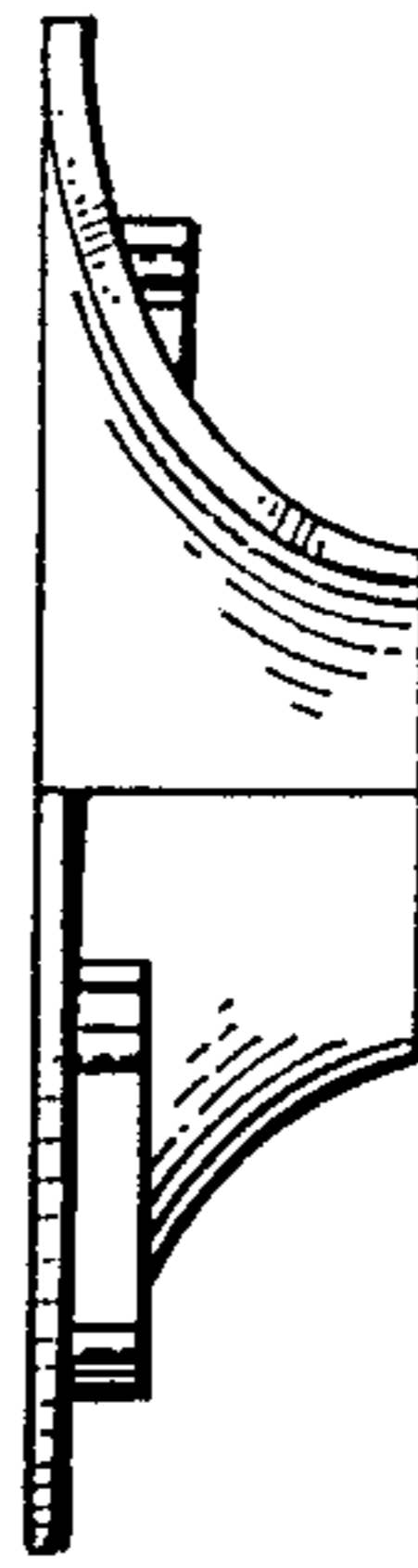

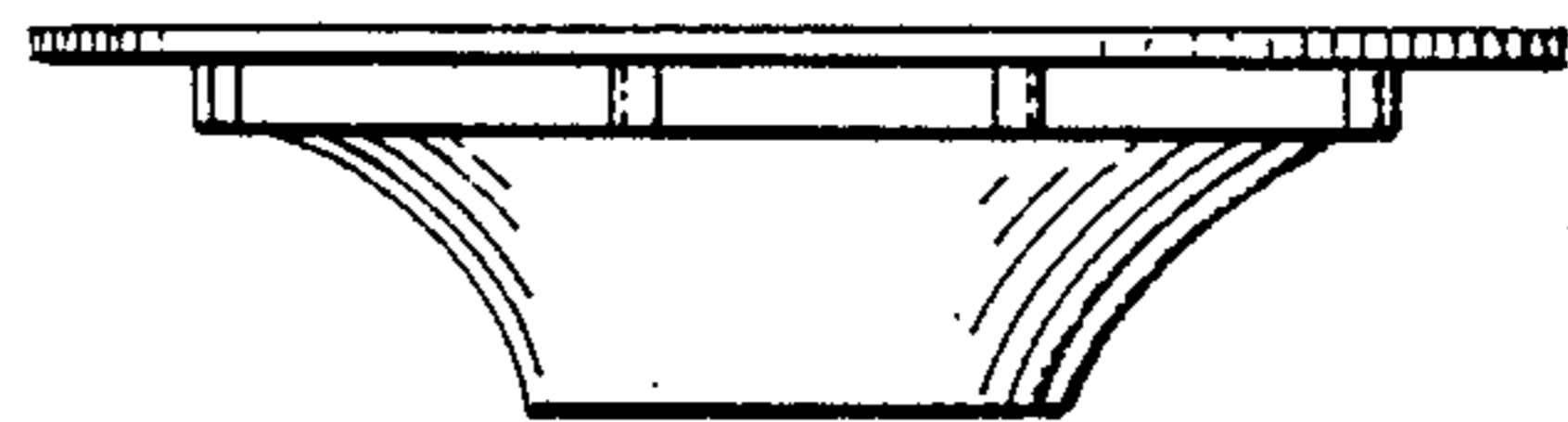
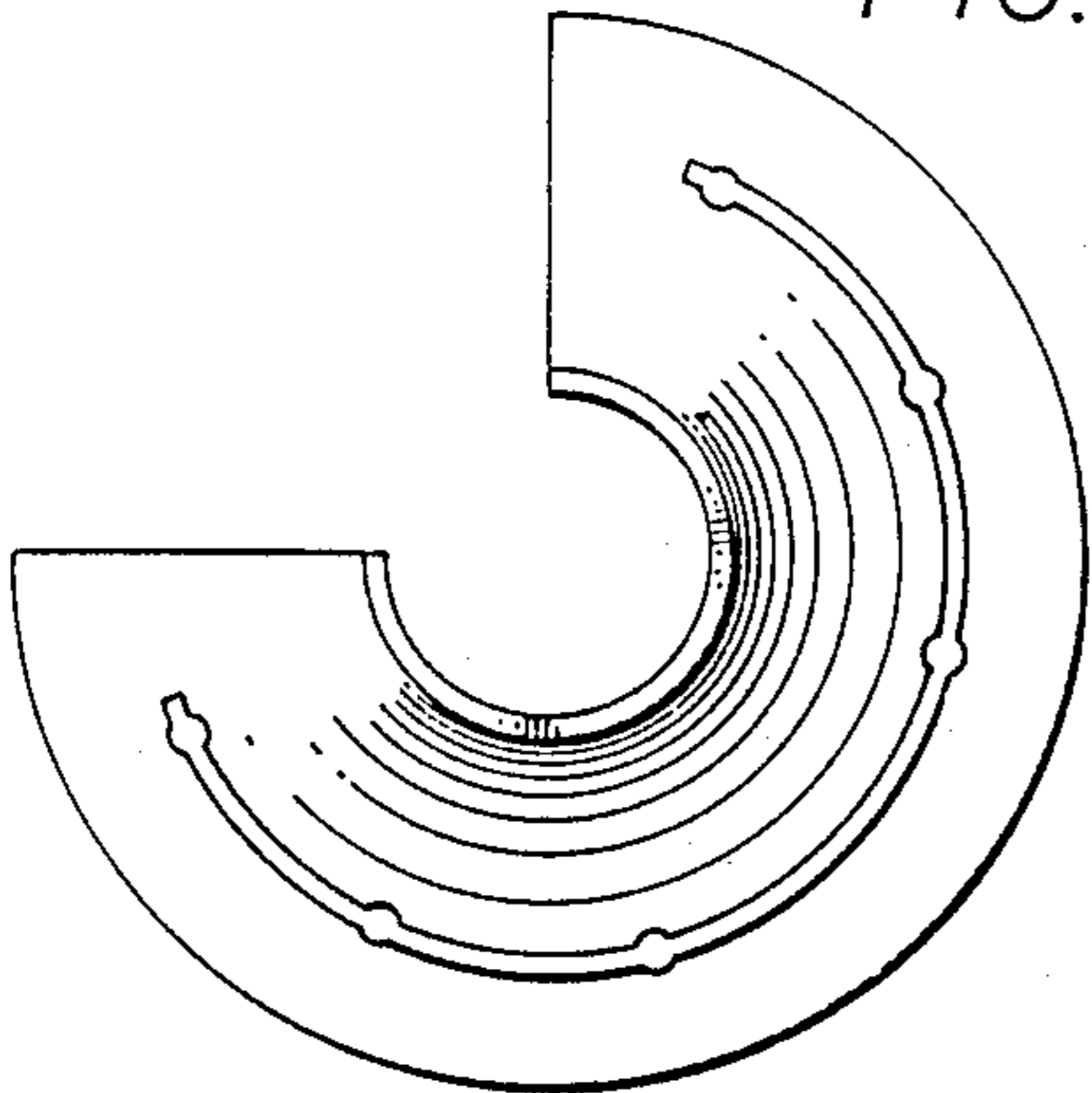

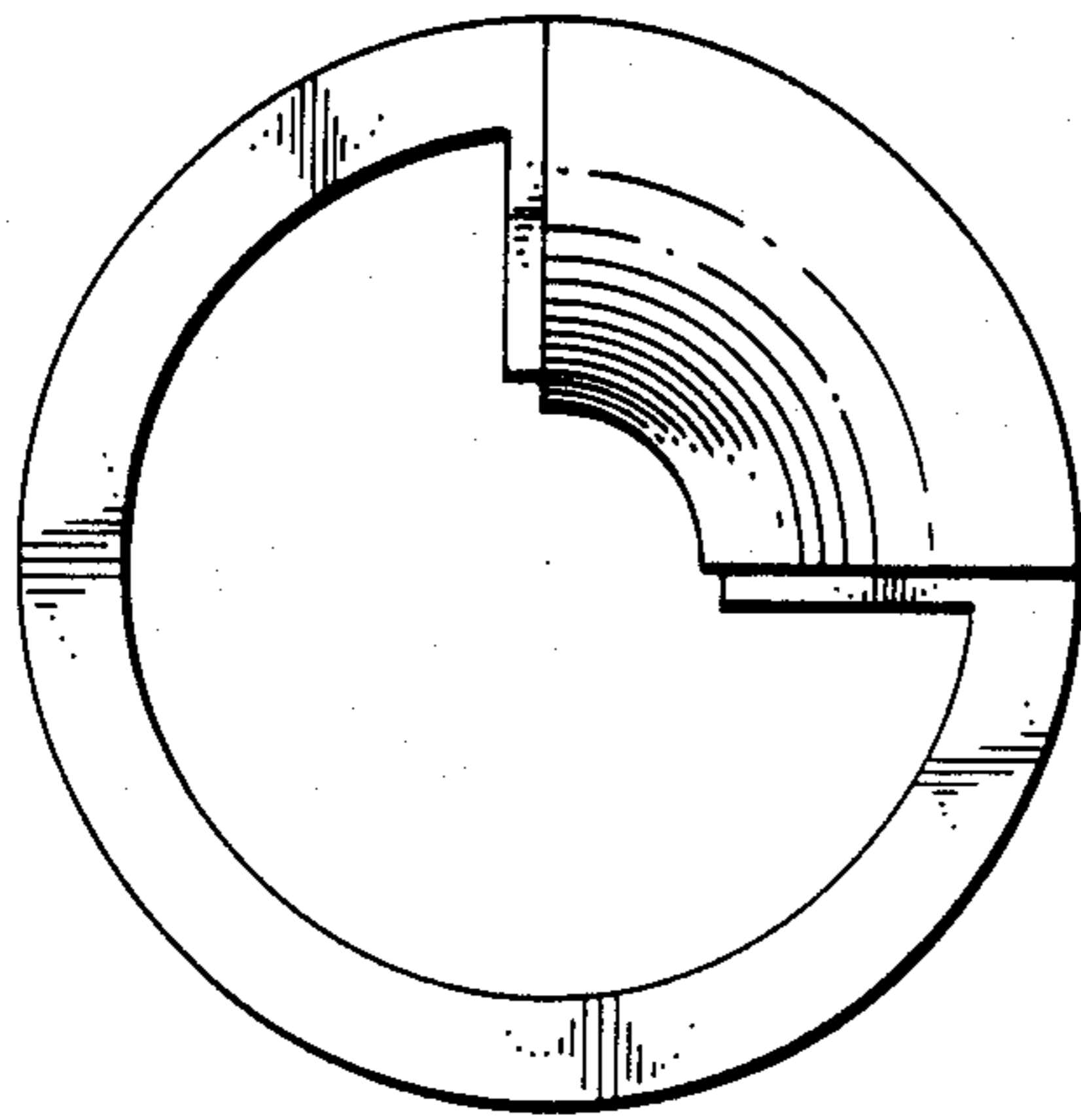

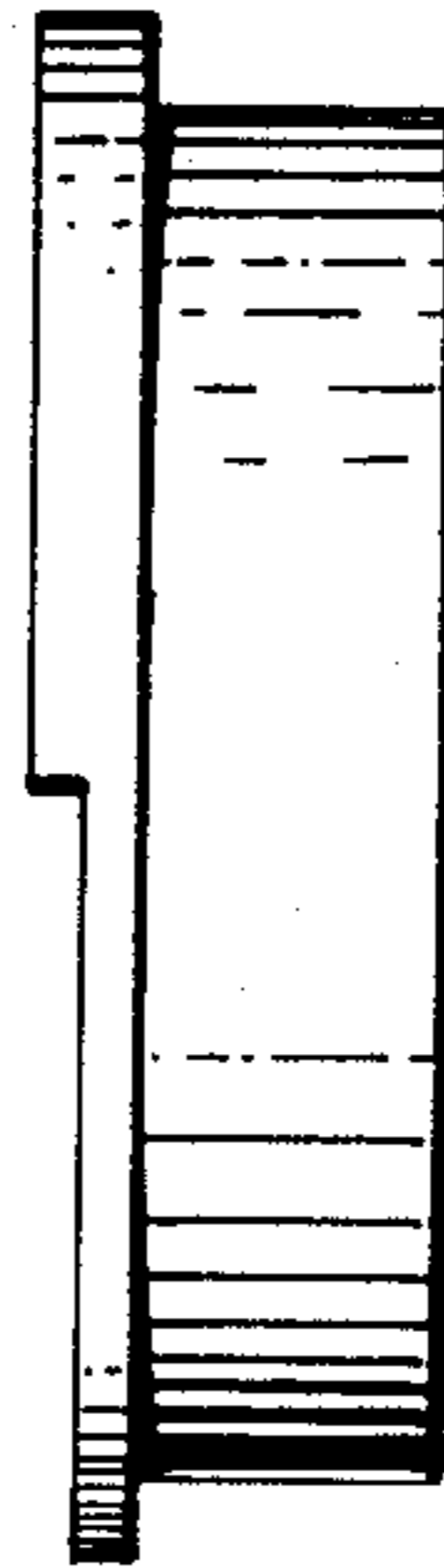

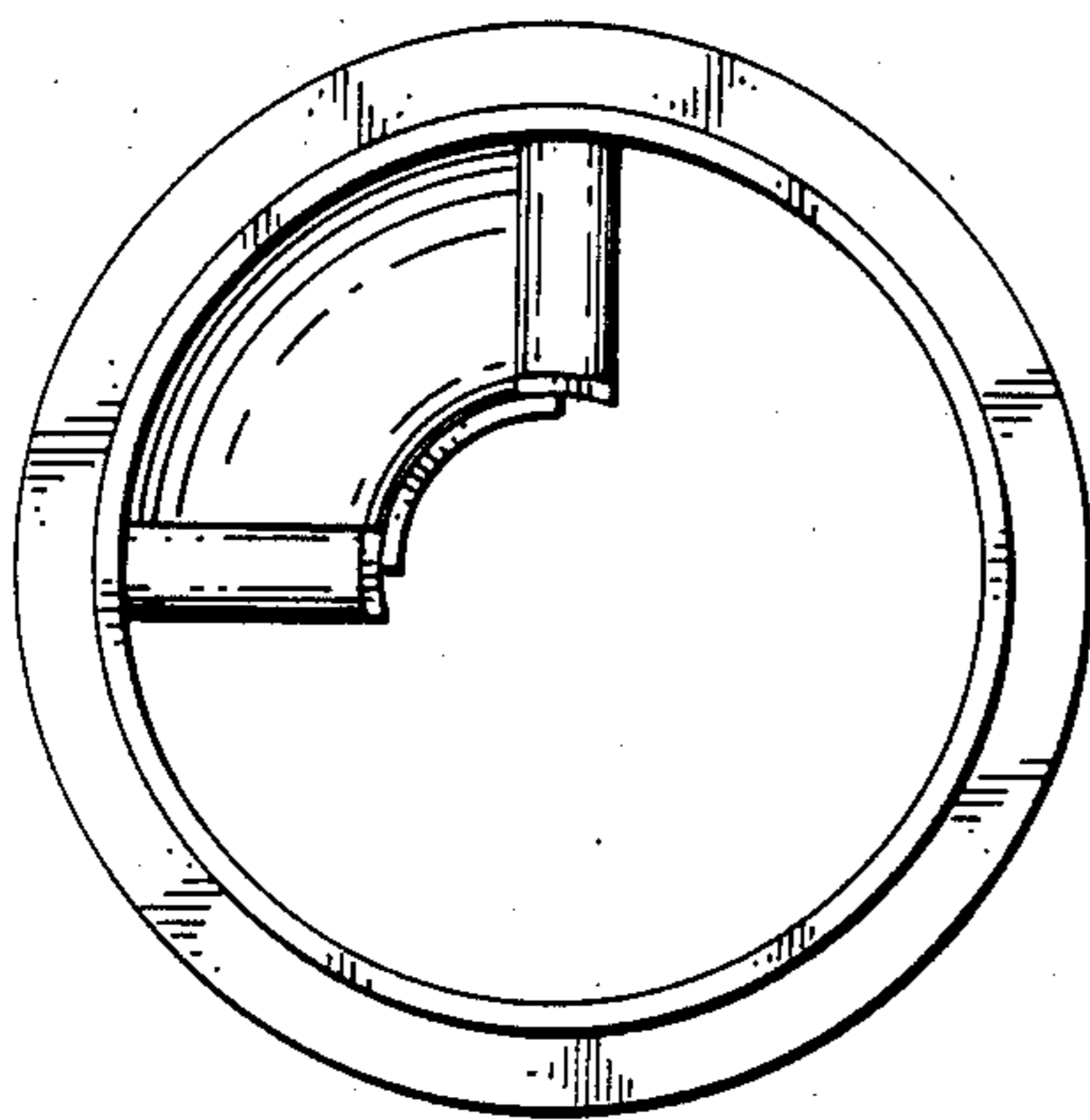

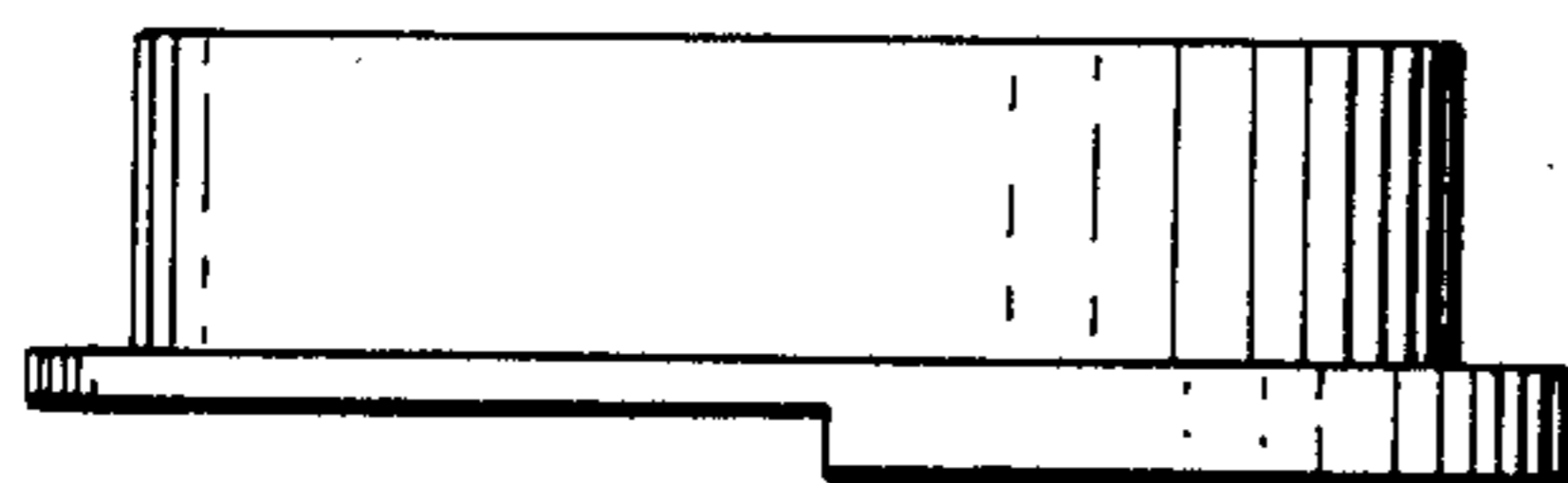
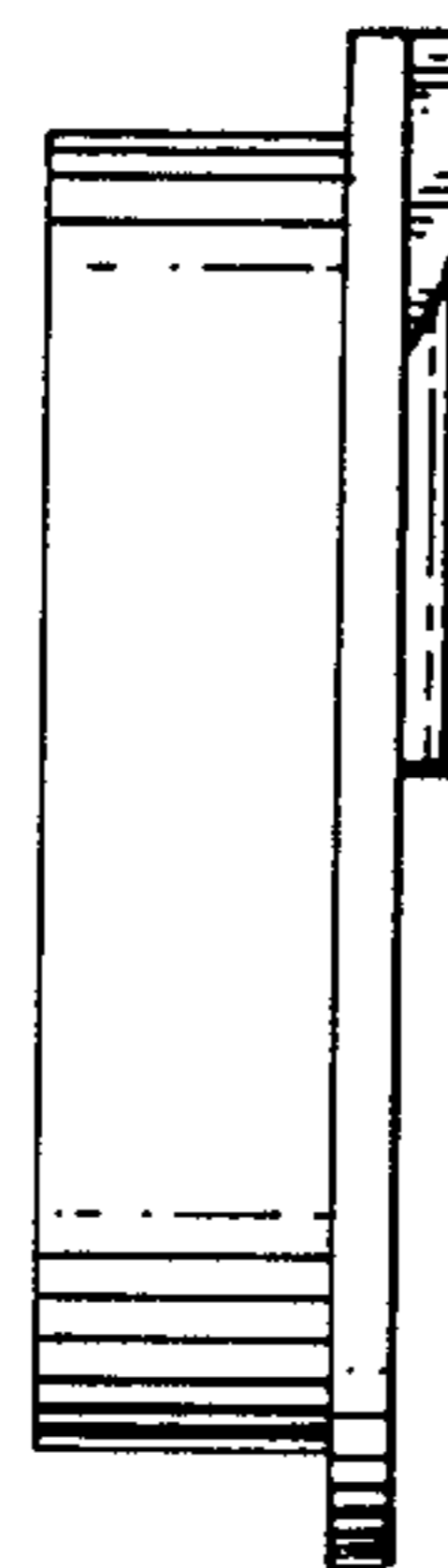

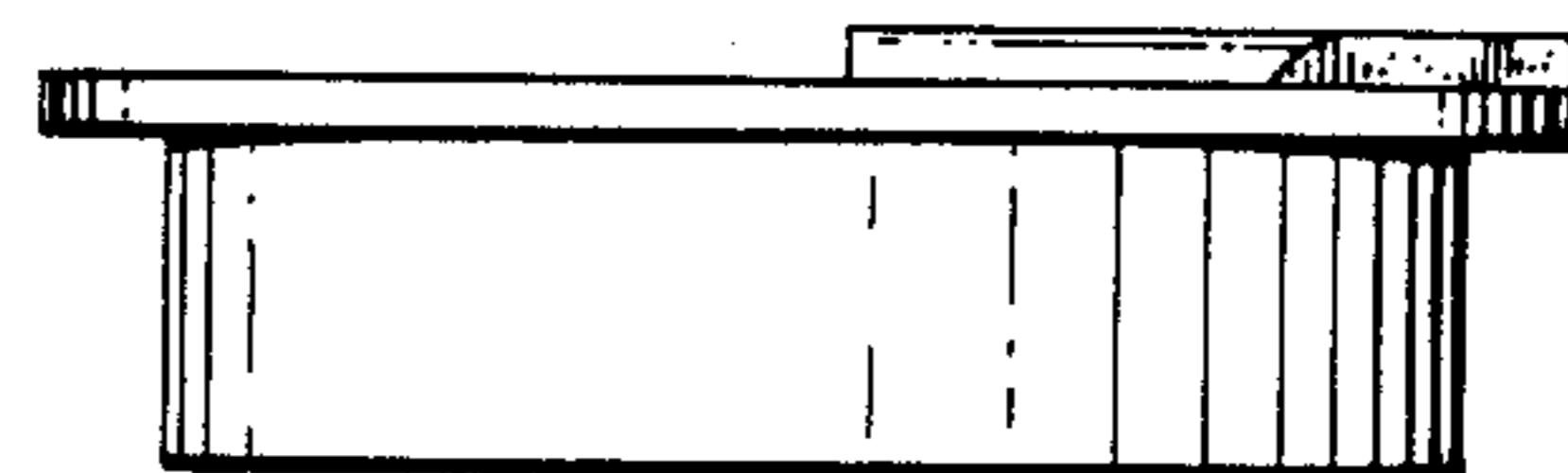
