[57] CLAIM

The ornamental design for a housing for an electrical connector, as shown and described.

DESCRIPTION

FIG. 1 is a rear, top and left side perspective view of a housing for an electrical connector showing my new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a rear elevational view thereof;

FIG. 4 is a right side elevational view thereof, the left side elevational view being a mirror image;

FIG. 5 is a top plan view thereof;

FIG. 6 is a bottom plan view thereof;

FIG. 7 is a front elevational view of a housing for an electrical connector showing my new design in the open position;

FIG. 8 is a rear elevational view thereof;

FIG. 9 is a top plan view thereof;

FIG. 10 is a right side elevational view thereof, the left side elevational view being a mirror image;

FIG. 11 is a rear, top and left side perspective view of a housing for an electrical connector showing my new design with its conductors mounted, positioned for coupling to another connector housing for the purpose of a complete disclosure.

The broken line showing is for illustrative purposes only and forms no part of the claimed design.

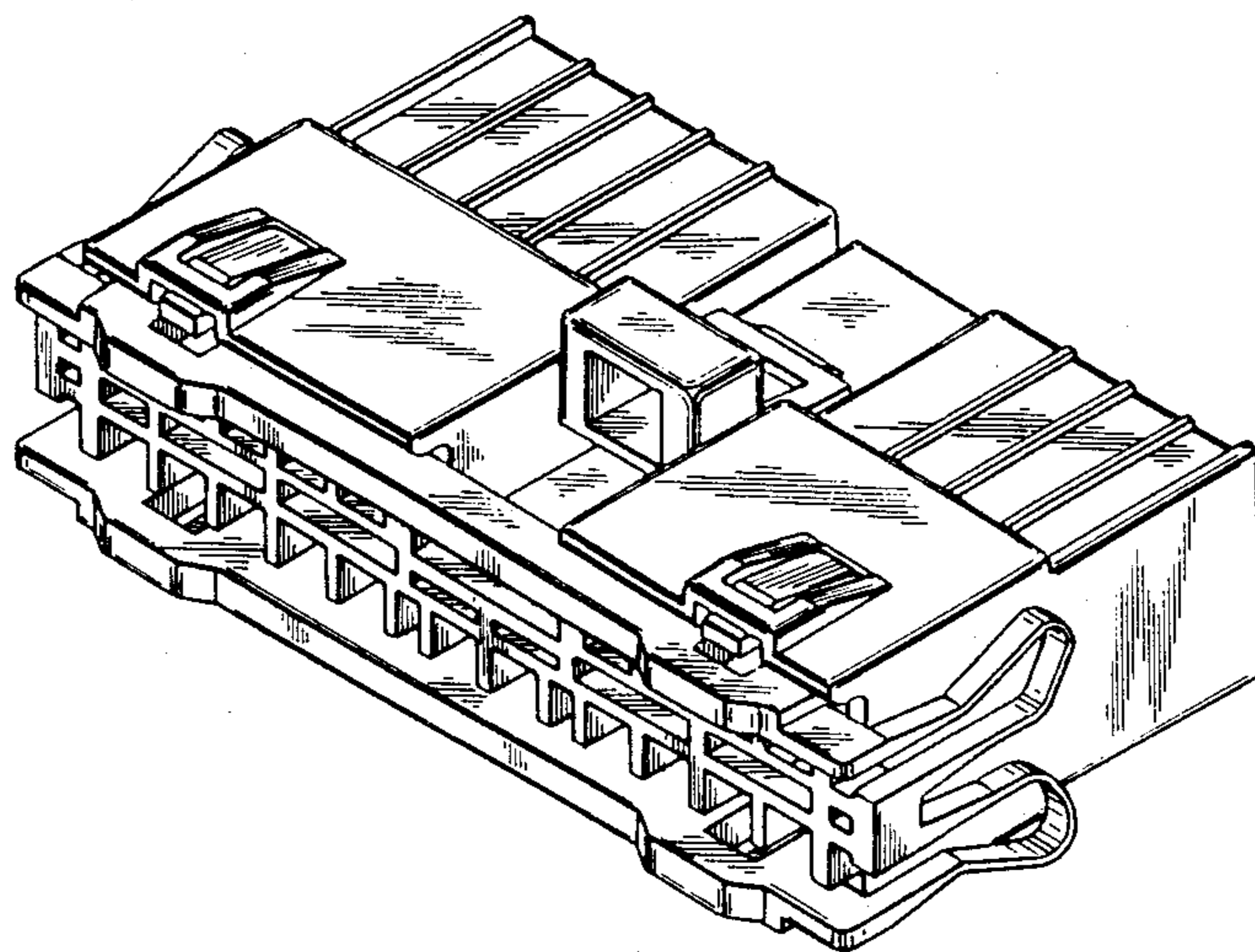

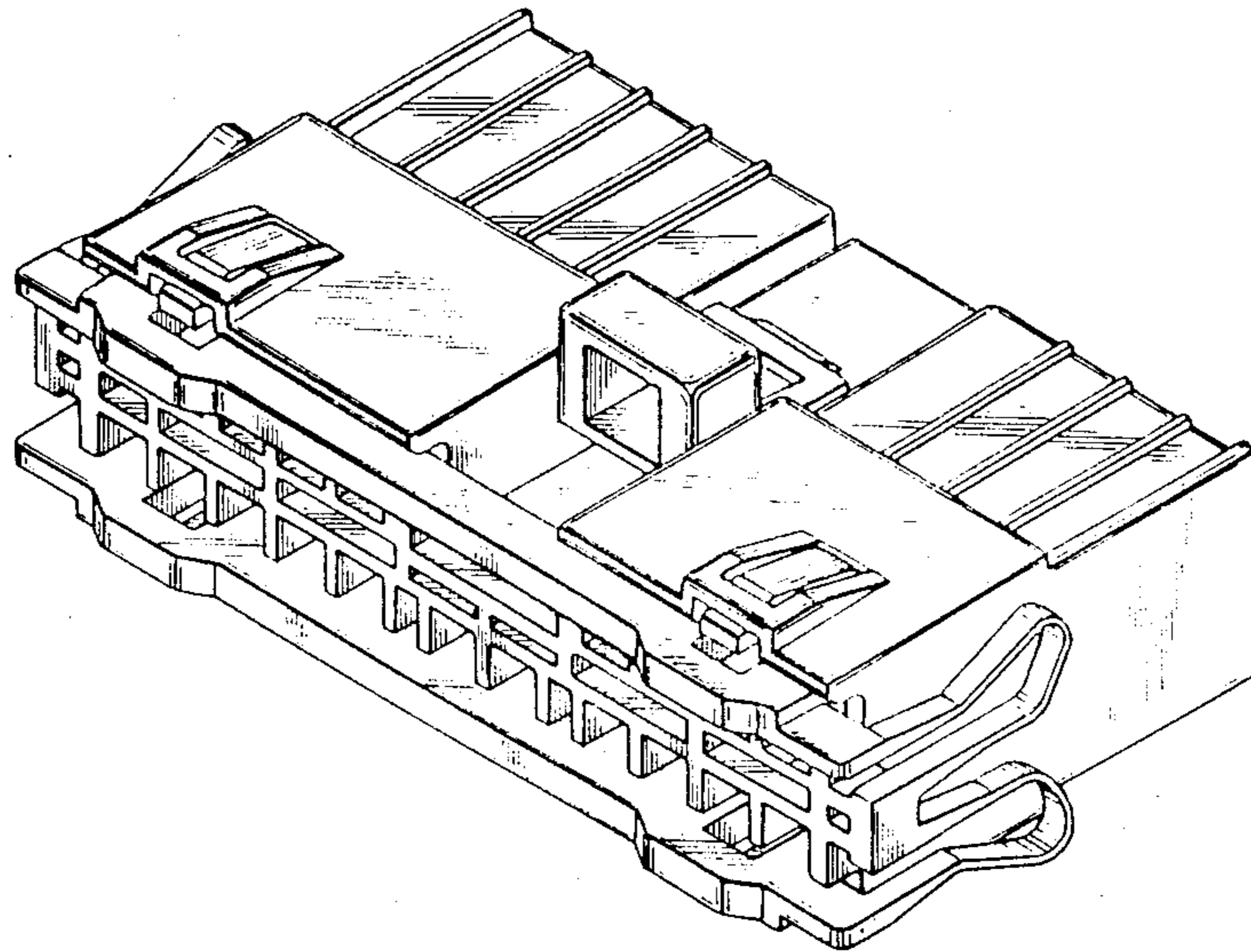

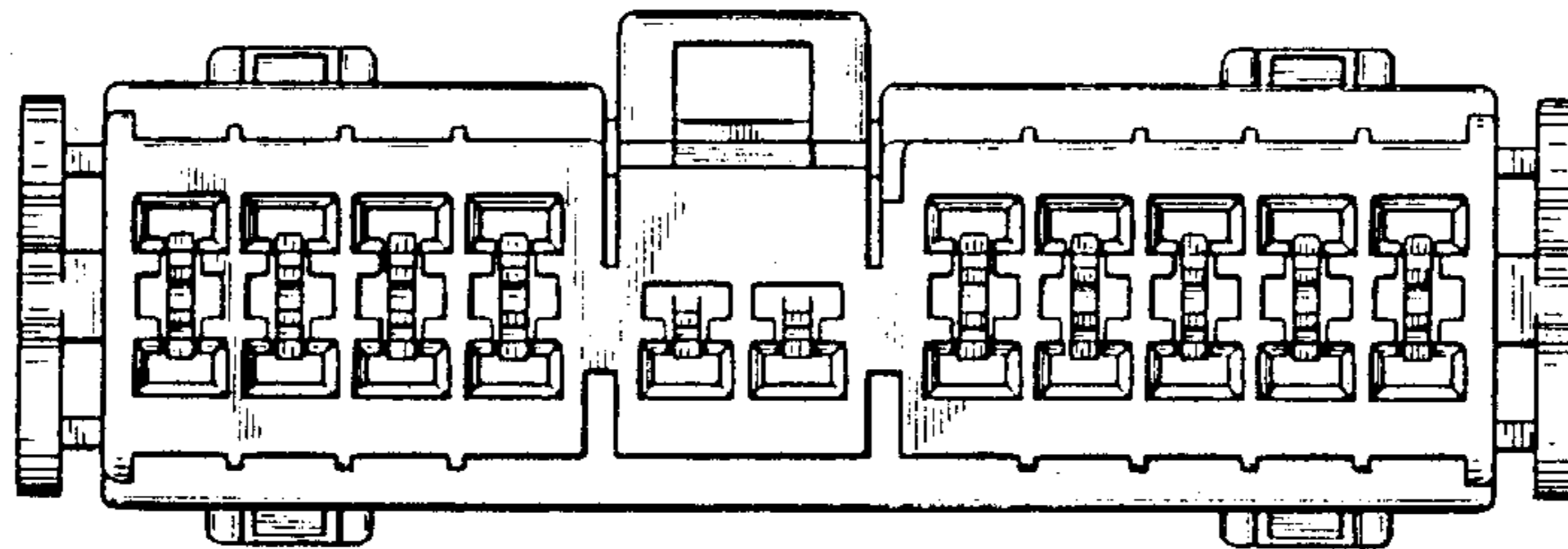

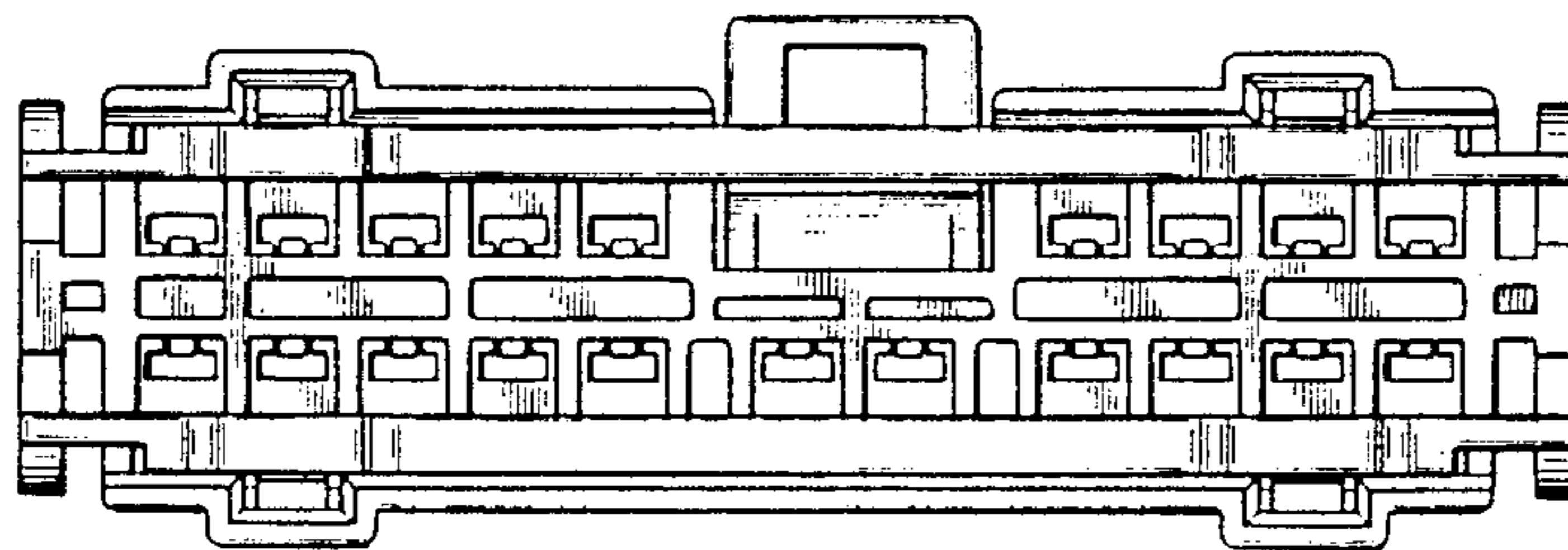

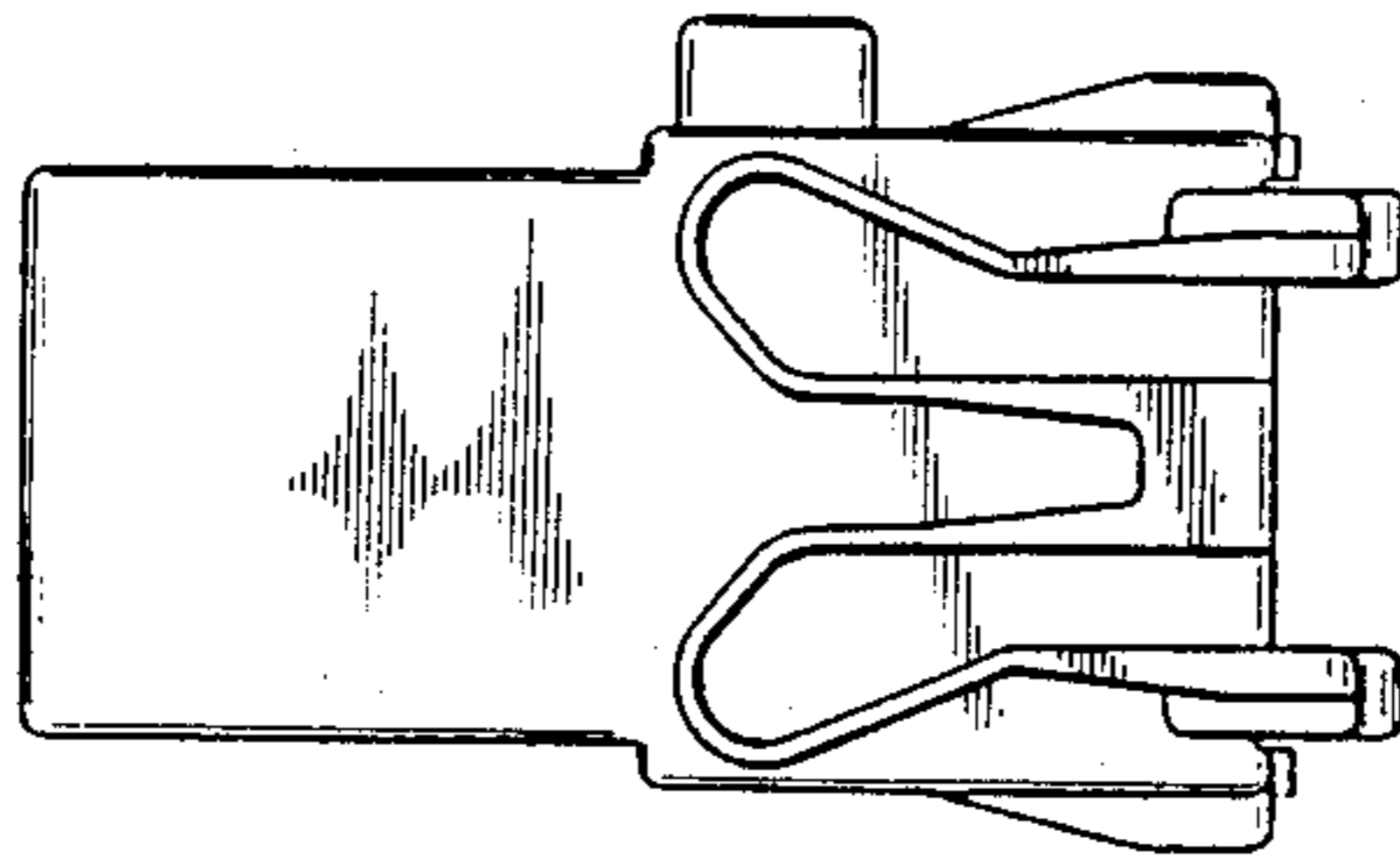

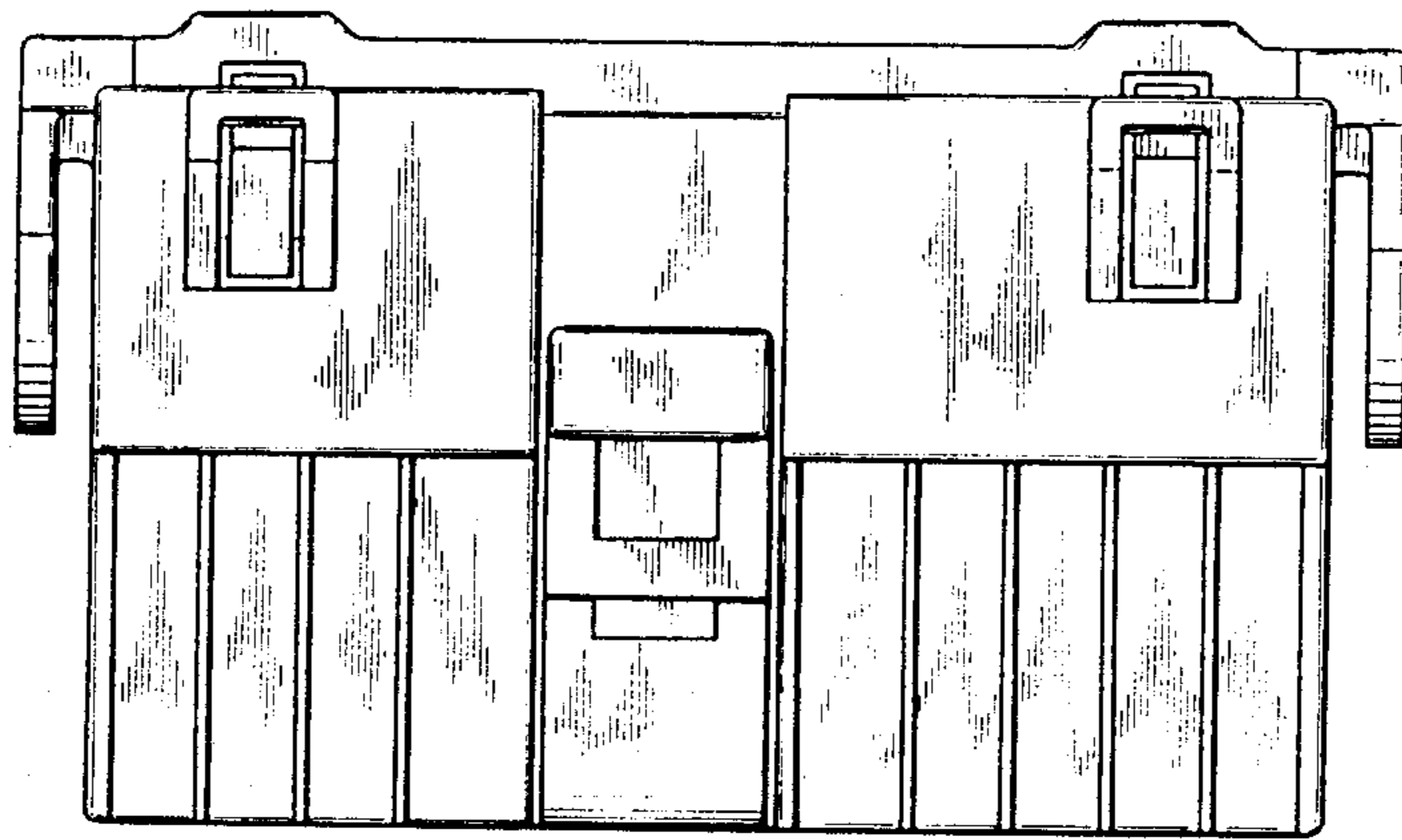

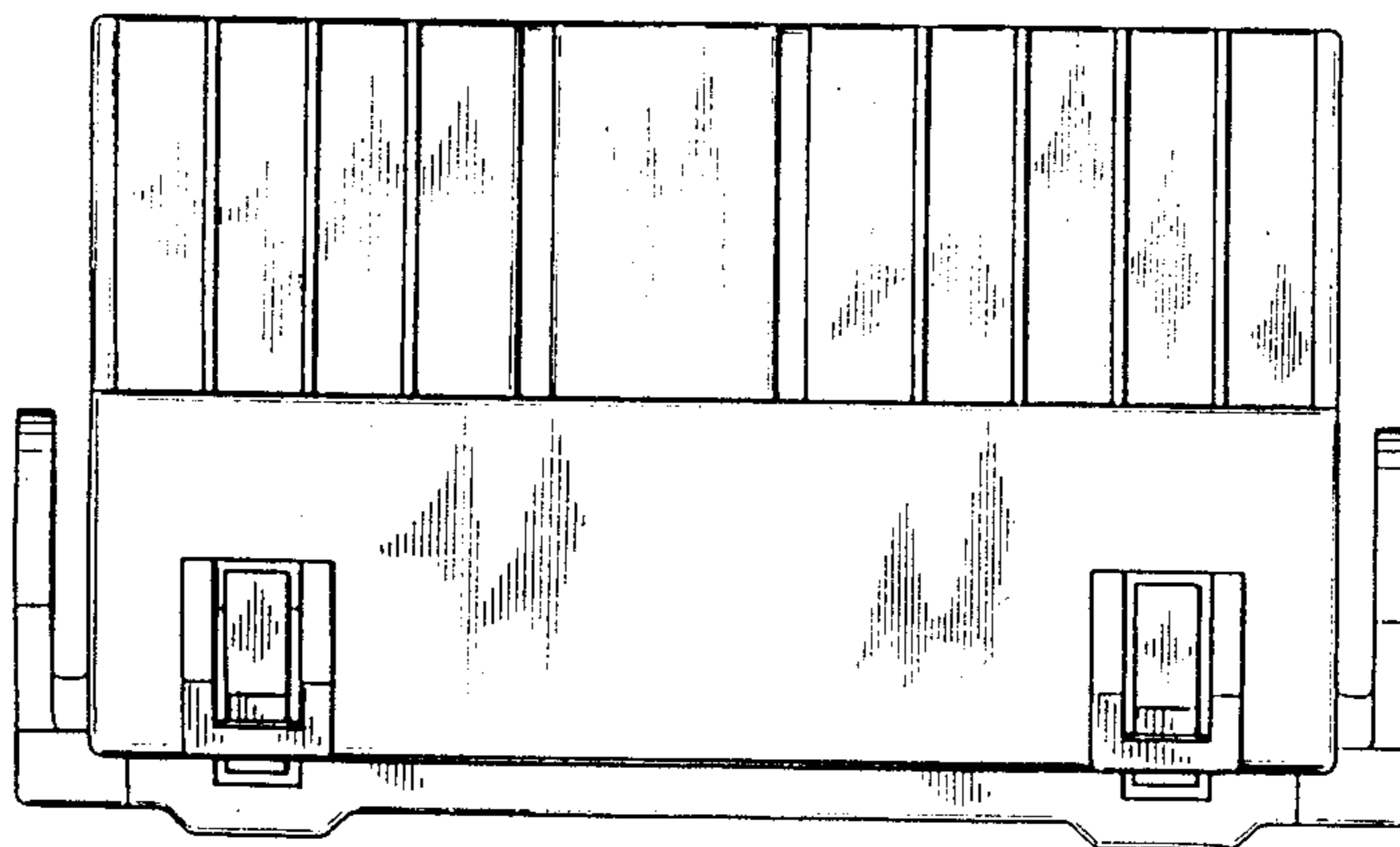

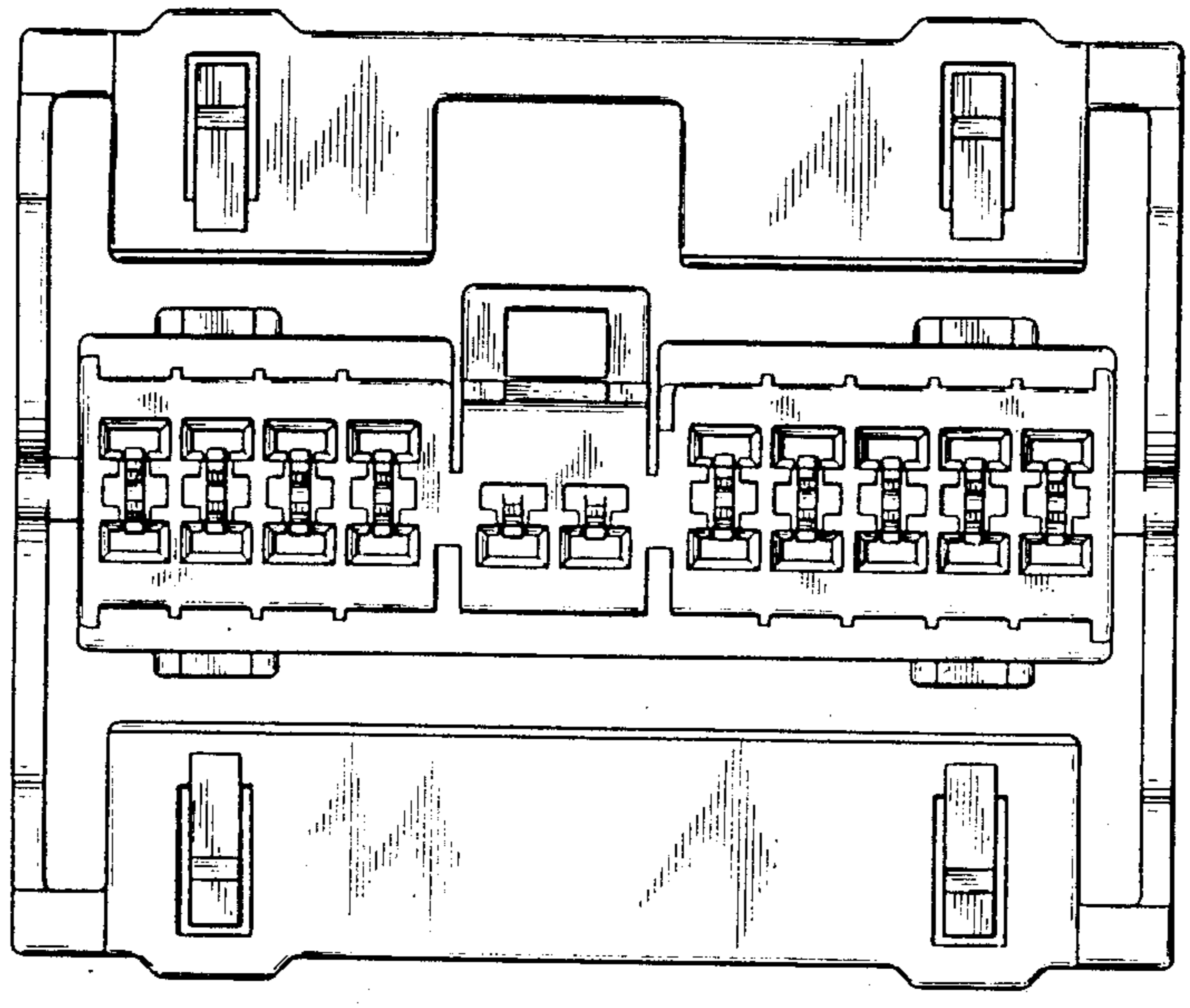

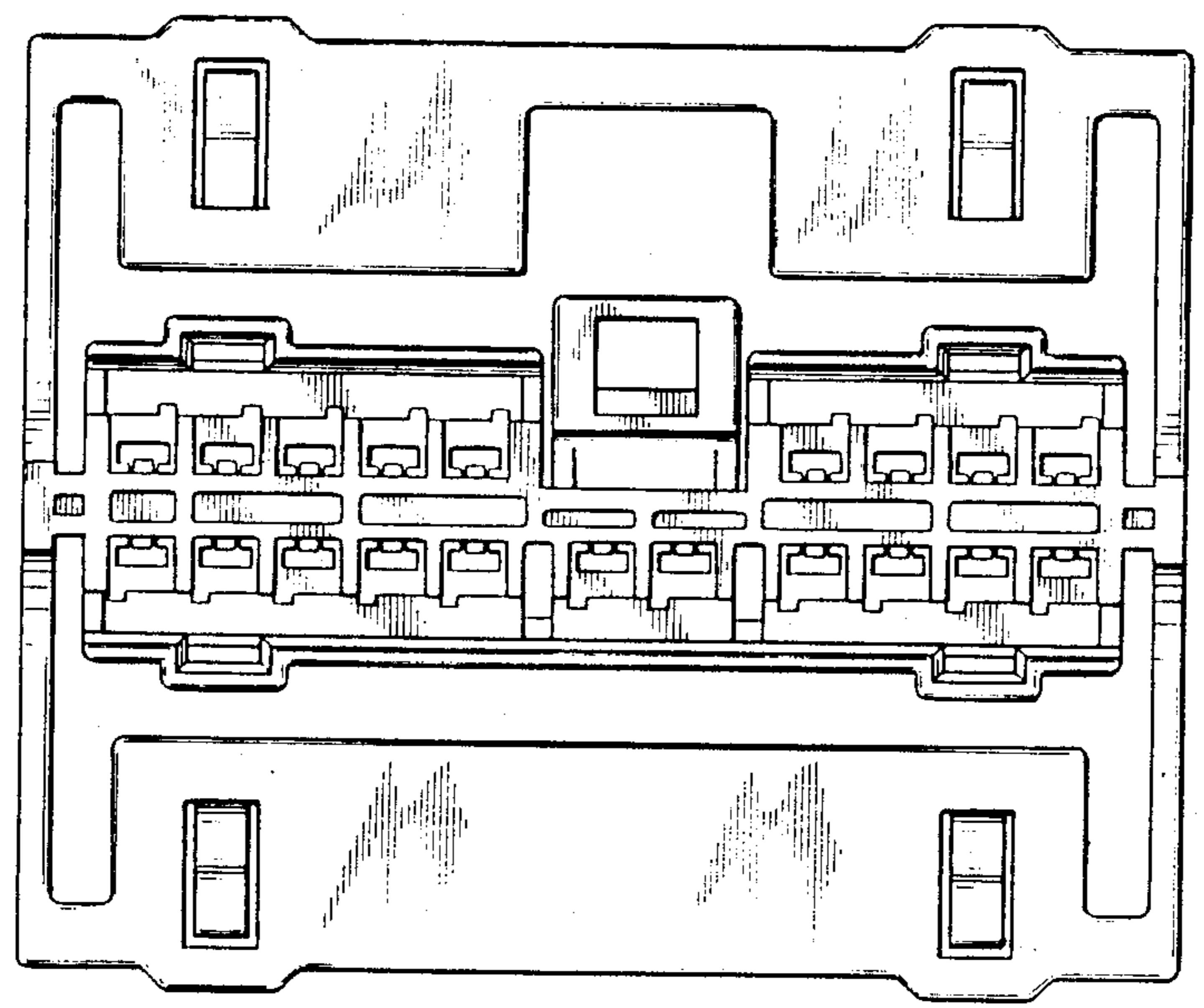

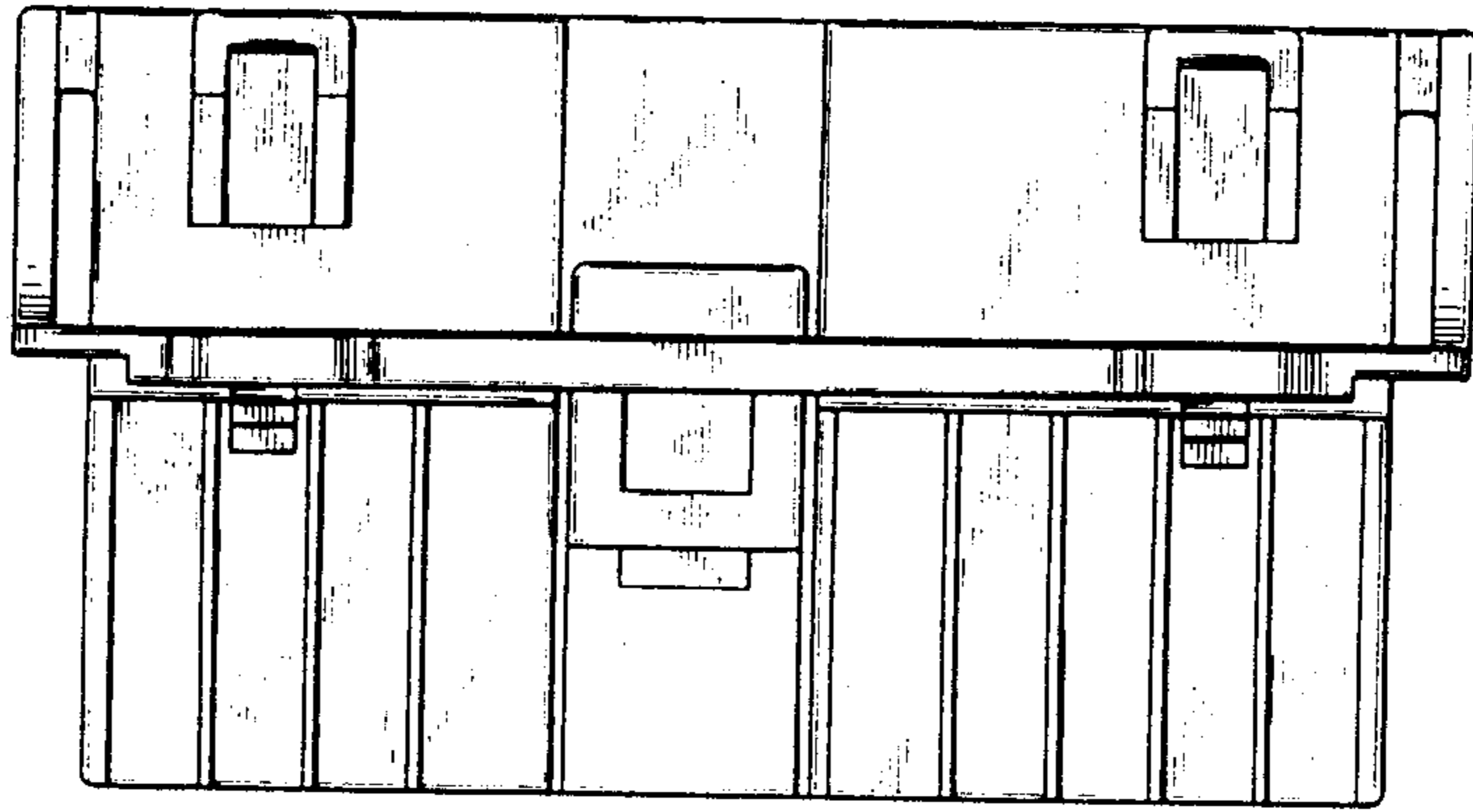
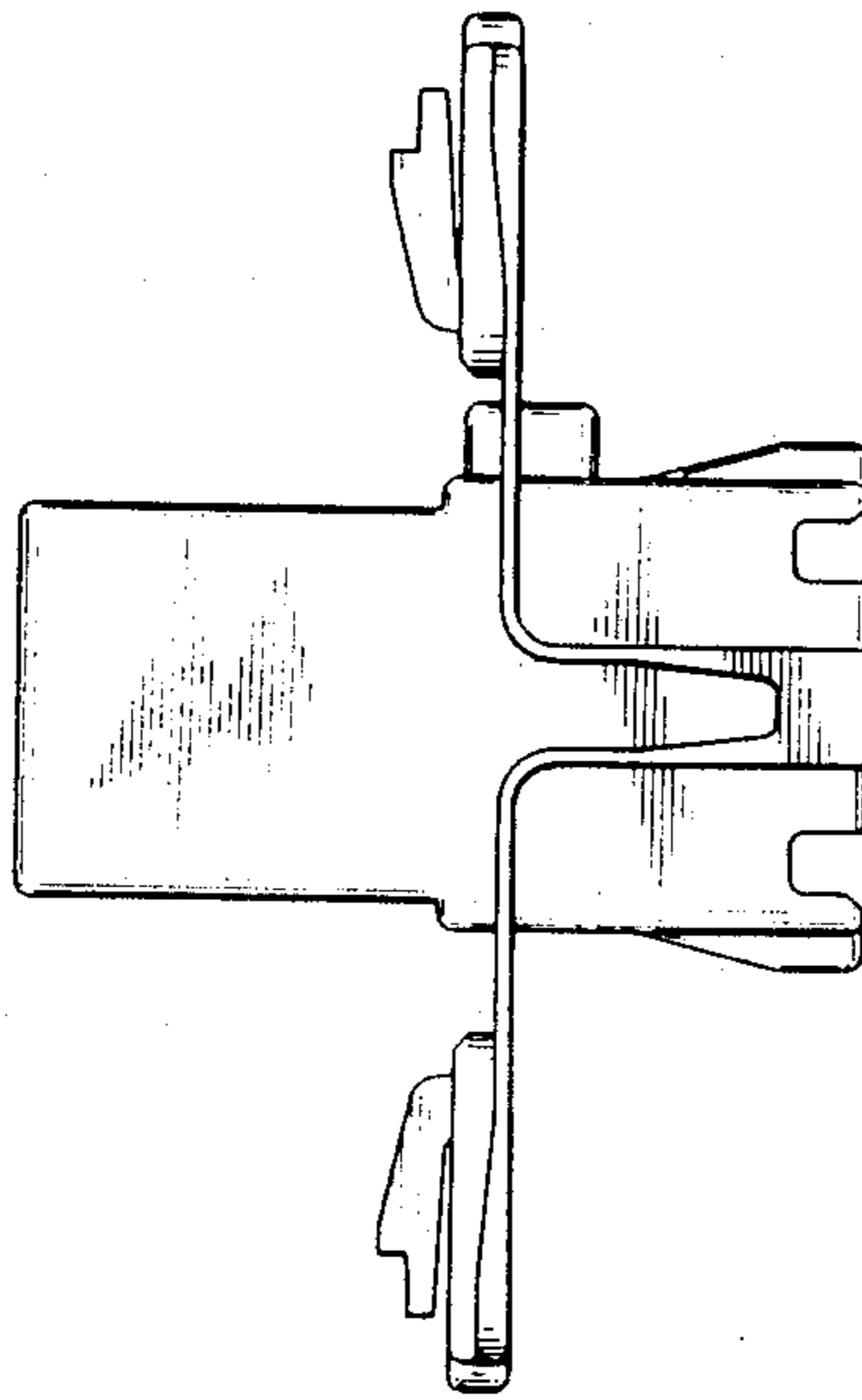

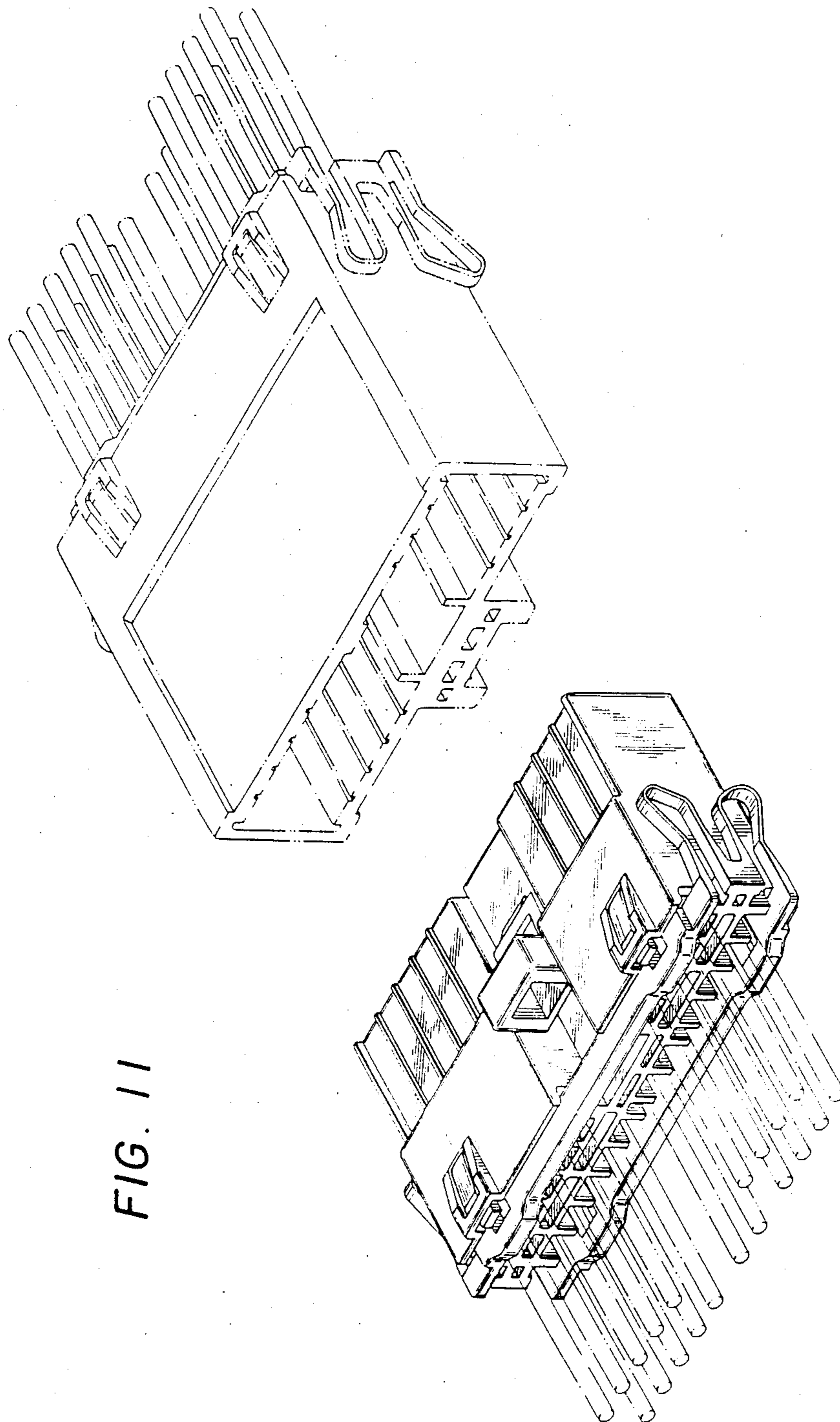
