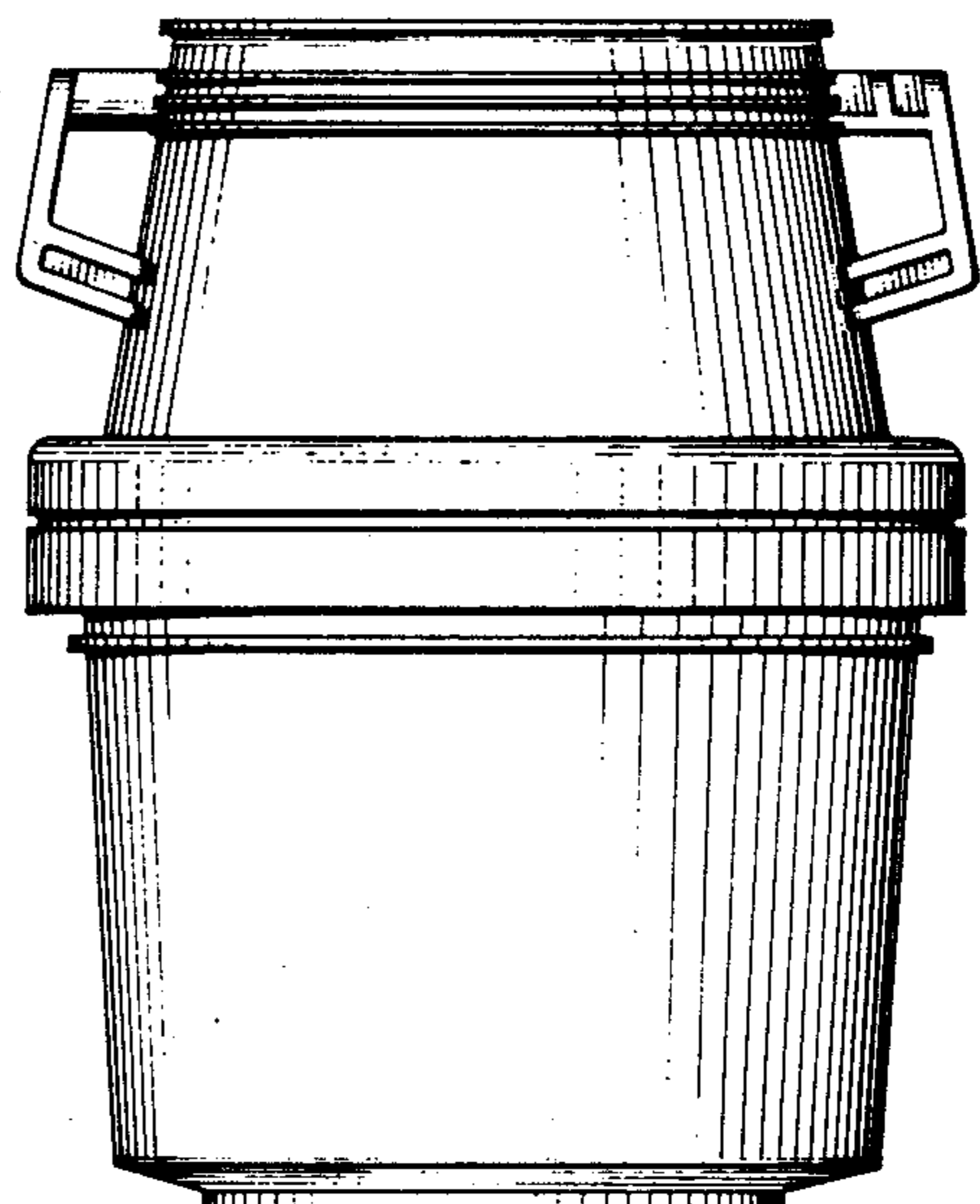
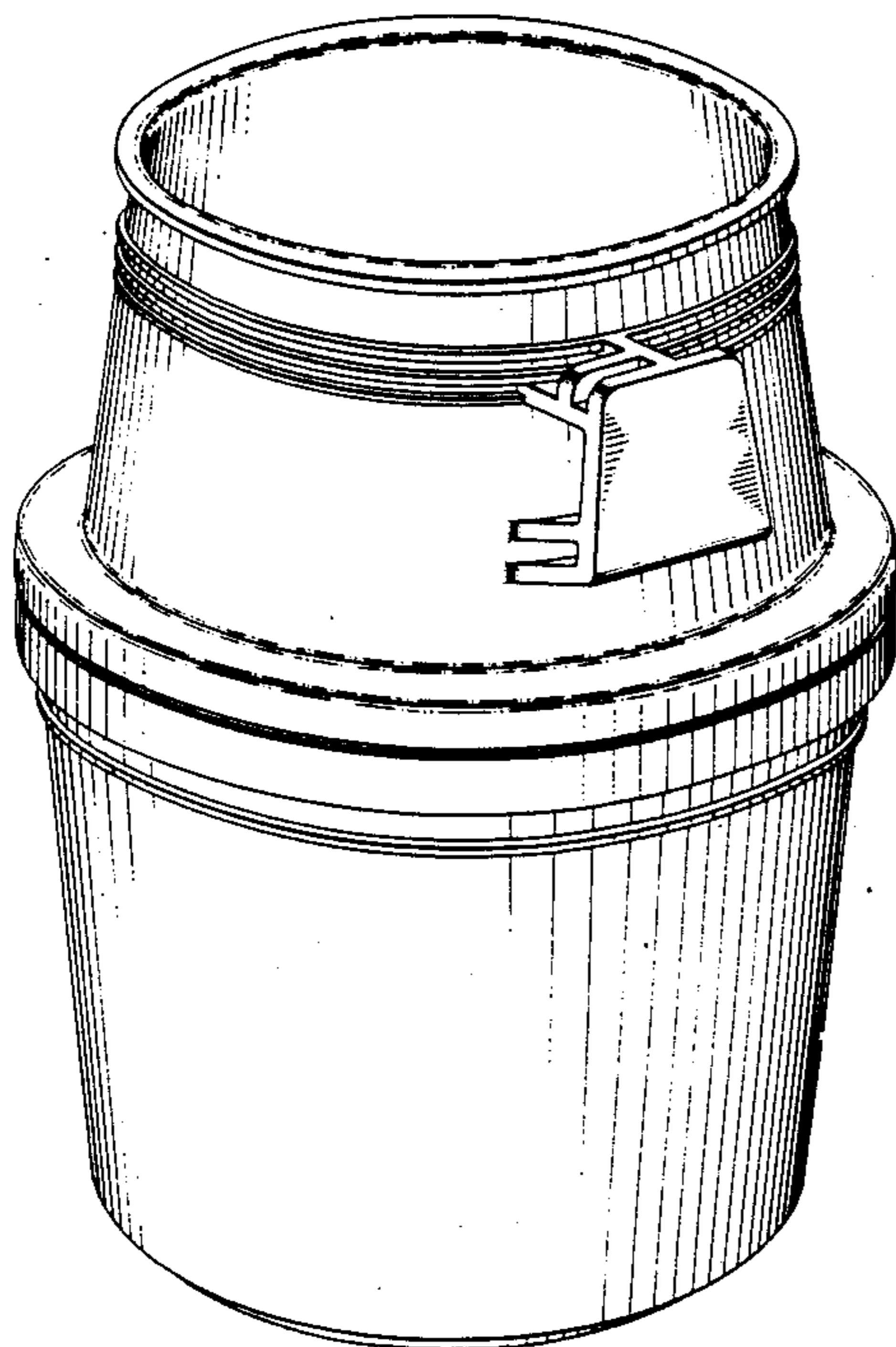

[57] **CLAIM**

The ornamental design for a combined paint container and attachment therefor, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a combined paint container and attachment therefor showing our new design; FIG. 2 is a top plan view thereof; FIG. 3 is a side elevational view, the opposite side being a mirror image thereof; FIG. 4 is a front elevational view, the rear being a mirror image thereof; and FIG. 5 is a bottom plan view thereof.



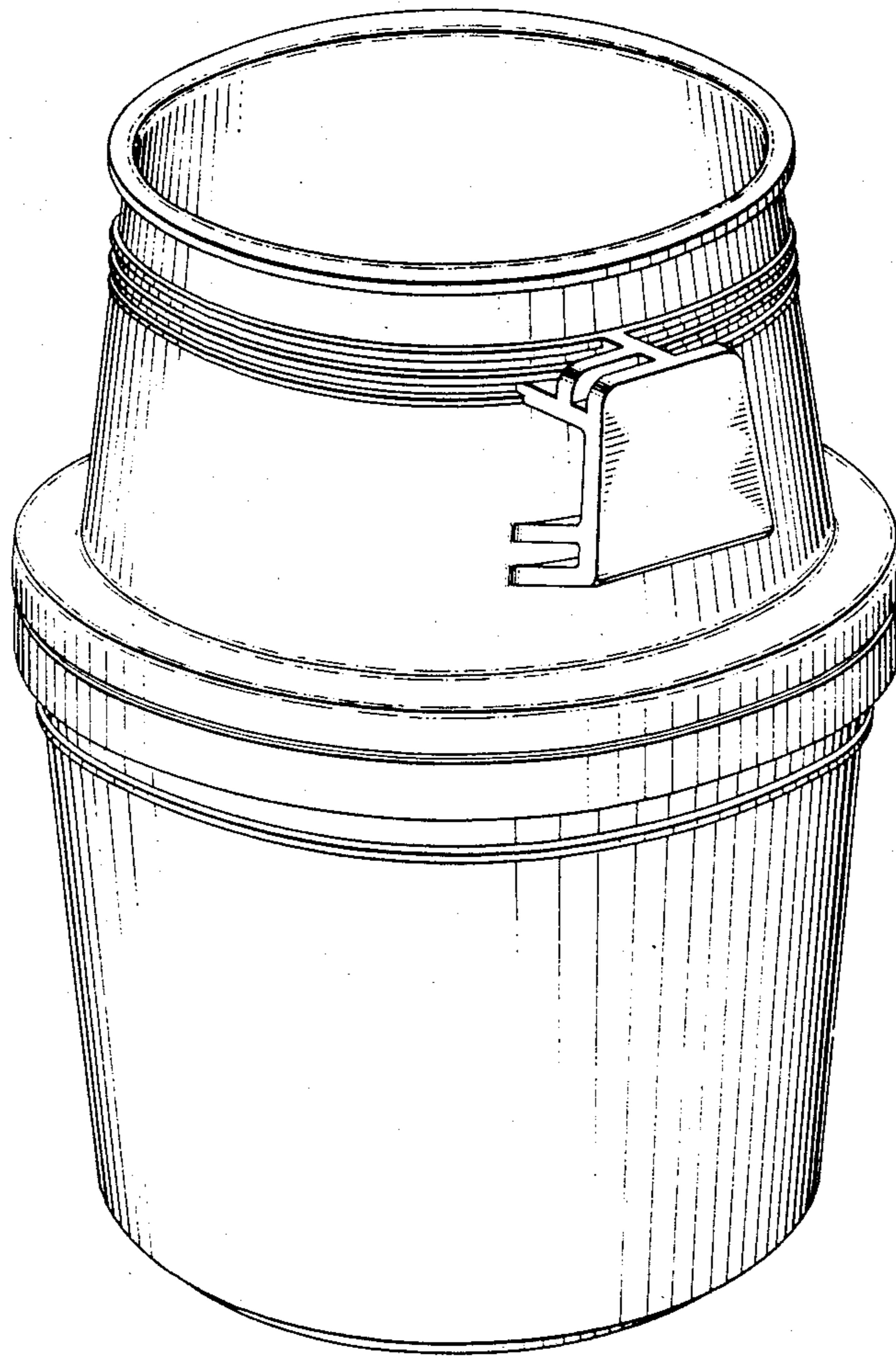

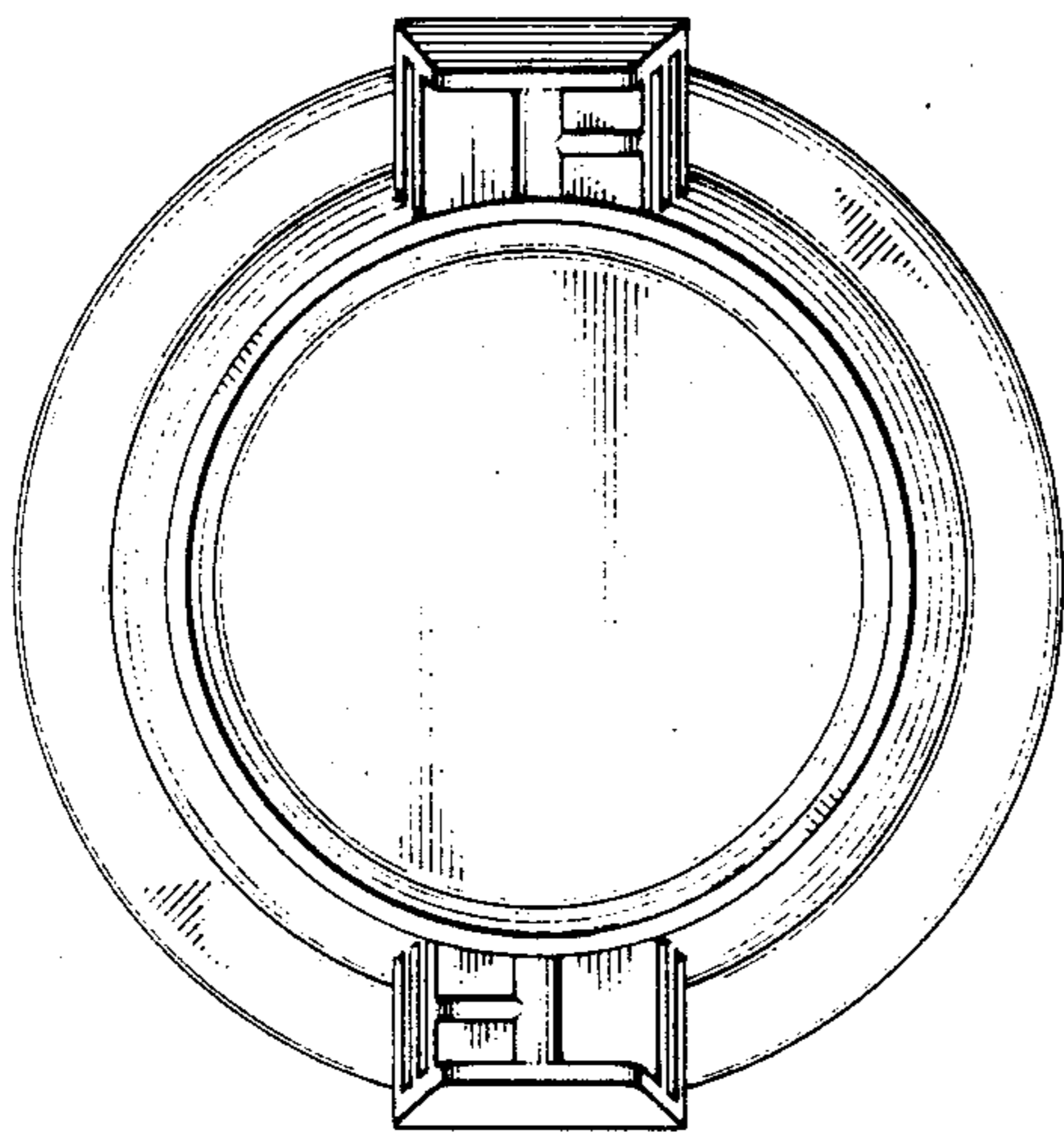

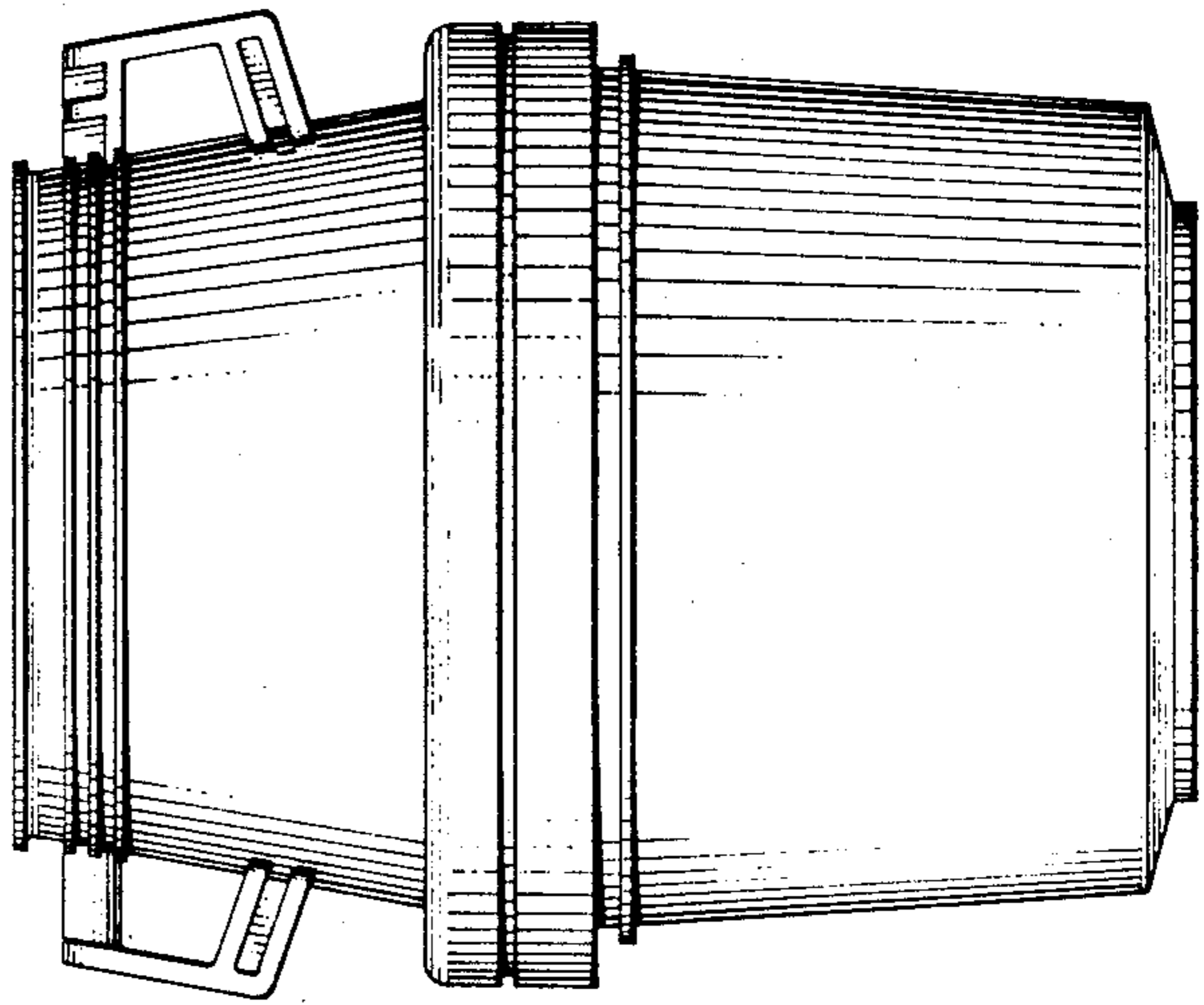

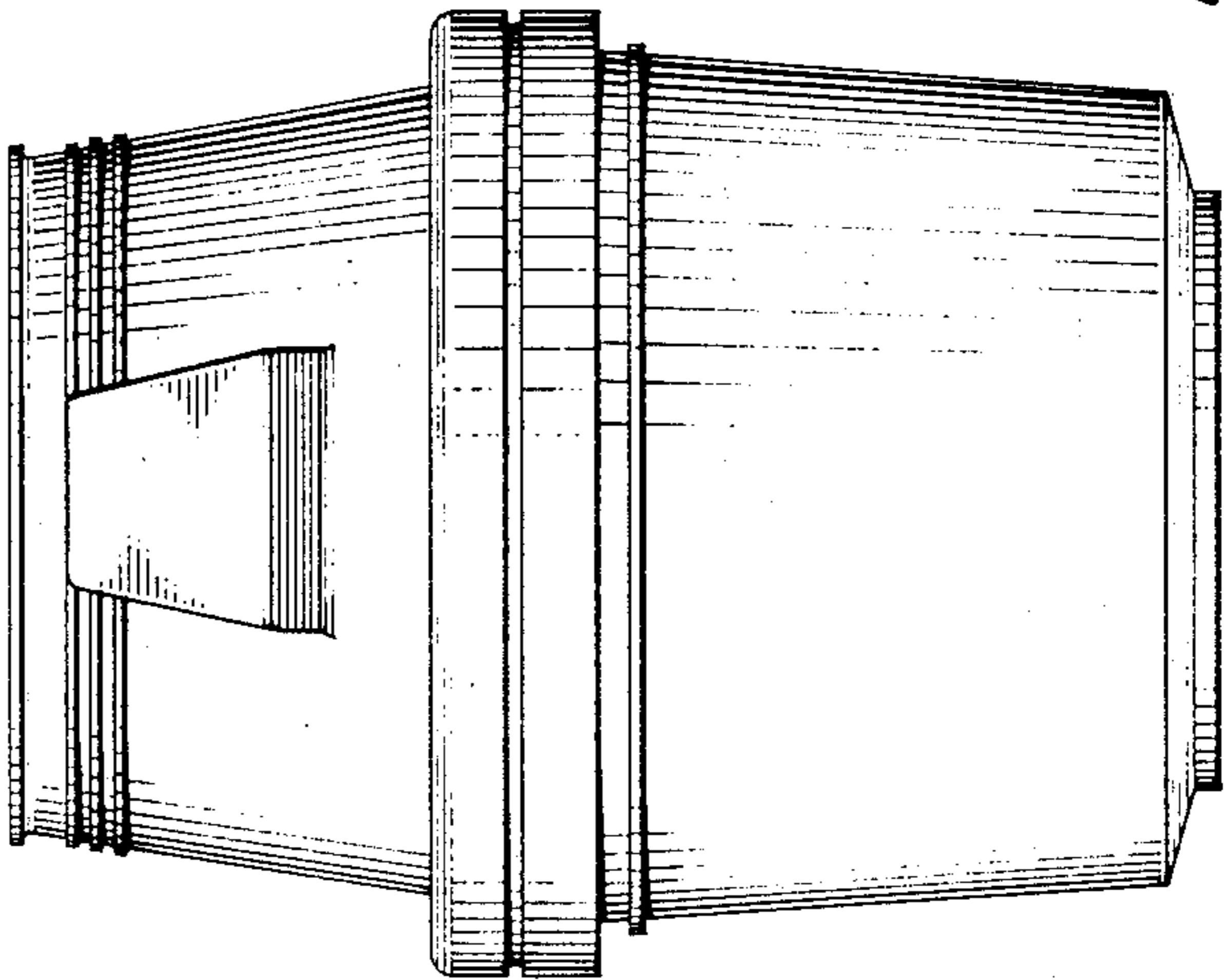

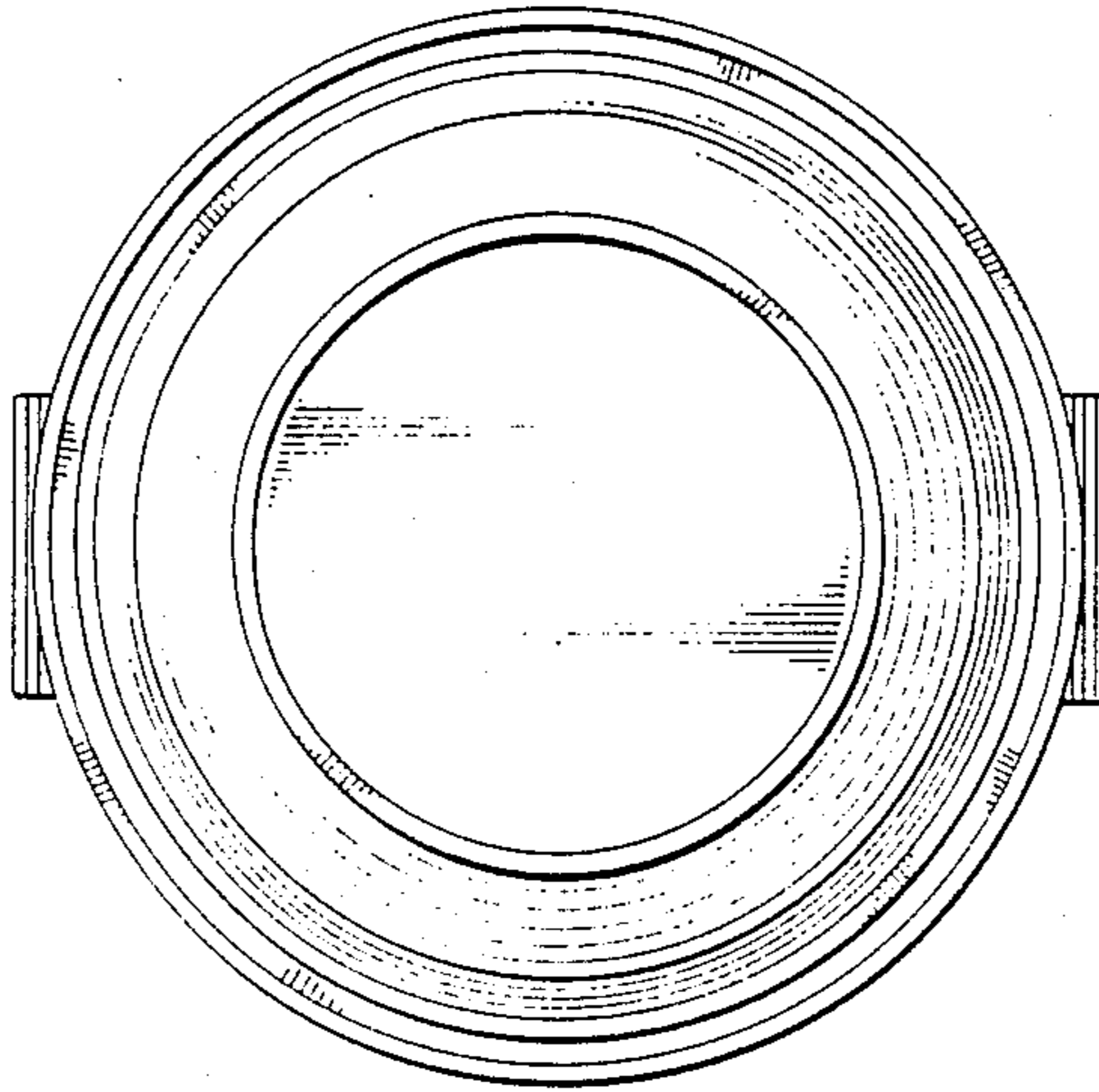
