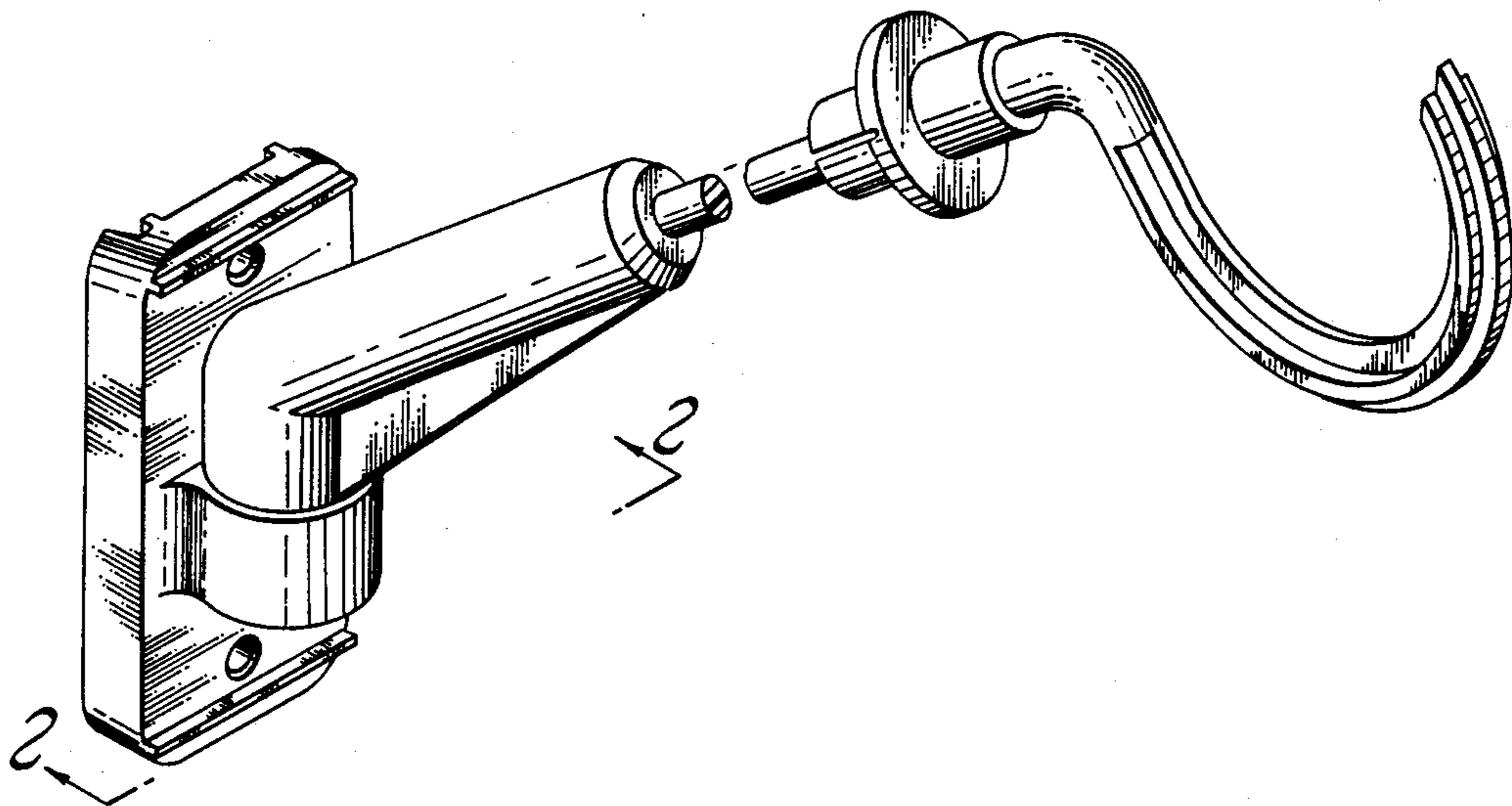

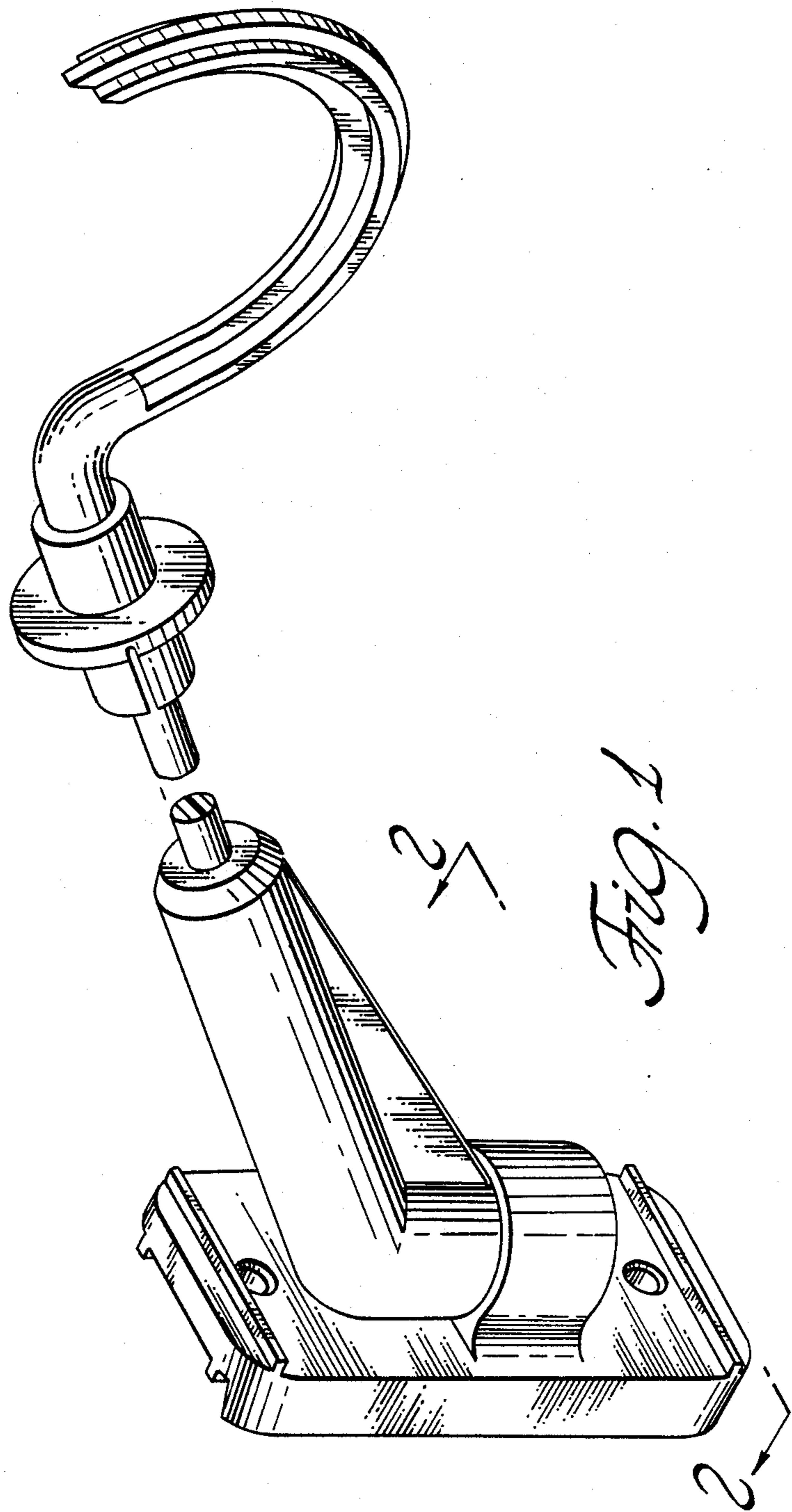

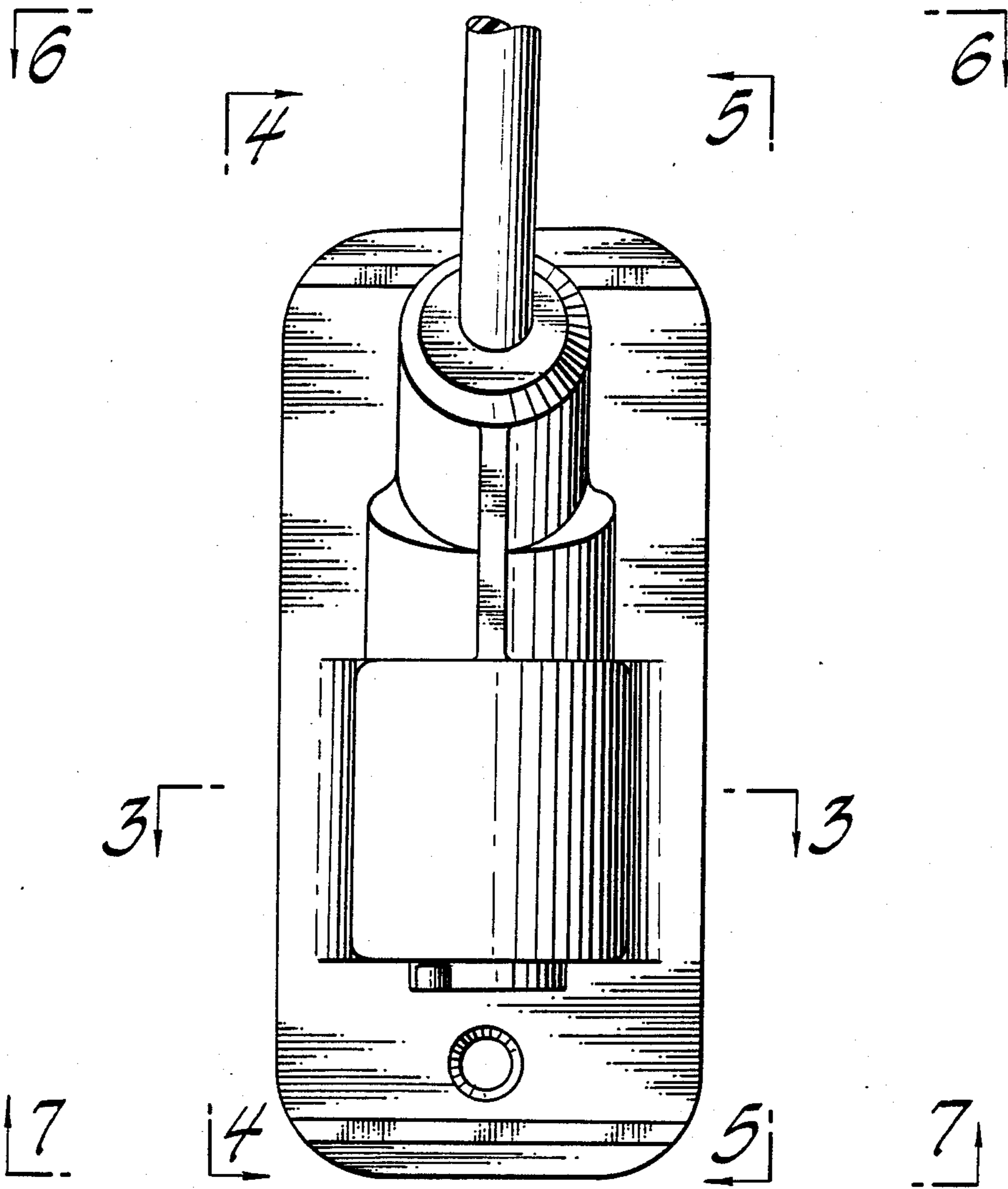
The ornamental design for a post mounted mooring line holder, as shown and described.

DESCRIPTION

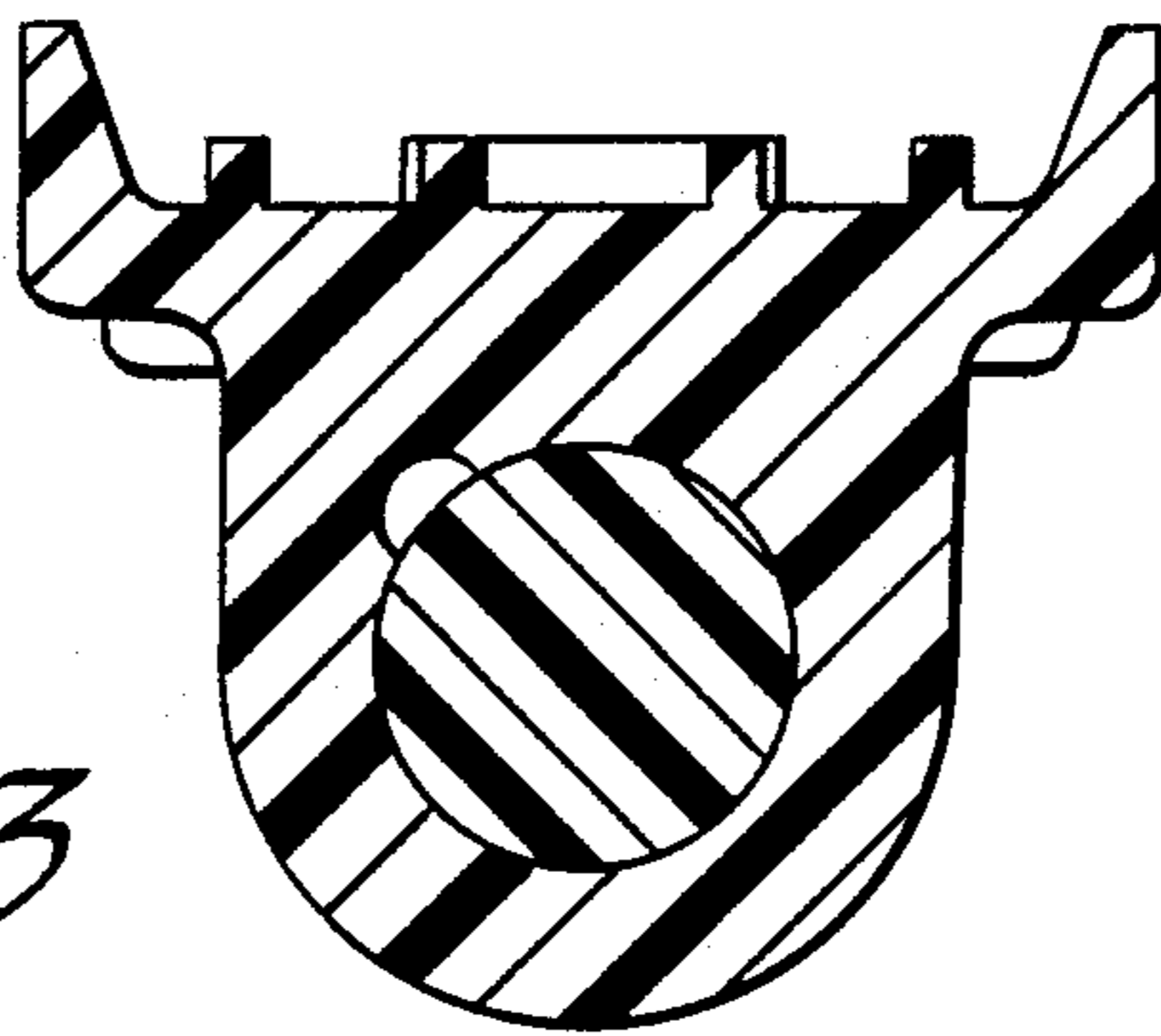
FIG. 1 is a perspective view of a post mounted mooring line holder showing my new design;  
 FIG. 2 is a front elevational view taken along lines 2—2 of FIG. 1;  
 FIG. 3 is a cross sectional view taken along lines 3—3 of FIG. 2;  
 FIG. 4 is a side elevational view as seen along lines 4—4 of FIG. 2;  
 FIG. 5 is a side elevational view as seen along lines 5—5 of FIG. 2;

 FIG. 7 is a bottom plan view as seen along lines 7—7 of FIG. 2.



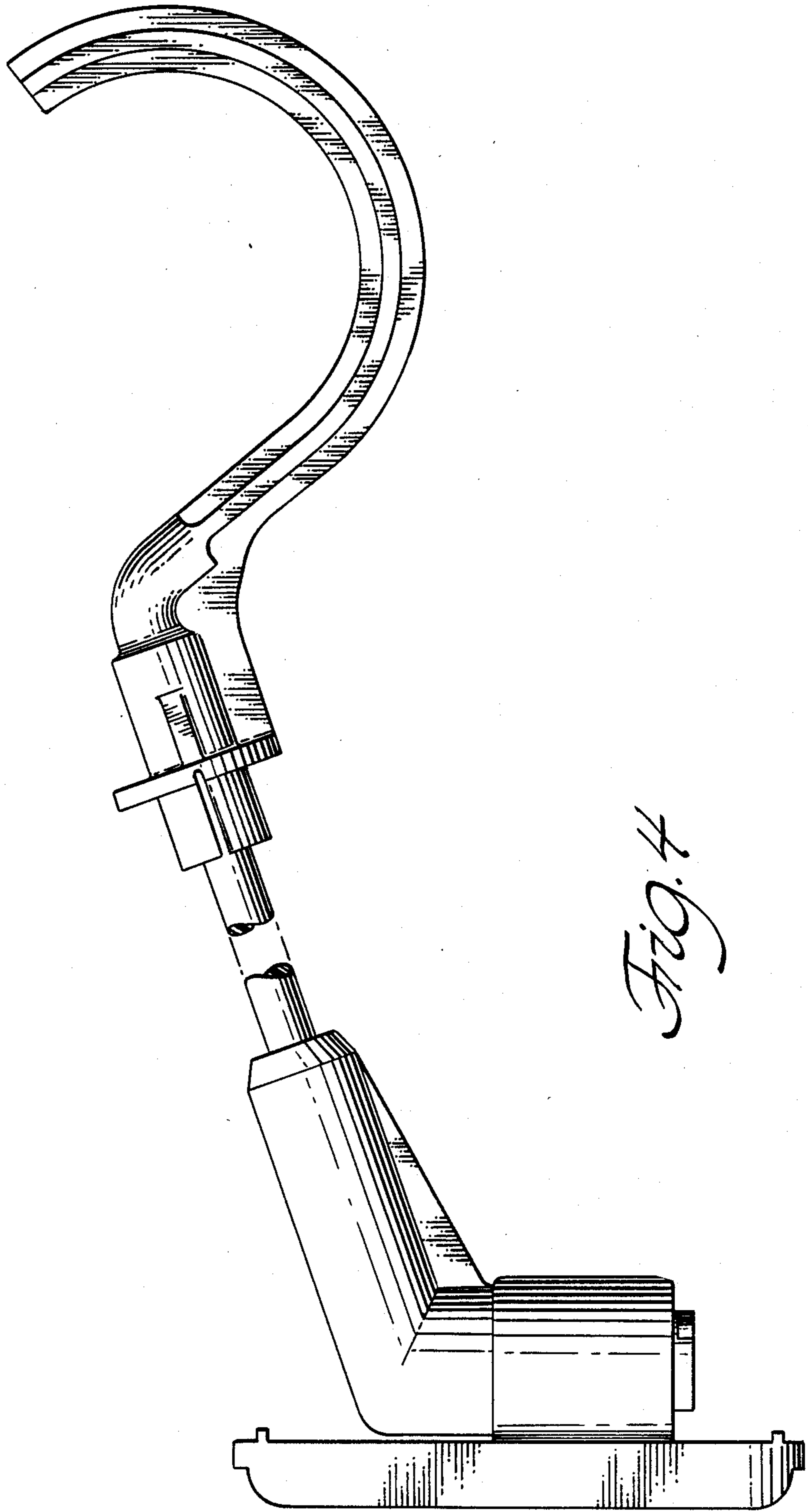




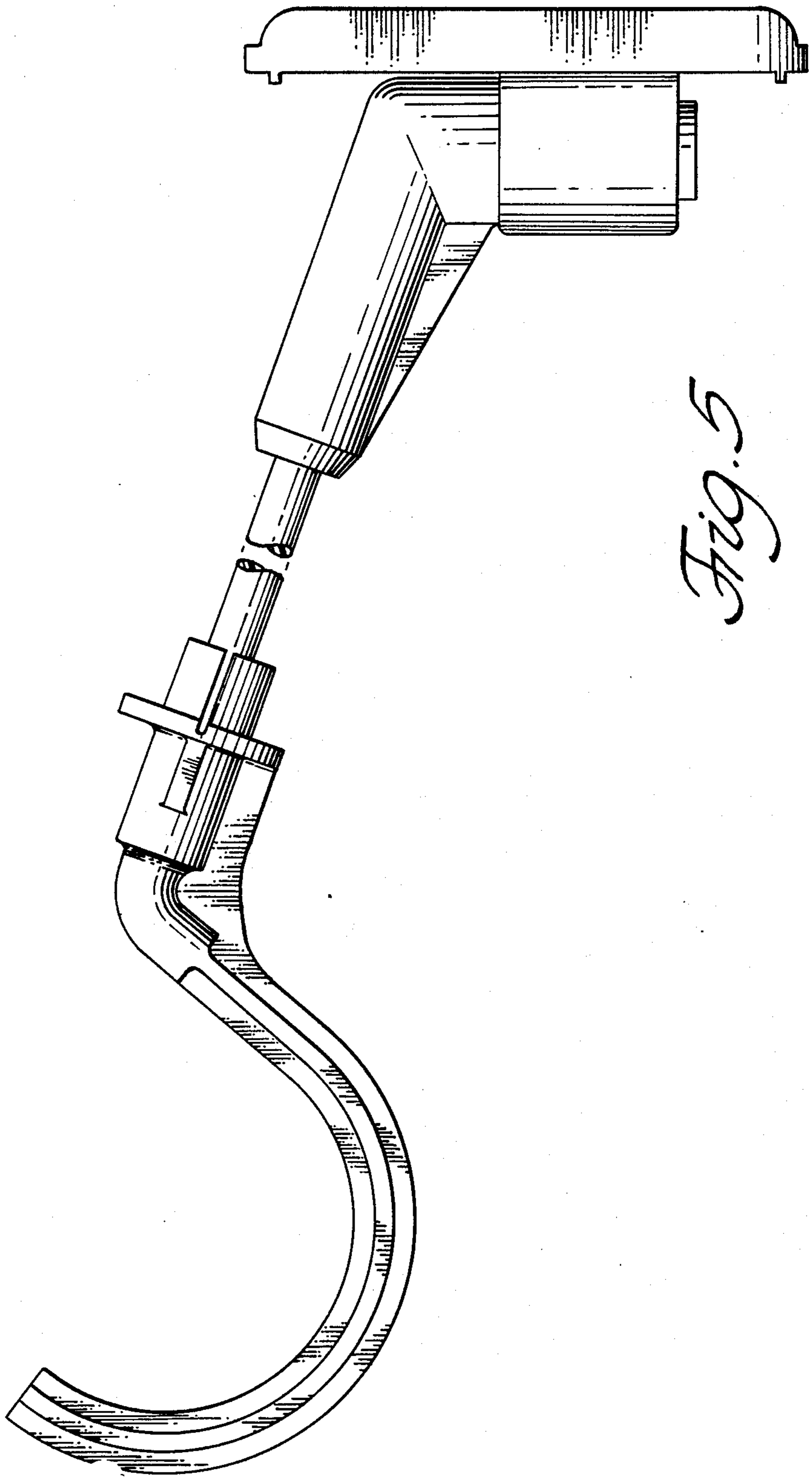

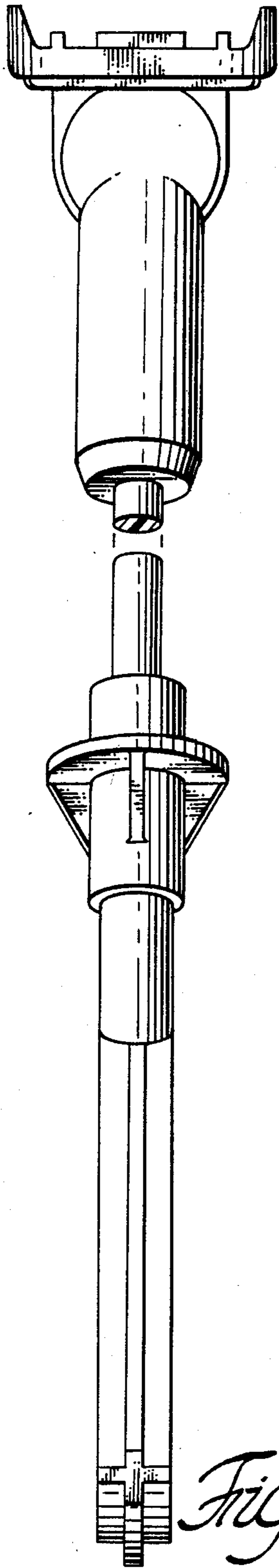

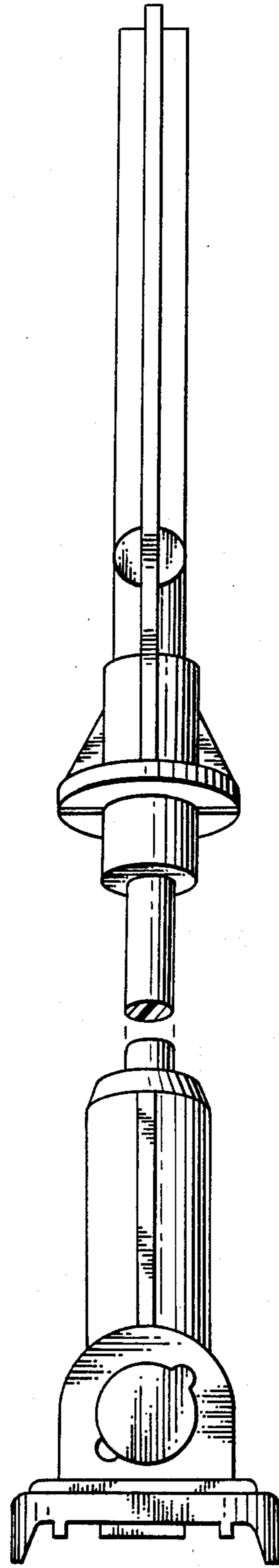
