DESCRIPTION

FIG. 1 is a front elevational view of a combined automotive electrical testing module and holder/display therefor, showing our new design;
 FIG. 2 is a right side elevational view, the broken-line showing being environmental only and forming no part of the claimed design;
 FIG. 3 is a top plan view;
 FIG. 4 is a rear elevational view;
 FIG. 5 is a left side elevational view;
 FIG. 6 is a bottom plan view;
 FIG. 7 is a front elevational view of the module portion of FIG. 1, the remainder being omitted for ease of illustration;
 FIG. 8 is a rear elevational view of FIG. 7;
 FIG. 9 is a left side elevational view of FIG. 7;
 FIG. 10 is a right side elevational view of FIG. 7;
 FIG. 11 is a top plan view of FIG. 7;
 FIG. 12 is a bottom plan view of FIG. 7;
 FIG. 13 is a front elevational view of FIG. 1, with the module portion omitted for ease of illustration;
 FIG. 14 is a right side elevational view of FIG. 13, the broken-line showing being environmental only and forming no part of the claimed design;

 FIG. 18 is a bottom plan view of FIG. 13 thereof.

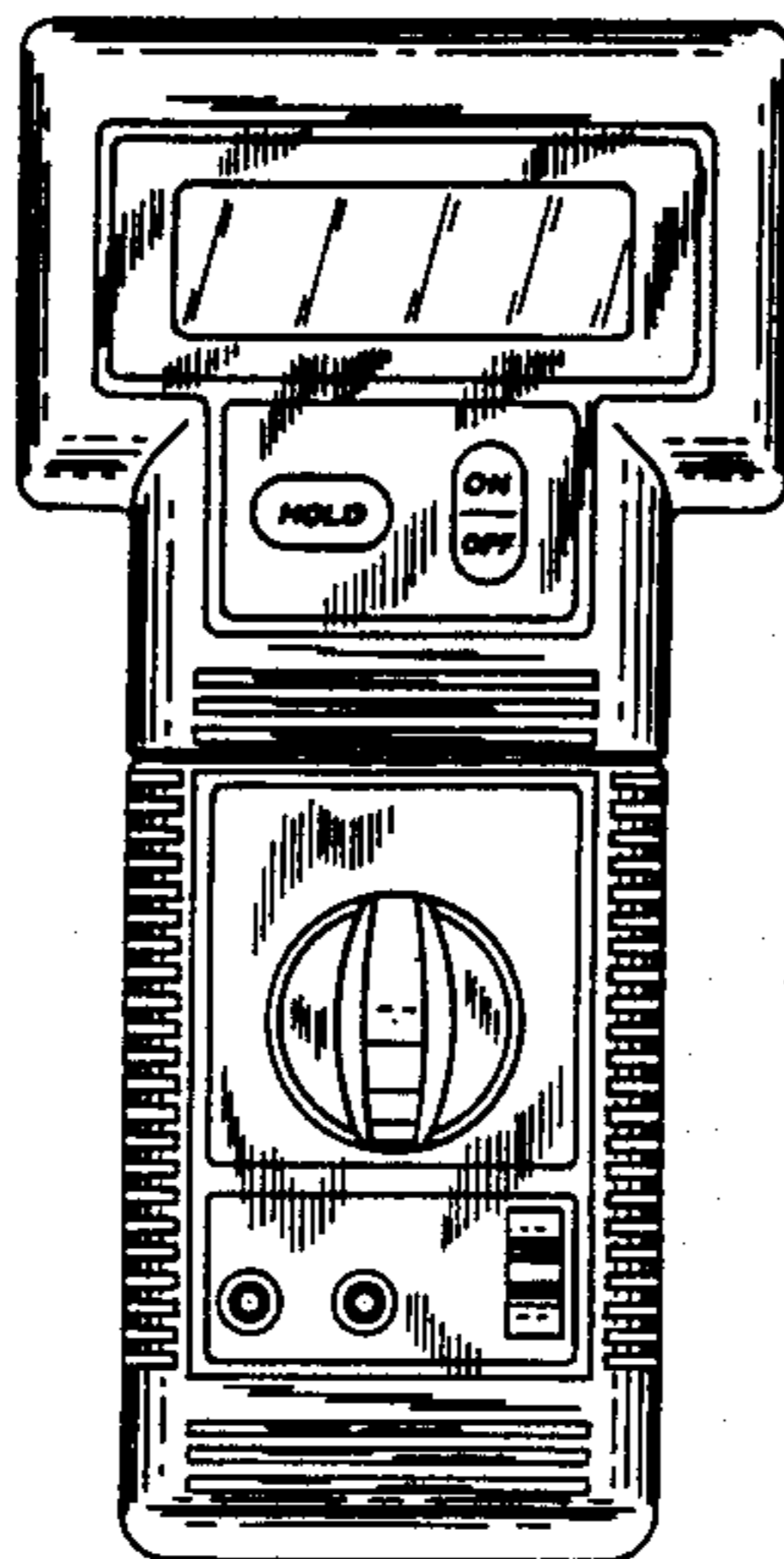

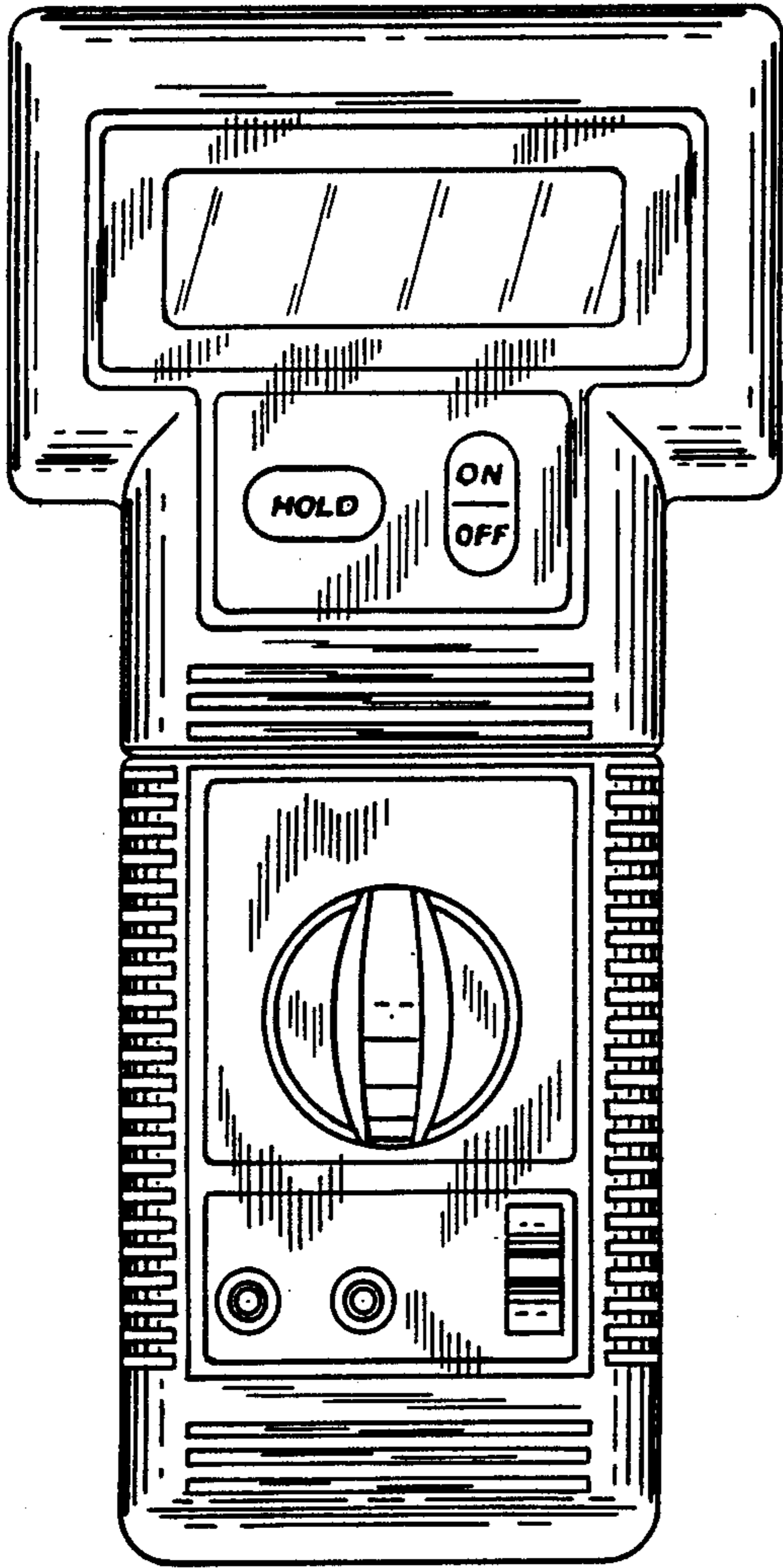

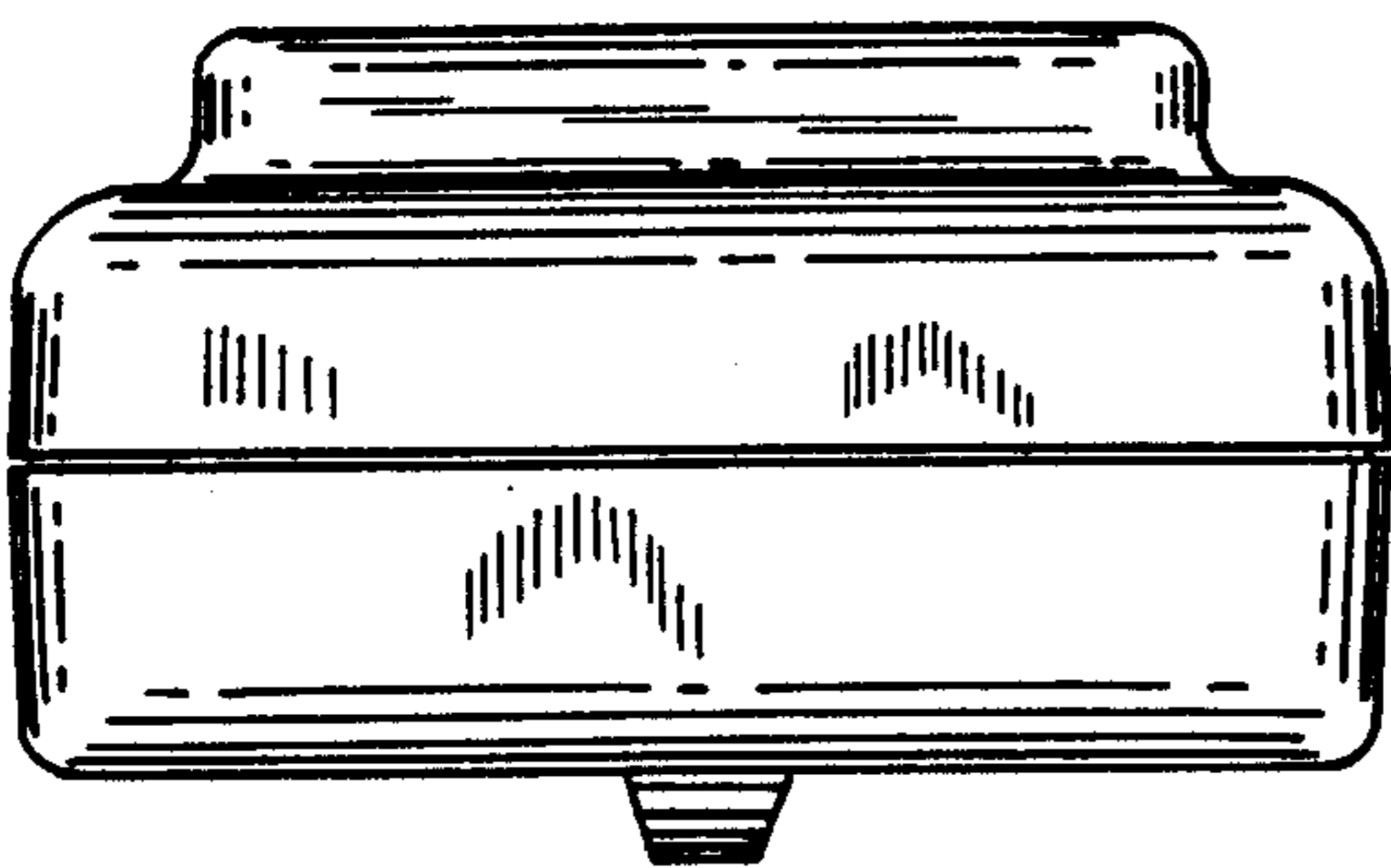
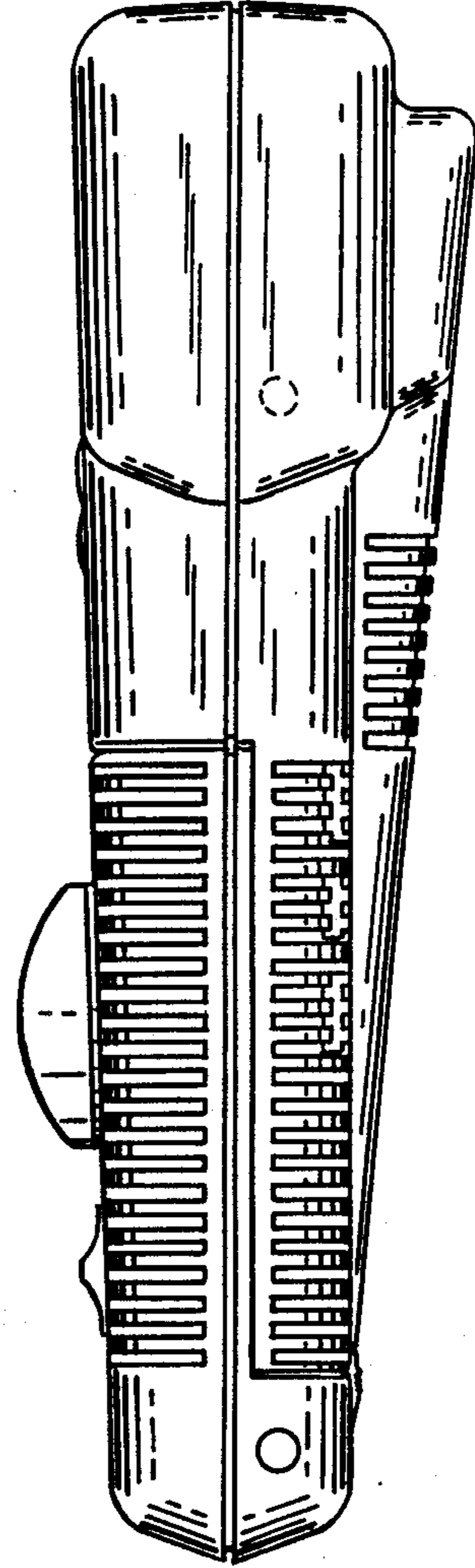

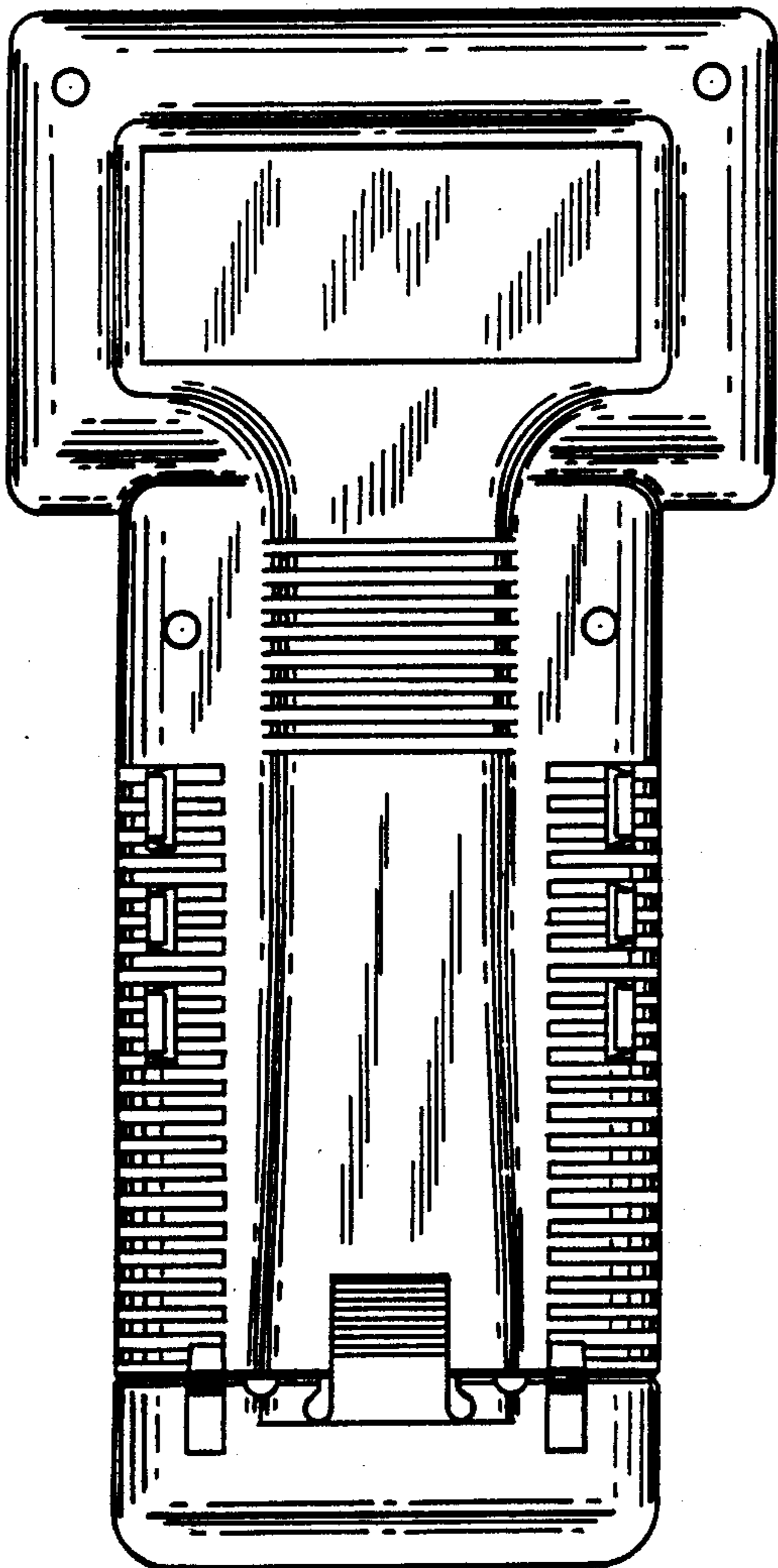

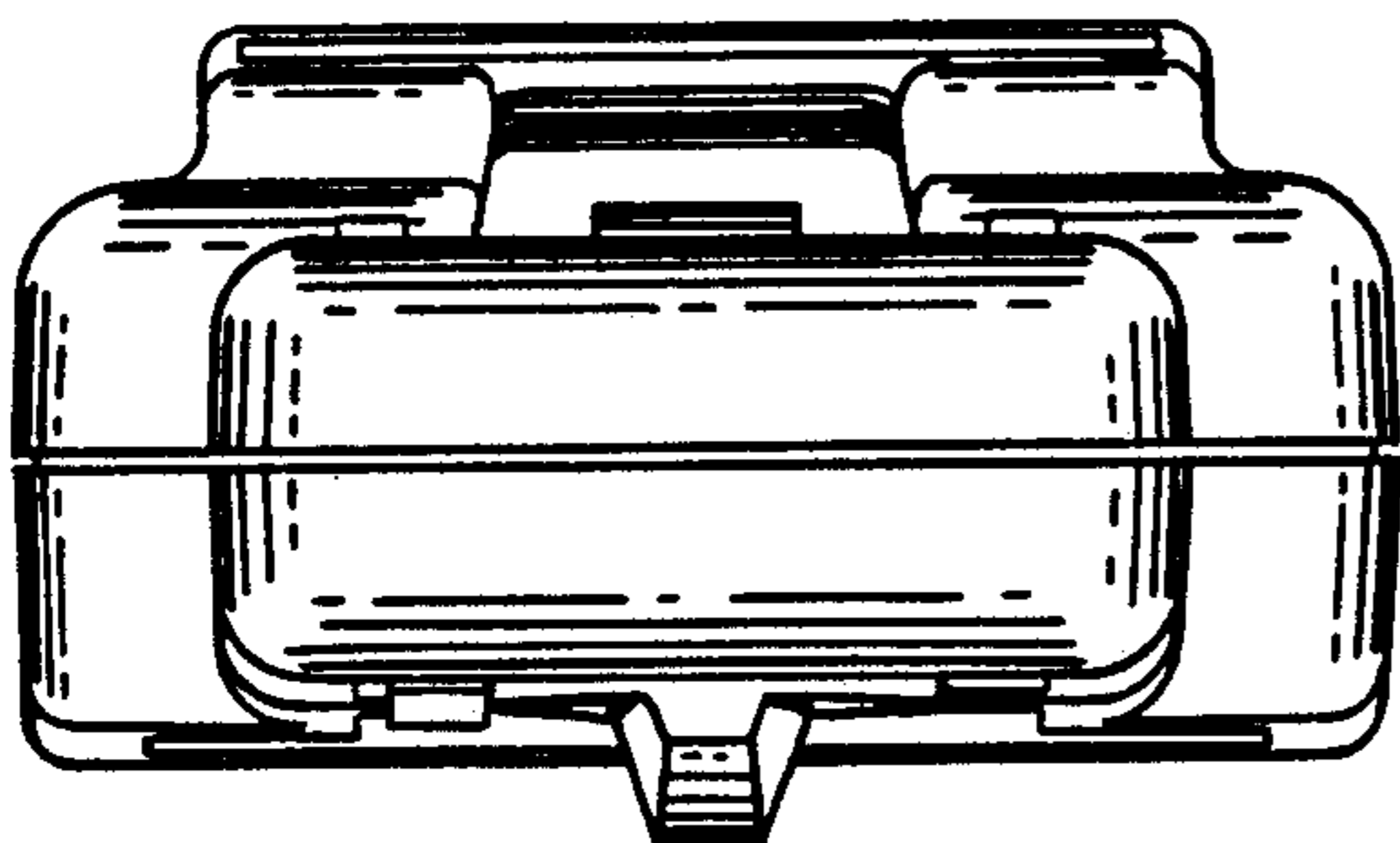
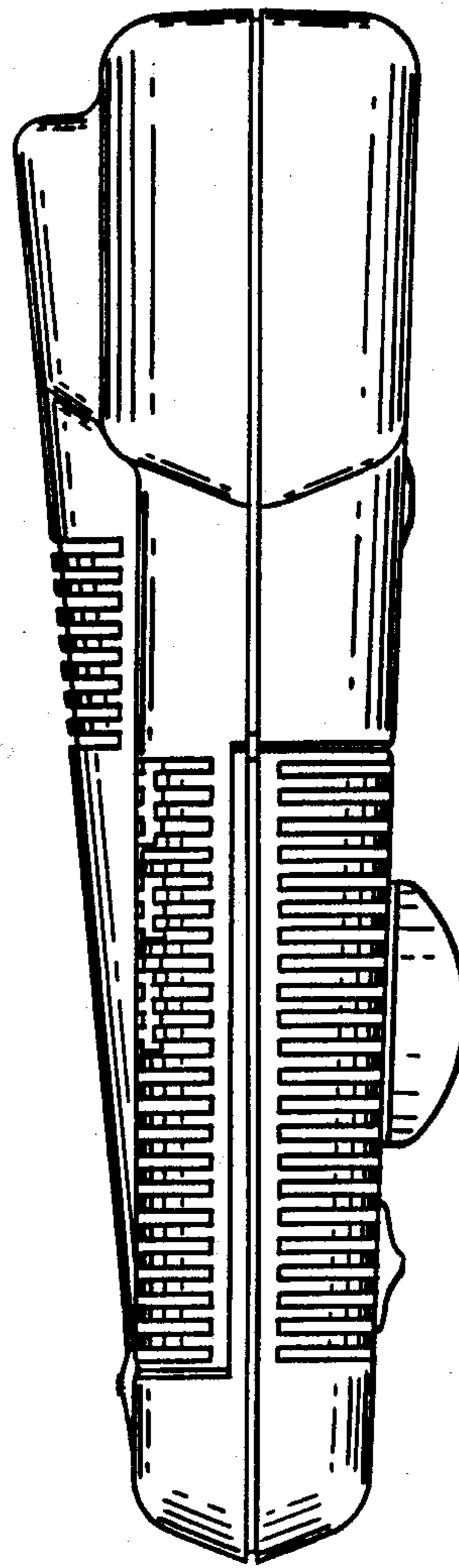

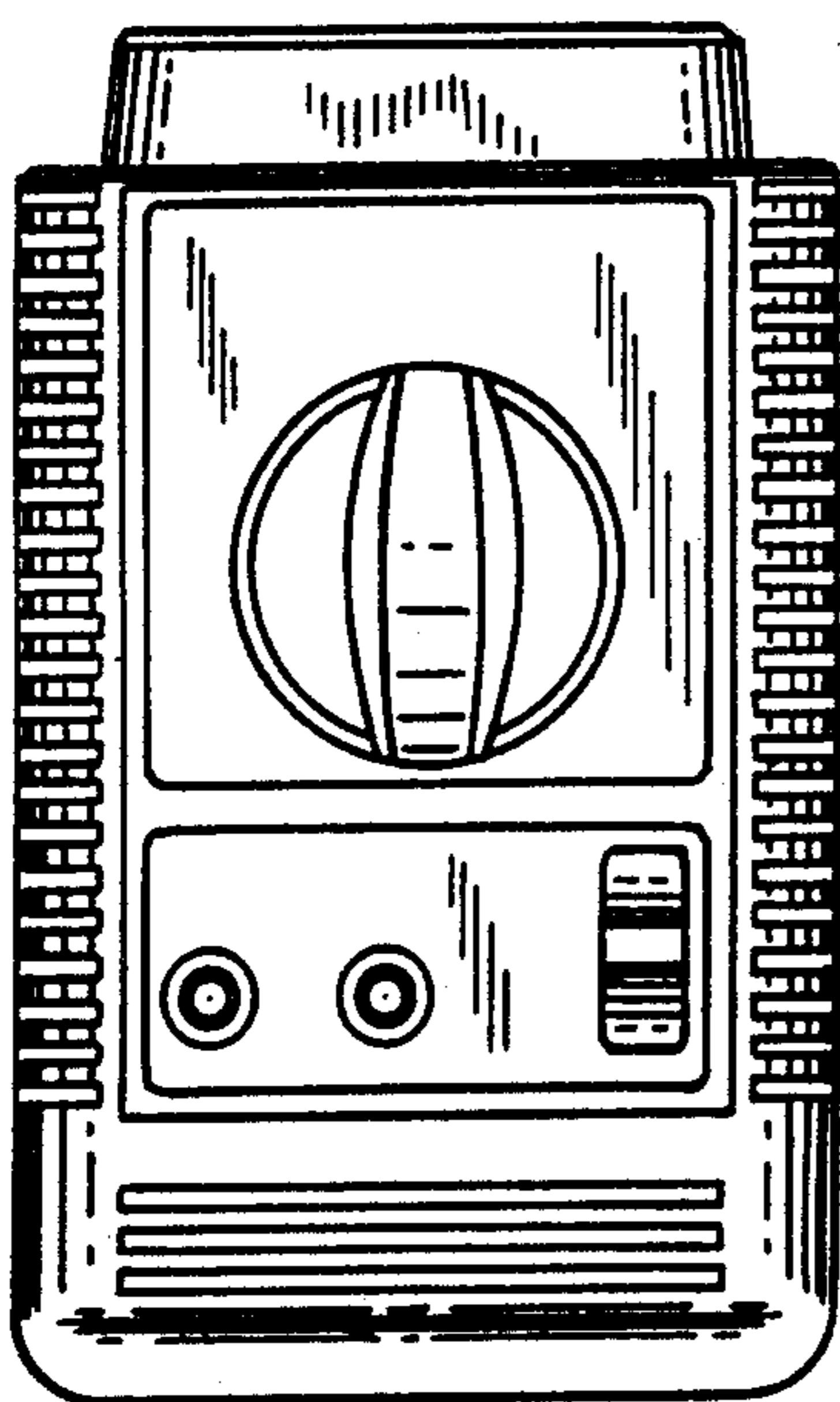

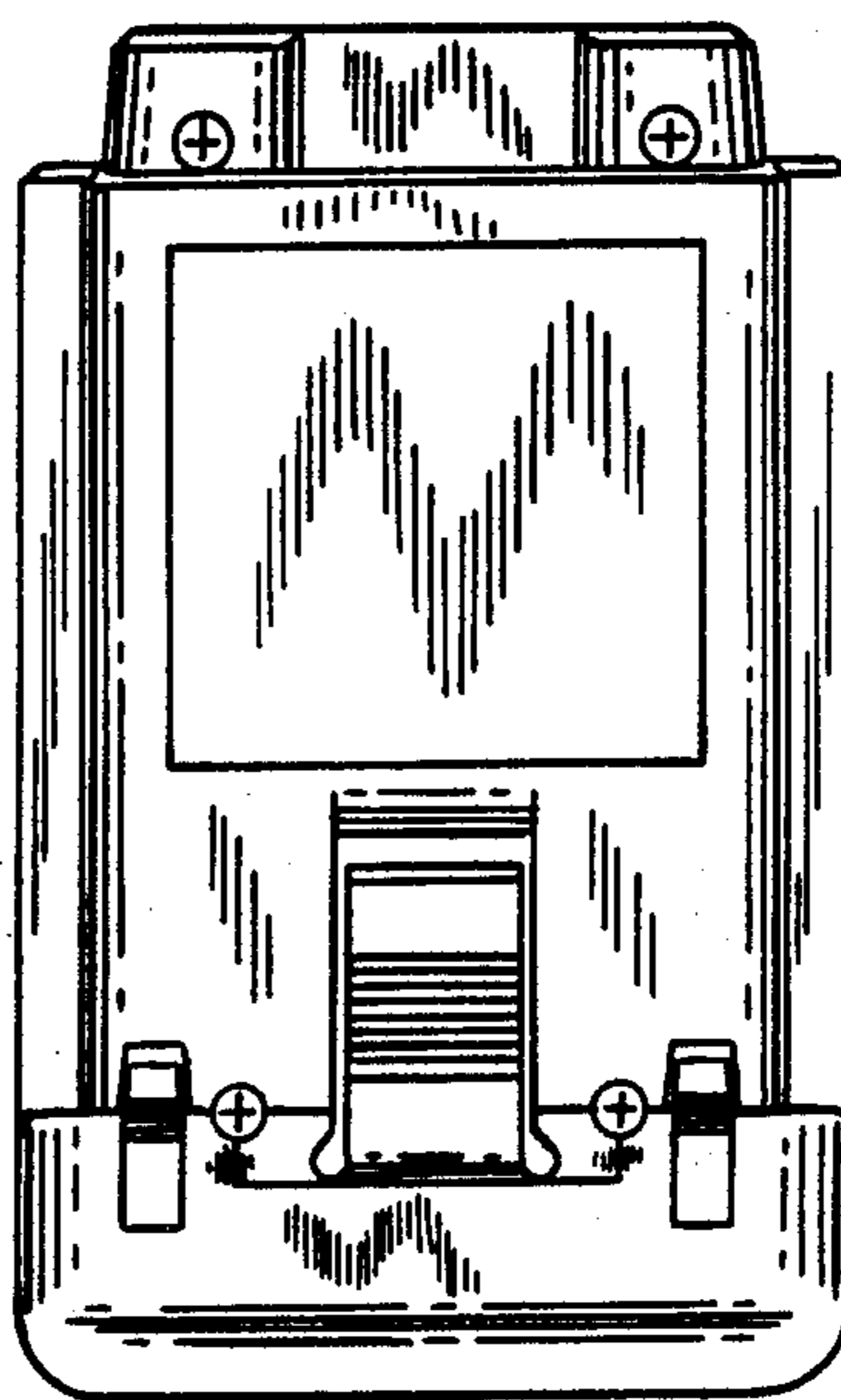

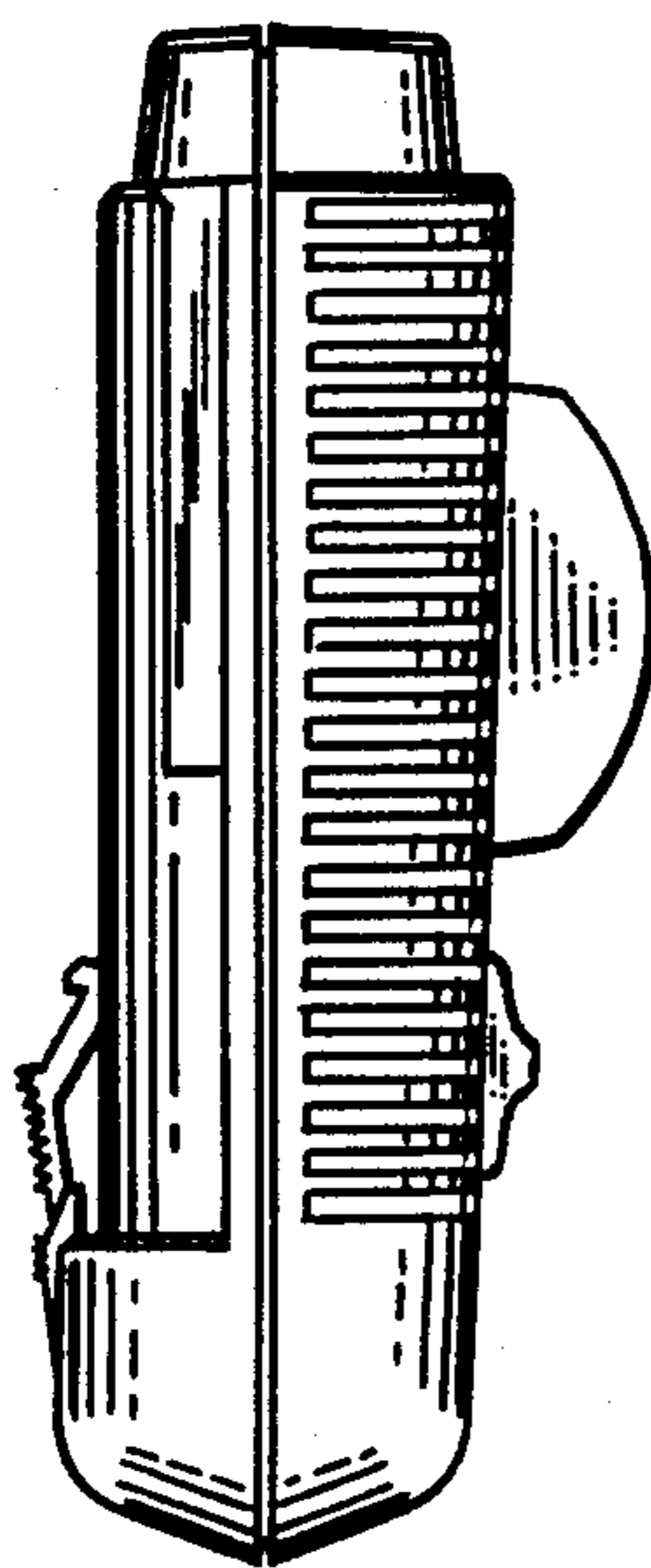

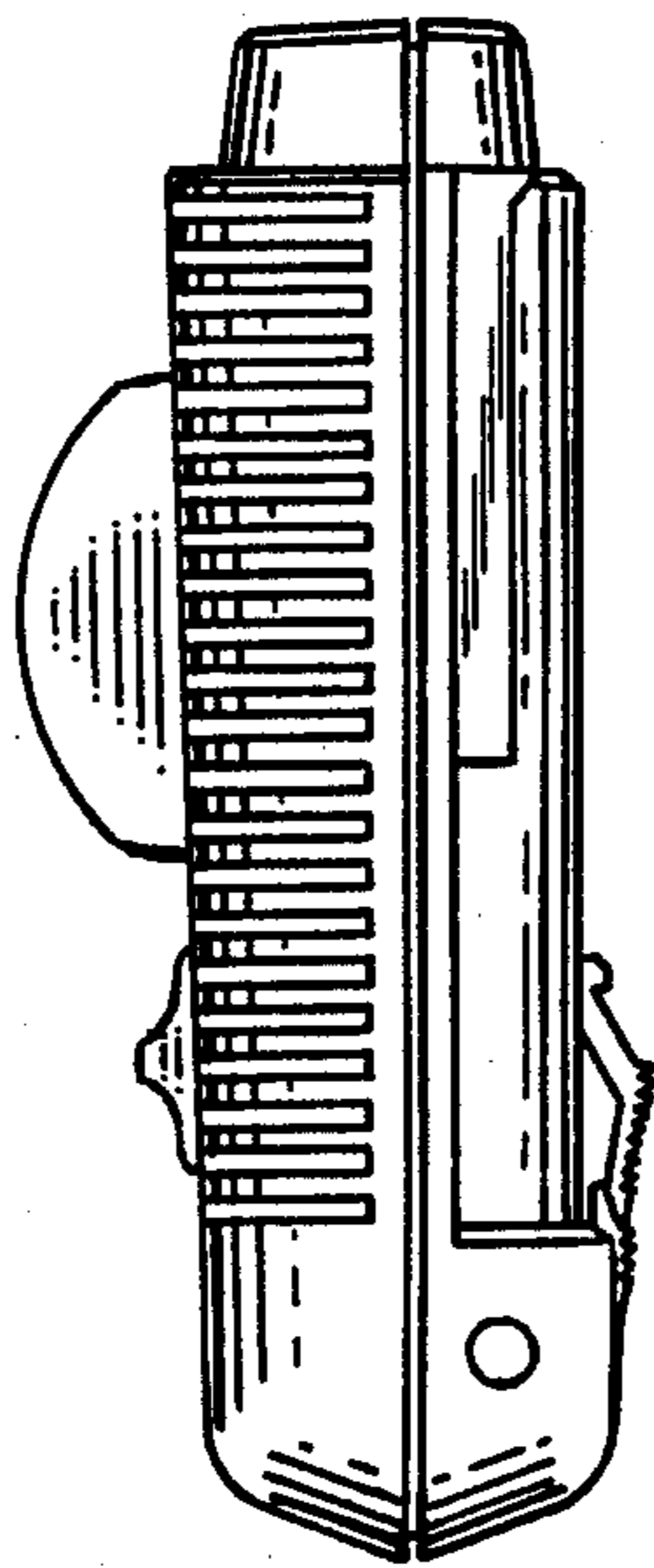

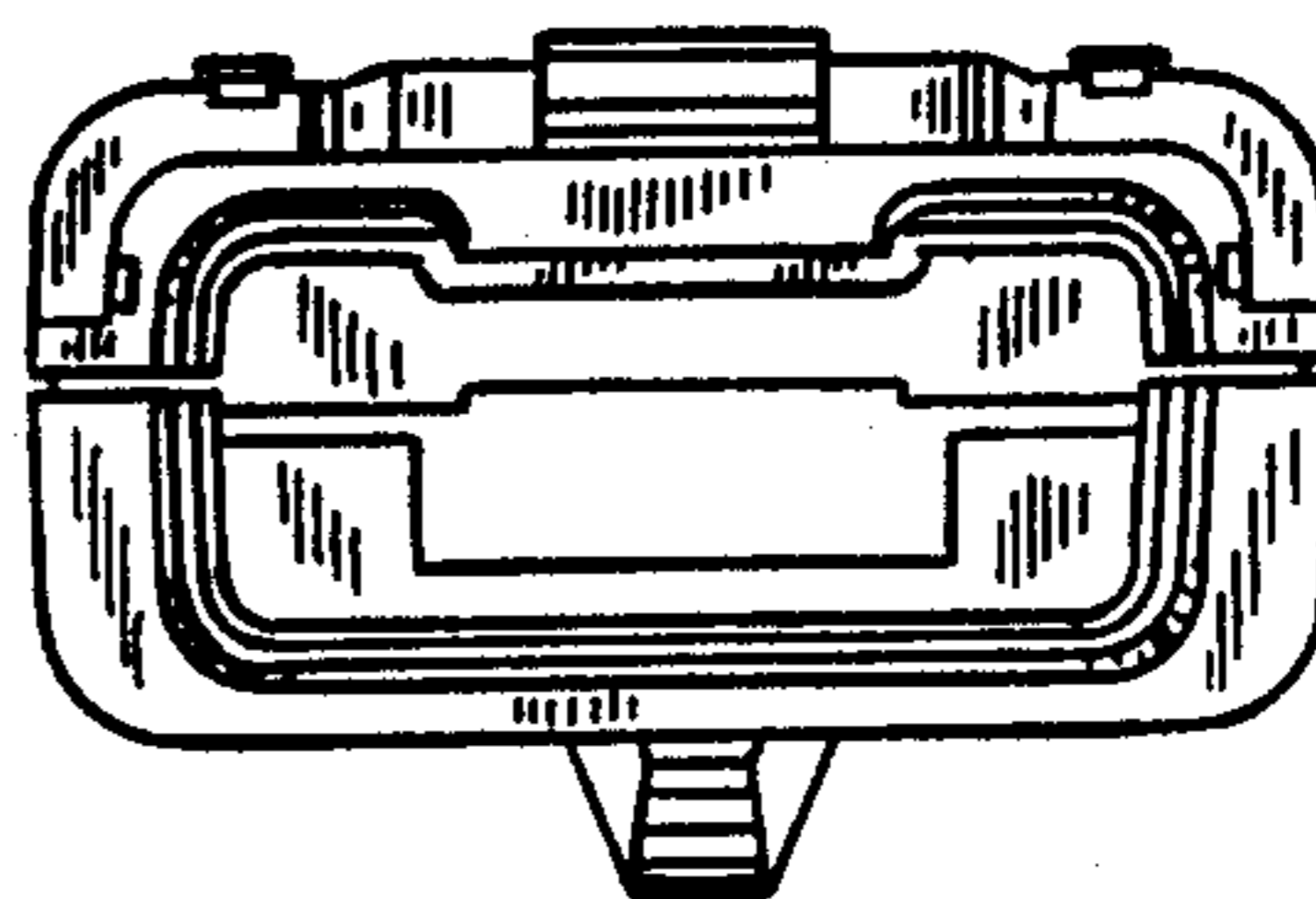
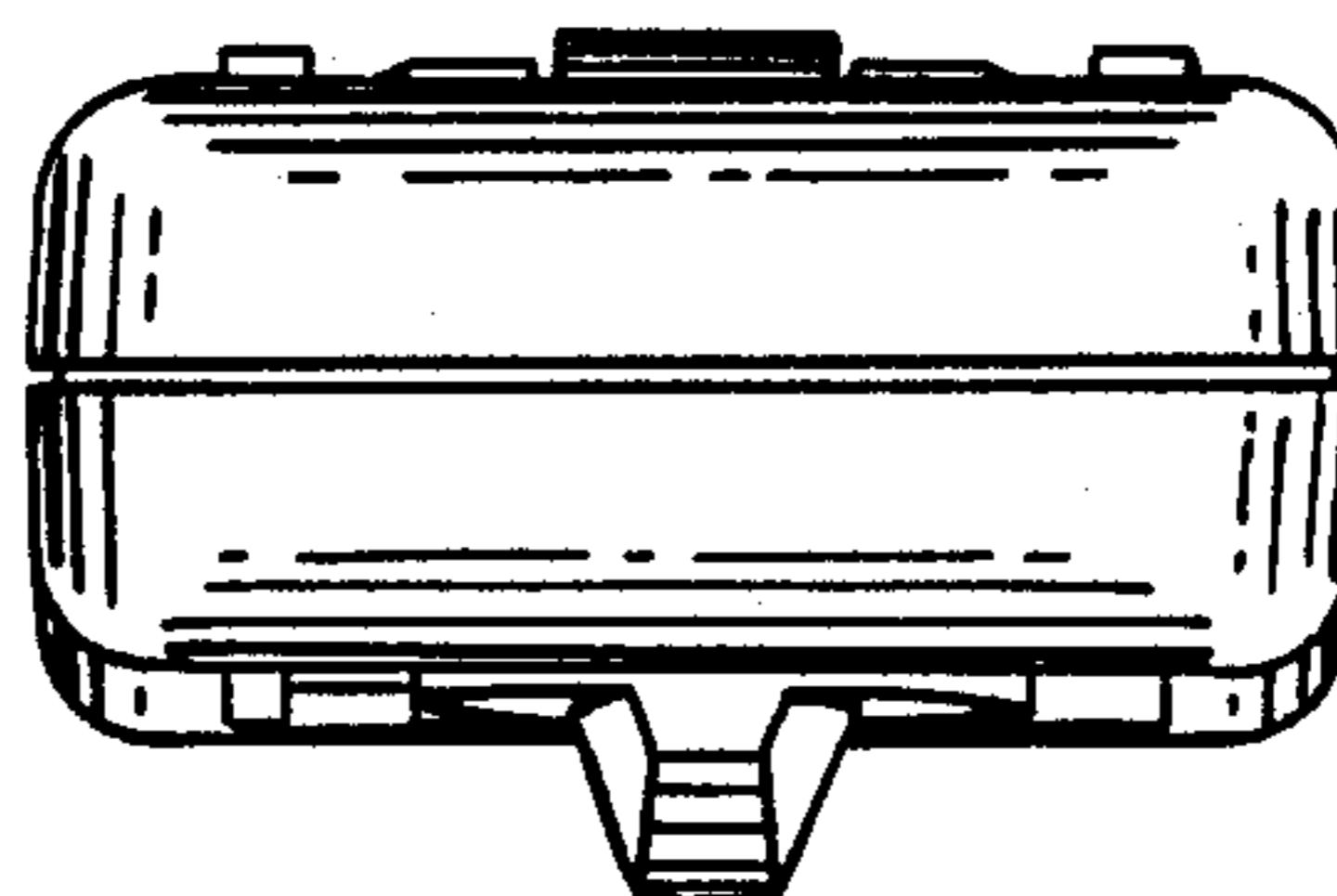

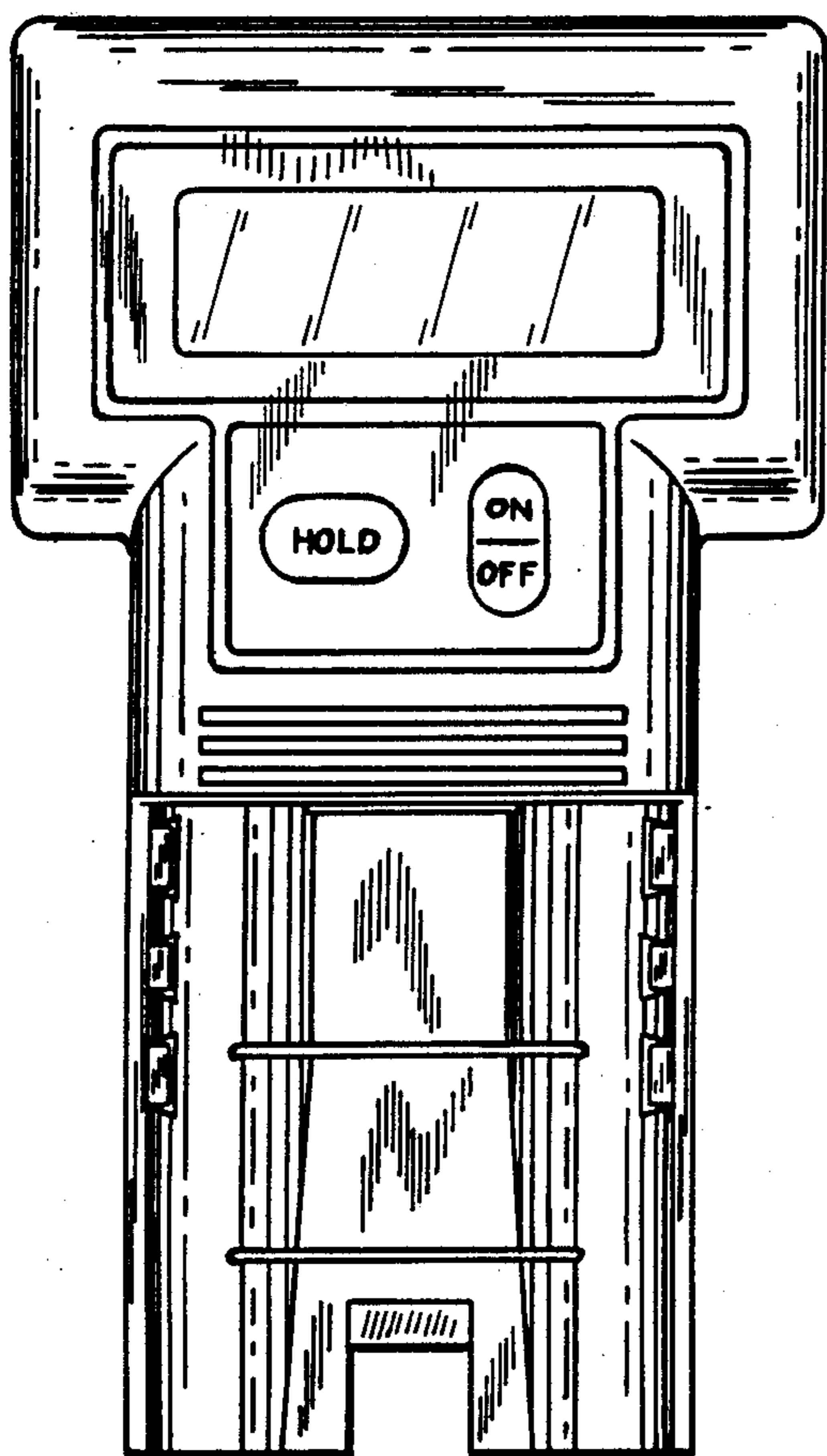

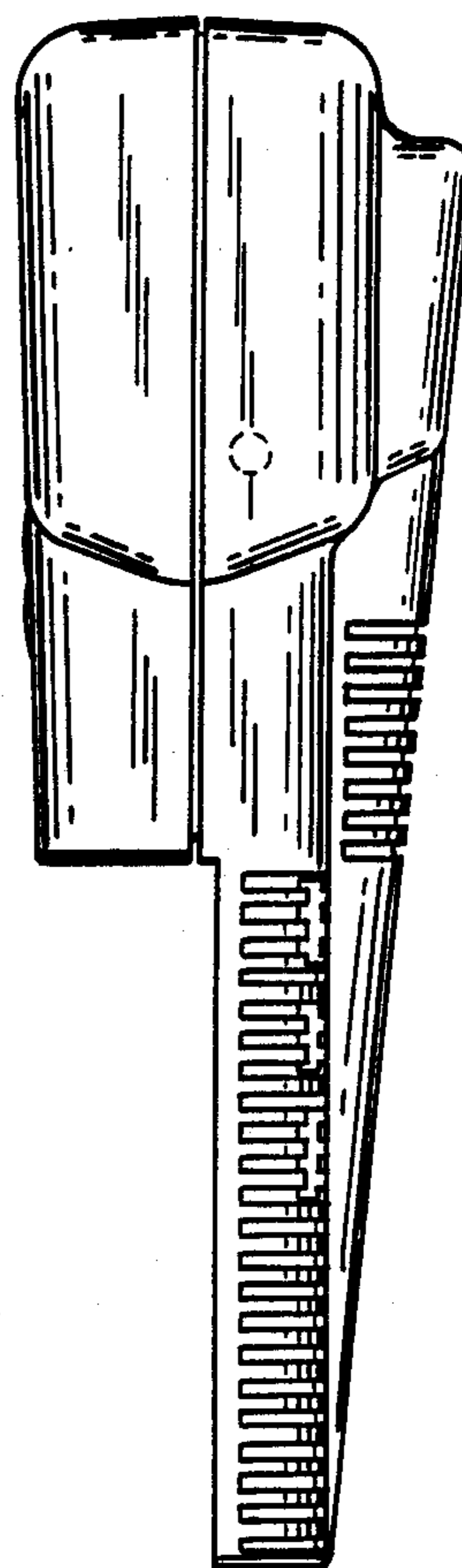

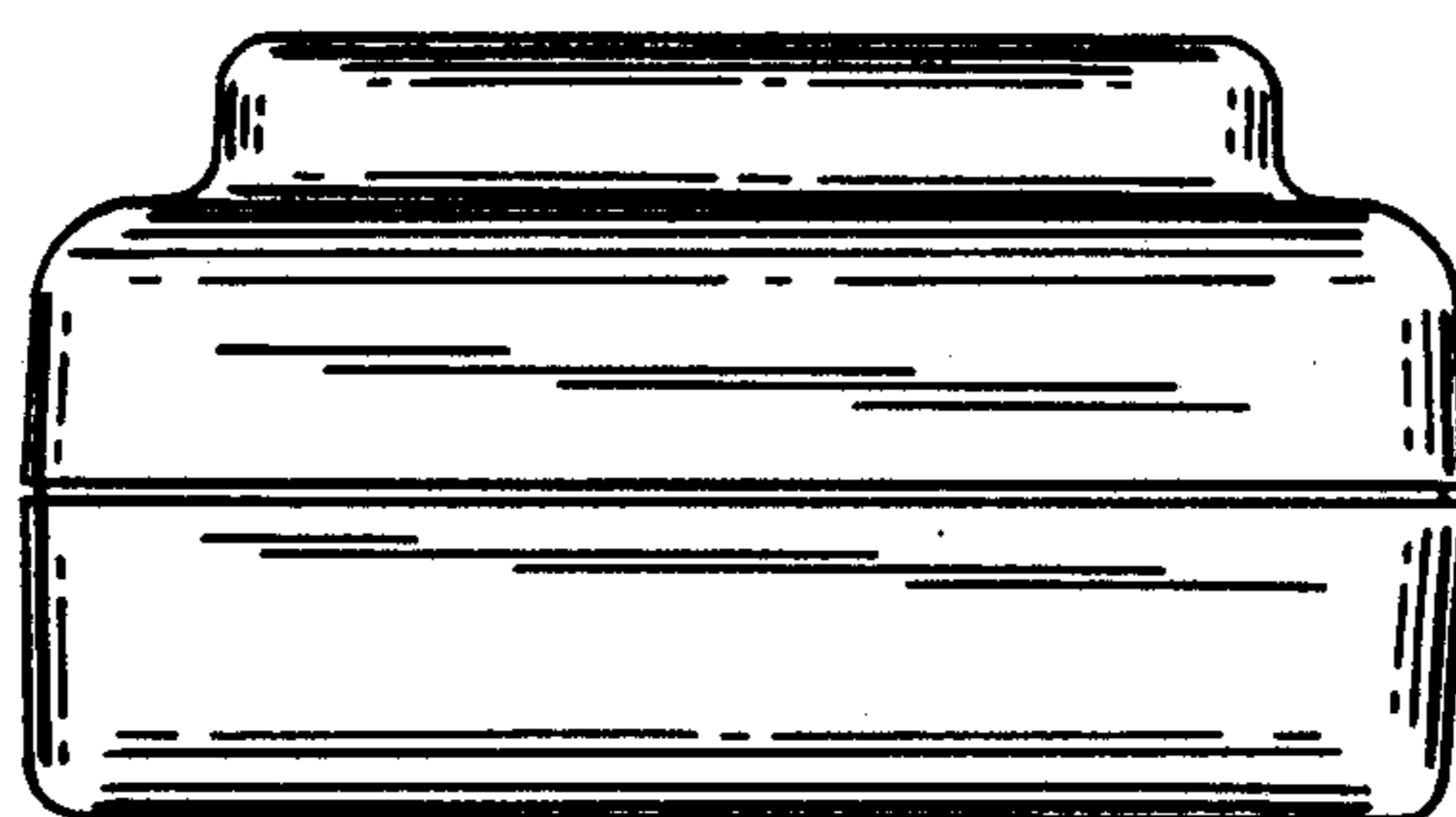

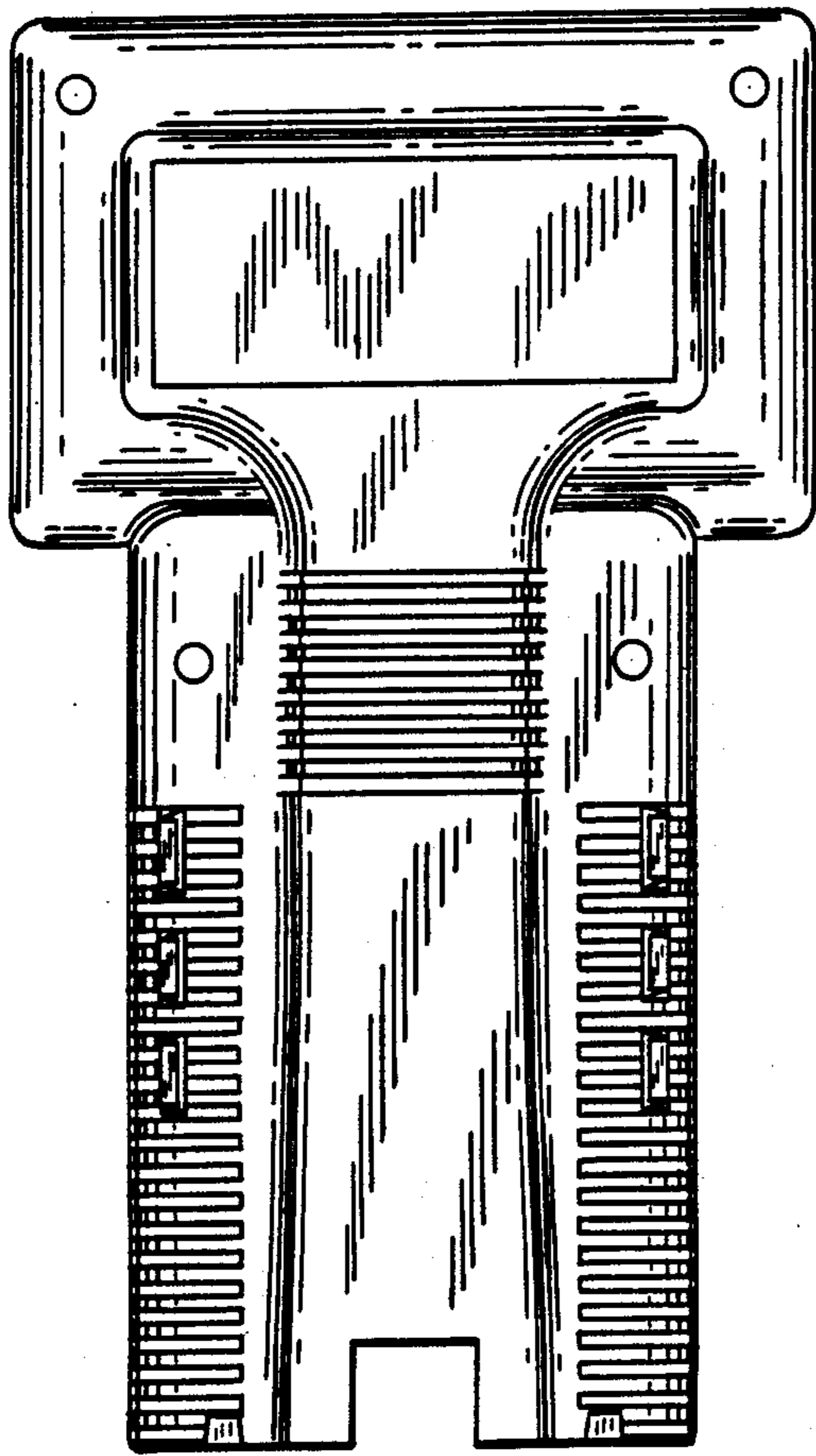

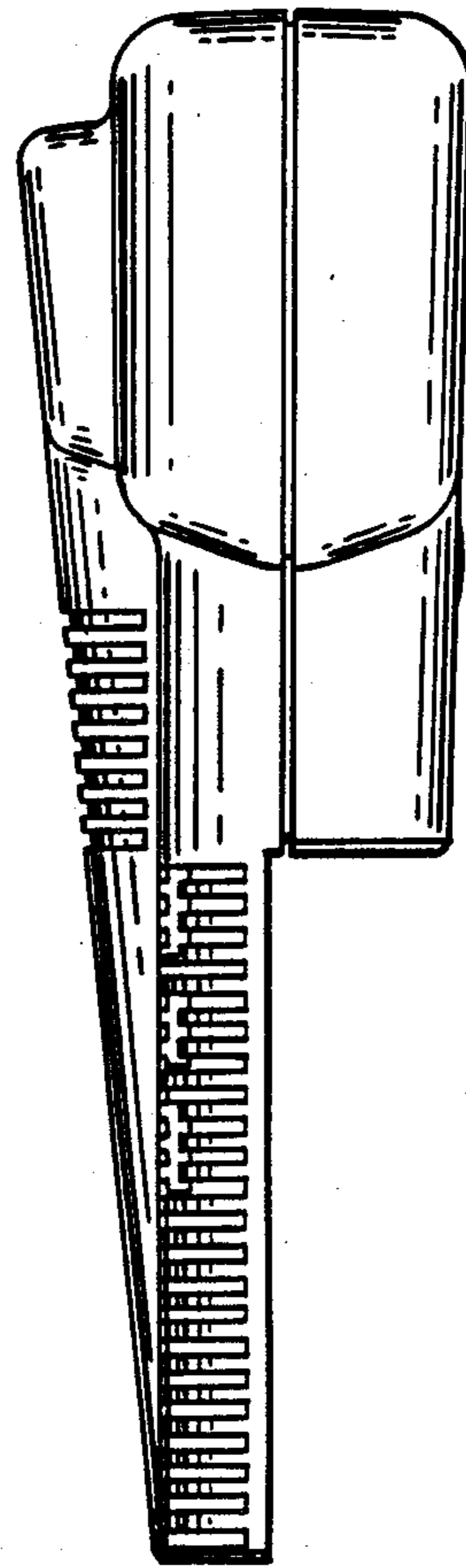

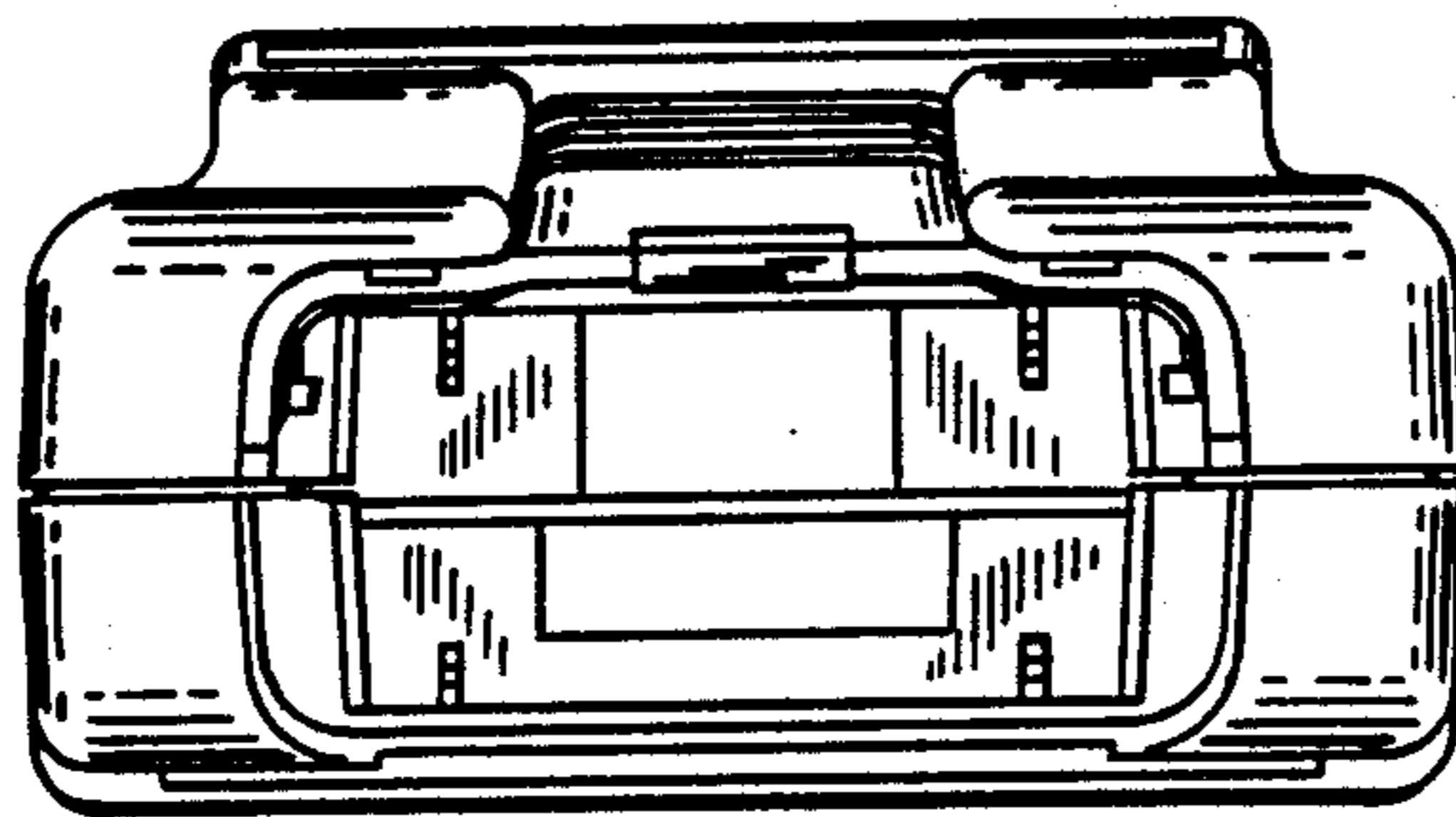
