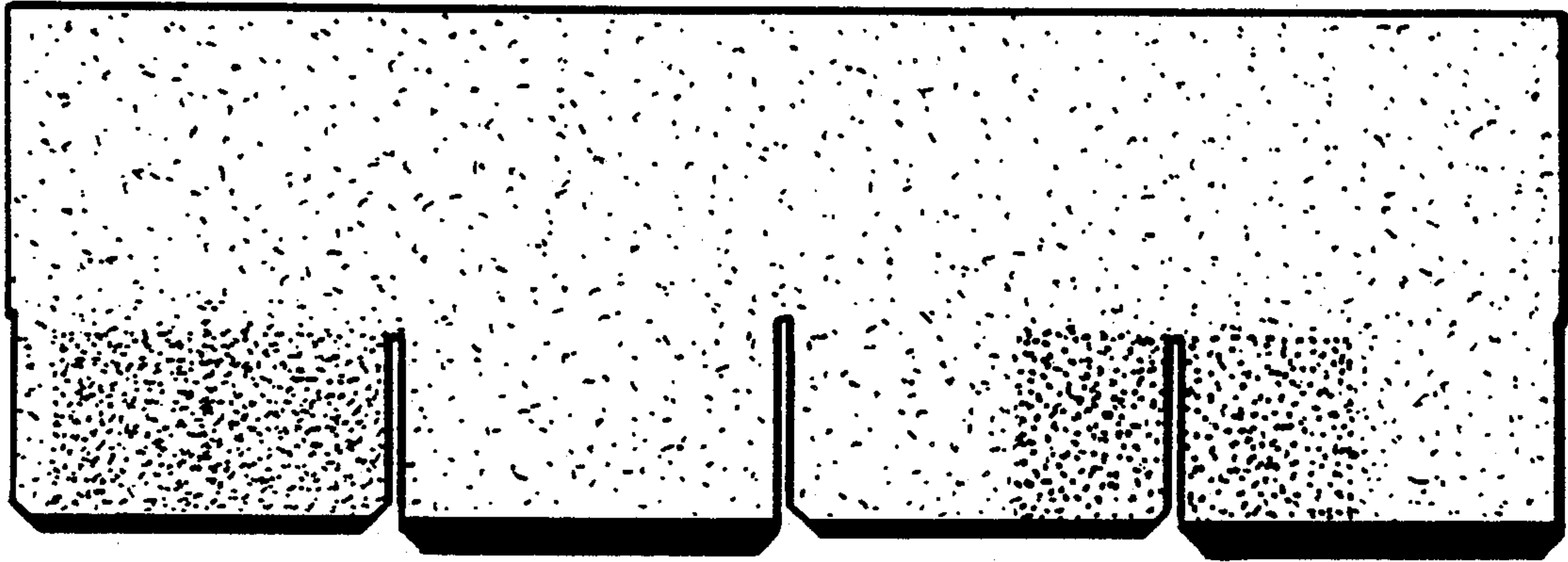

The ornamental design for a shingle, as shown and described.

DESCRIPTION
FIG. 1 is a front elevational view of a shingle showing my new design, the rear elevational view being plain and unornamented;
FIG. 2 is an end elevational view thereof;
FIG. 3 is a front elevational view of a second embodiment of a shingle showing my new design, the rear elevational view being plain and unornamented;
FIG. 4 is a front elevational view of a third embodiment of a shingle showing my new design, the rear elevational view being plain and unornamented; and
FIG. 5 is a front elevational view of a fourth embodiment of a shingle showing my new design, the rear elevational view being plain and unornamented.



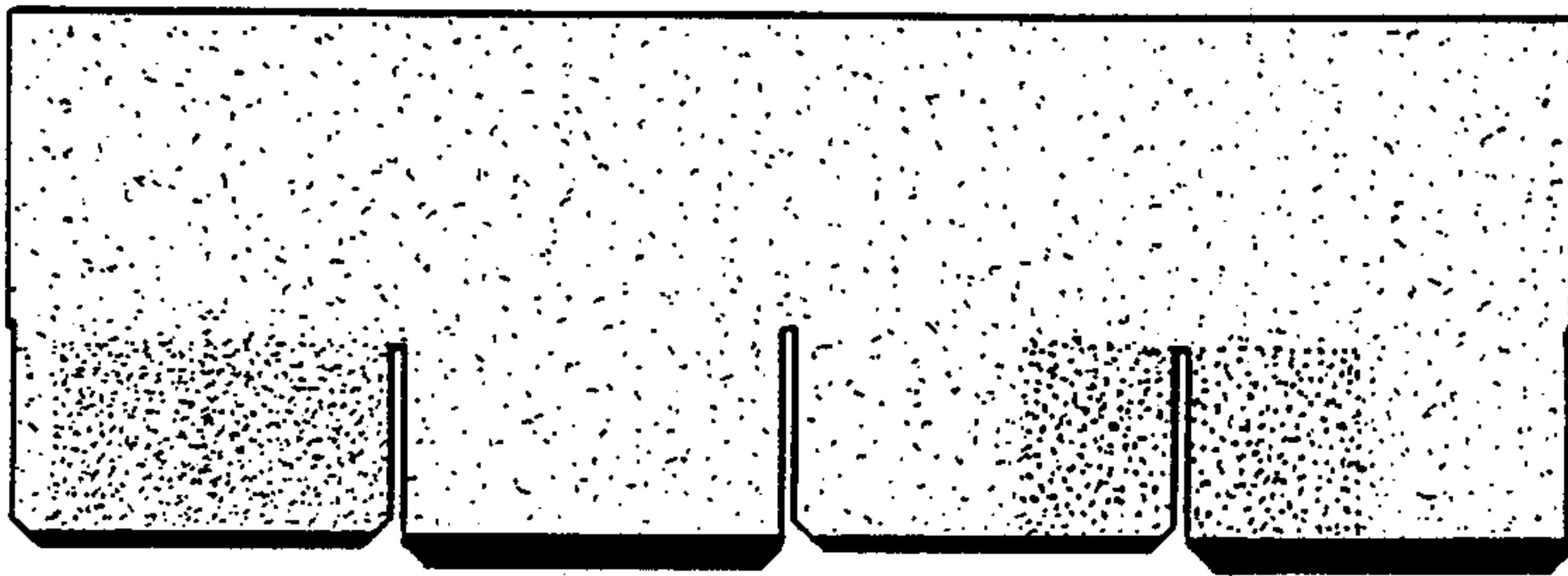

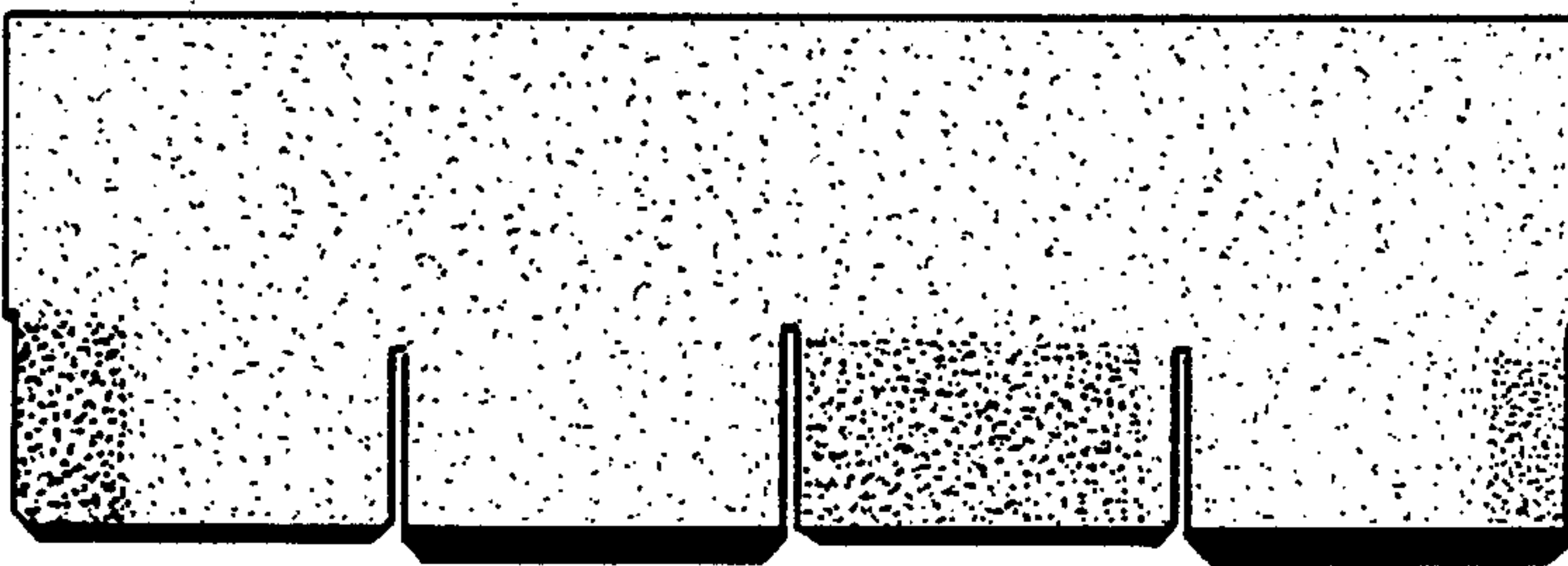

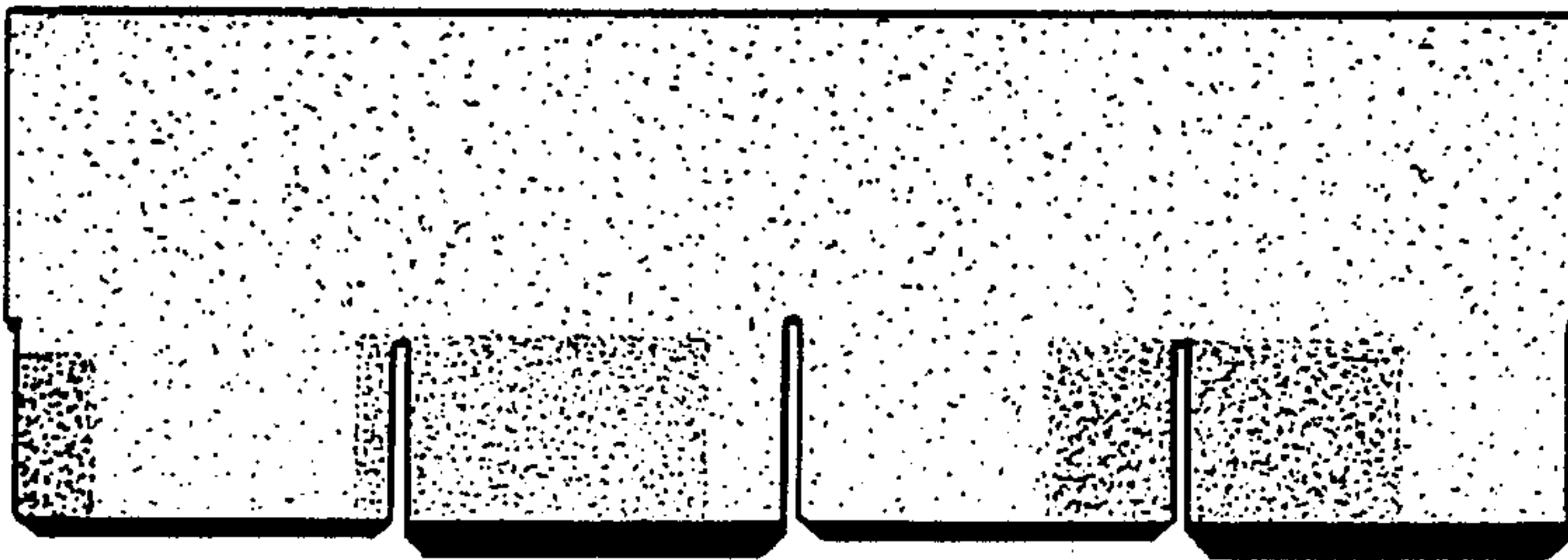

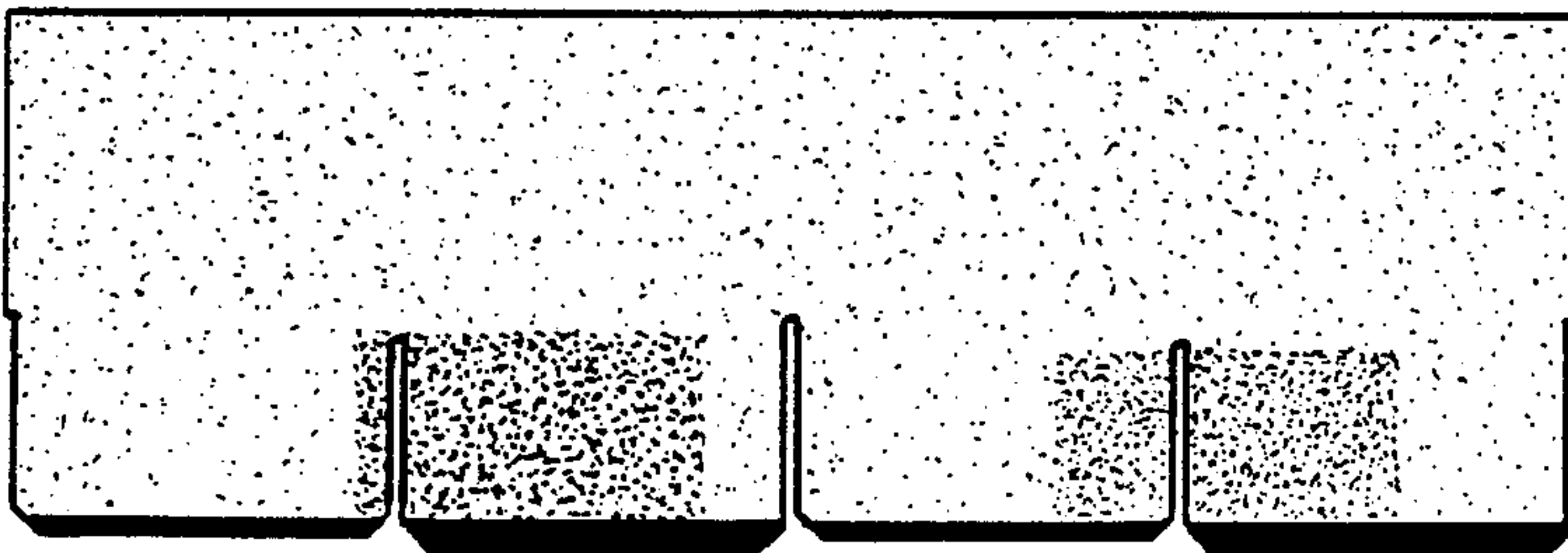
