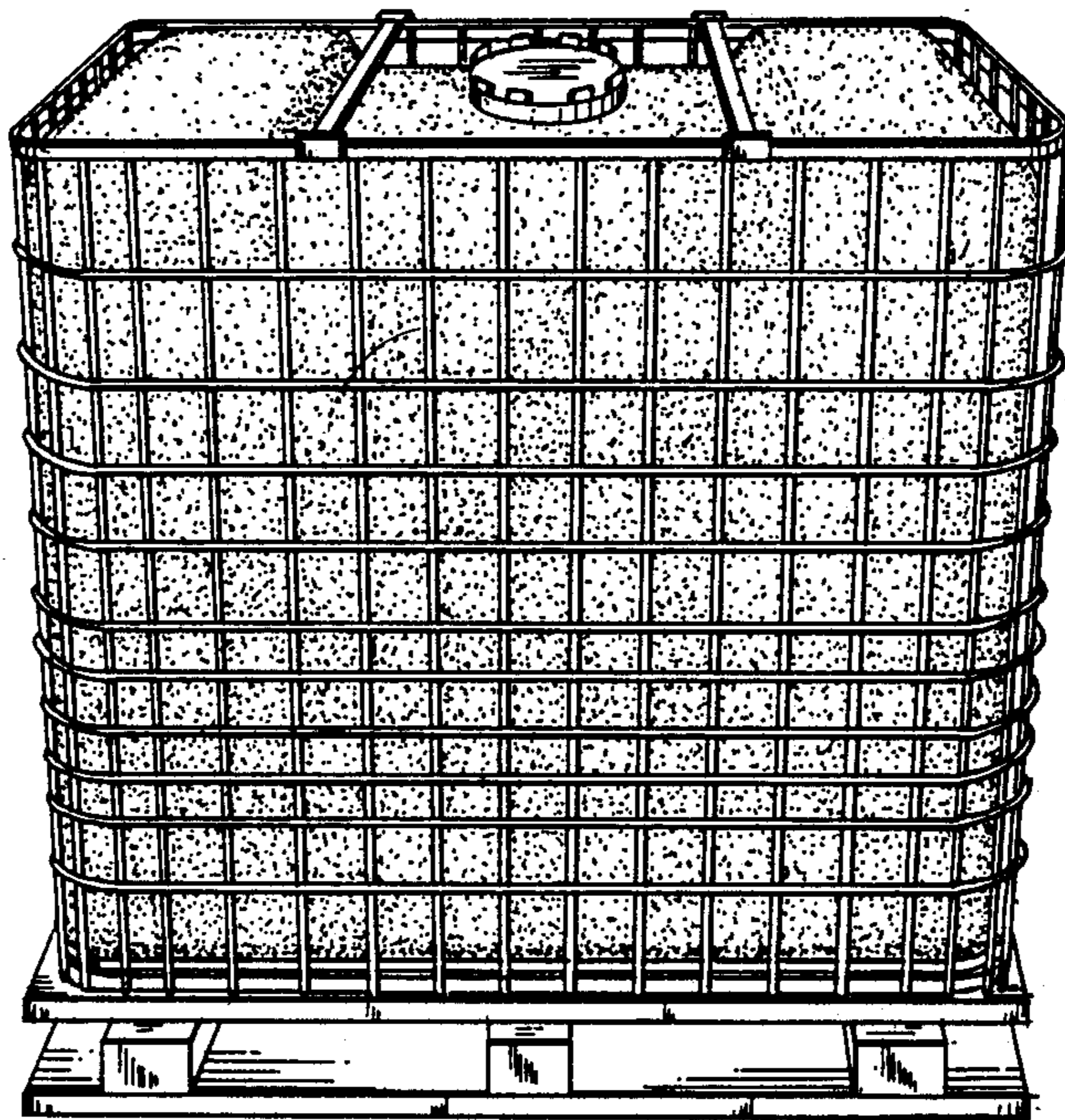

[57] **CLAIM**

The ornamental design for a combined container and pallet, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a combined container and pallet showing our new design; the rear being a mirror image thereof;  
FIG. 2 is a left side and top perspective view thereof; the right side is similar to the left side thereof;  
FIG. 3 is a front, side and top perspective view of a modified form of FIG. 1; and  
FIG. 4 is a top perspective view showing undisclosed sides in FIG. 3.



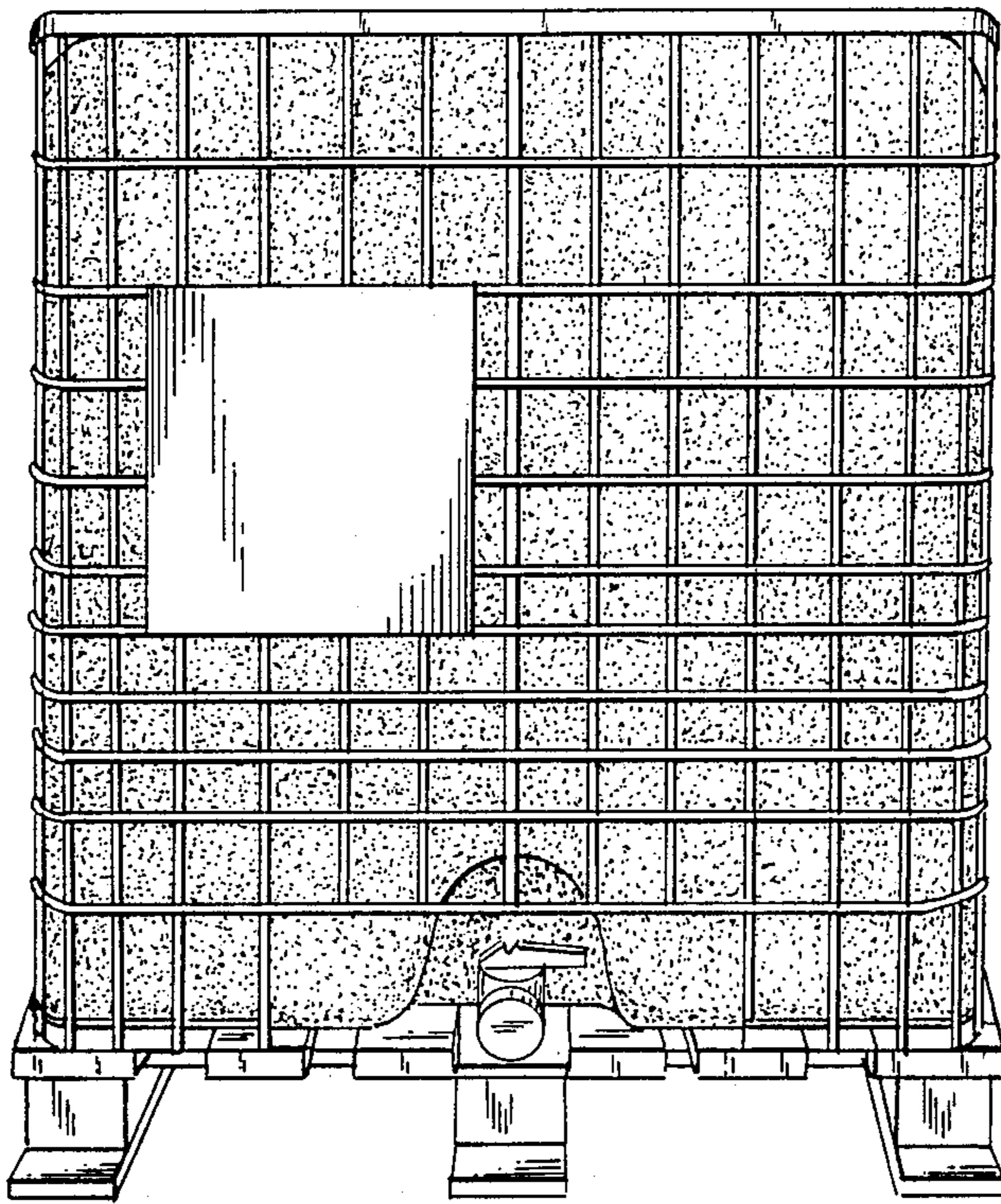
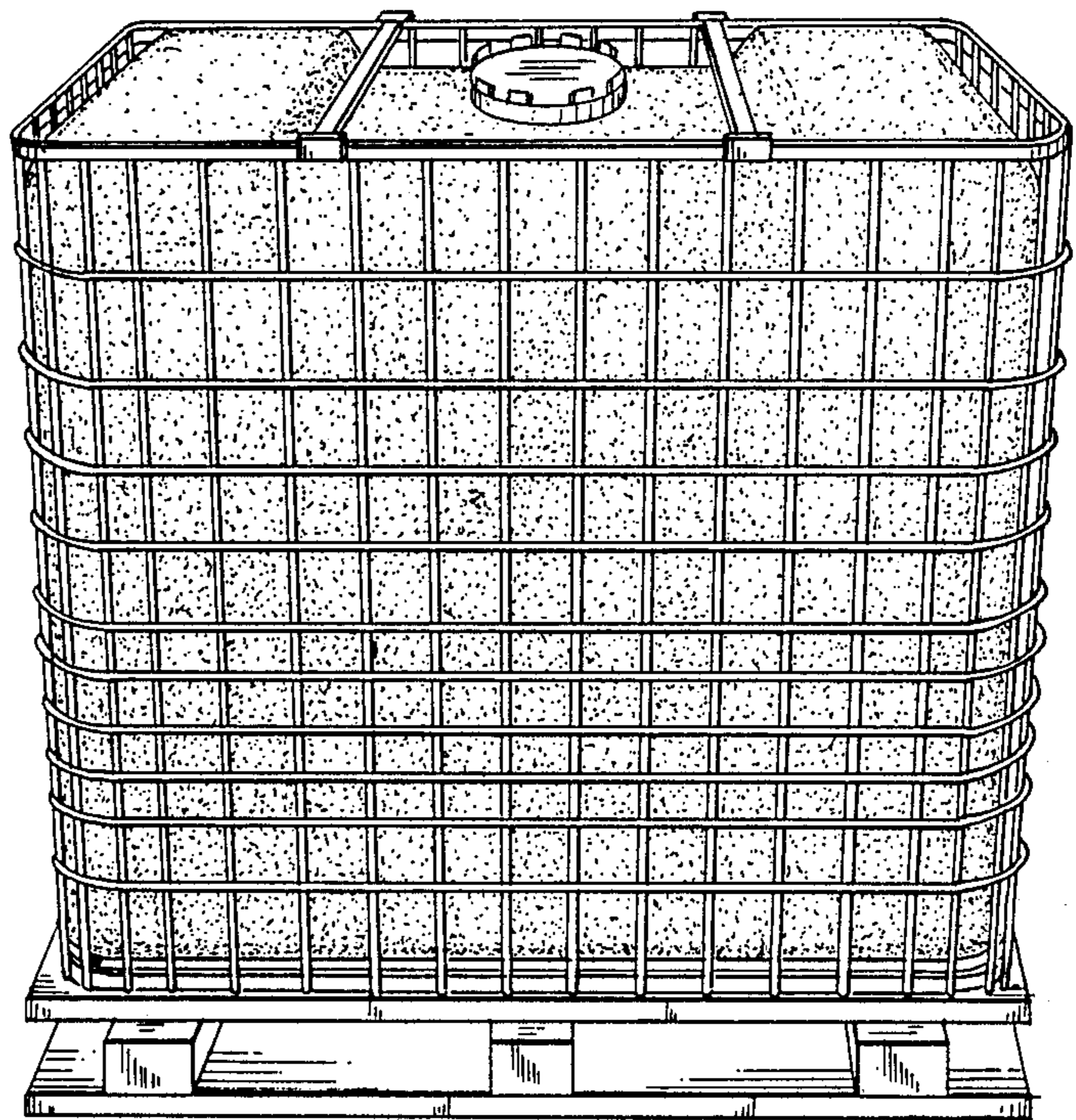

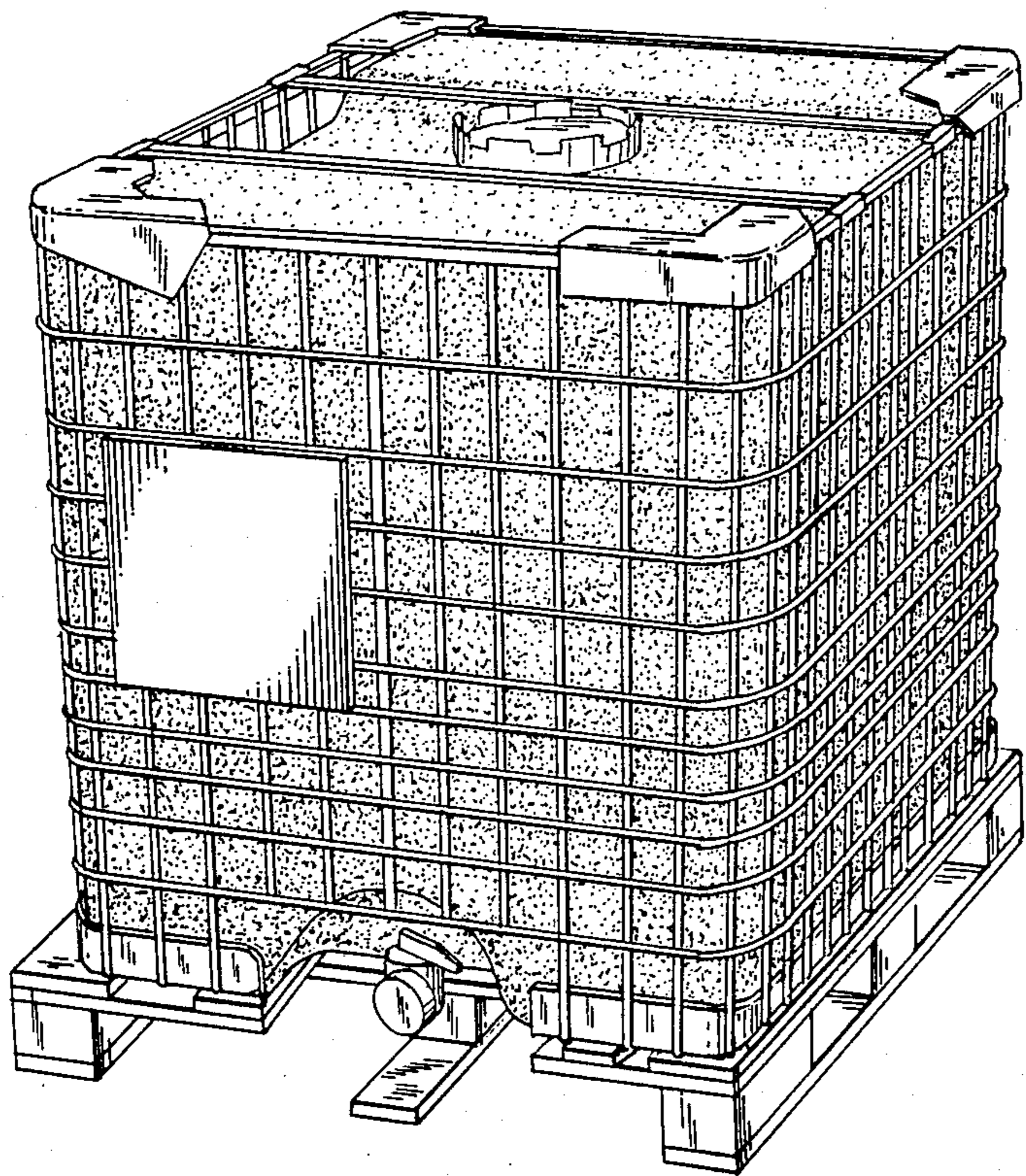
