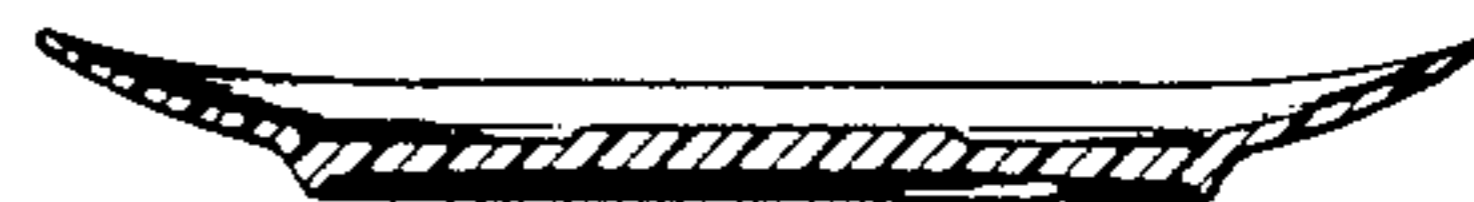
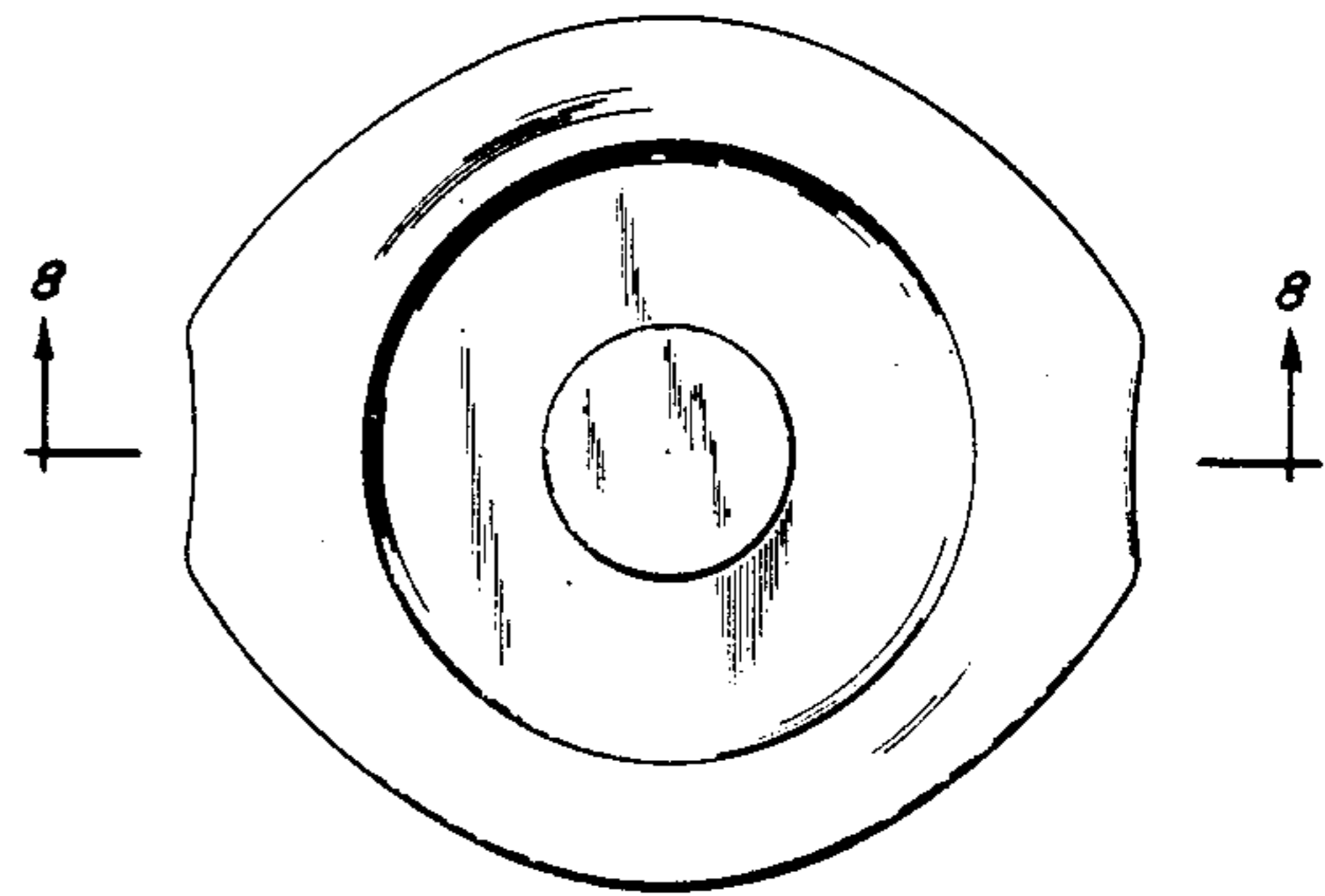
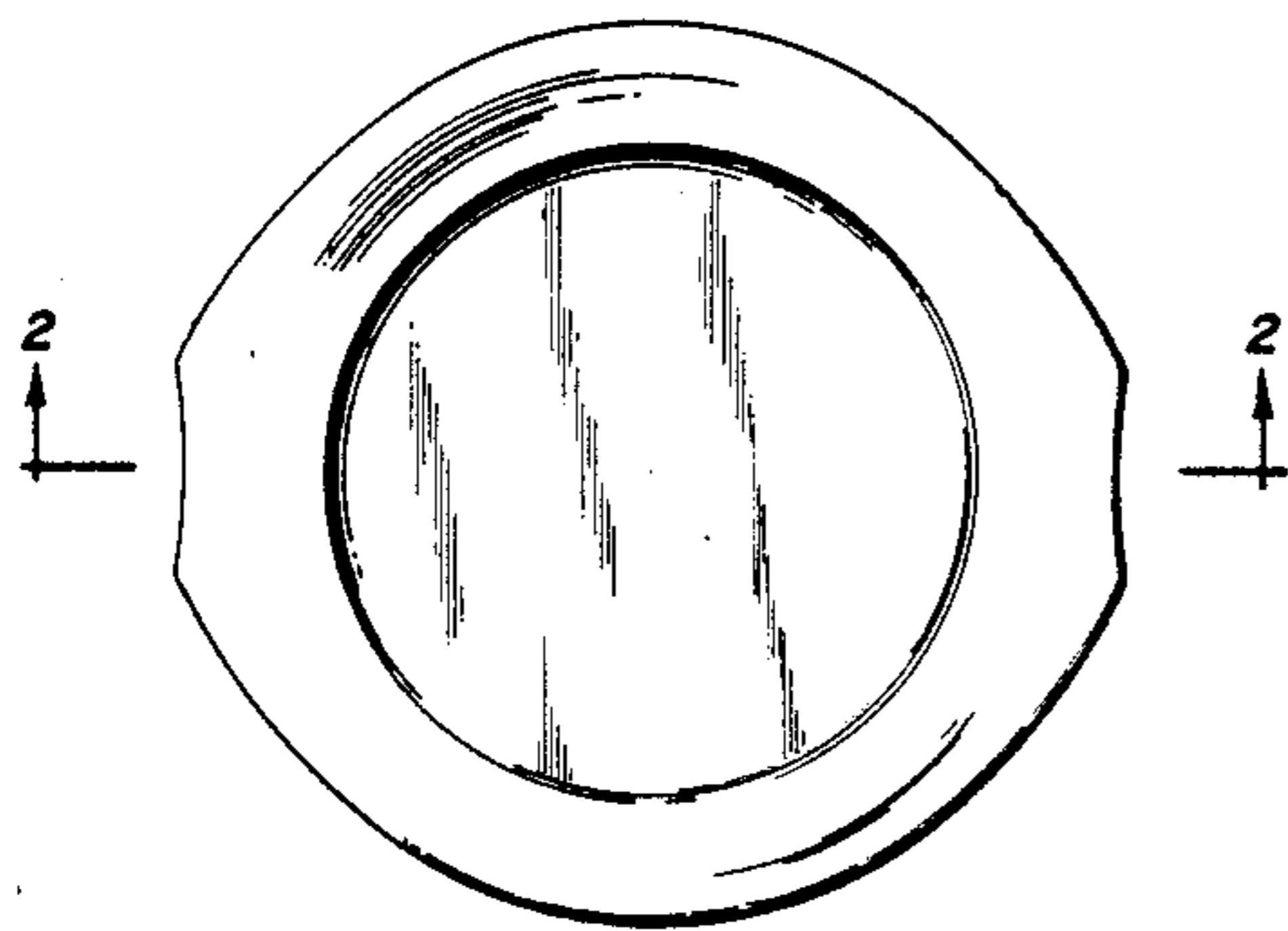

The ornamental design for a plate or similar article, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a plate or similar article showing my new design;
 FIG. 2 is a sectional view taken on line 2—2 of FIG. 1;
 FIG. 3 is a side elevational view, the side opposite being a mirror image;
 FIG. 4 is a sectional view taken on line 4—4 of FIG. 3;
 FIG. 5 is an end elevational view, the end opposite being a mirror image;
 FIG. 6 is a bottom plan view;
 FIG. 7 is a top plan view of my new design for a plate or similar article as embodied in a saucer;
 FIG. 8 is a sectional view taken on line 8—8 of FIG. 7;
 FIG. 9 is a side elevational view of the saucer of FIG. 7, the side opposite being a mirror image;
 FIG. 10 is a sectional view taken on line 10—10 of FIG. 9;
 FIG. 11 is an end elevational view of the saucer of FIG. 7, the end opposite being a mirror image; and
 FIG. 12 is a bottom plan view of the saucer of FIG. 7.



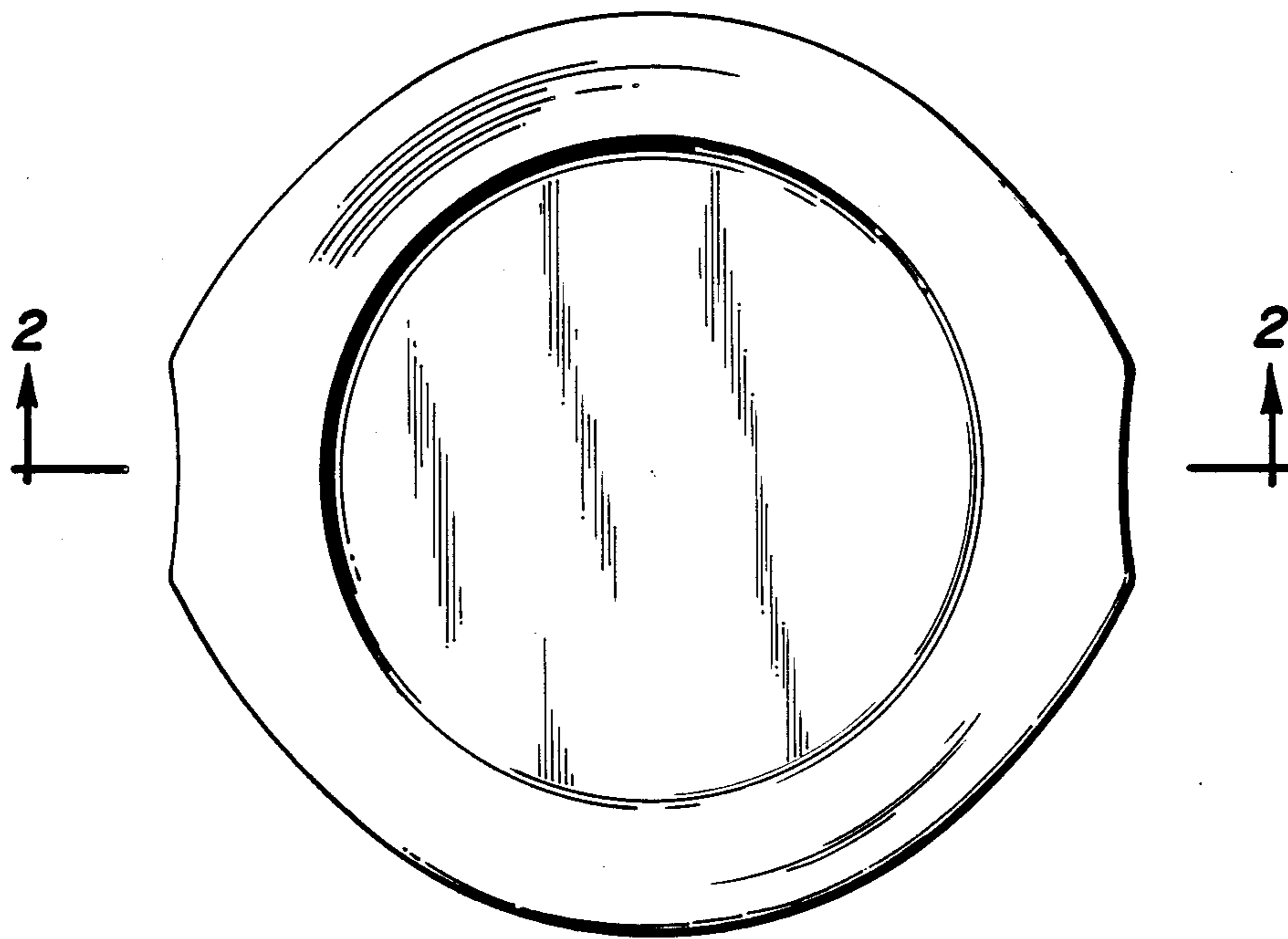

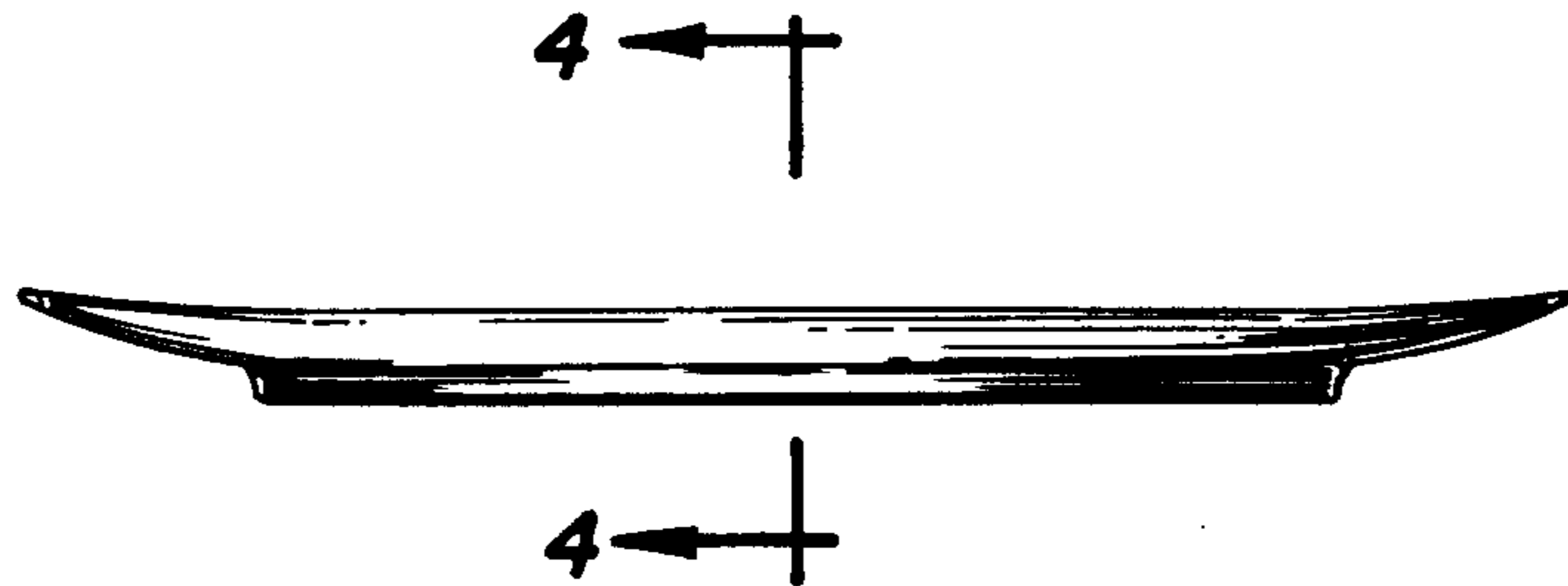

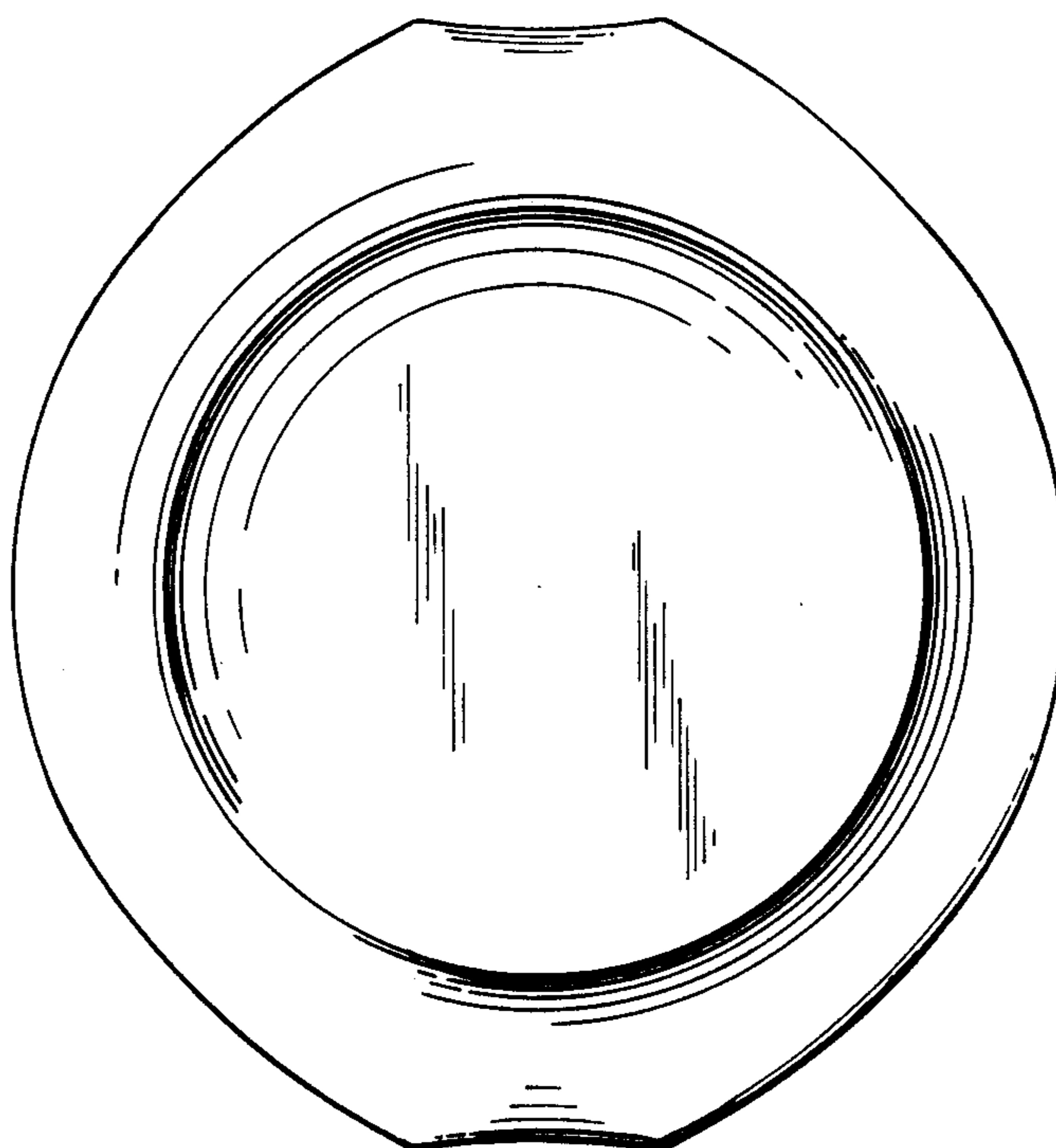

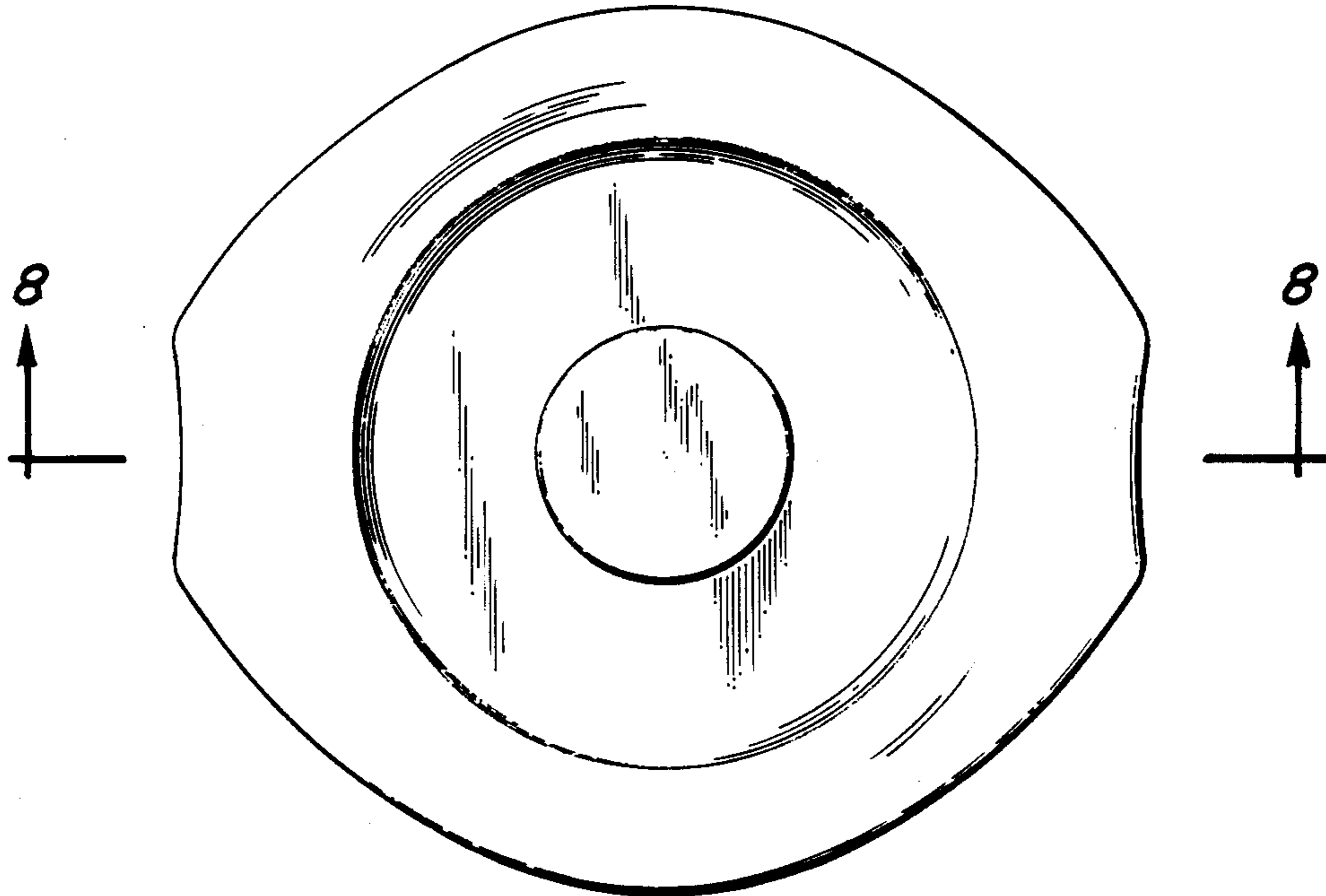

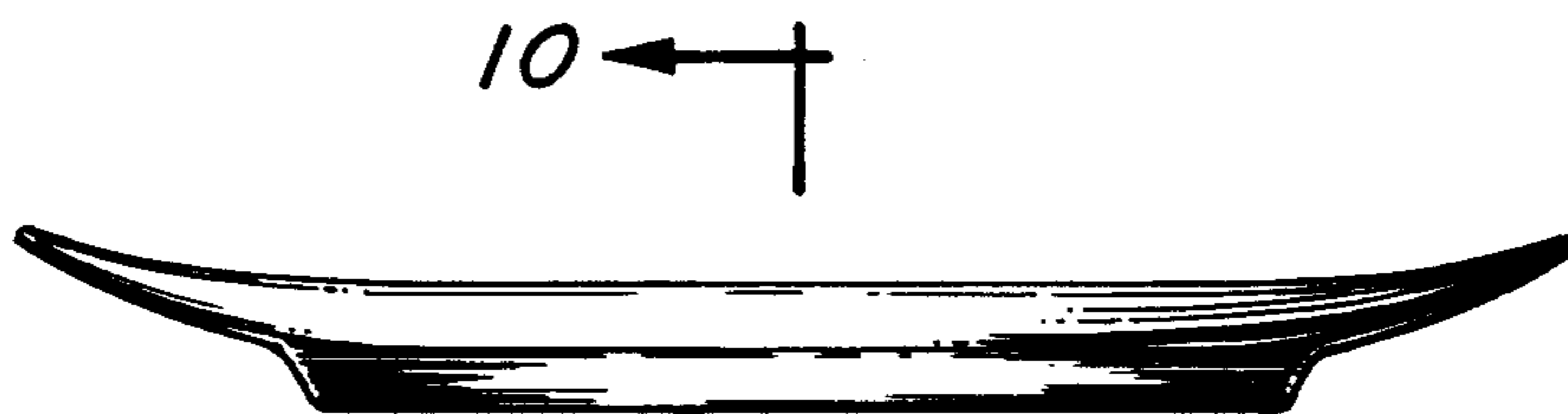

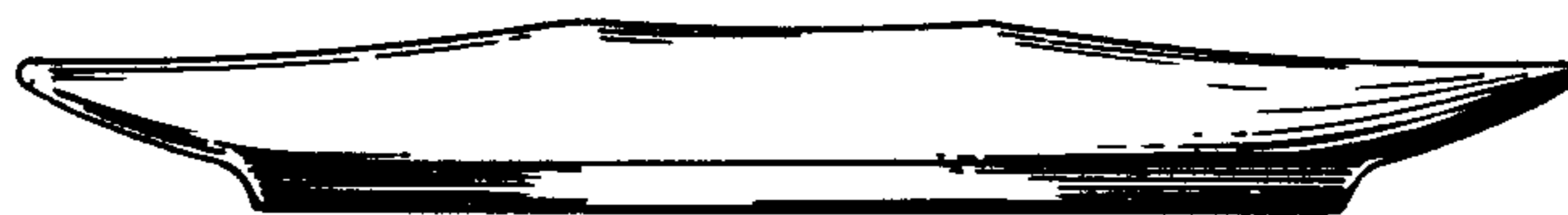

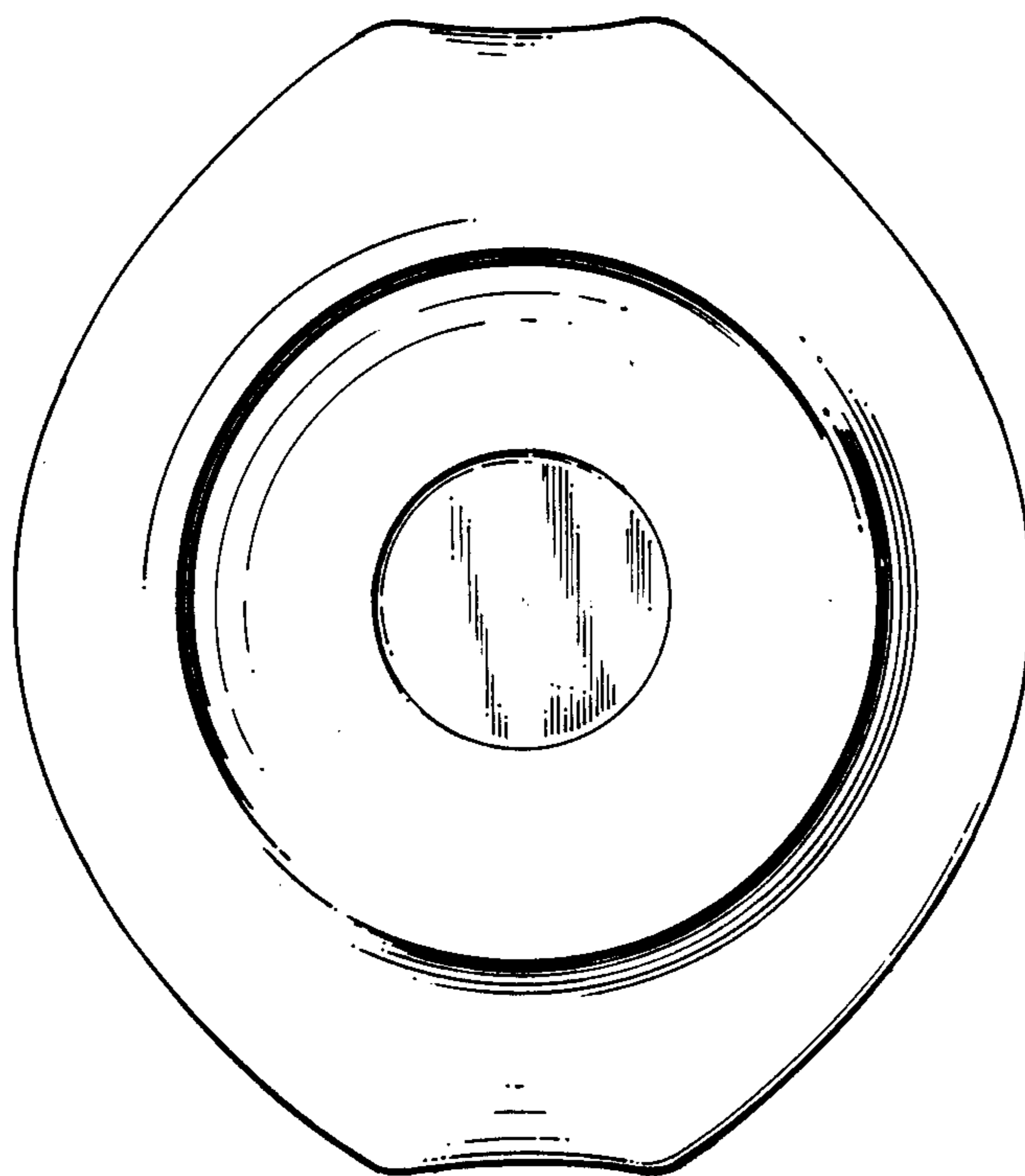
