The ornamental design for a hand-held control unit for the operation of an inflatable air mattress, as shown and described.

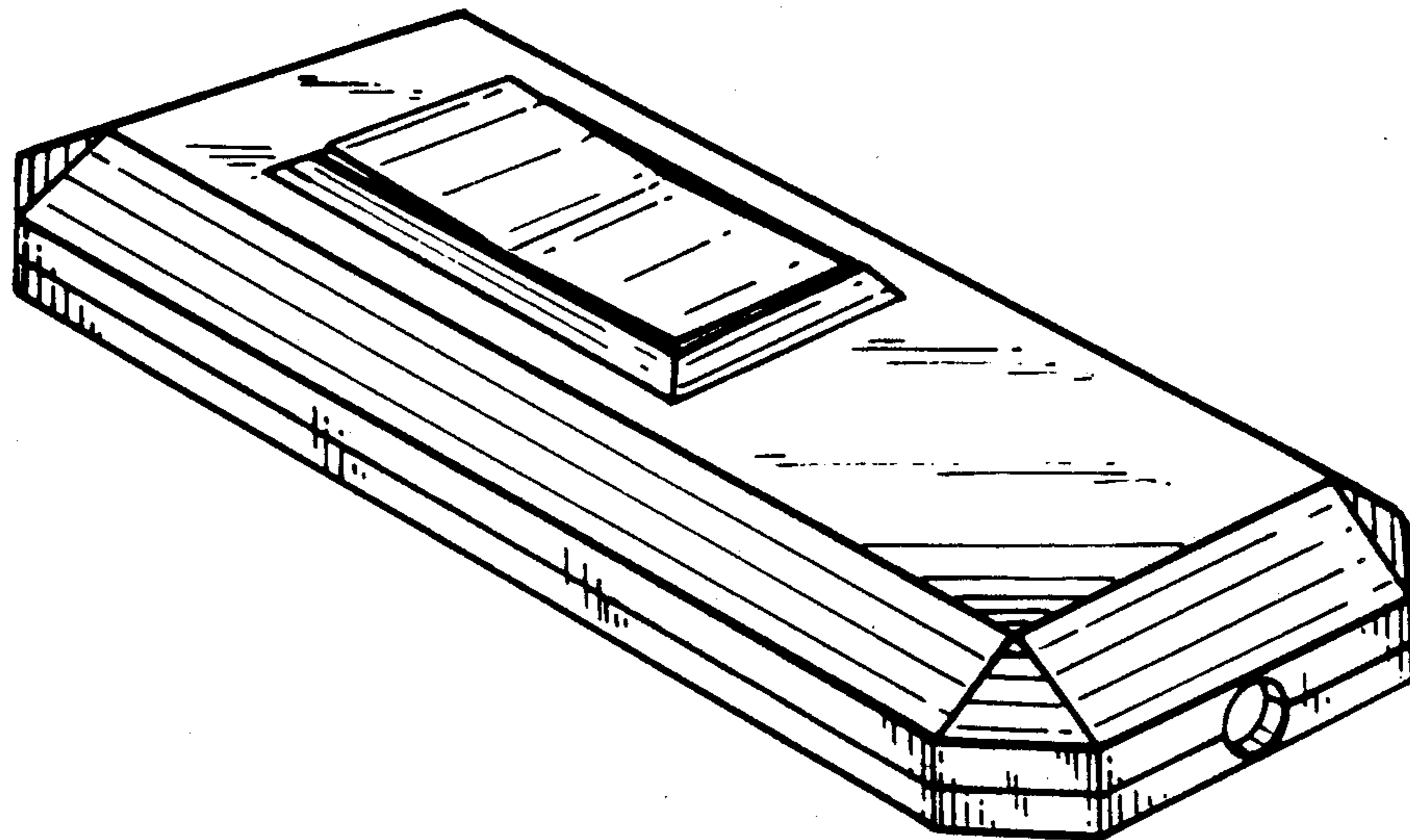
DESCRIPTION

FIG. 1 is a perspective view of a hand-held control unit for the operation of an inflatable air mattress showing my new design;  
 FIG. 2 is a top plan view thereof;  
 FIG. 3 is a side elevational view thereof, the opposite side being a mirror image of that shown;  
 FIG. 4 is a bottom plan view thereof;  
 FIG. 5 is an end elevational view thereof; and

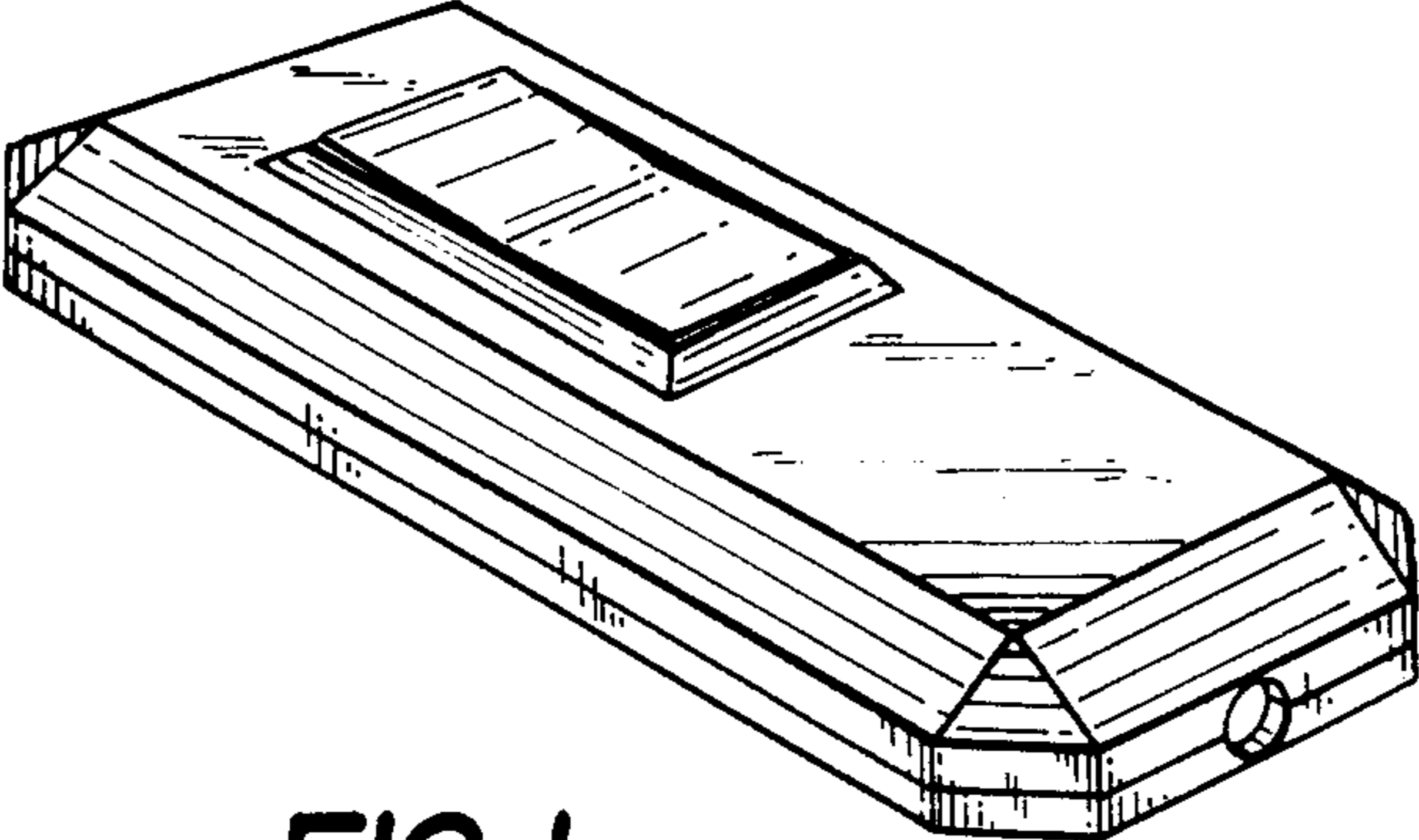

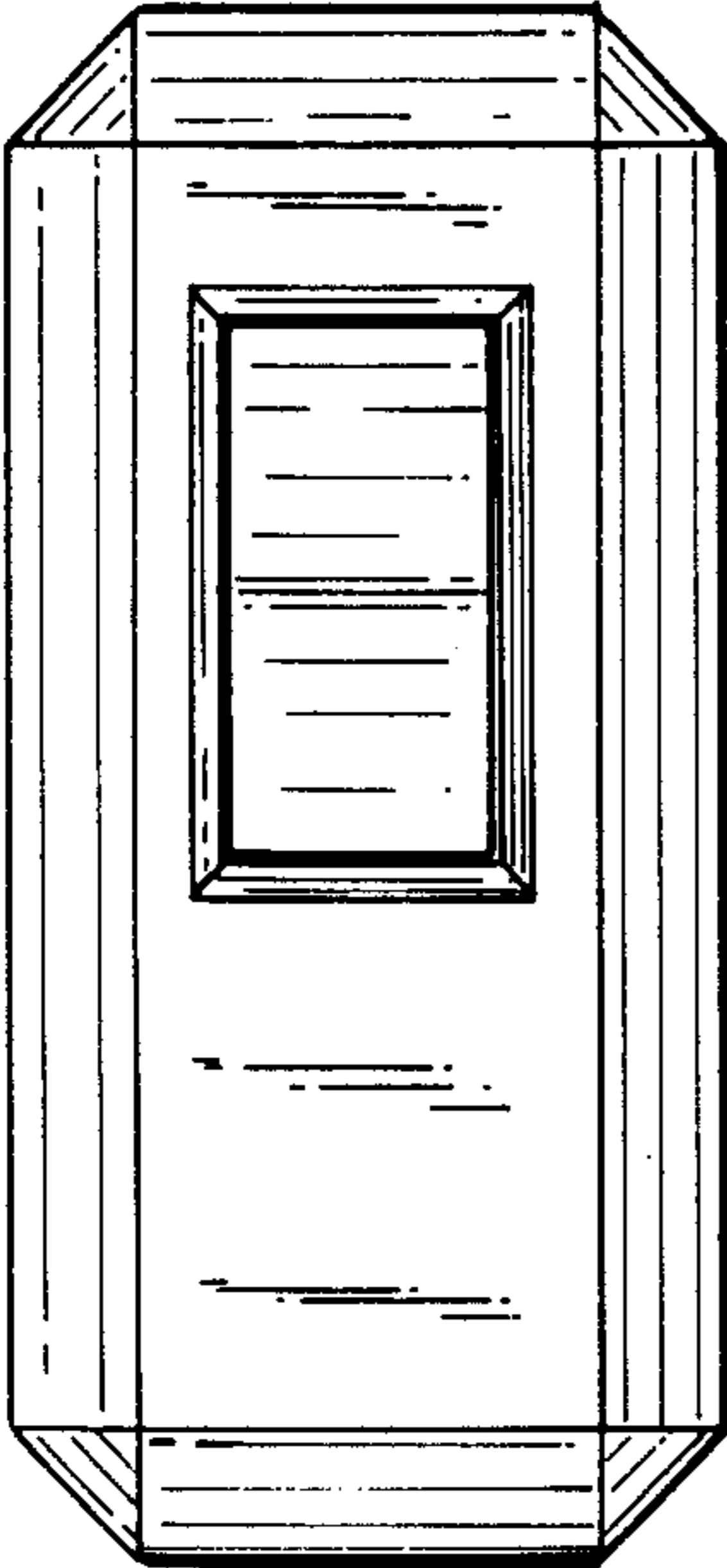

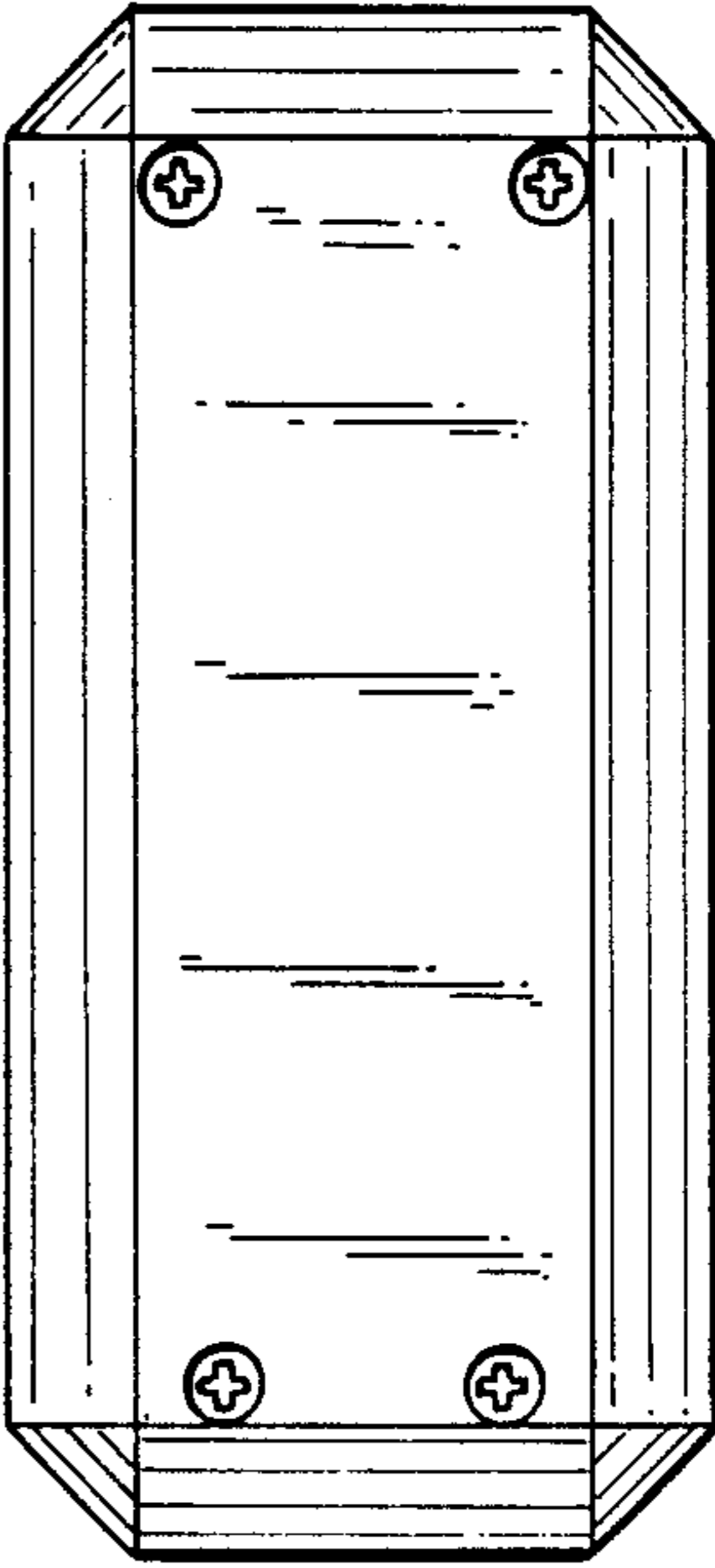

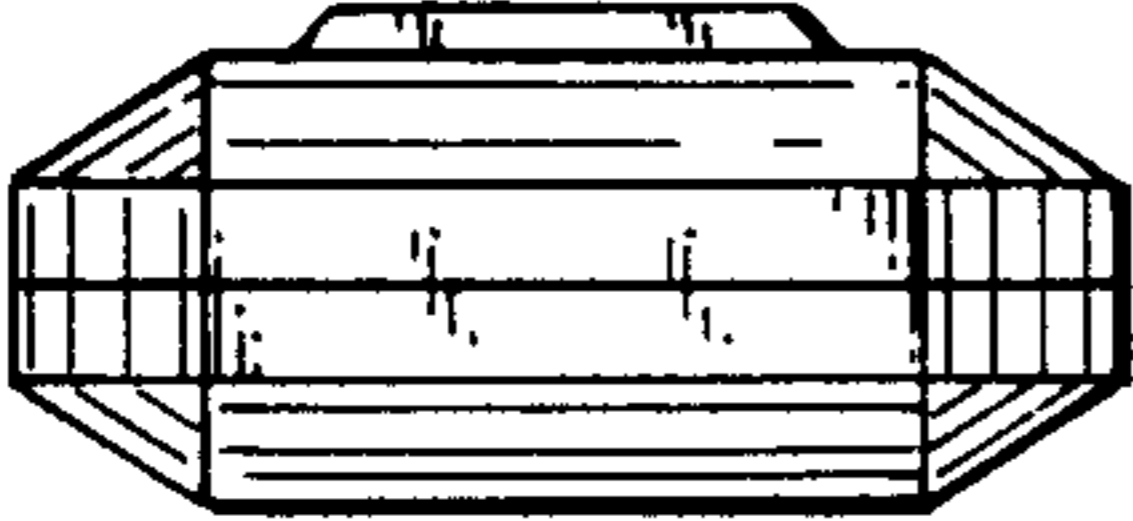
