The ornamental design for an image recorder for printing, as shown and described.

DESCRIPTION

FIG. 1 is a left, front and top perspective view of an image recorder for printing showing our new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is a top plan view thereof; FIG. 5 is a bottom plan view thereof; FIG. 6 is a right side elevational view thereof; FIG. 7 is a left, front and top perspective view showing a second embodiment of our new design of FIGS. 1-6; FIG. 8 is a front elevational view thereof; FIG. 9 is a top plan view thereof; FIG. 10 is a right side elevational view thereof; FIG. 11 is a left, front and top perspective view showing a third embodiment of our new design of FIGS. 1-6; FIG. 12 is a front elevational view thereof; FIG. 13 is a top plan view thereof; FIG. 14 is a right side elevational view thereof; FIG. 15 is a left, front and top perspective view showing a fourth embodiment of our new design of FIGS. 1-6; FIG. 16 is a front elevational view thereof; FIG. 17 is a top plan view thereof; and FIG. 18 is a right side elevational view thereof.

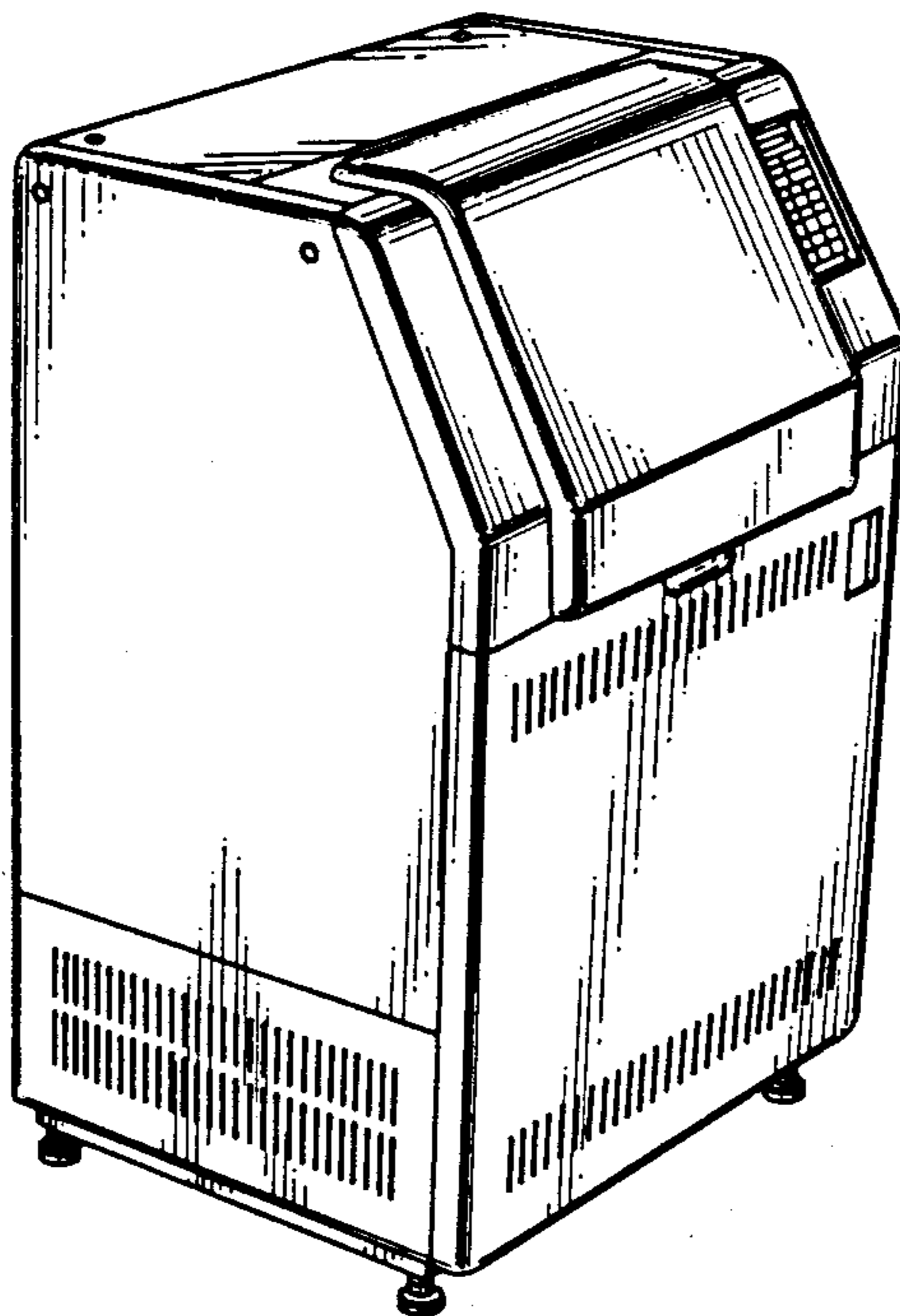

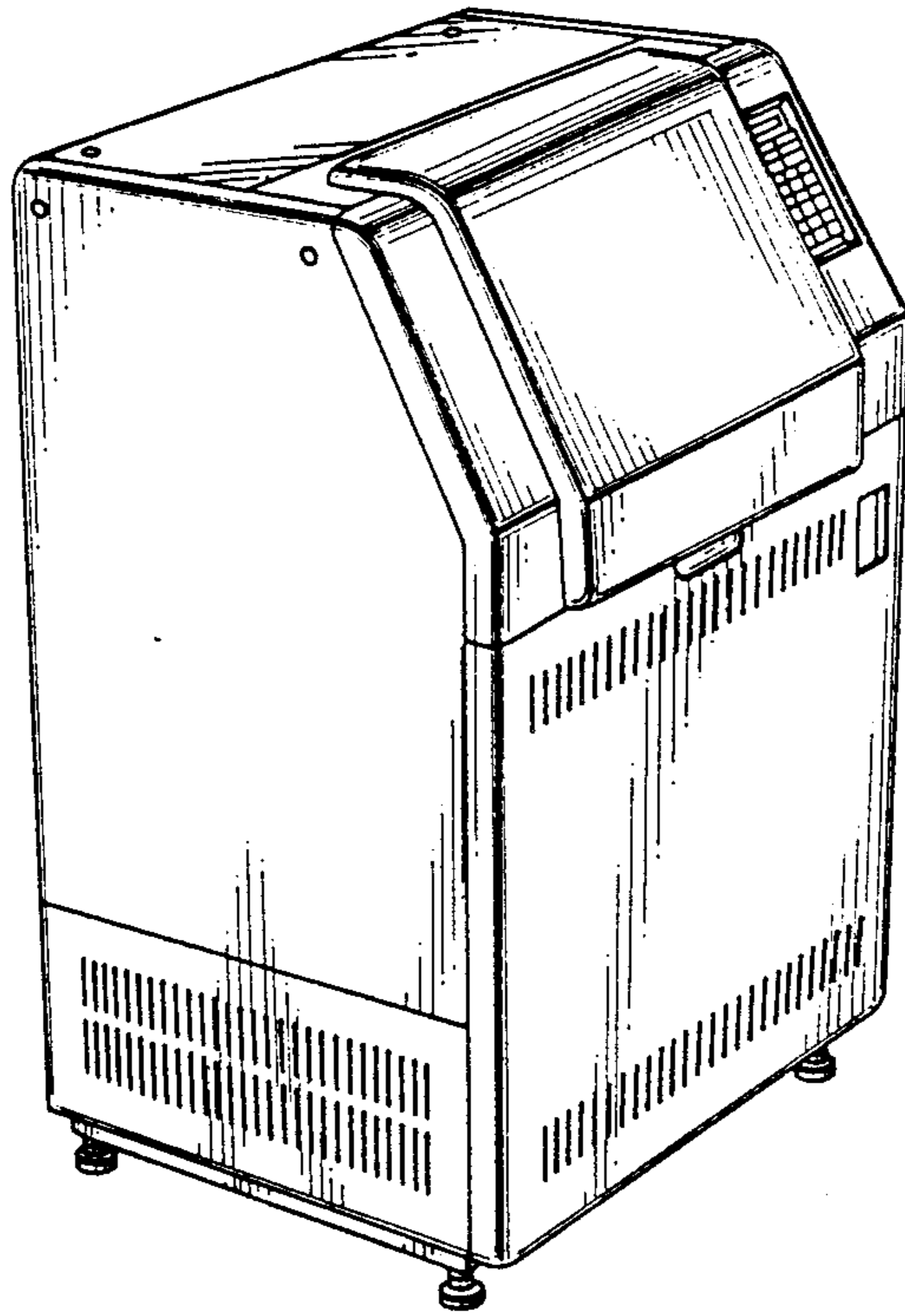

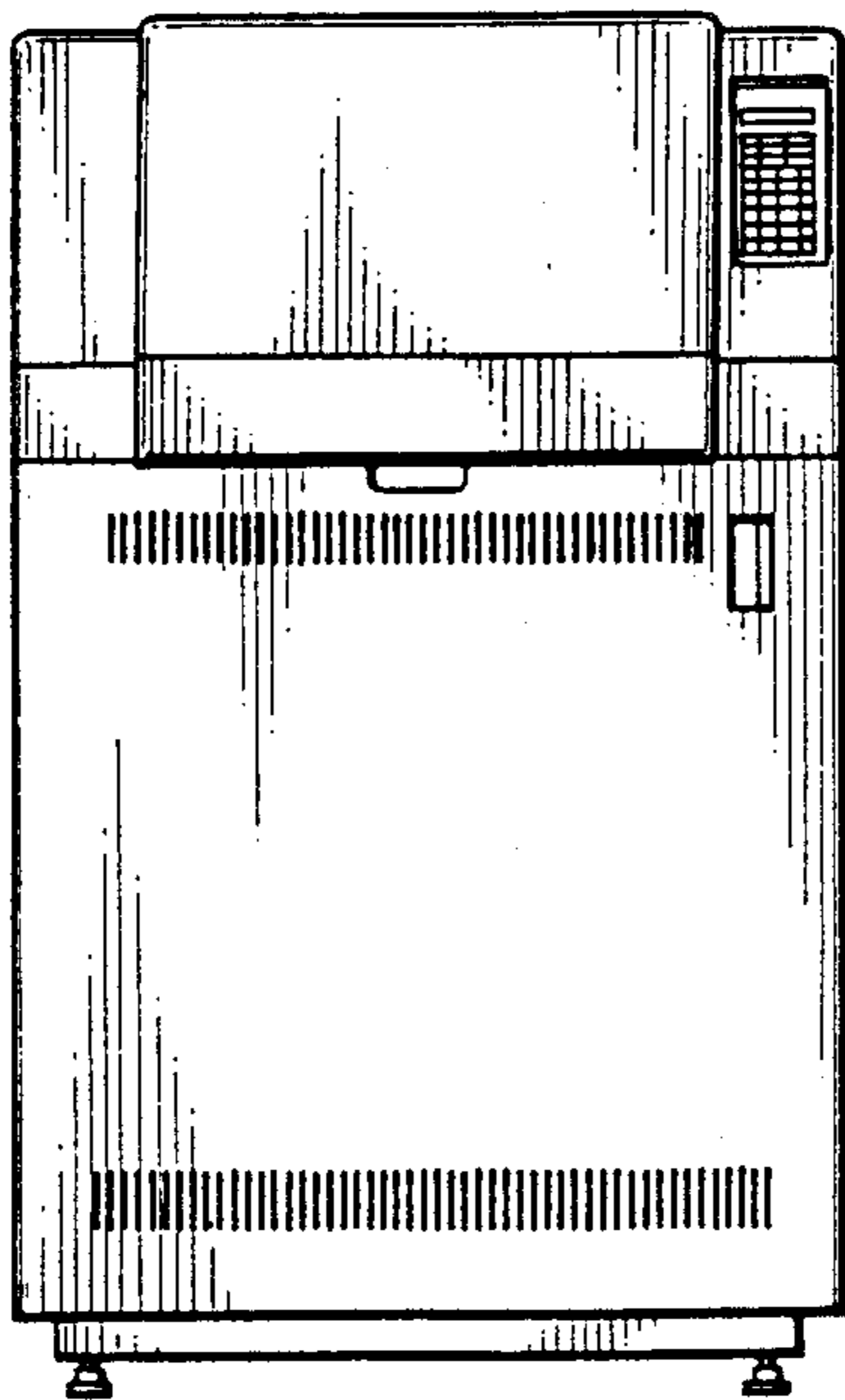

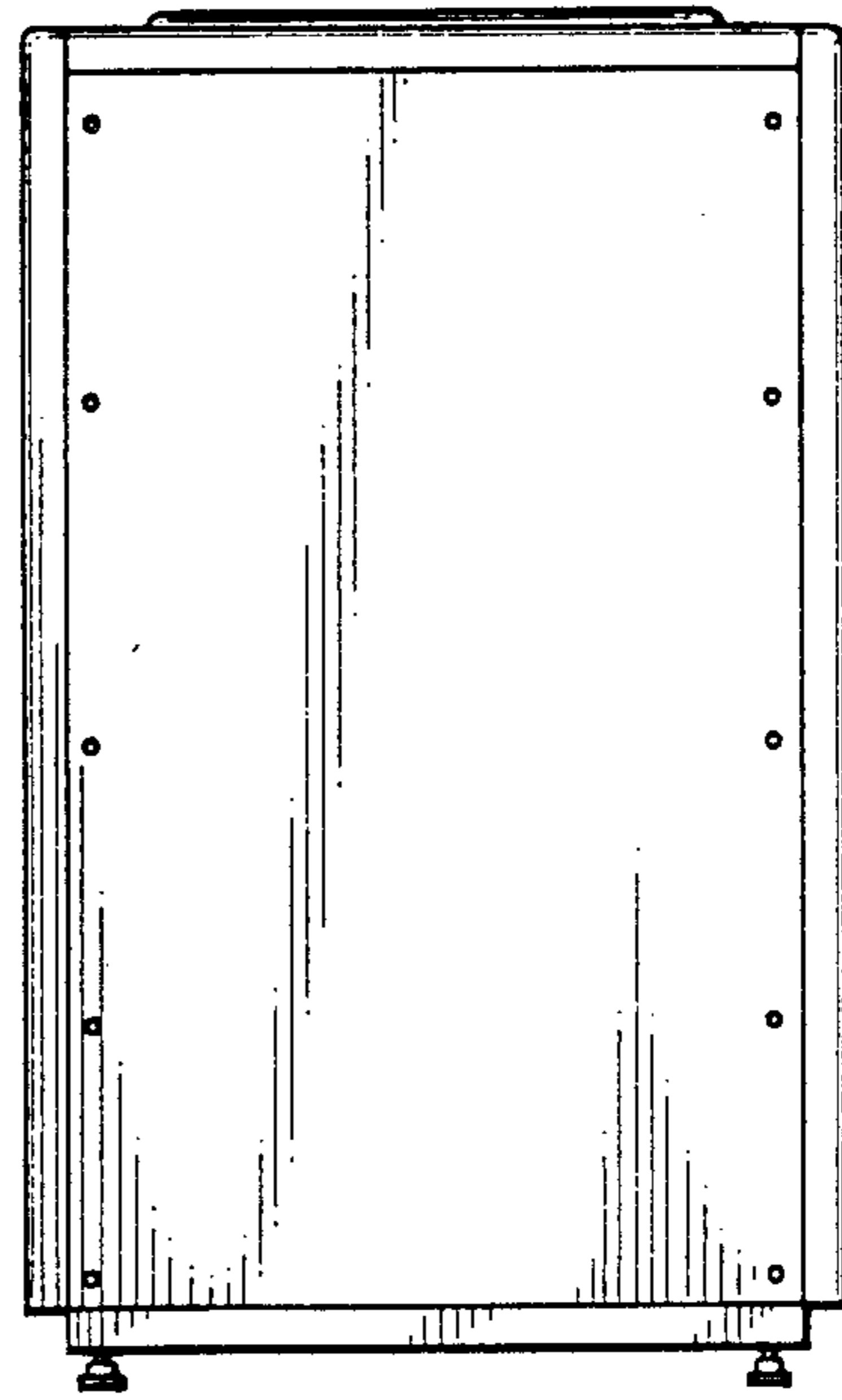

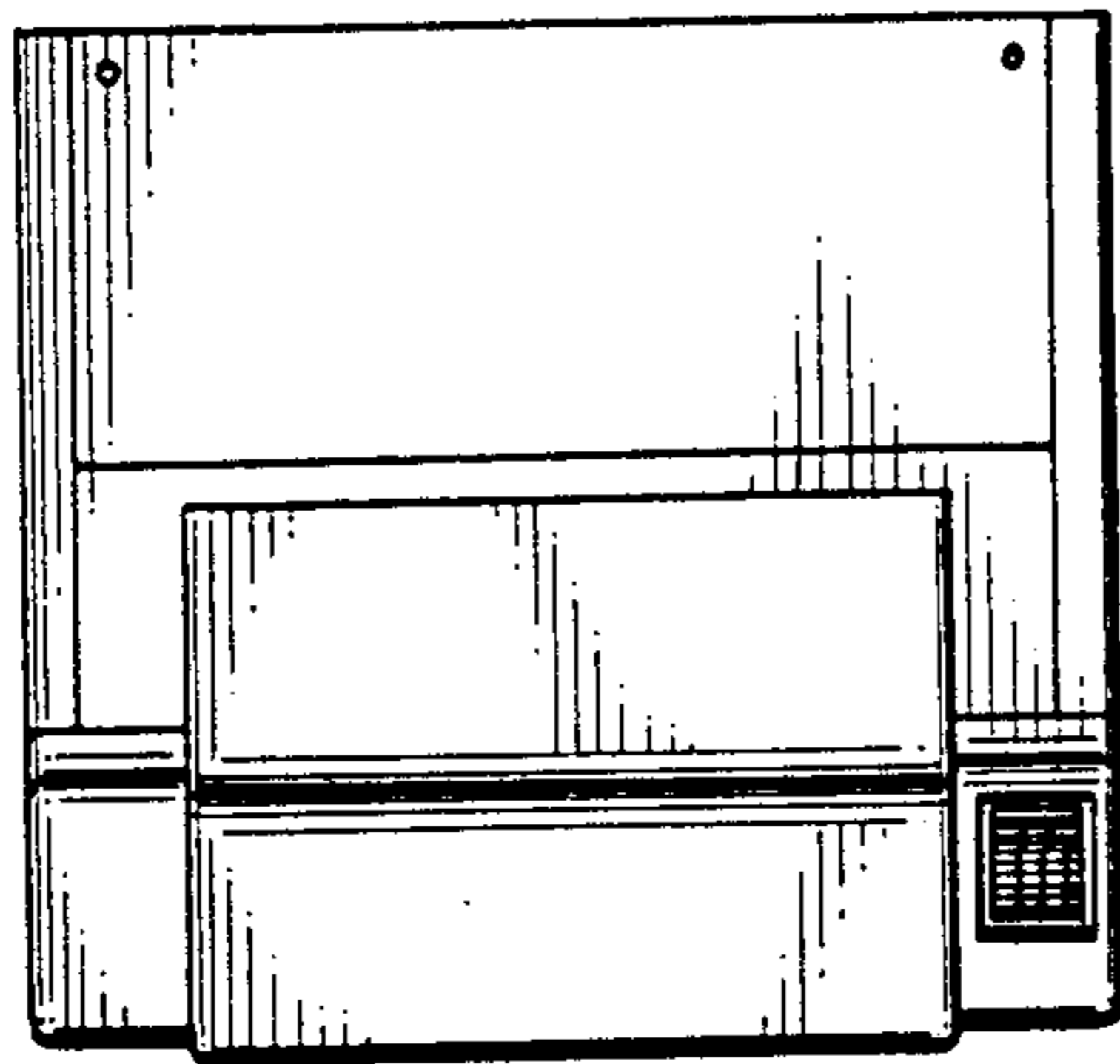

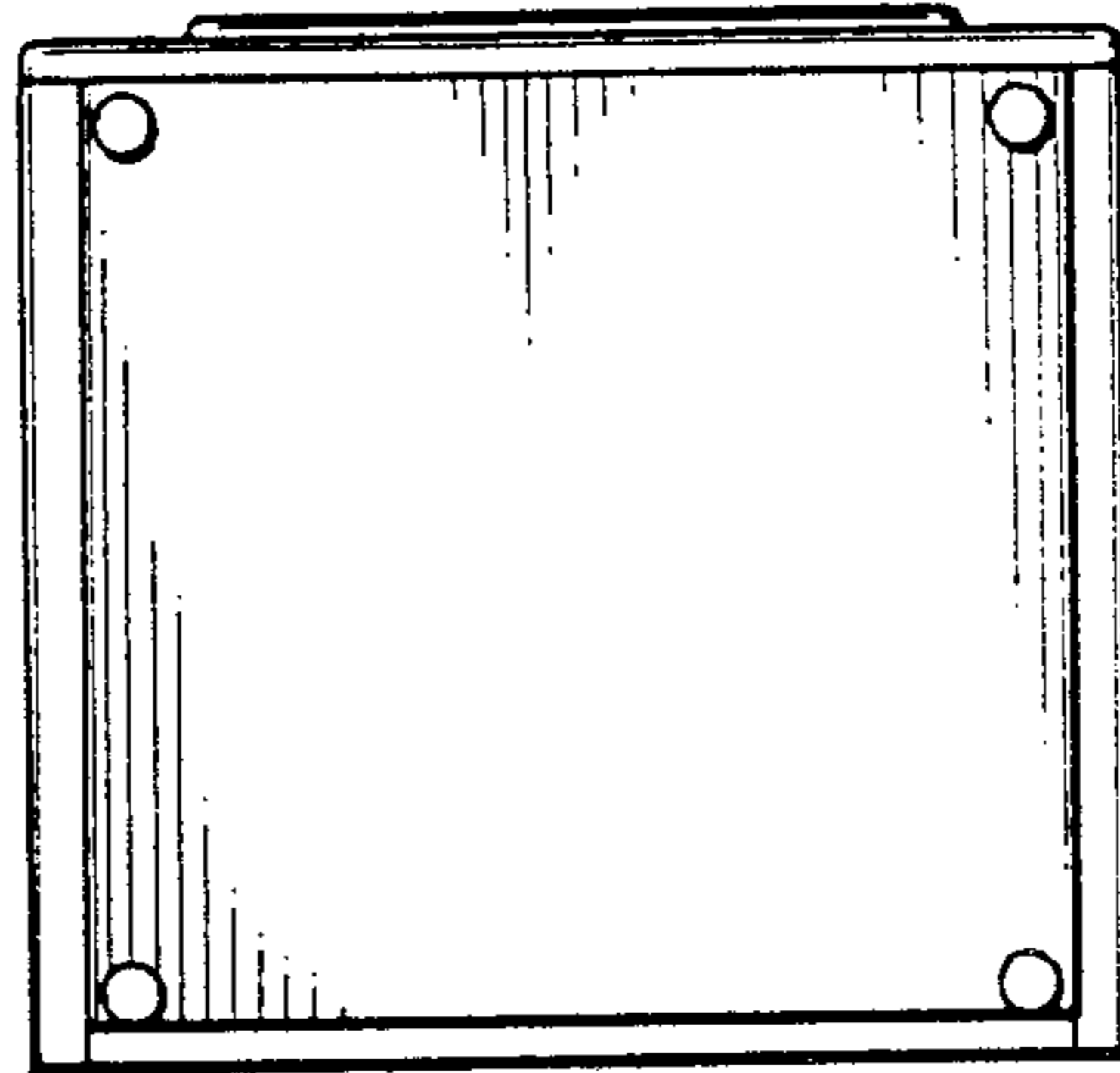

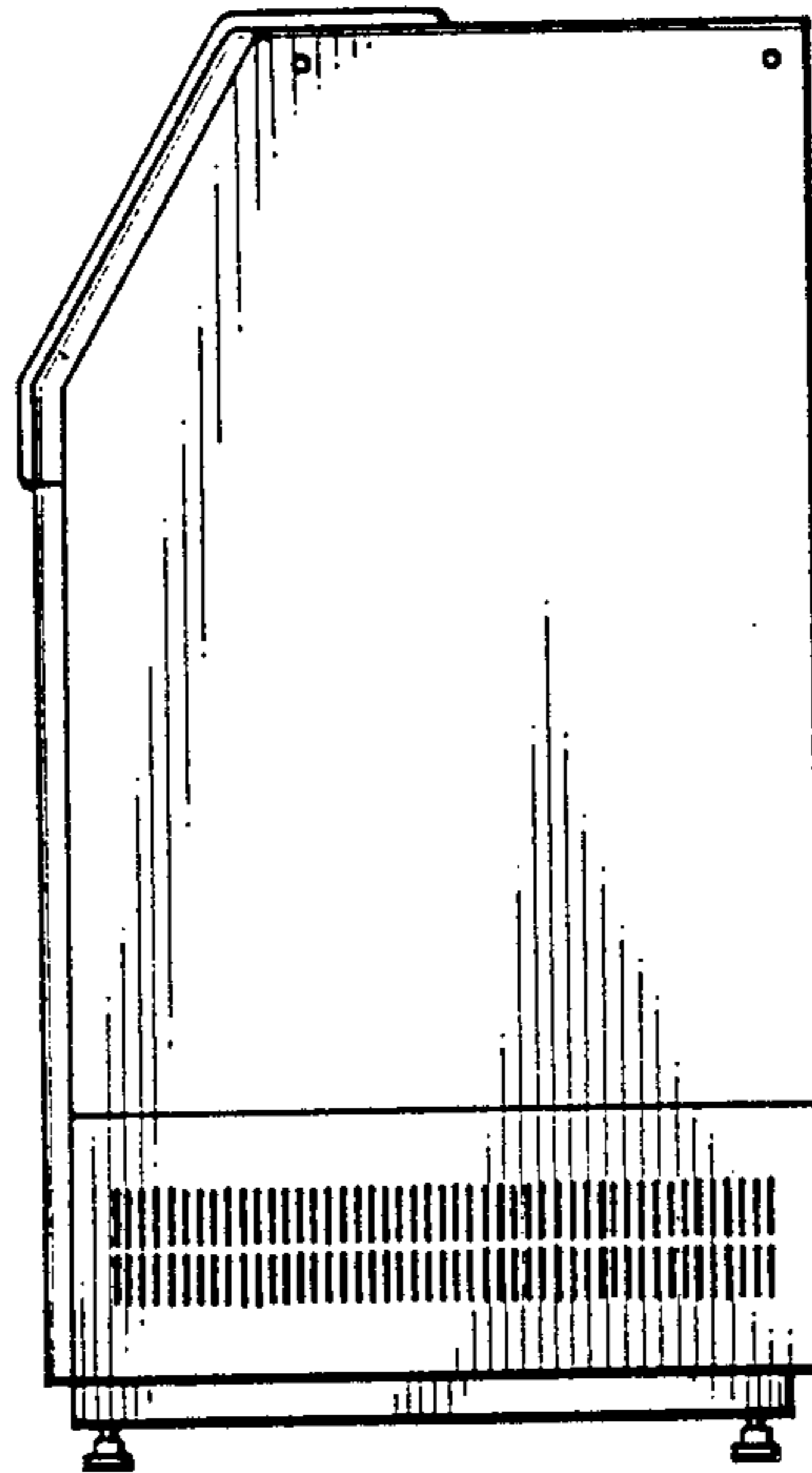

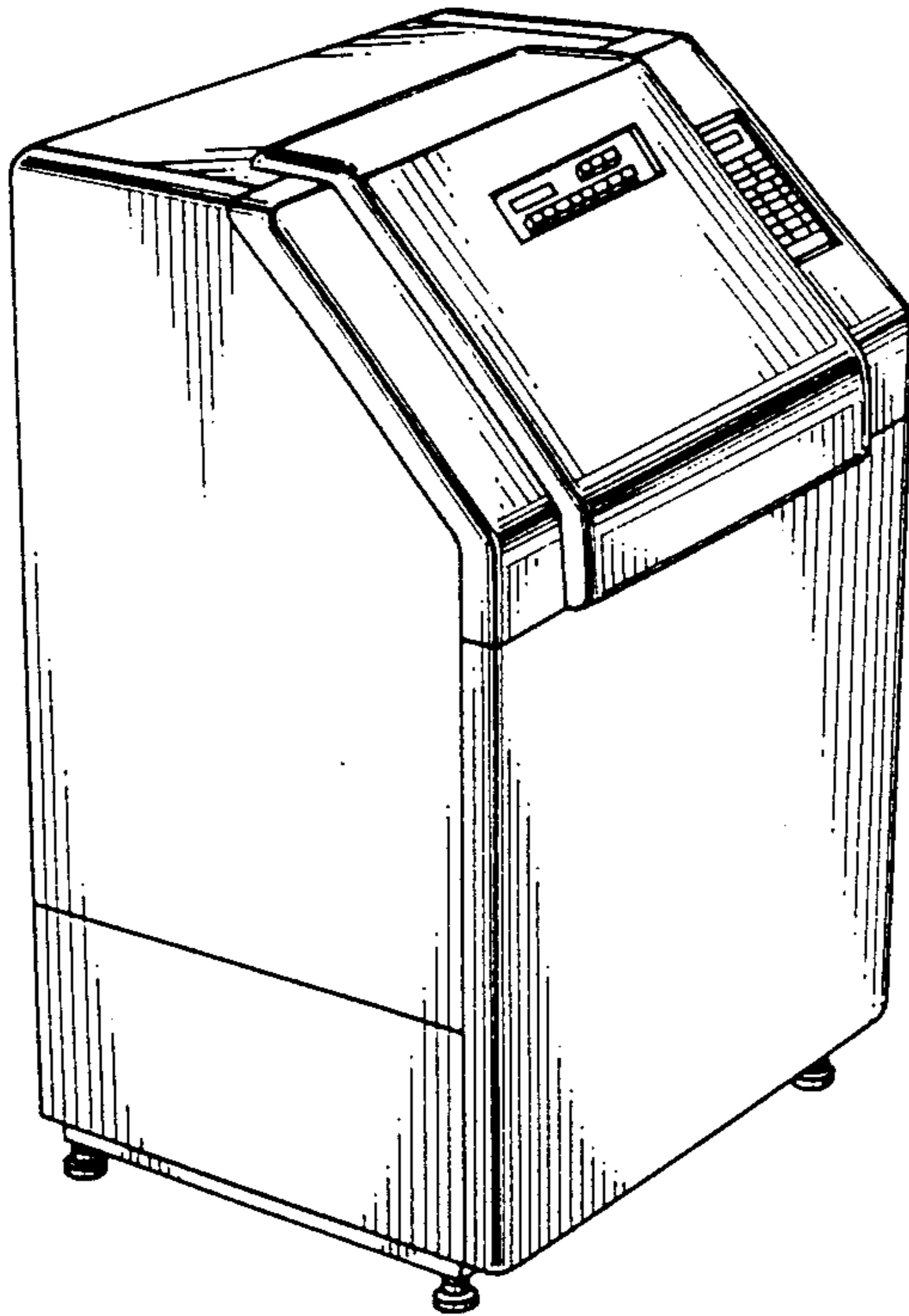

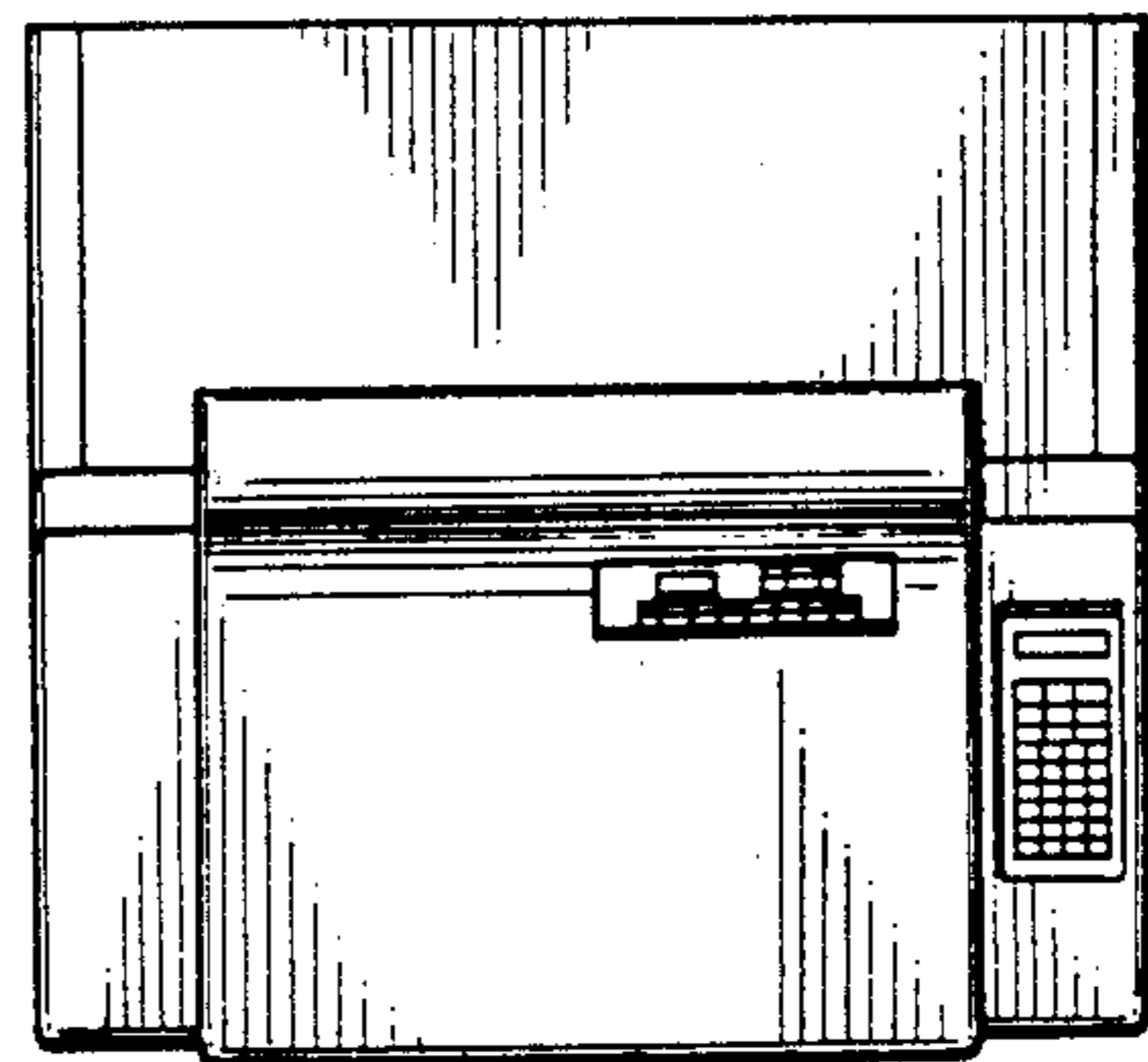

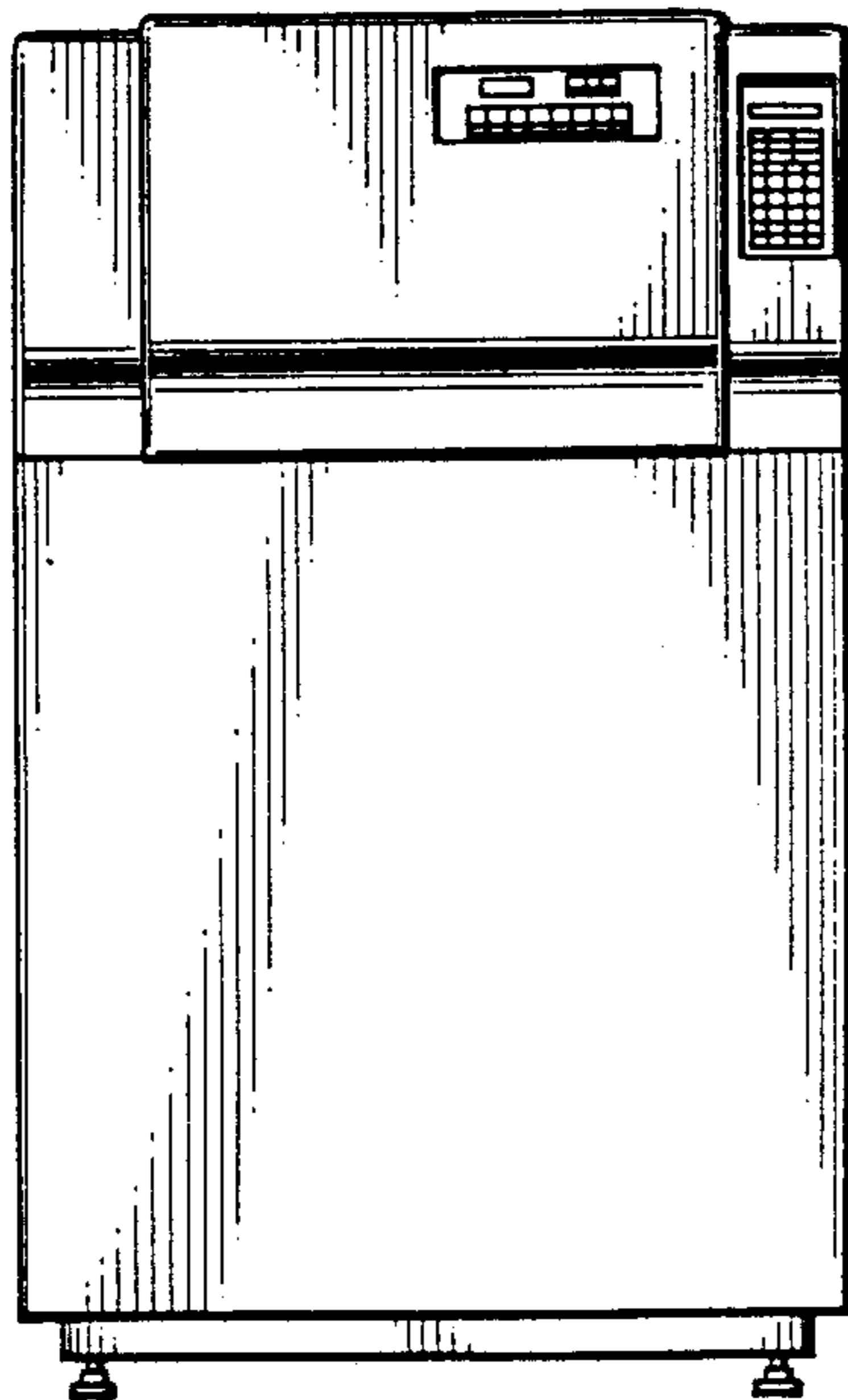

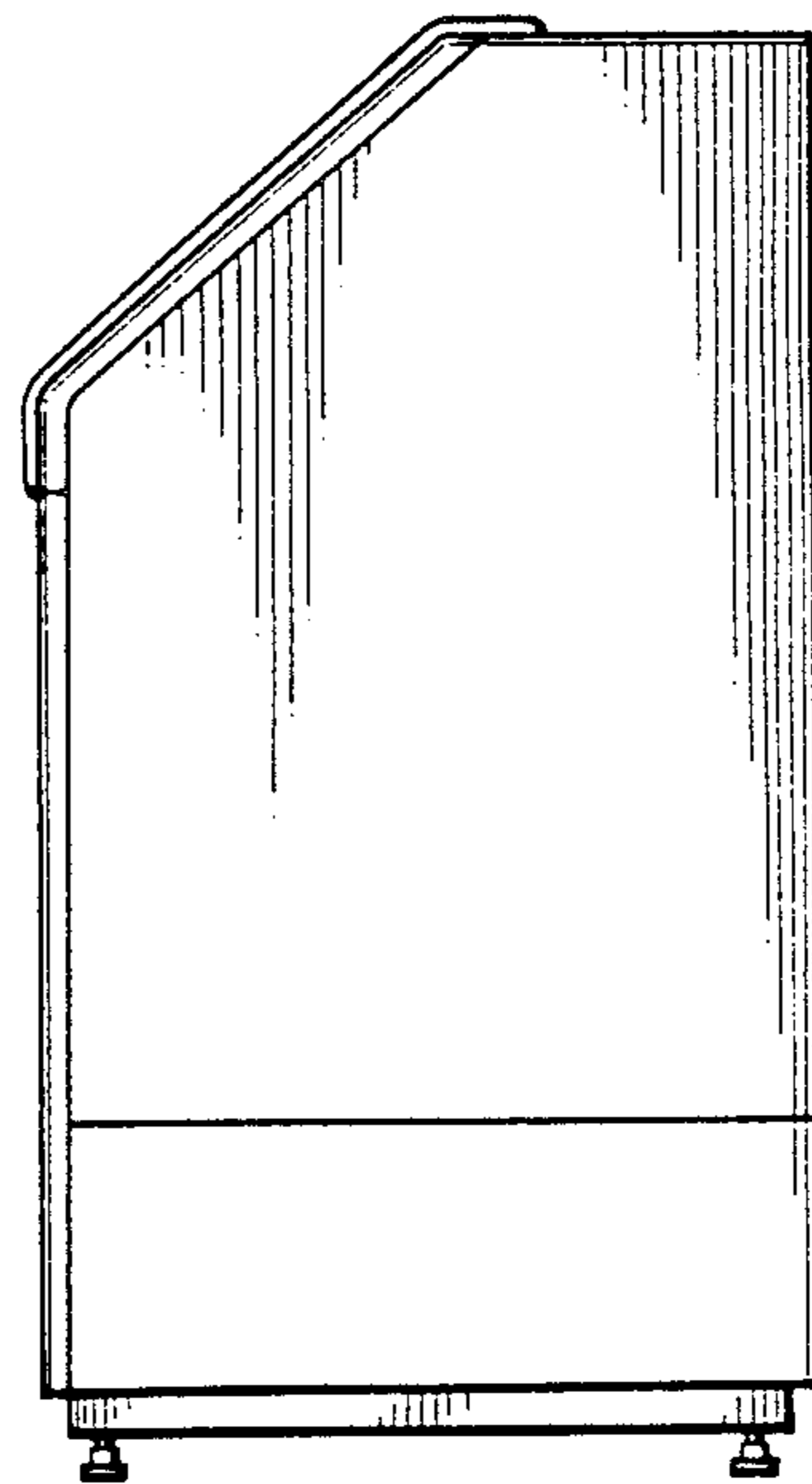

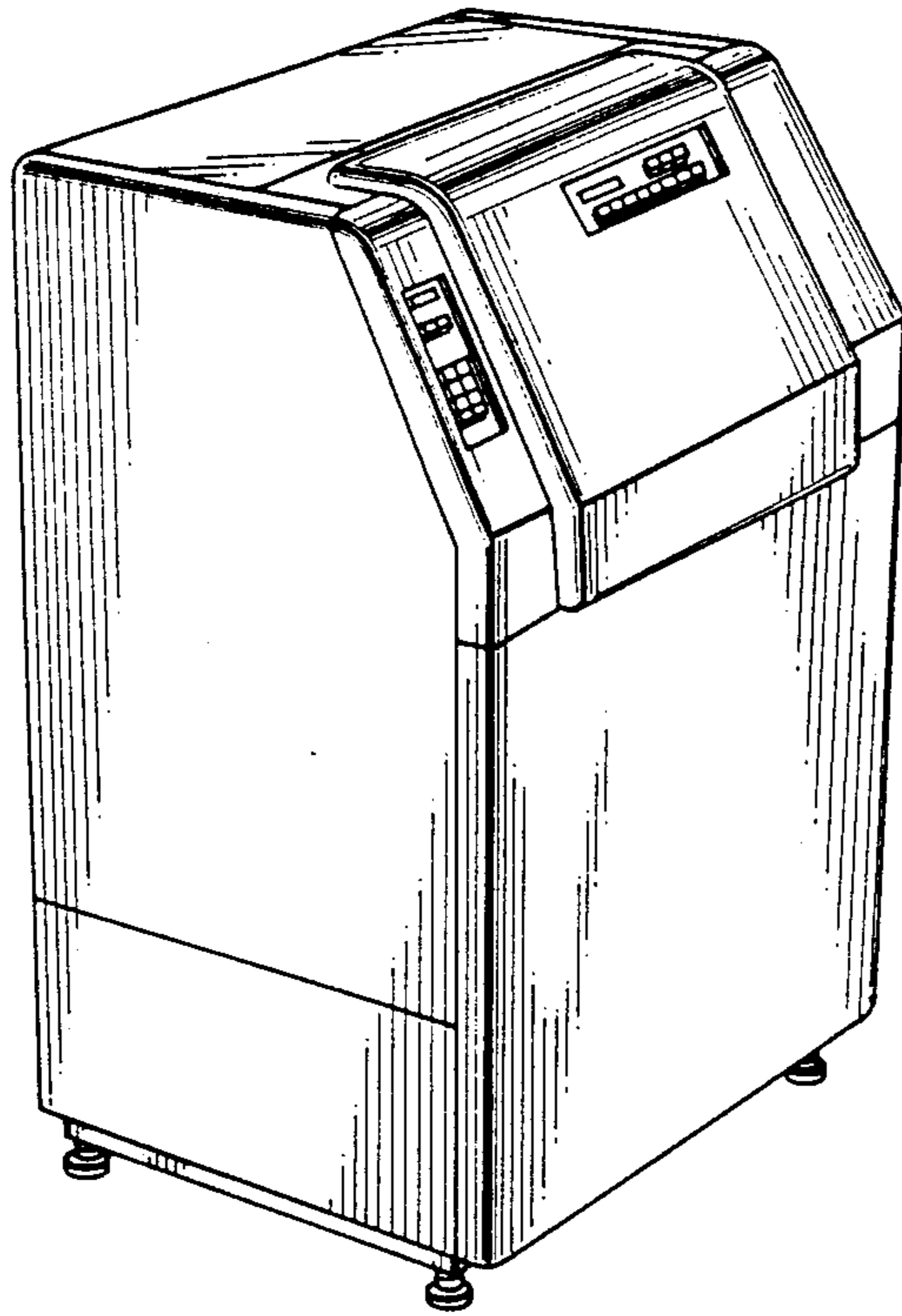

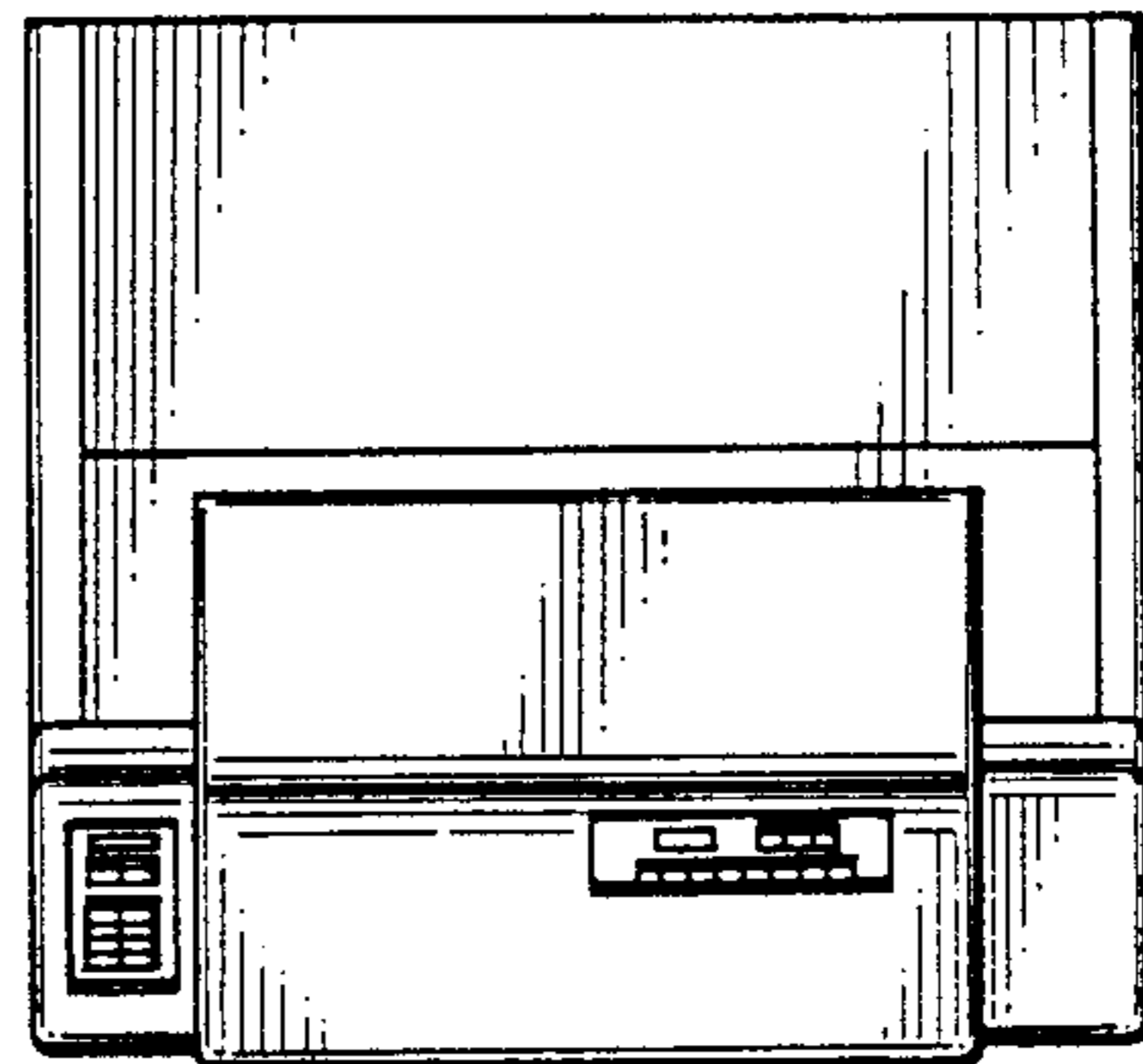

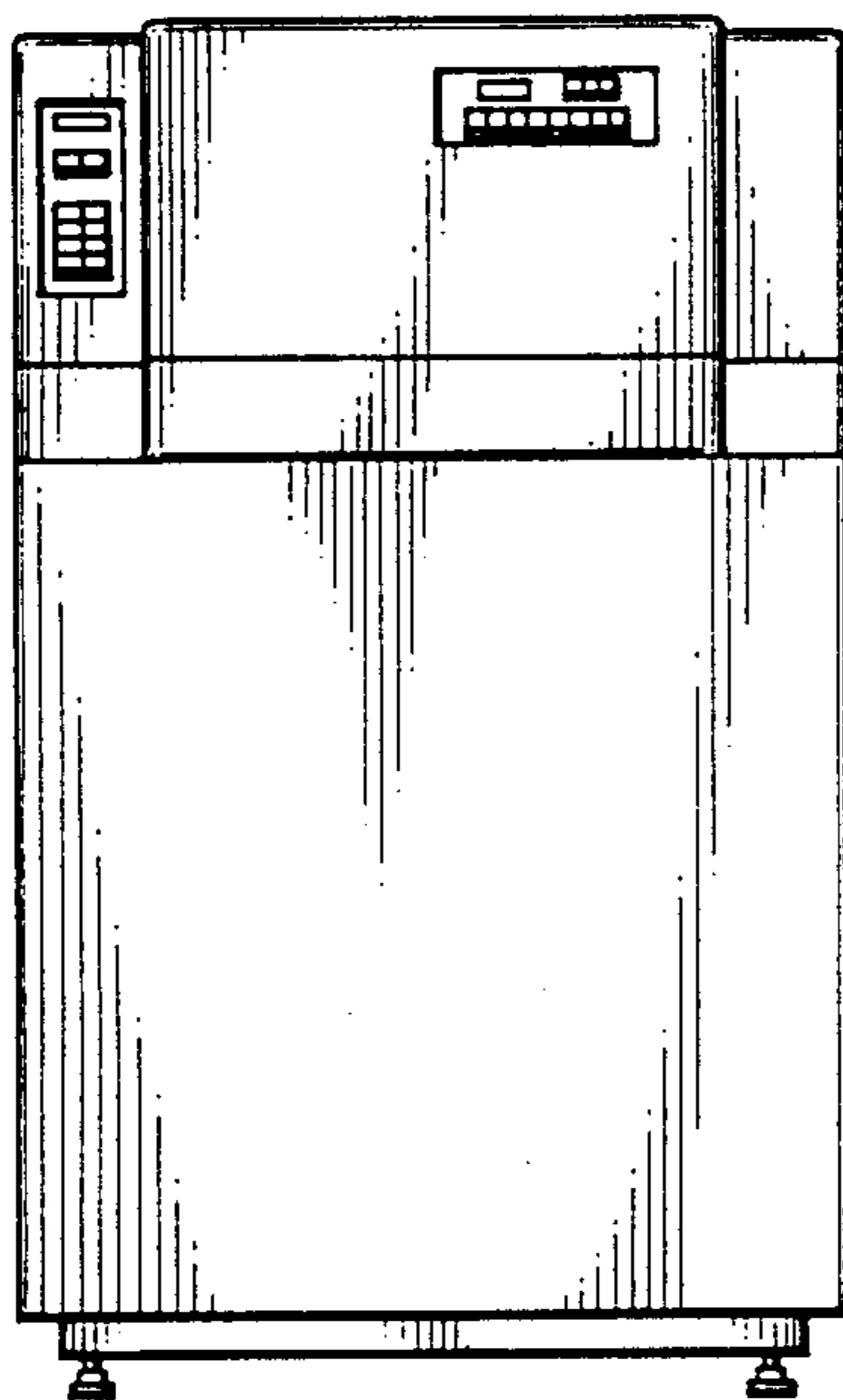

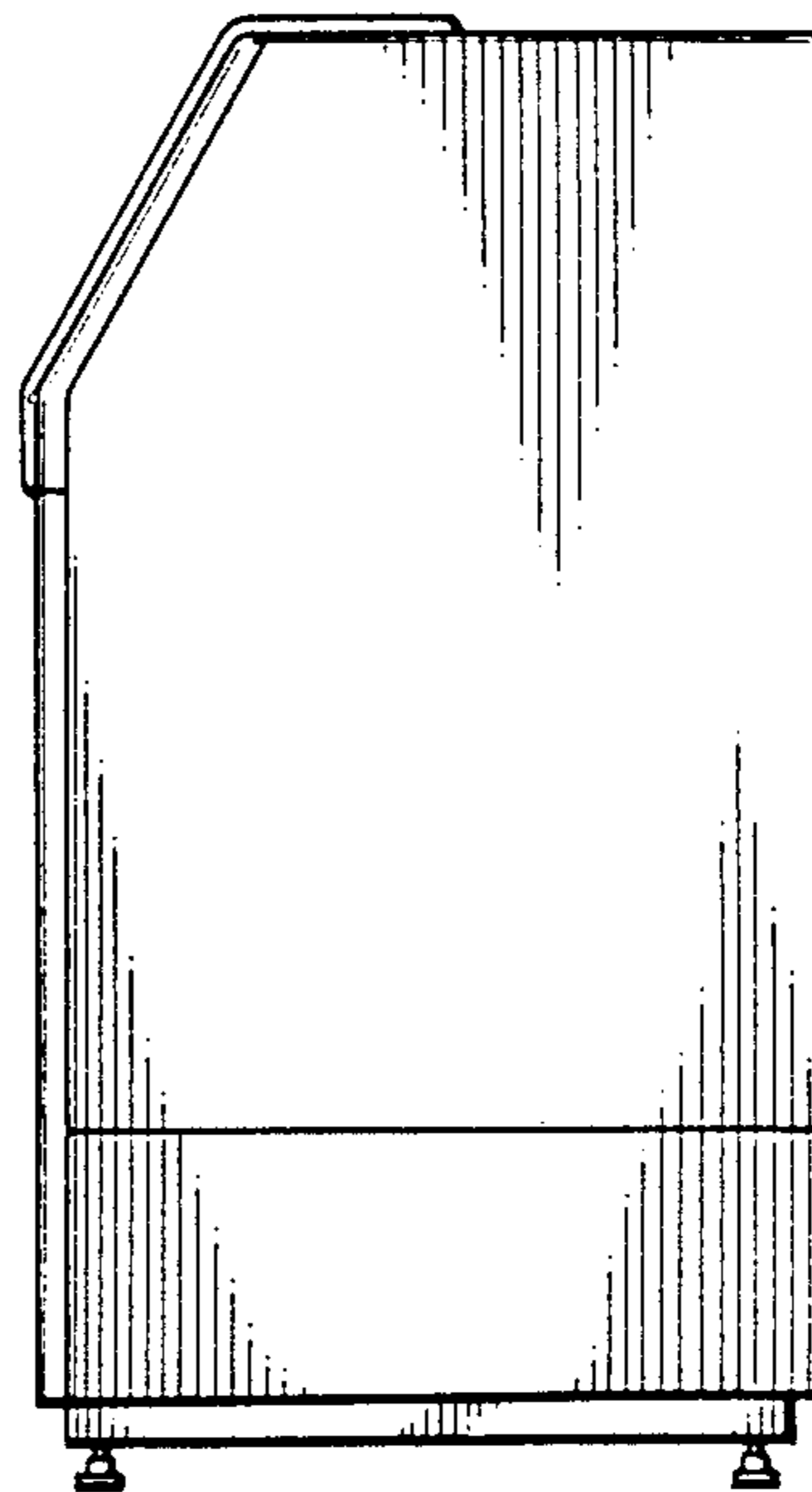

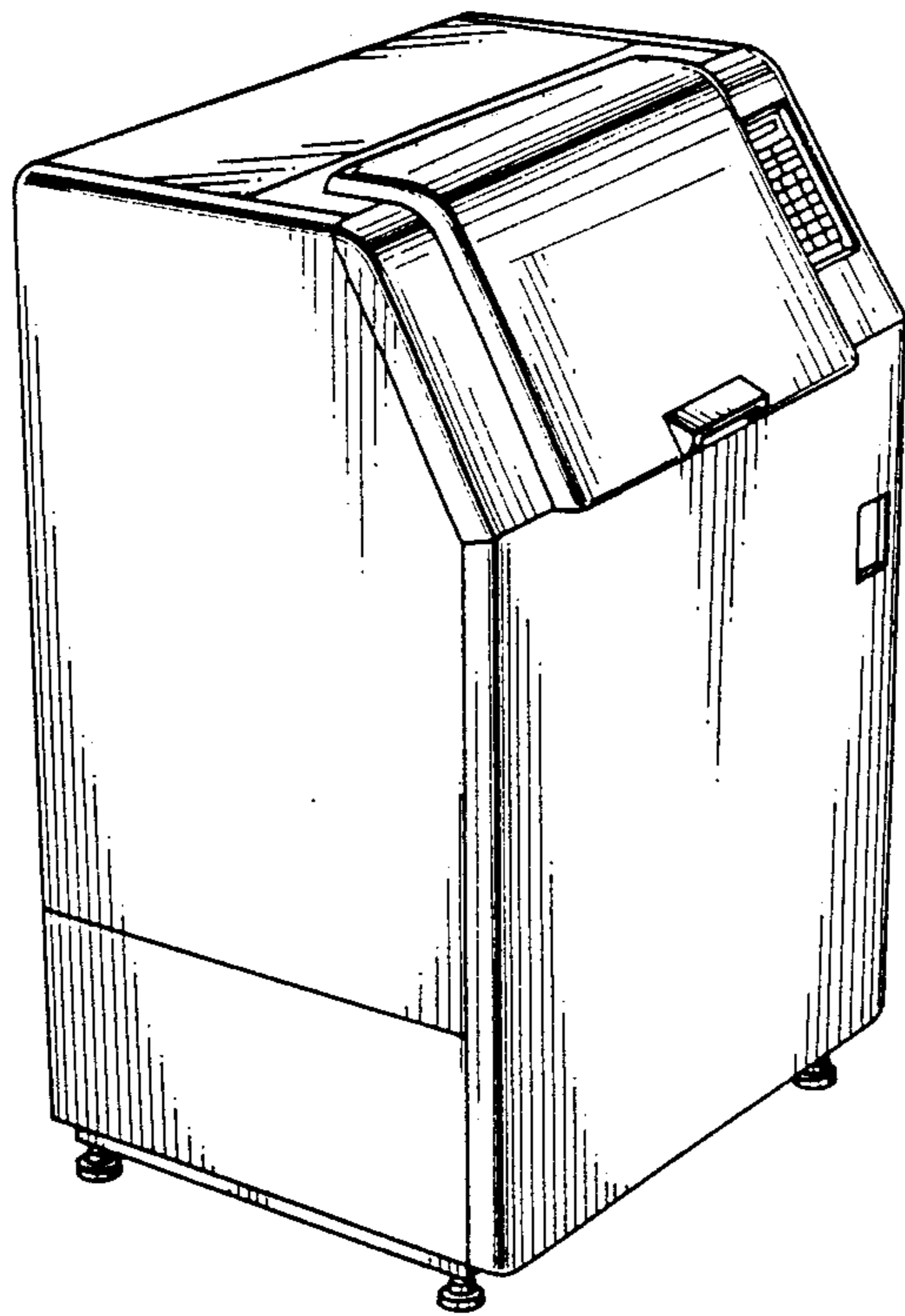

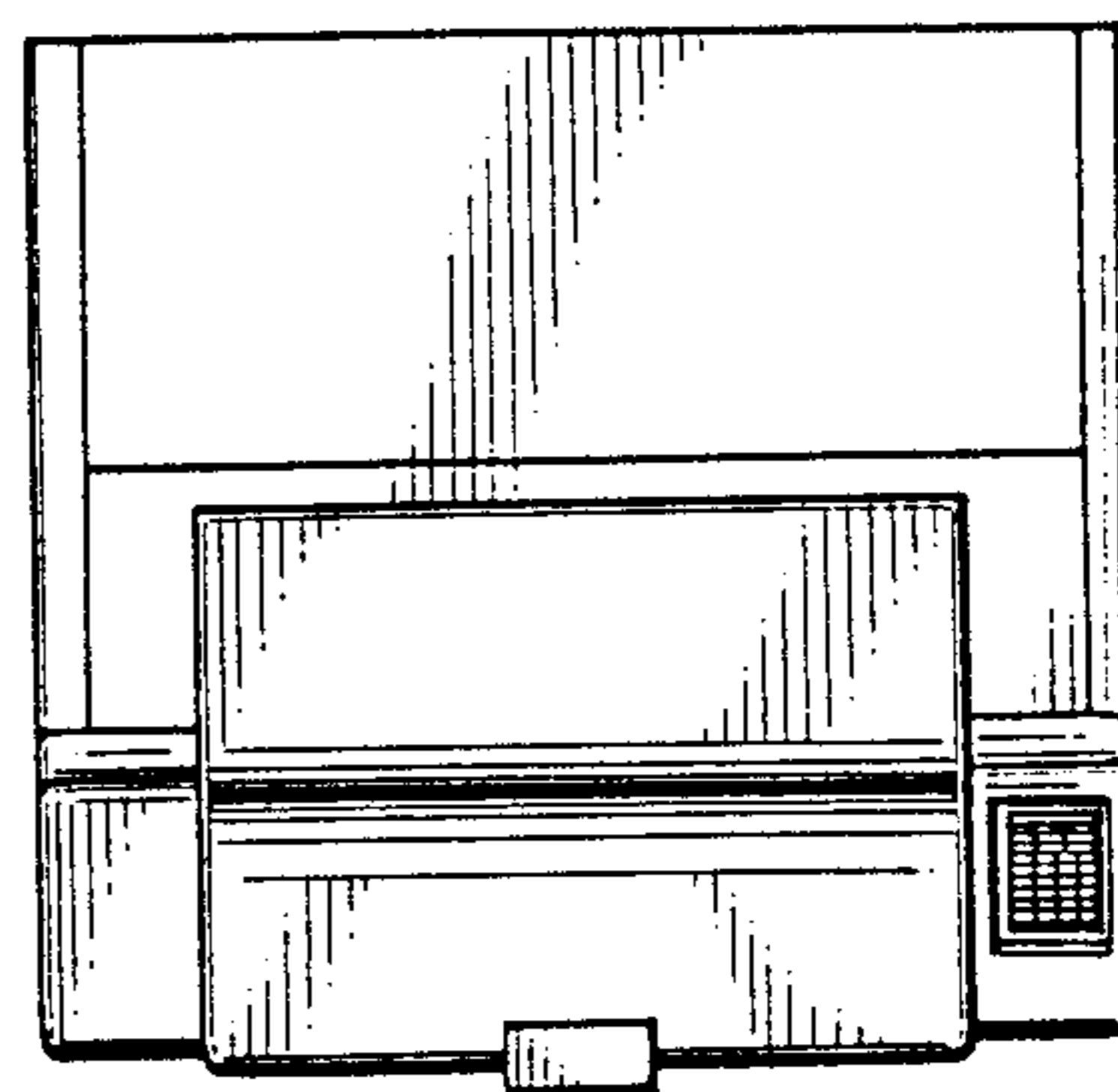

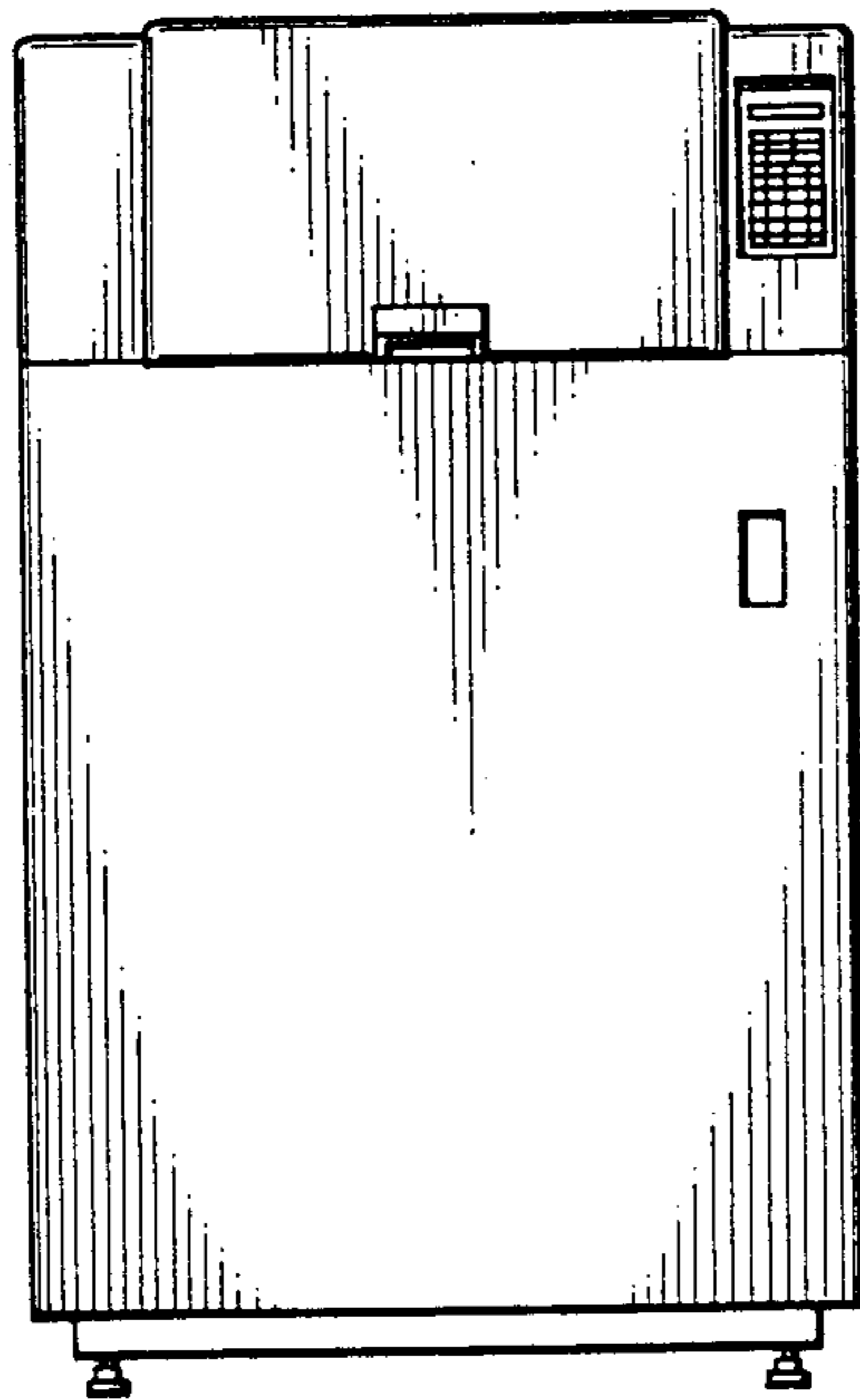
