The ornamental design for a furniture support unit, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a furniture support unit showing my new design in the form of a TV/VCR stand;

FIG. 2 is a rear perspective view of the stand of FIG. 1; FIG. 3 is a front elevational view of the stand of FIG. 1;

FIG. 4 is a side elevational view showing a second embodiment of the stand of FIG. 1;

FIG. 5 is a front elevational view showing a third embodiment of the stand of FIG. 1 in the form of a plant stand;

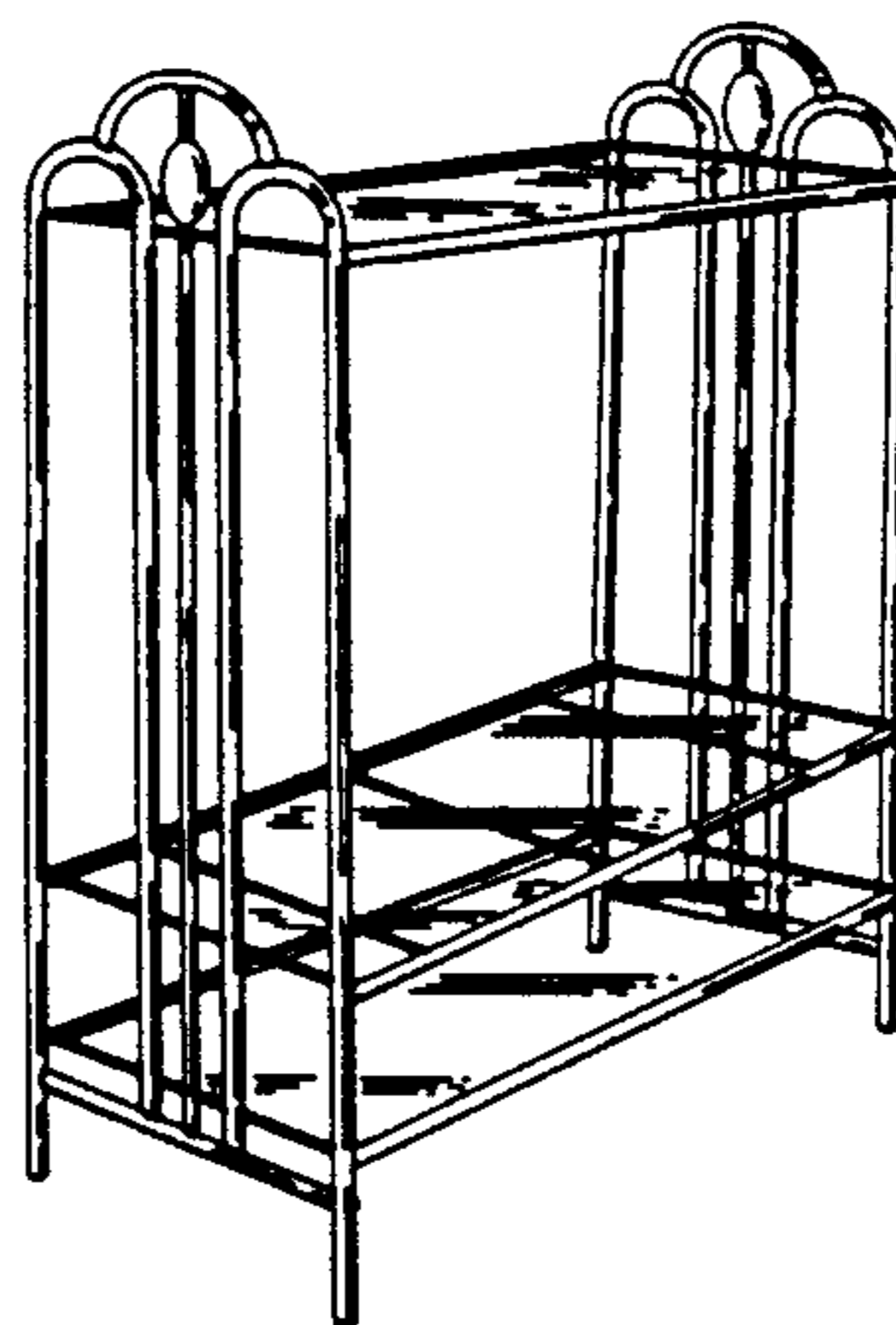
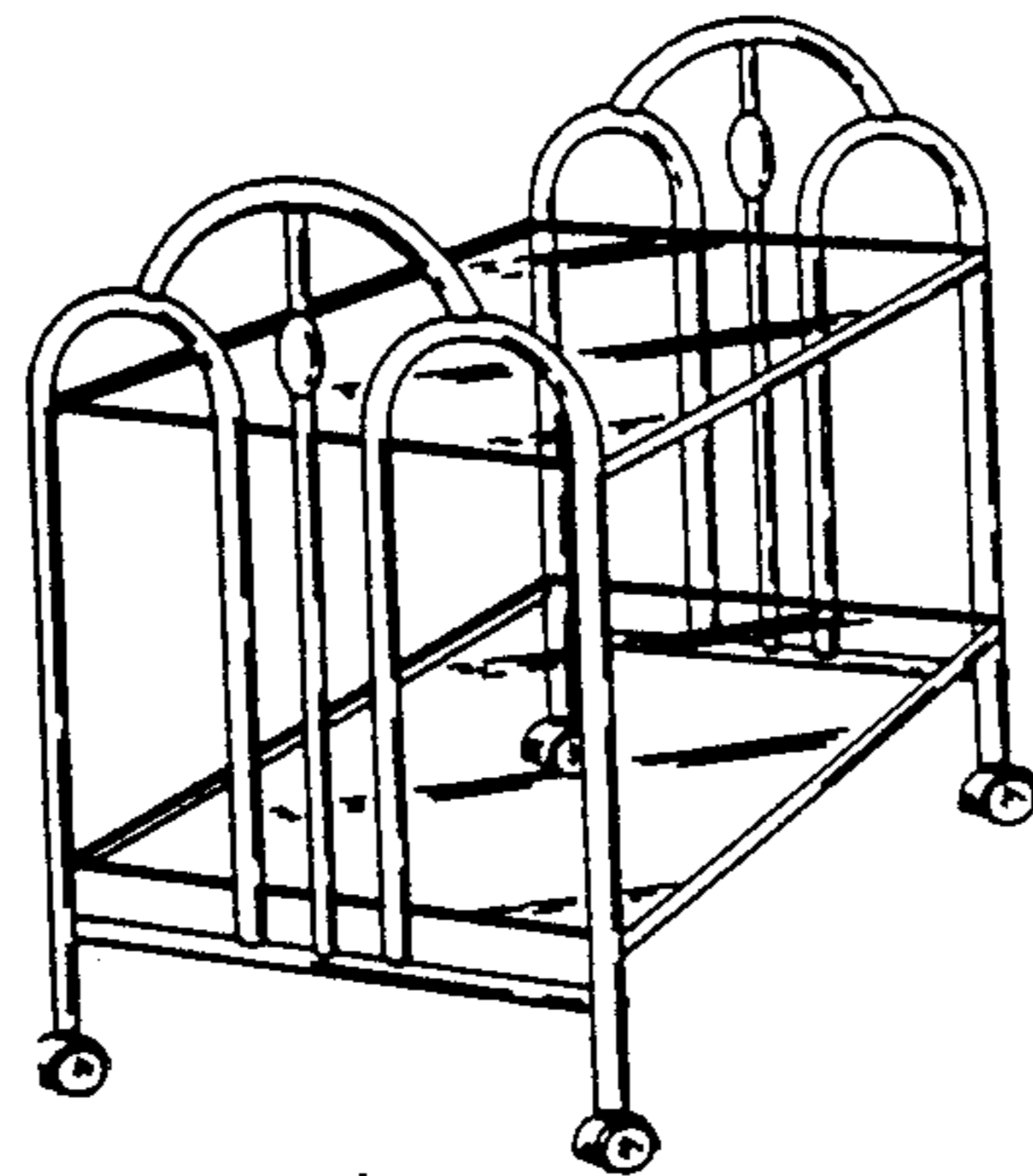
FIG. 6 is a rear perspective view of the stand of FIG. 5; FIG. 7 is a front elevational view of the stand of FIG. 5;

FIG. 12 is a side elevational view of a sixth embodiment of the stand of FIG. 1.



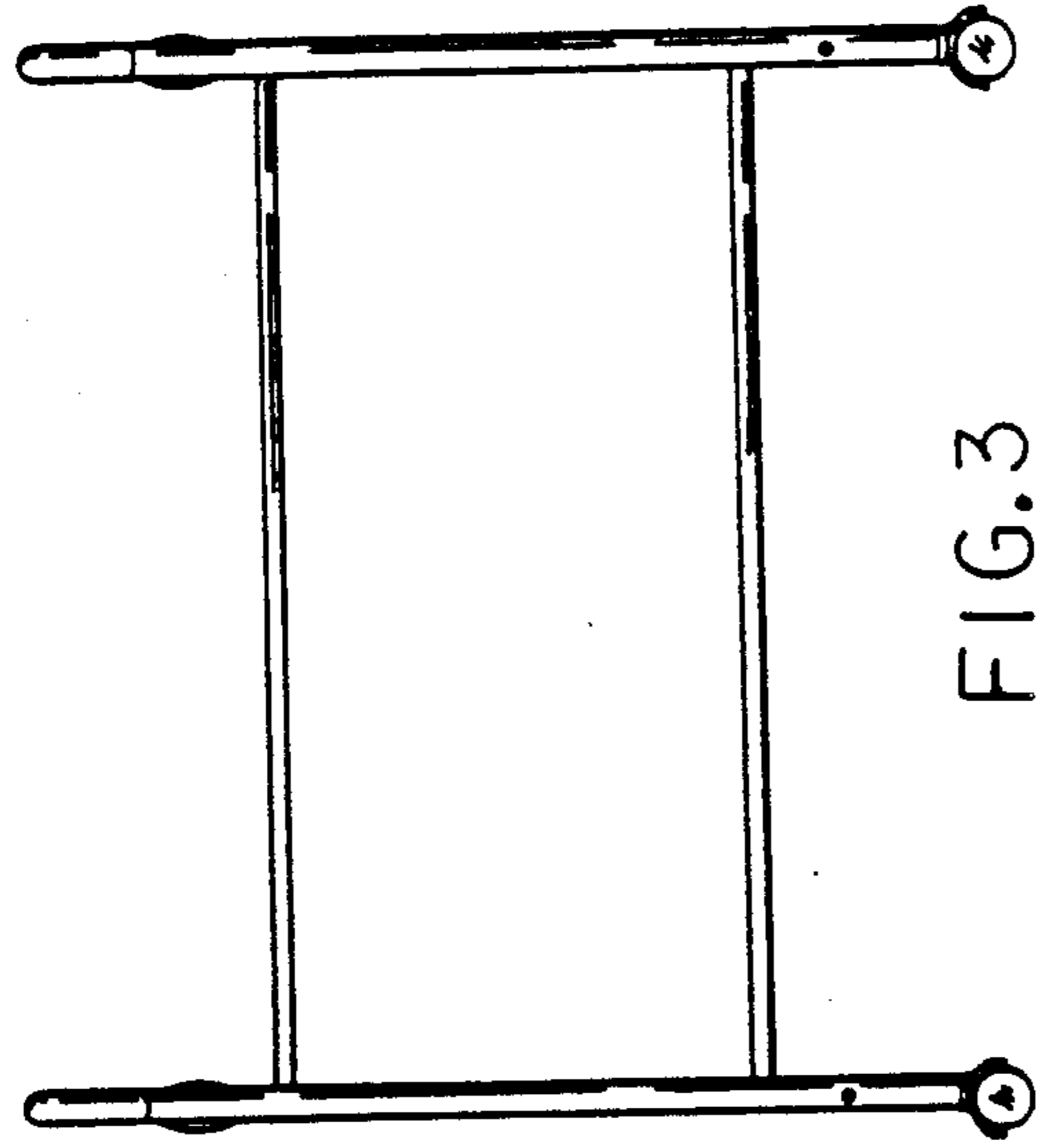

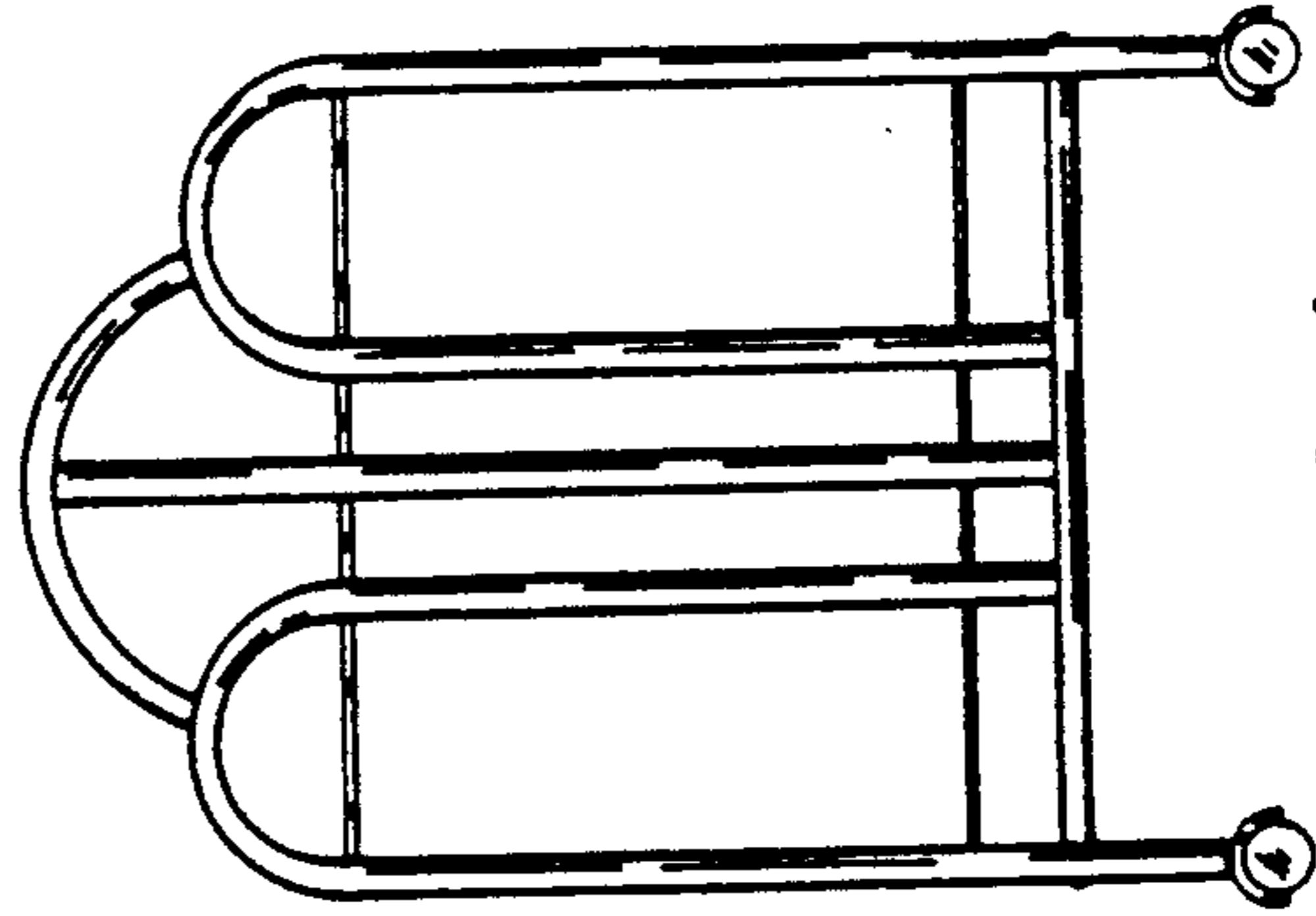

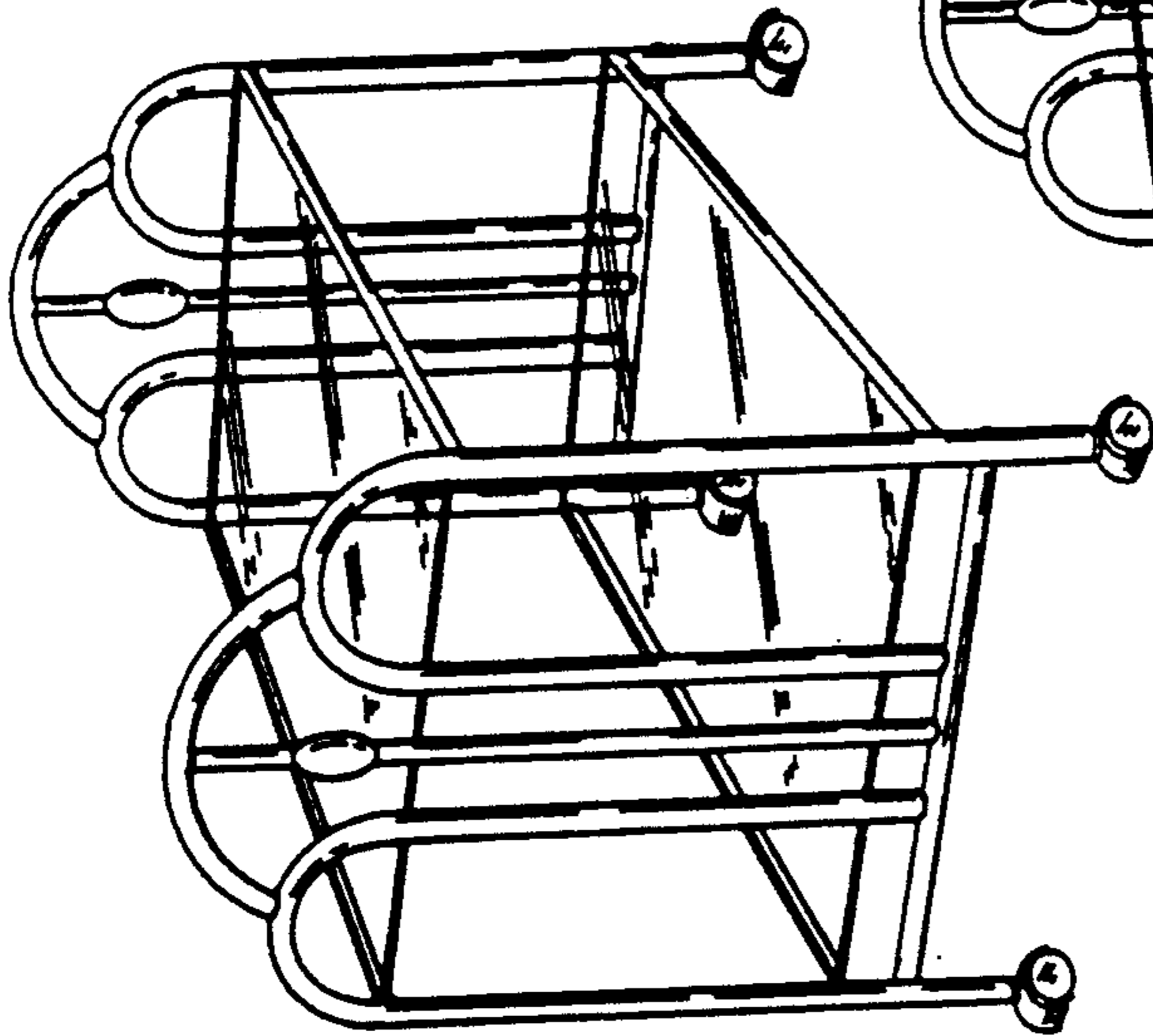

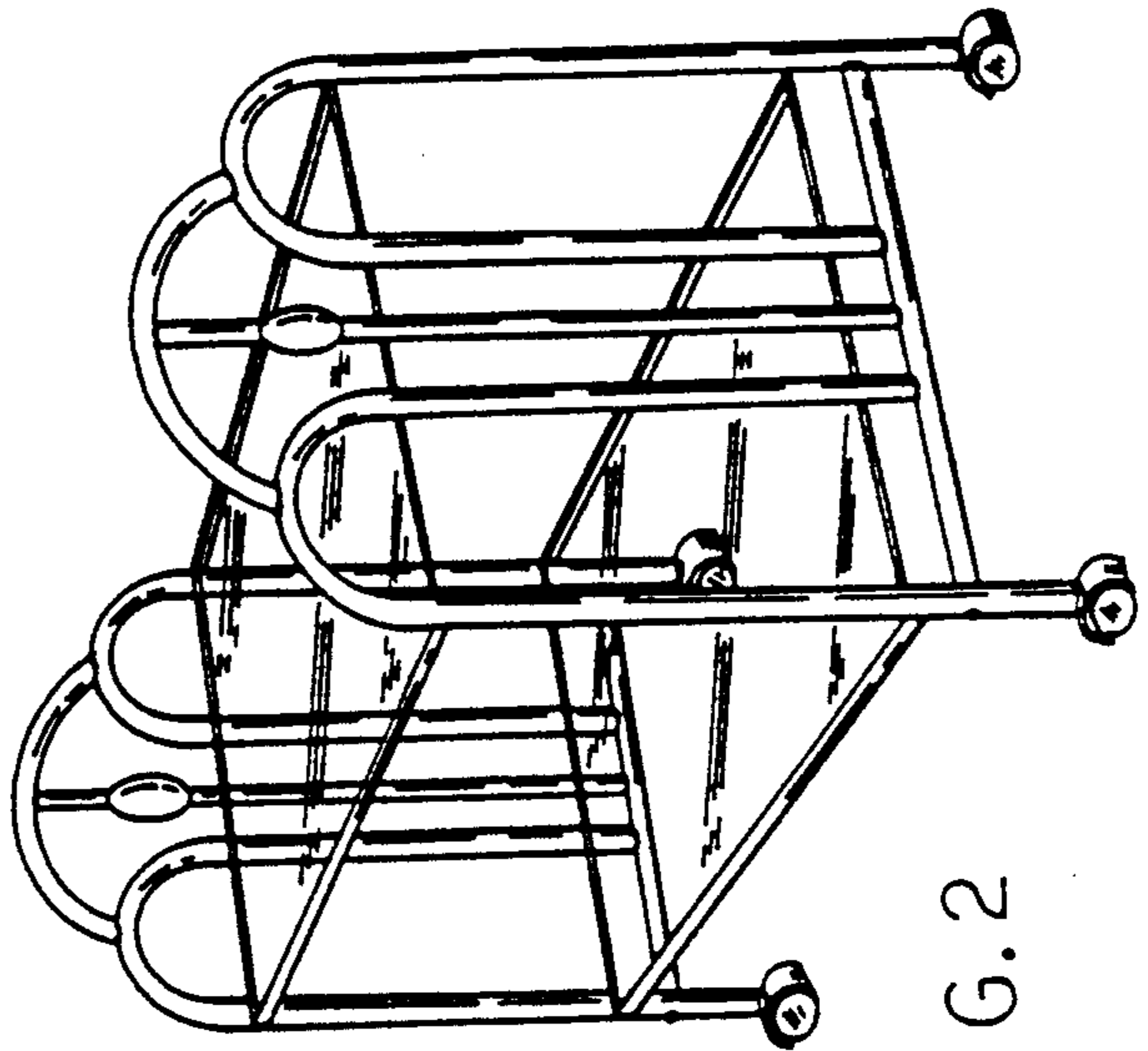

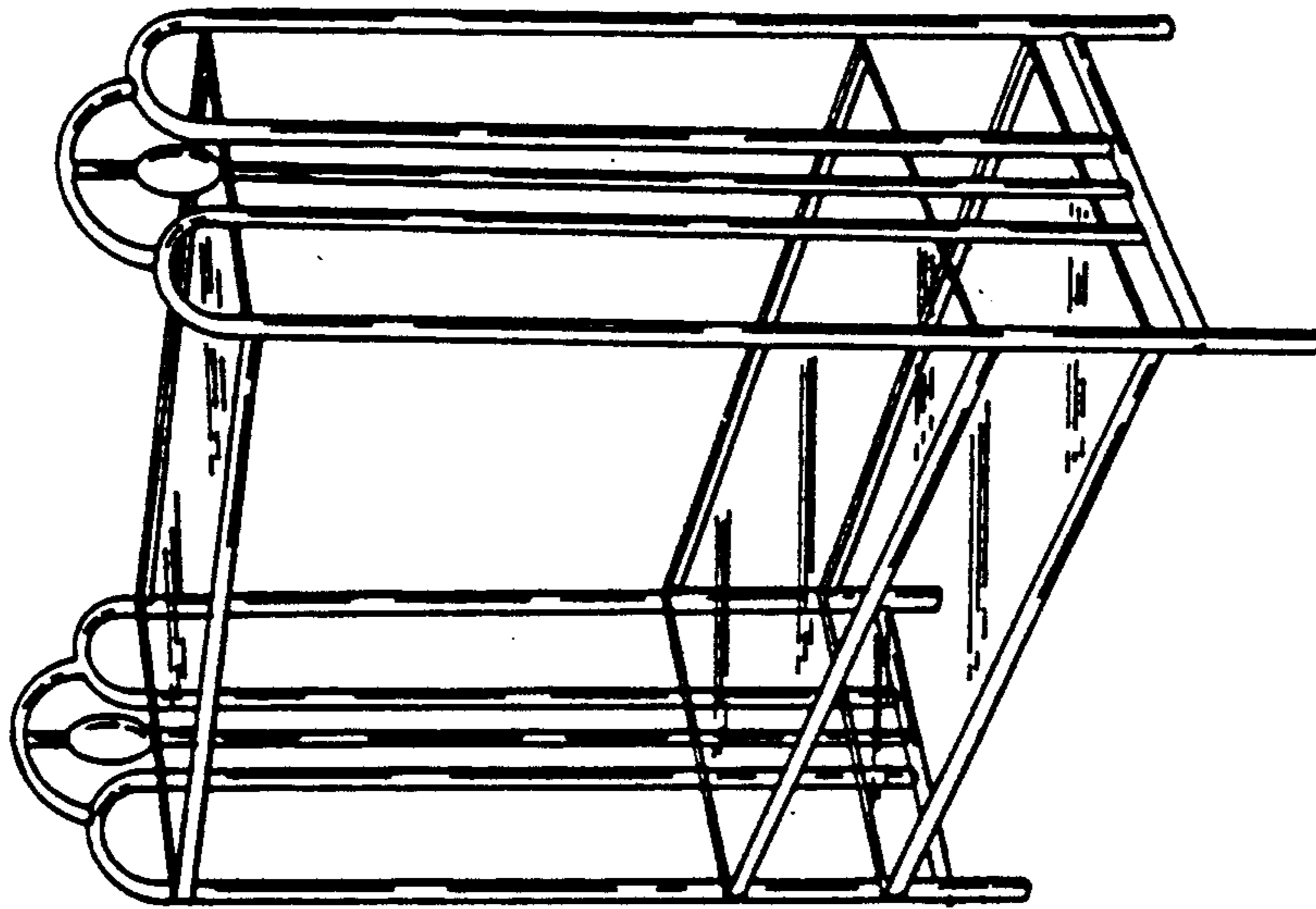

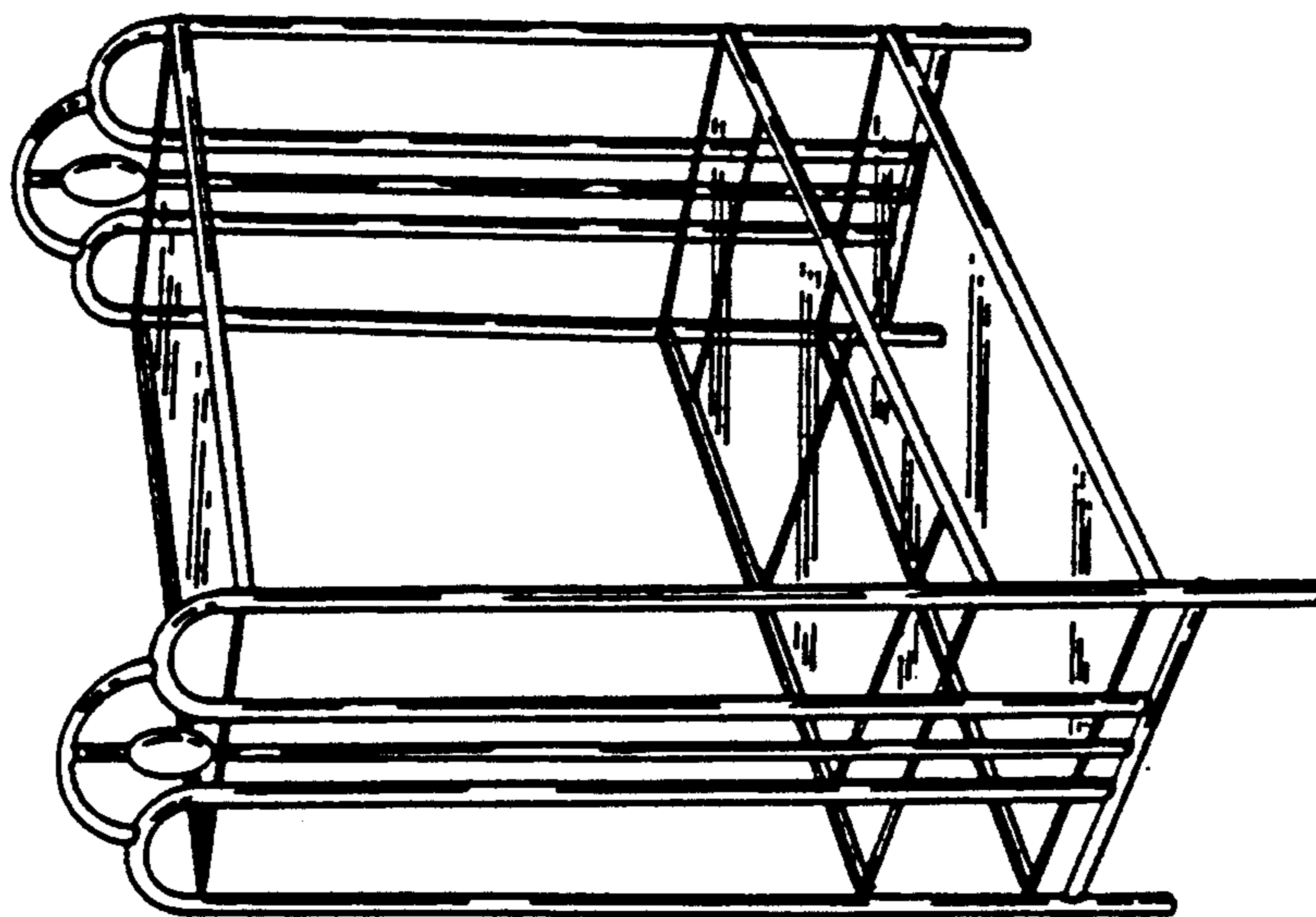

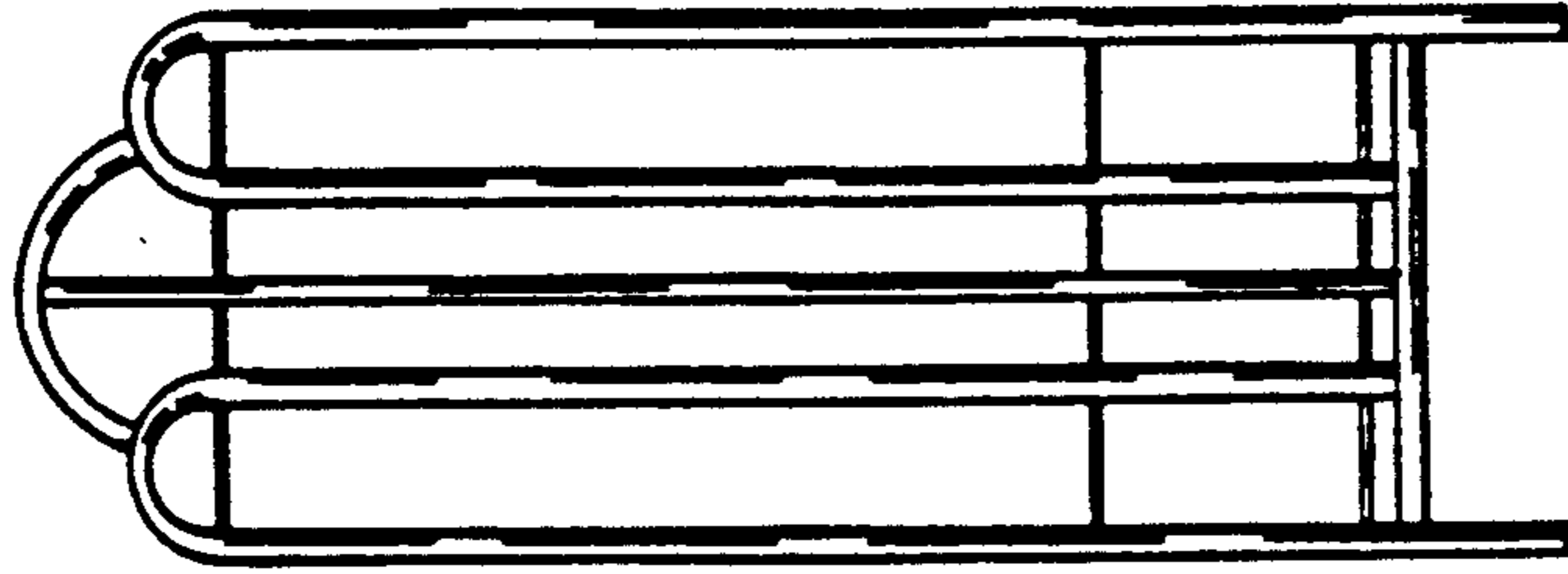

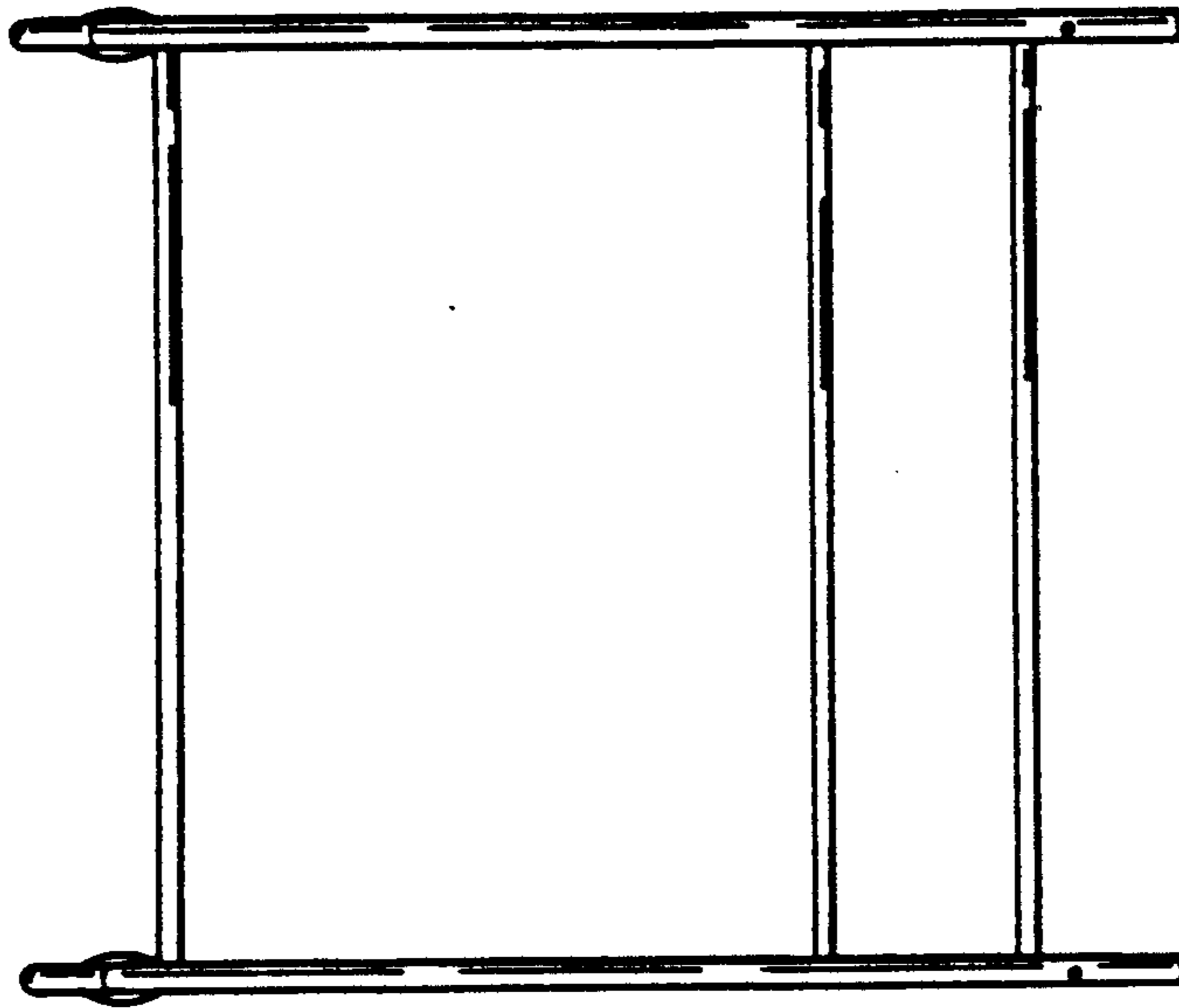

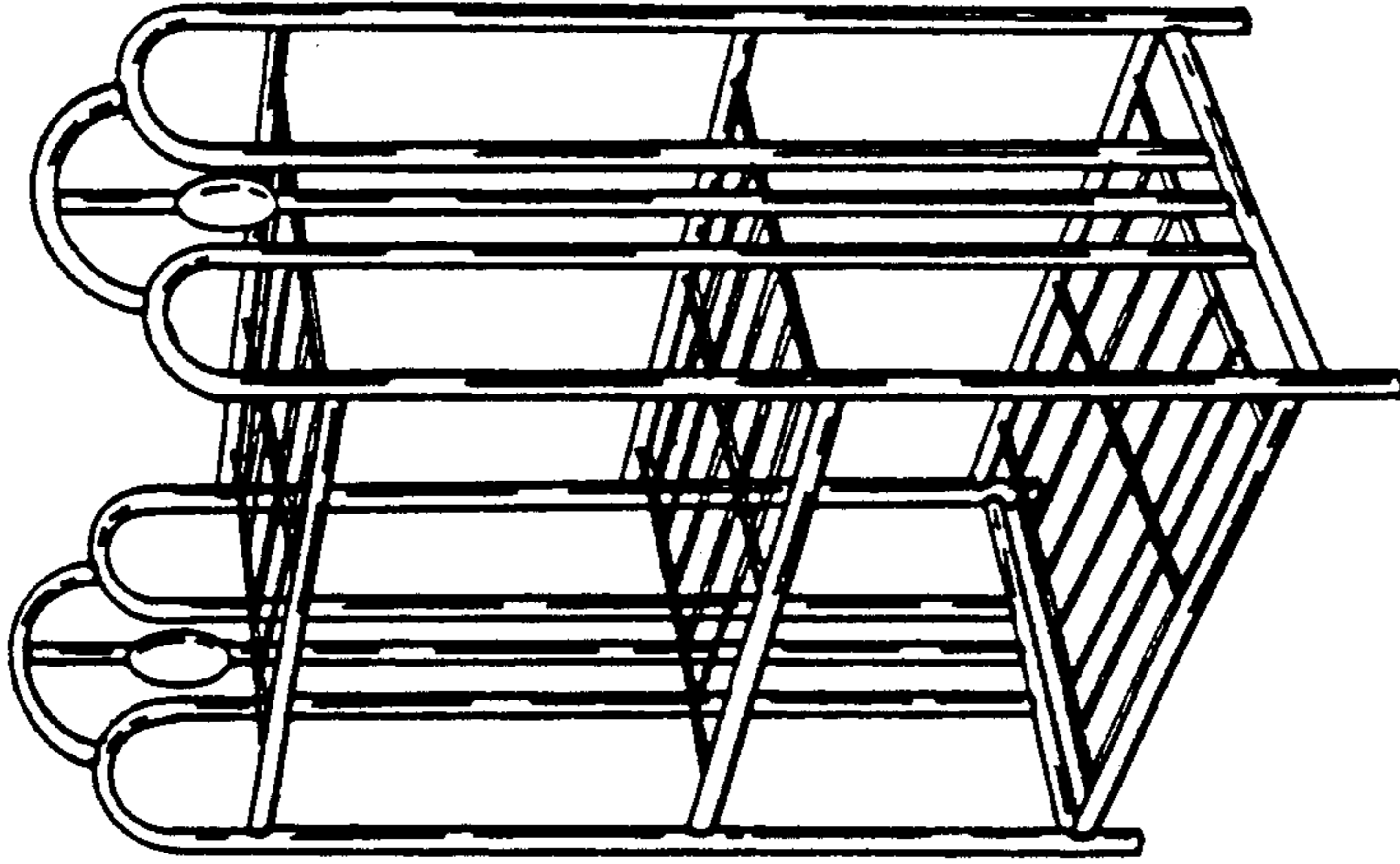

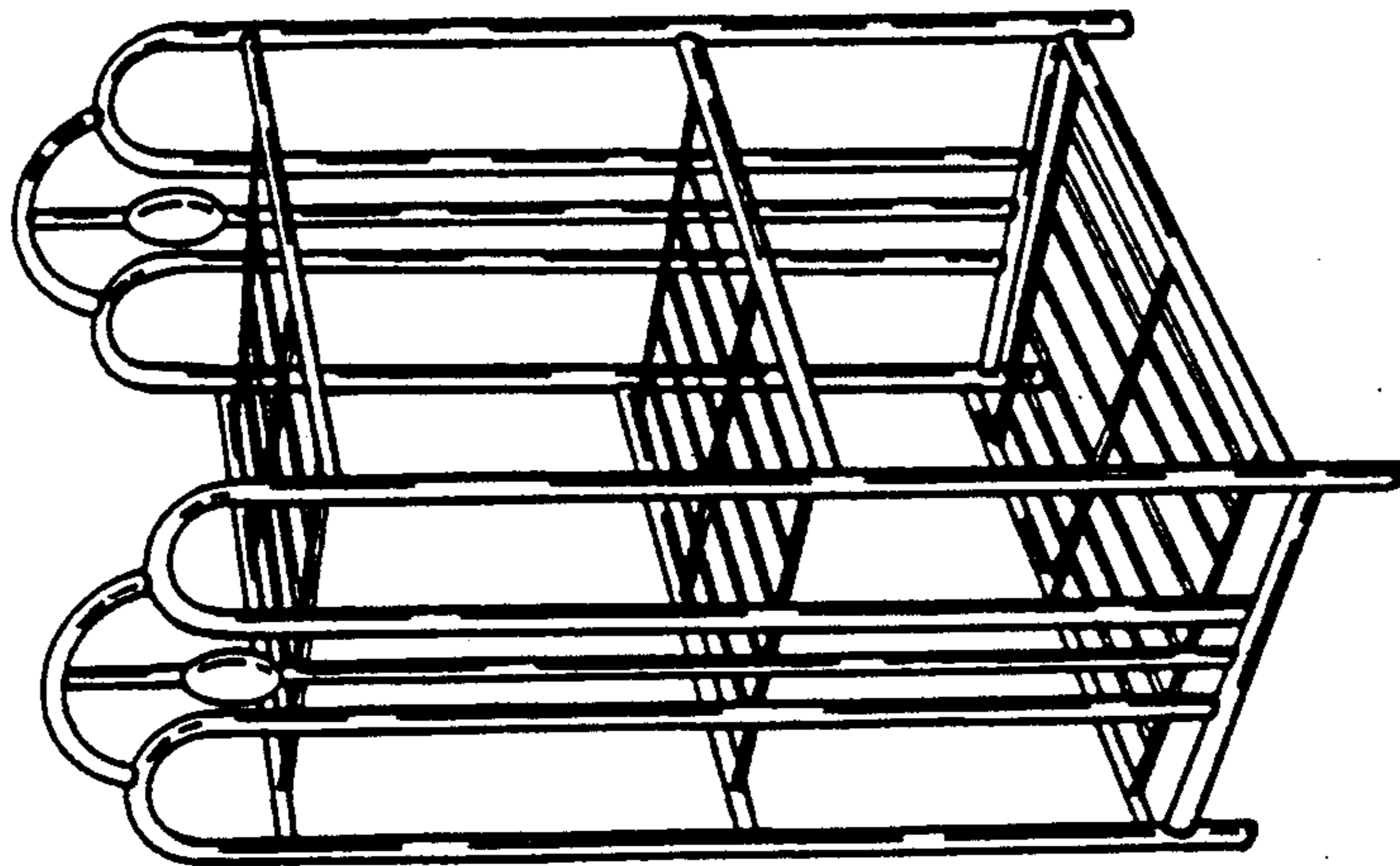

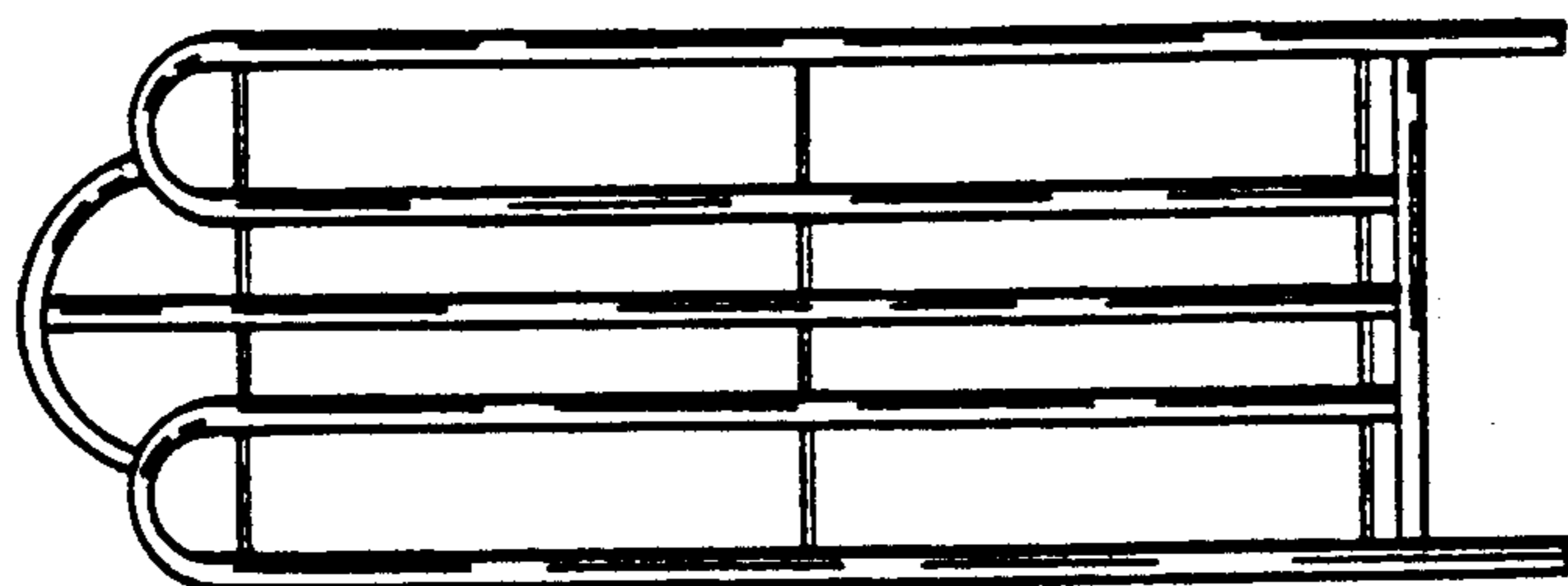

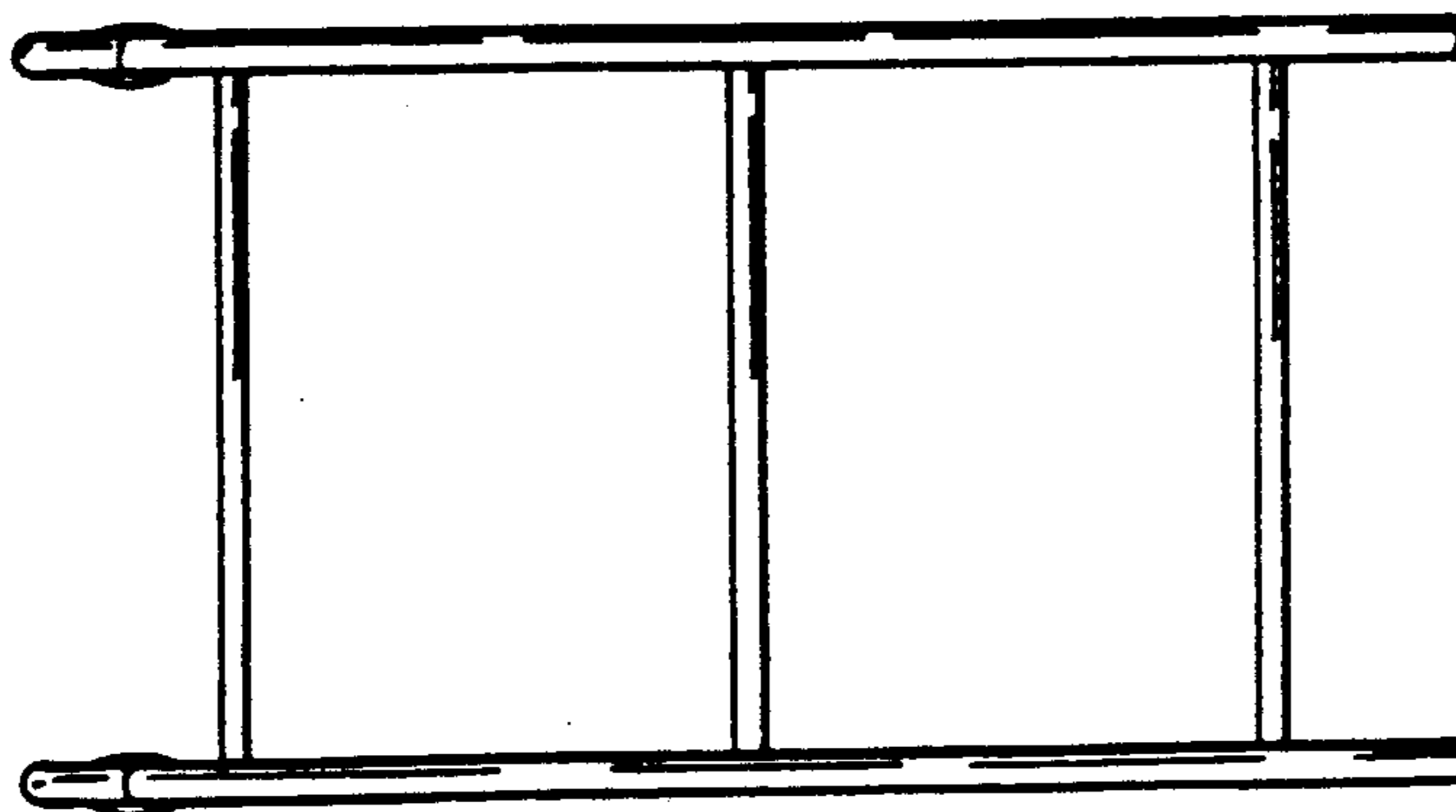
