DESCRIPTION

FIG. 1 is a front perspective view of the shelf unit showing my new design in the form of a baker's rack;
 FIG. 2 is a rear perspective view of the shelf unit of FIG. 1;
 FIG. 3 is a front elevational view of the shelf unit of FIG. 1;
 FIG. 4 is a front perspective view showing a second

embodiment of the shelf unit of FIG. 1 in the form of a book case;
 FIG. 5 is a rear perspective view of the shelf unit of FIG. 4;
 FIG. 6 is a front elevational view of the shelf unit of FIG. 4;
 FIG. 7 is a front perspective view of a third embodiment of the shelf unit of FIG. 1 in the form of a telephone stand;

 FIG. 24 is a front elevational view of the shelf unit of FIG. 22.

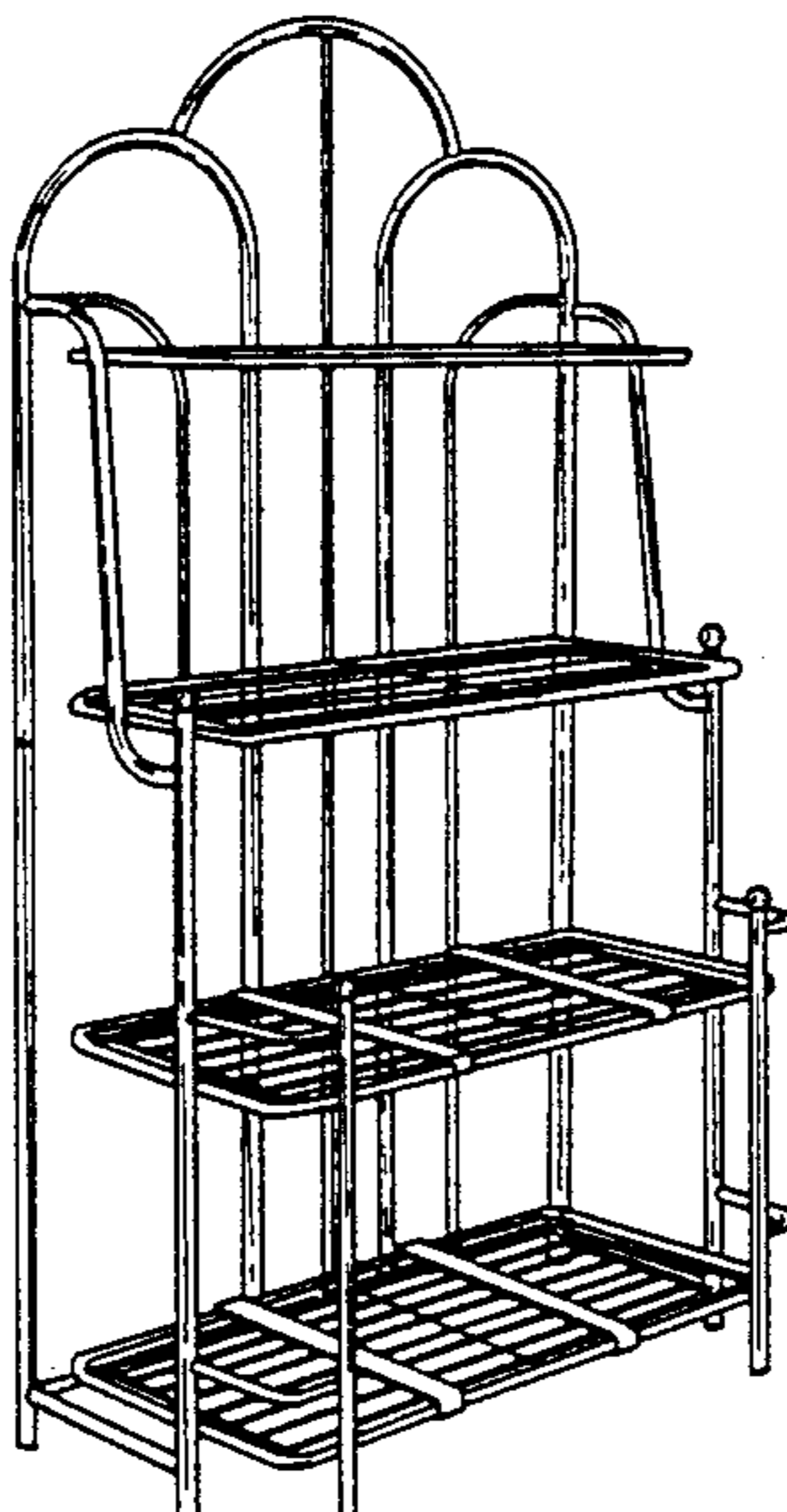

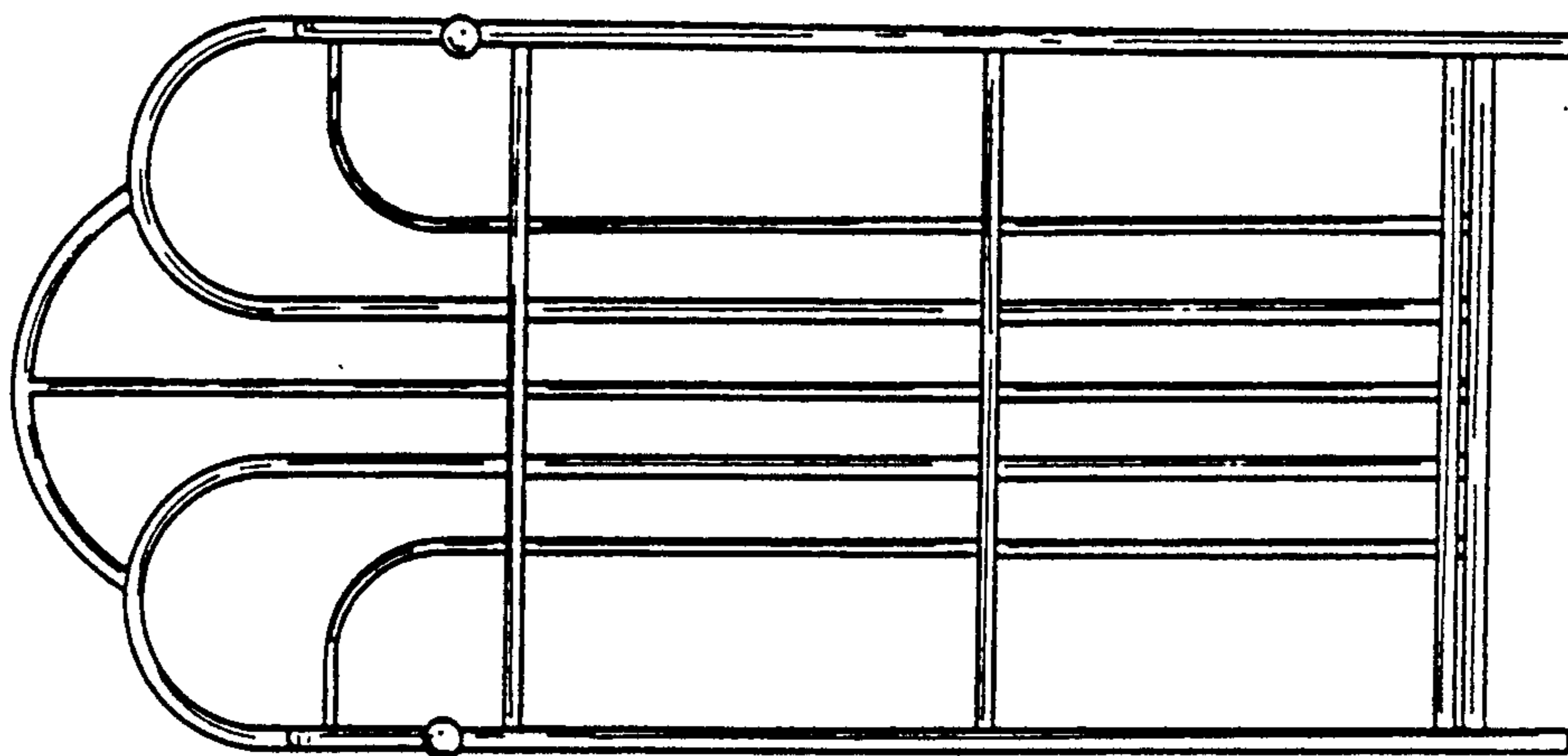

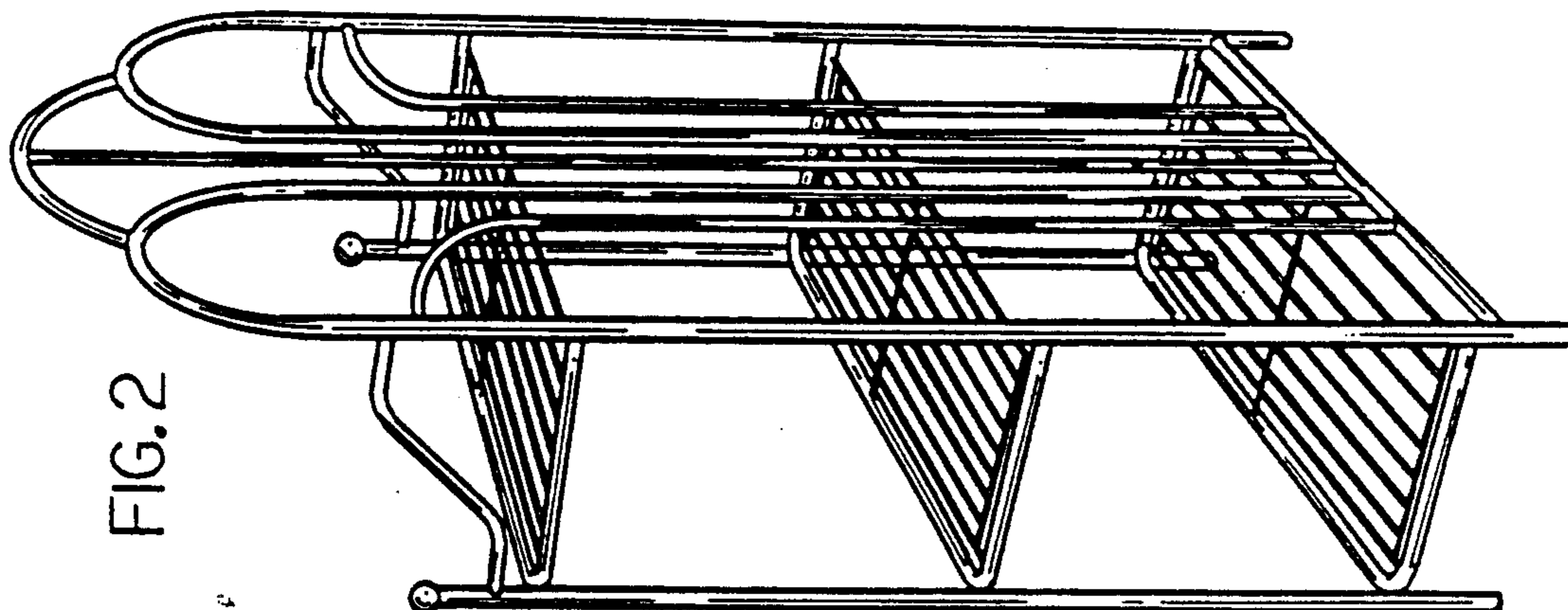
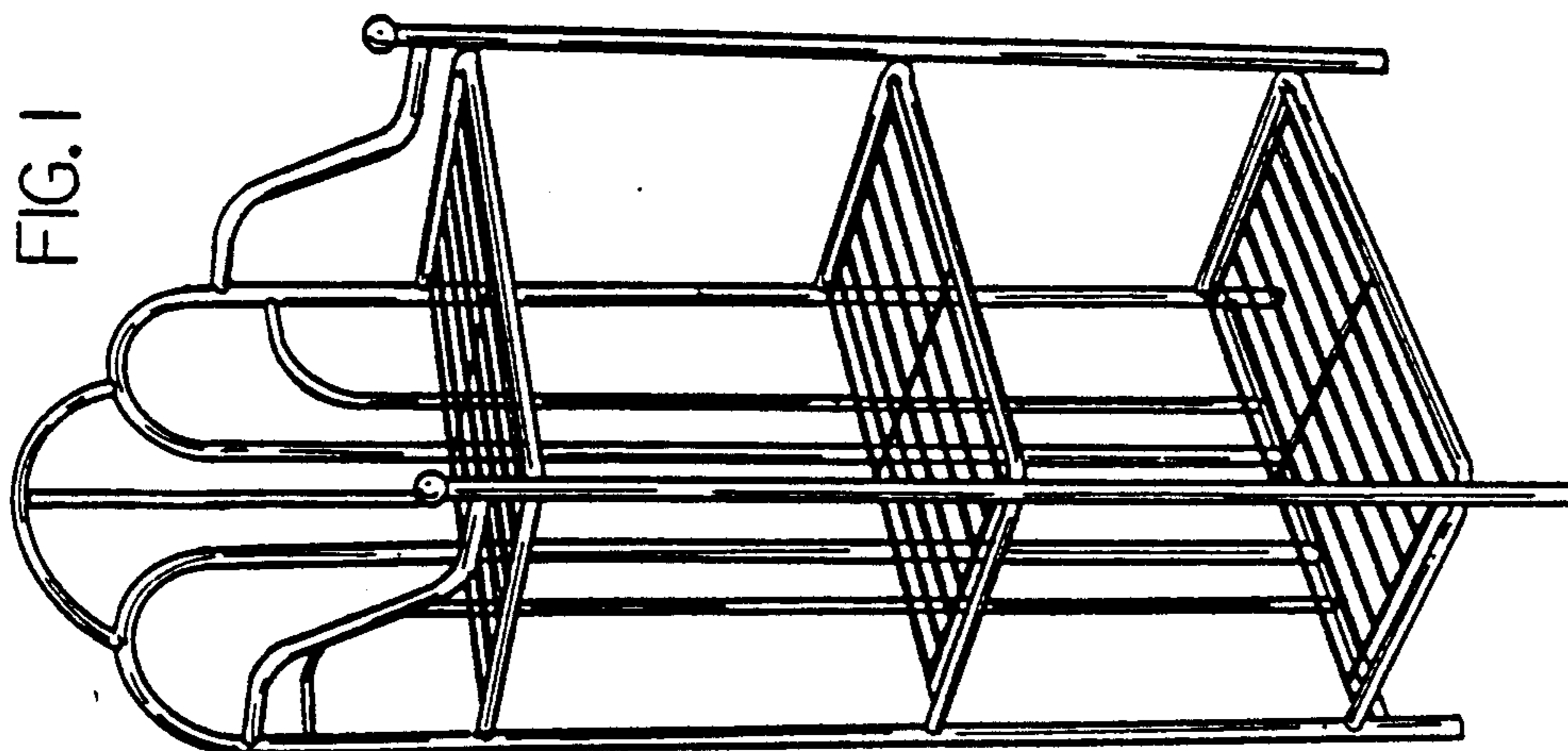

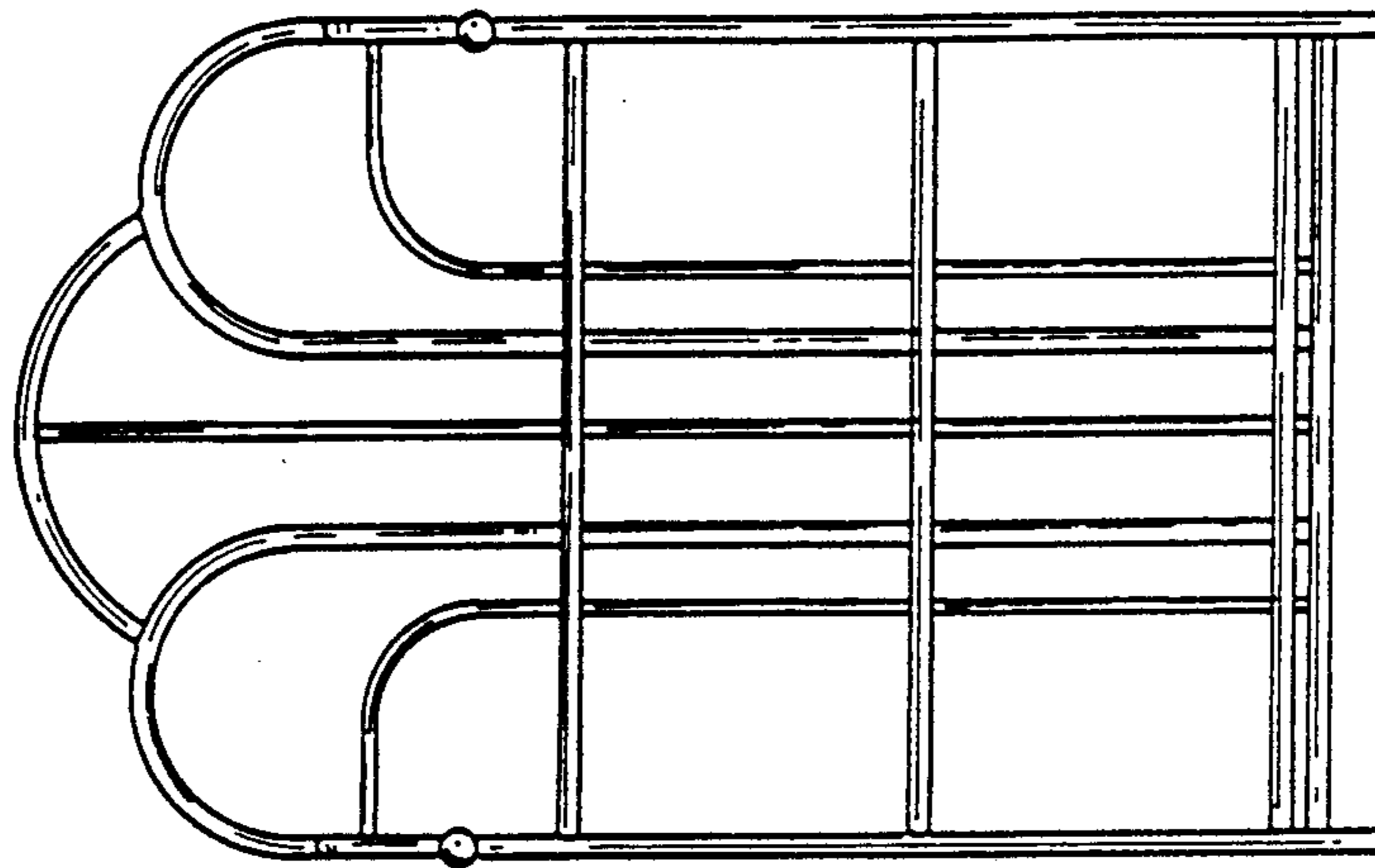

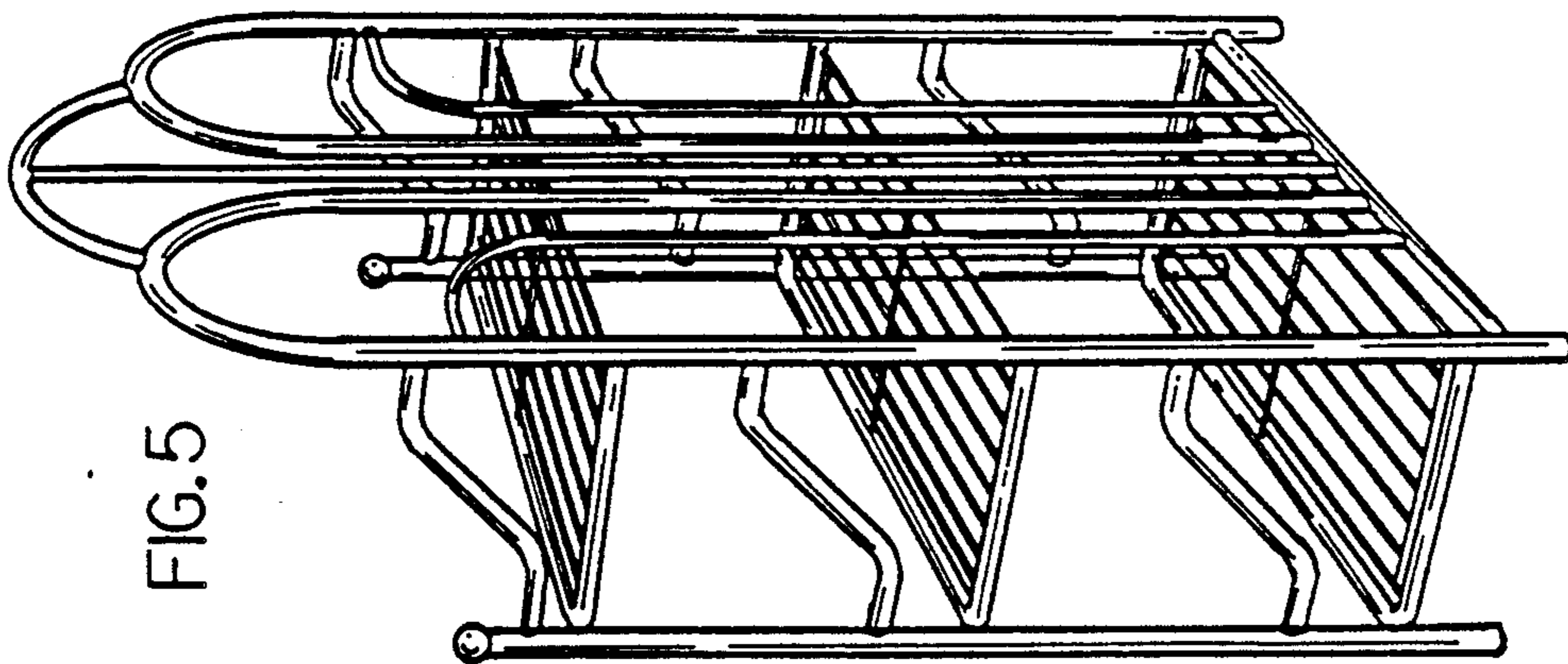

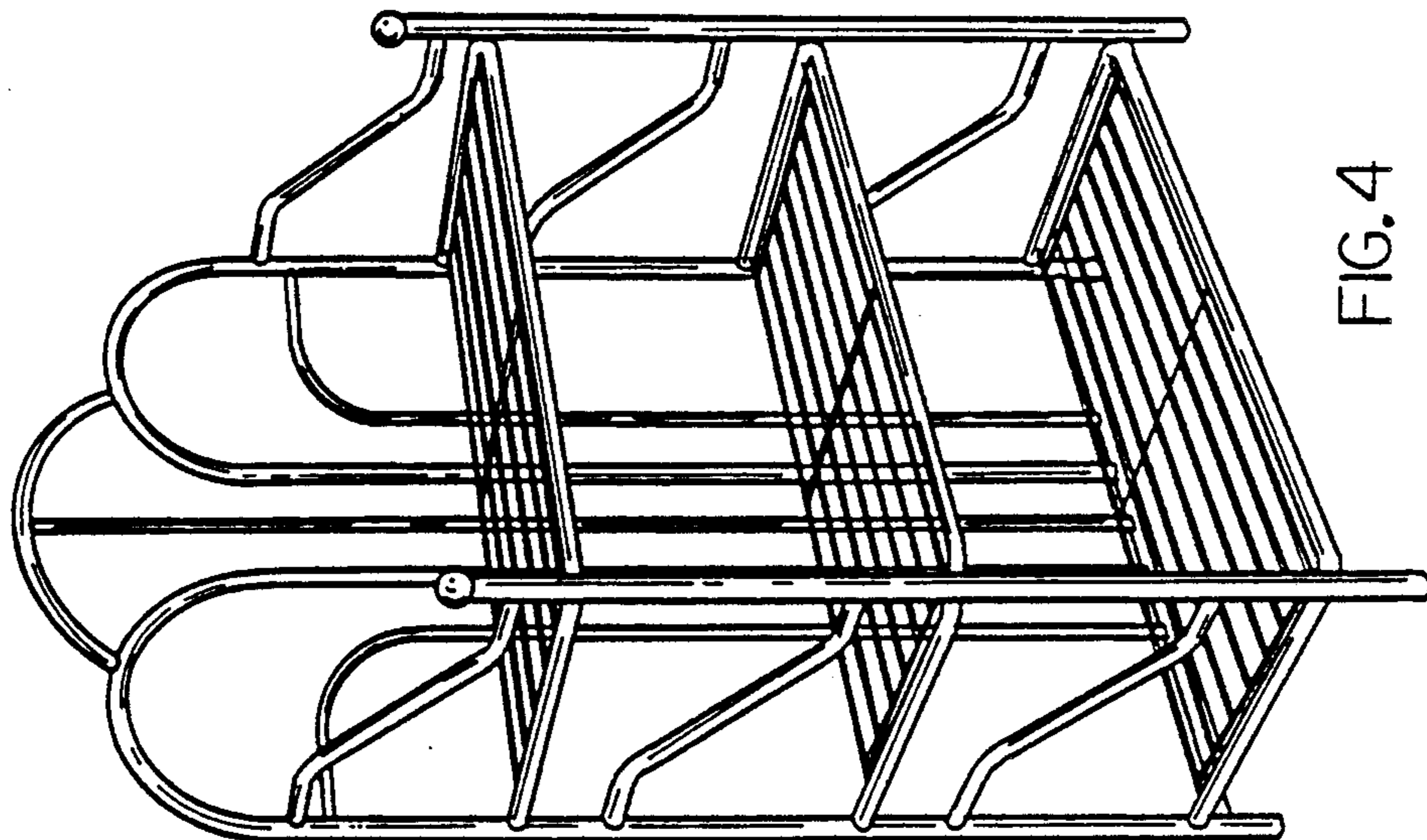

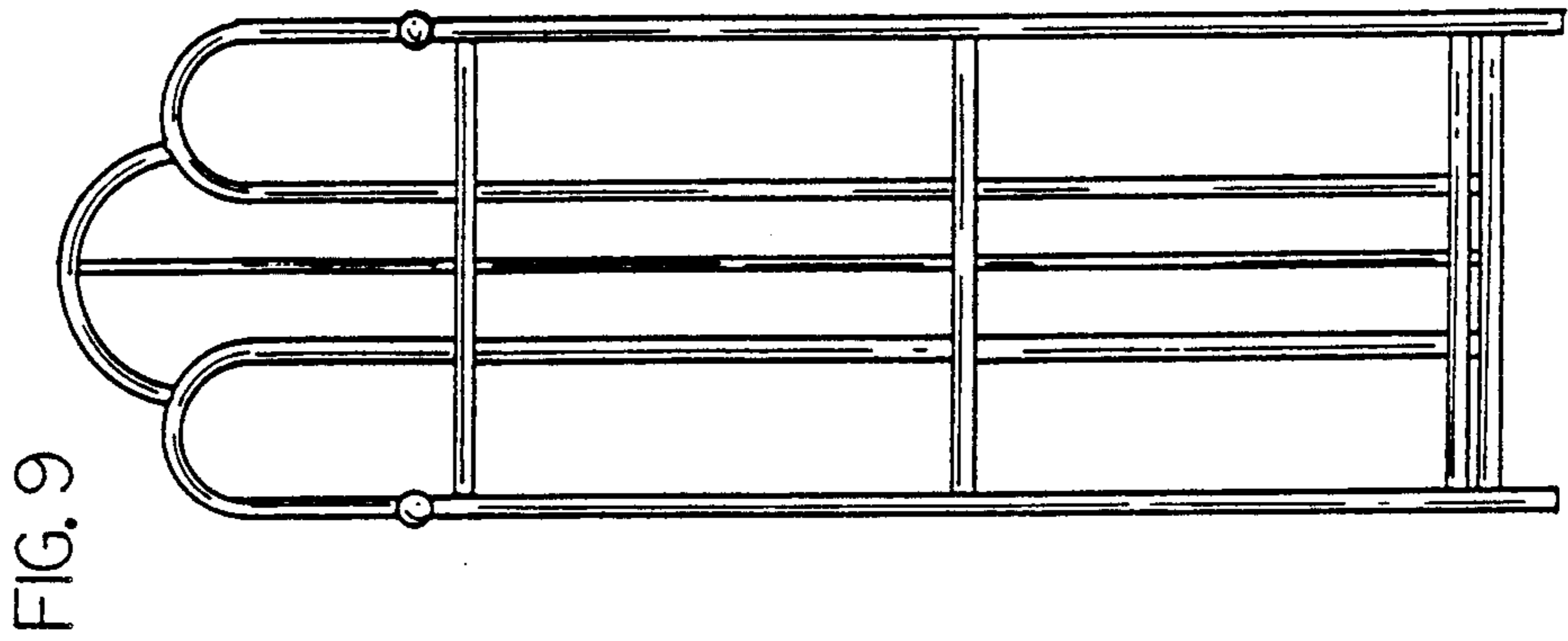

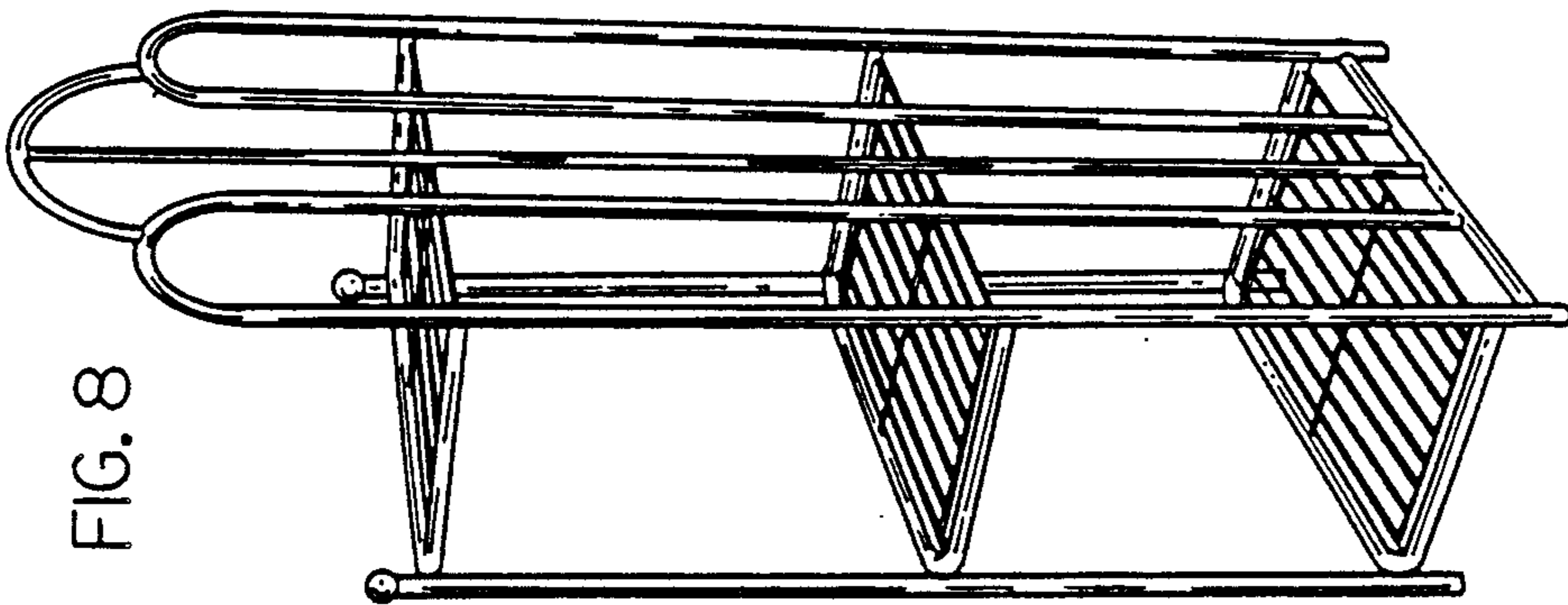

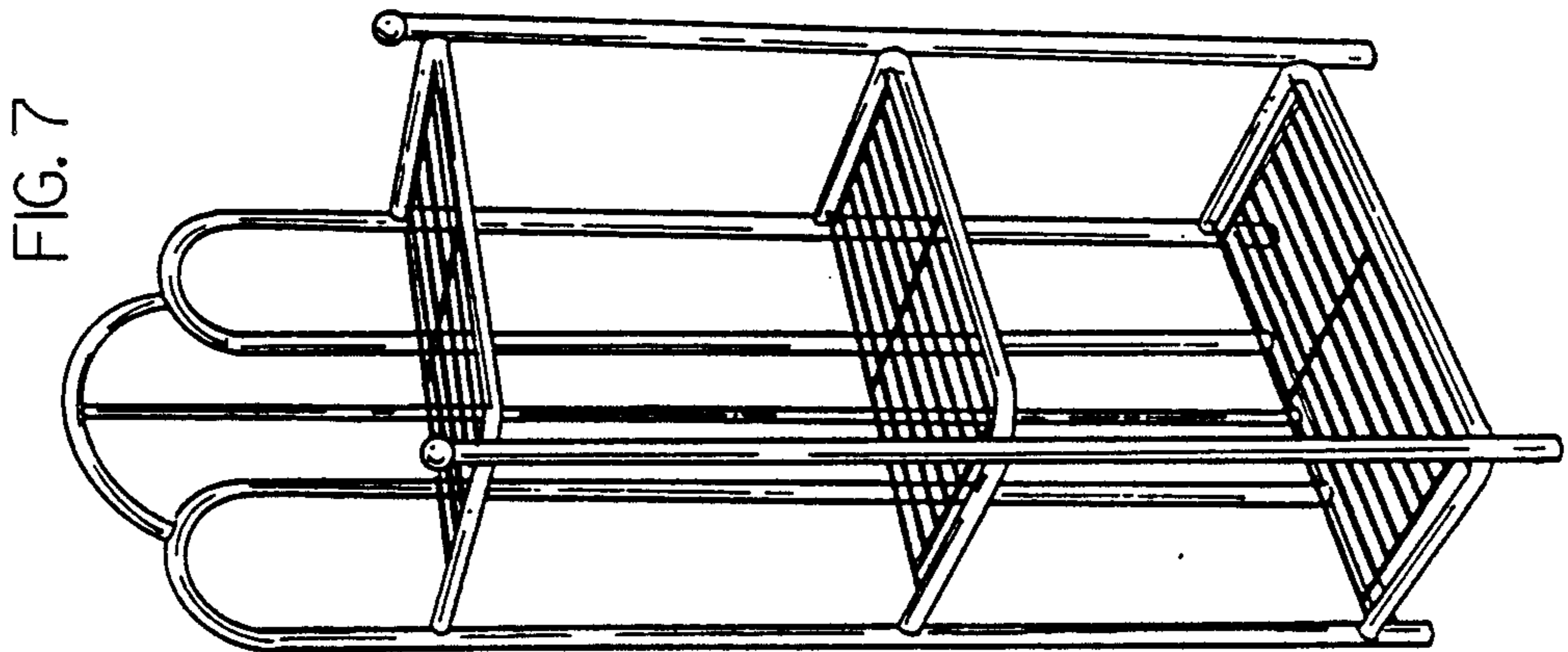

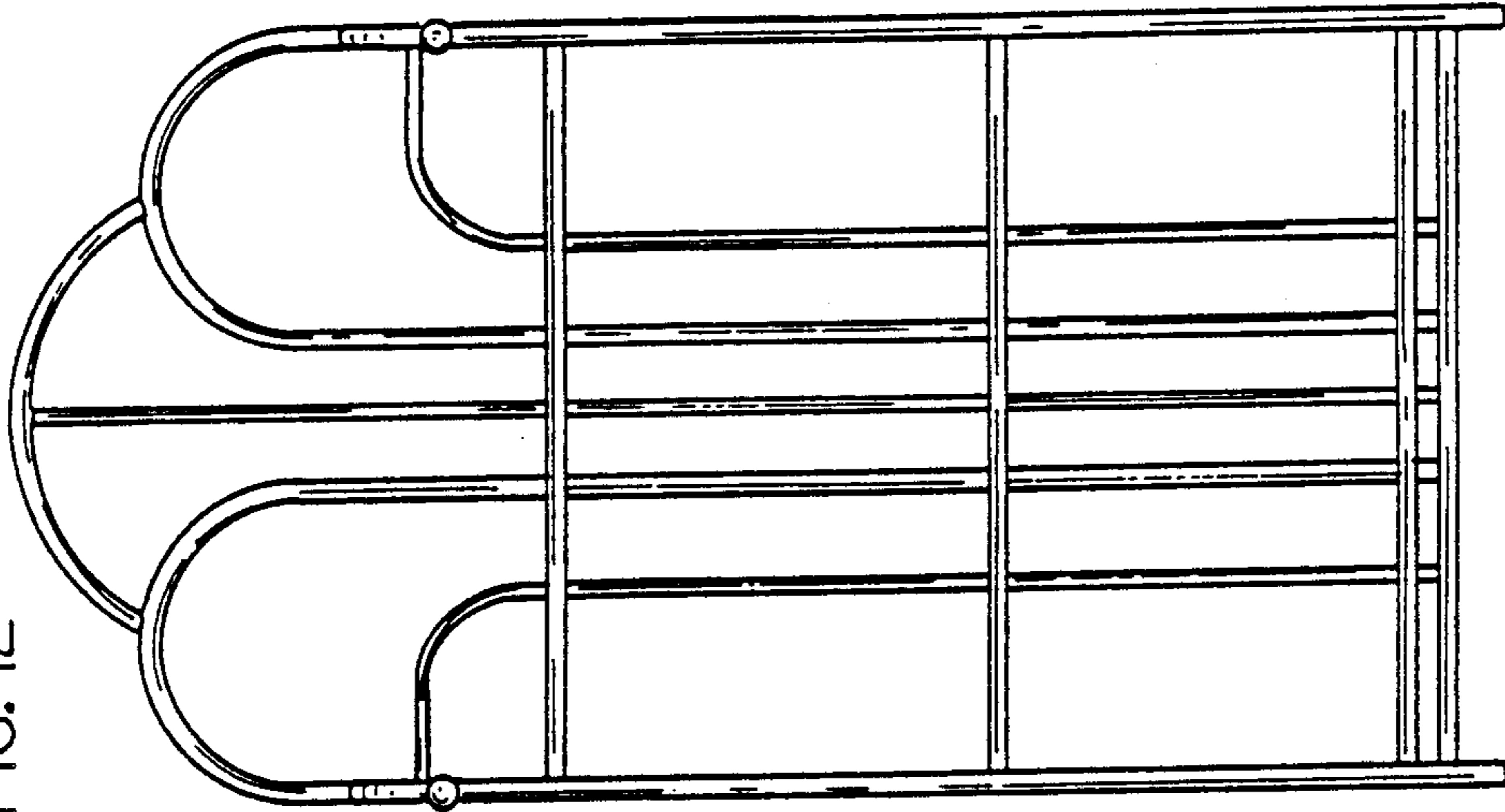

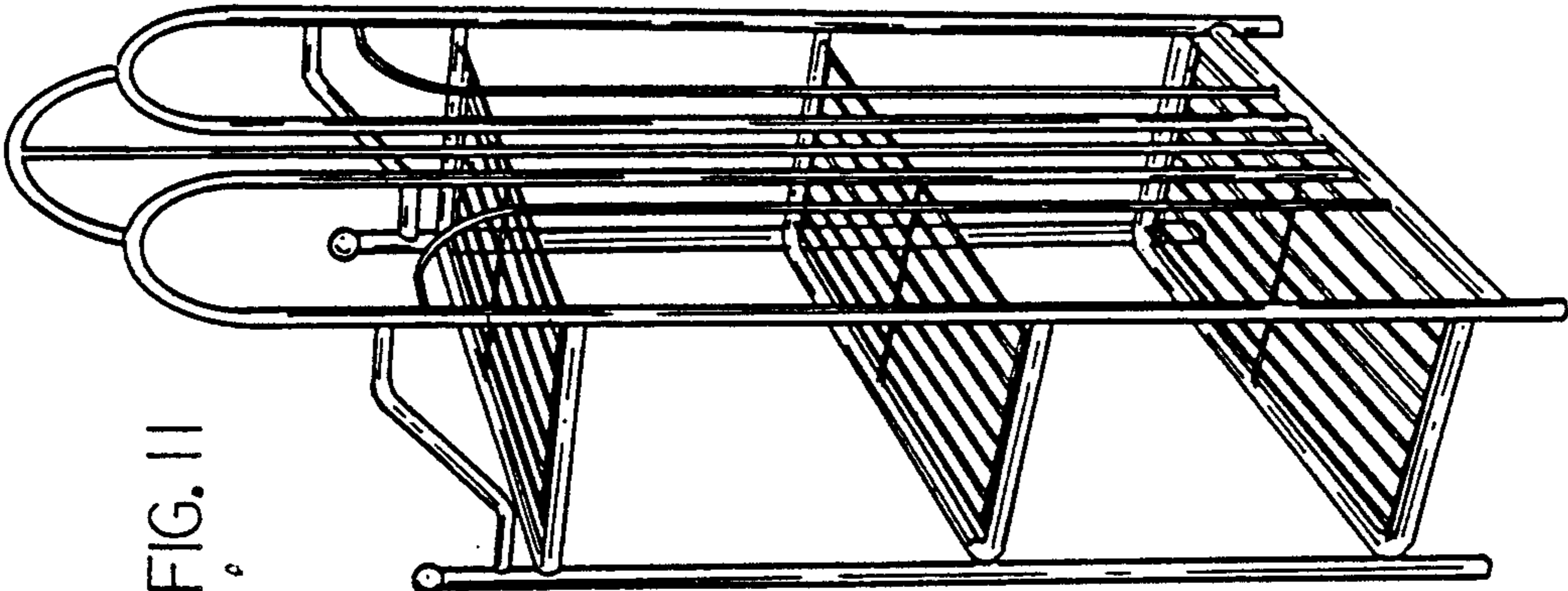
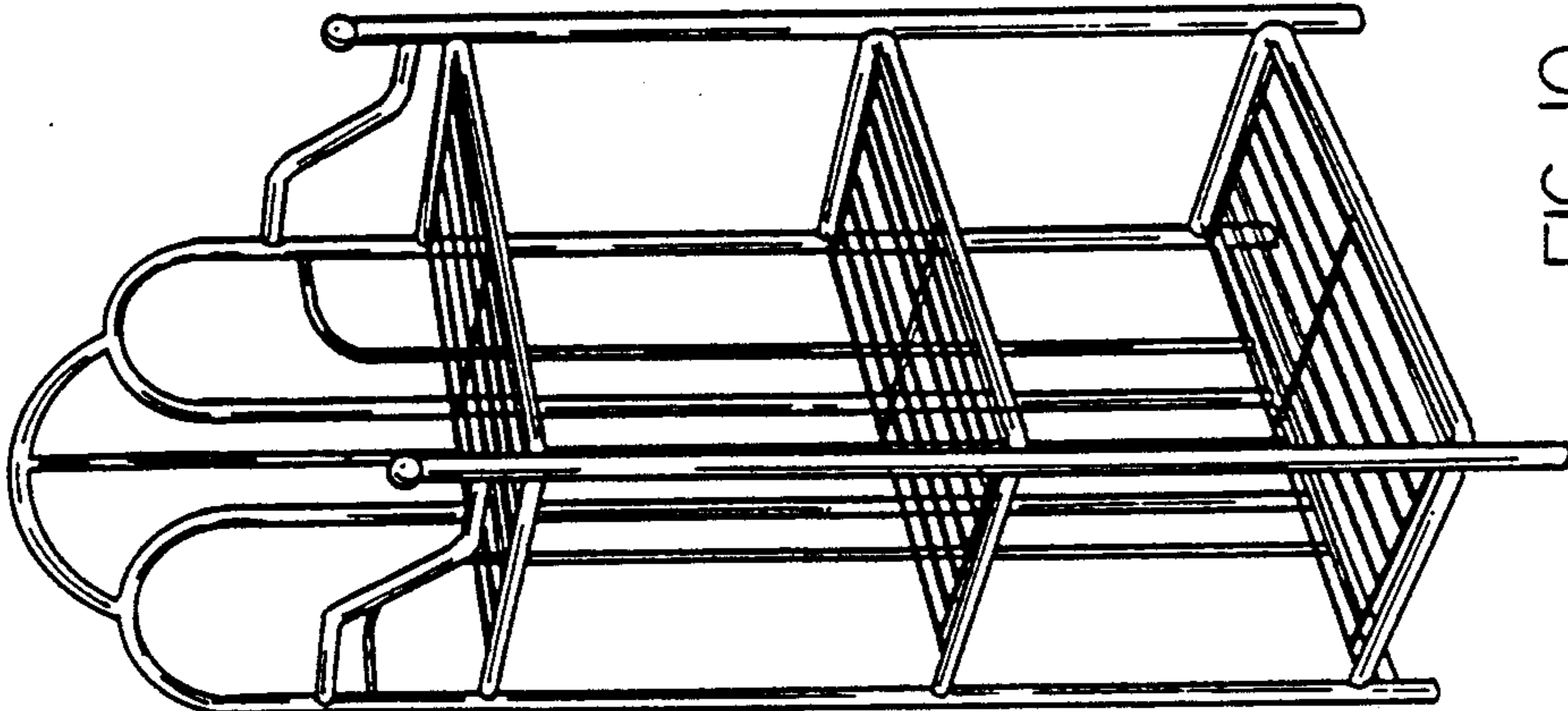

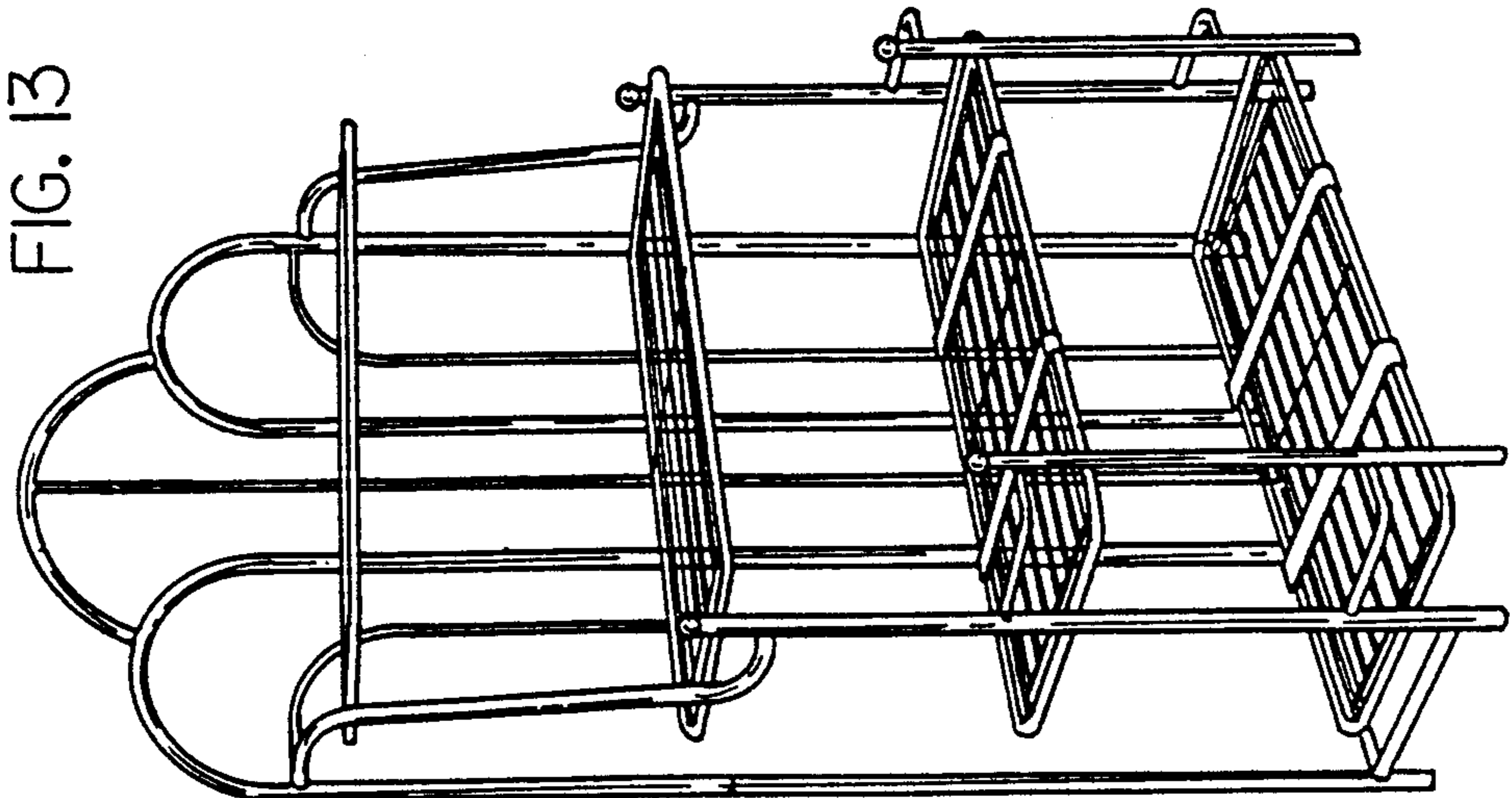
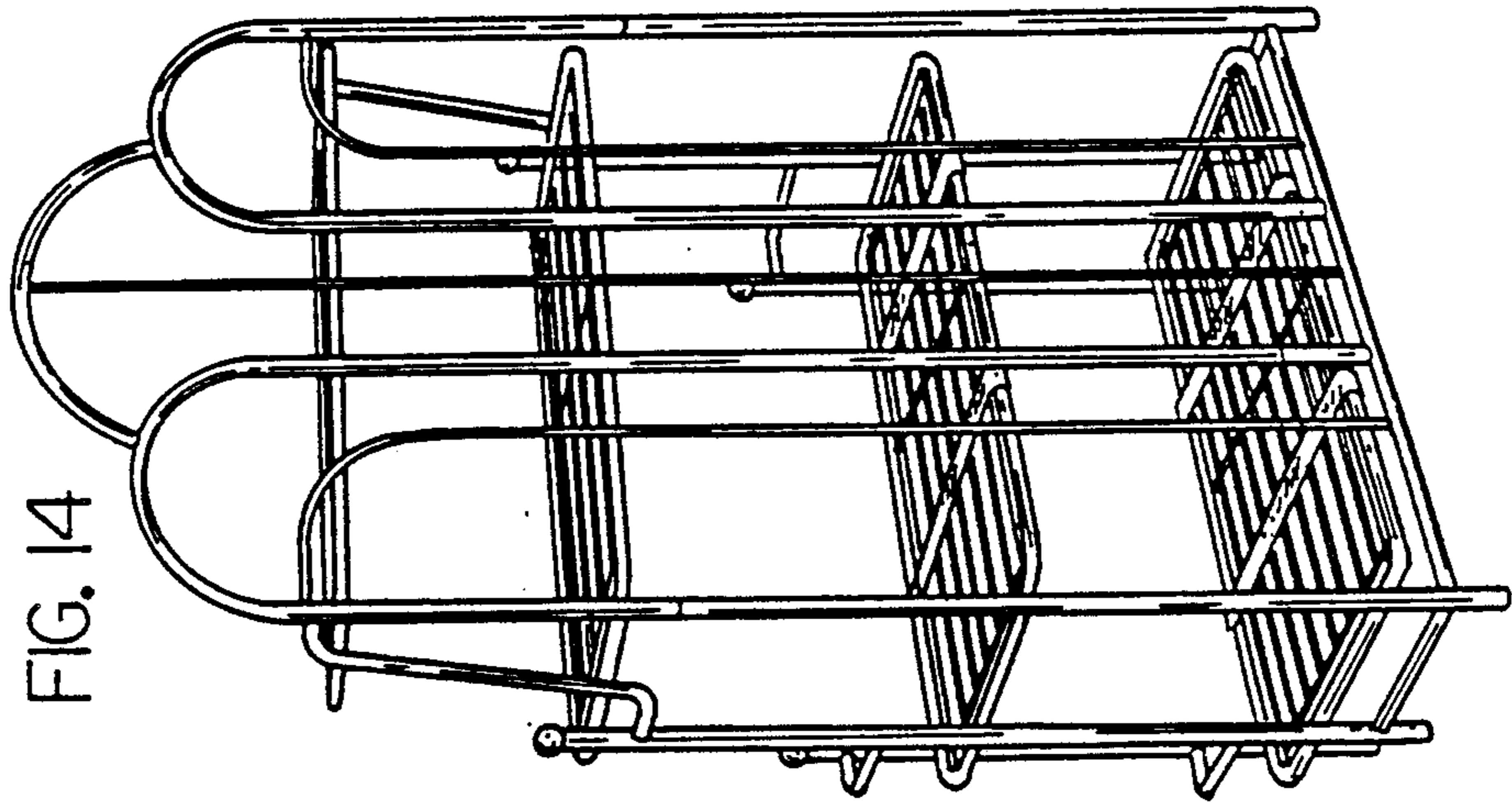
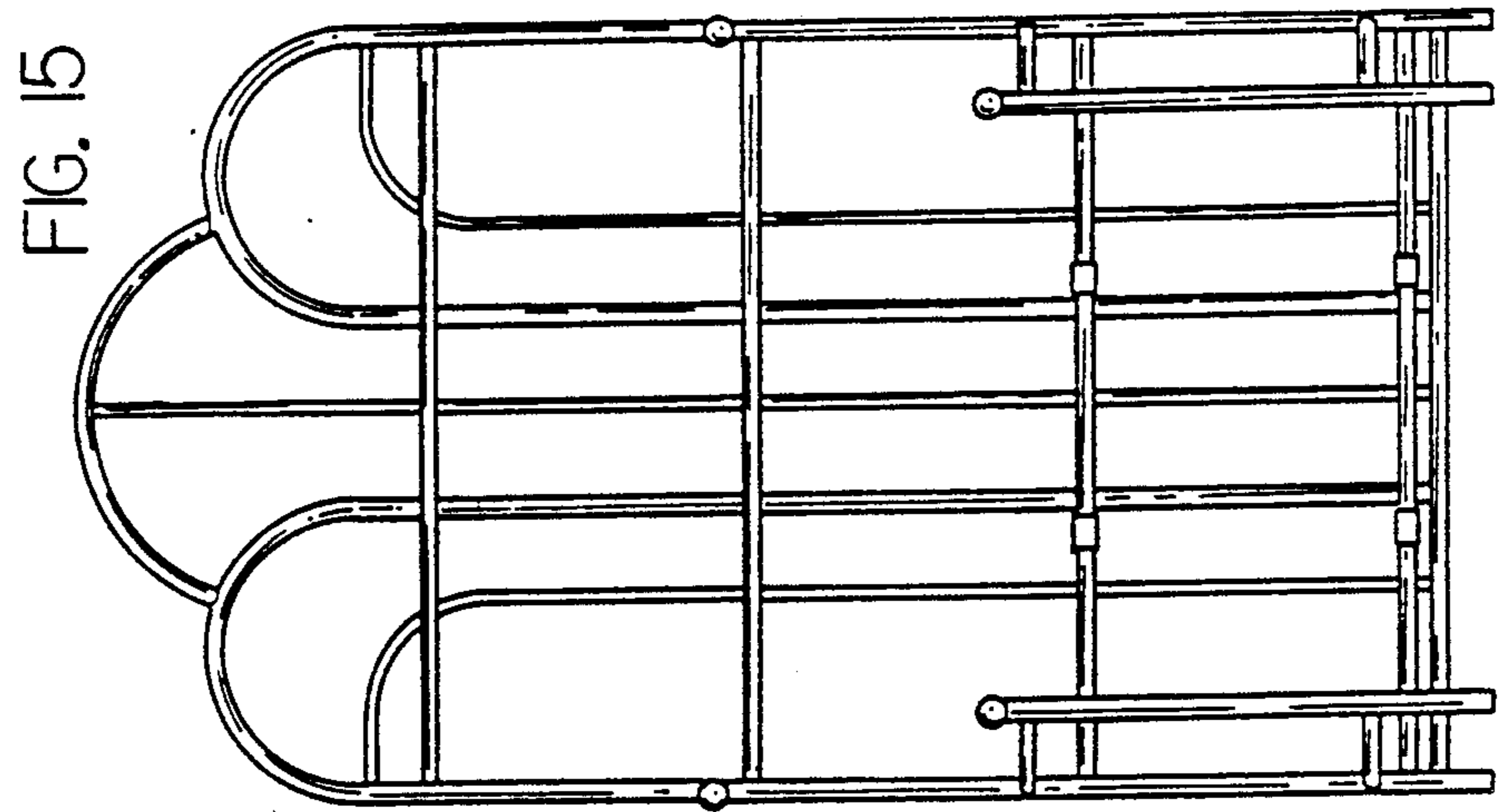

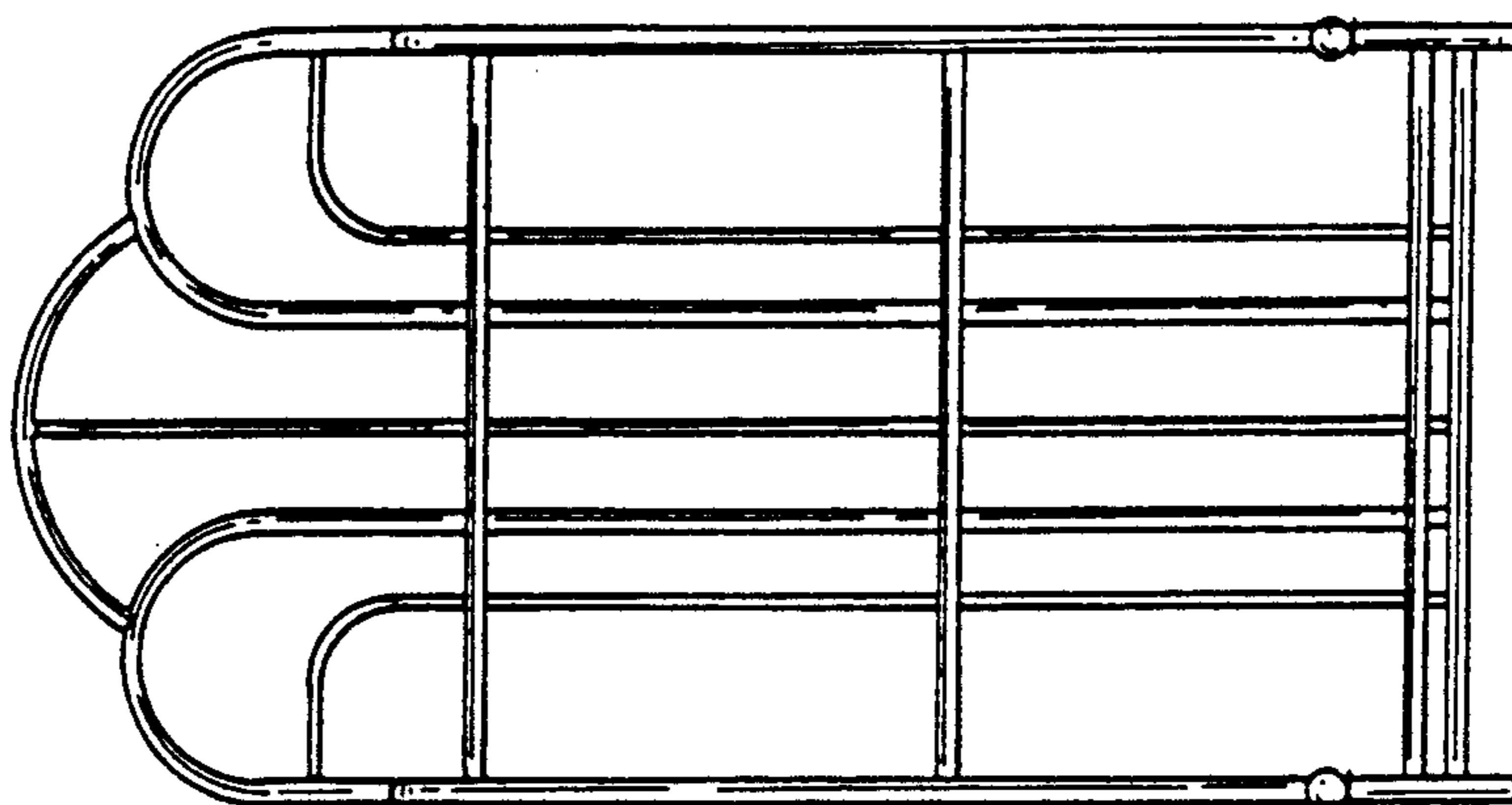

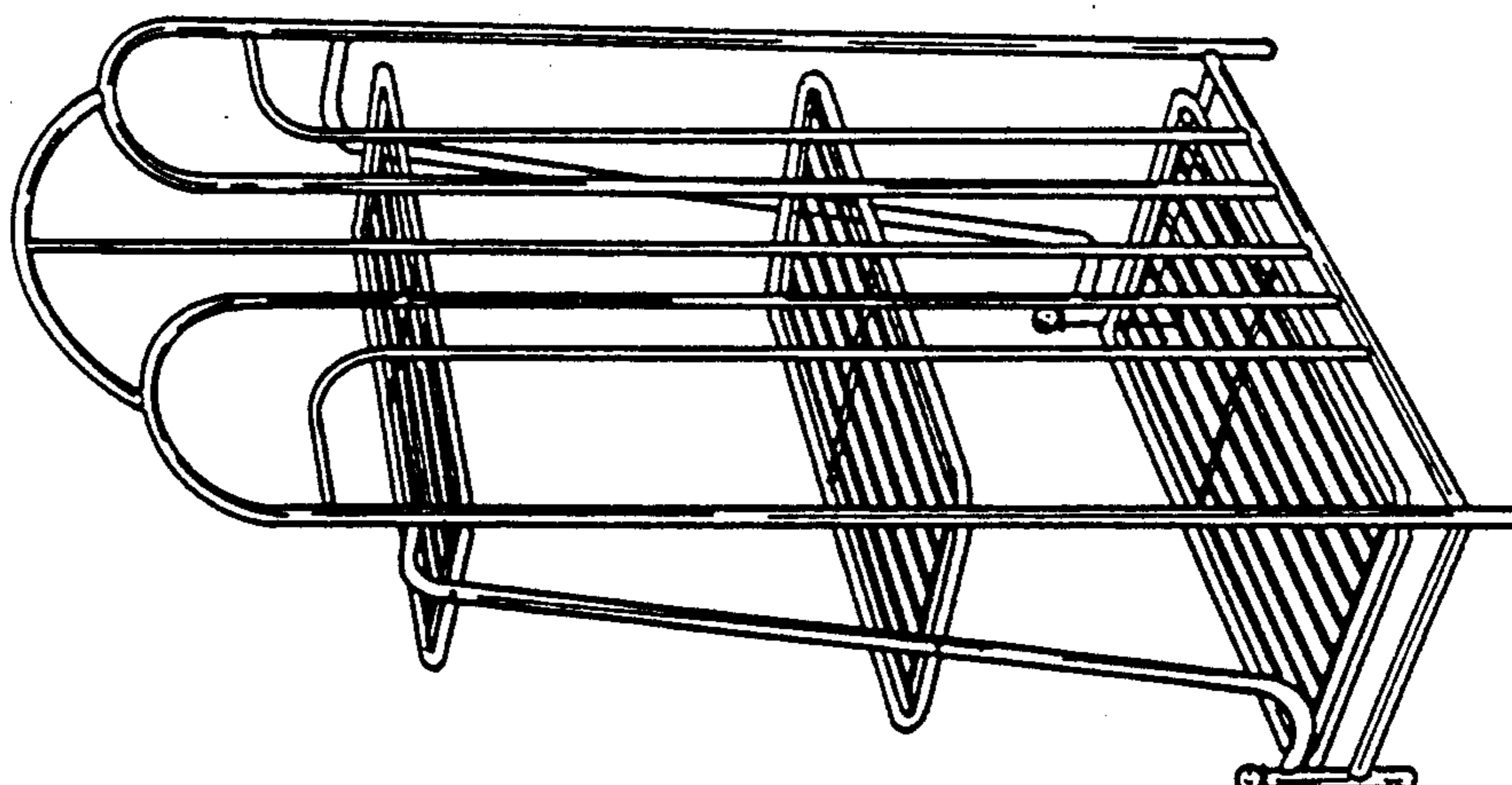
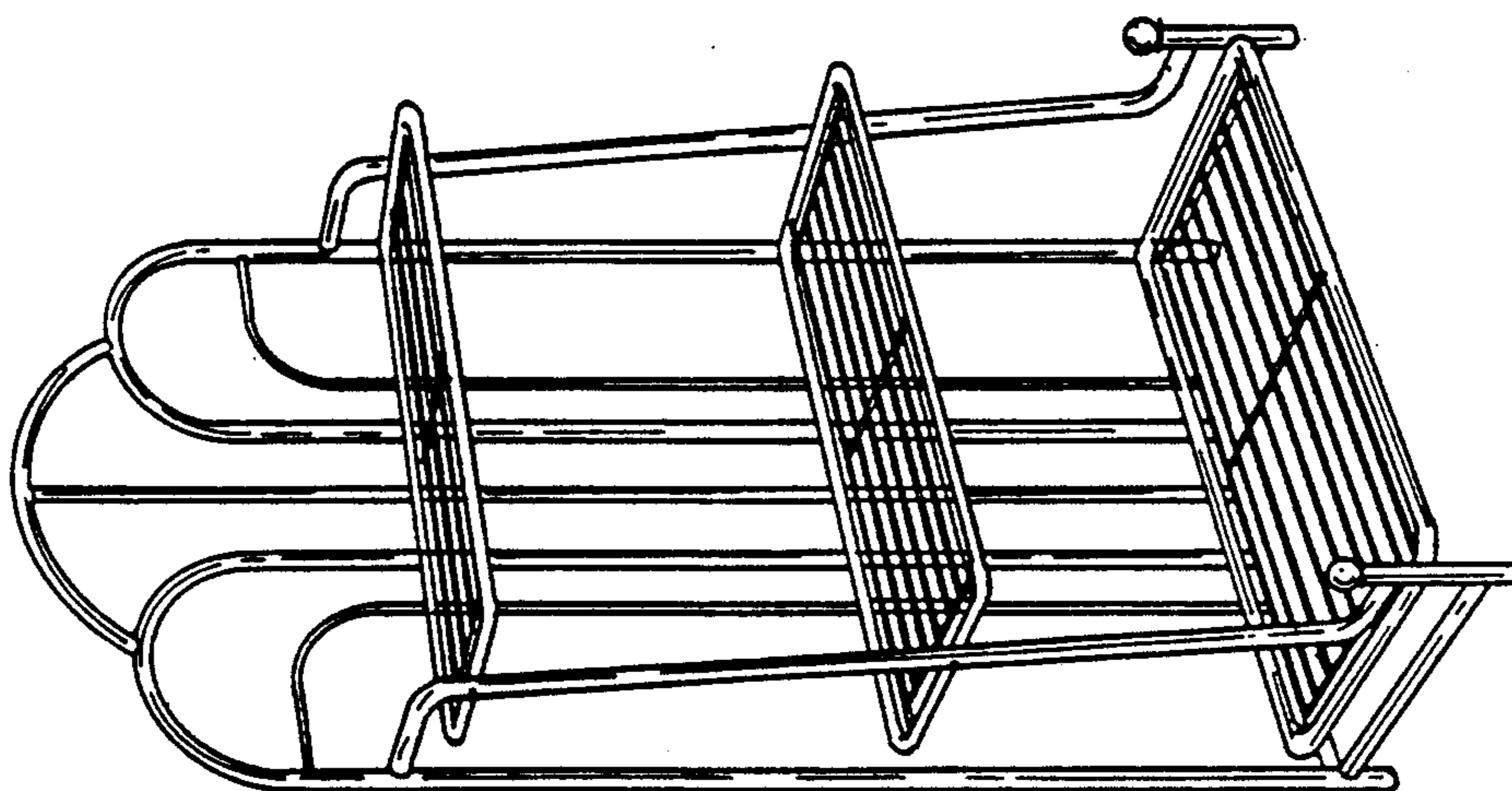

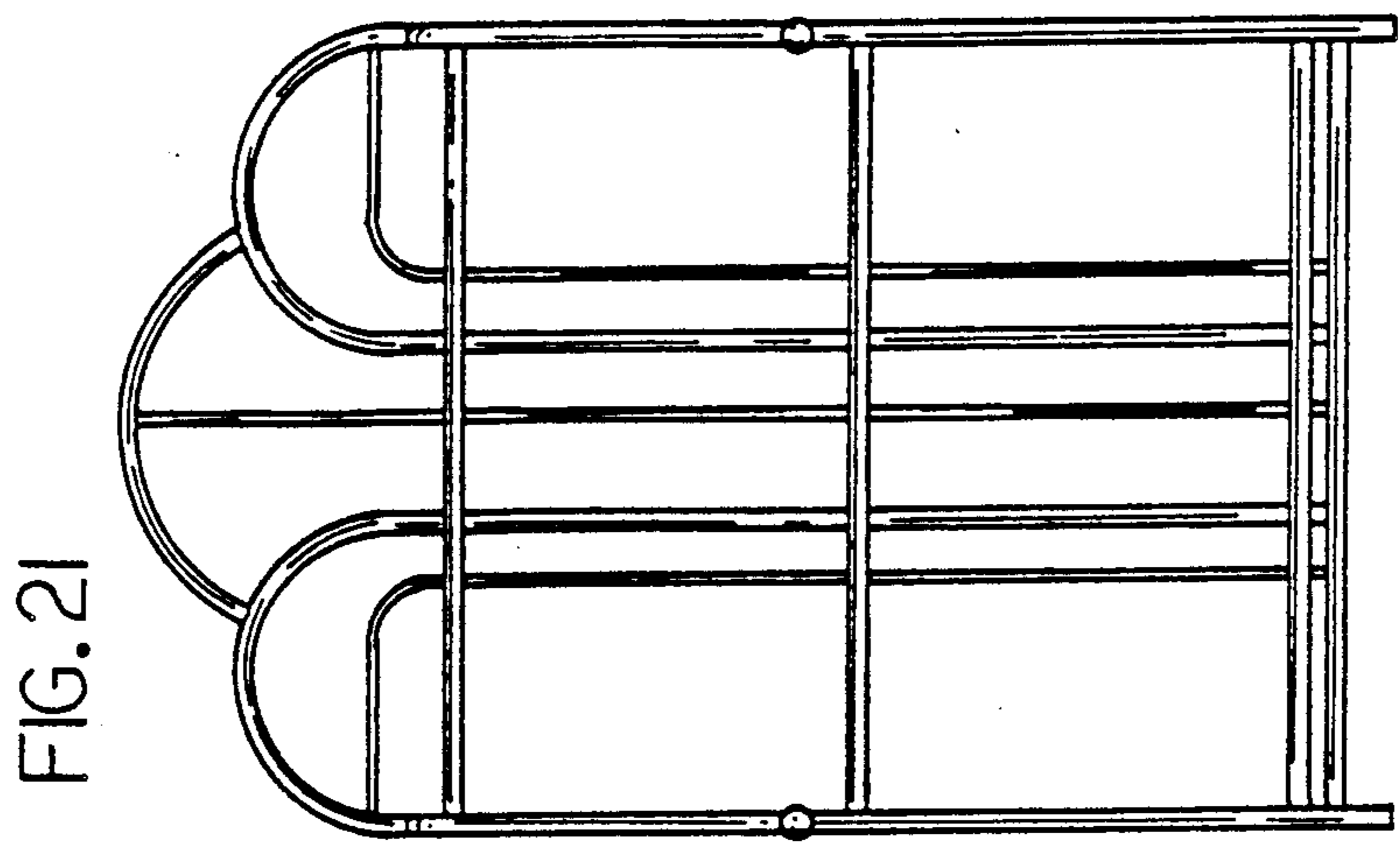

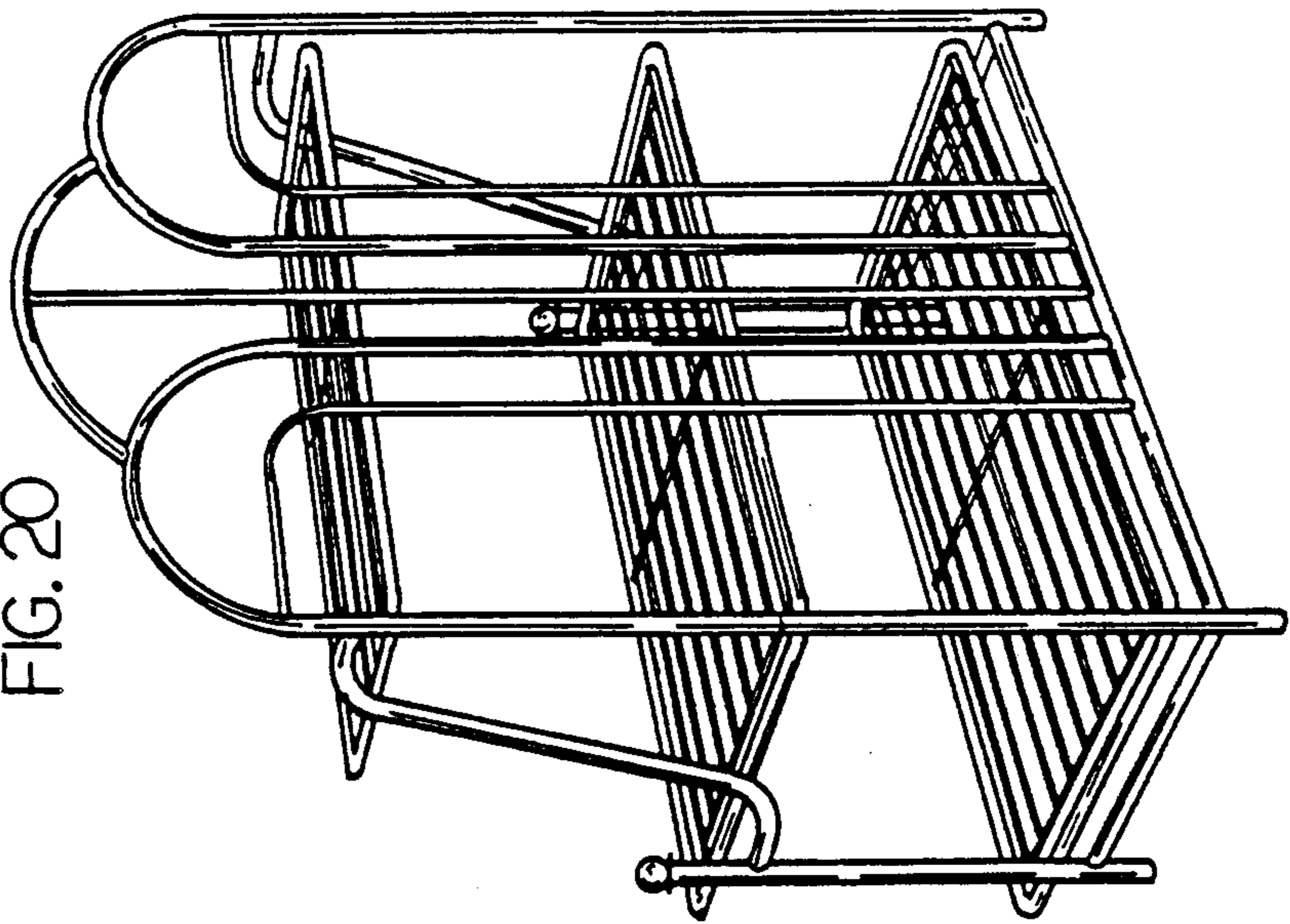

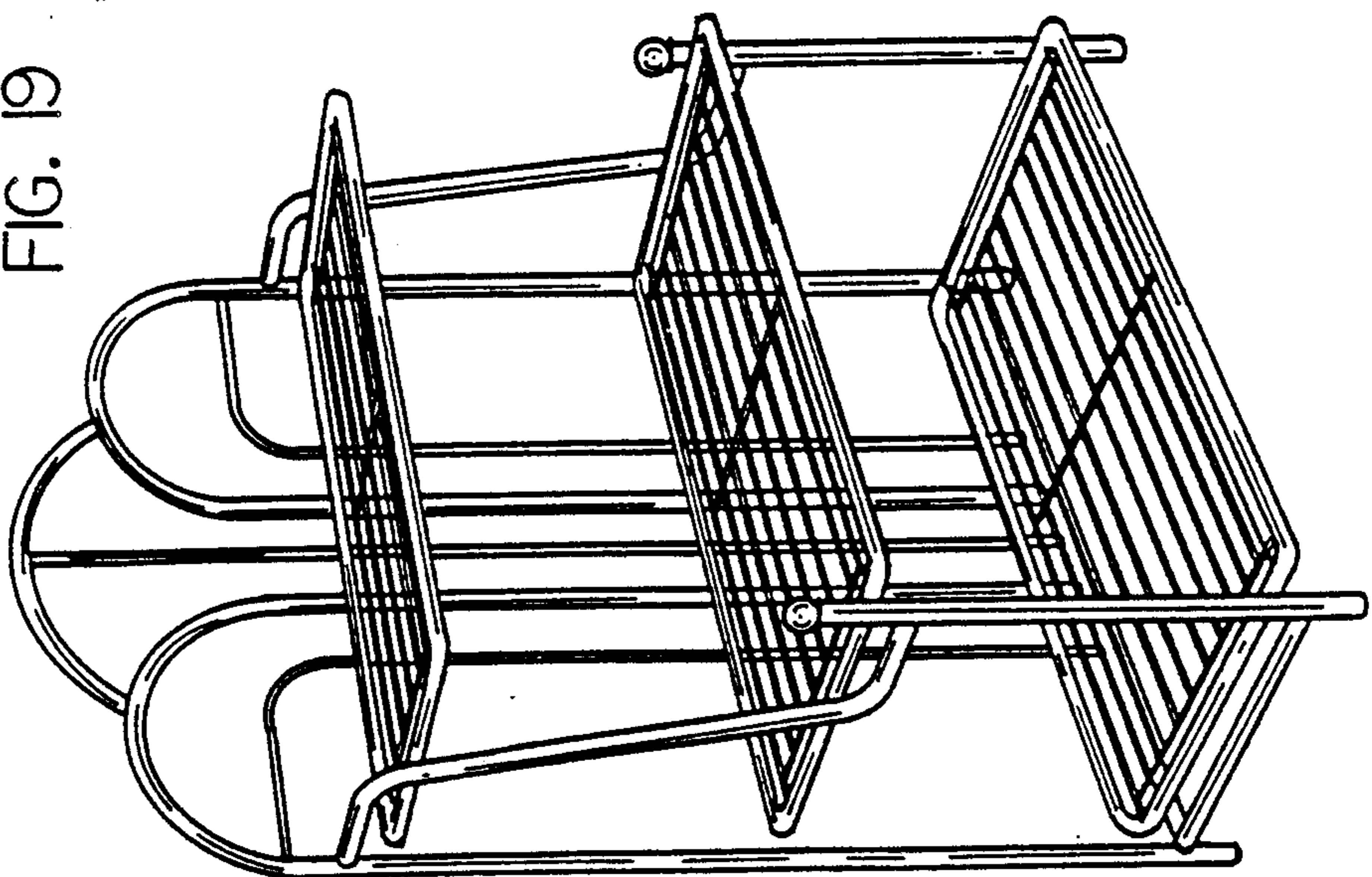

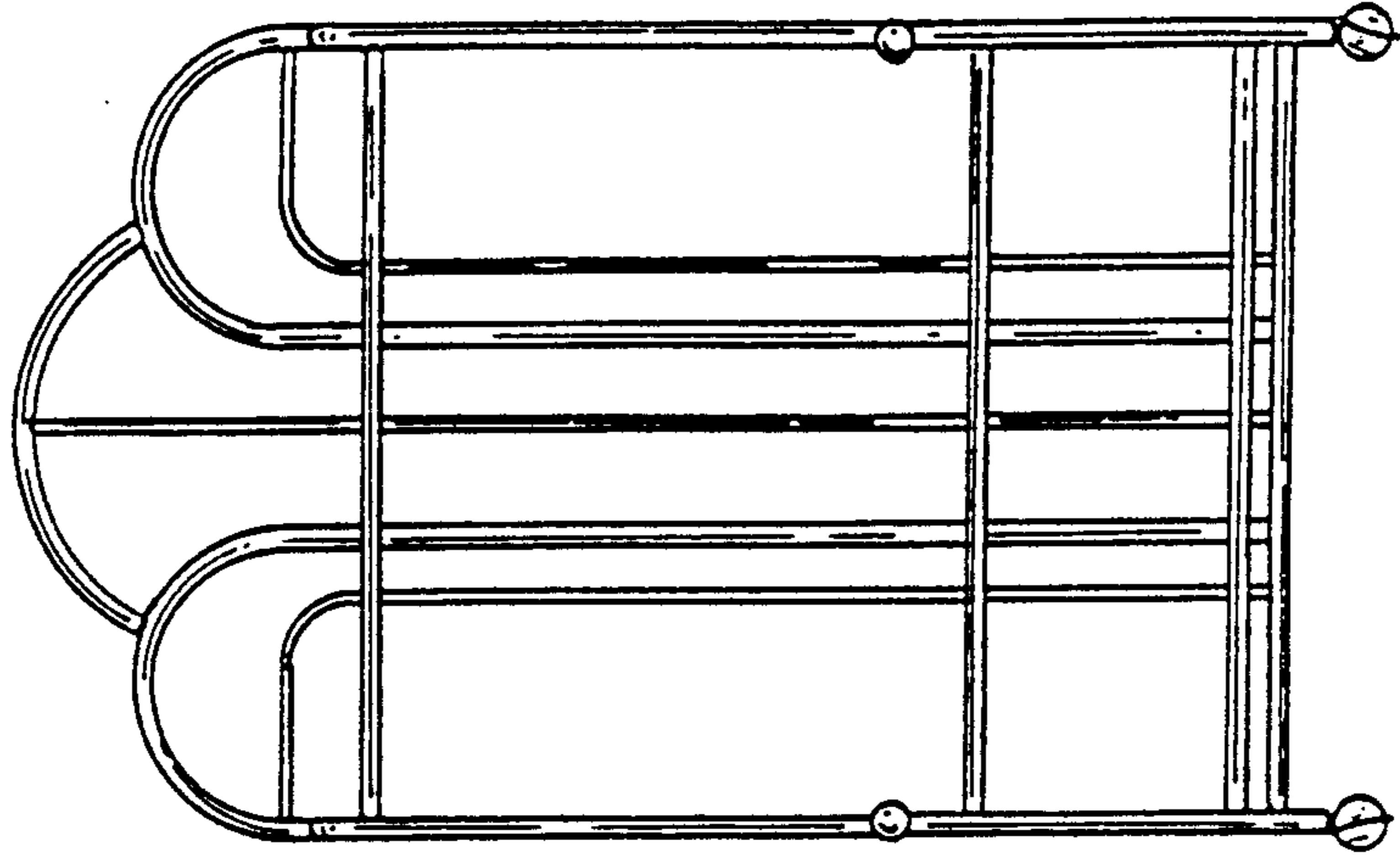

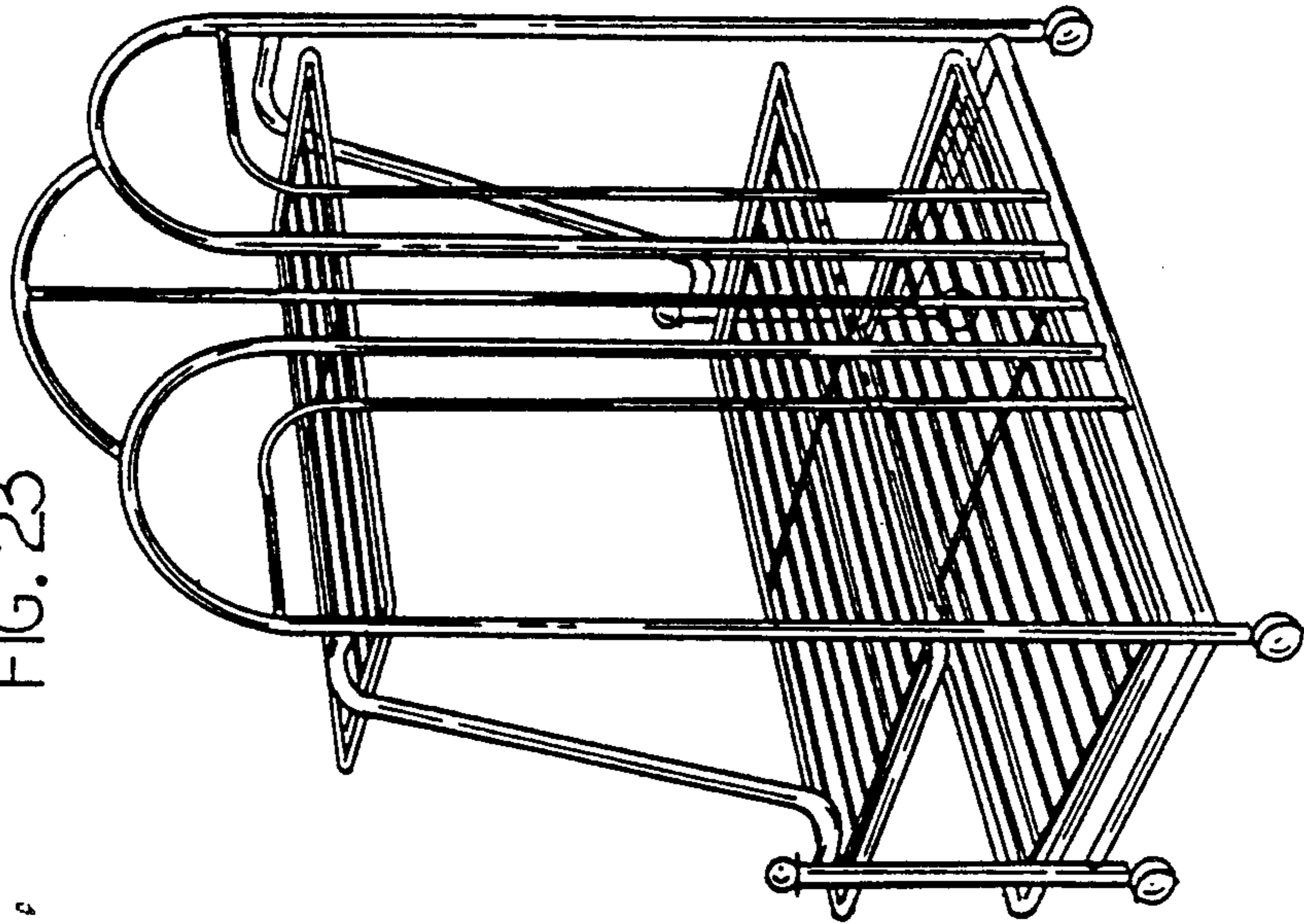
