The ornamental design for an electronic equipment housing, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of an electronic equipment housing showing our design; FIG. 2 is a front elevational view thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is an elevational view of one side thereof, the other side being a mirror-image thereof; FIG. 5 is a top plan view thereof; FIG. 6 is a bottom plan view thereof; FIG. 7 is a perspective view of a second embodiment of an electronic equipment housing showing our new design, the top plan and bottom plan views being the same as FIGS. 5 and 6 respectively; FIG. 8 is a front elevational view thereof; FIG. 9 is a rear elevational view thereof; FIG. 10 is an elevational view of one side thereof, the other side being a mirror-image thereof; FIG. 11 is a perspective view of a third embodiment of an electronic equipment housing showing our new design, the top plan and bottom plan views being the same as FIGS. 5 and 6 respectively; FIG. 12 is a front elevational view thereof; FIG. 13 is a rear elevational view thereof; FIG. 14 is an elevational view of one side thereof, the other side being a mirror-image thereof.

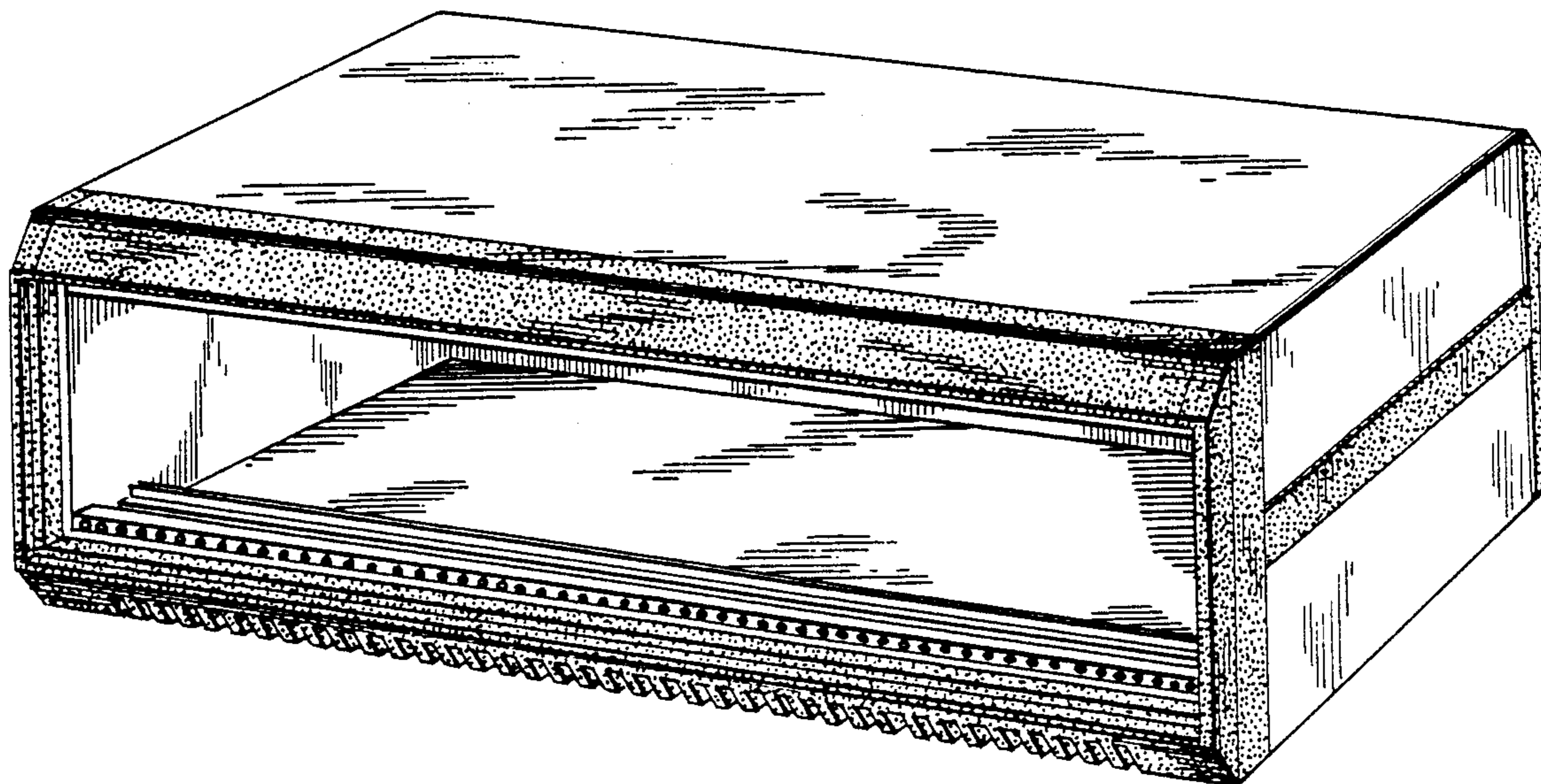

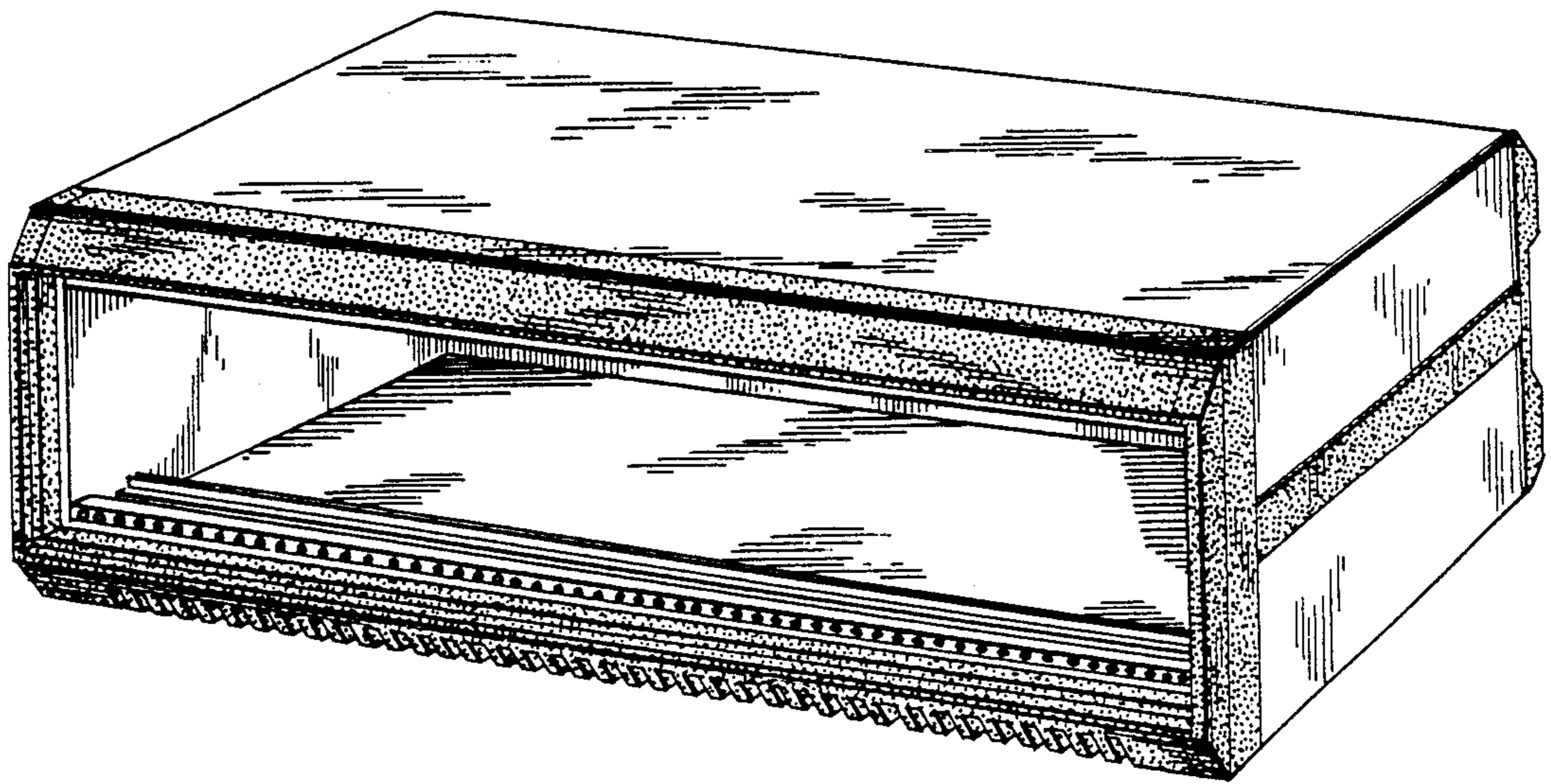

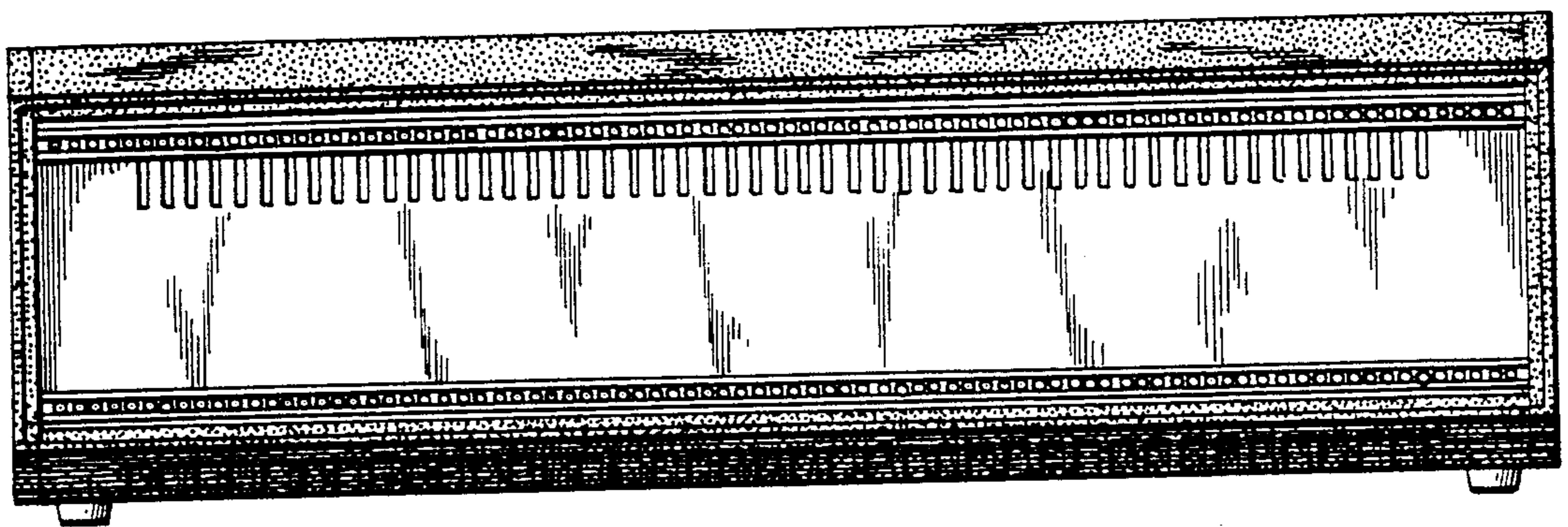

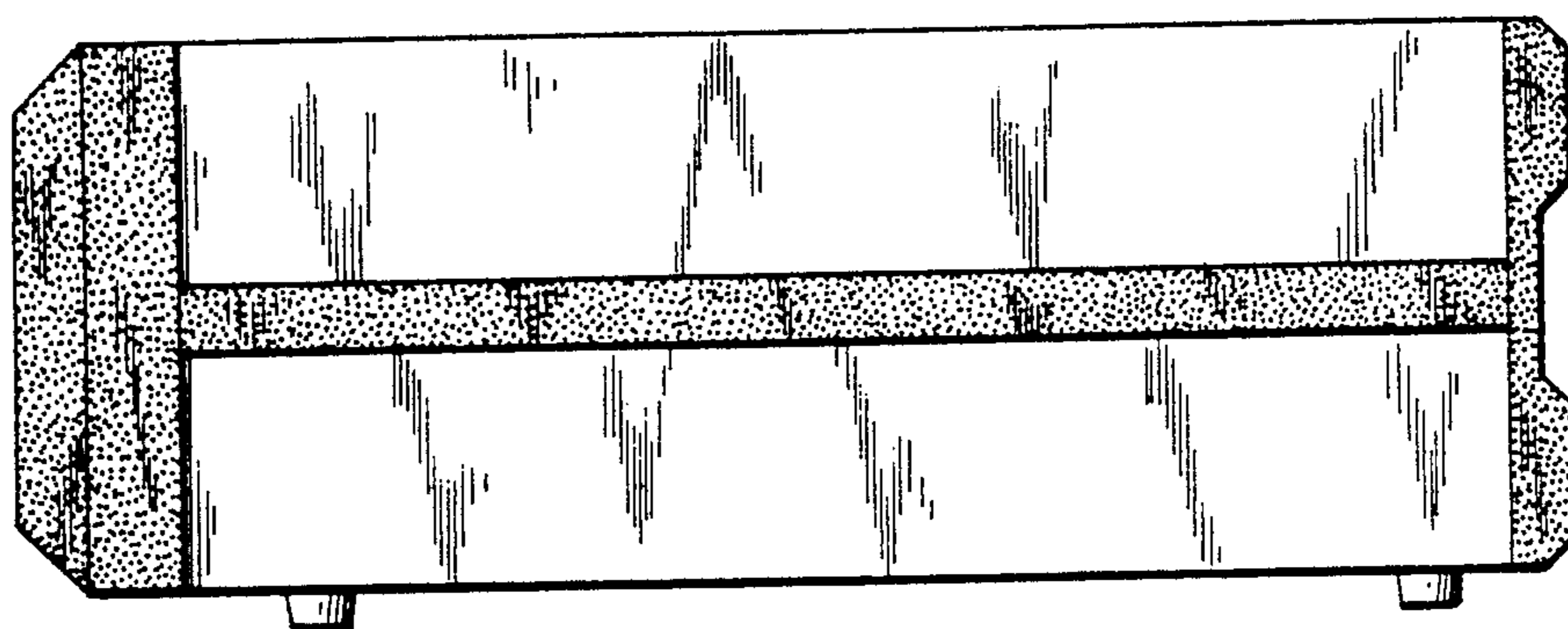
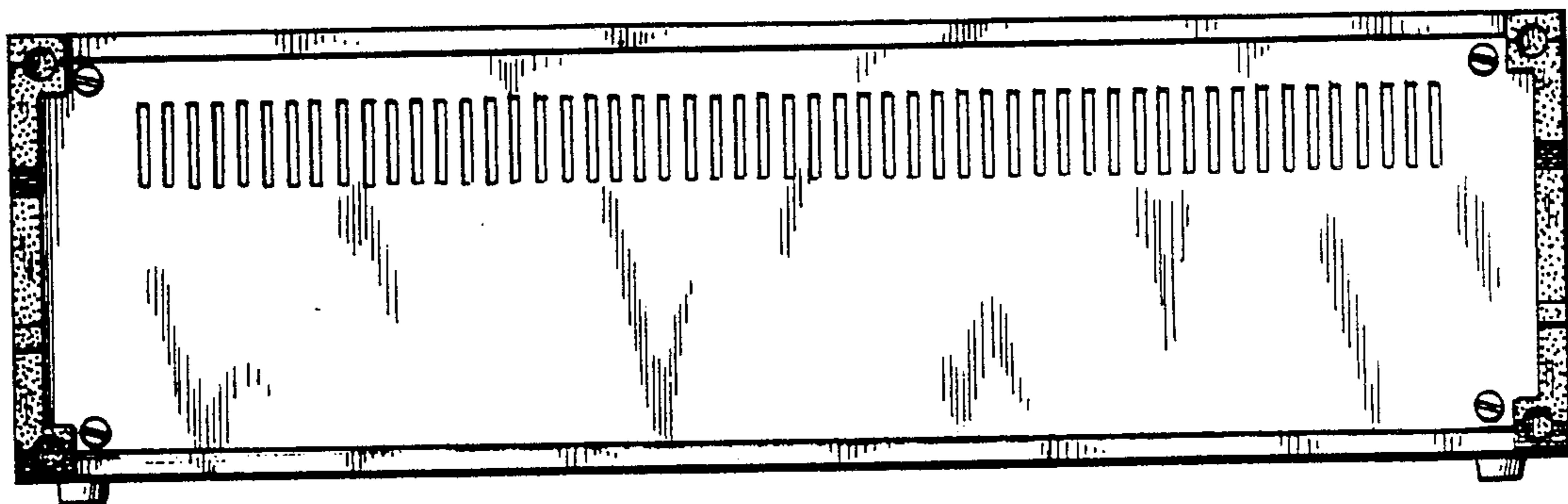

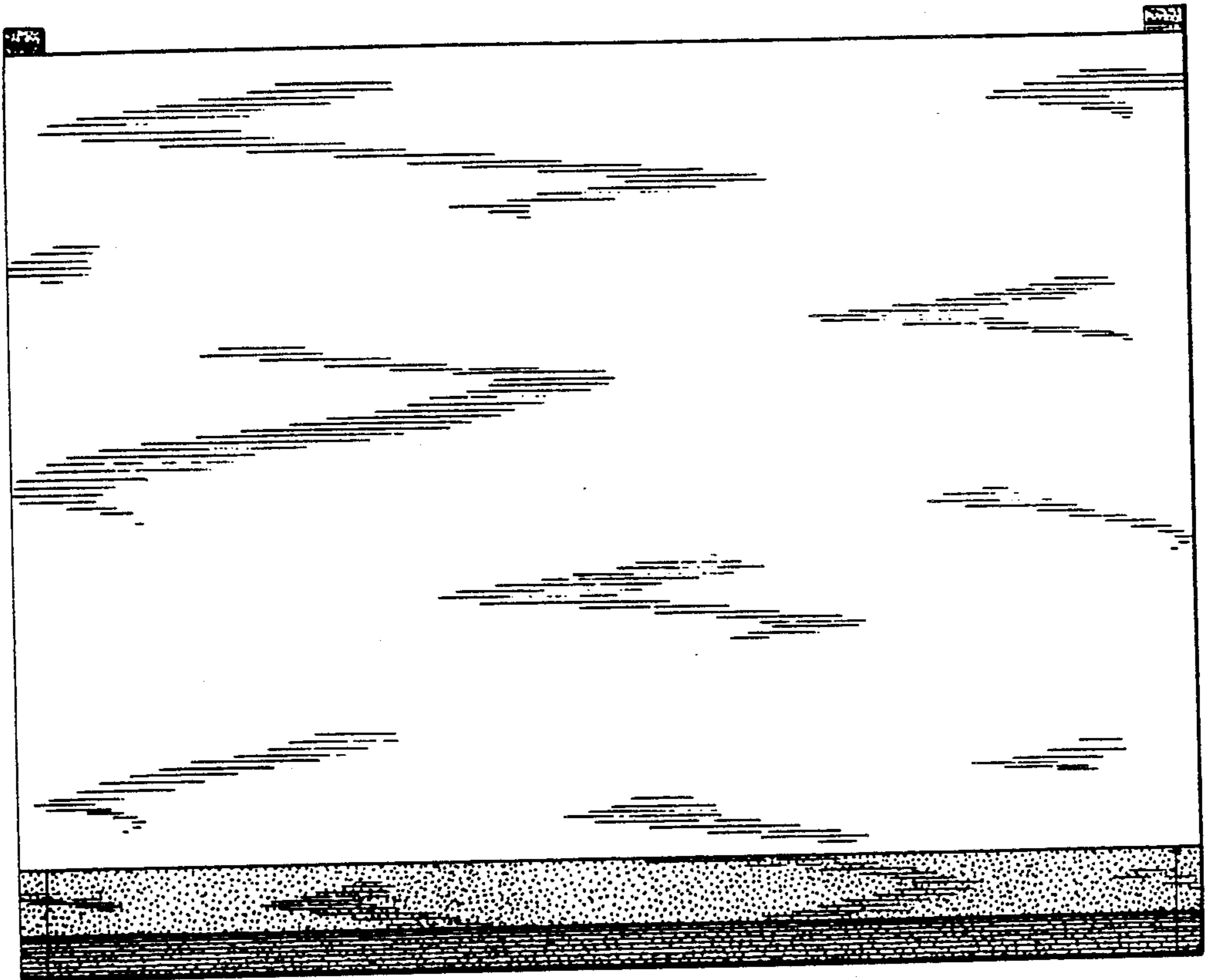

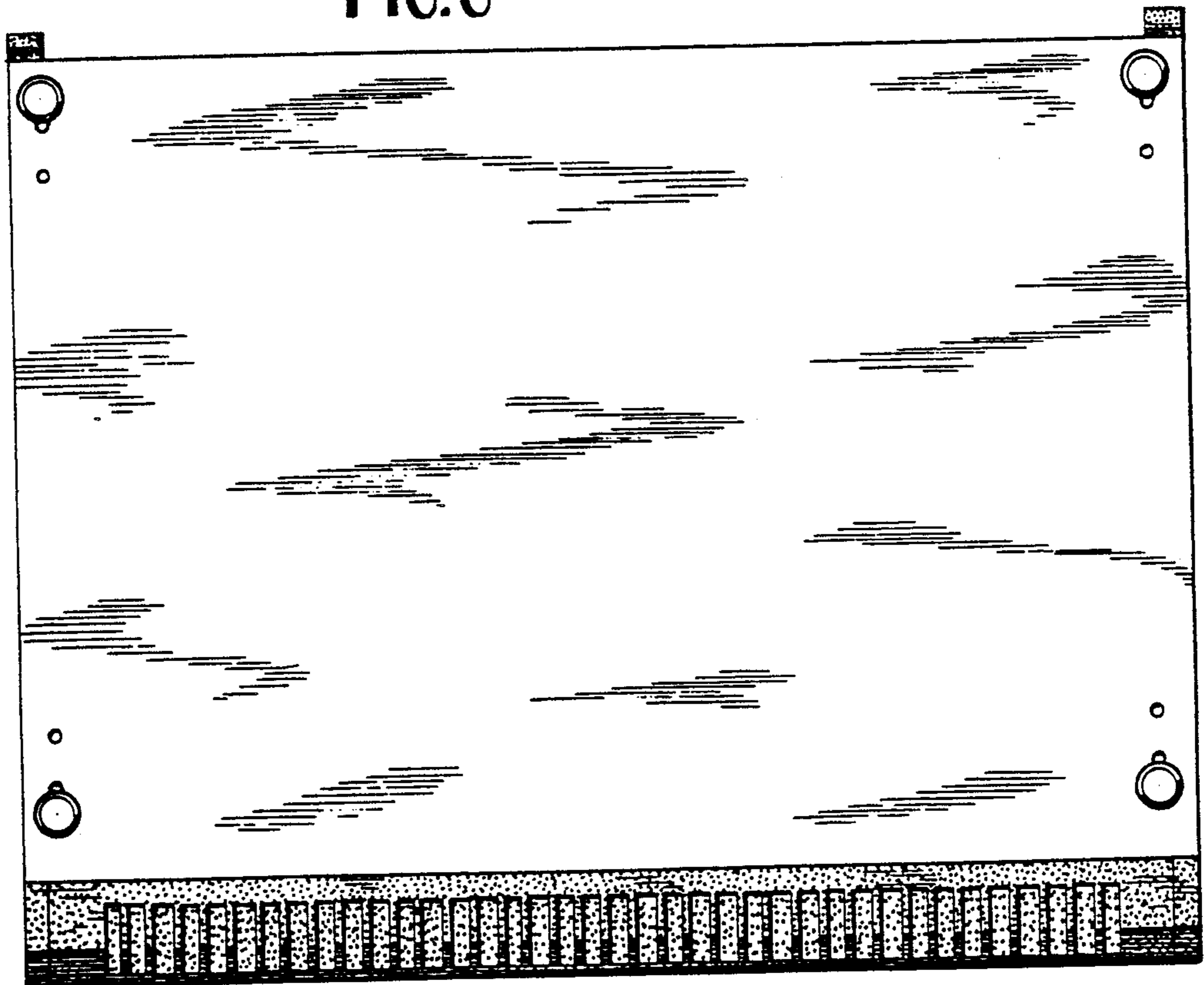

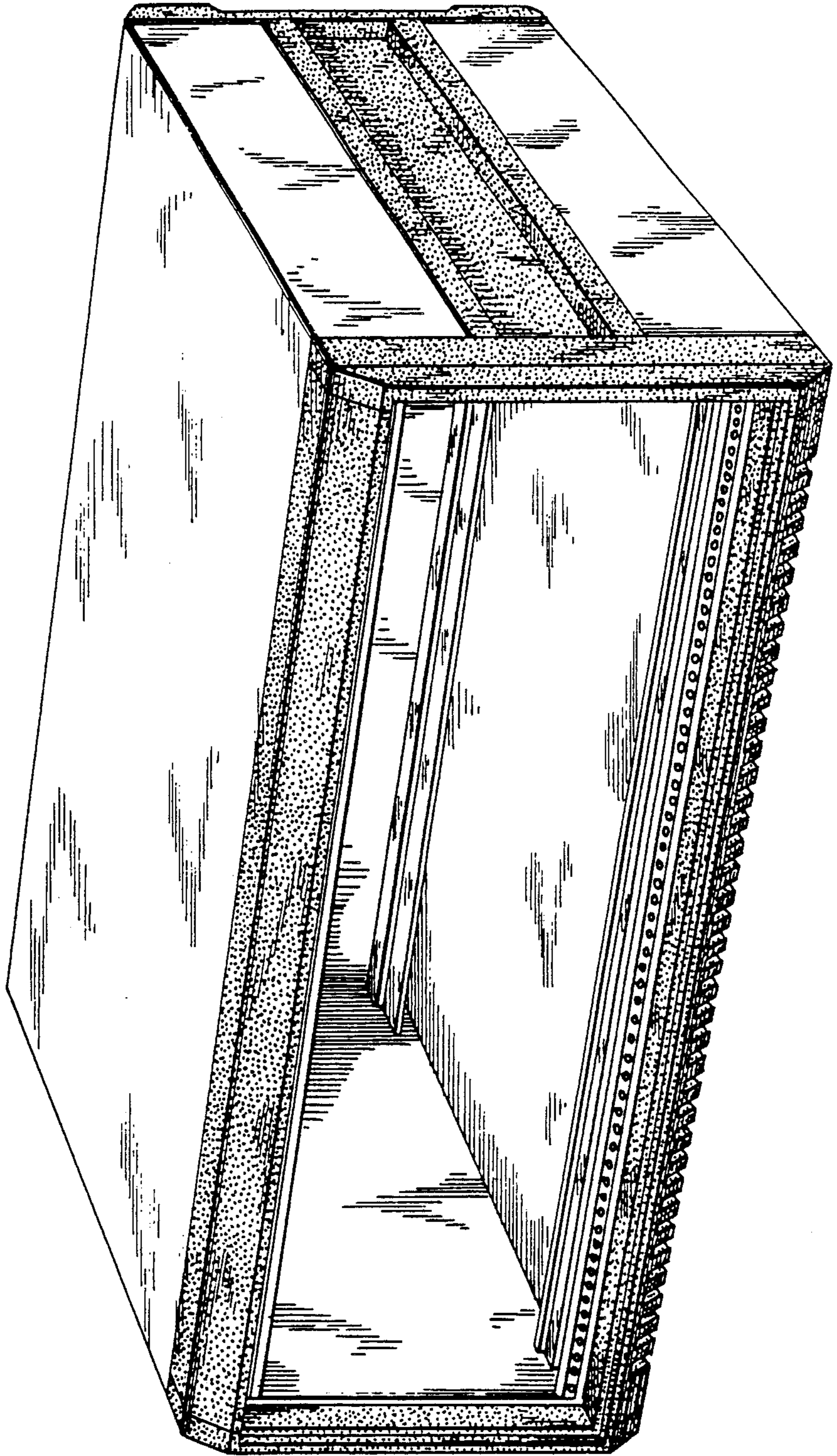

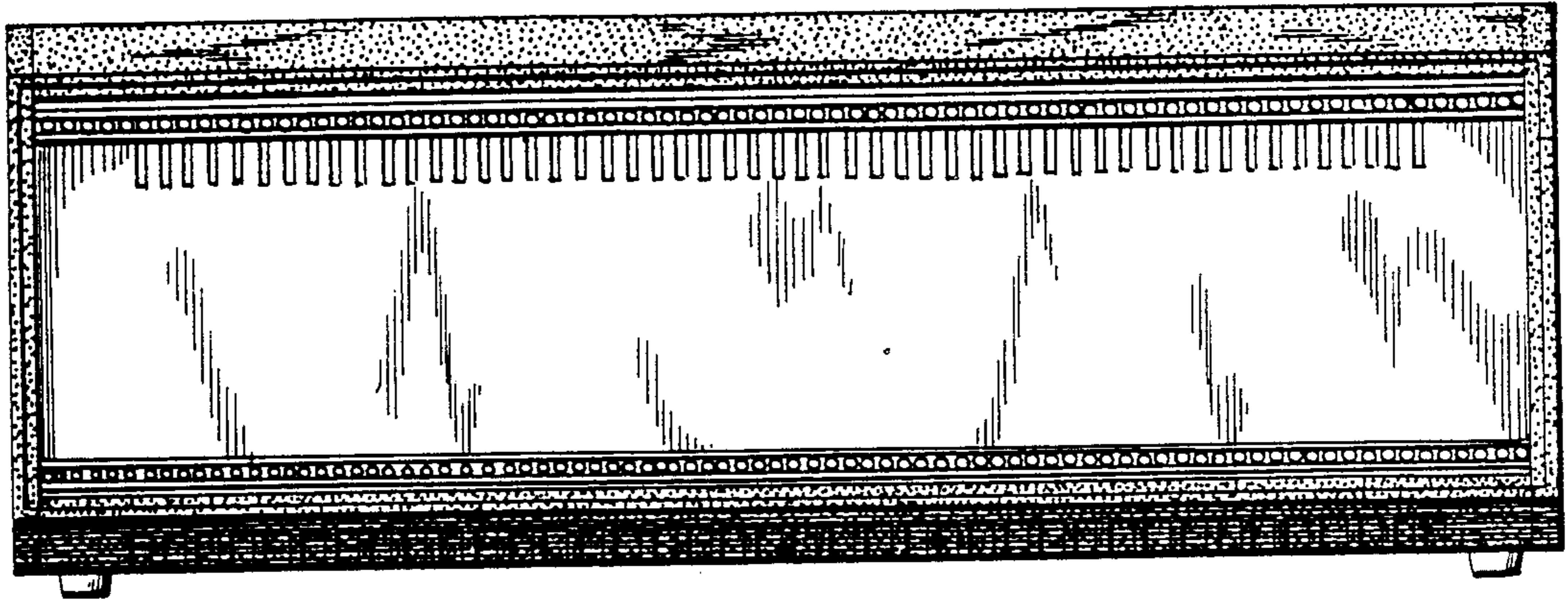

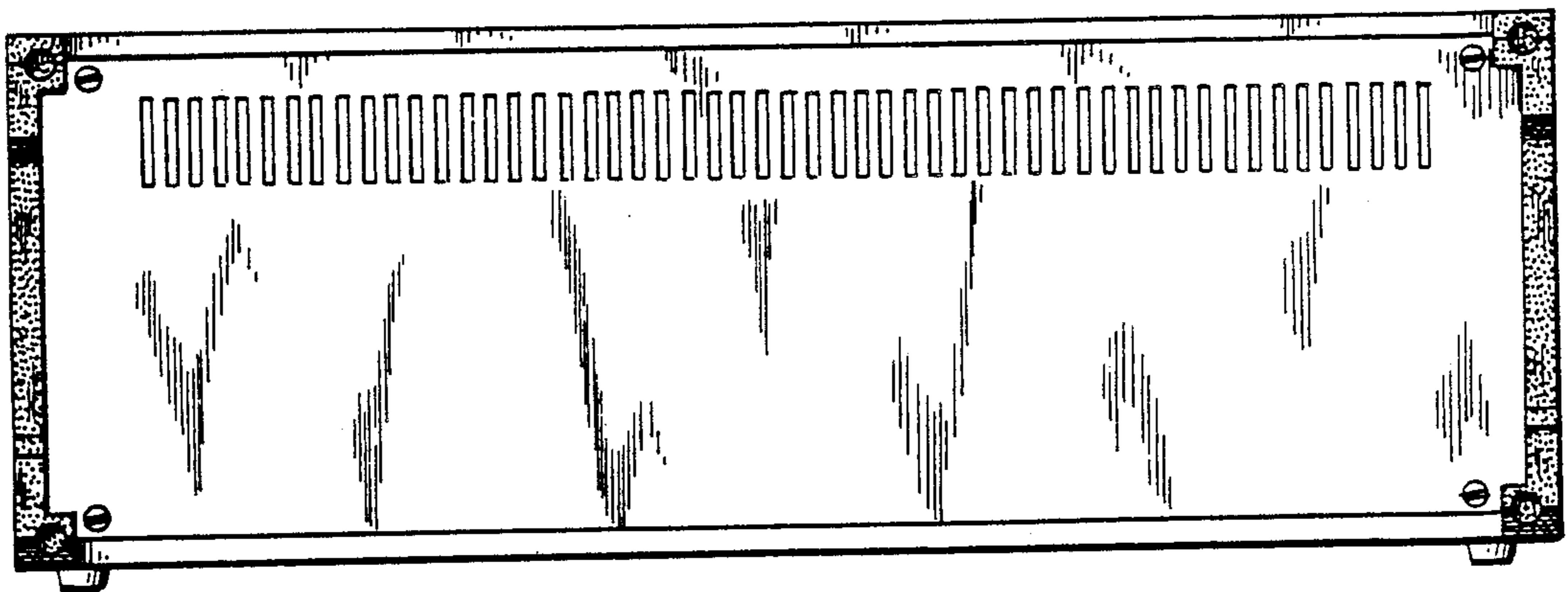

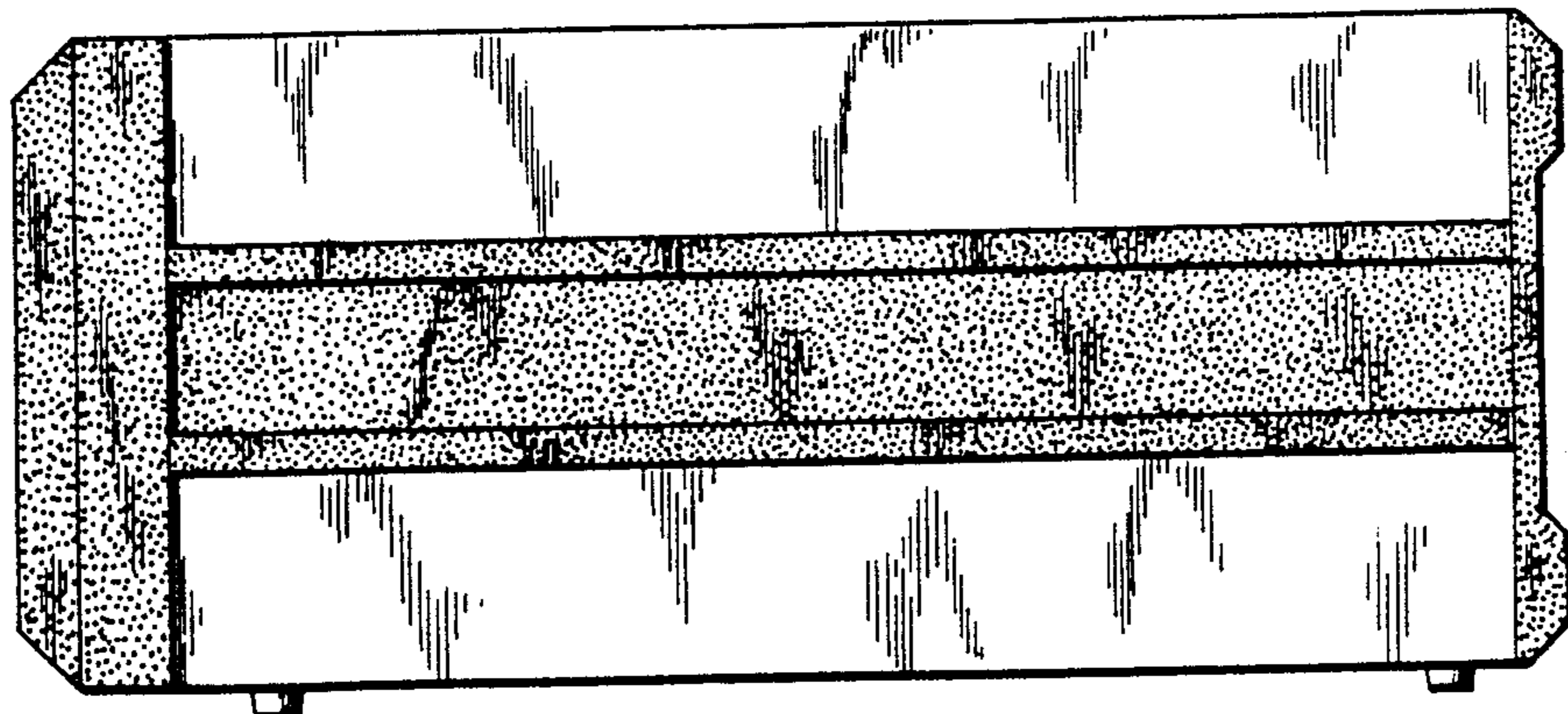

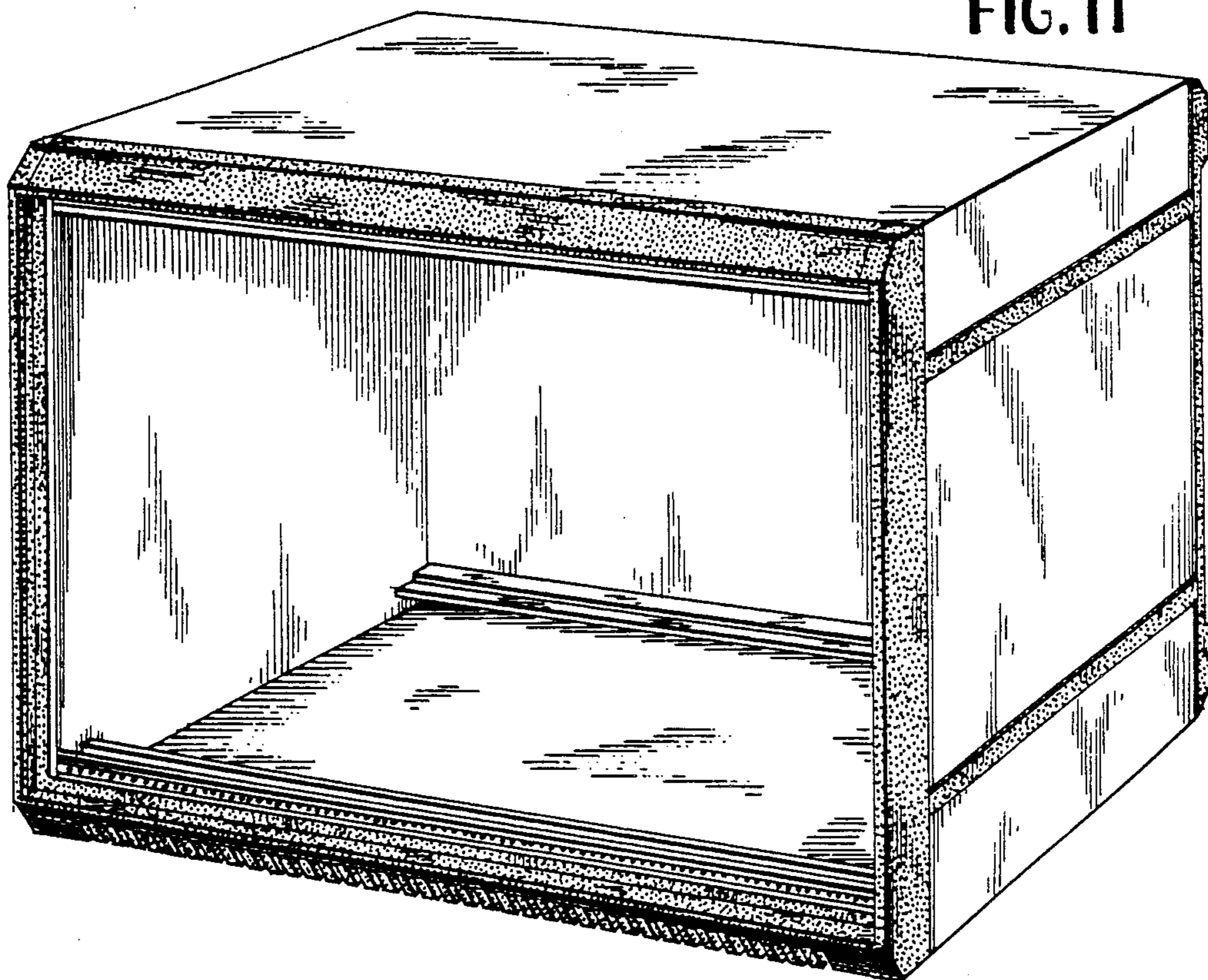

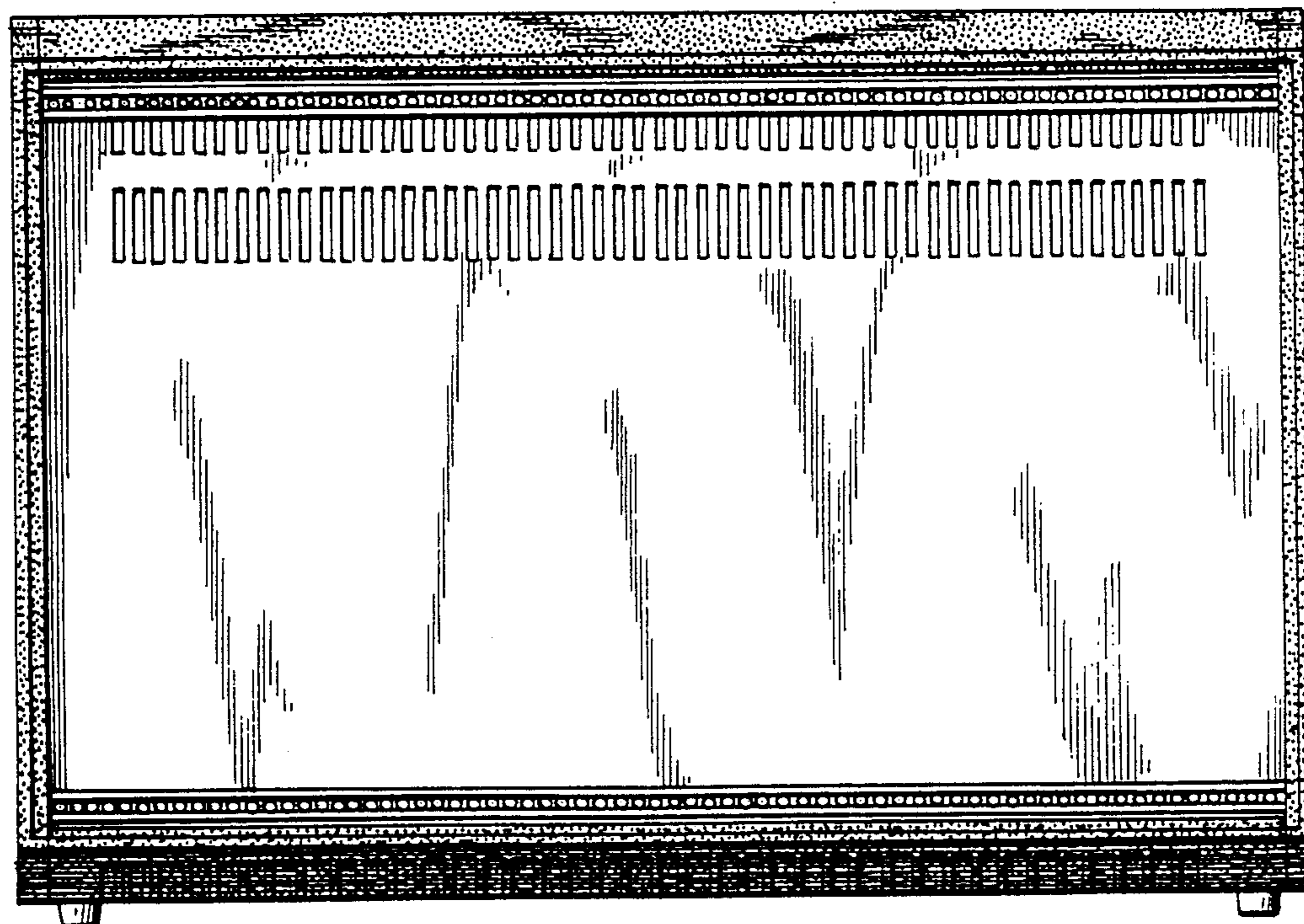

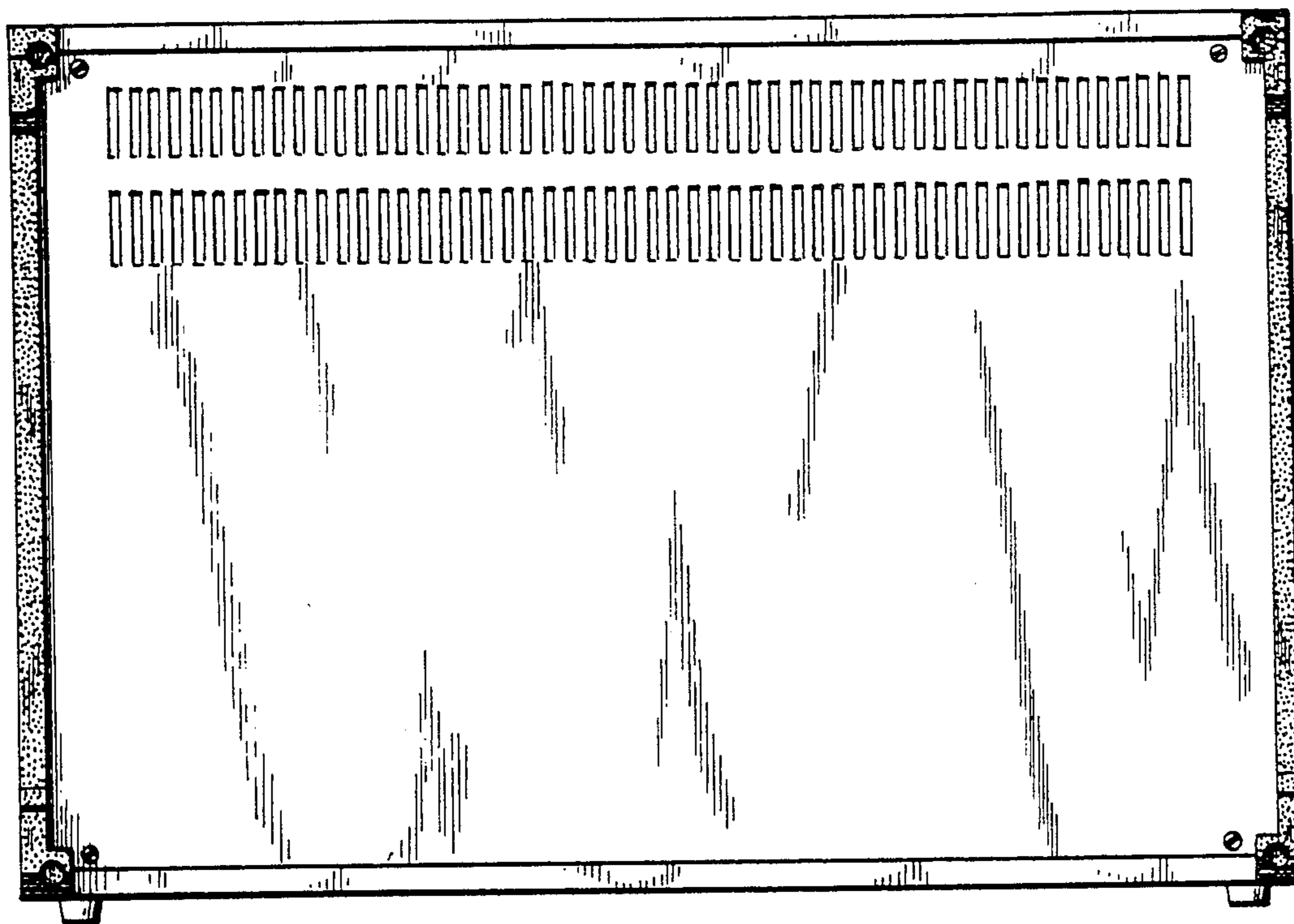
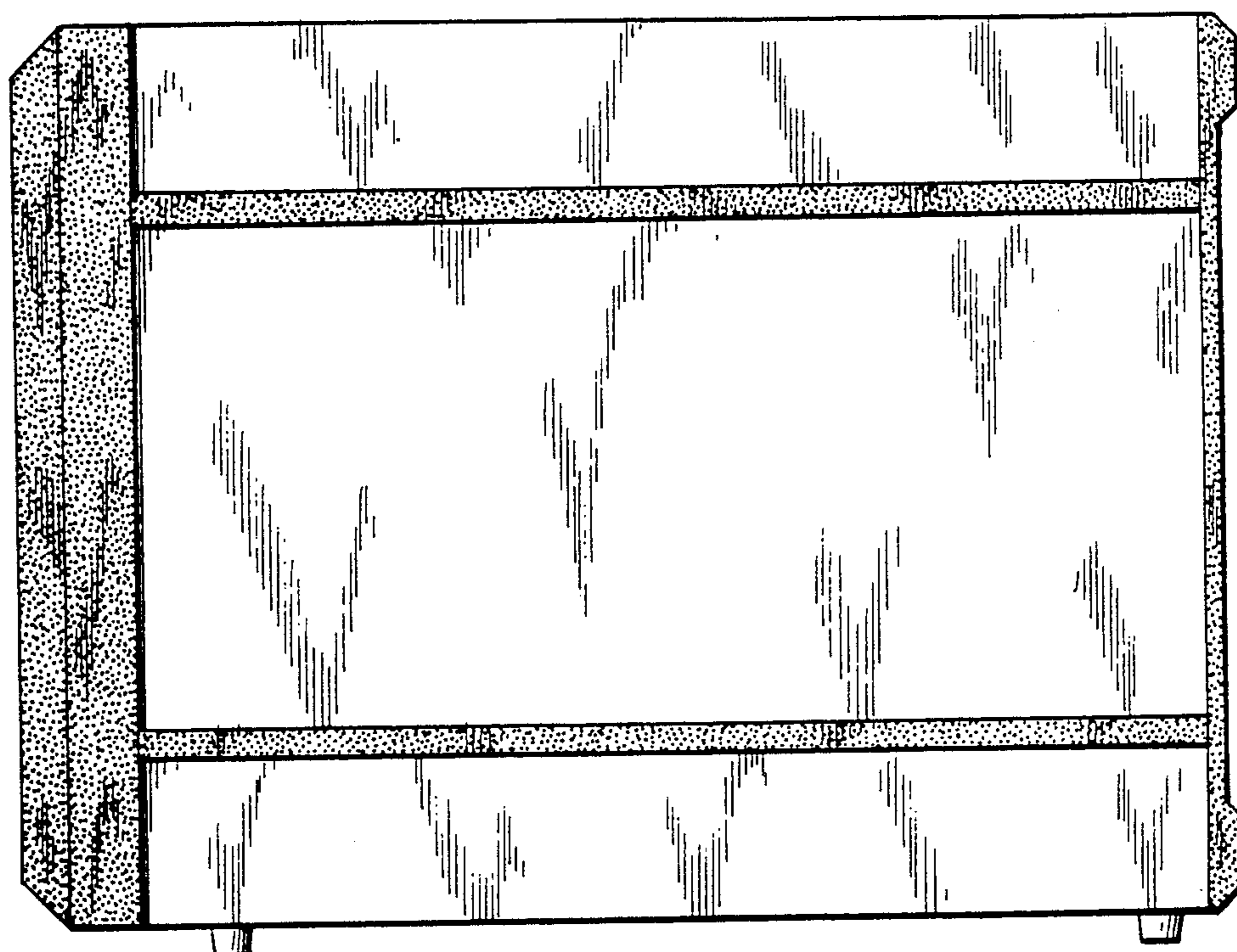
